(57) **CLAIM**

The ornamental design for a combined siren and lighthouse assembly for a vehicle bumper, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of a combined siren and lighthouse assembly for a vehicle bumper for the vehicle driver side thereof;

FIG. 2 is a front elevational view of a combined siren and lighthouse assembly of FIG. 1;

FIG. 3 is a right side view of a combined siren and lighthouse assembly of FIG. 1;

FIG. 4 is a left side view of a combined siren and lighthouse assembly of FIG. 1;

FIG. 5 is a top plan view of a combined siren and lighthouse assembly of FIG. 1;

FIG. 6 is a bottom plan view of a combined siren and lighthouse assembly of FIG. 1;

FIG. 7 is a frontal perspective view of a combined siren and lighthouse assembly for a vehicle bumper for the passenger side thereof;

FIG. 8 is a front elevational view of a combined siren and lighthouse assembly of FIG. 7;

FIG. 9 is a right side view of a combined siren and lighthouse assembly of FIG. 7;

FIG. 10 is a left side view of a combined siren and lighthouse assembly of FIG. 7;

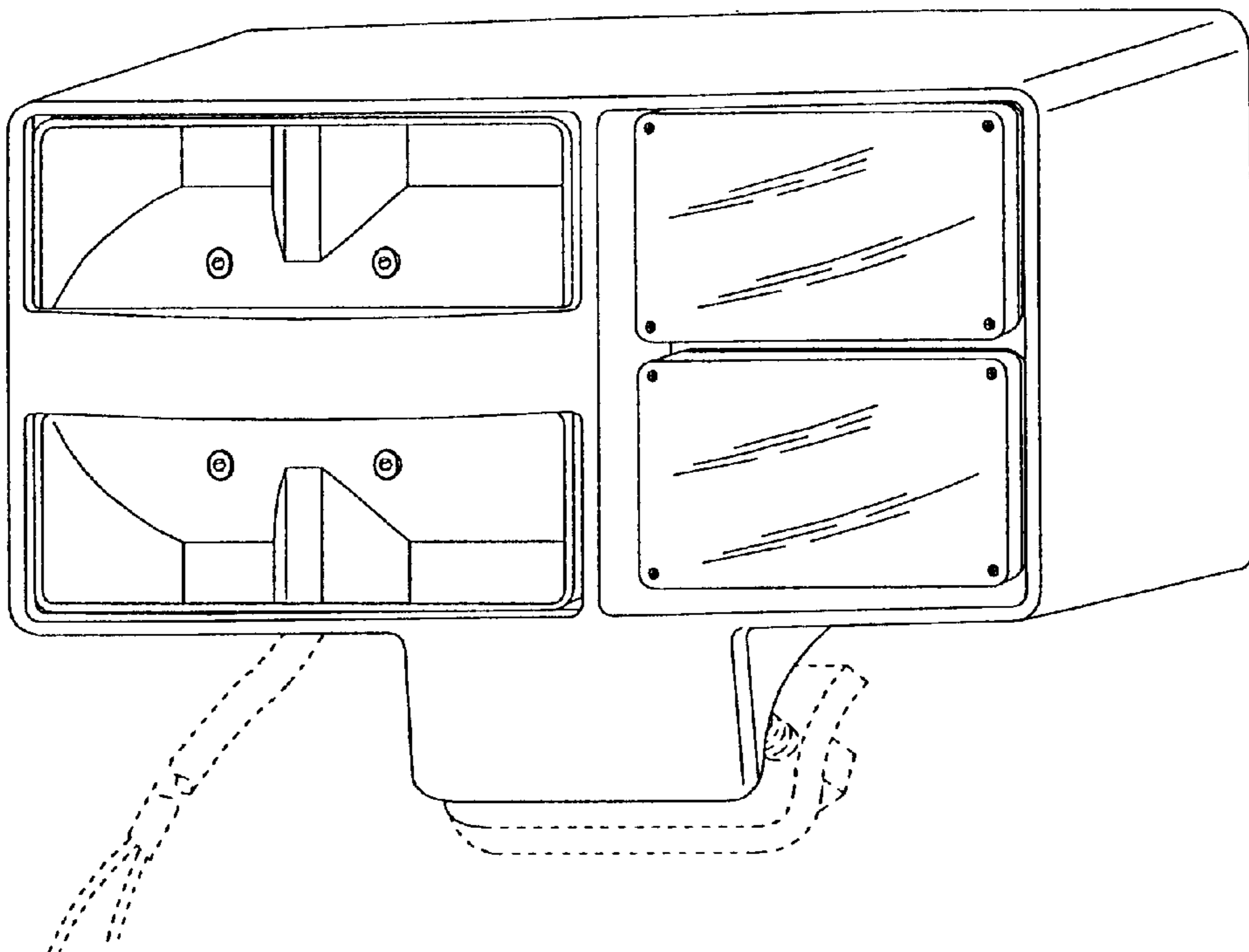
FIG. 11 is a top plan view of a combined siren and lighthouse assembly of FIG. 7; and,

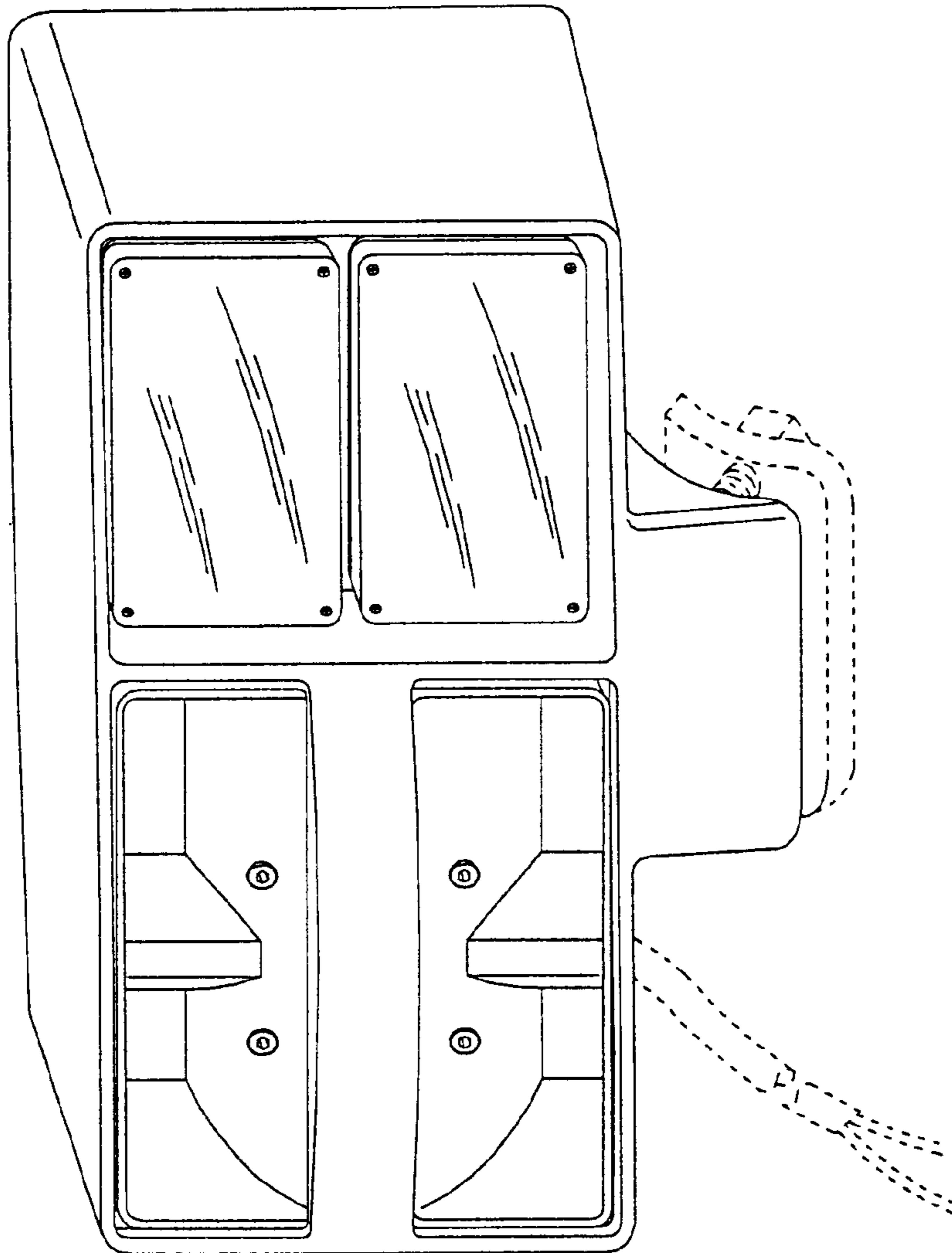

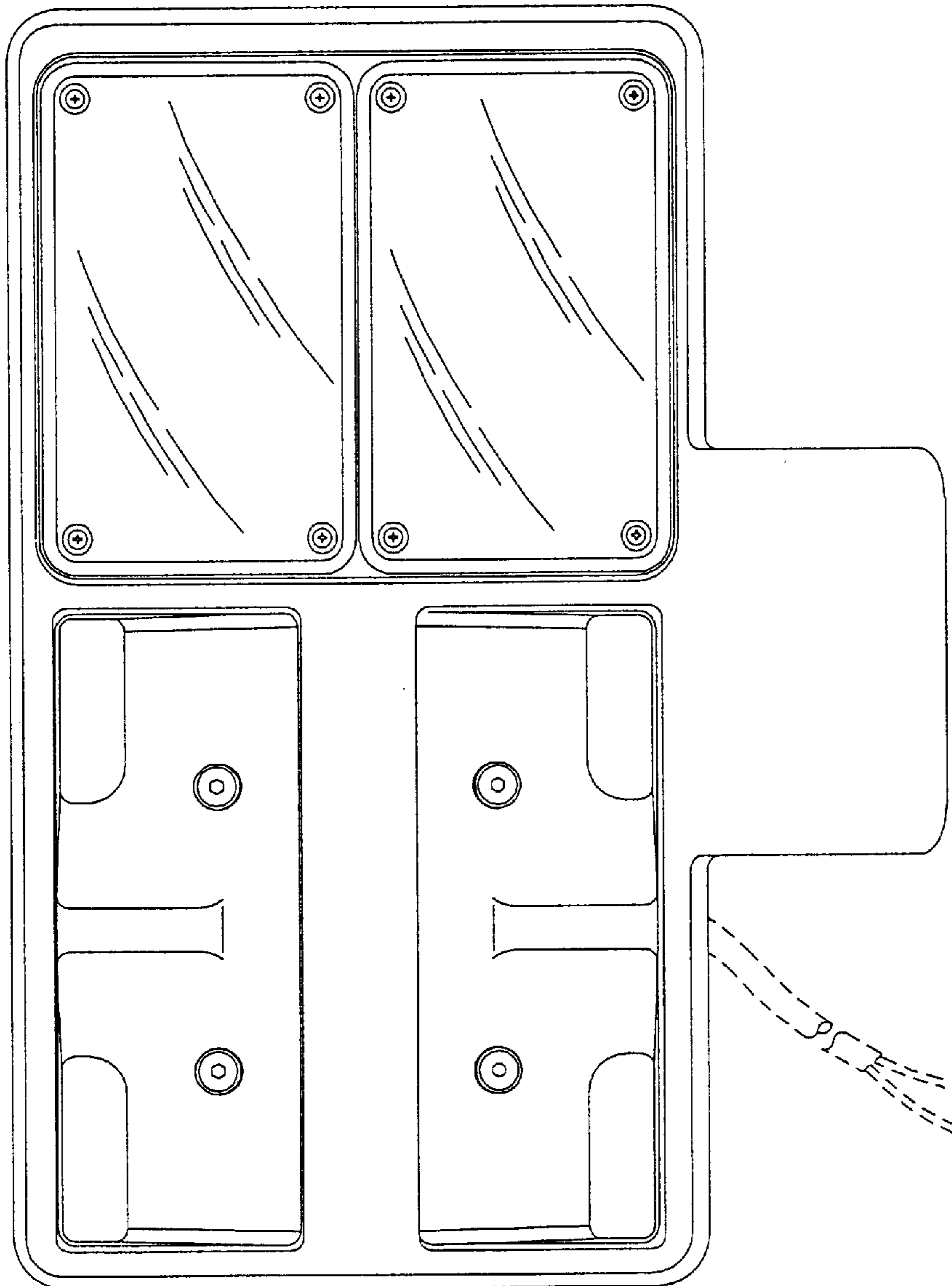

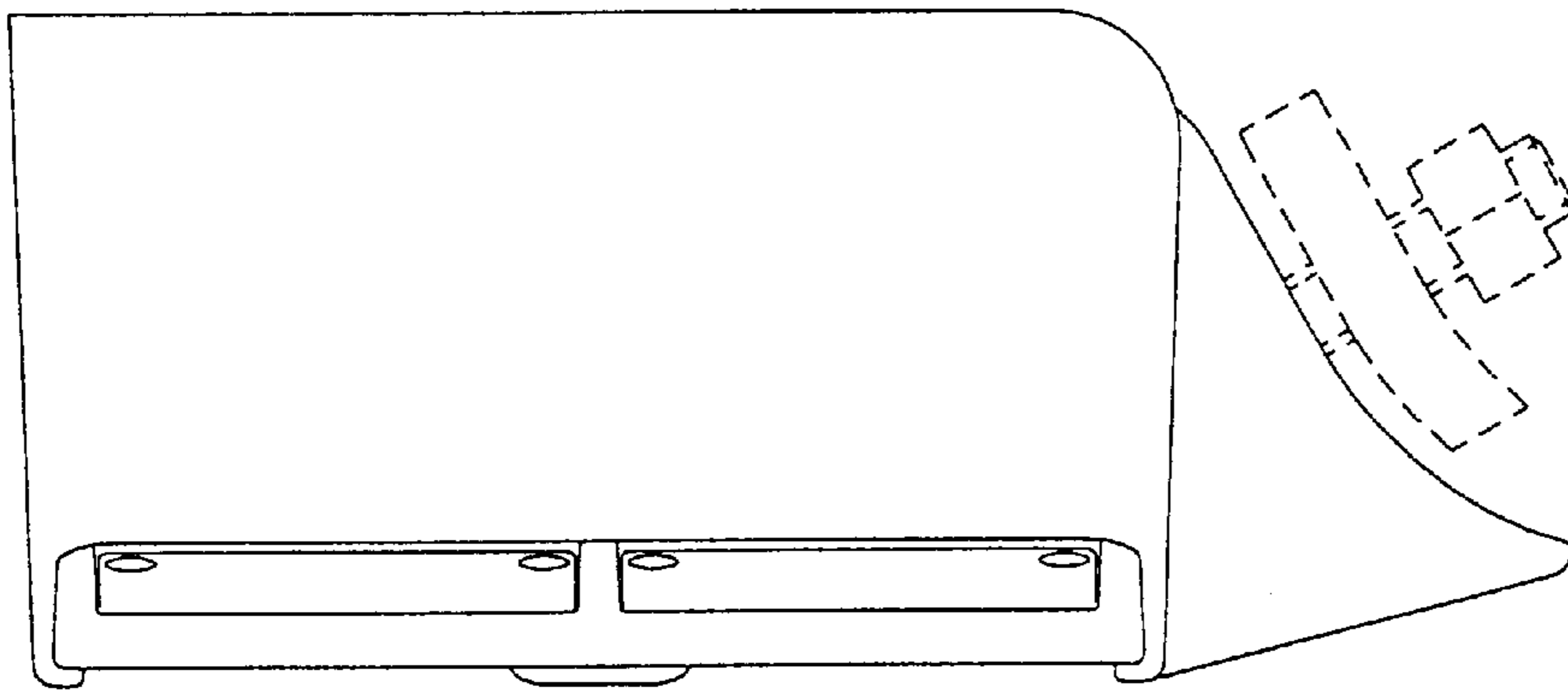

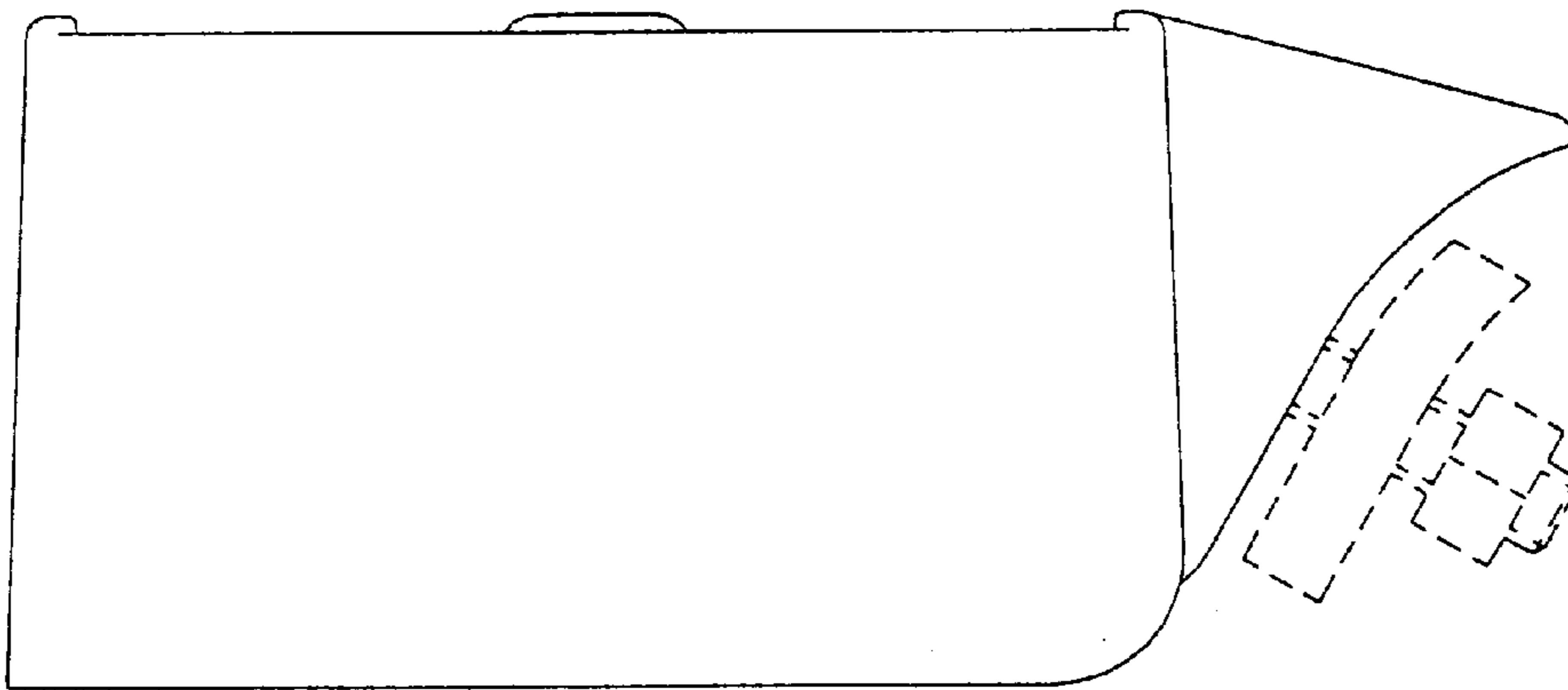

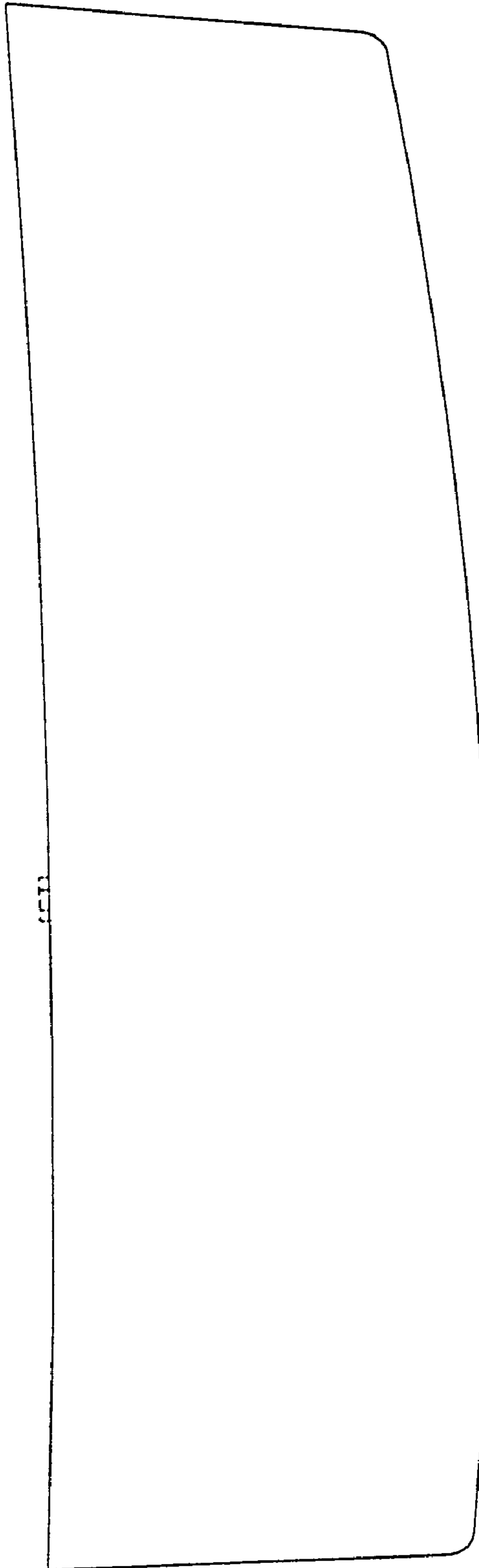

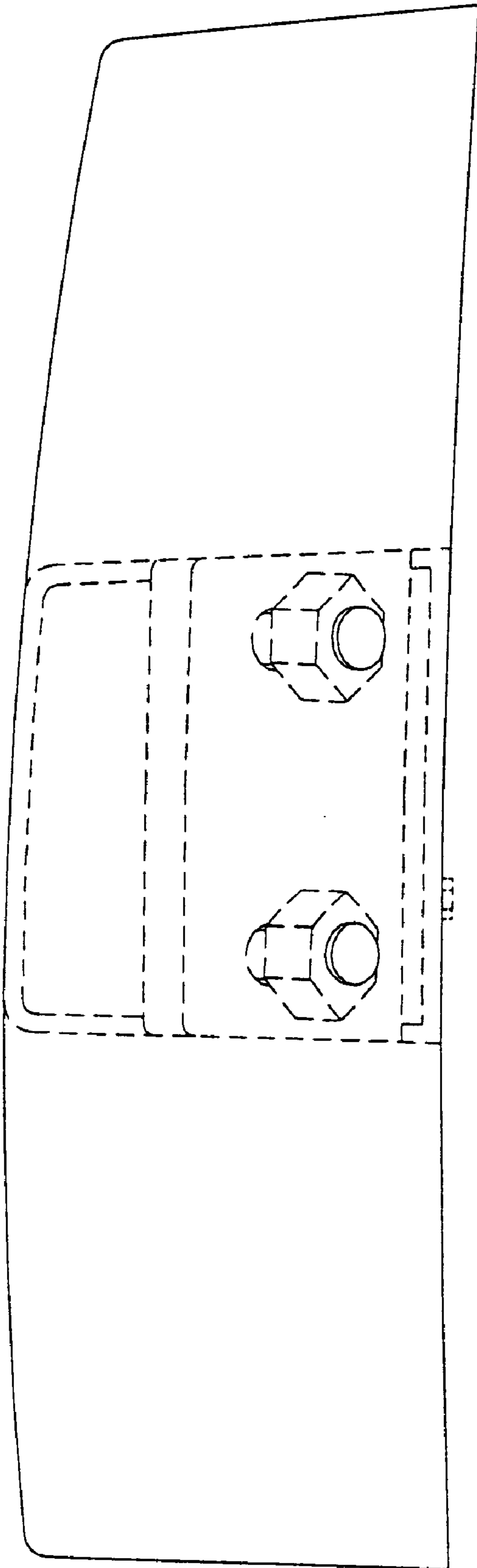

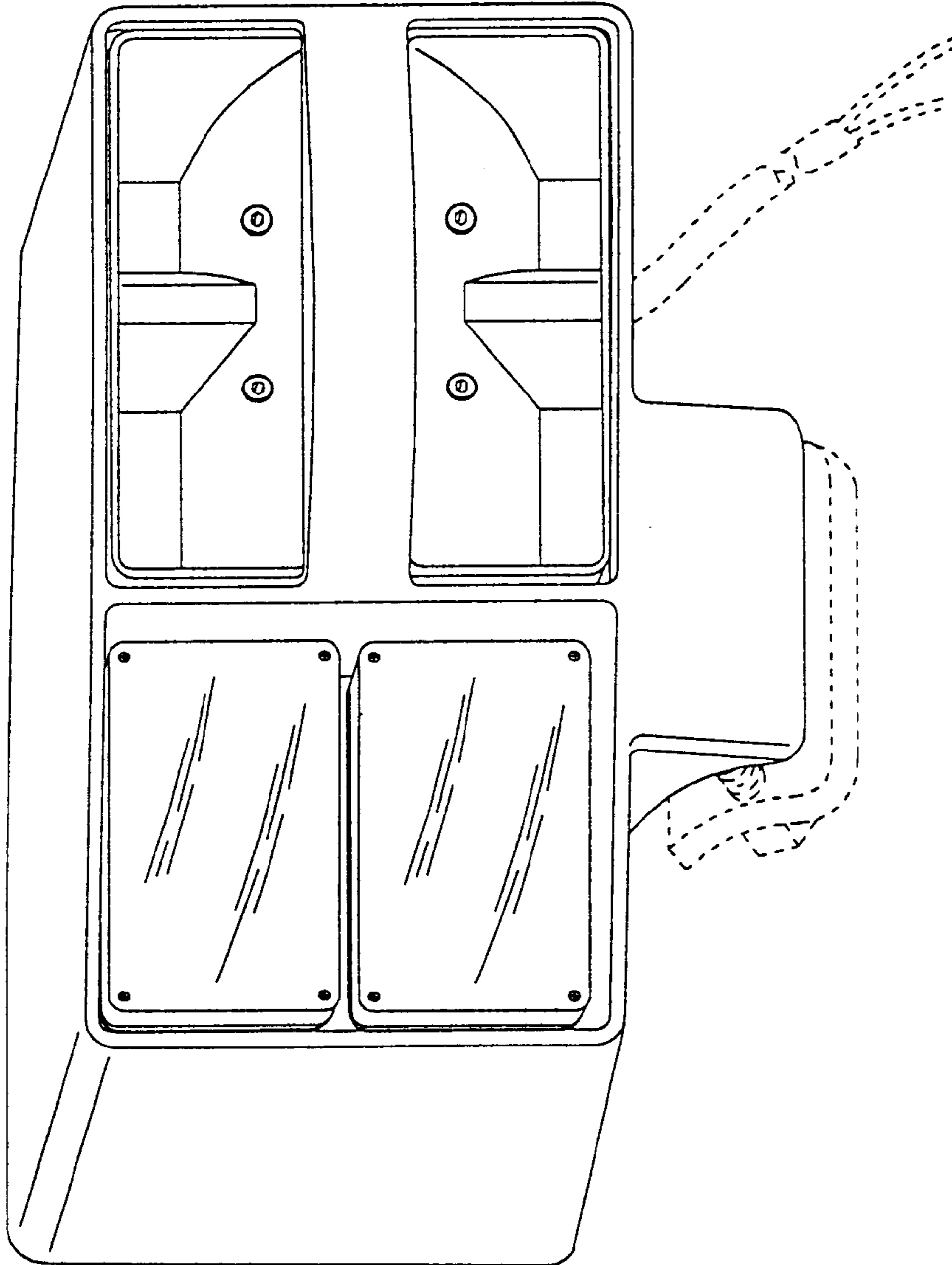

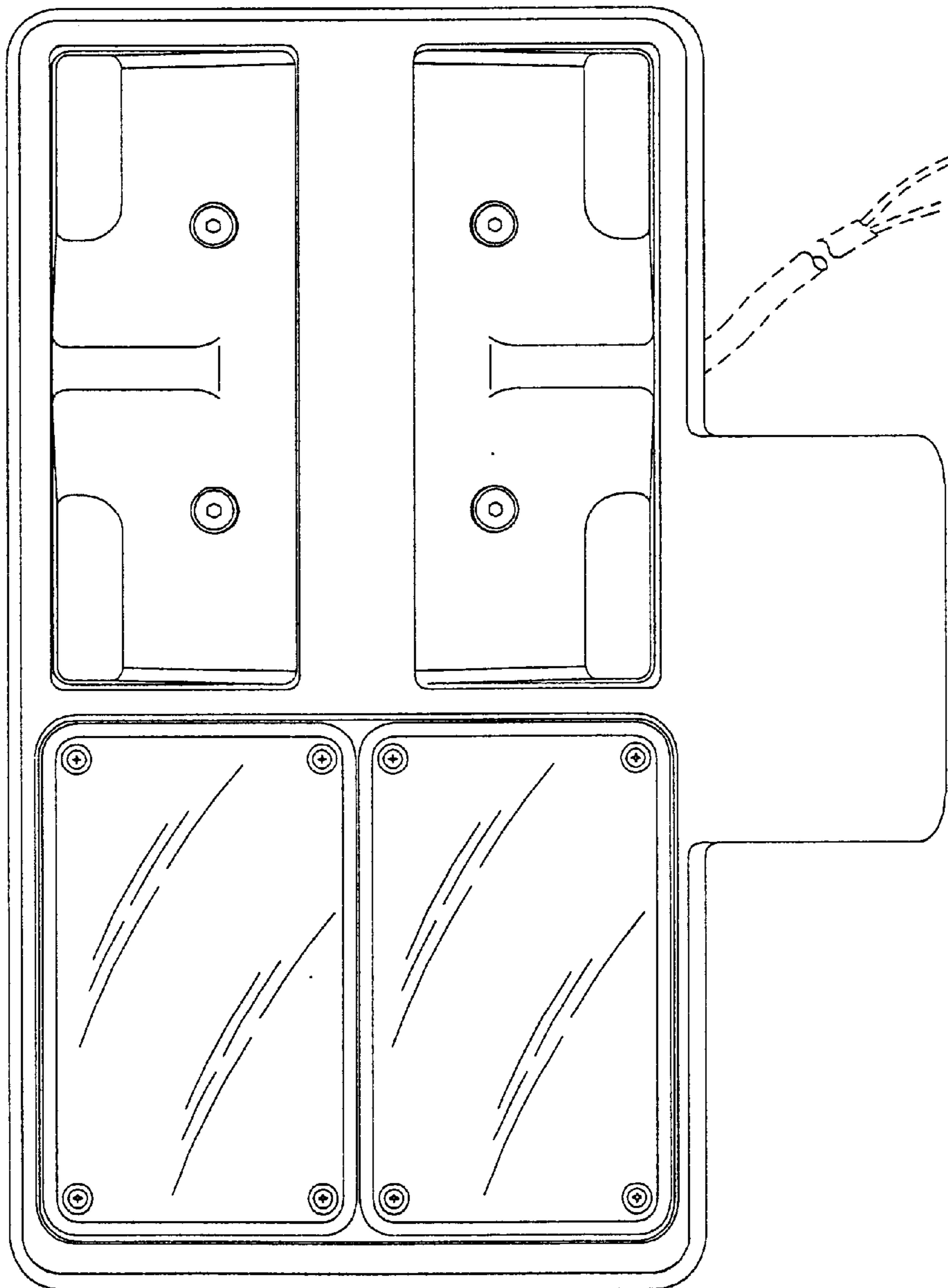

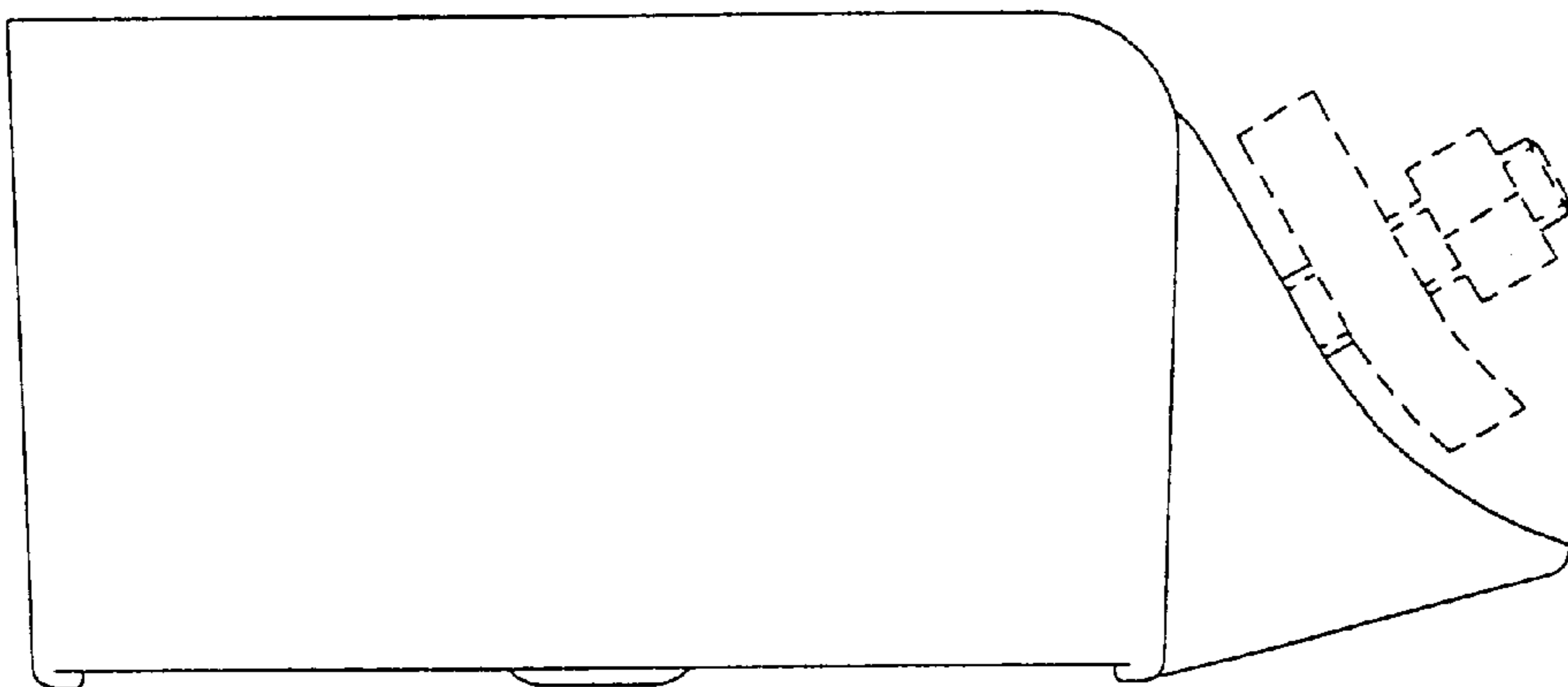

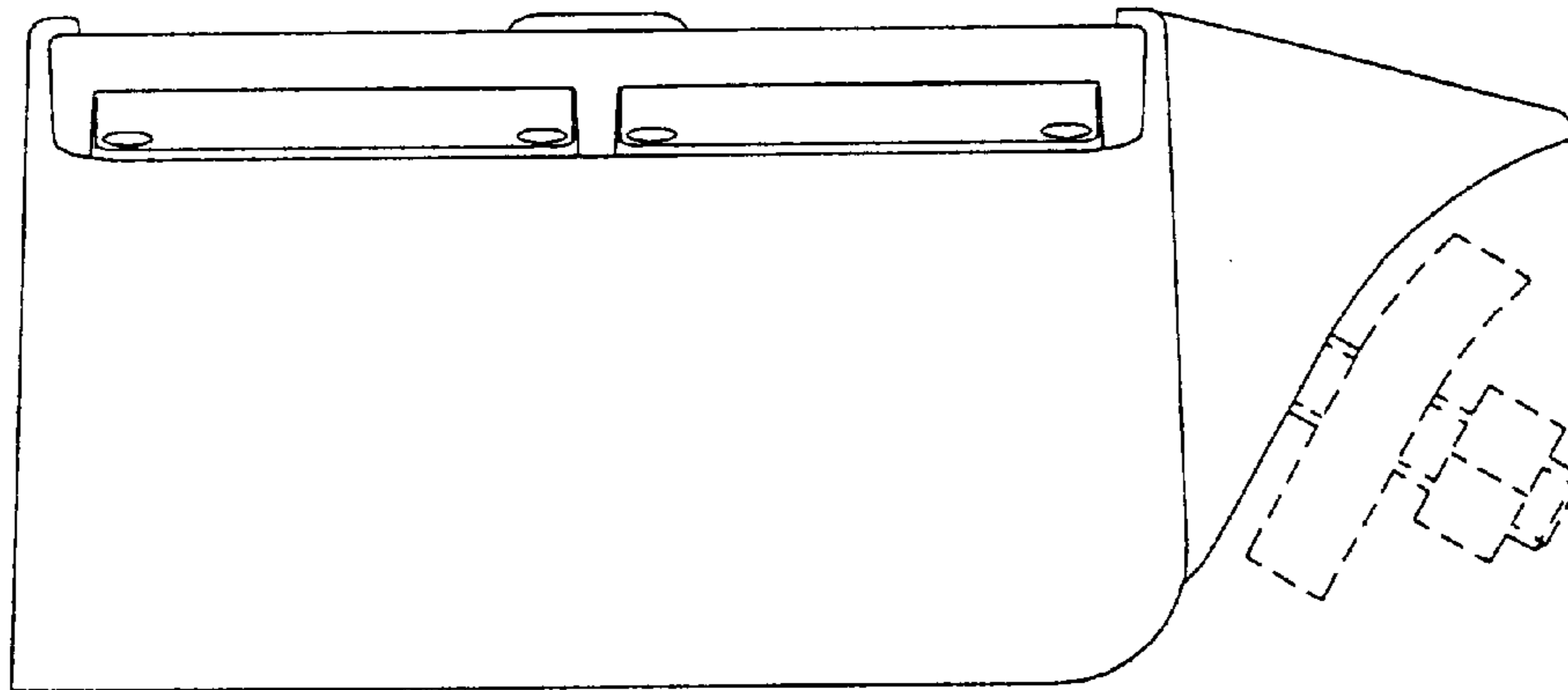

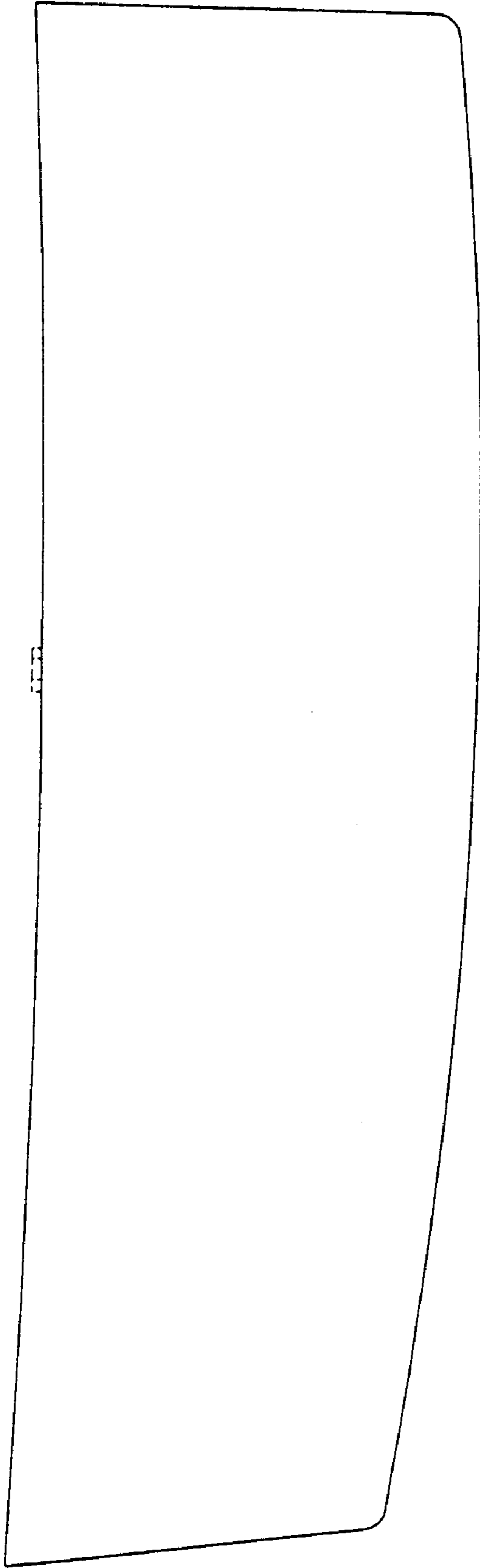

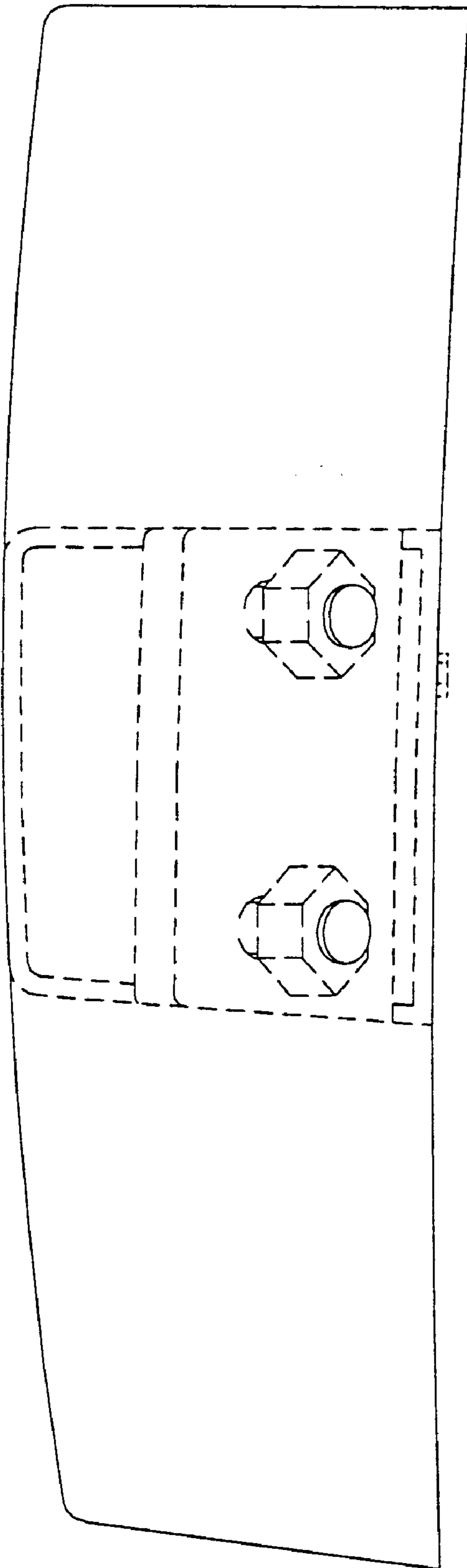
