I claim the ornamental design for the ring, as shown and described.

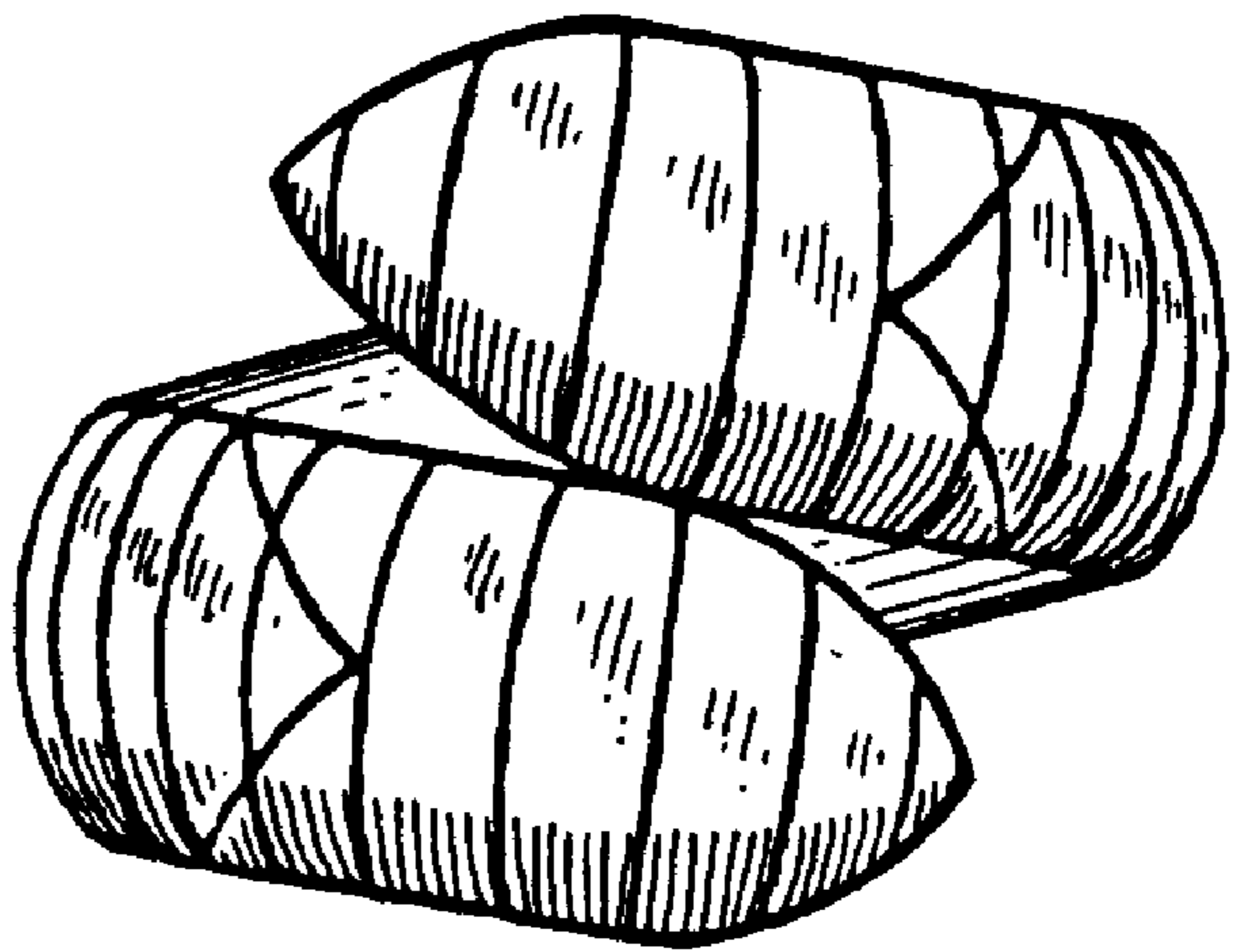
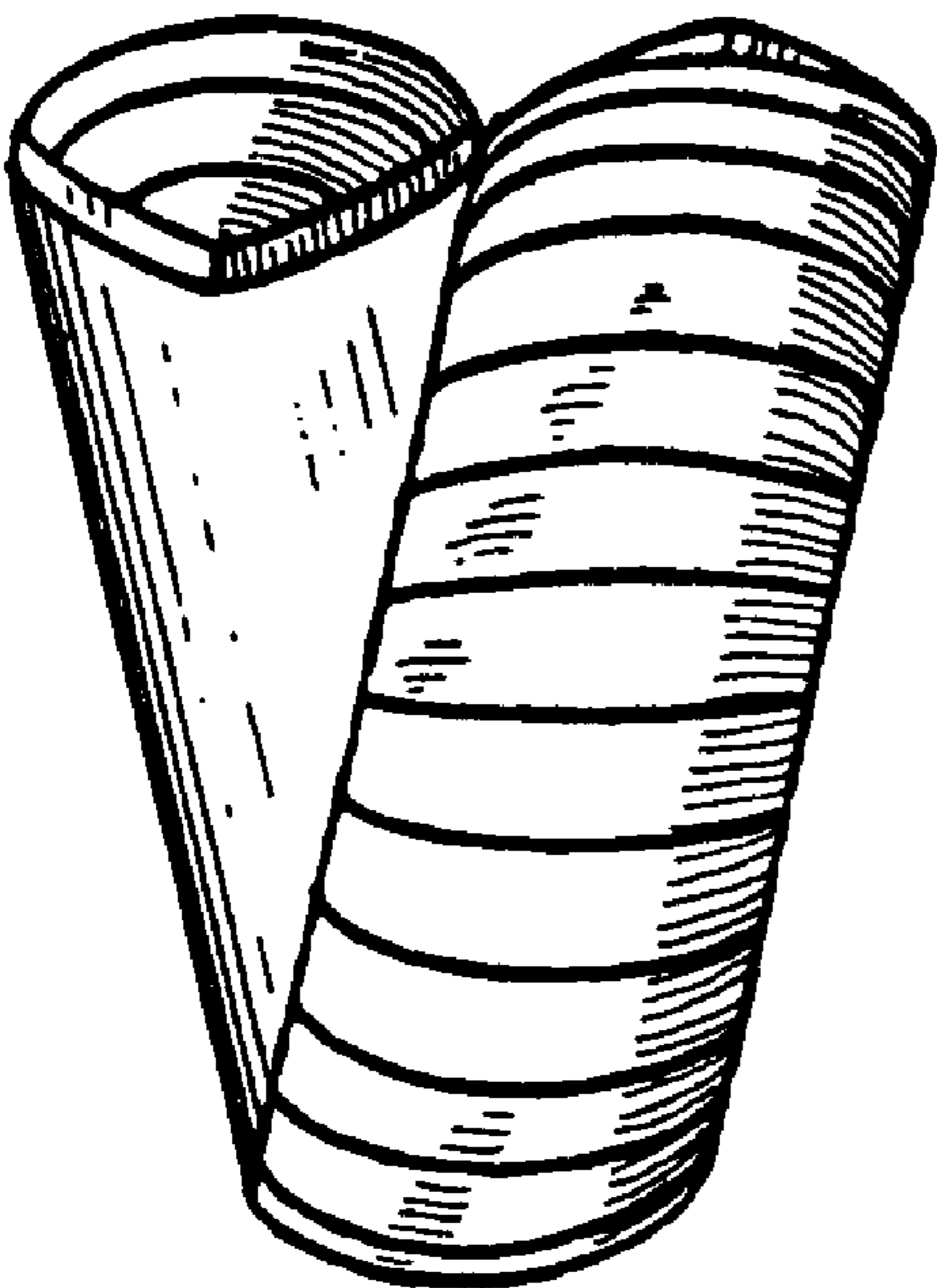
DESCRIPTION

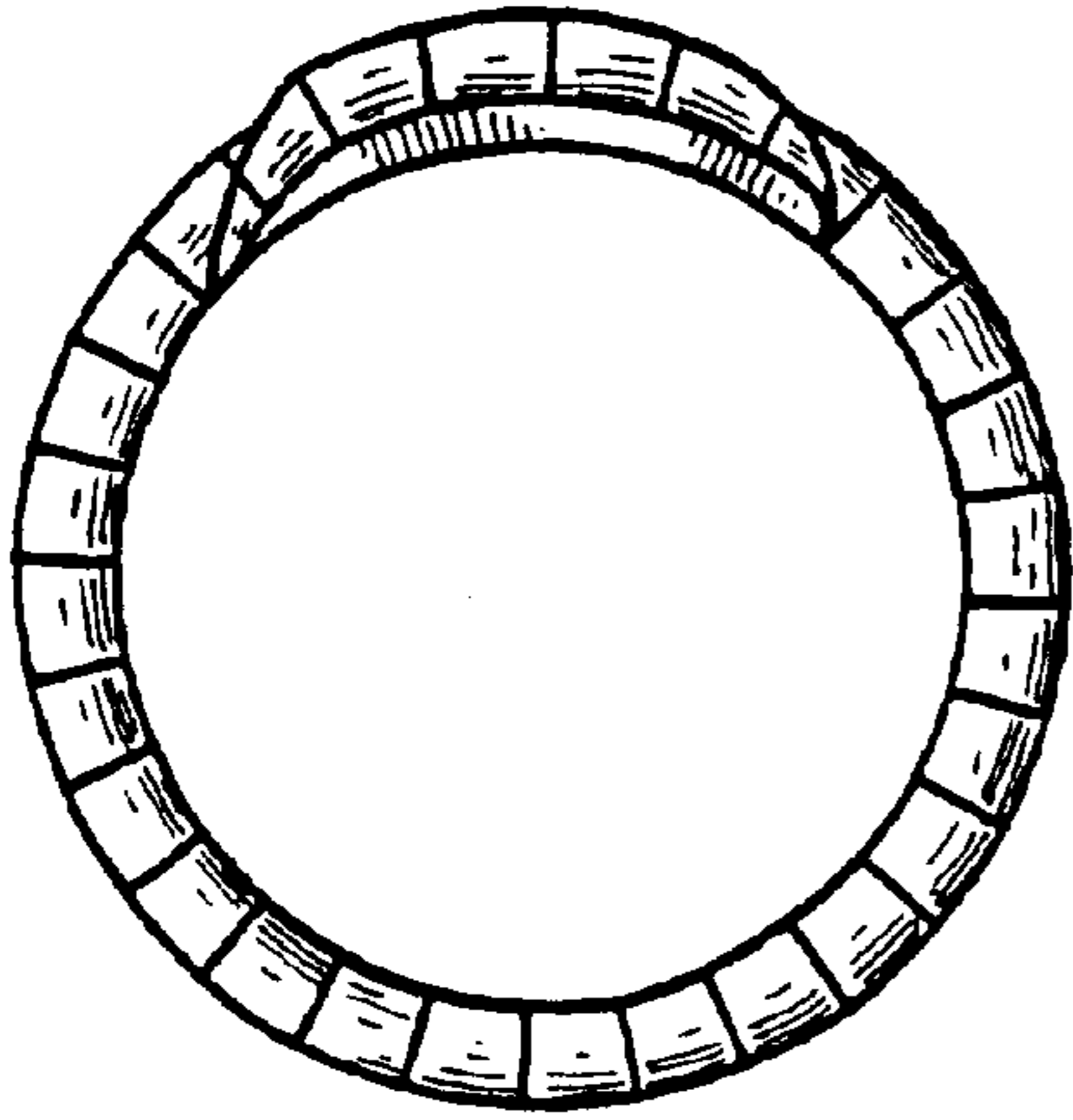

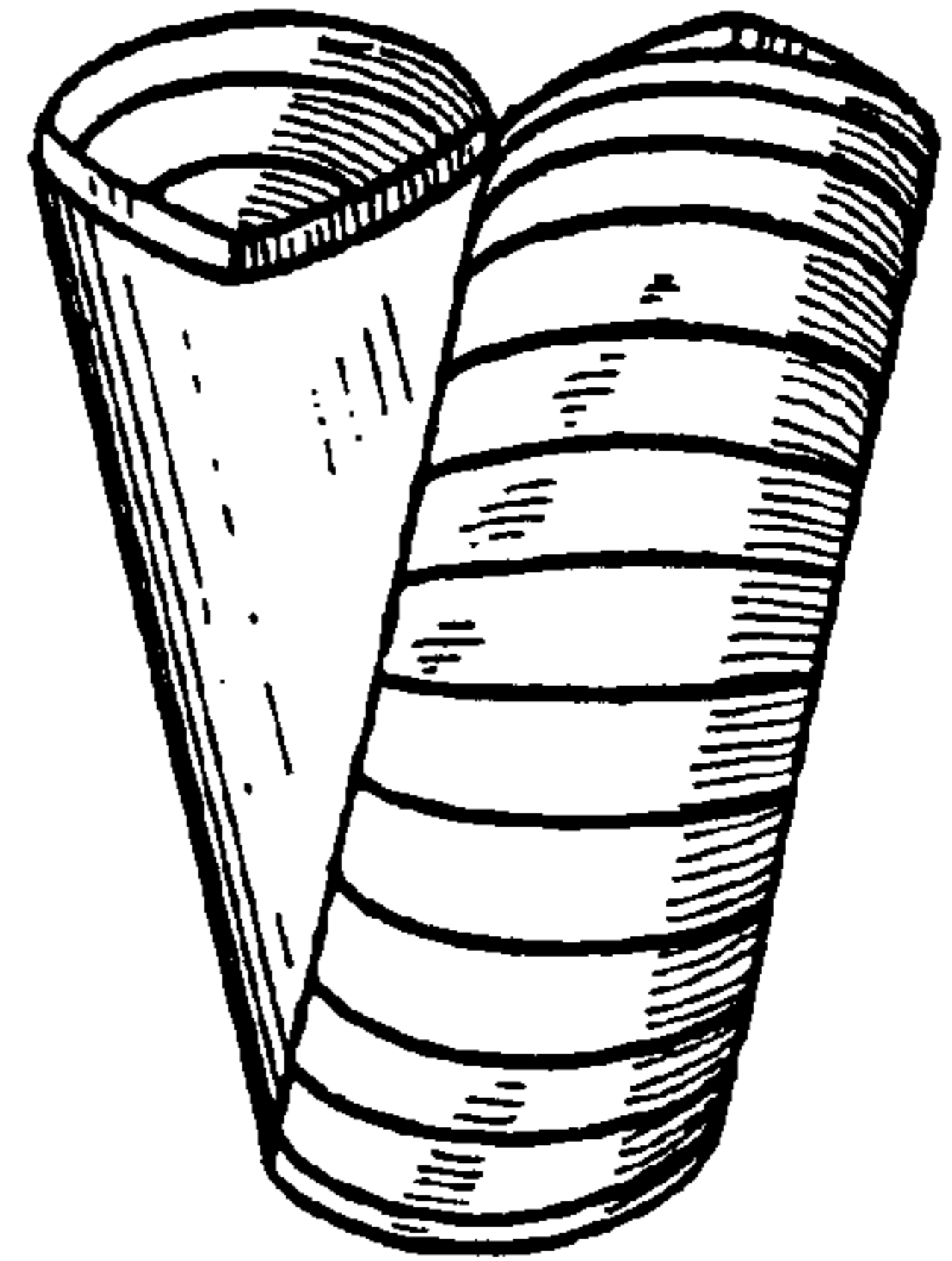

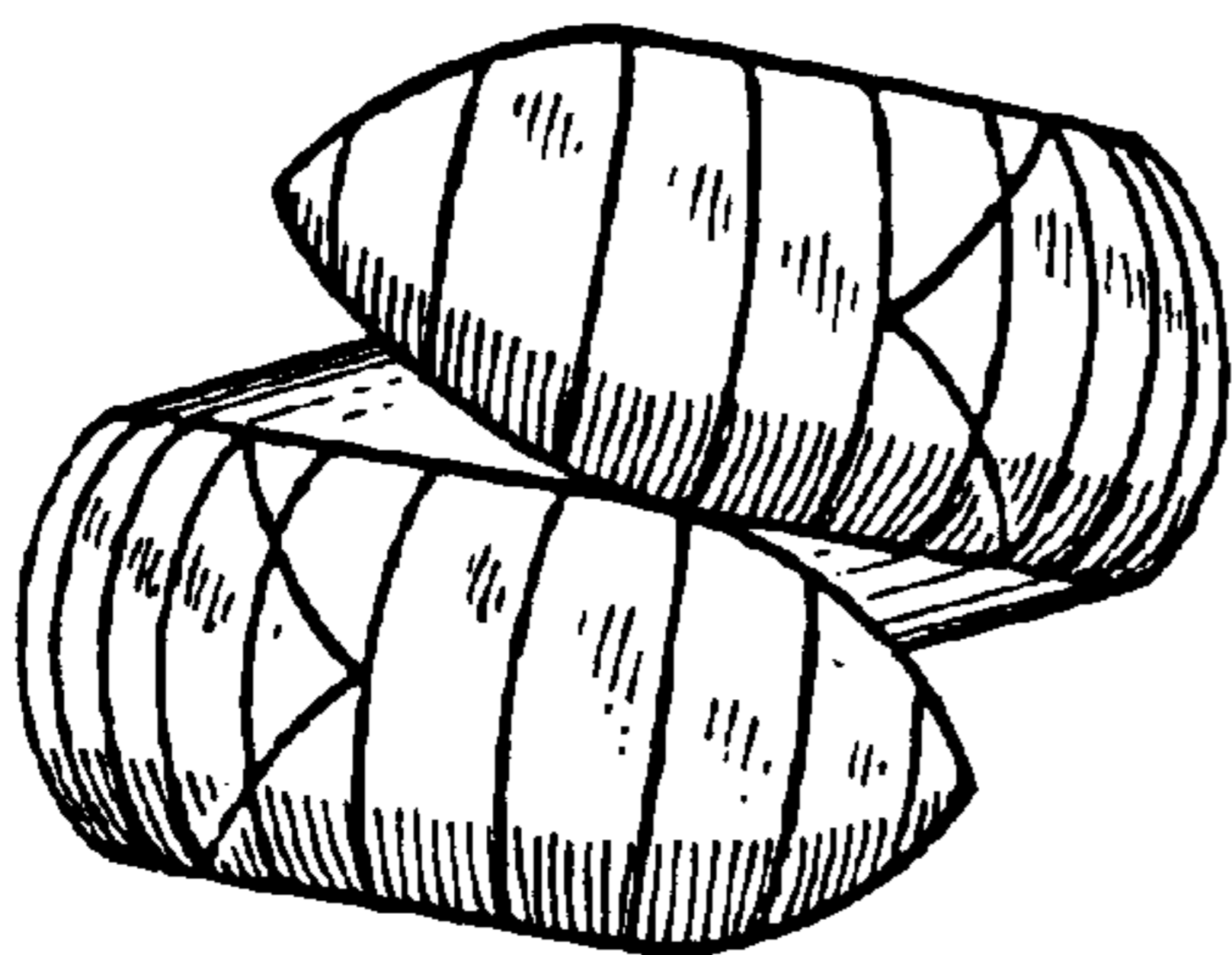
