FIG. 3 is a front view of the vehicle tire;

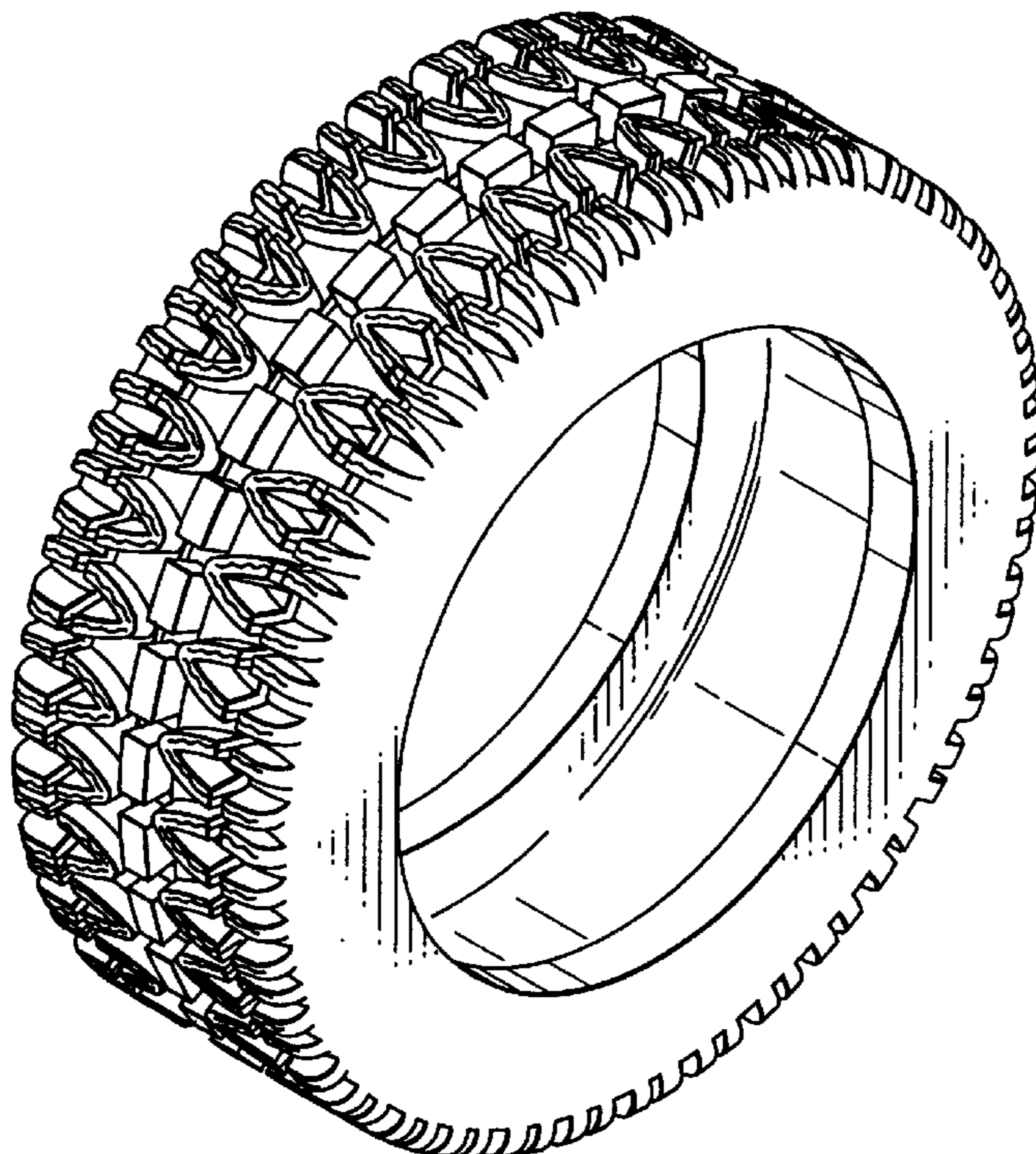
FIG. 4 is a right side view of the vehicle tire;

FIG. 5 is a cross-sectional view of the vehicle tire taken along line 5—5 of FIG. 3;

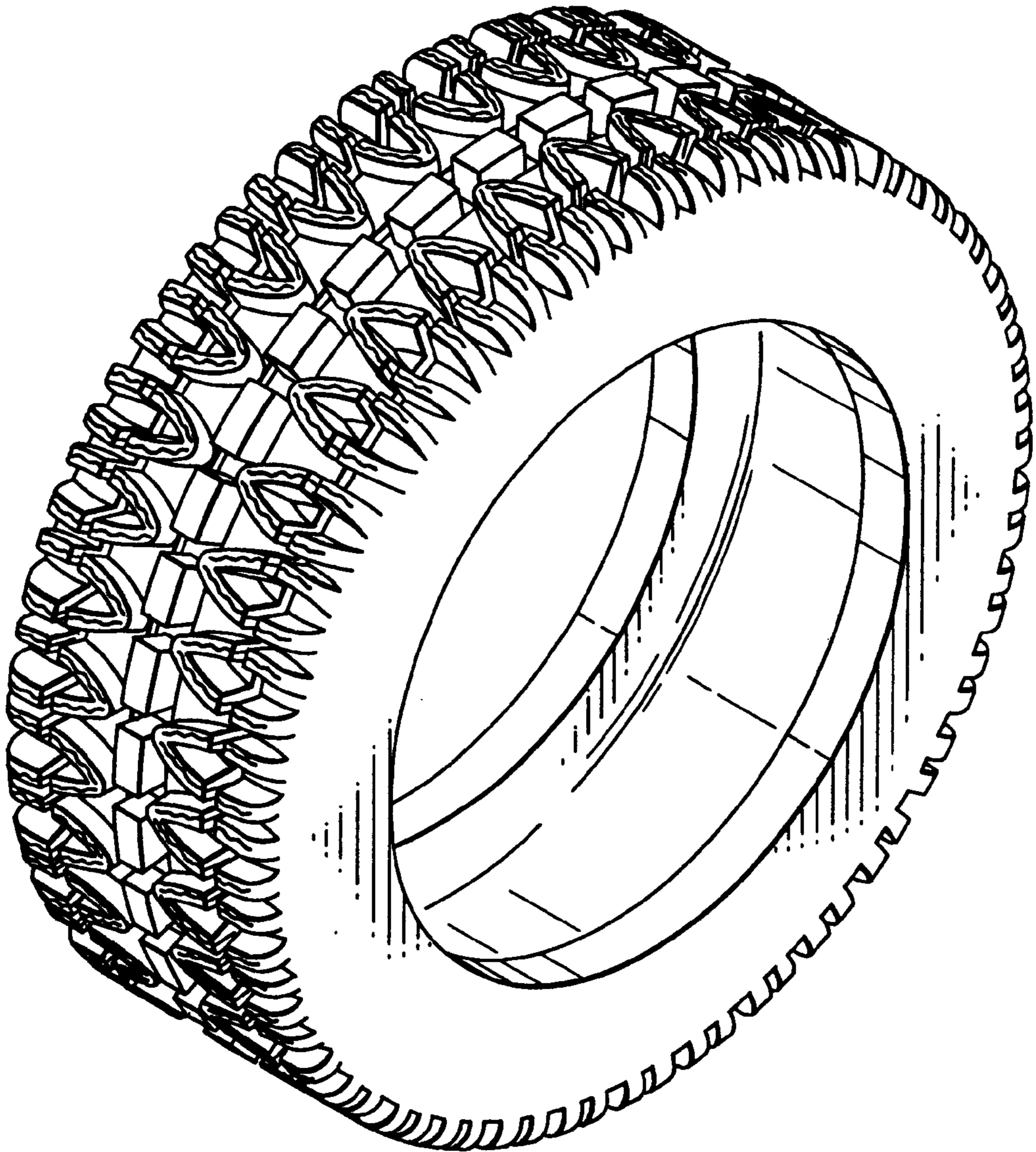
FIG. 6 is a cross-sectional view of the vehicle tire taken along line 6—6 of FIG. 4; and,

FIG. 7 is a cross-sectional view of the vehicle tire taken along line 7—7 of FIG. 4.

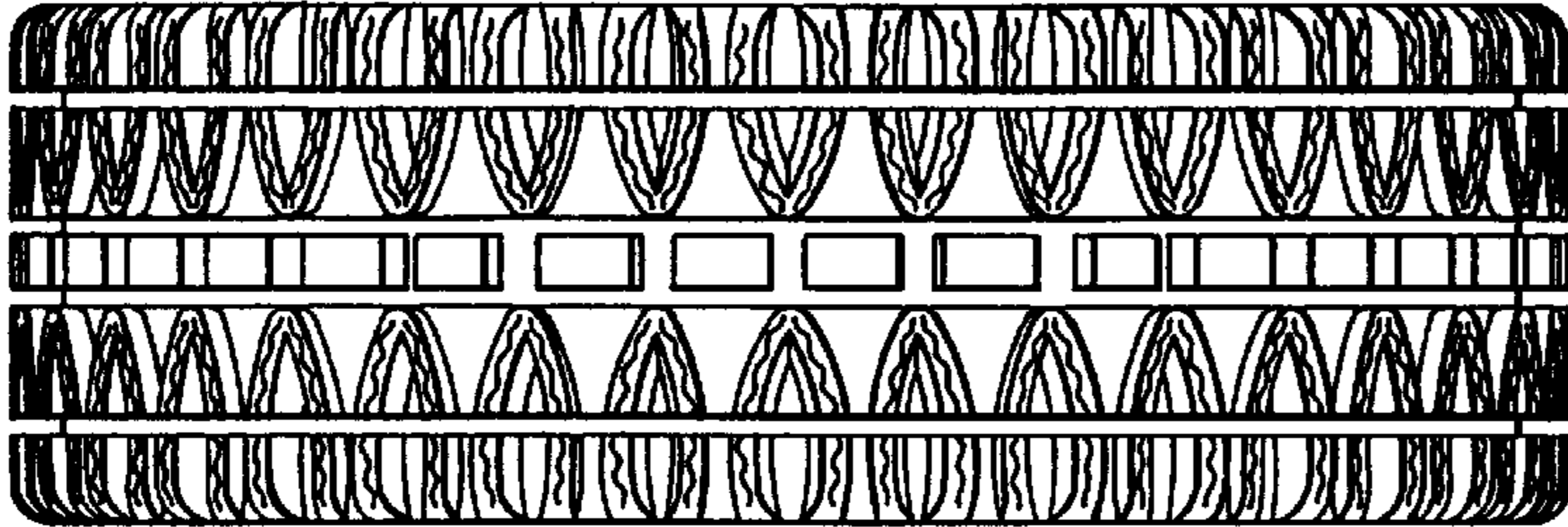

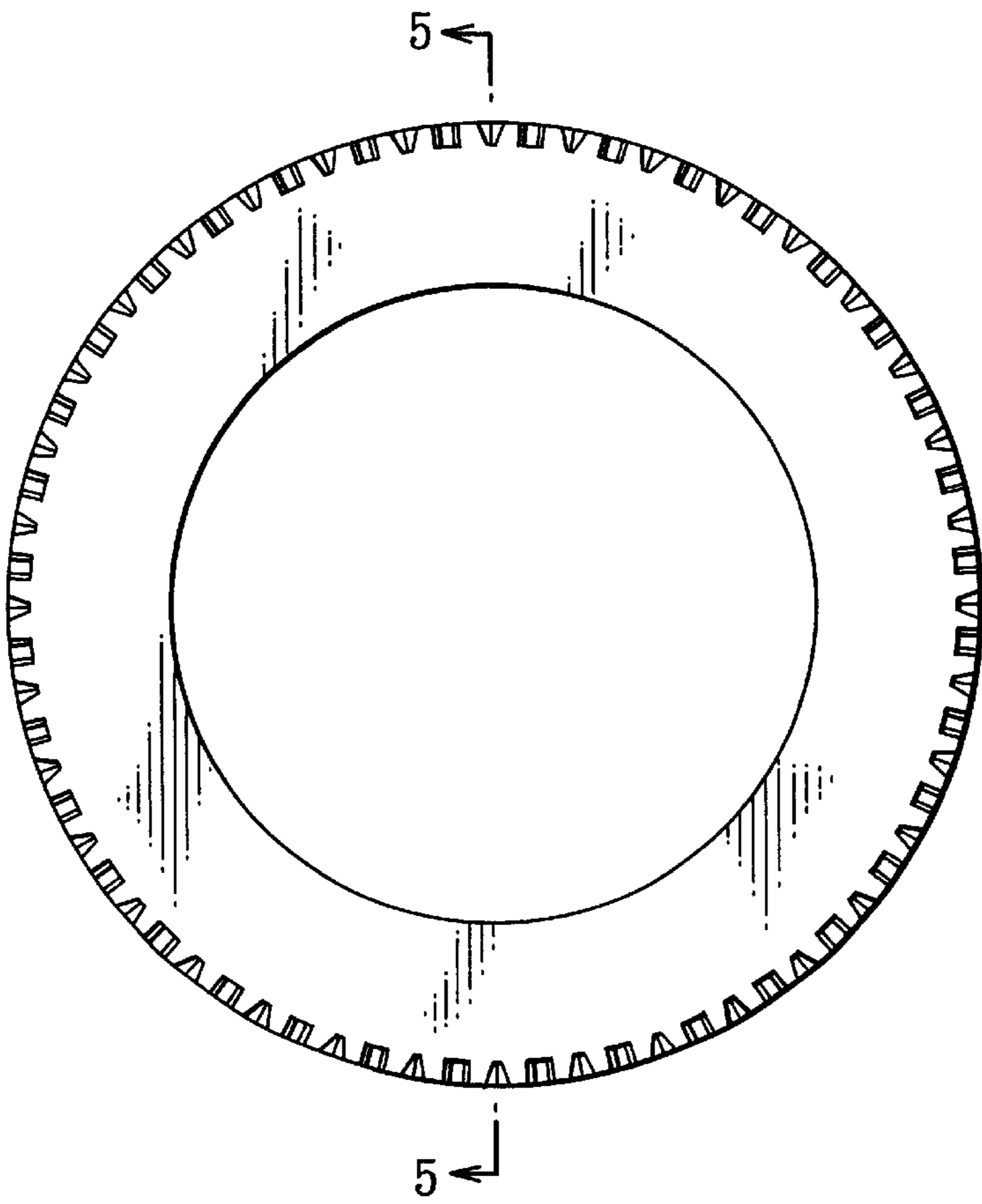

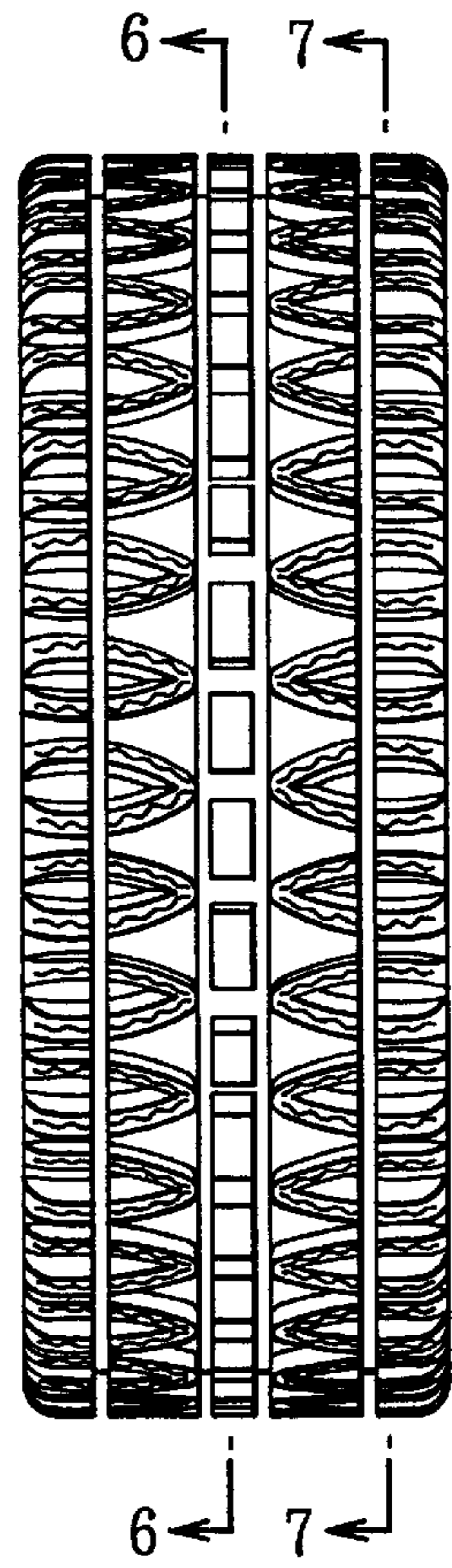

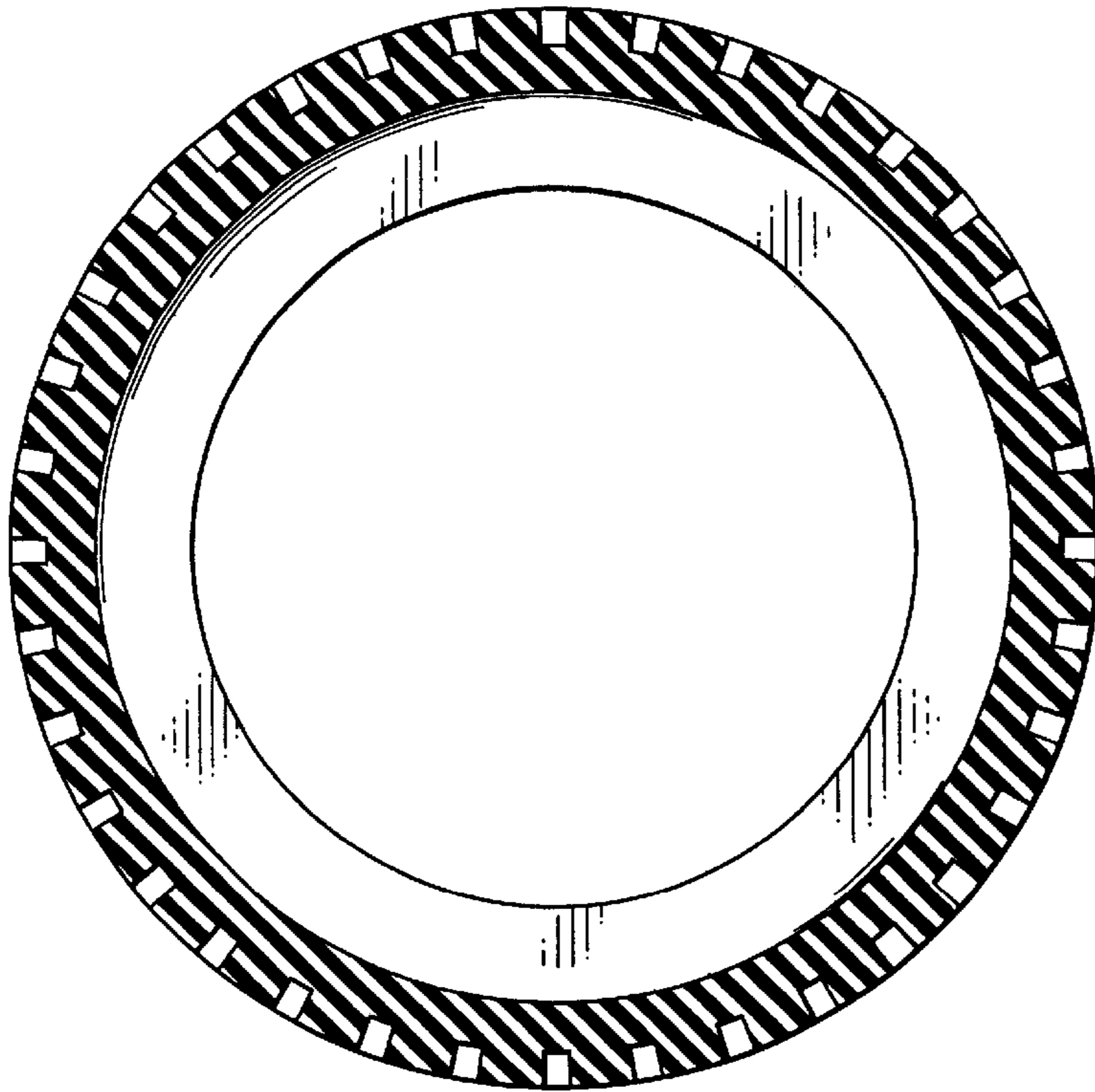

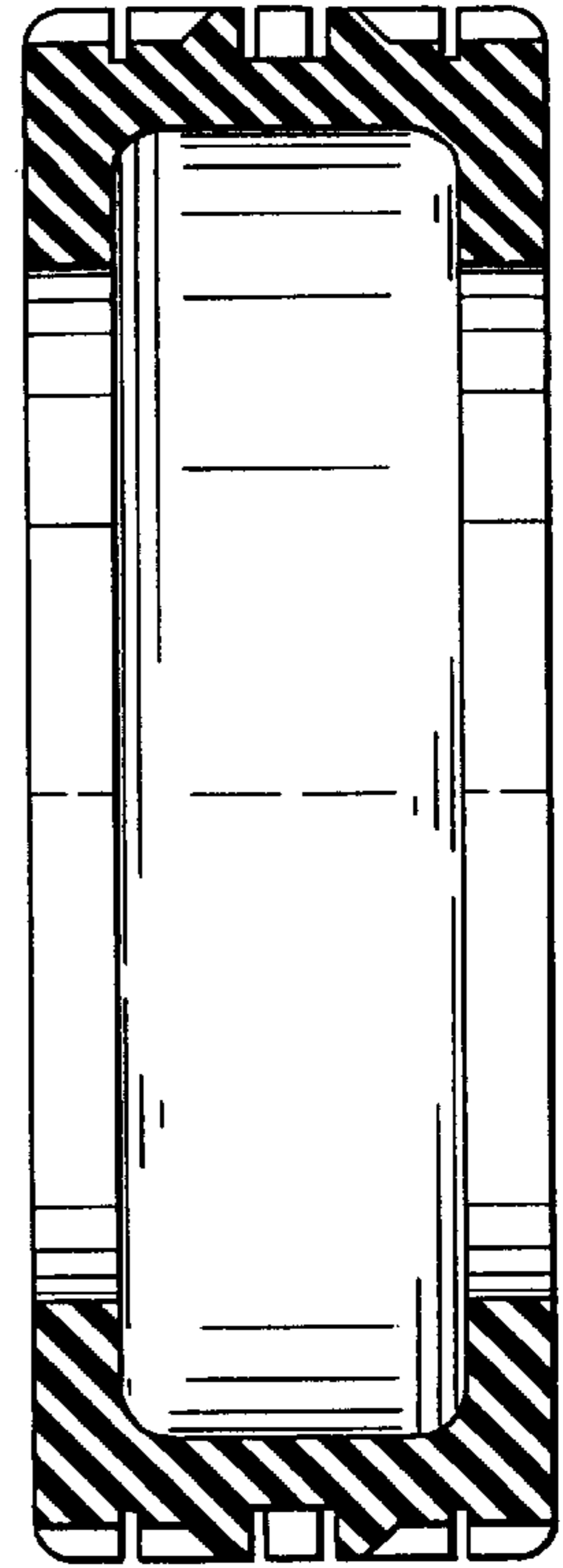
