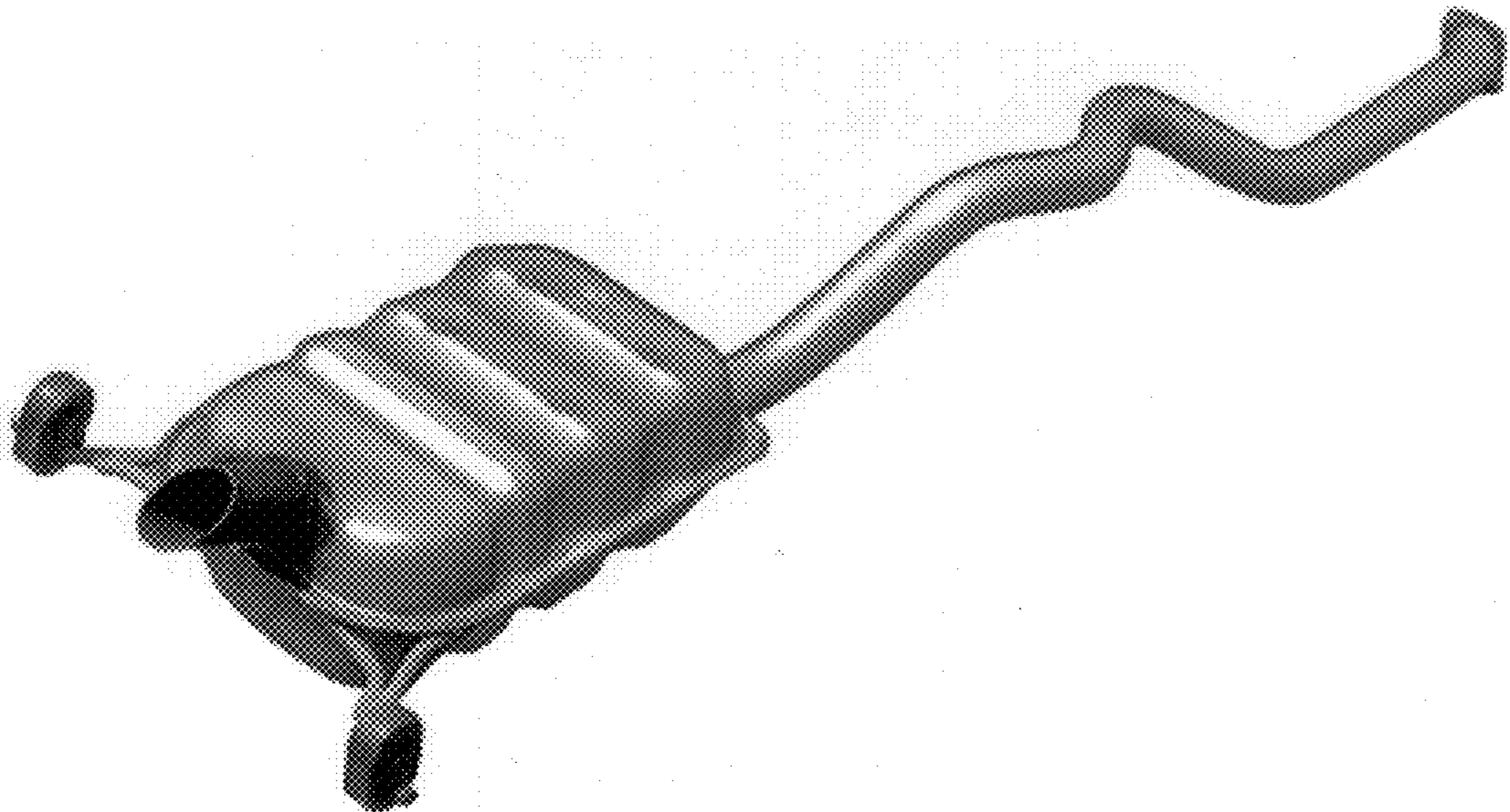
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a muffler for automobile, showing my new design;
 FIG. 2 is a left side plan view of the muffler;

 FIG. 4 is a front elevation view of the muffler;
 FIG. 5 is a back elevation view of the muffler;

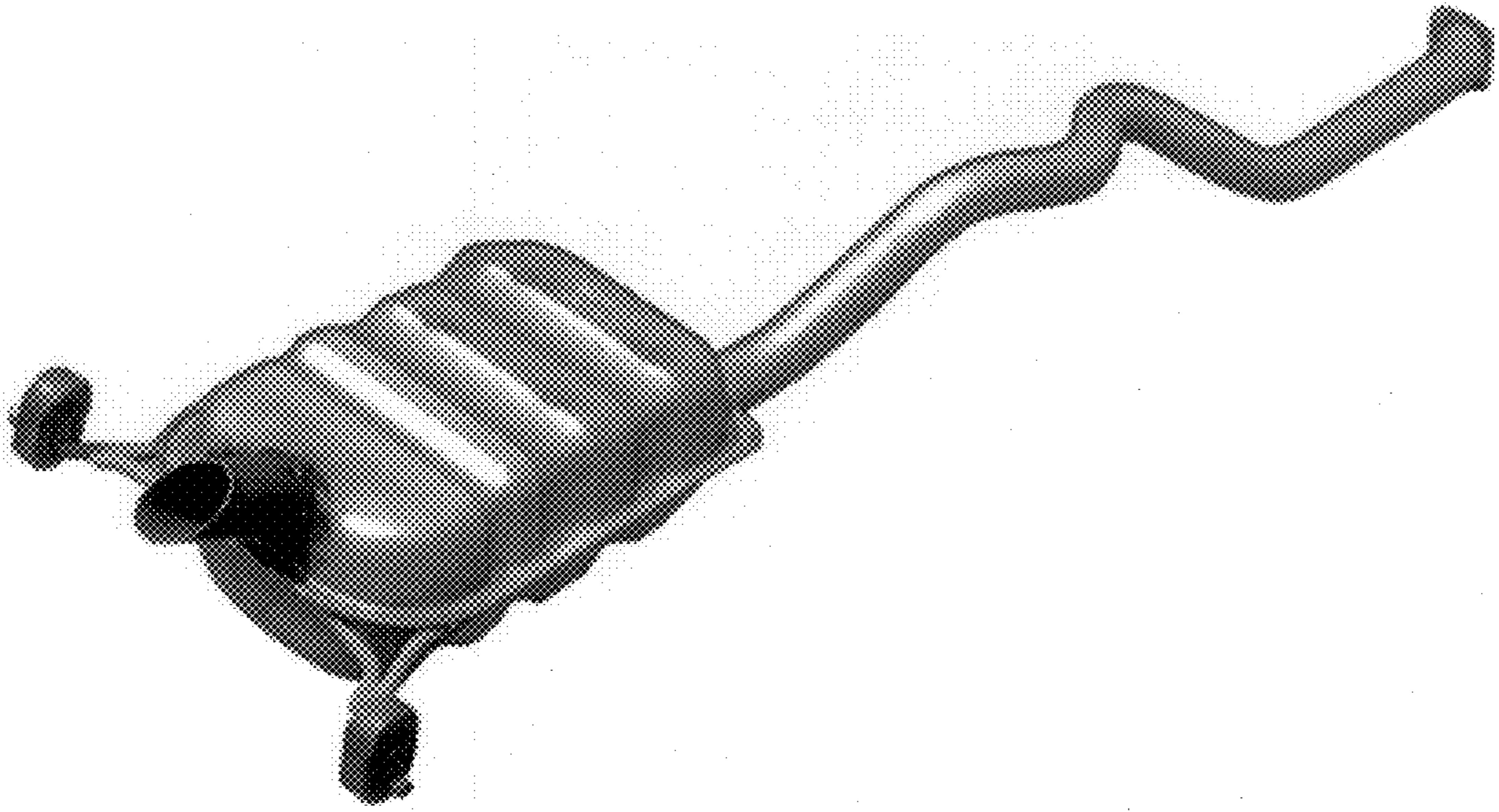

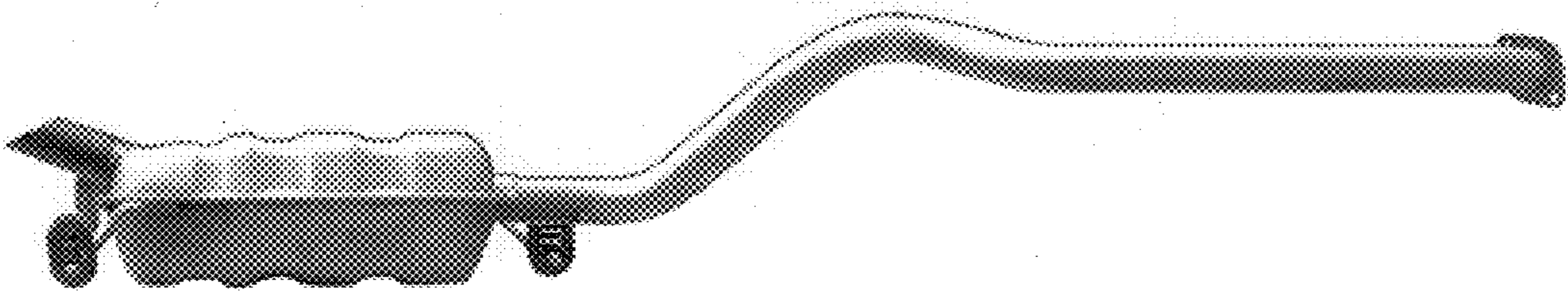

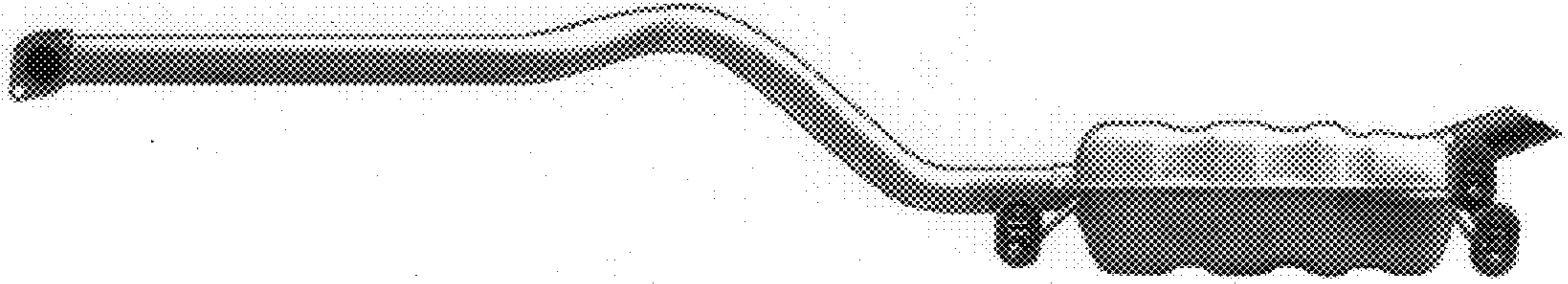

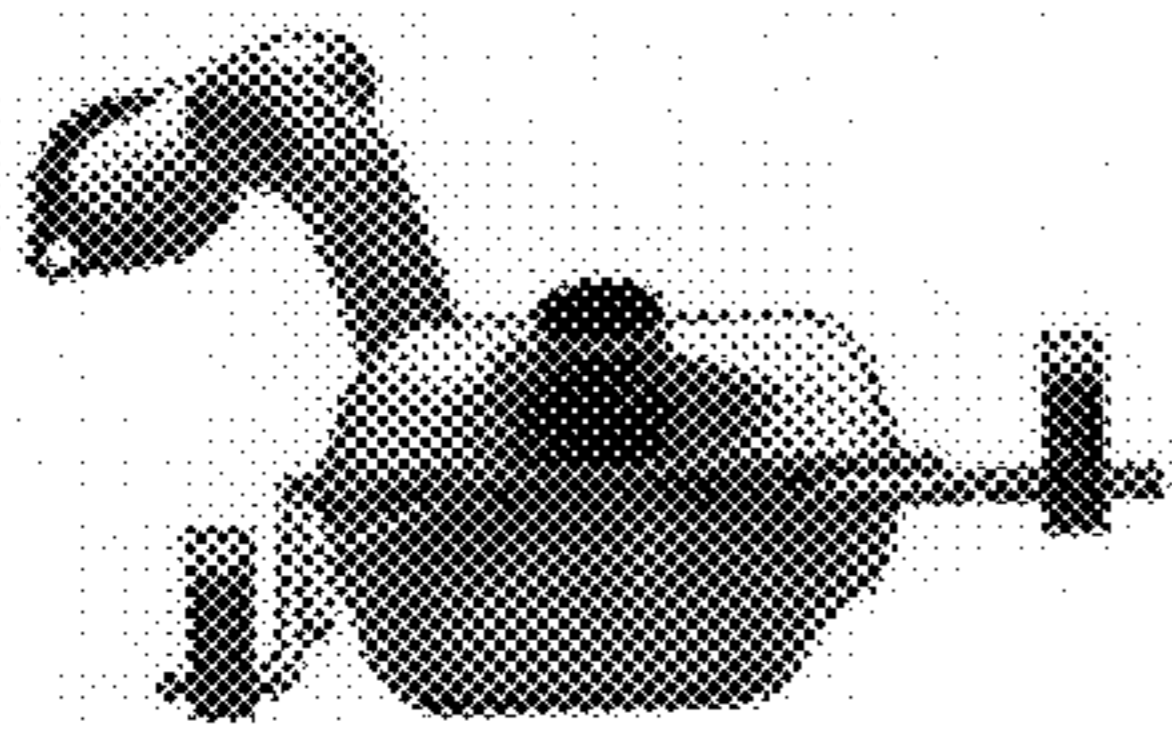

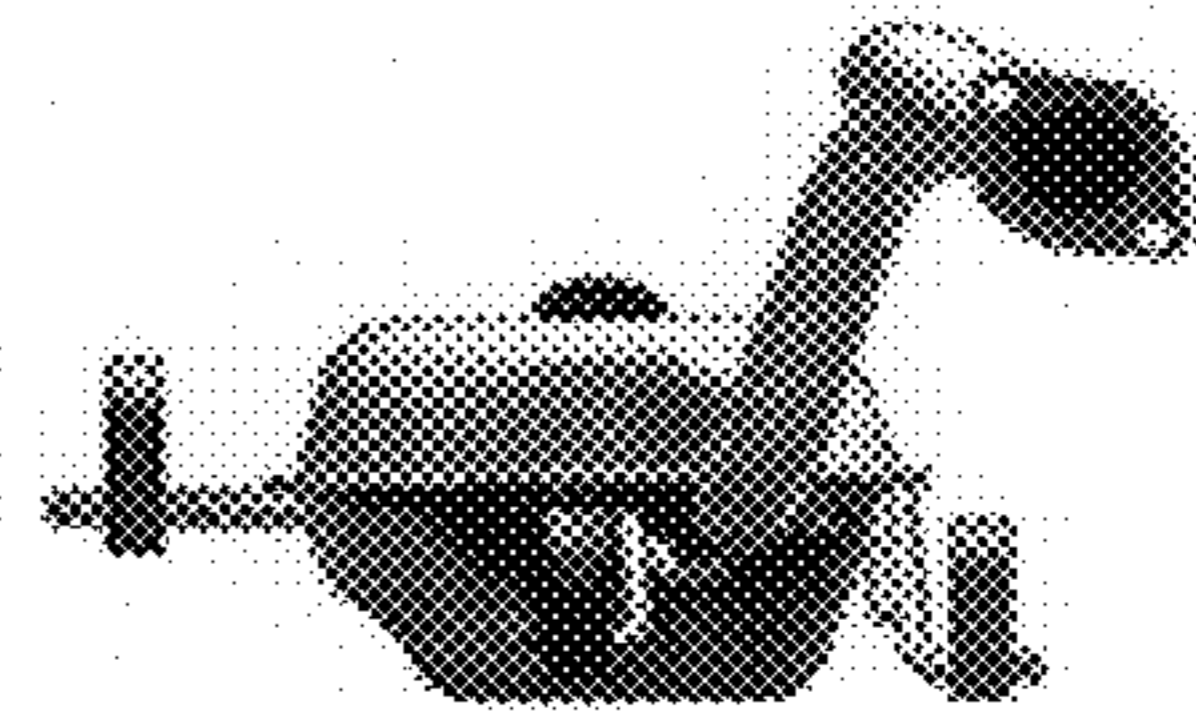

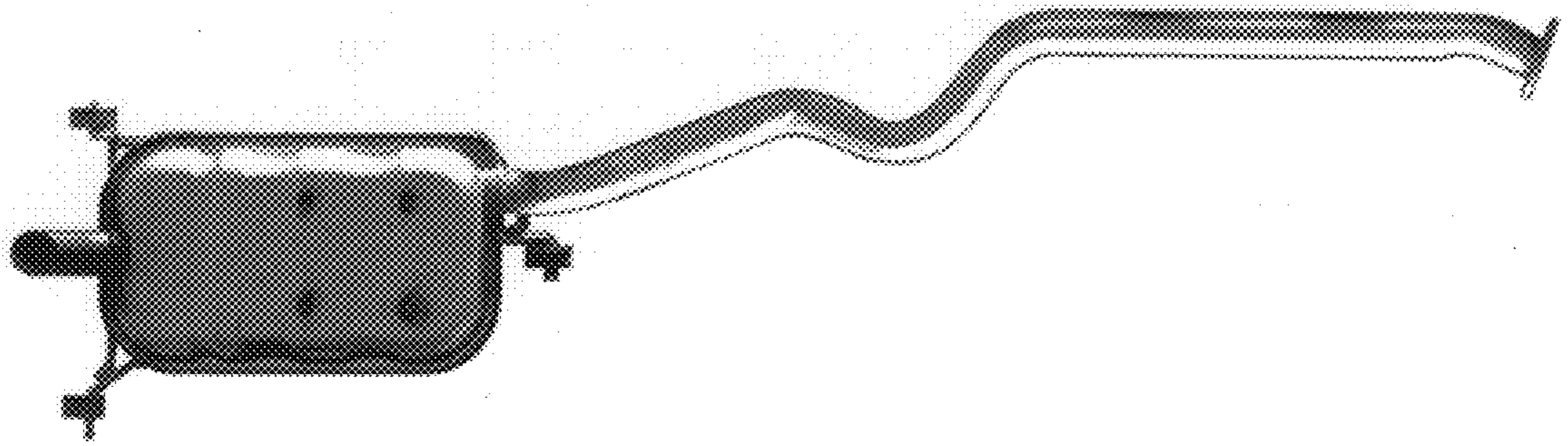

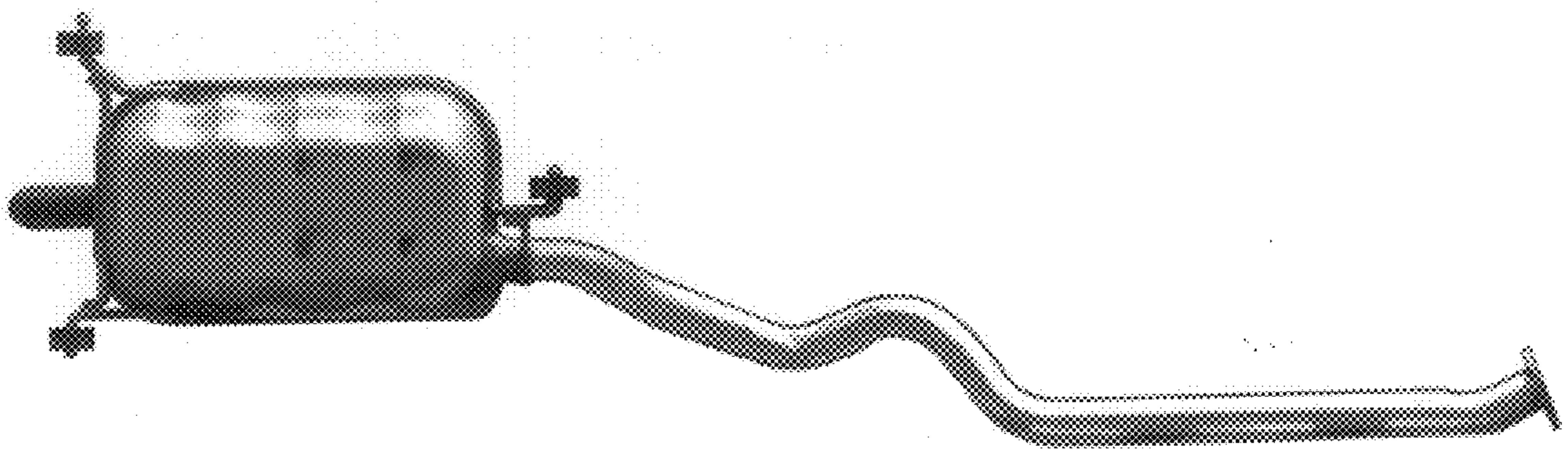
