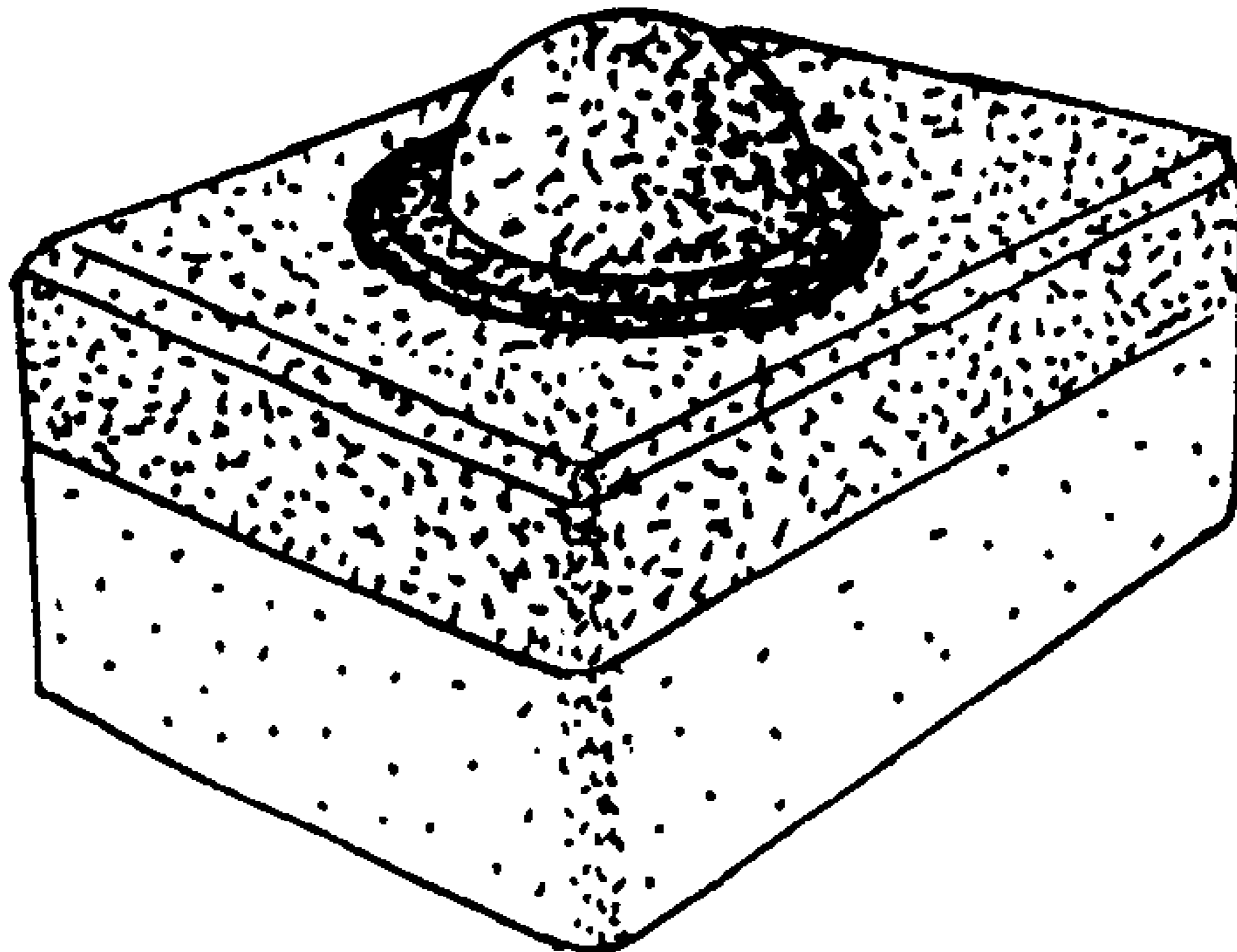
(57) **CLAIM**

The ornamental design for a detergent tablet, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a detergent tablet showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a side elevational view thereof the side opposite appearing the same as the side shown;
 FIG. 4 is an end elevational view thereof the end opposite appearing the same as the end shown; and,
 FIG. 5 is a bottom view thereof.

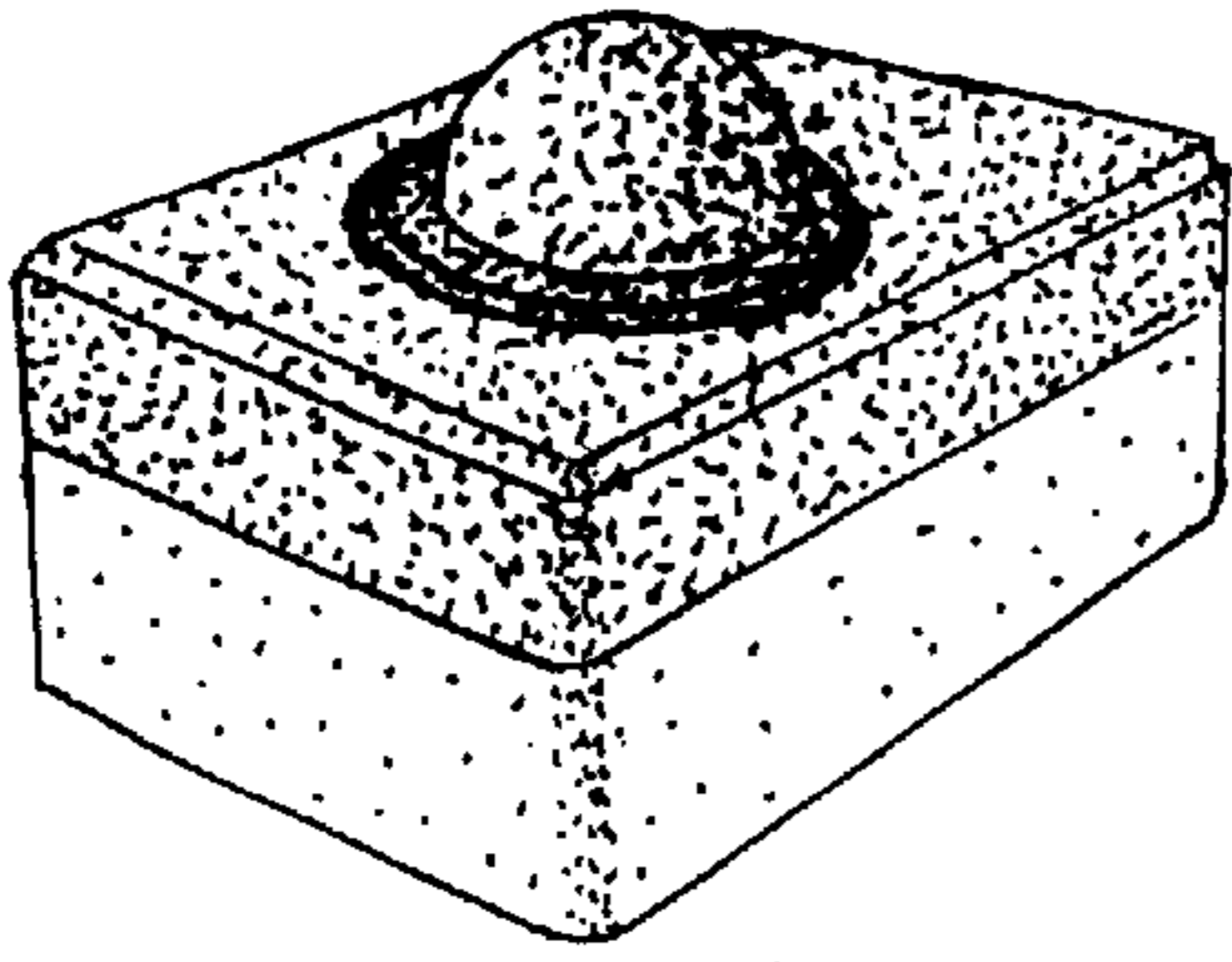

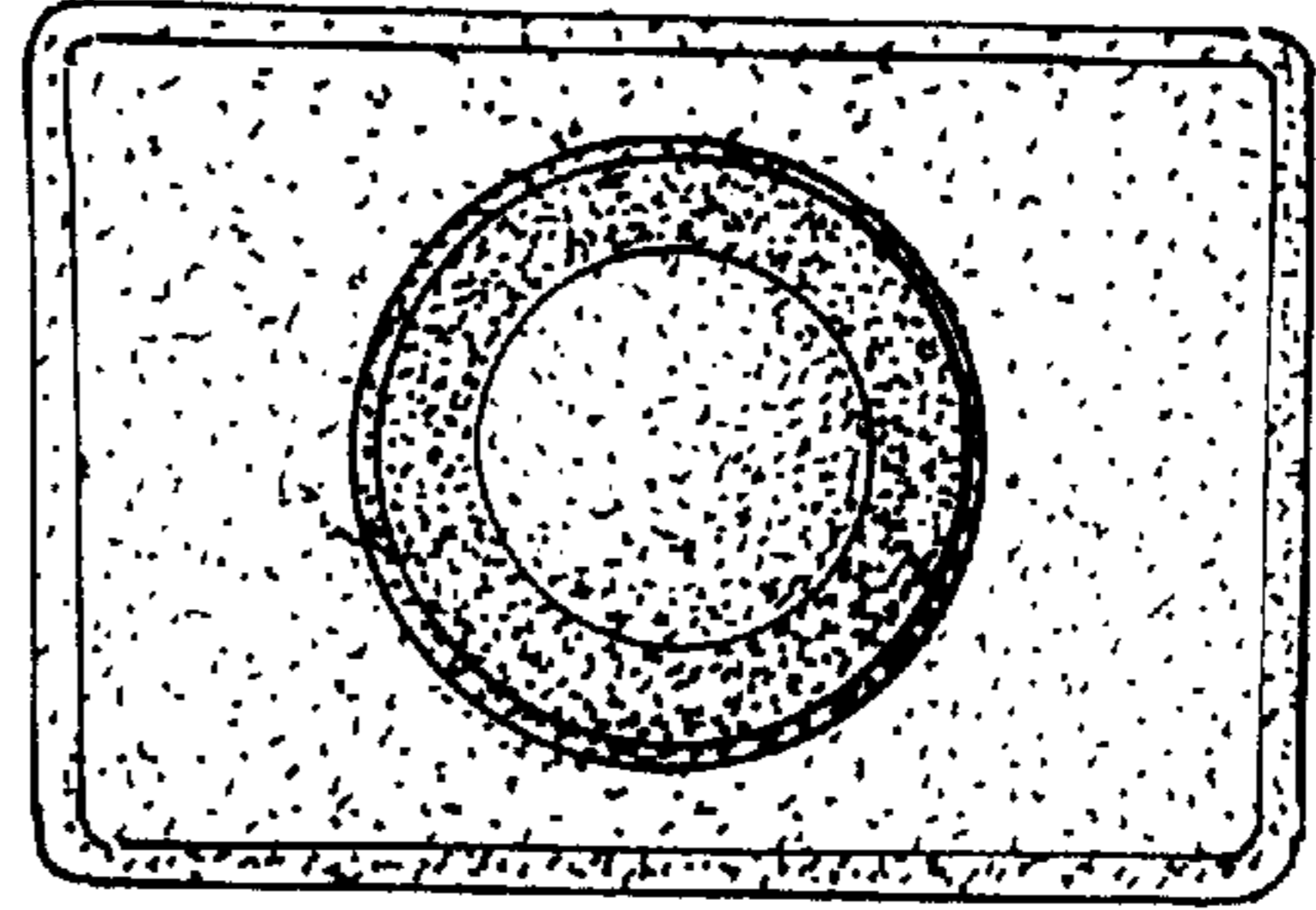

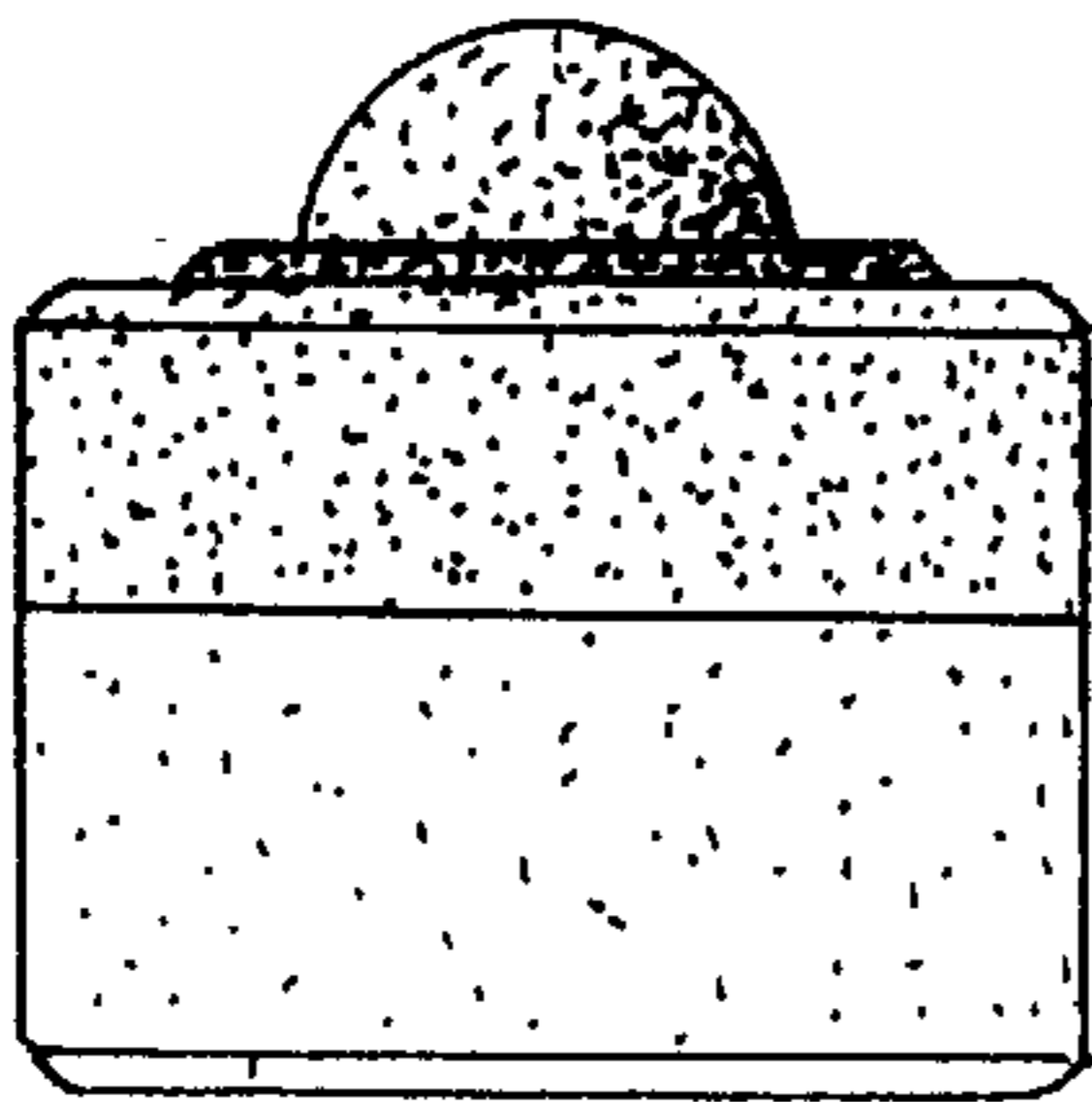

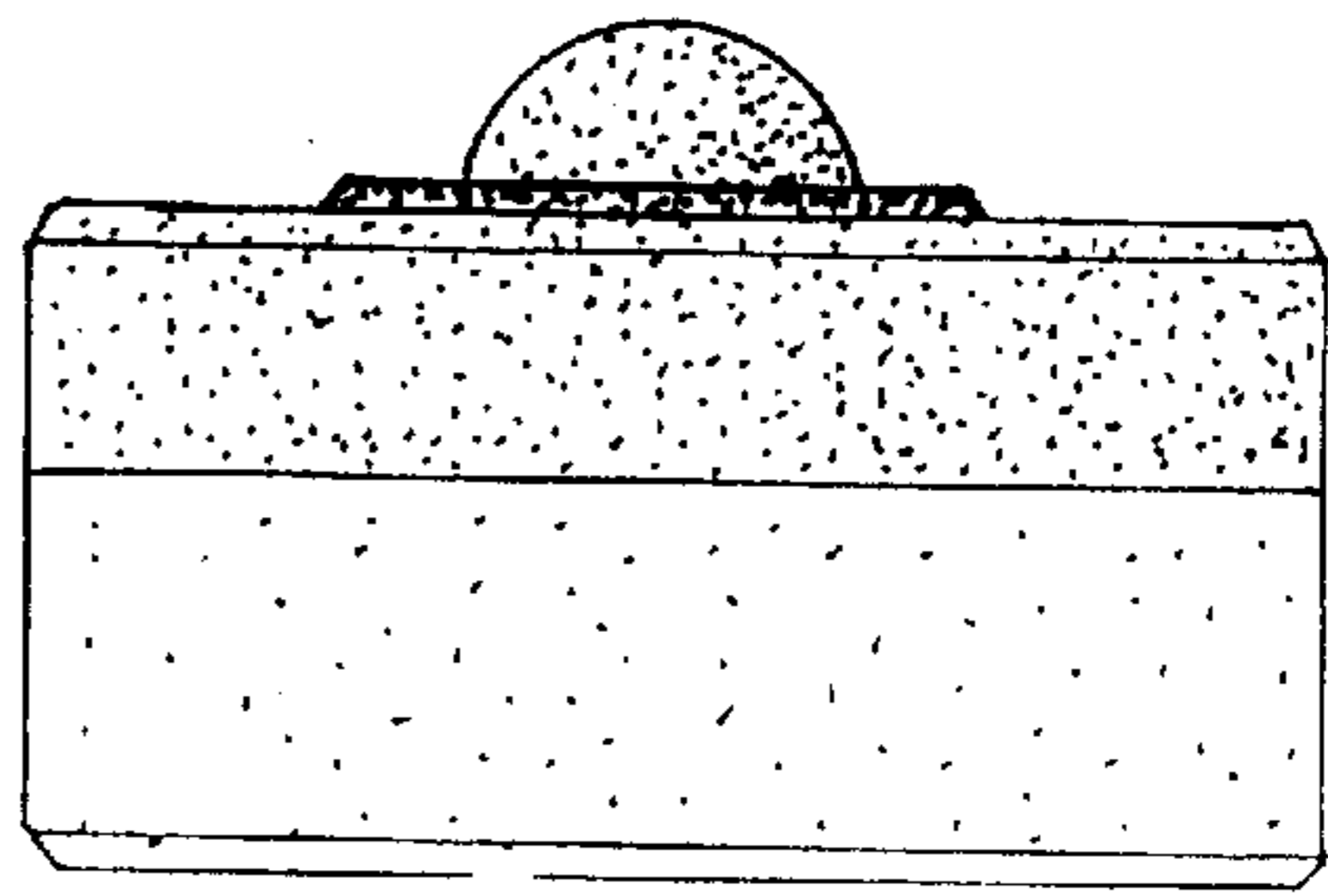

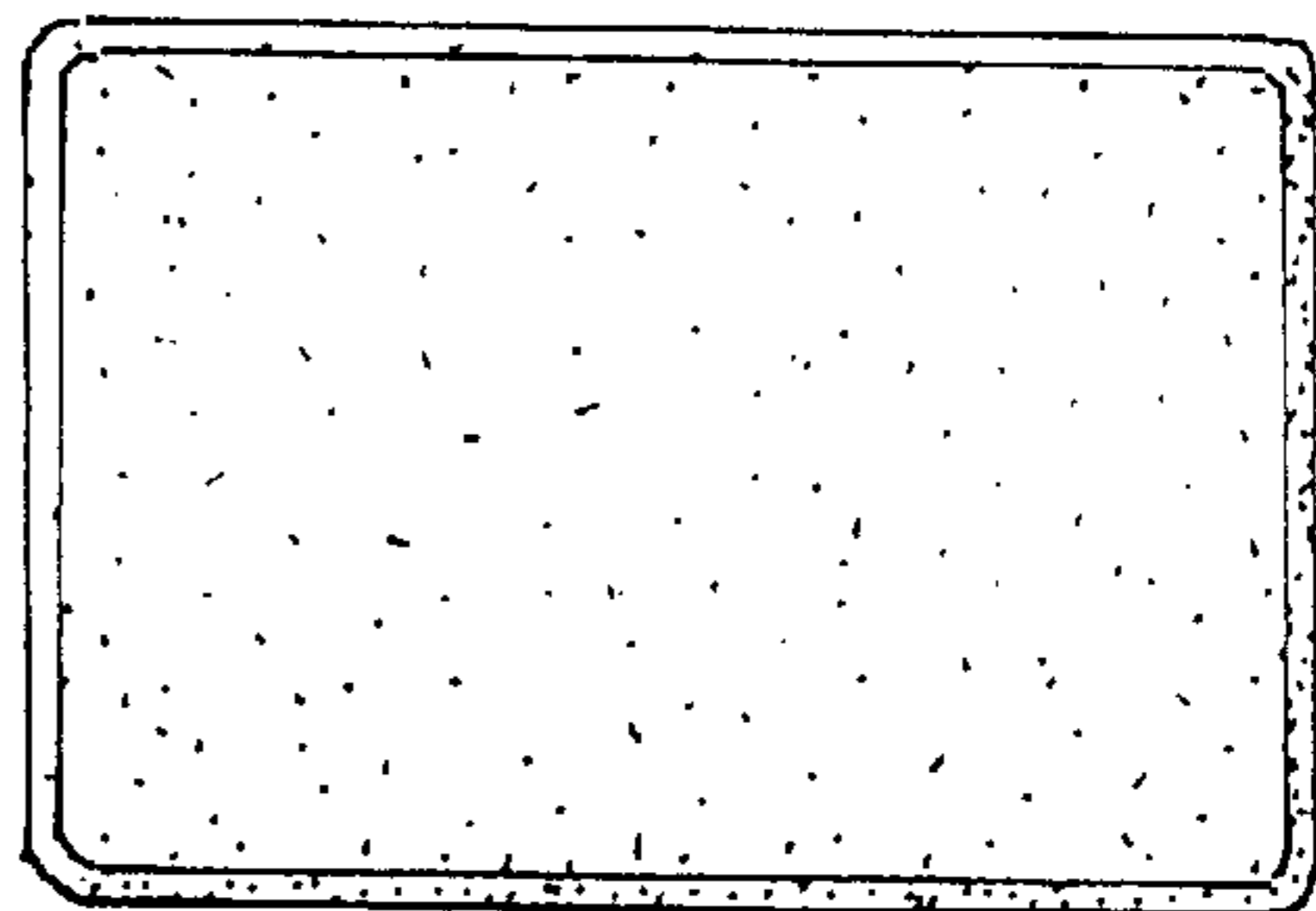
