(57) **CLAIM**

The ornamental design for a razor handle, as shown and described.

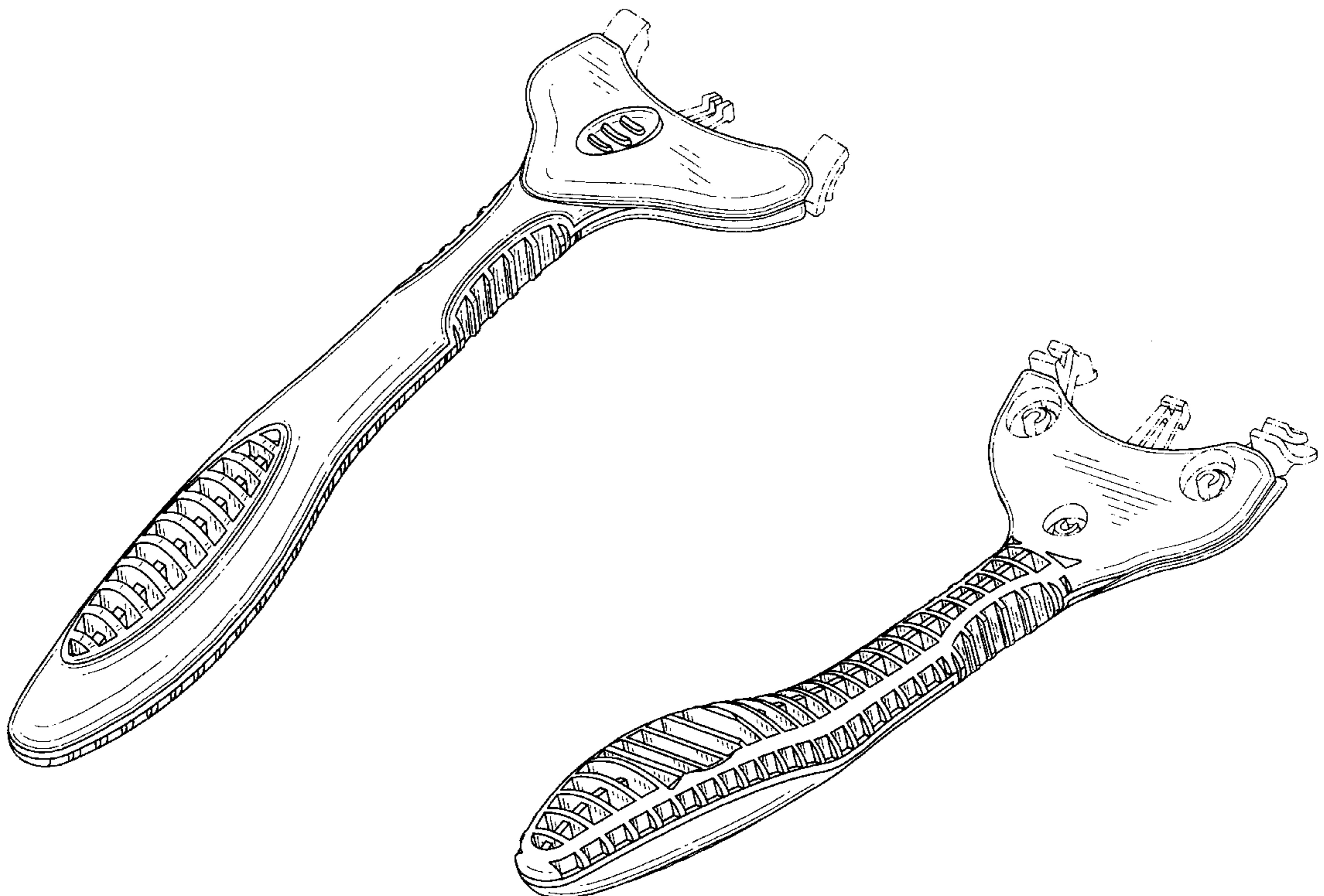
DESCRIPTION

FIG. 1 is a top perspective view of the razor handle; FIG. 2 is a bottom perspective view of the razor handle; FIG. 3 is a front end view of the razor handle; FIG. 4 is a rear end view of the razor handle; FIG. 5 is a top view of the razor handle; FIG. 6 is a side view of the razor handle the side opposite being a mirror image of the side shown; and, FIG. 7 is a bottom view of the razor handle.

The broken lines showing portions of the razor are for illustrative purposes only and form no part of the claimed design; and the broken circular outlines defining the bounds of the claim on the bottom surface form no part thereof.

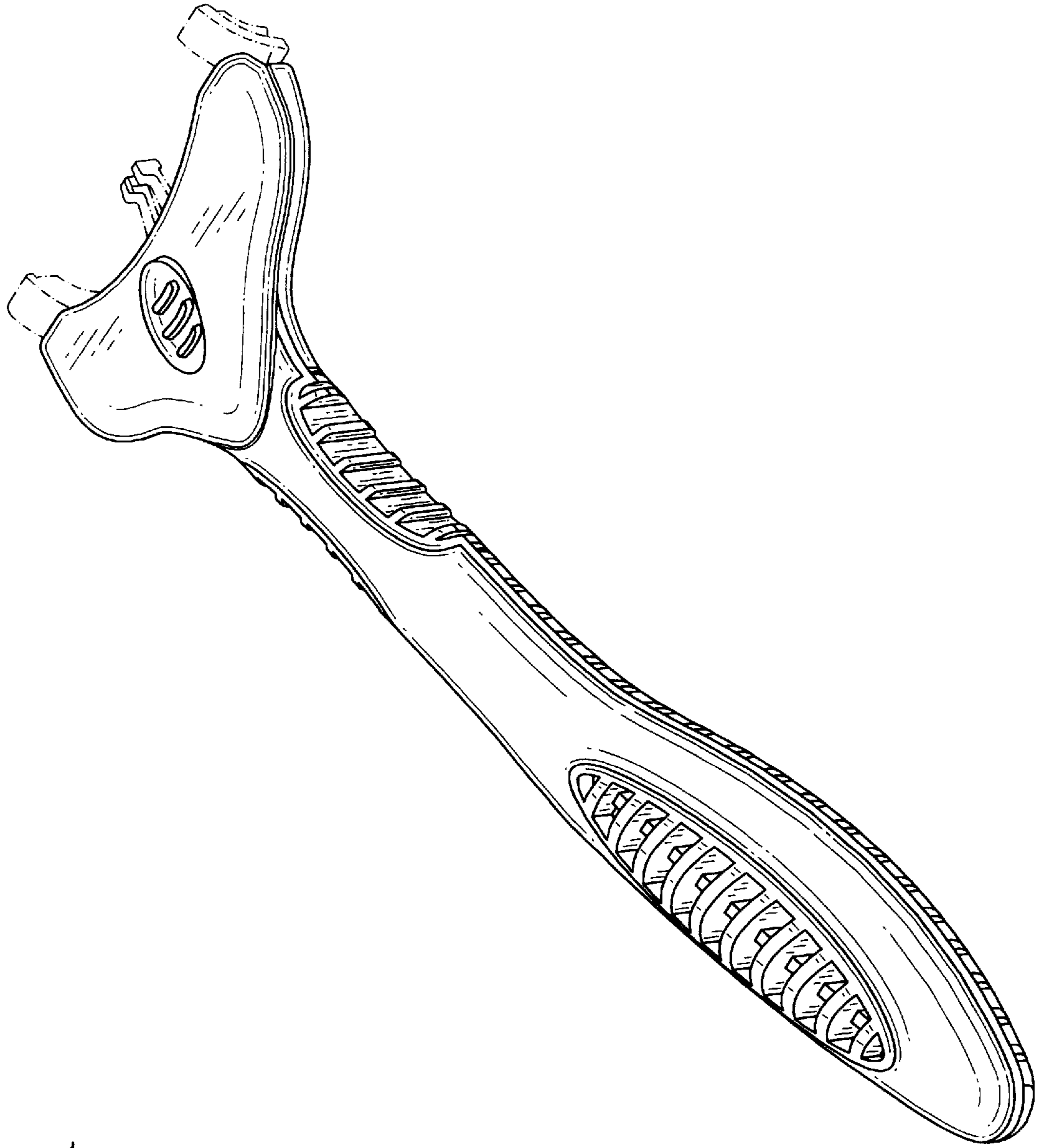

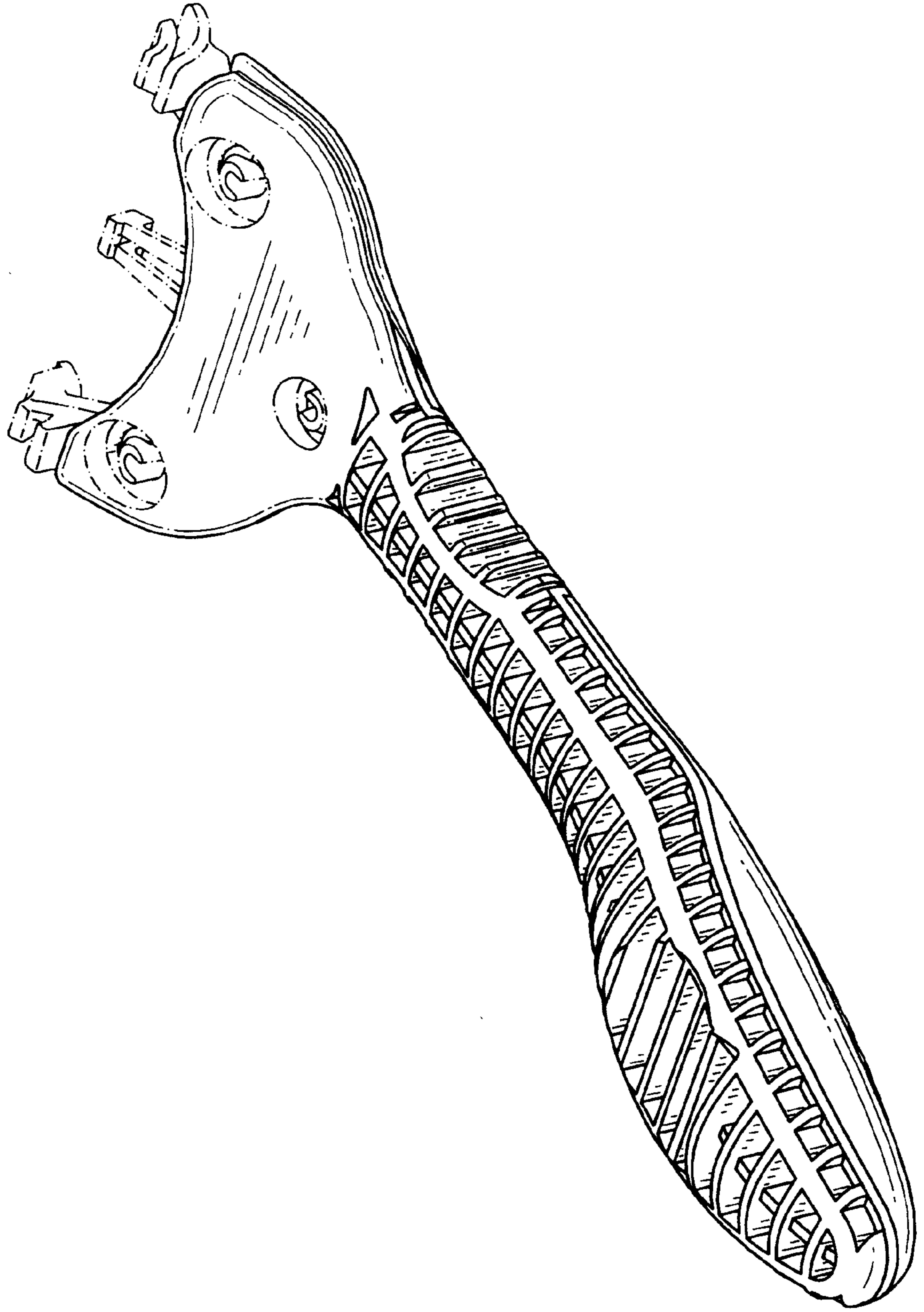

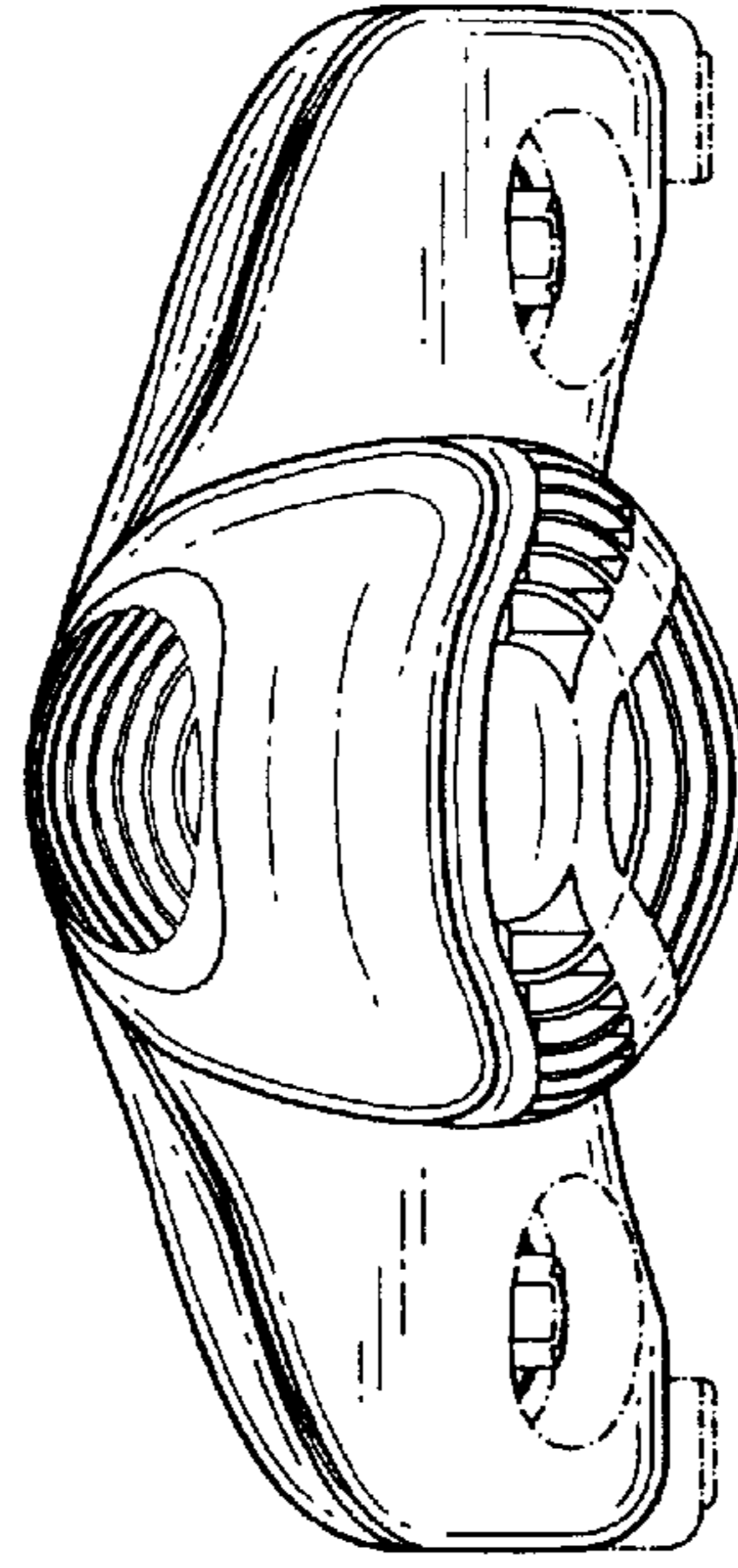
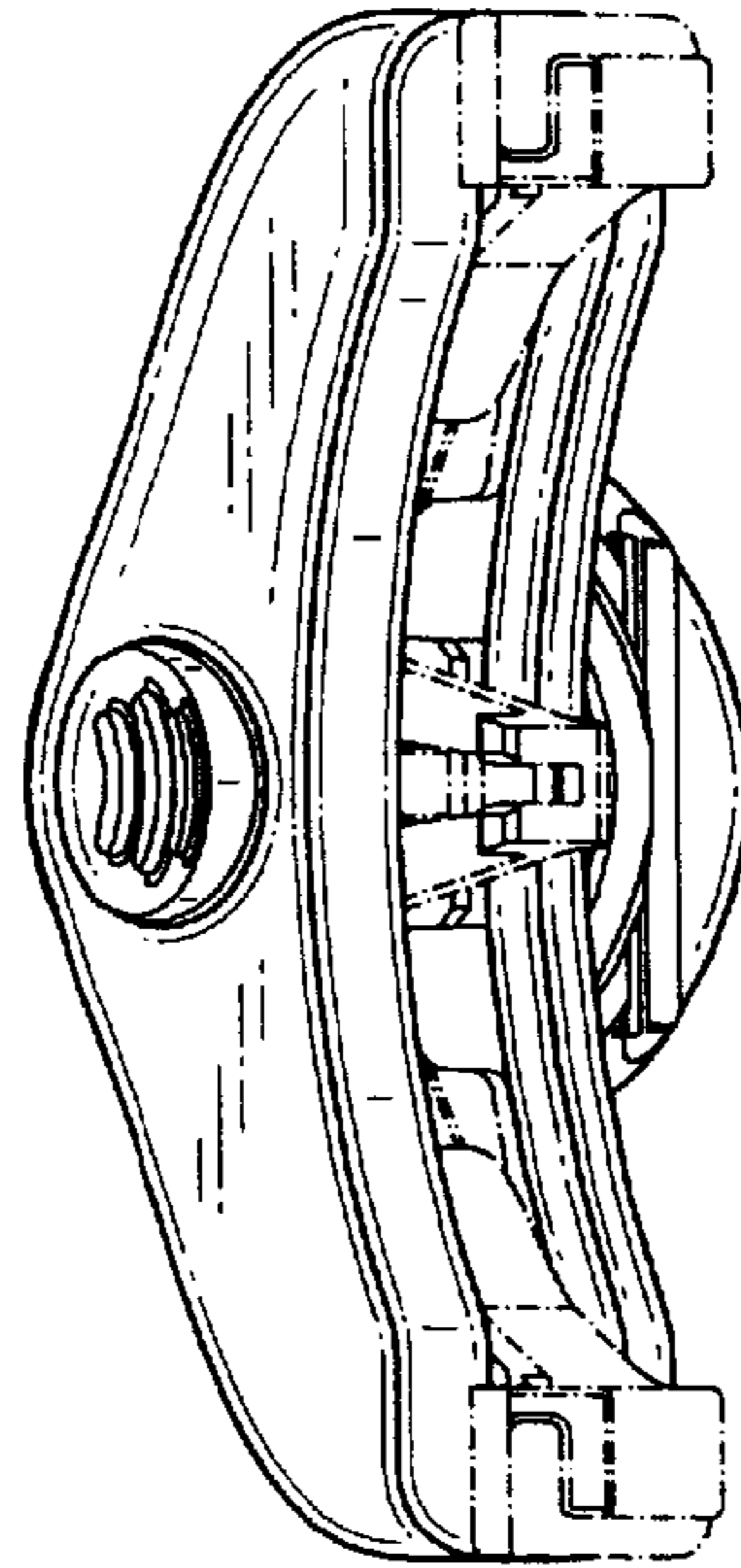

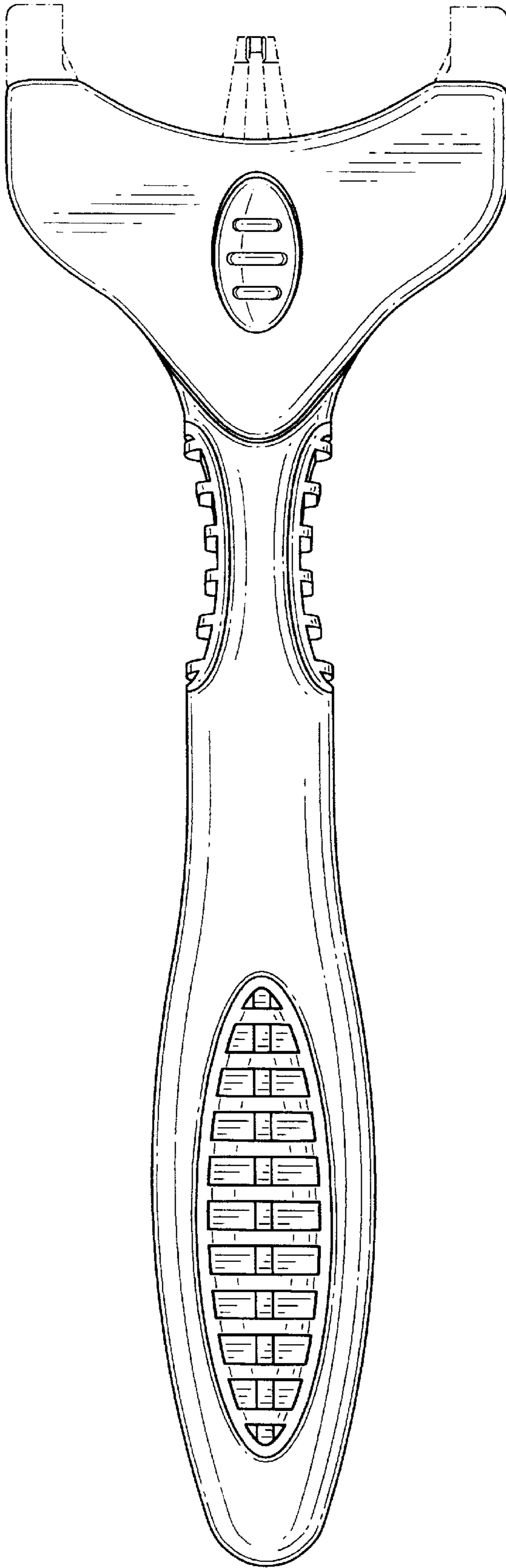
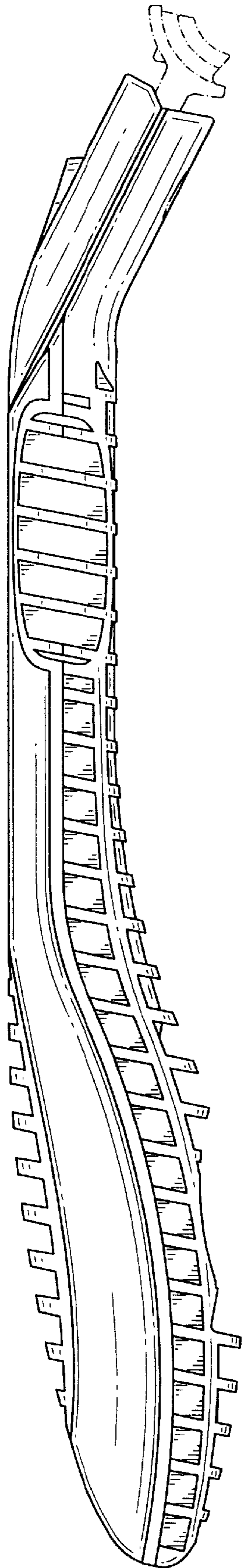

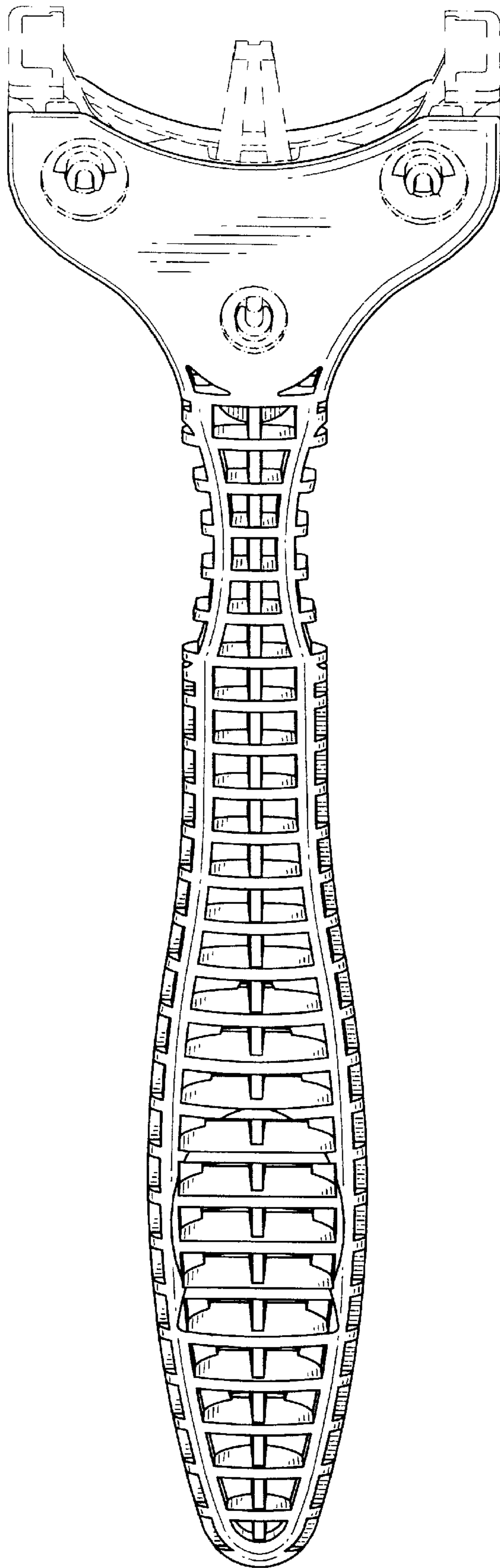
