garments of FIG. 1;

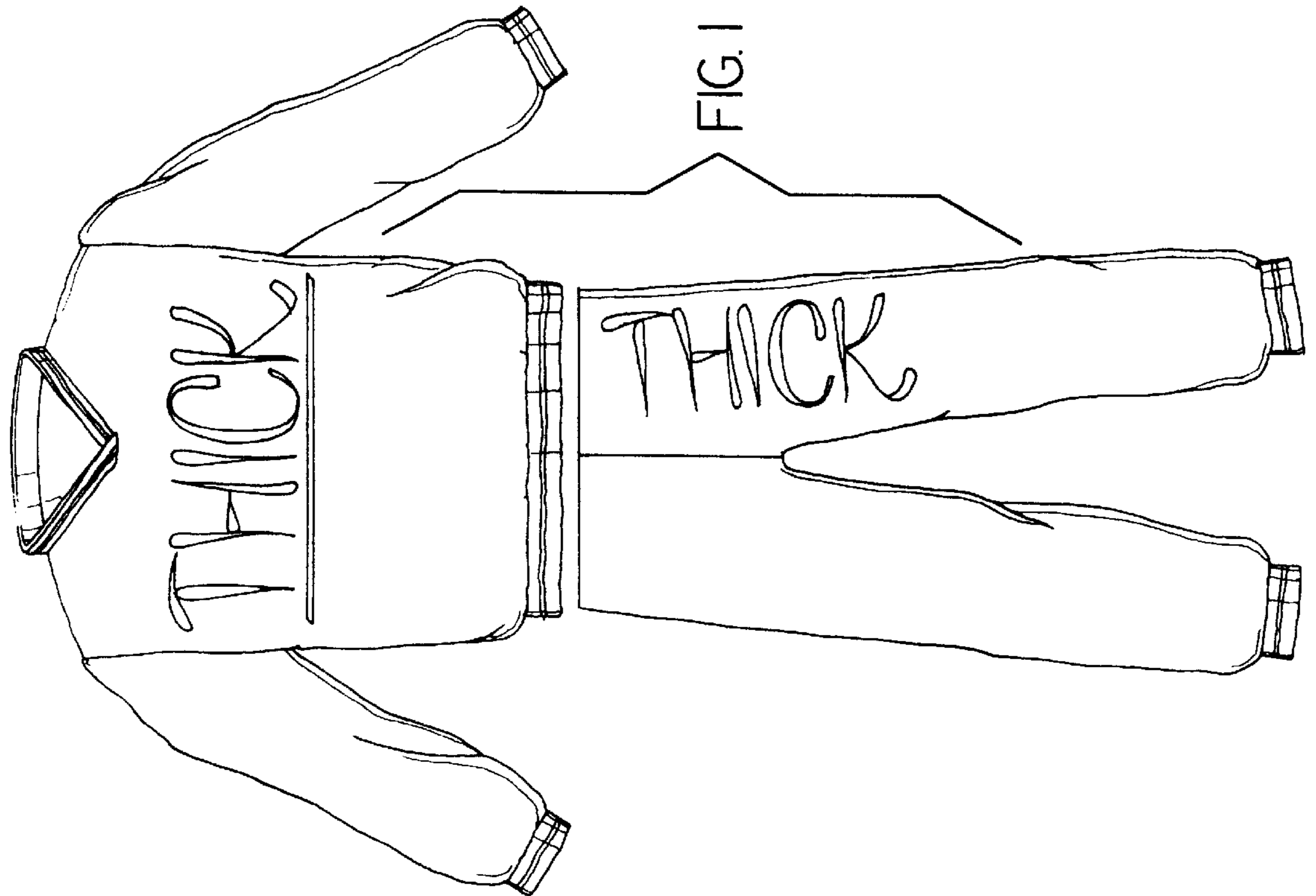
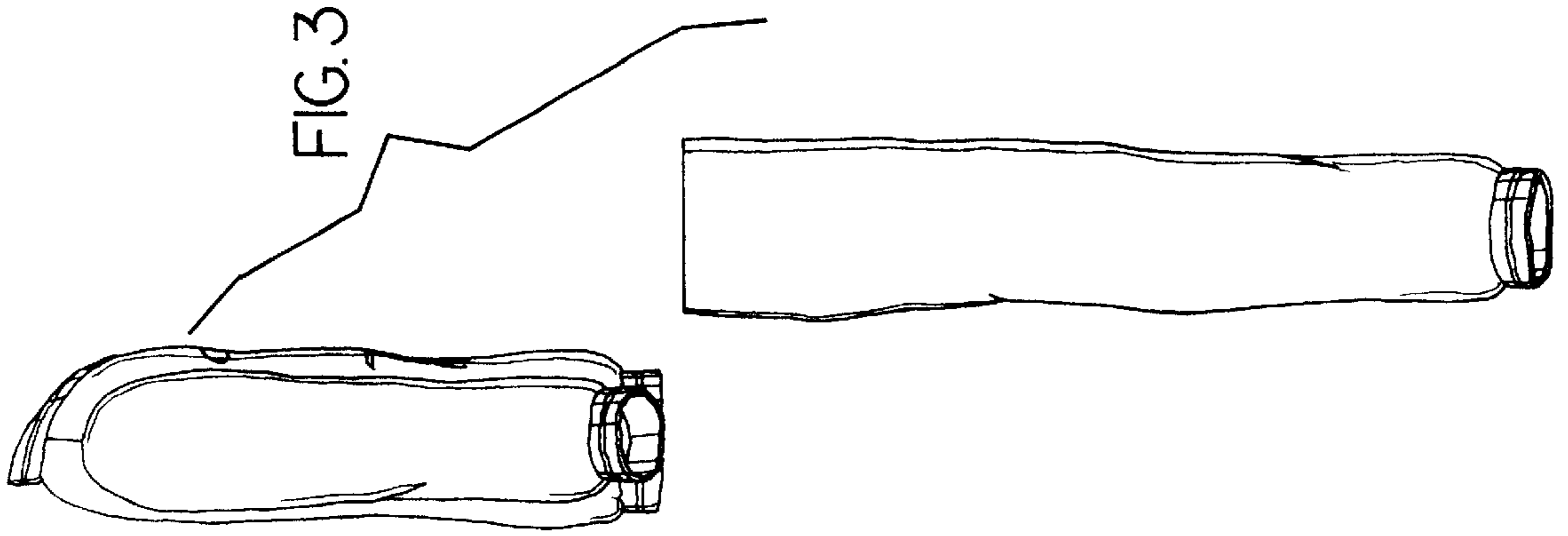
FIG. 4 is a right side elevational view of the insulated

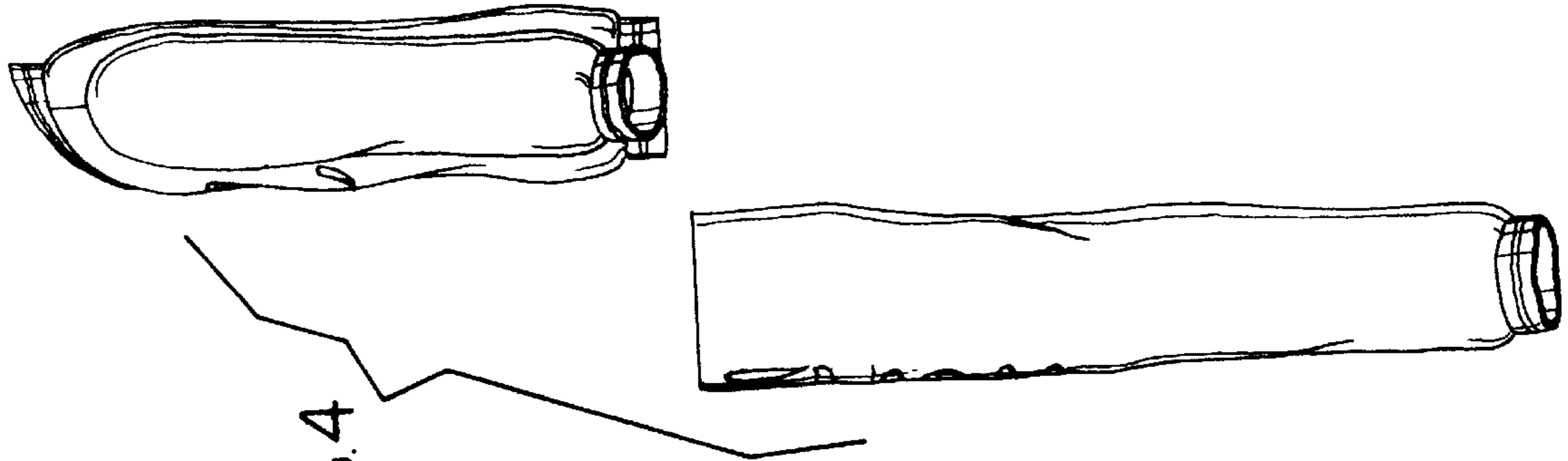

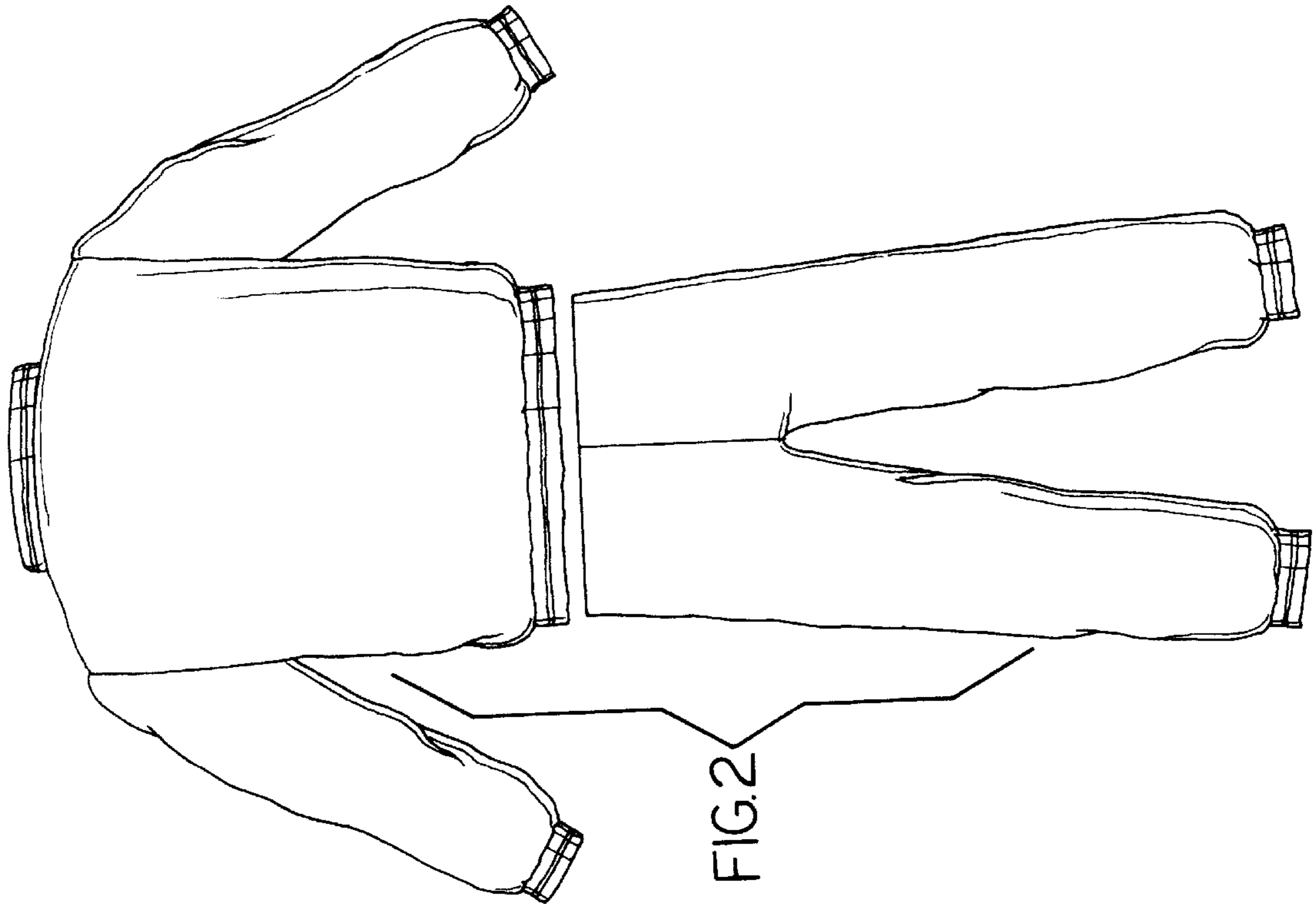
