(57) **CLAIM**

The ornamental design for a portion of a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a portion of a shoe sole showing our new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is perspective view thereof;

FIG. 7 is a bottom plan view of a portion of a shoe sole showing an alternate embodiment of our new design;

FIG. 8 is a left side elevational view thereof;

FIG. 9 is a right side elevational view thereof;

FIG. 10 is a front elevational view thereof;

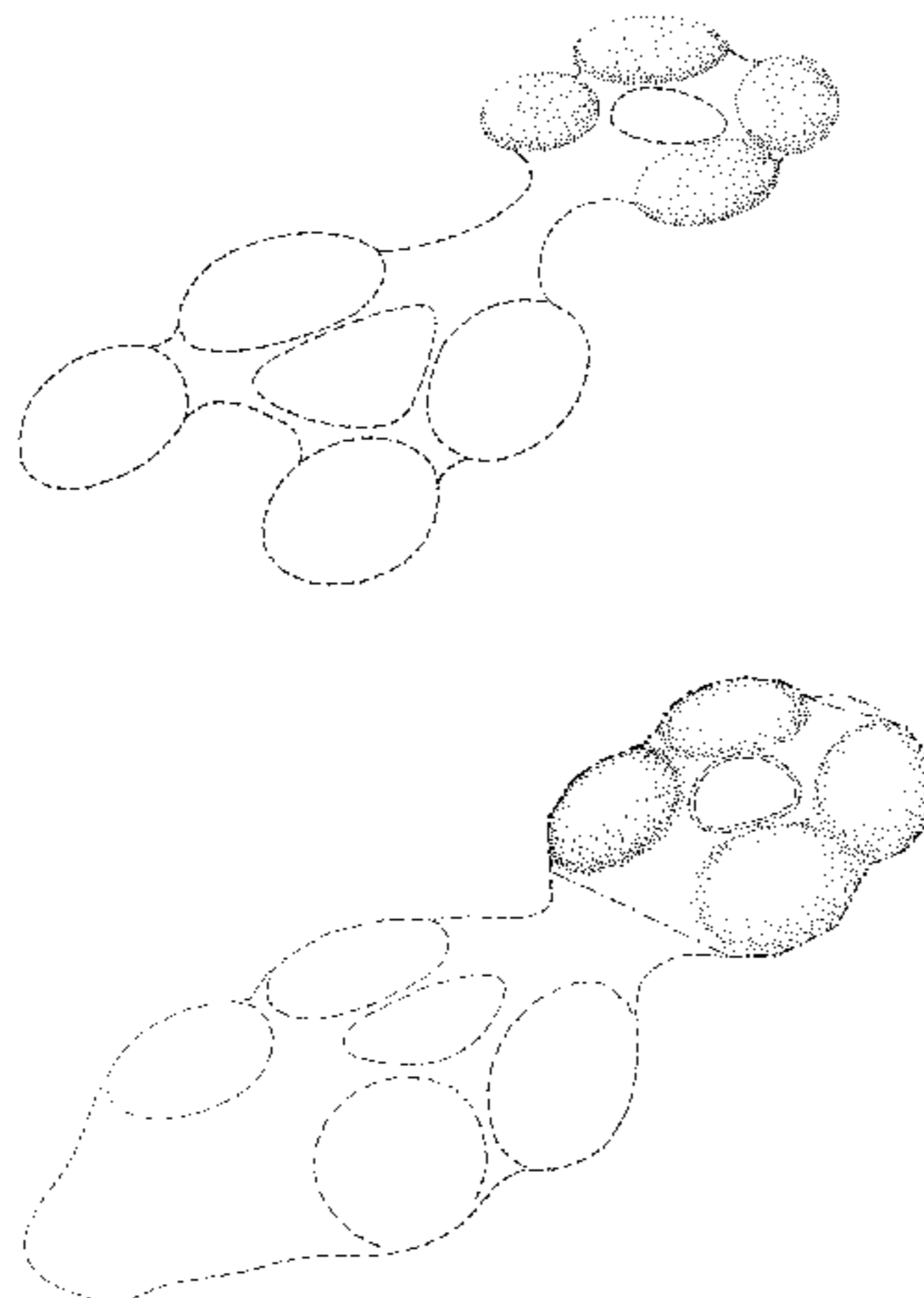
FIG. 11 is a rear elevational view thereof; and,

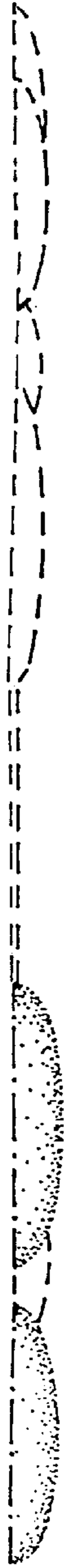

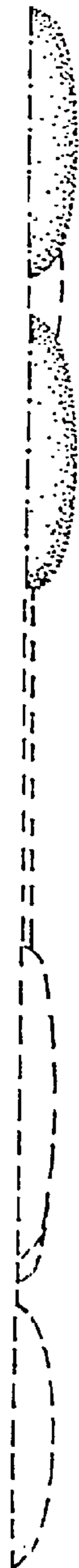

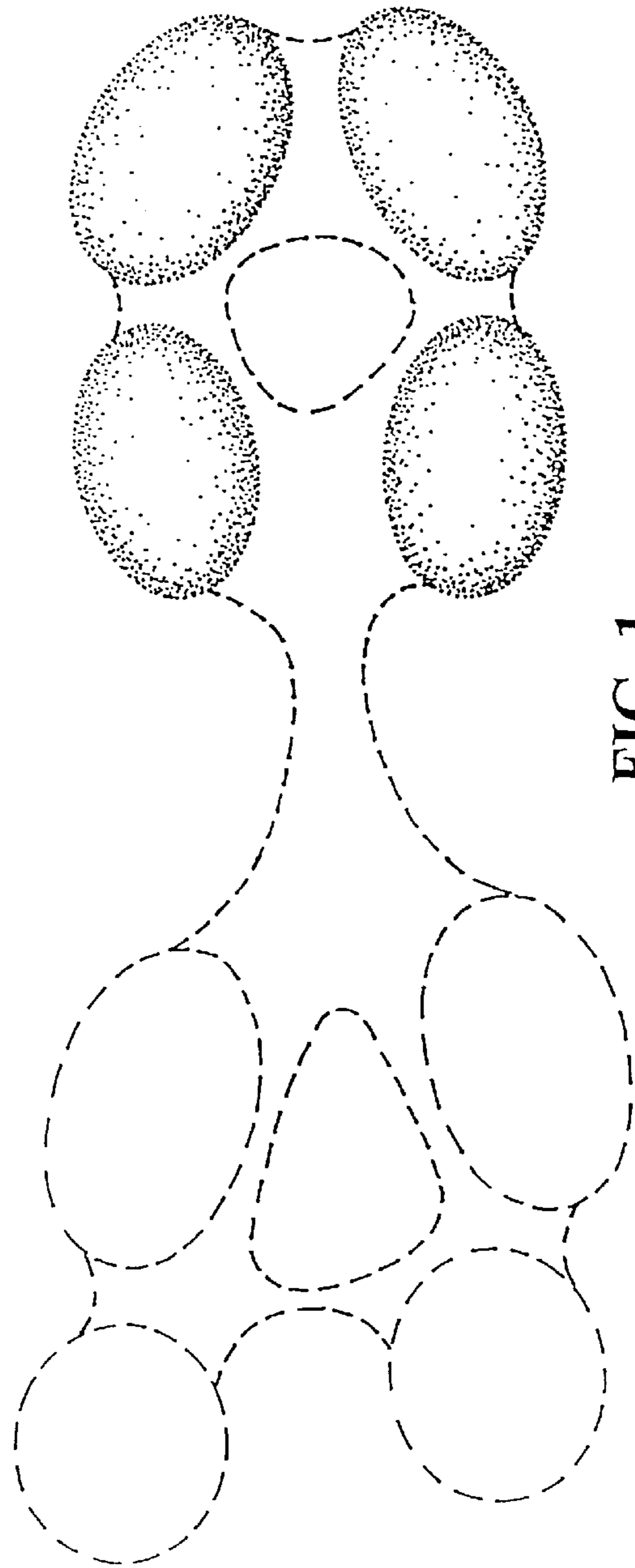

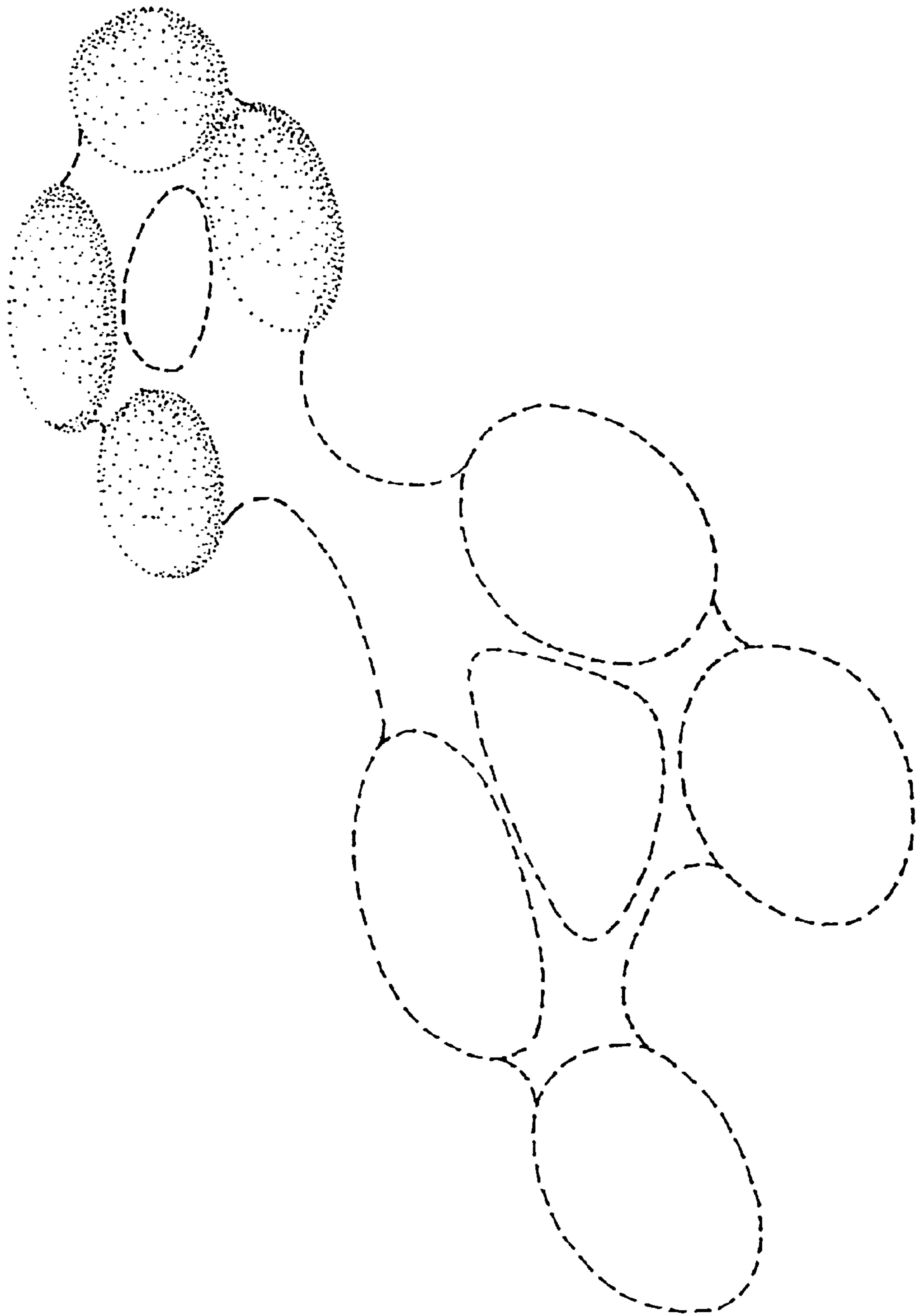

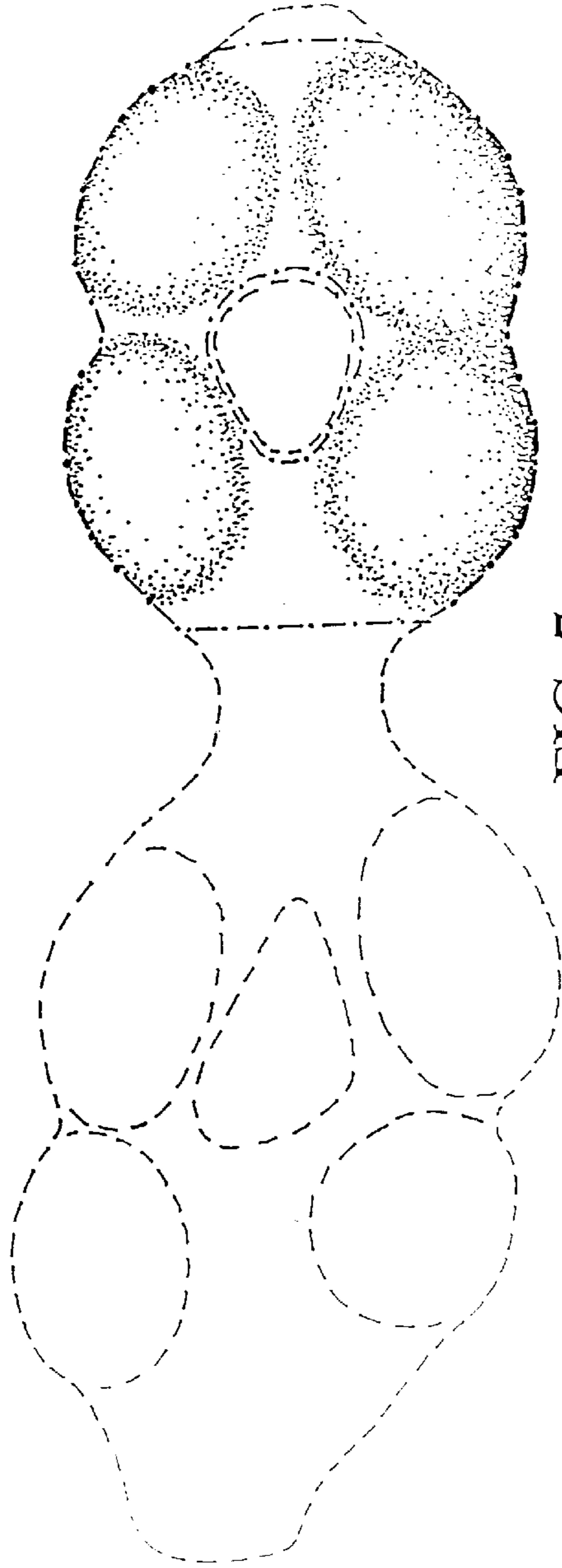

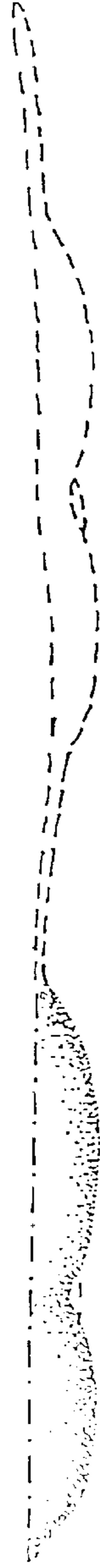

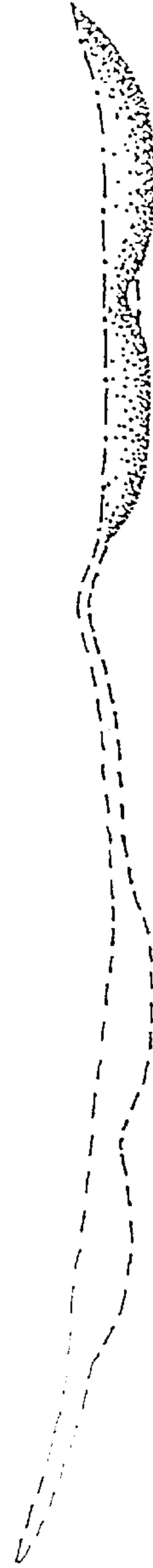

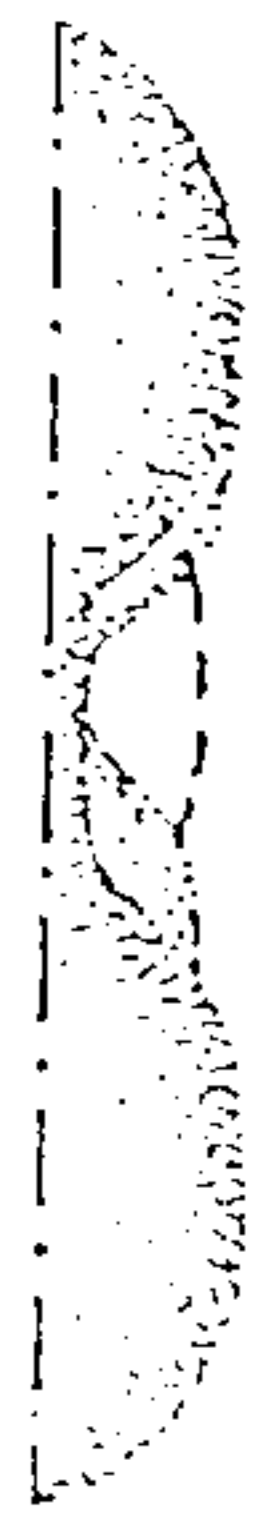

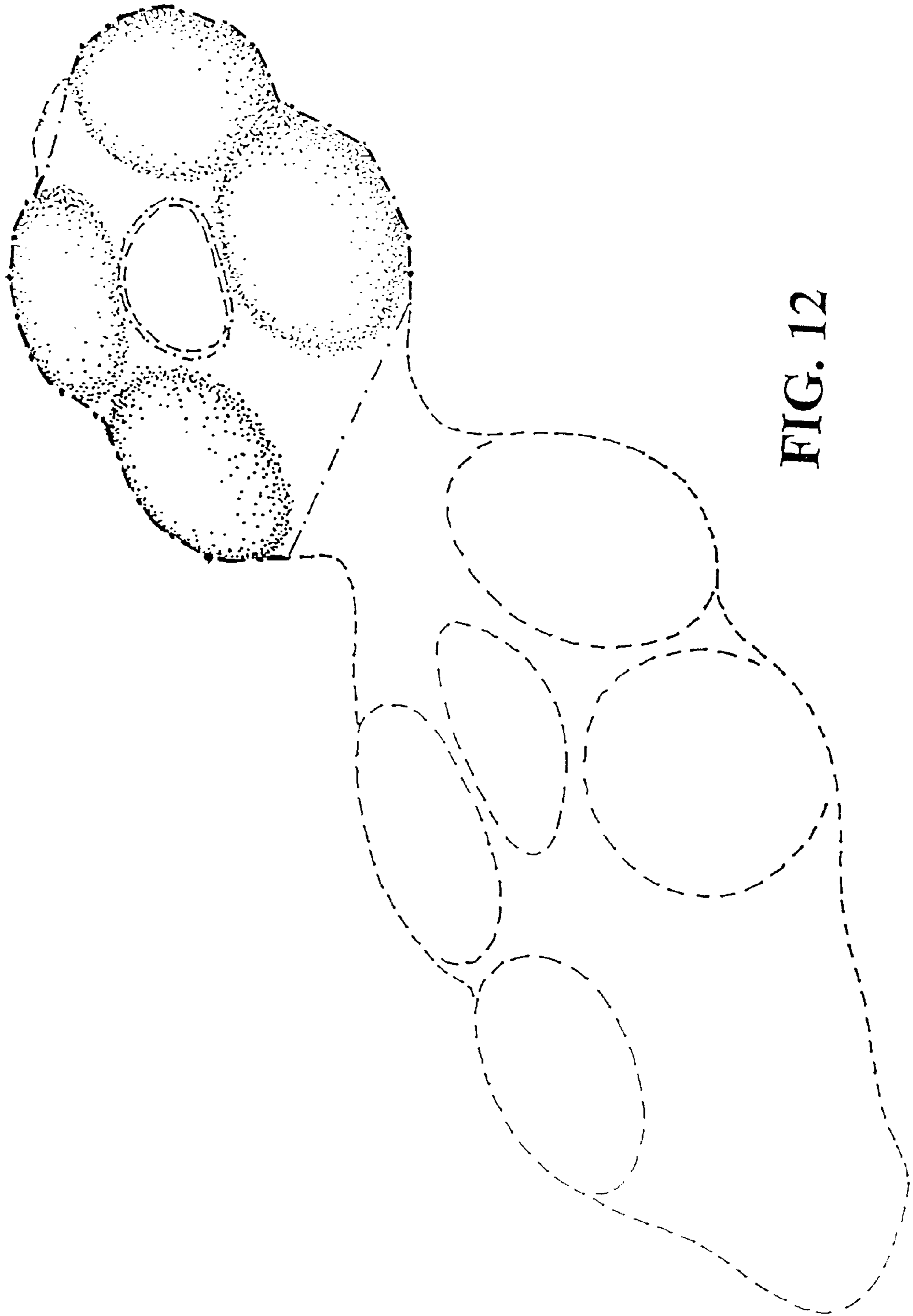
