(57) **CLAIM**

The ornamental design for a wooden basket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the wooden basket showing our new design.

FIG. 2 is a front elevation view thereof.

FIG. 3 is a right side elevation view thereof/

FIG. 4 is a rear elevation view thereof.

FIG. 5 is a left side elevation view thereof.

FIG. 6 is a top plan view thereof.

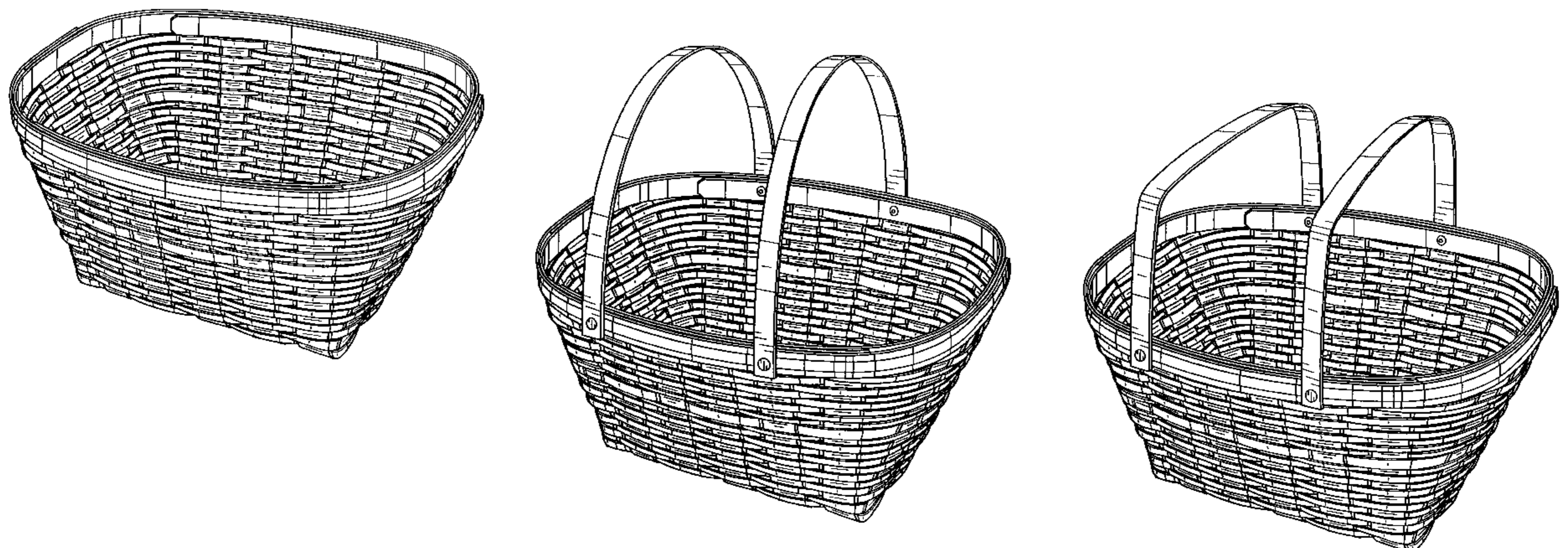
FIG. 7 is a bottom plan view thereof.

FIG. 8 is a front perspective view of a second embodiment of our design, having an appearance identical to that of FIG. 1, except for the indication of the color contrast.

FIG. 9 is a front perspective view of a third embodiment of our design, having an appearance identical to that of FIG. 1, except for the presence of a pair of rounded handles; and,

FIG. 10 is a front perspective view of a fourth embodiment of our design, having an appearance identical to that of FIG. 1, except for the presence of a pair of squarish handles.

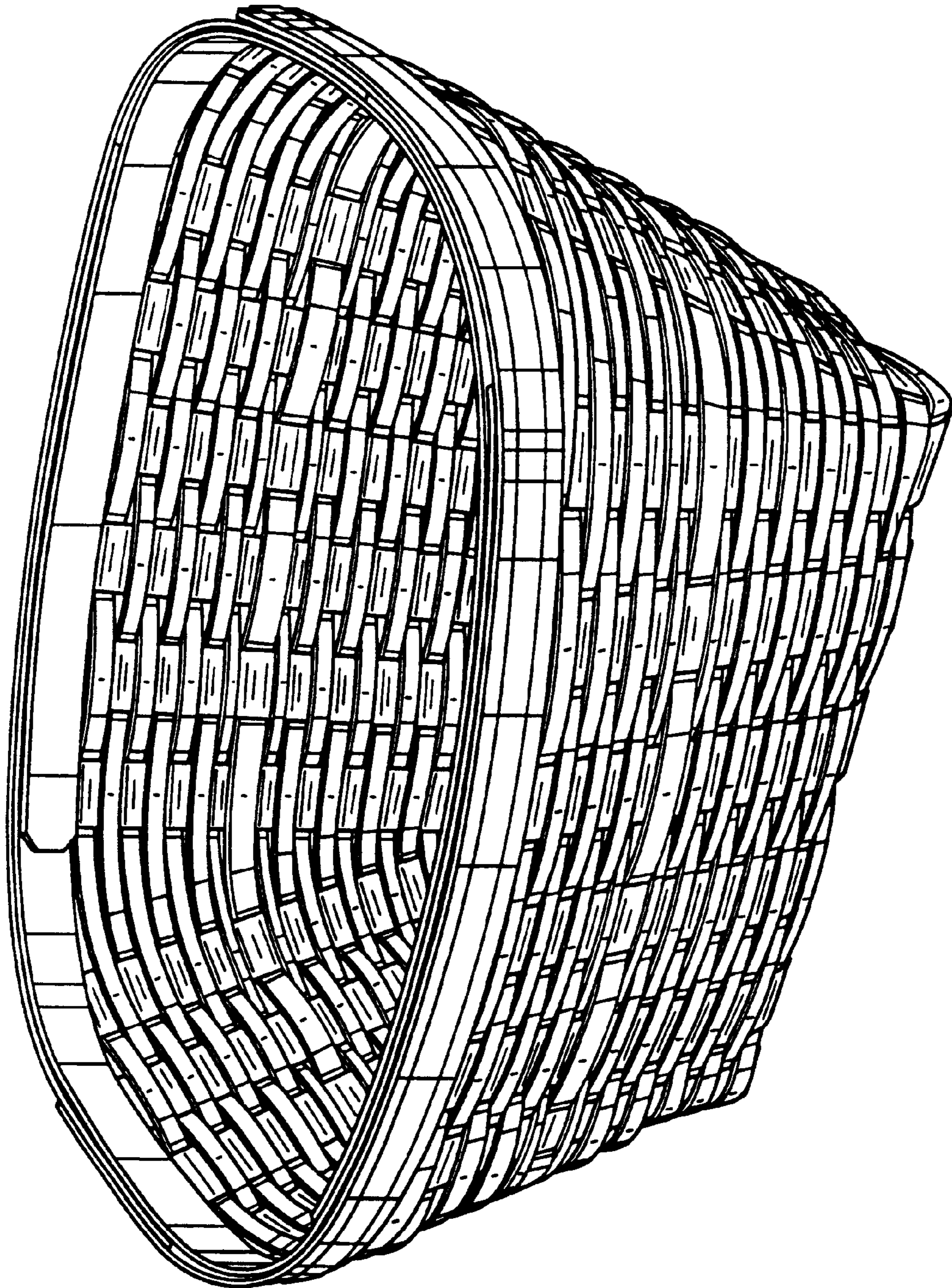

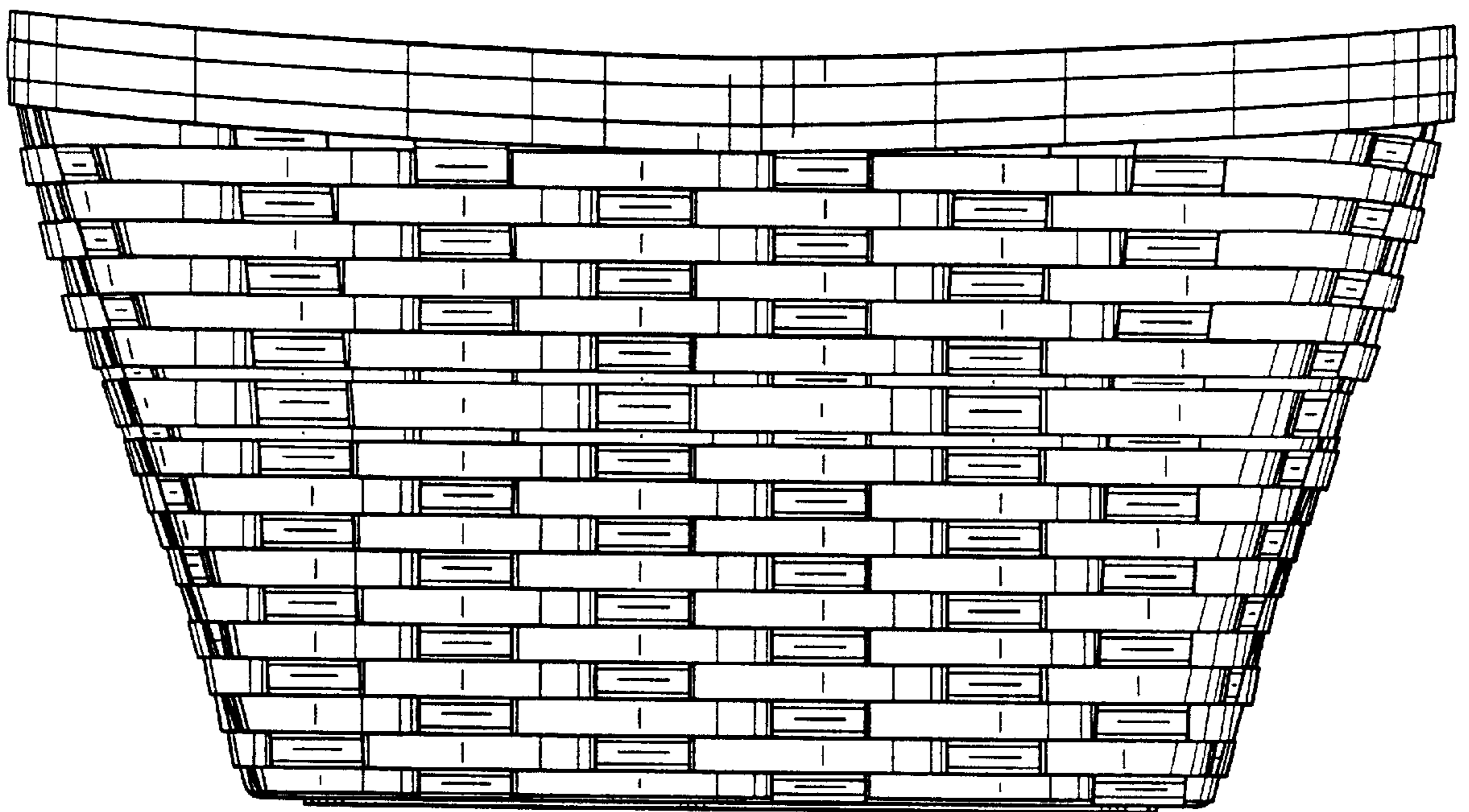

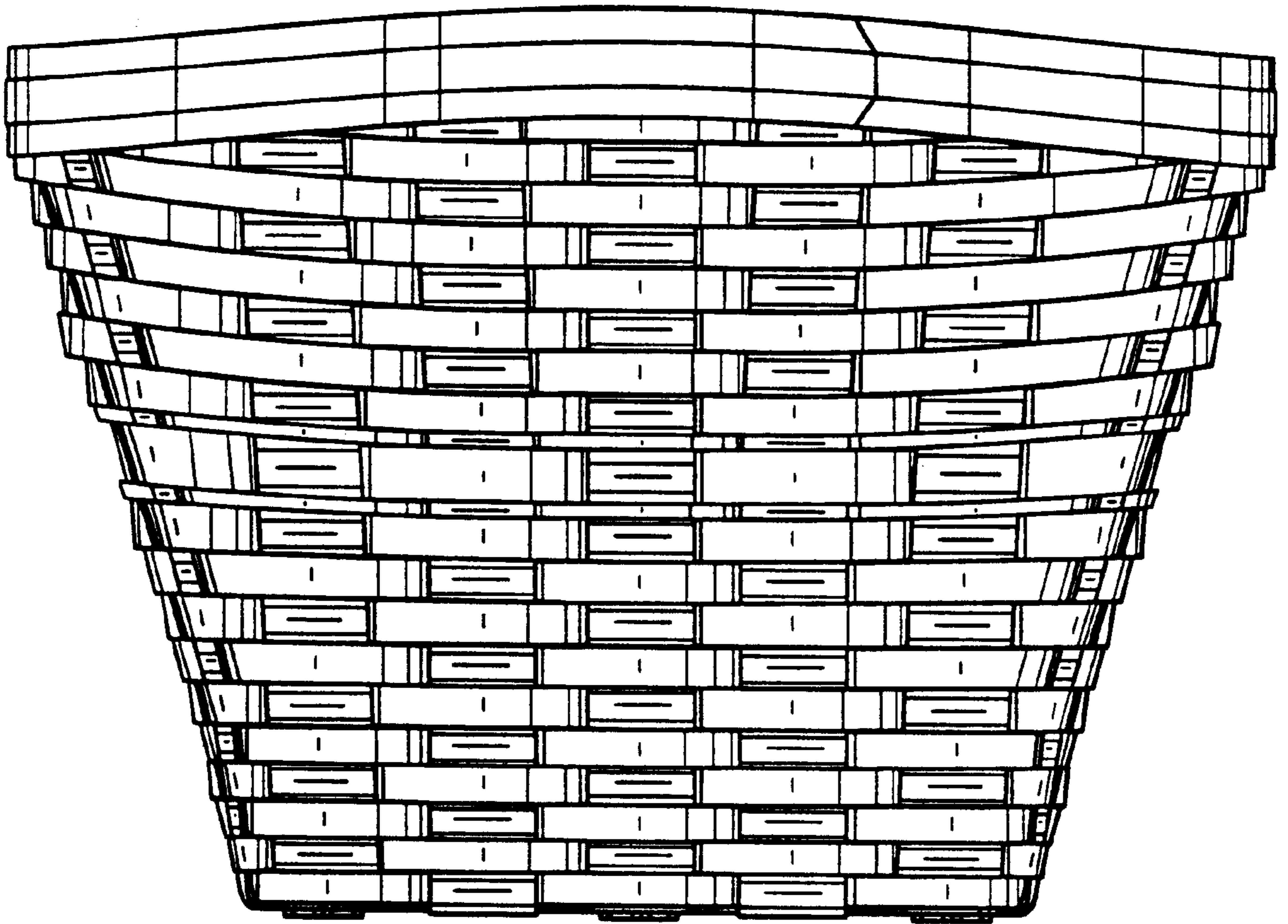

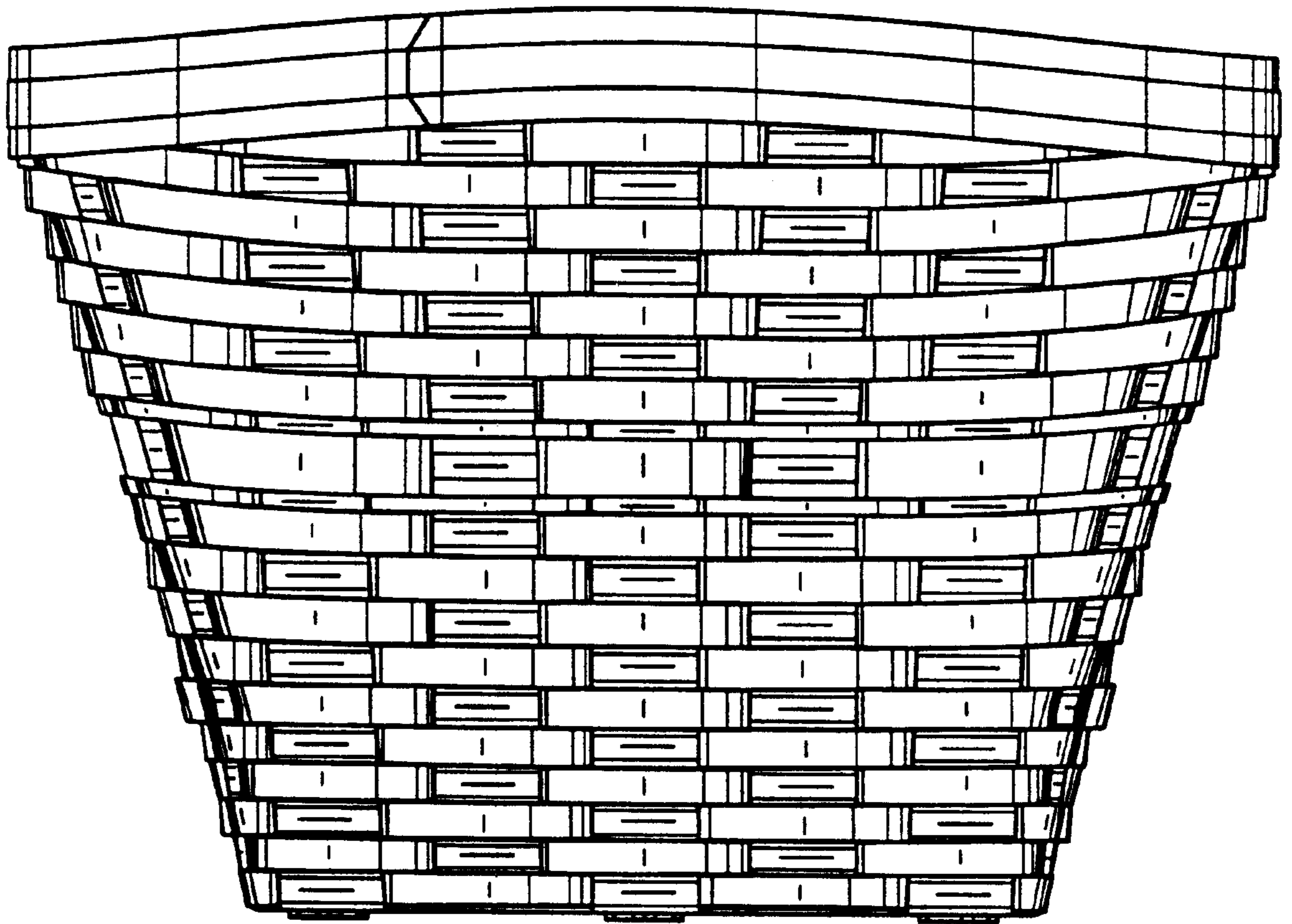

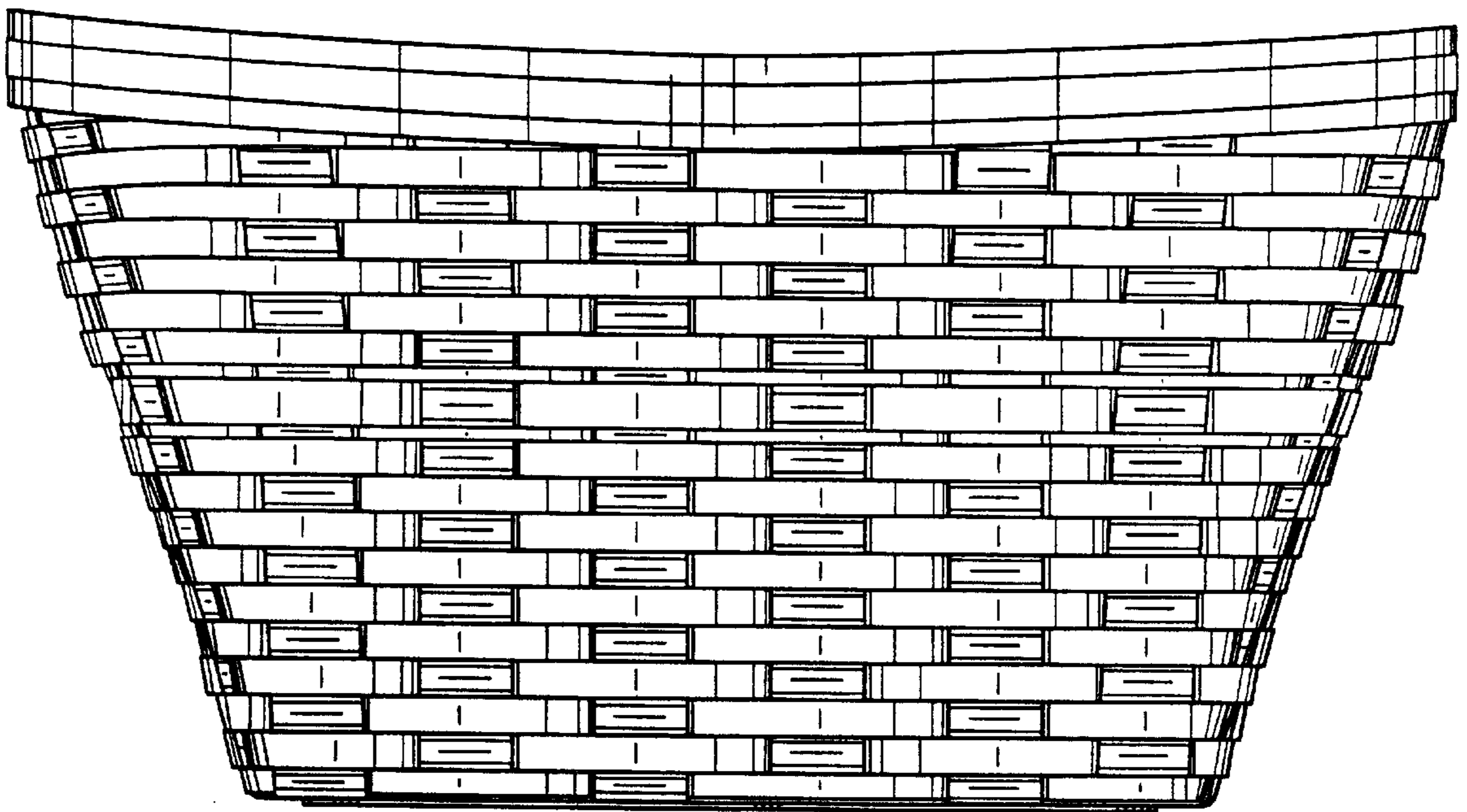

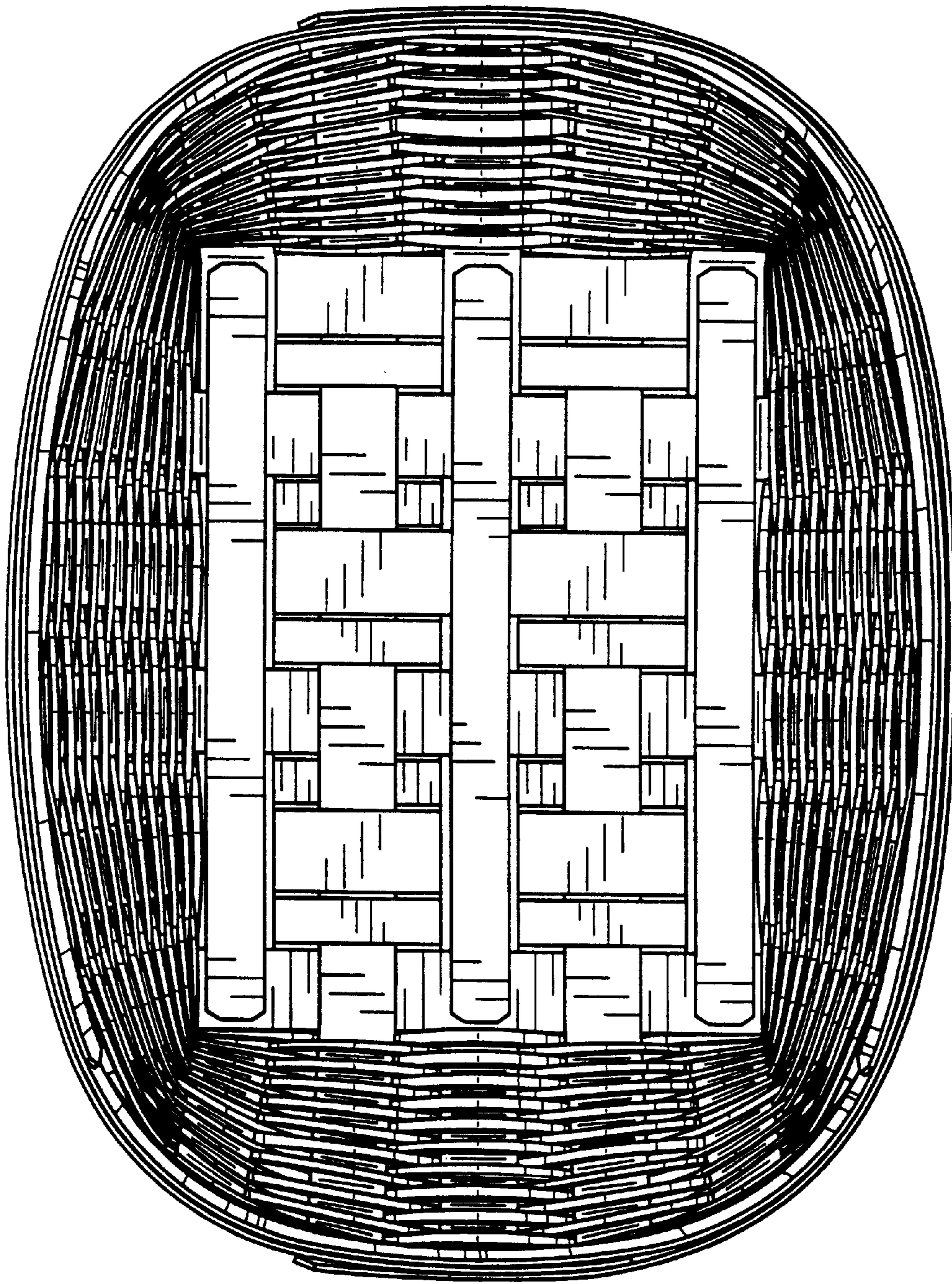

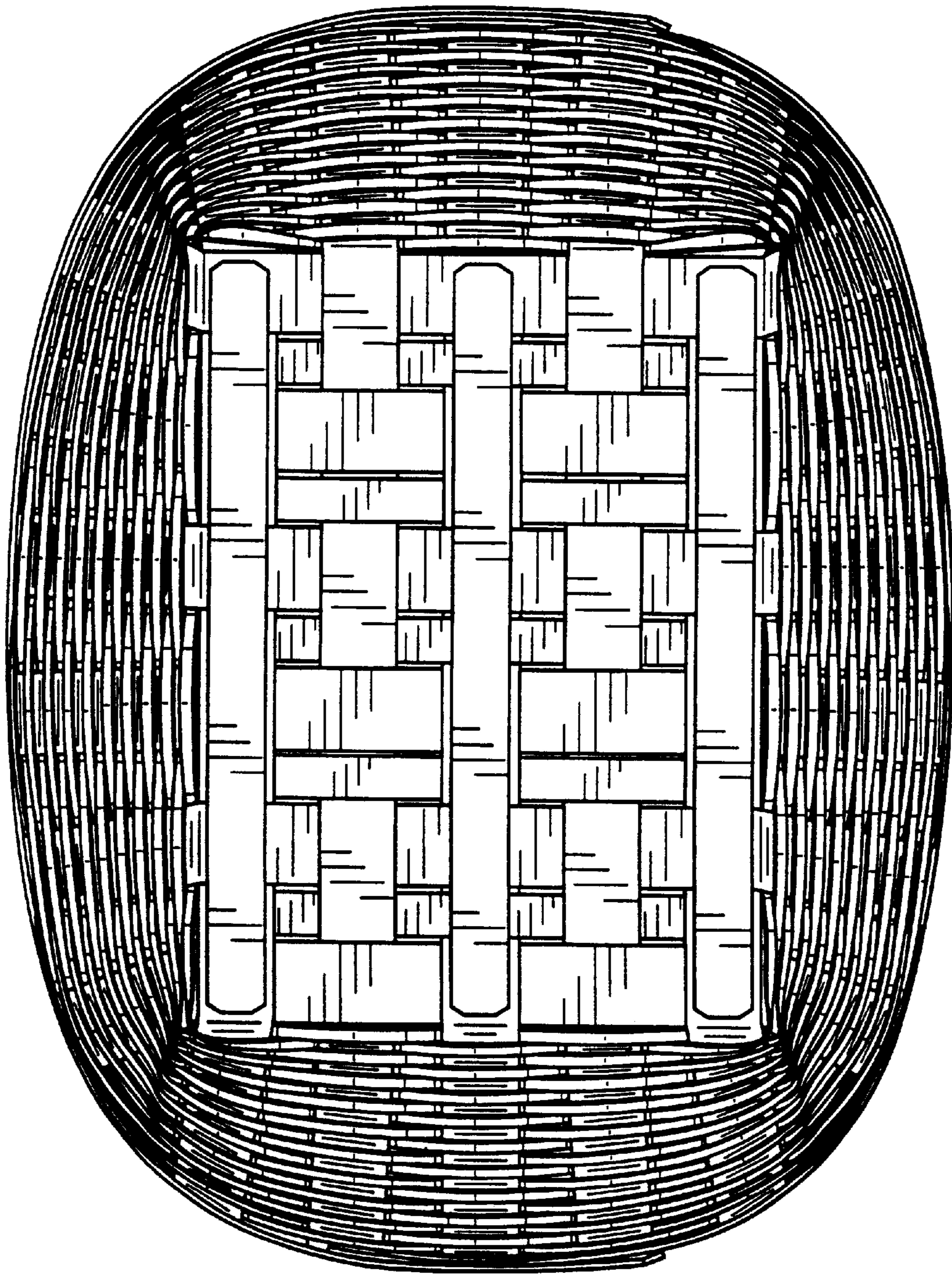

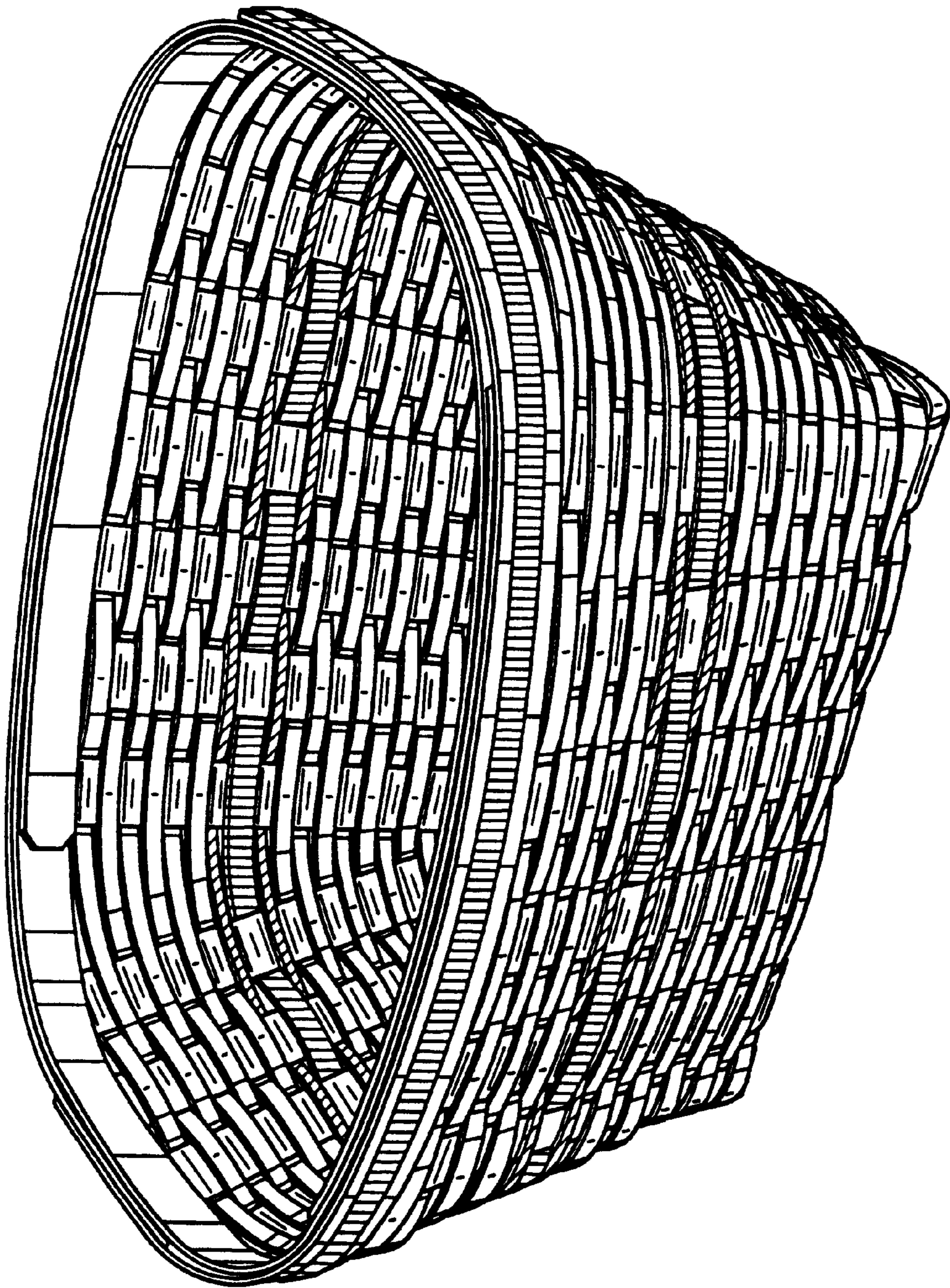

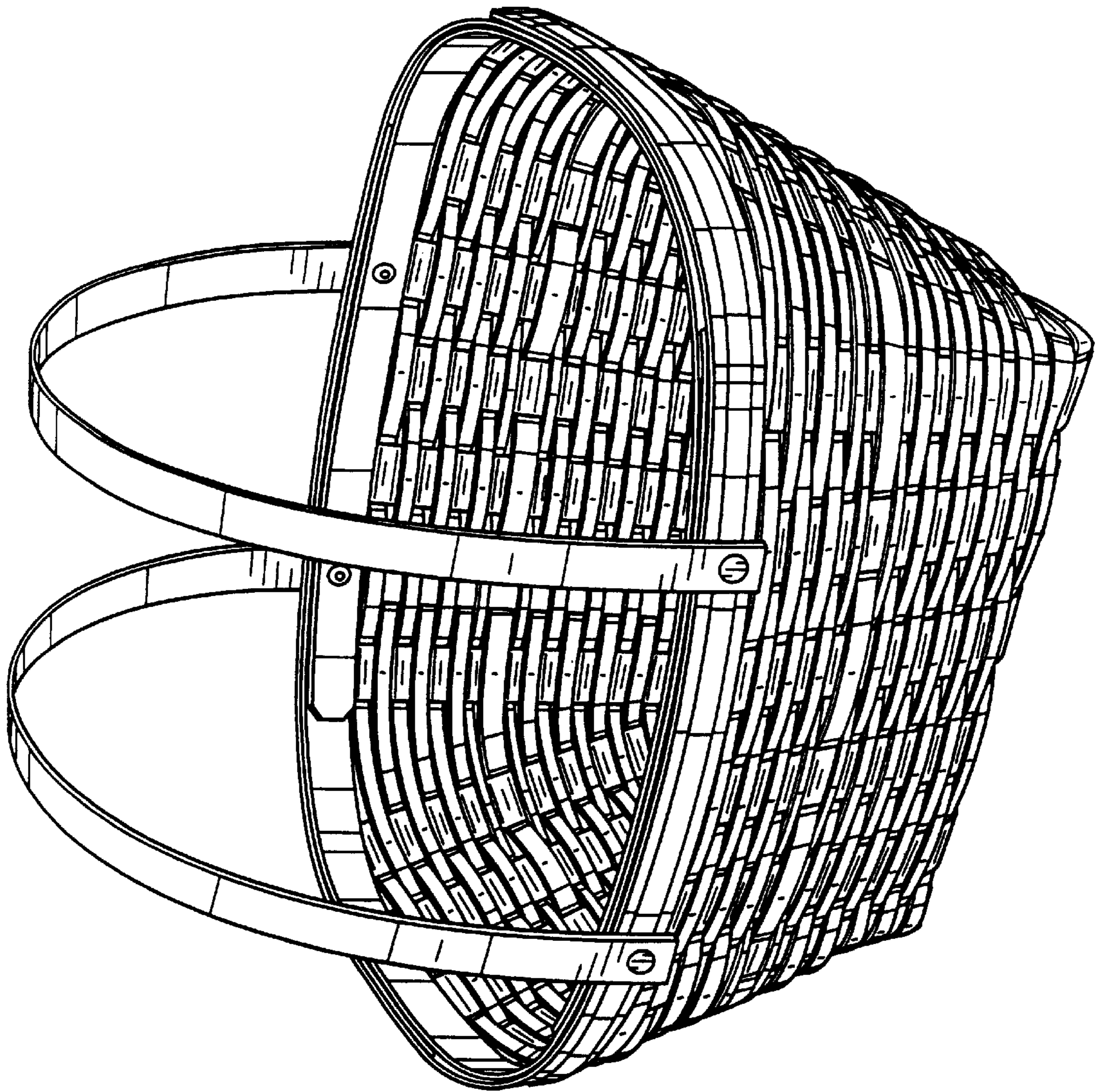

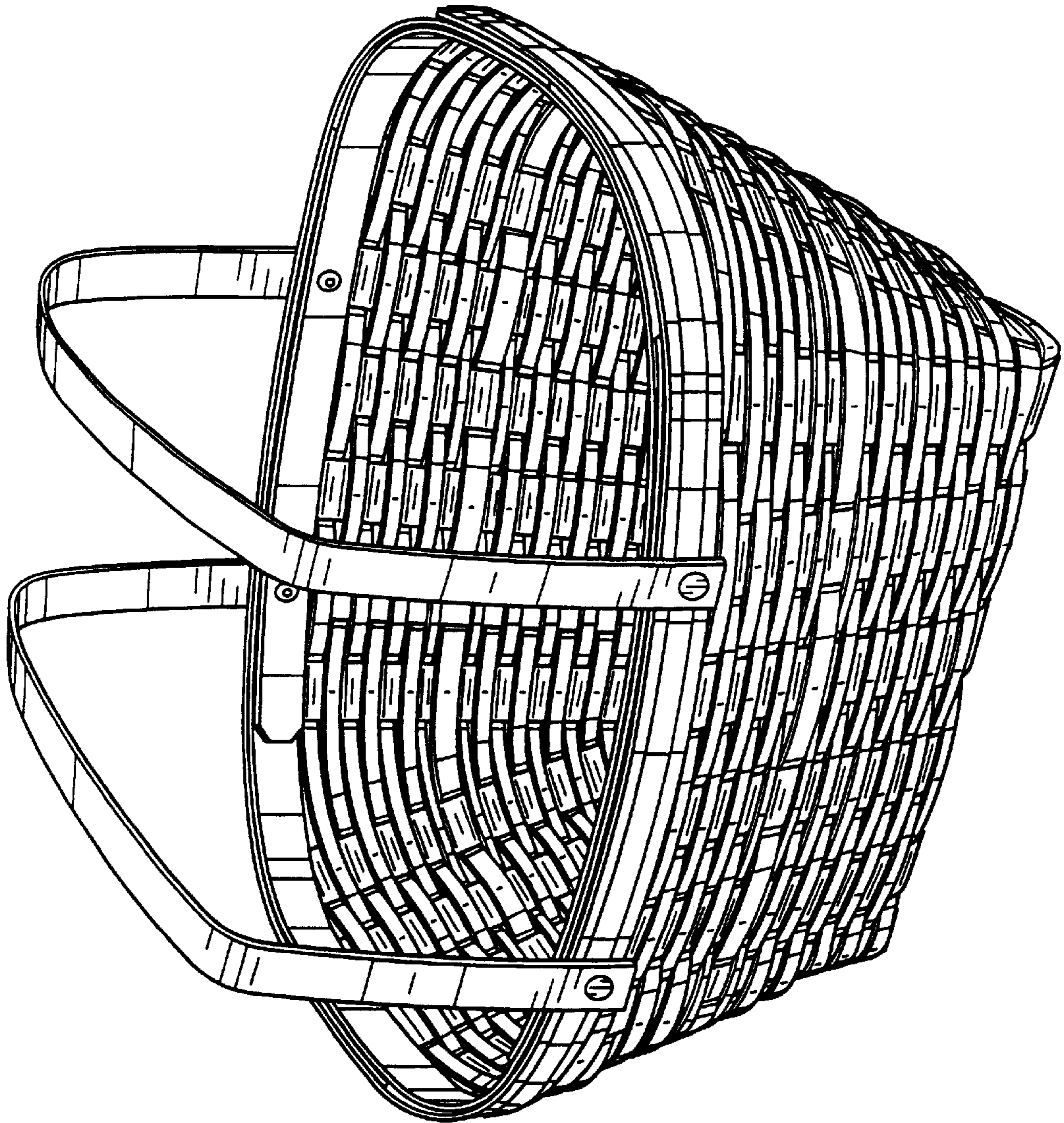
