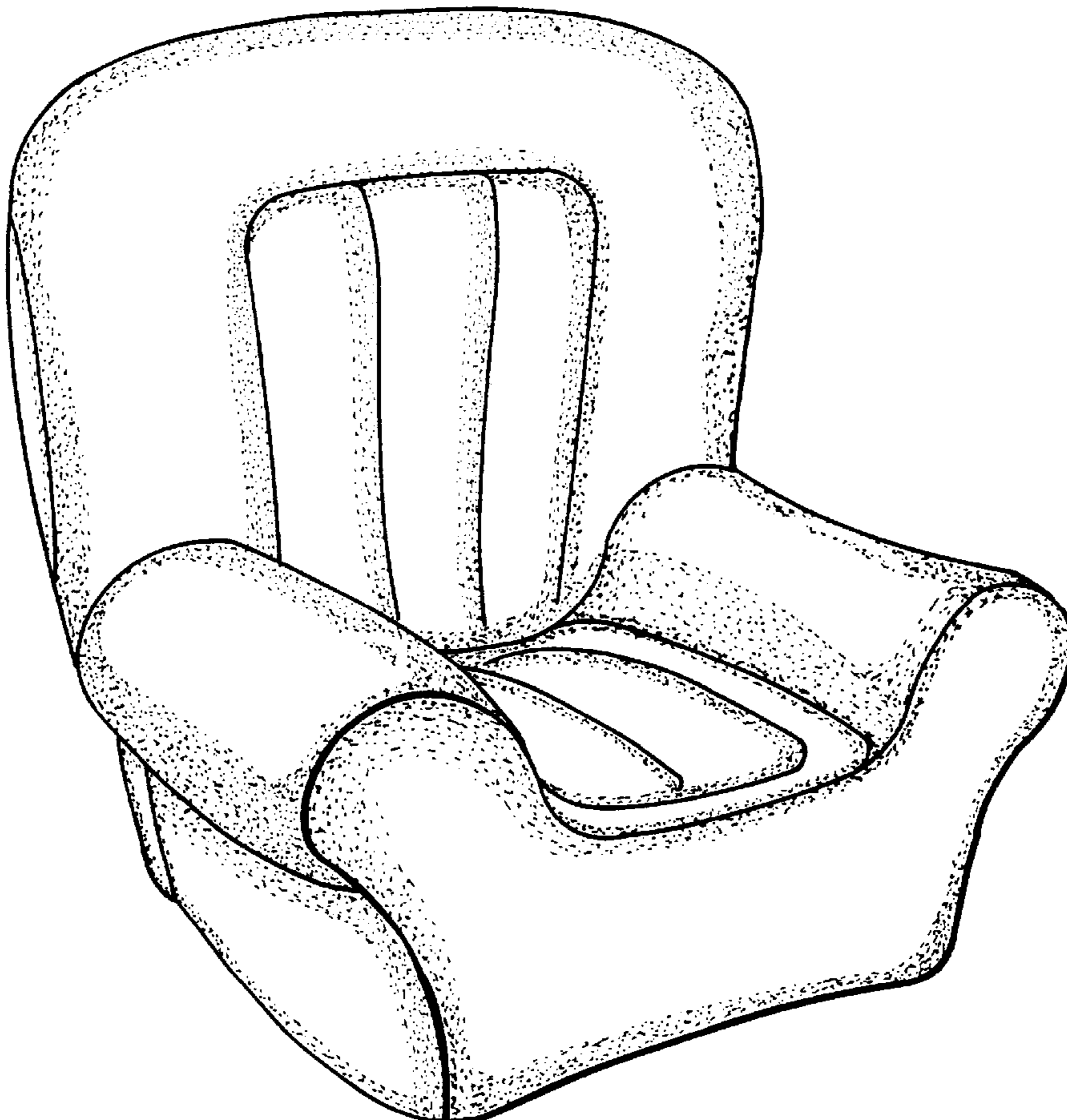

The ornamental design for an inflatable chair, as shown.

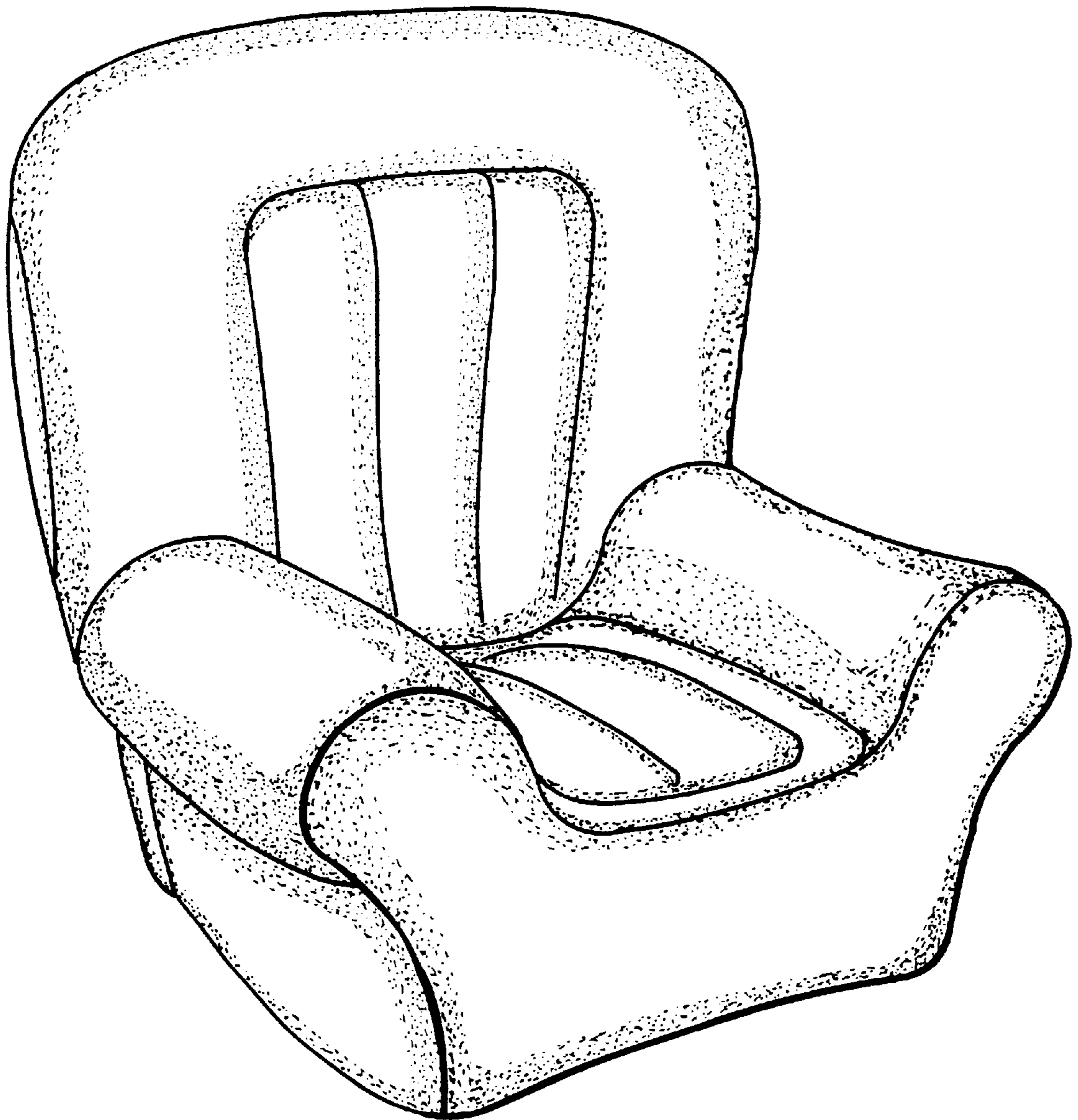
**DESCRIPTION**

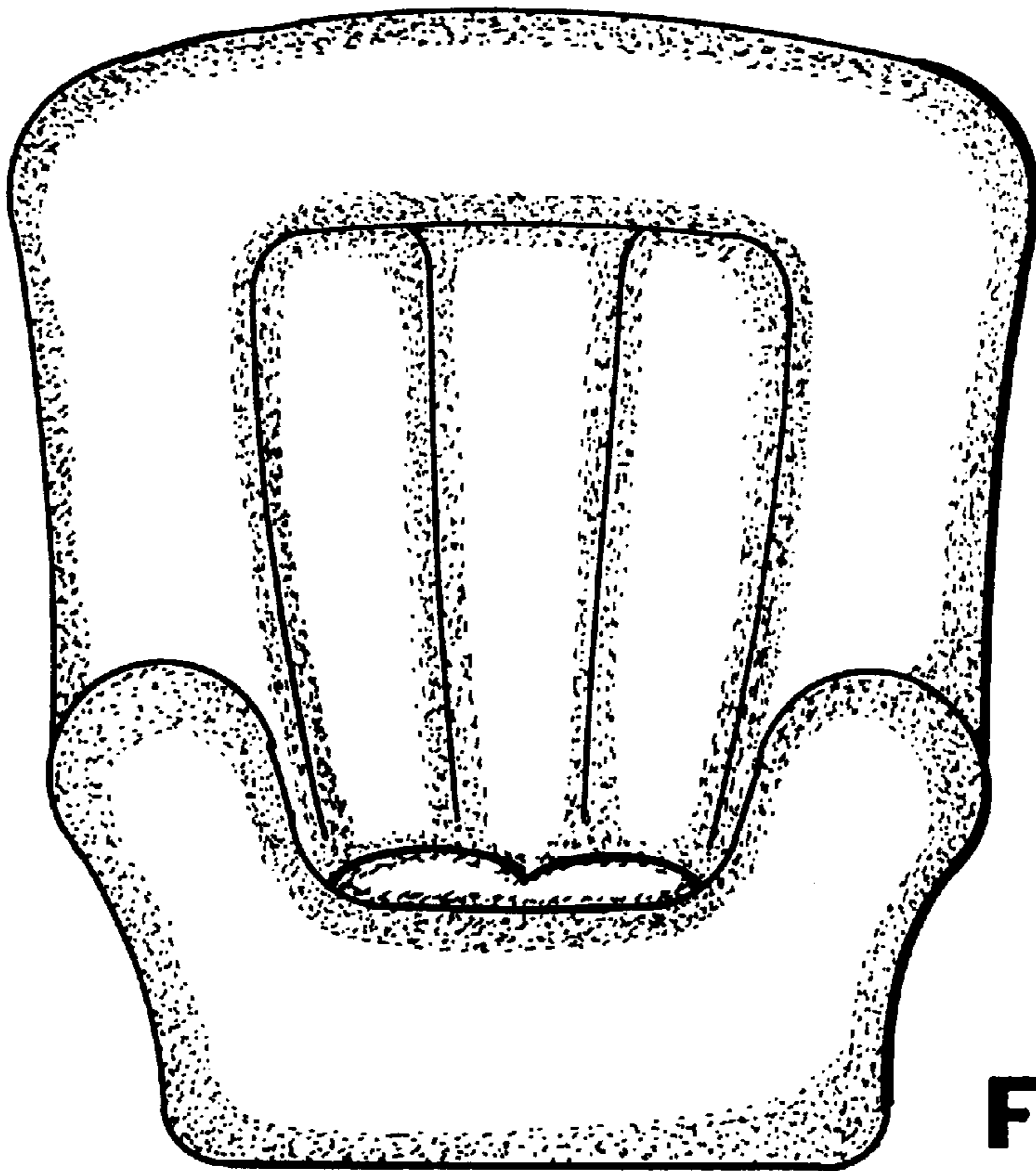
FIG. 1 is a perspective view from the top, front and one side of an inflatable chair showing my new design;

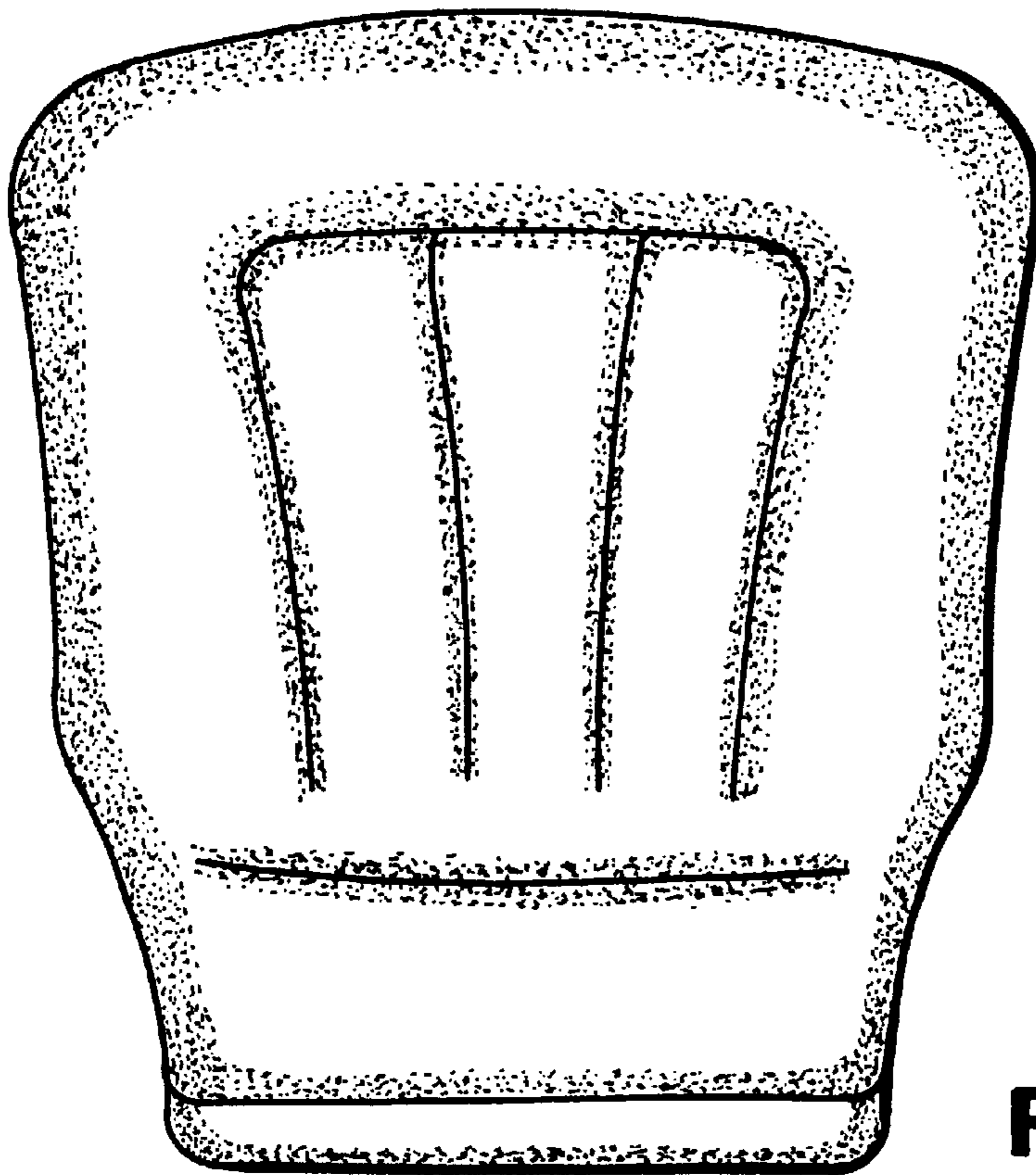

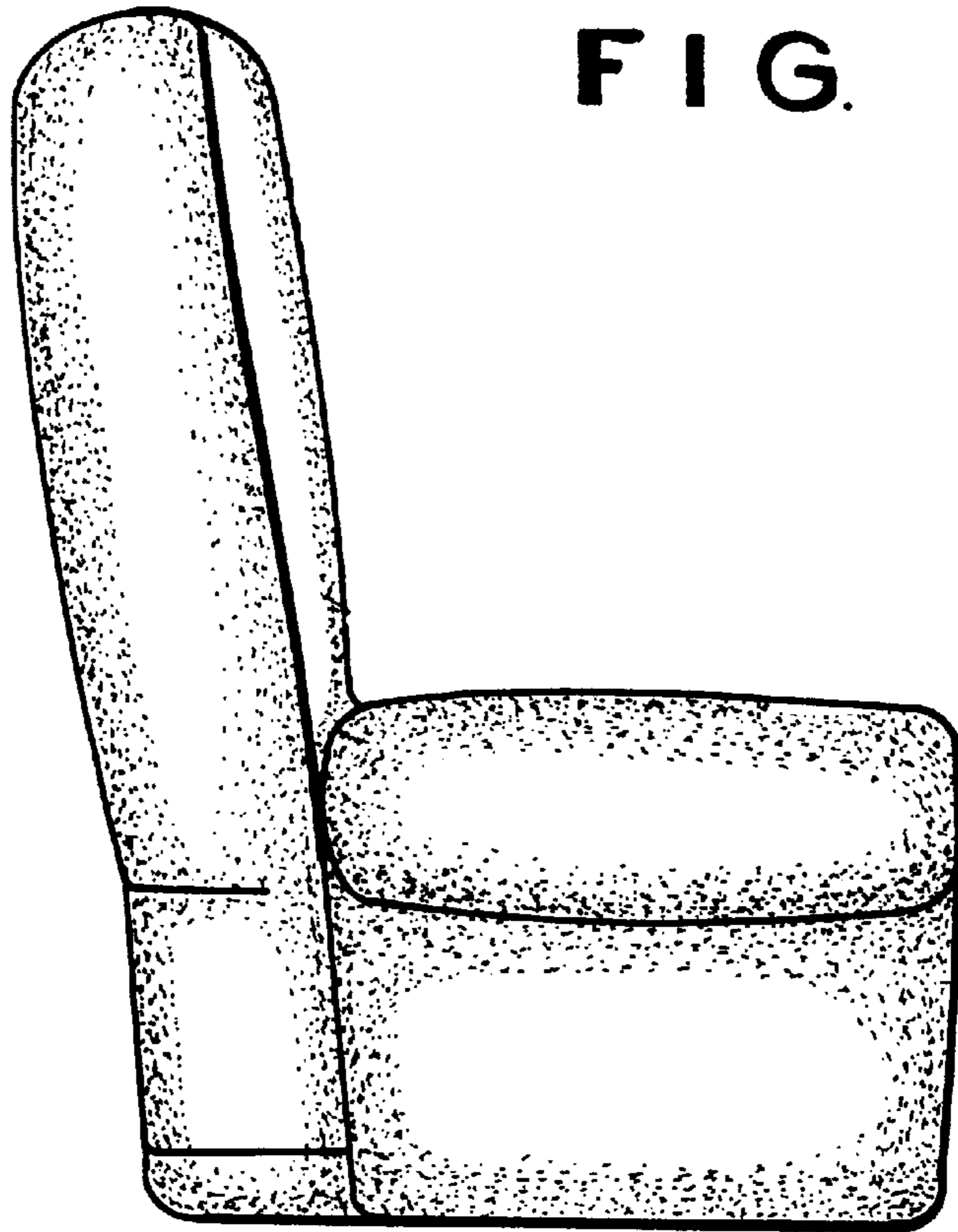

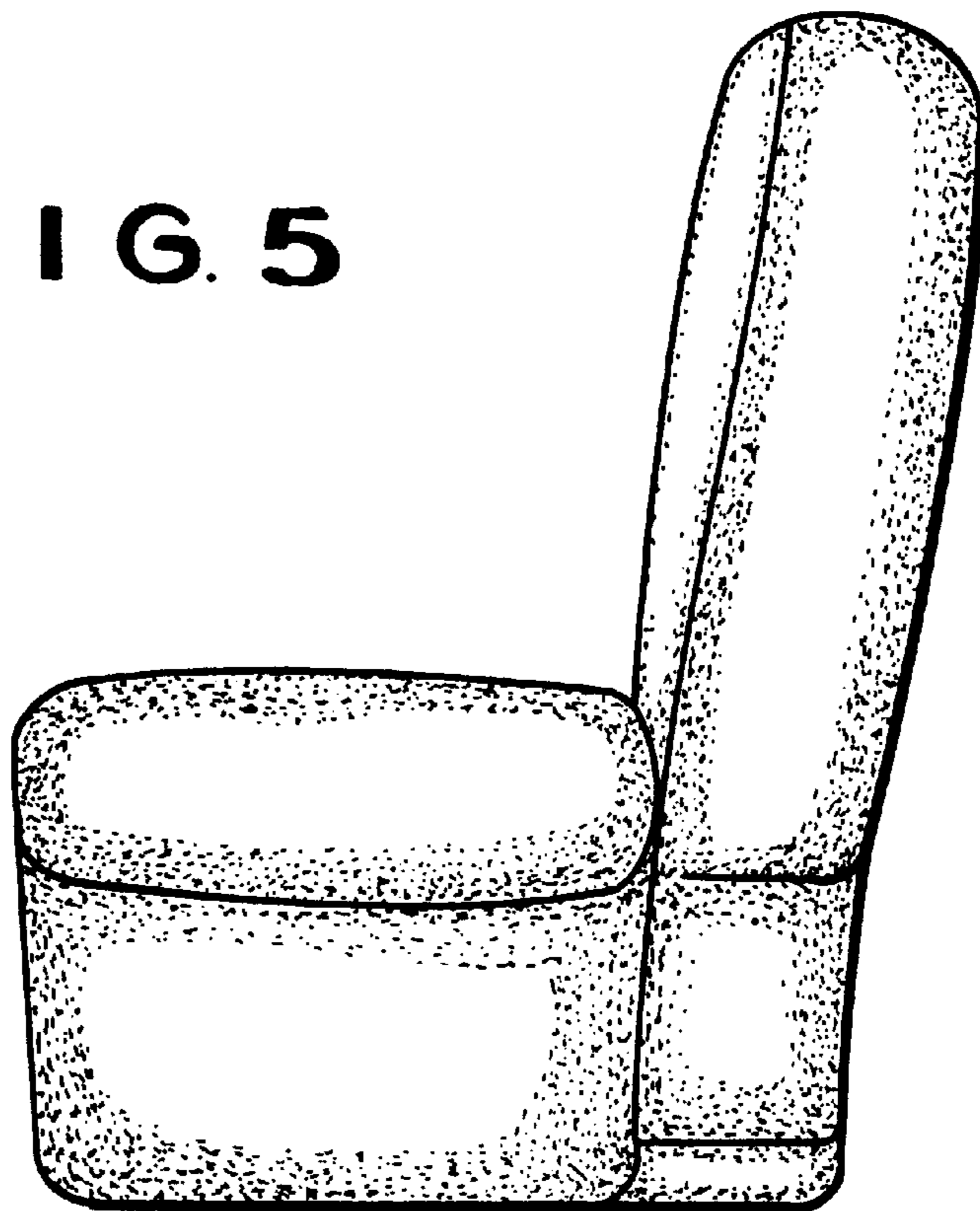


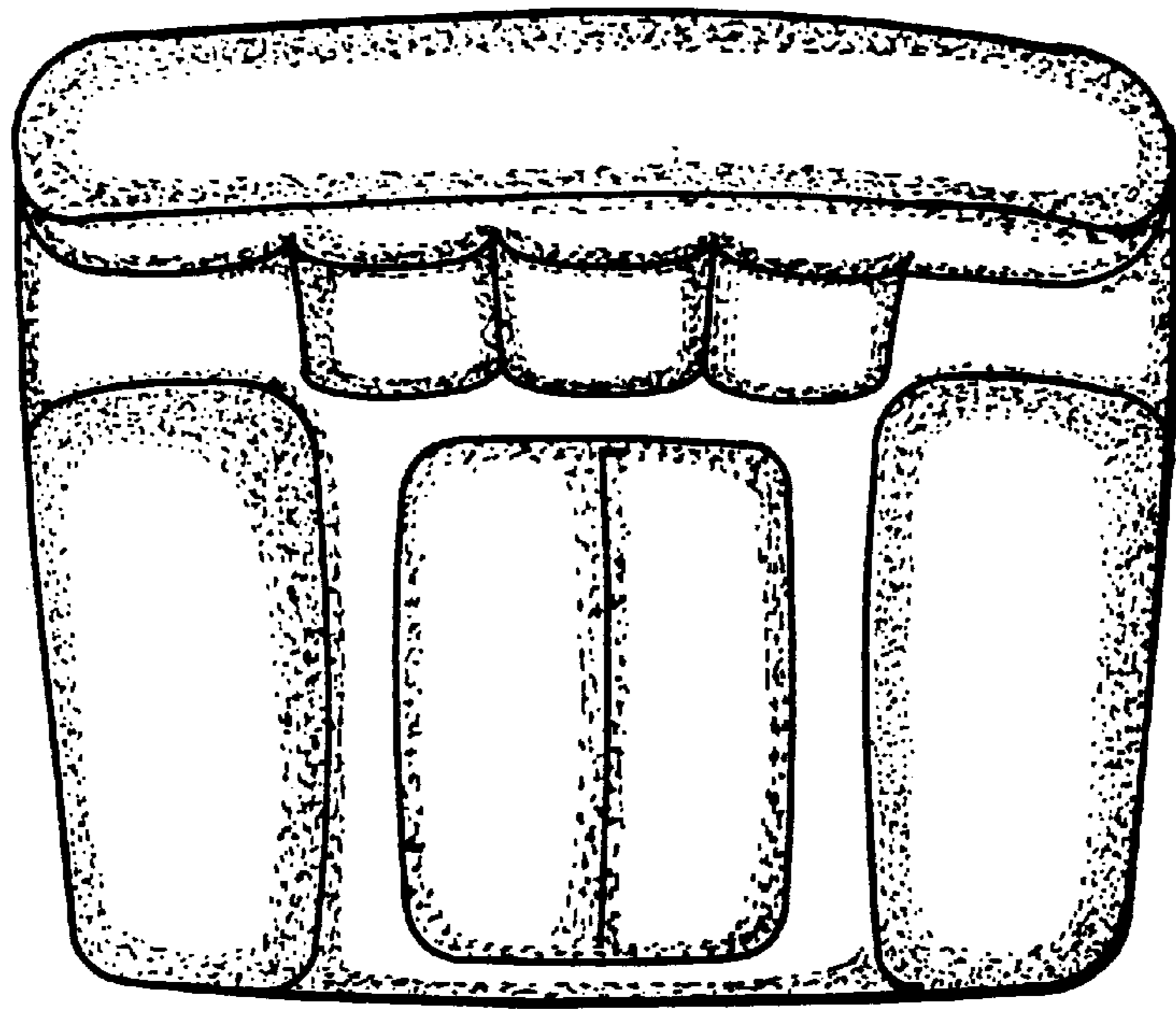

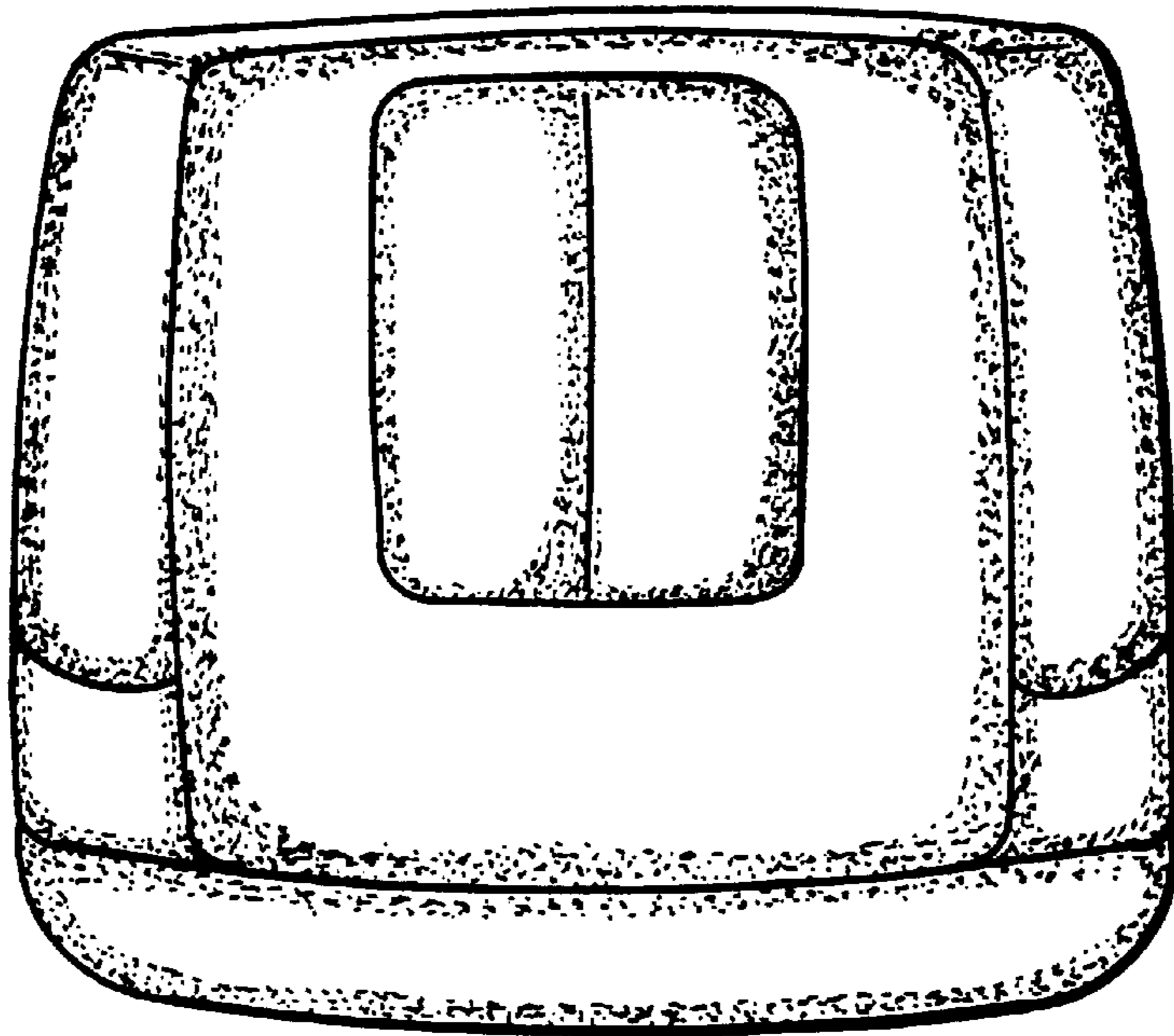
