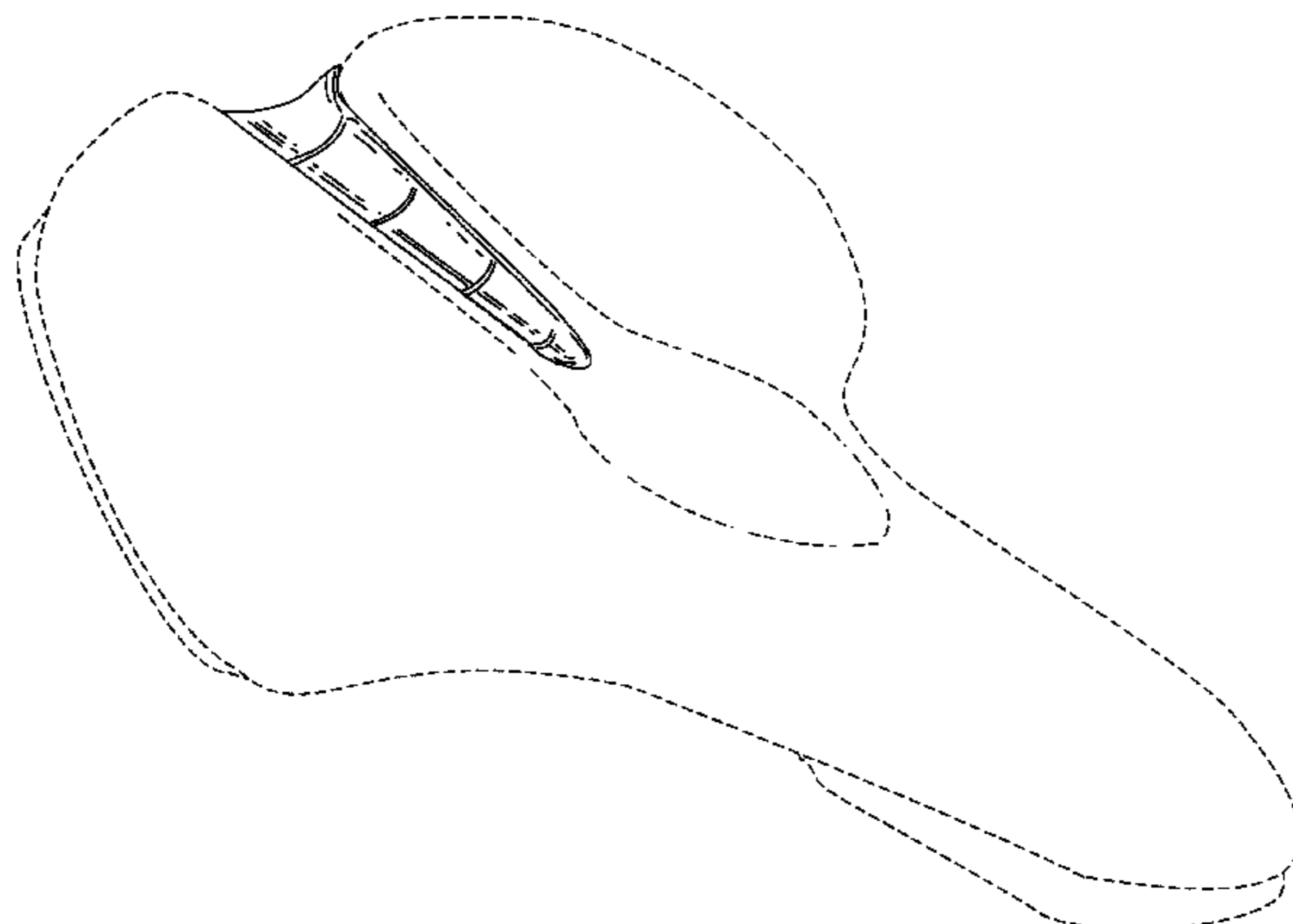
(57) **CLAIM**

The ornamental design for a bicycle saddle, as shown and described.

DESCRIPTION

FIG. 1 is a right perspective view of the bicycle saddle of the present invention;
 FIG. 2 is a left perspective view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a right-side elevational view thereof; and,
 FIG. 8 is a left-side elevational view thereof.
 The portions of the bicycle saddle shown in broken lines are for illustrative purposes only and form no part the claimed design.

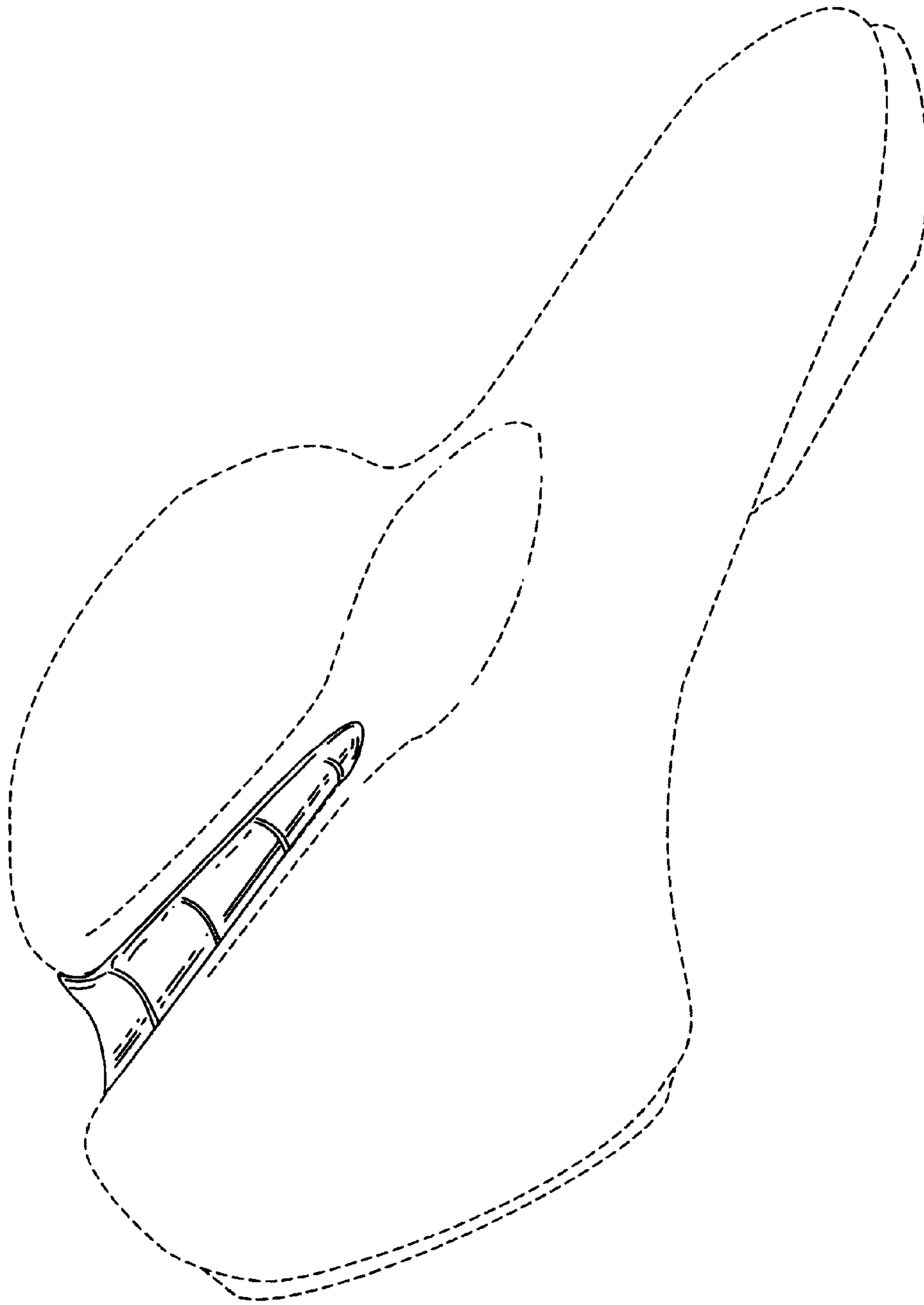

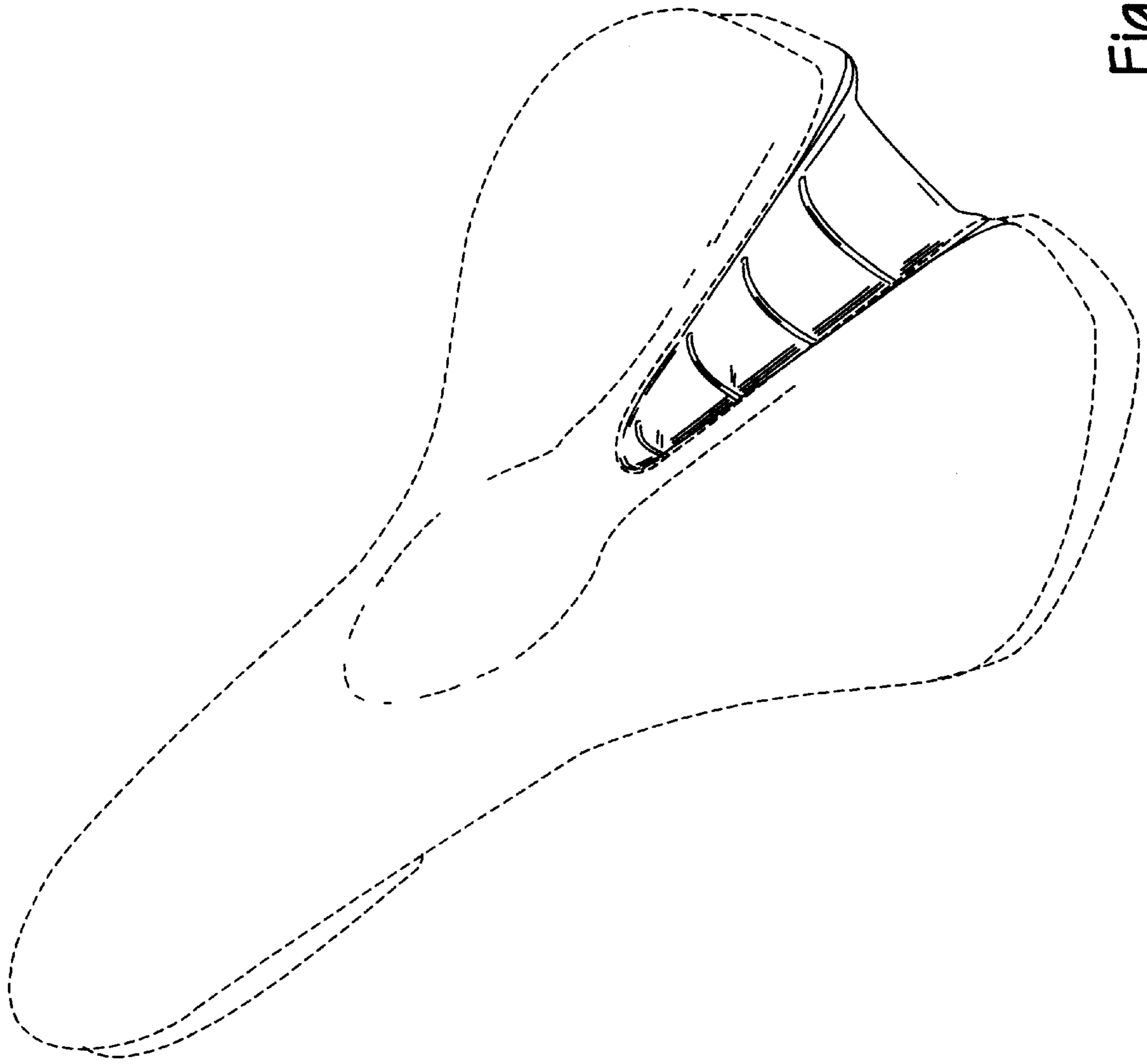

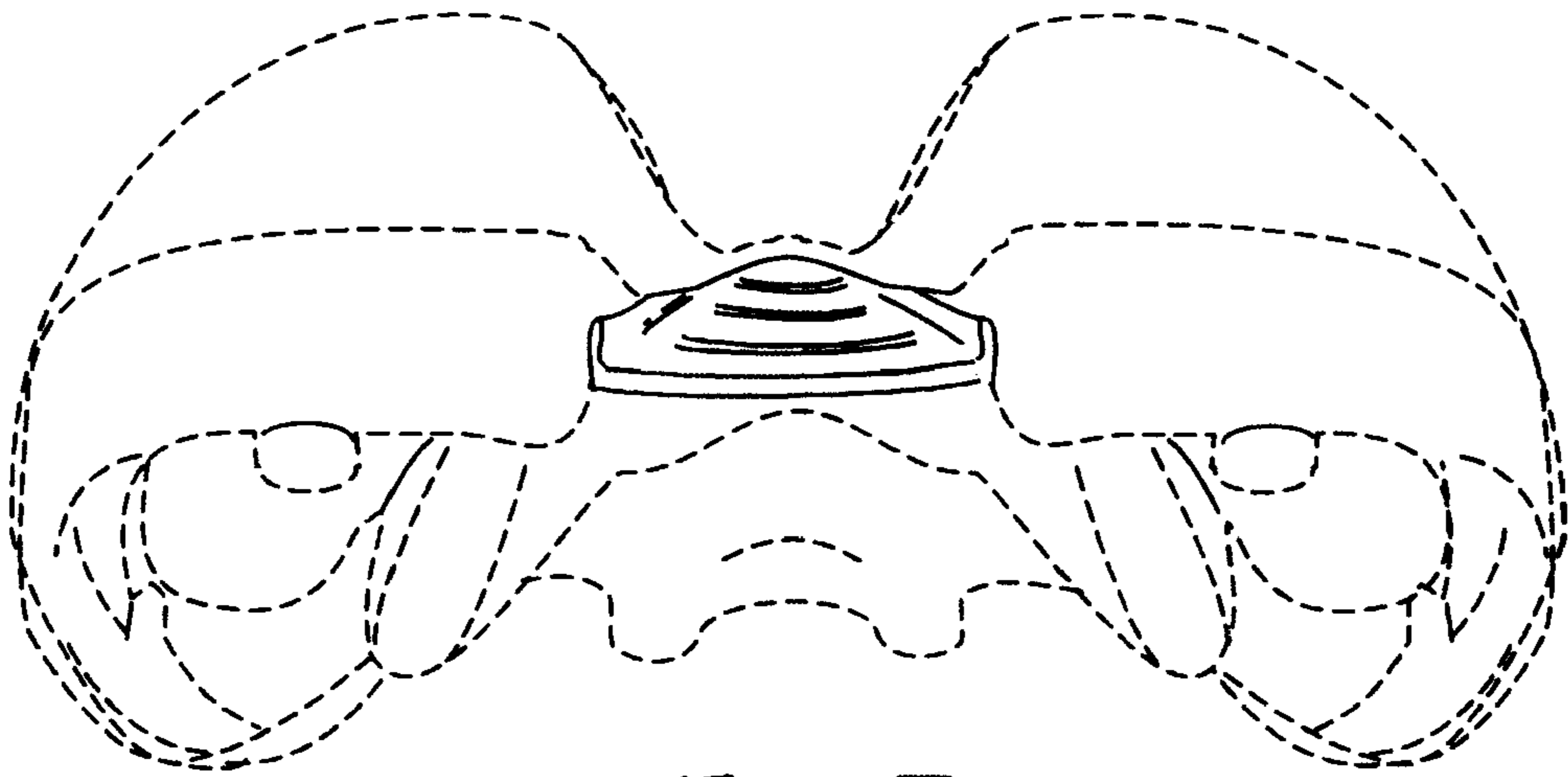

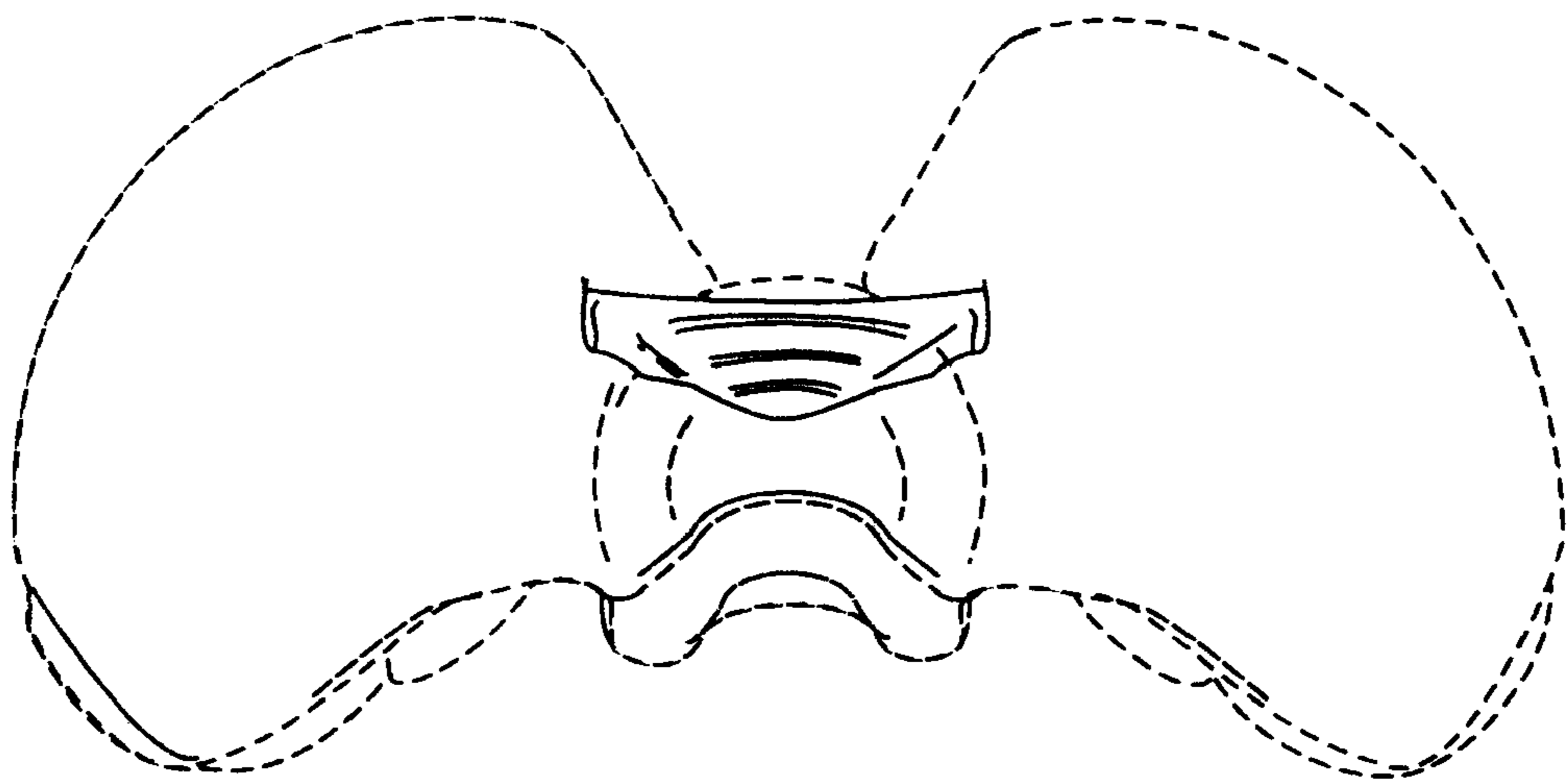

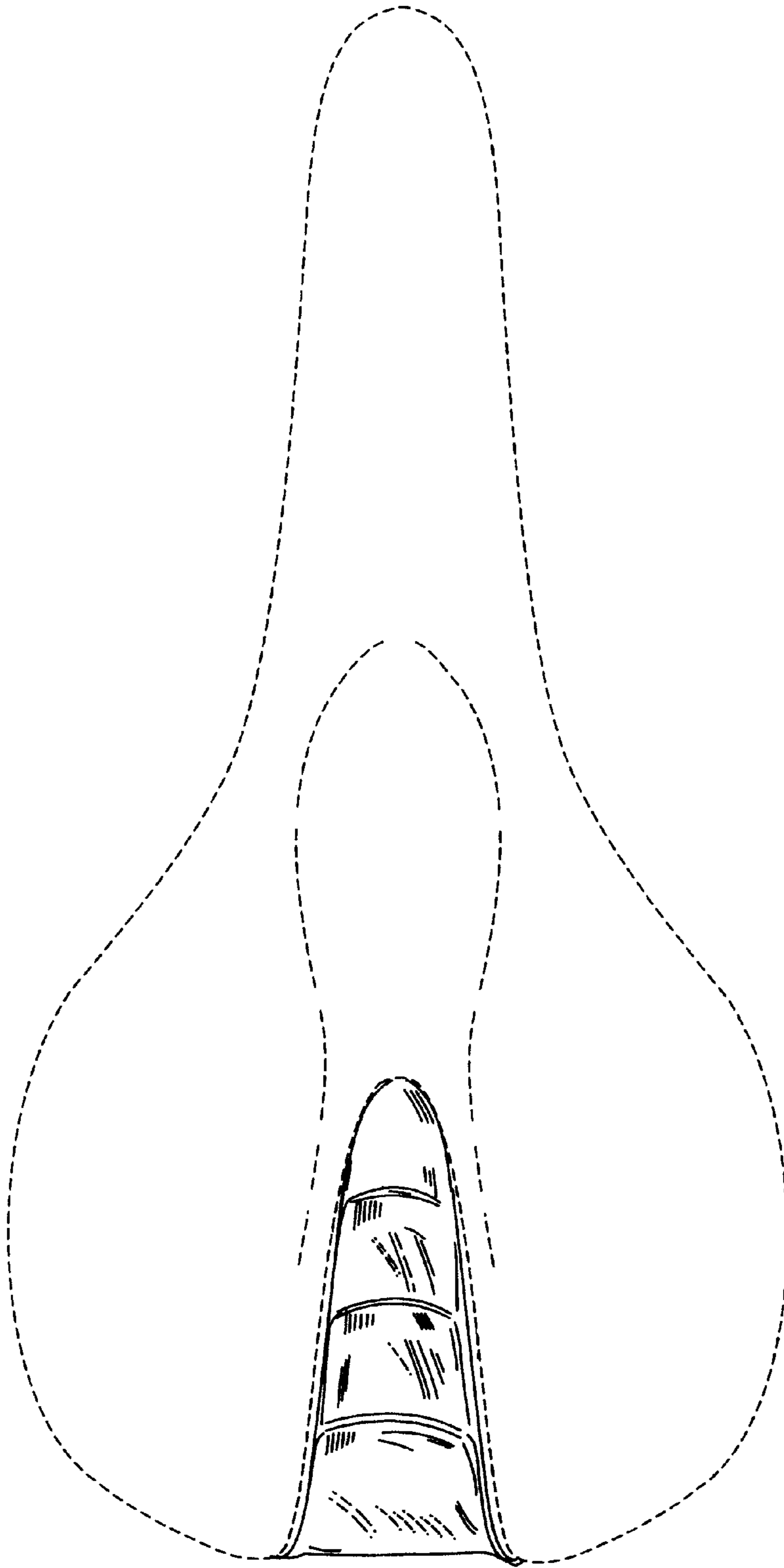

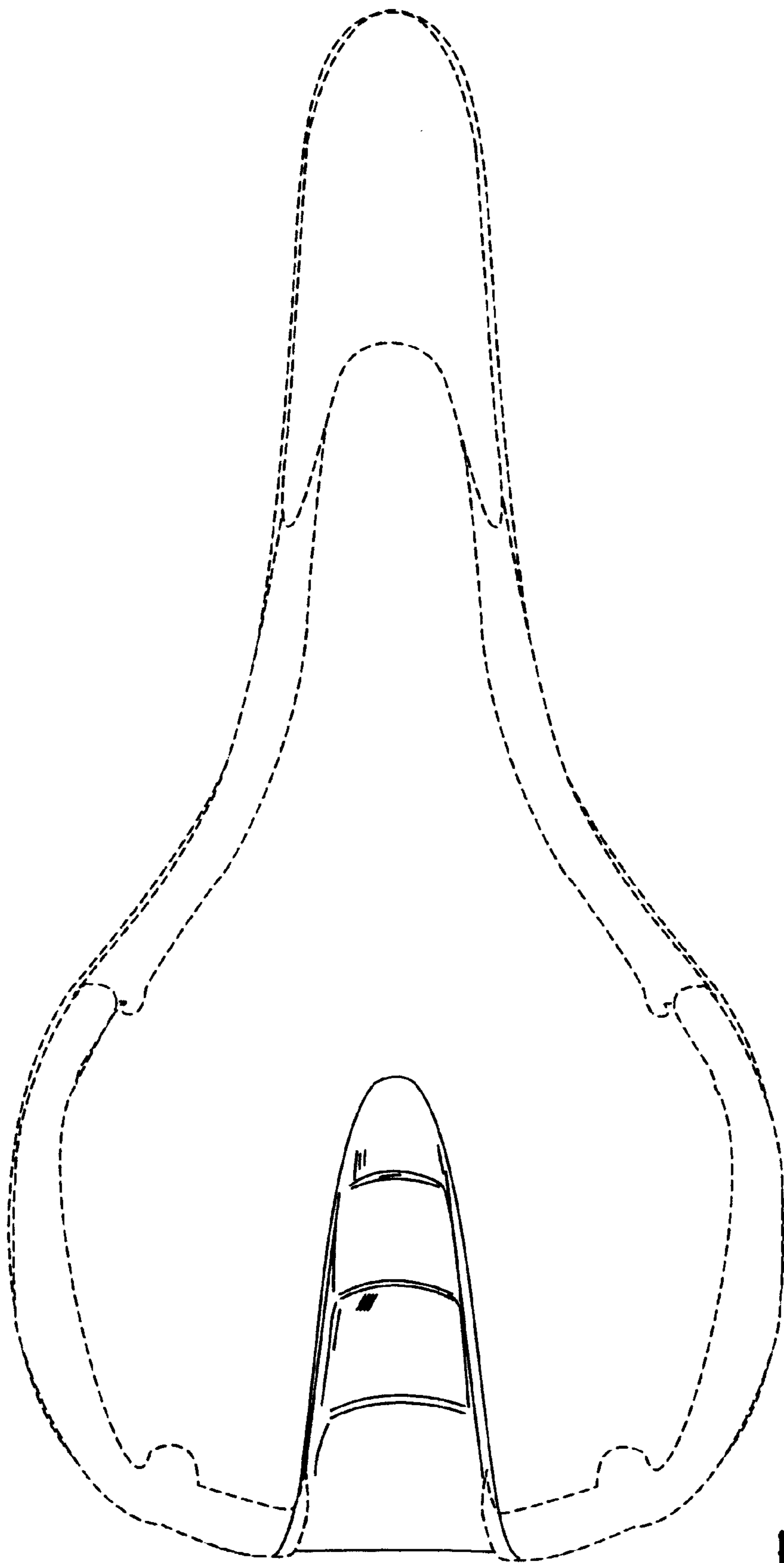

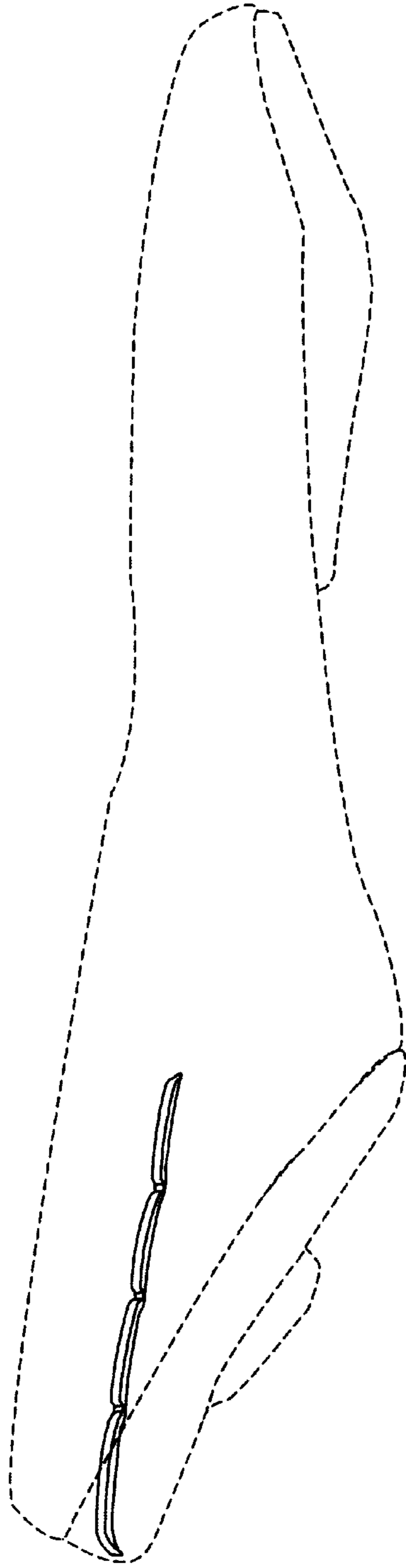

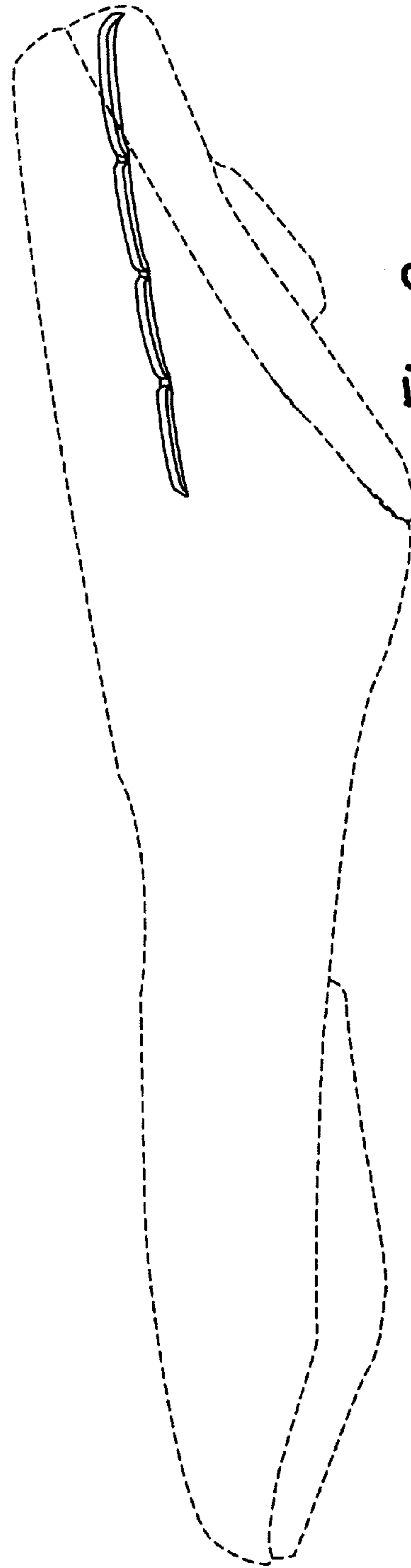
