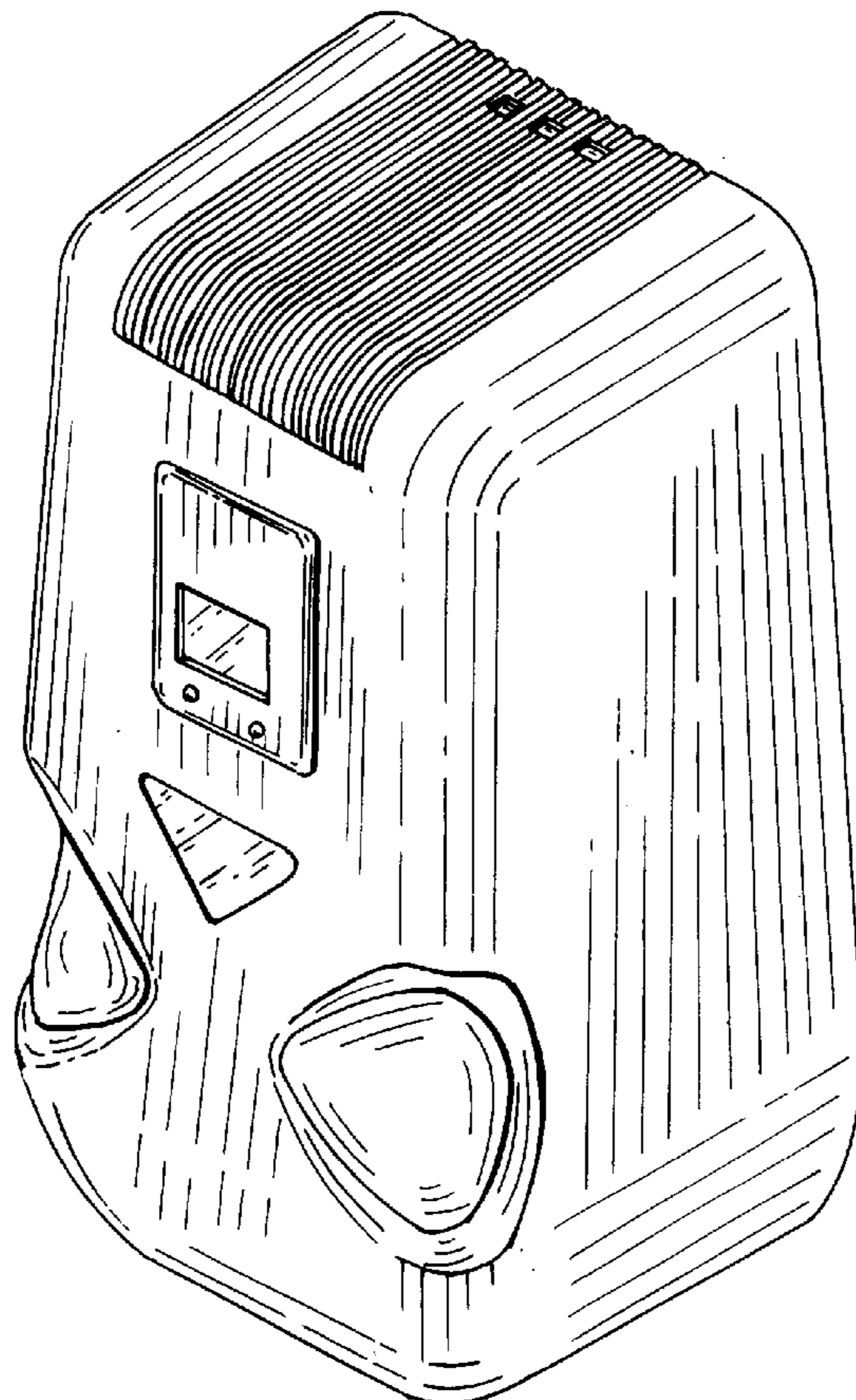
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the hands free I soap dispenser with clock embodying our new design;
 FIG. 2 is a front view of the hands free soap dispenser with clock illustrated in FIG. 1;

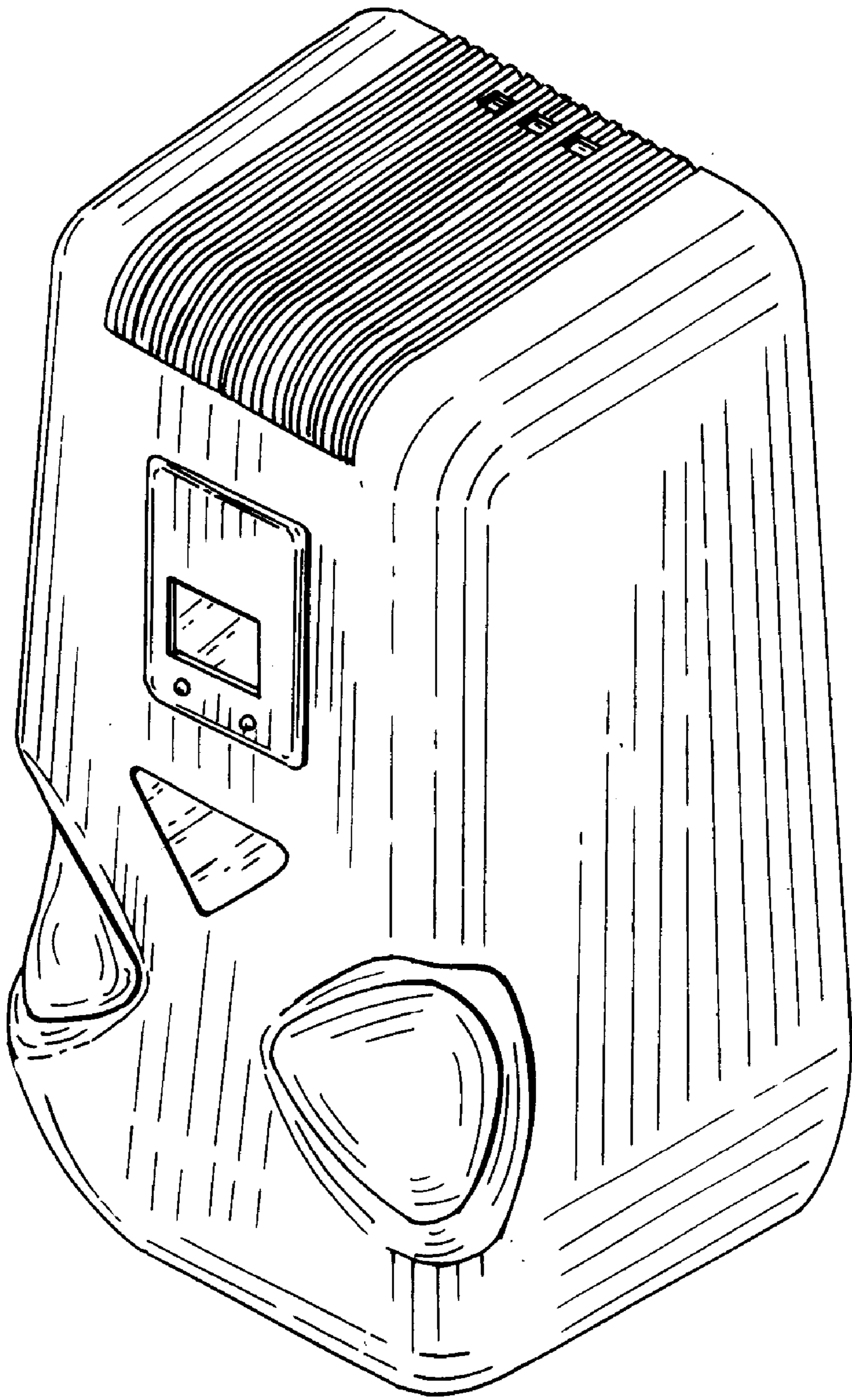

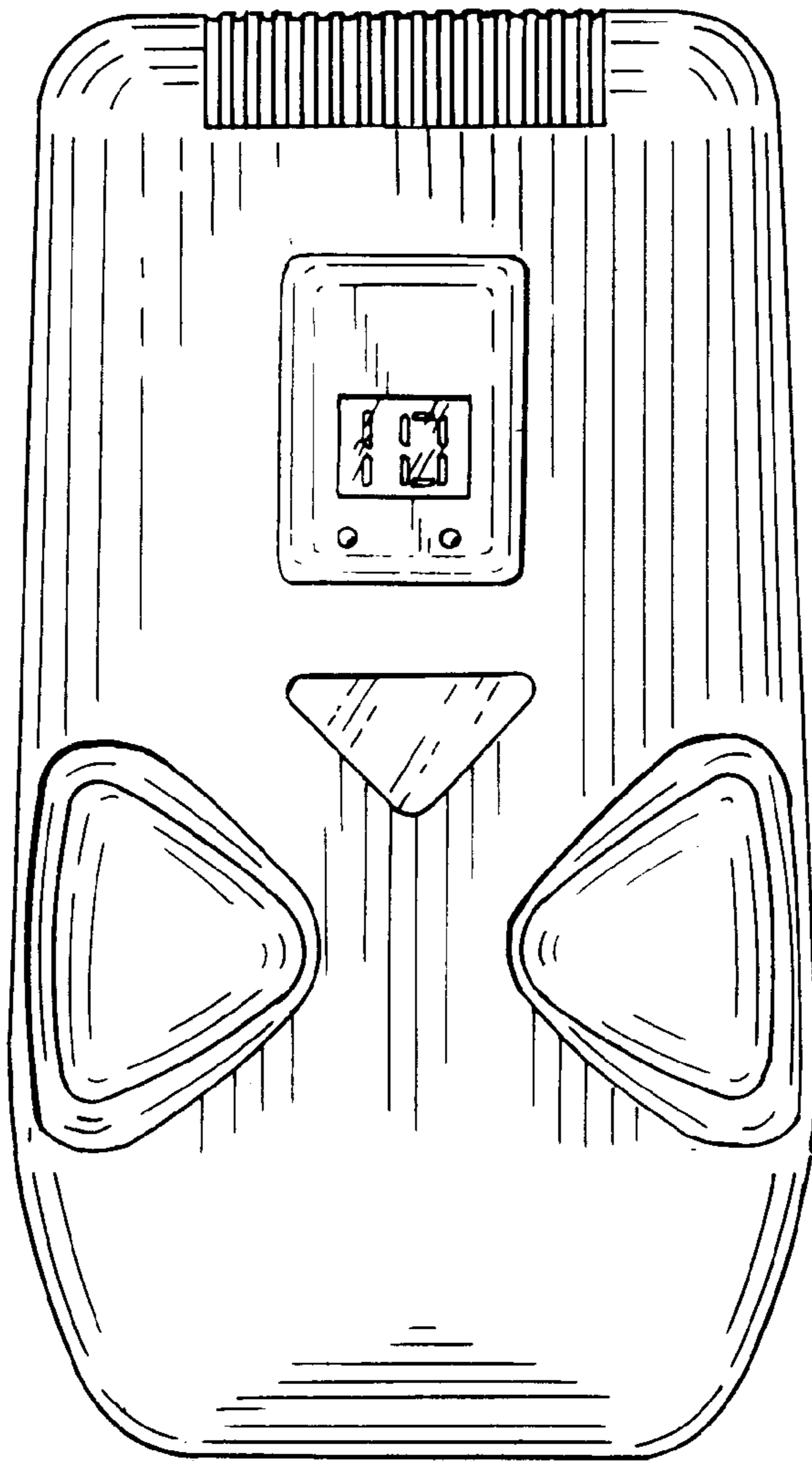

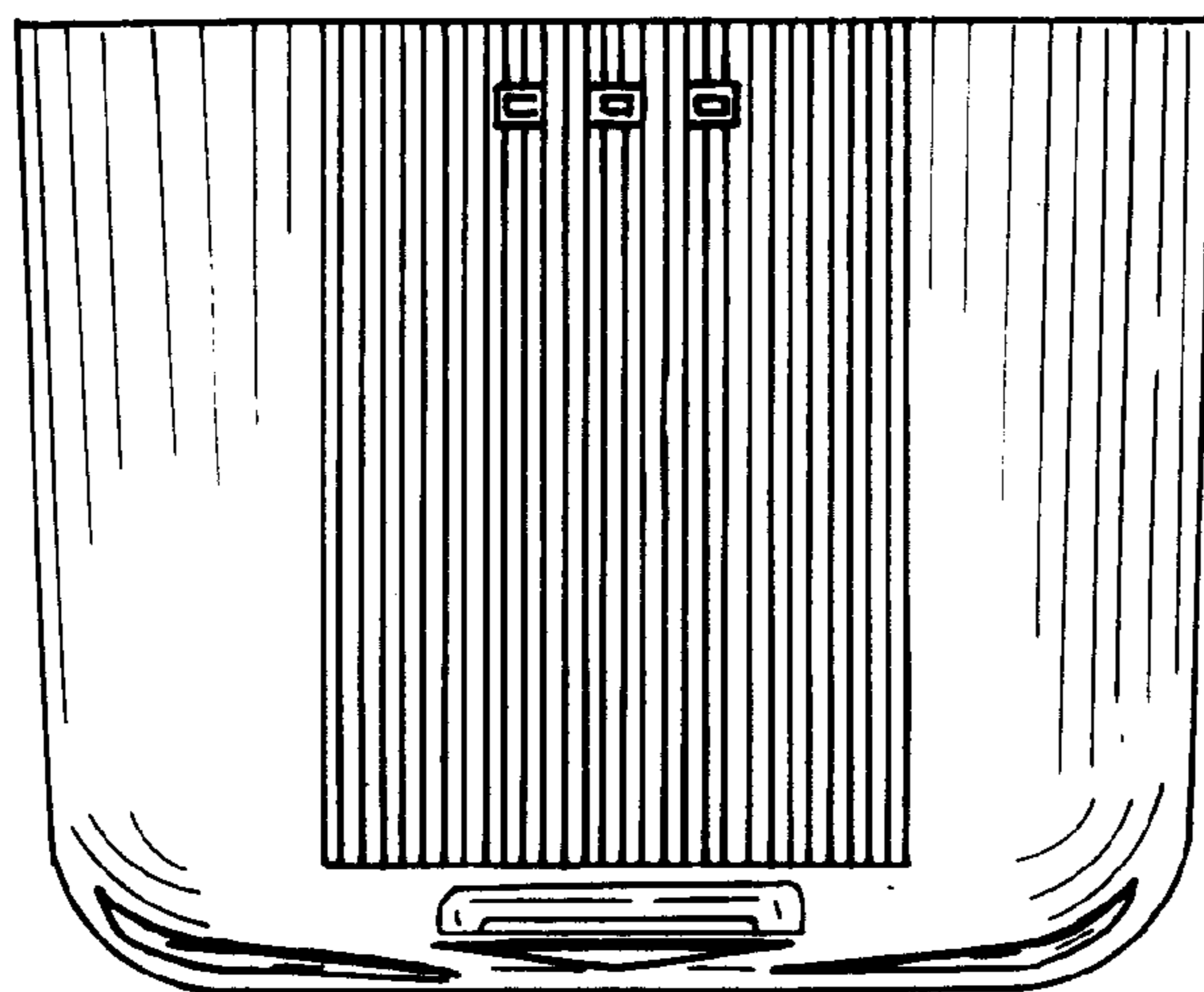

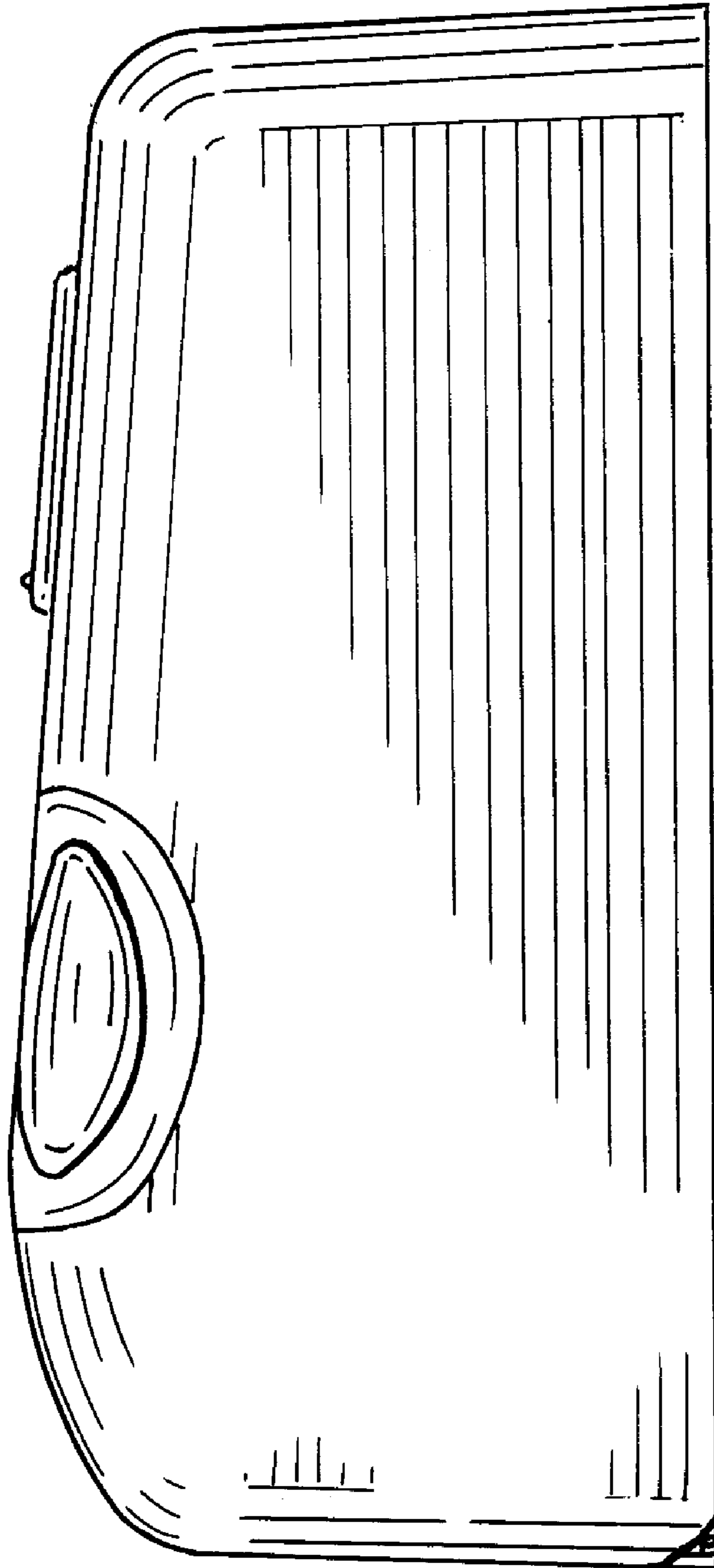

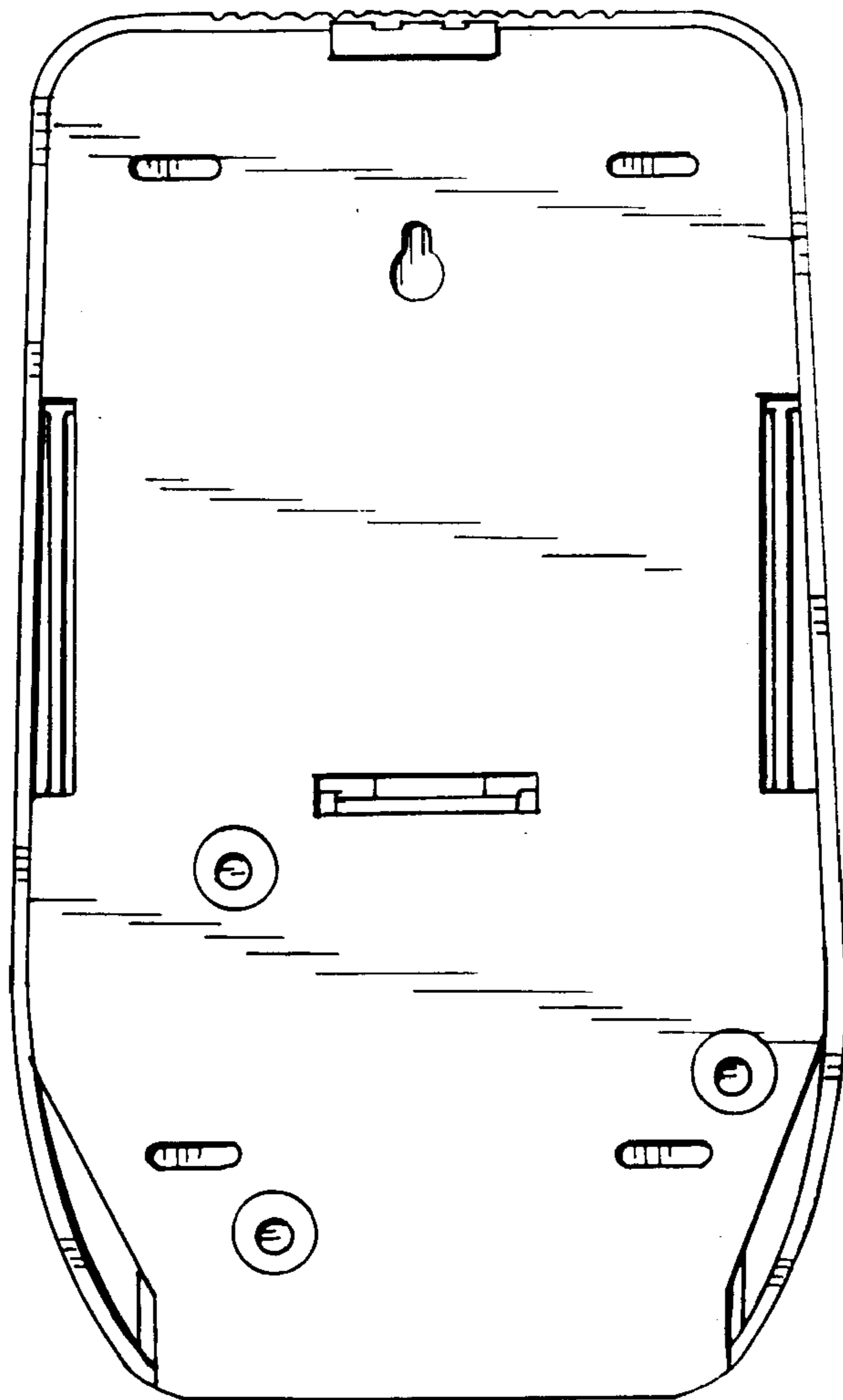

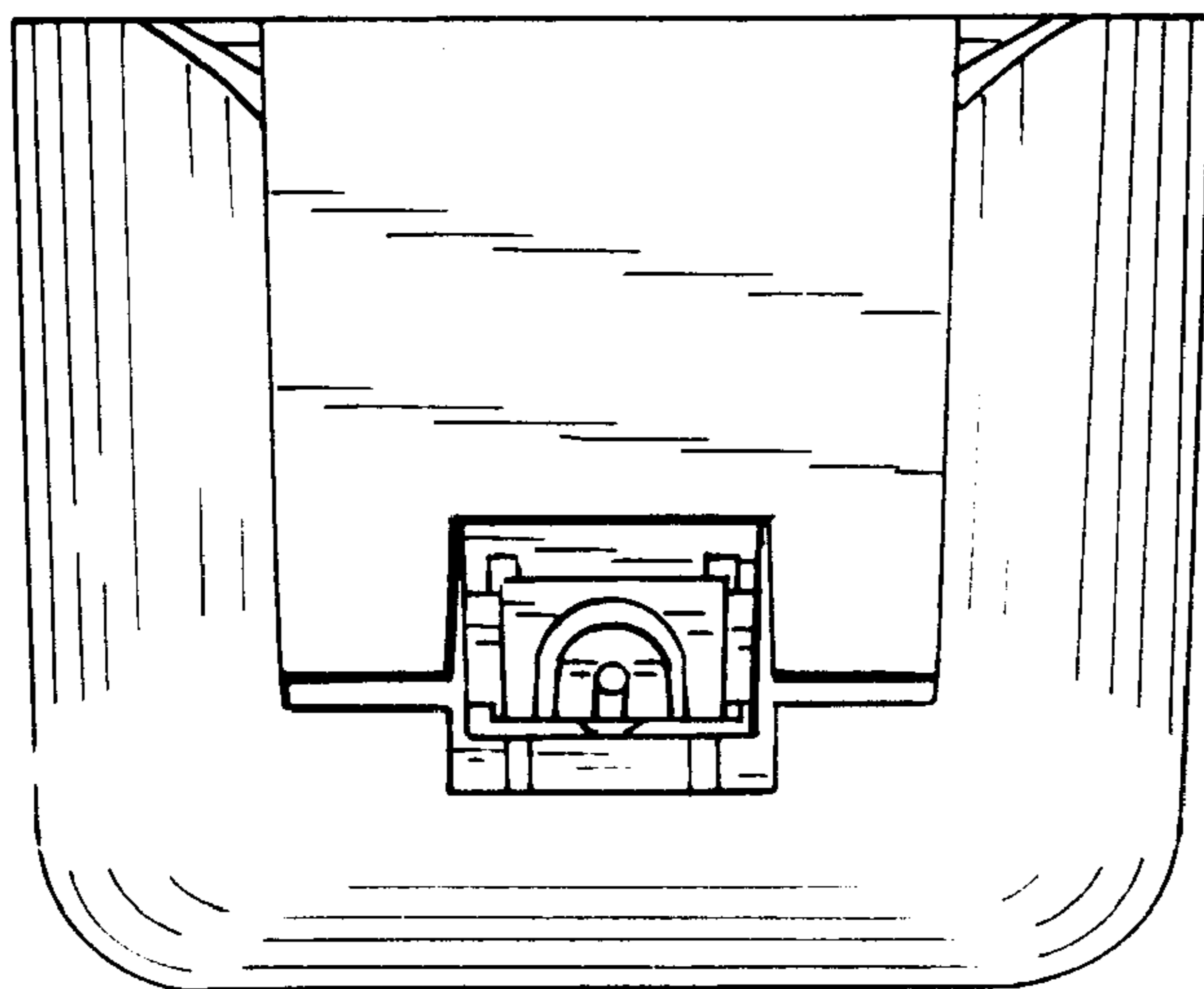
