DESCRIPTION

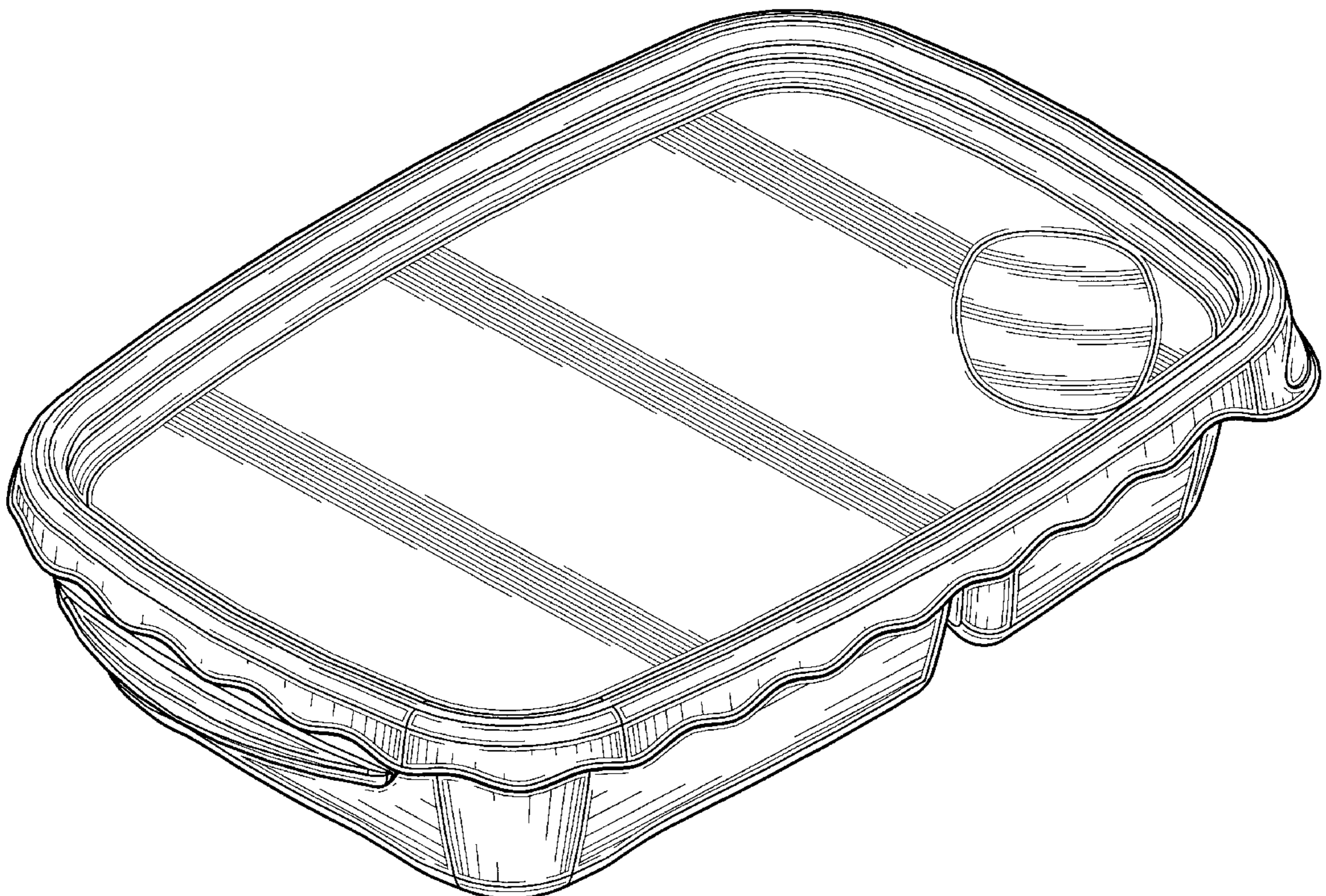
FIG. 1 is a top, left rear perspective view of a container showing my new design;

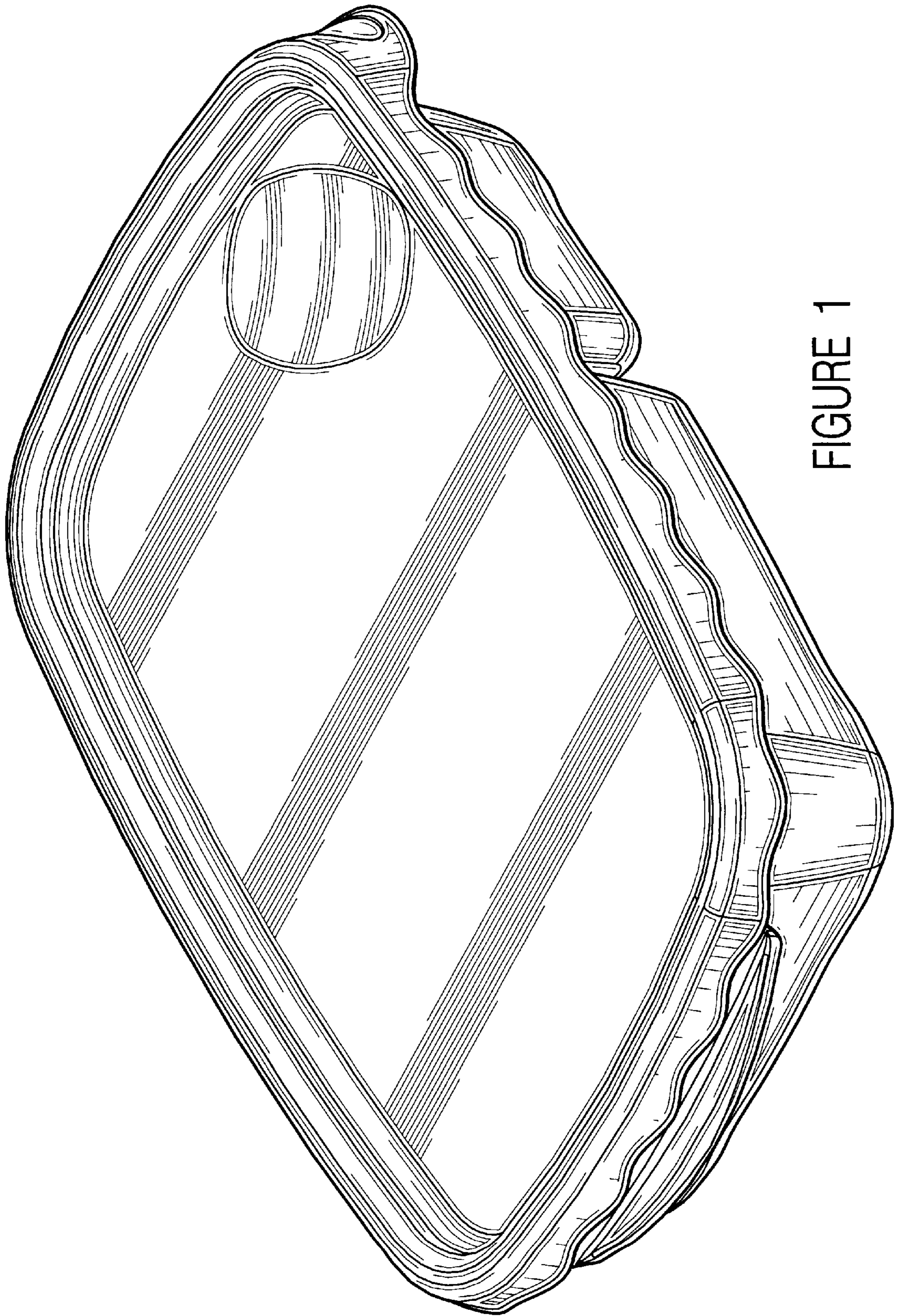

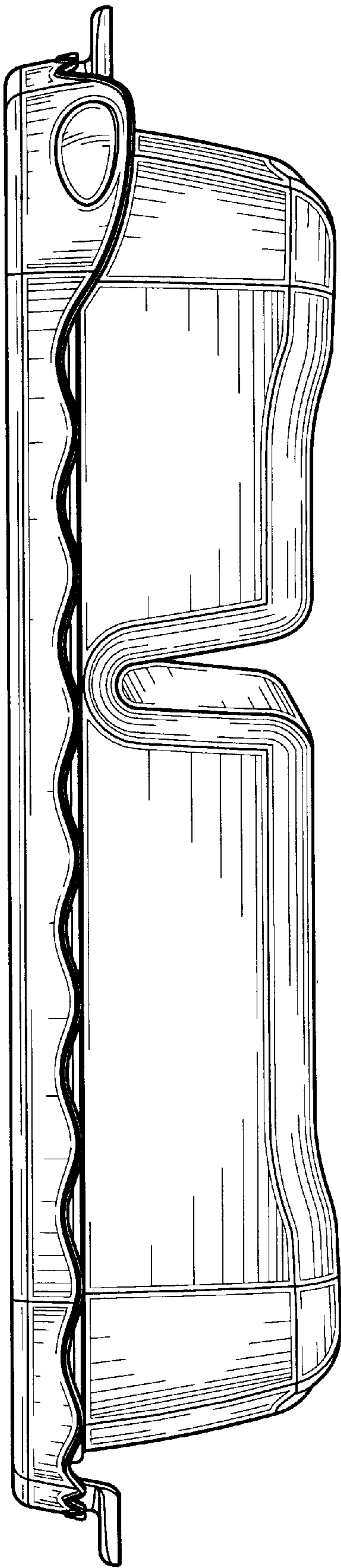

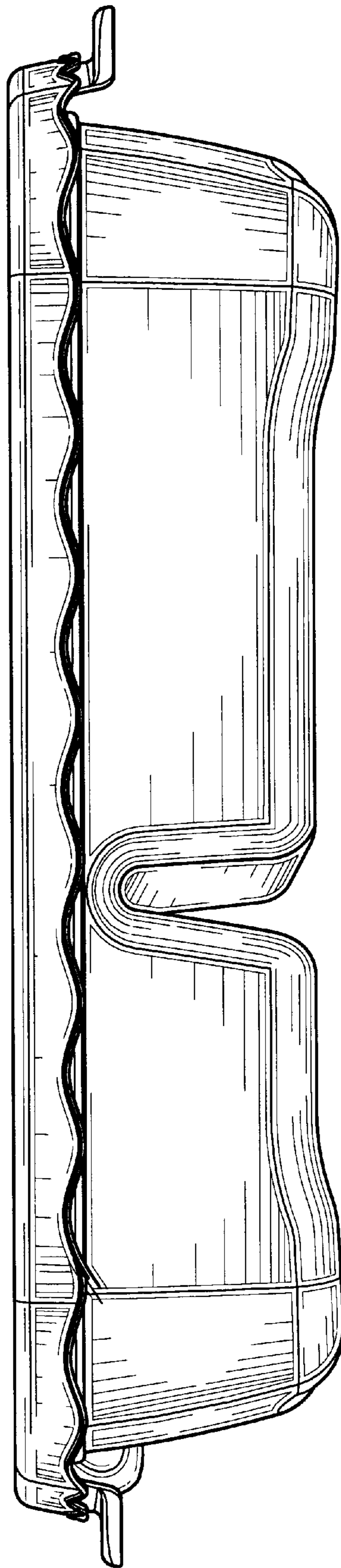

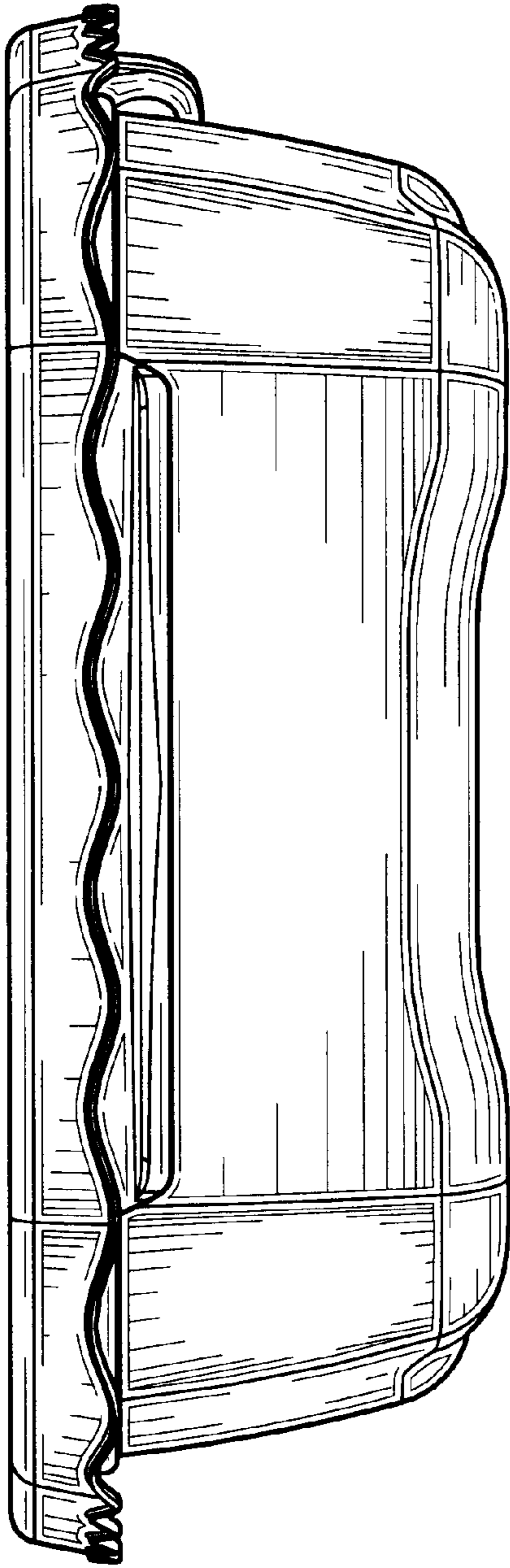

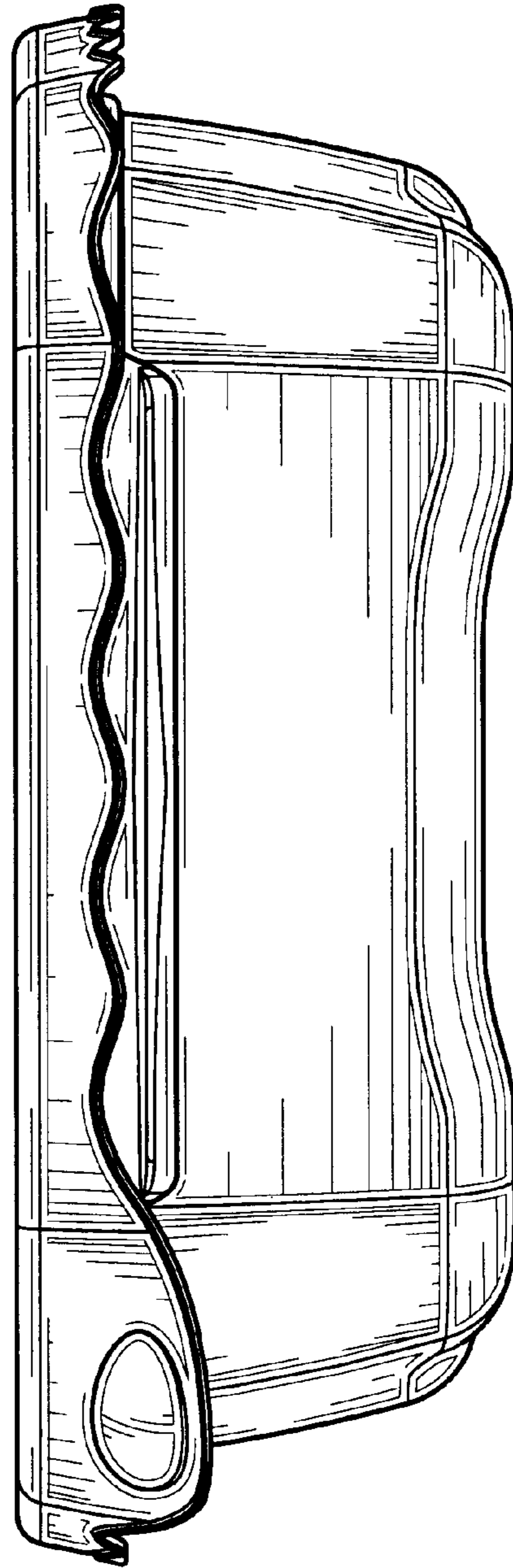

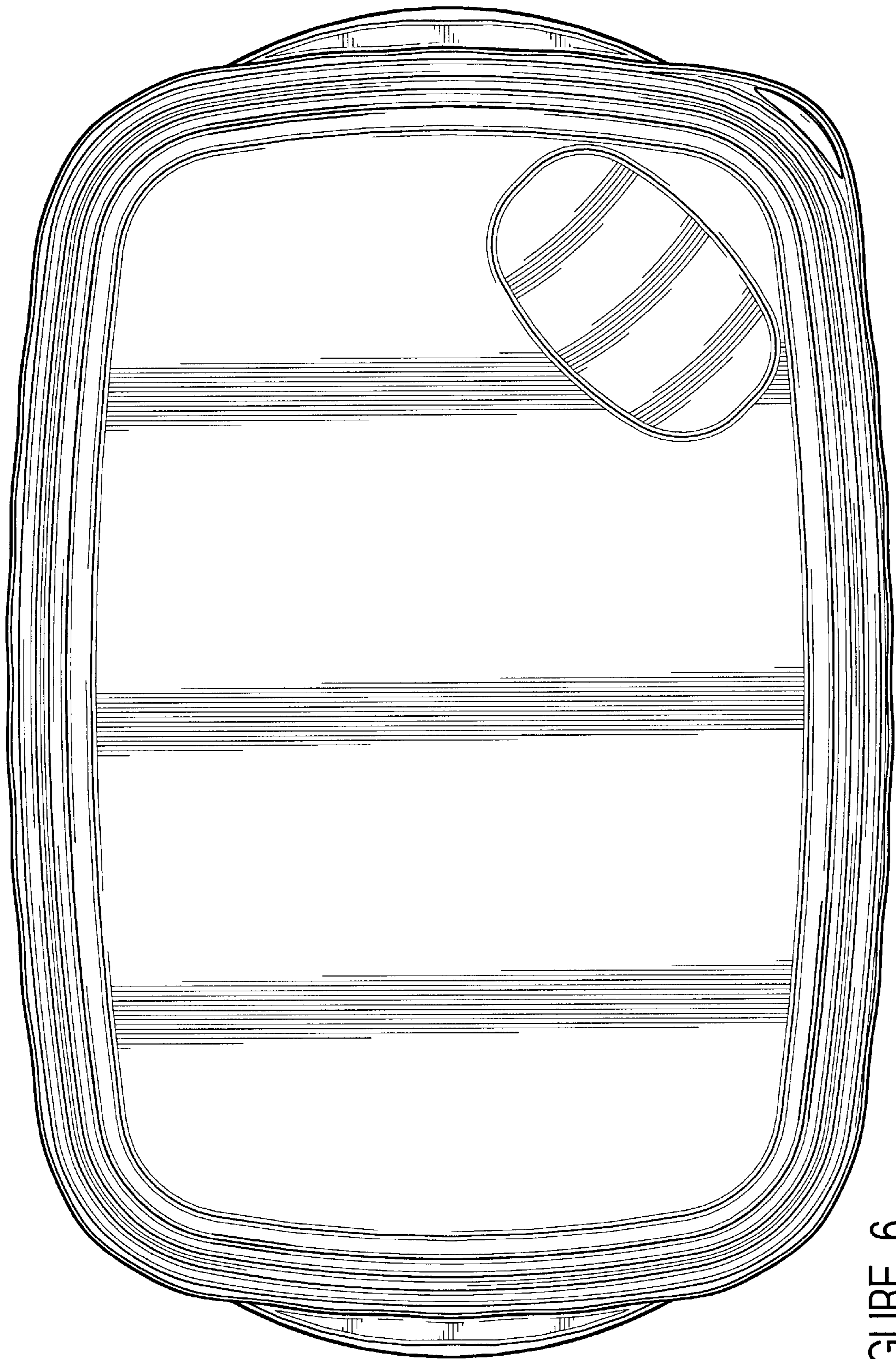

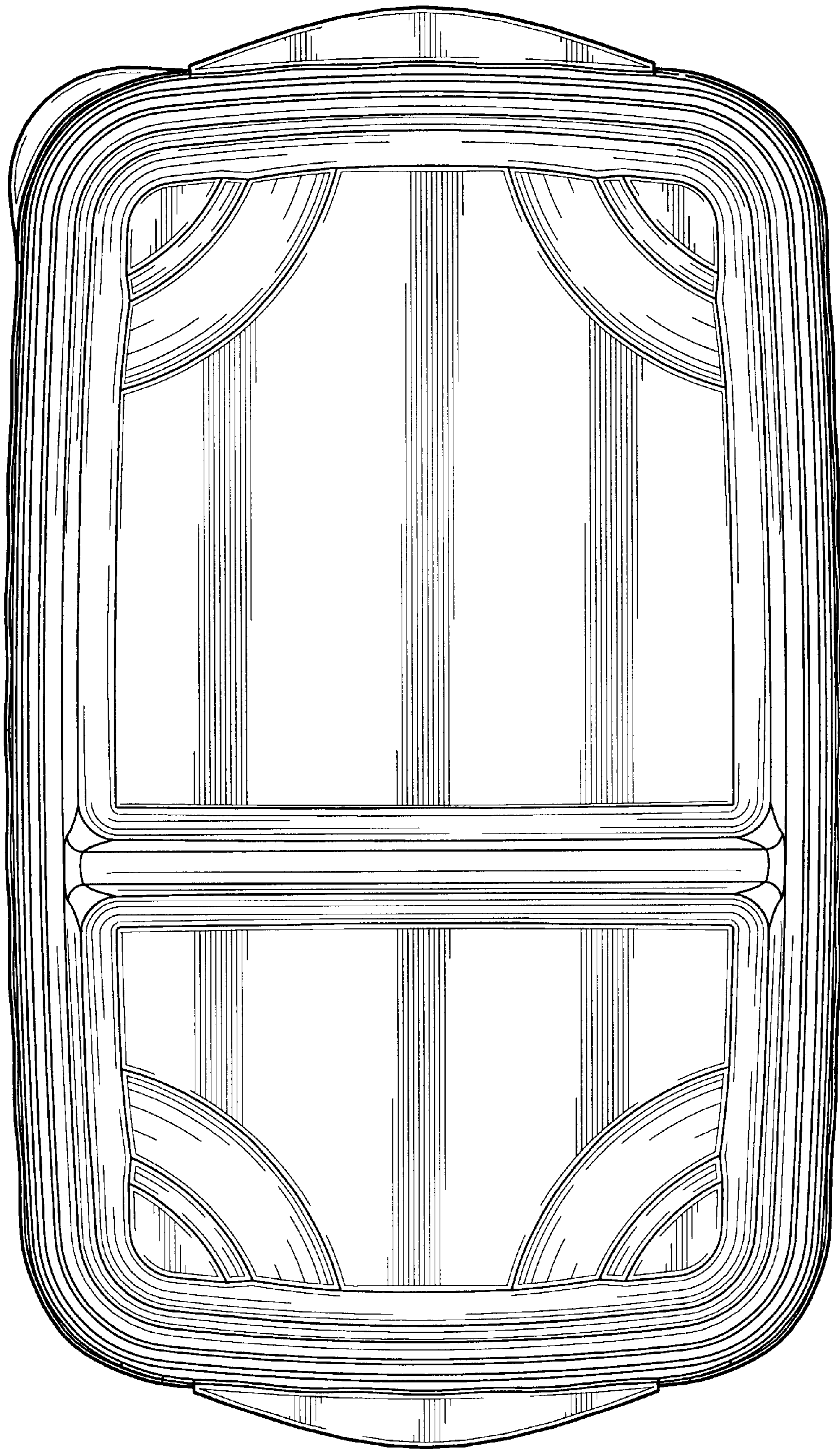
