FIG. 4 is a front elevational view thereof;

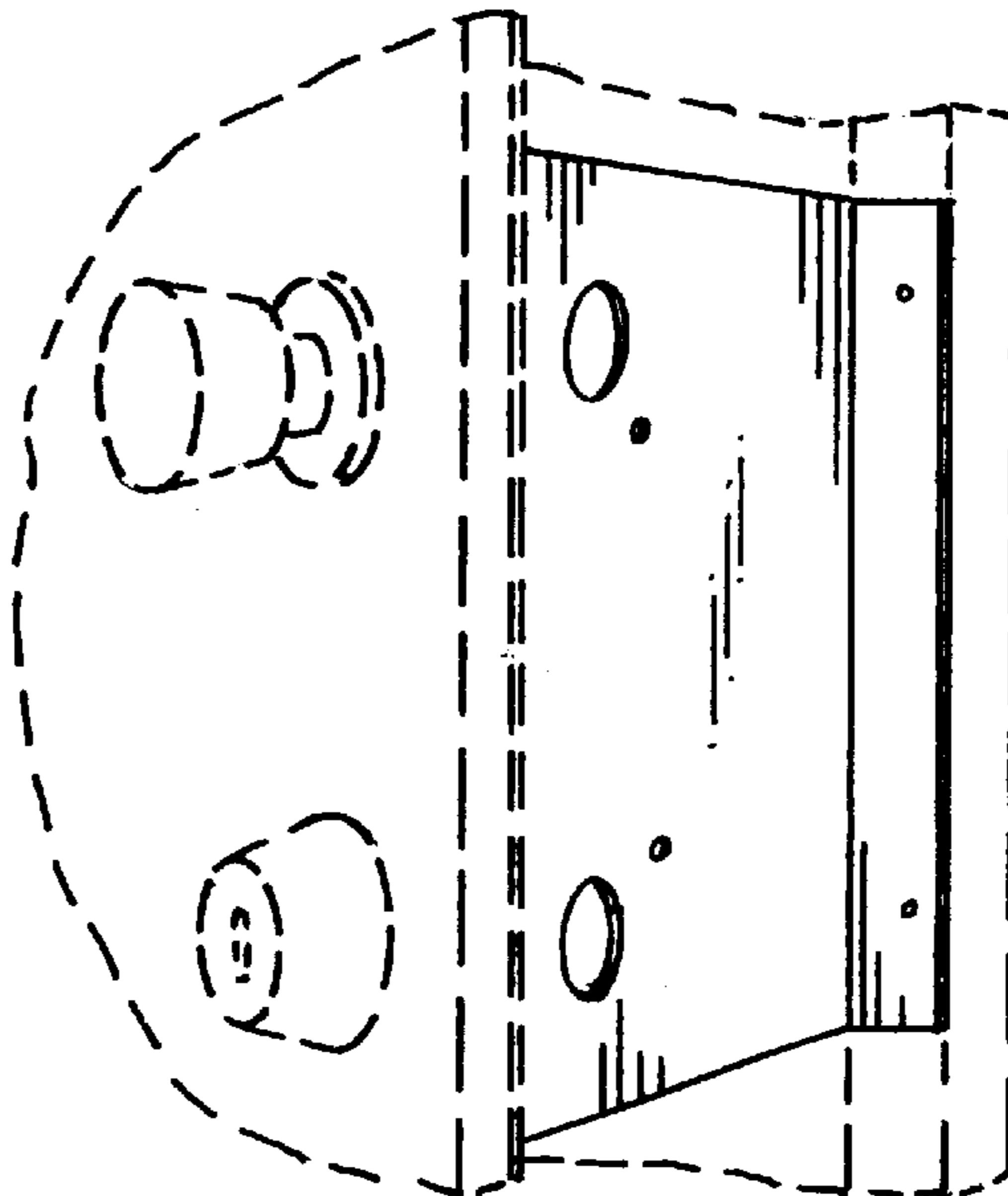
FIG. 5 is a rear elevational view thereof;

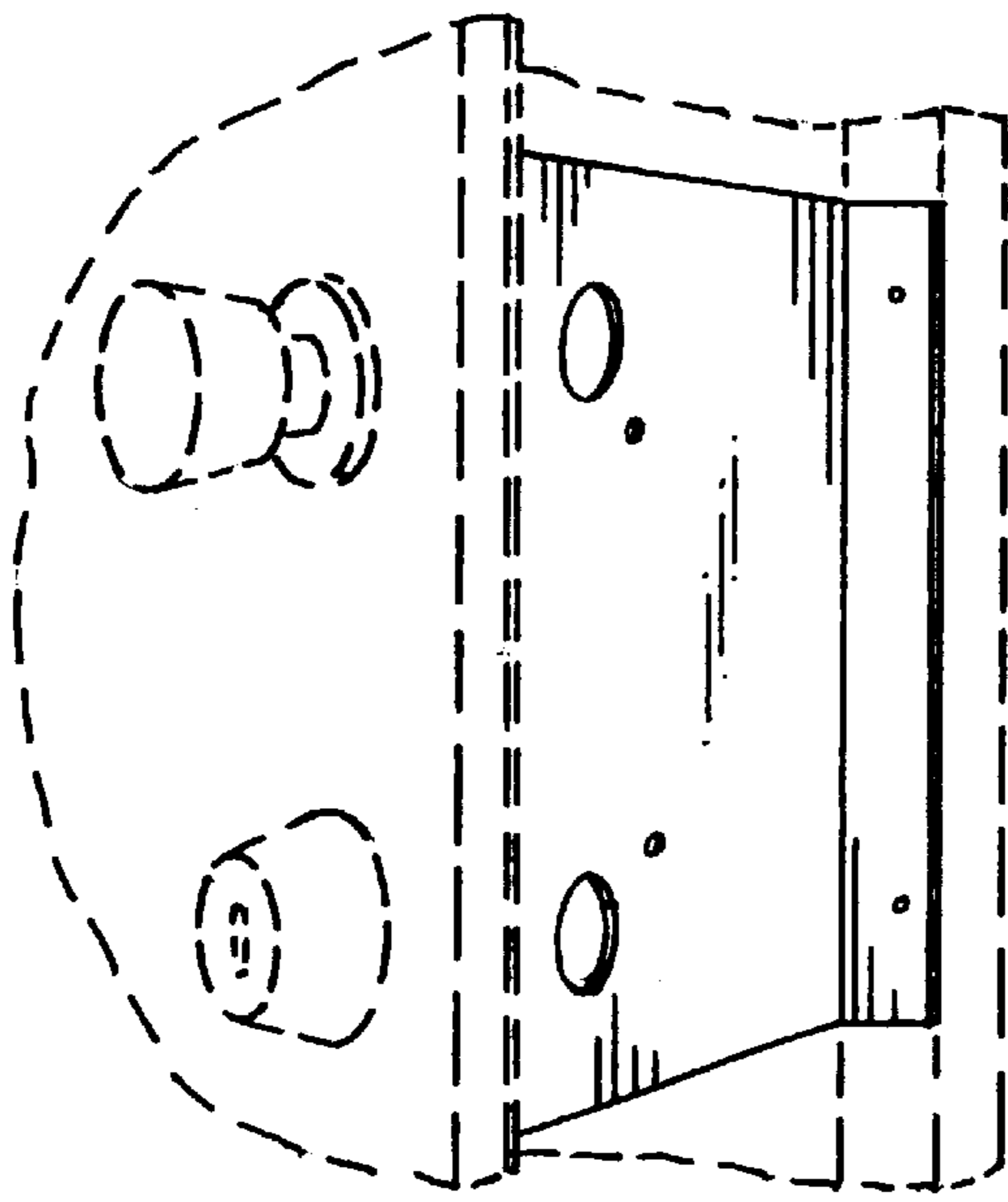
FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

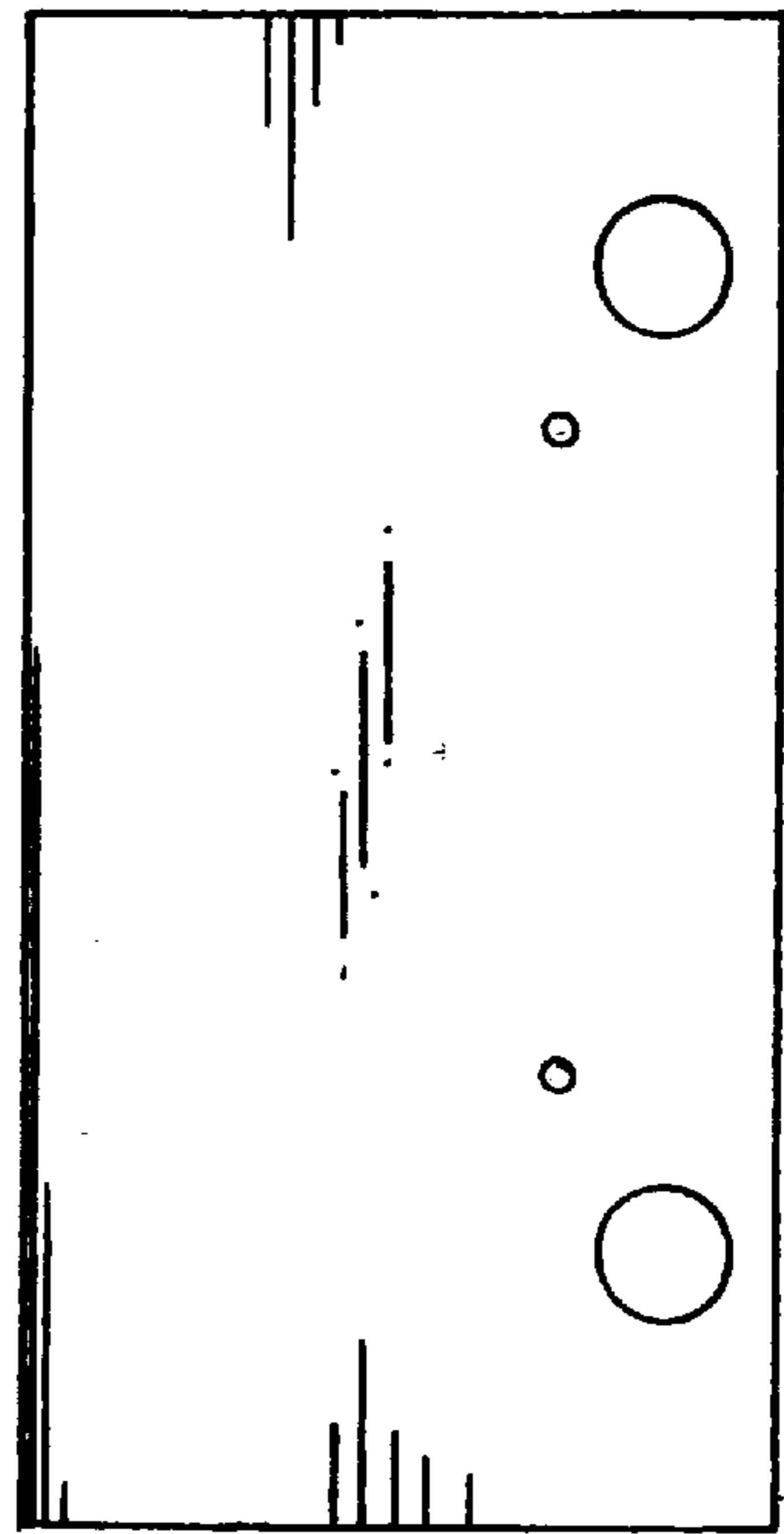
The dashed line showing of environment in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

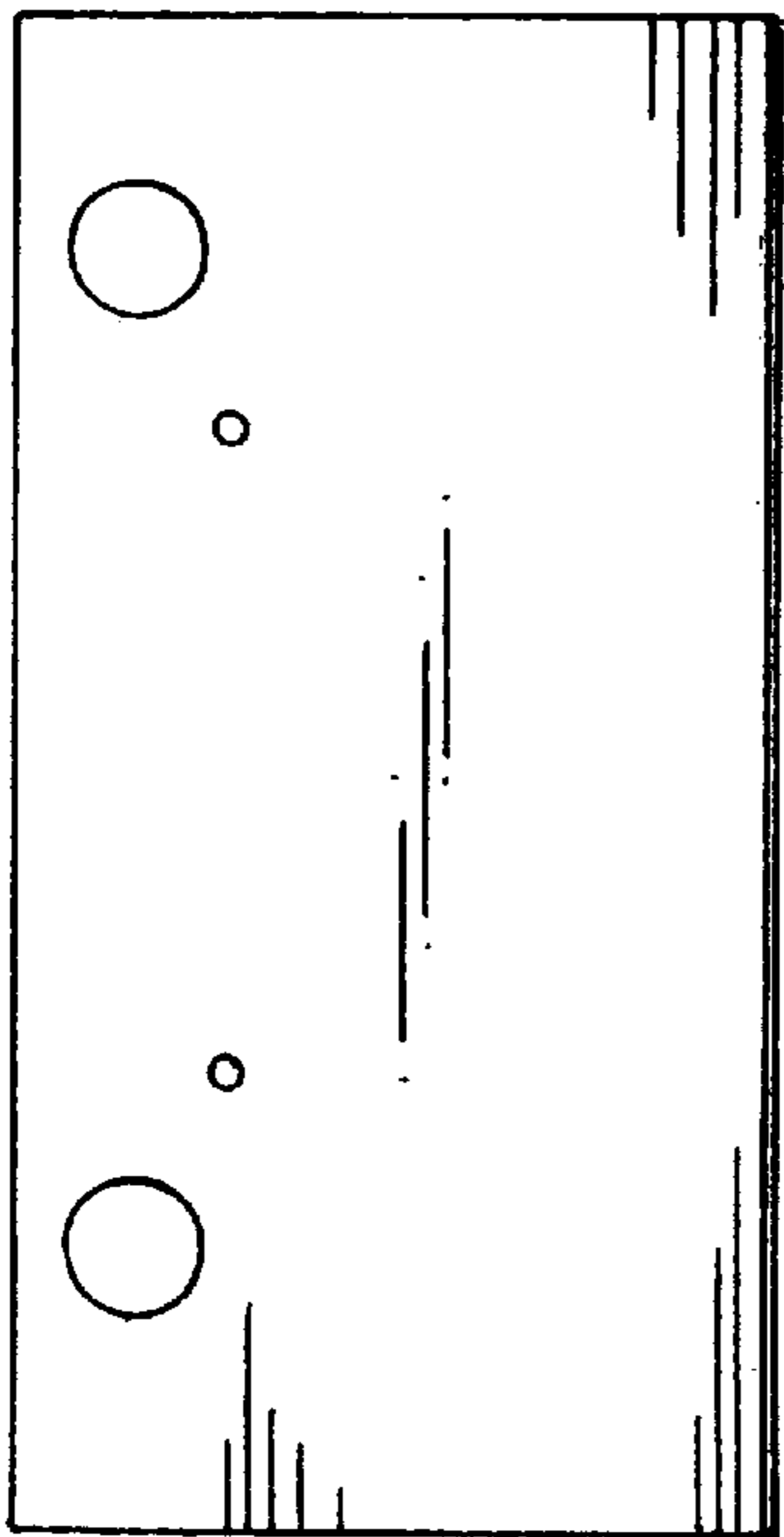




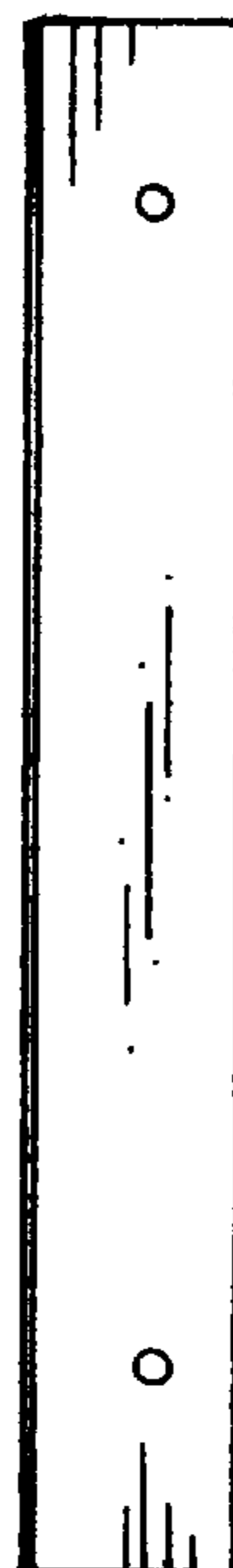

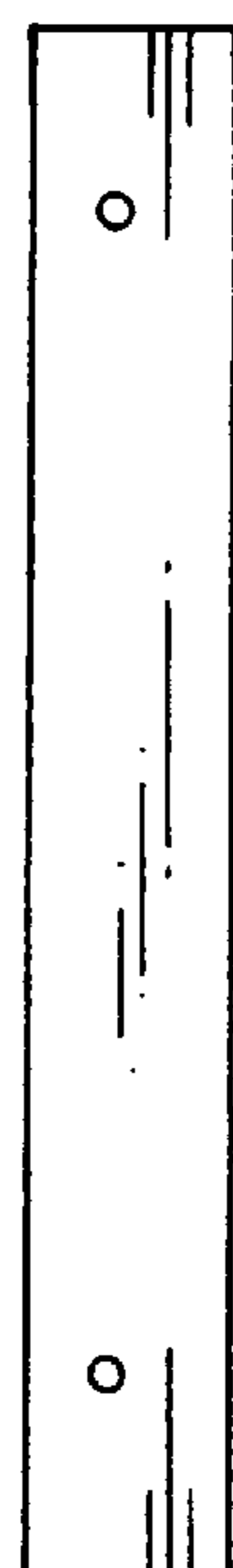

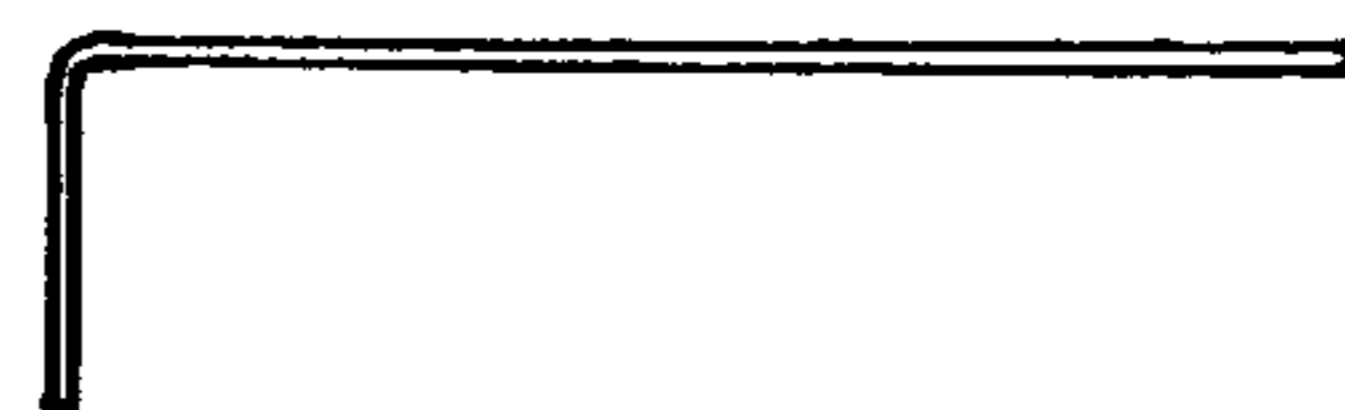
