(57) **CLAIM**

The ornamental design for a ceiling hanger, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the ceiling hanger showing our new design;

FIG. 2 is a bottom plan view of the ceiling hanger;

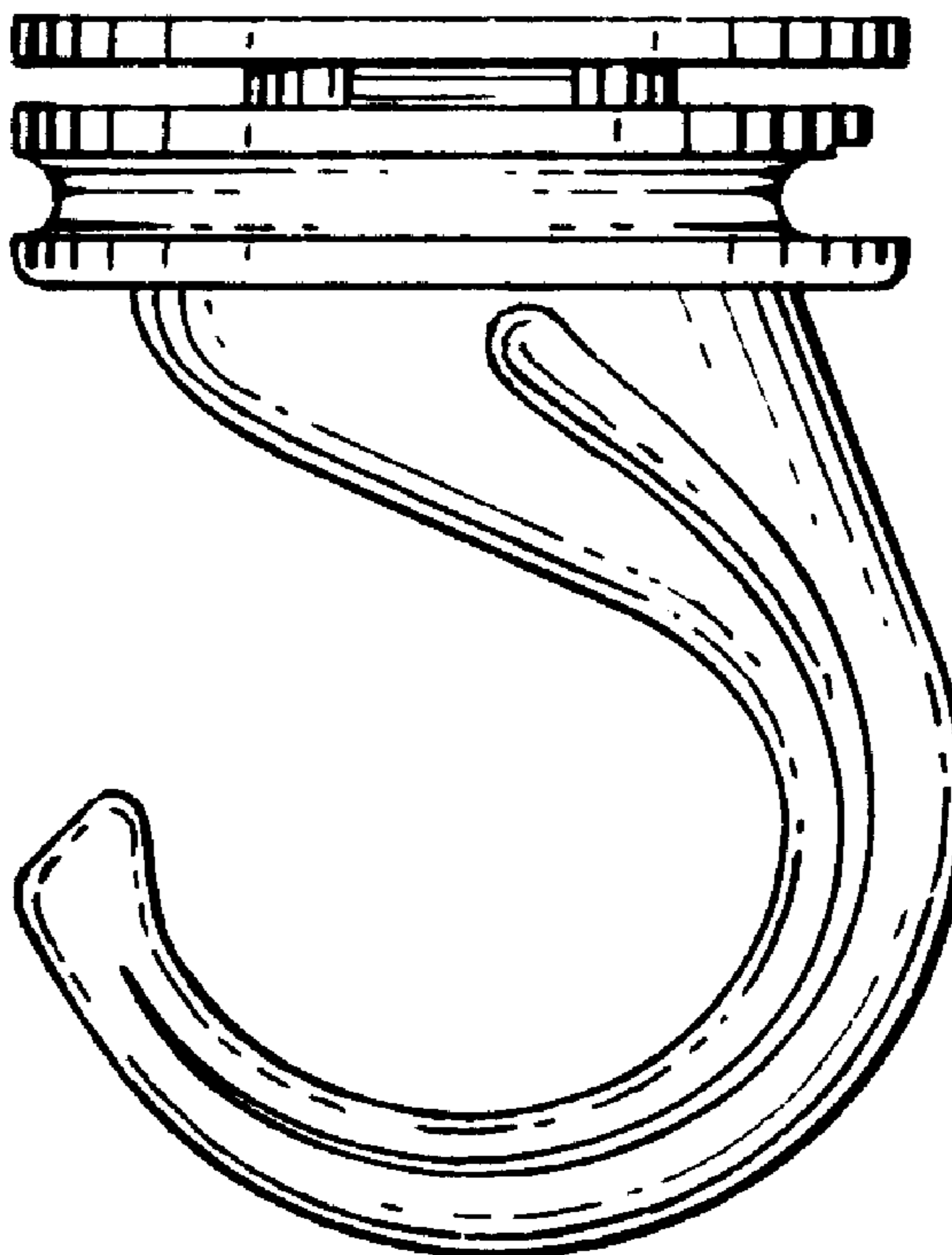
FIG. 3 is a left side view of the ceiling hanger, showing the hook member and the anchor member thereof in an unassembled position;

FIG. 4 is a right side view of the ceiling hanger, showing the hook member and the anchor member thereof in an unassembled position; and,

FIG. 5 is a rear view of the ceiling hanger, showing the hook member and the anchor member thereof in an unassembled position.

The elements of the claimed design are shown detached in FIGS. 3 to 5 for clarity of illustration.

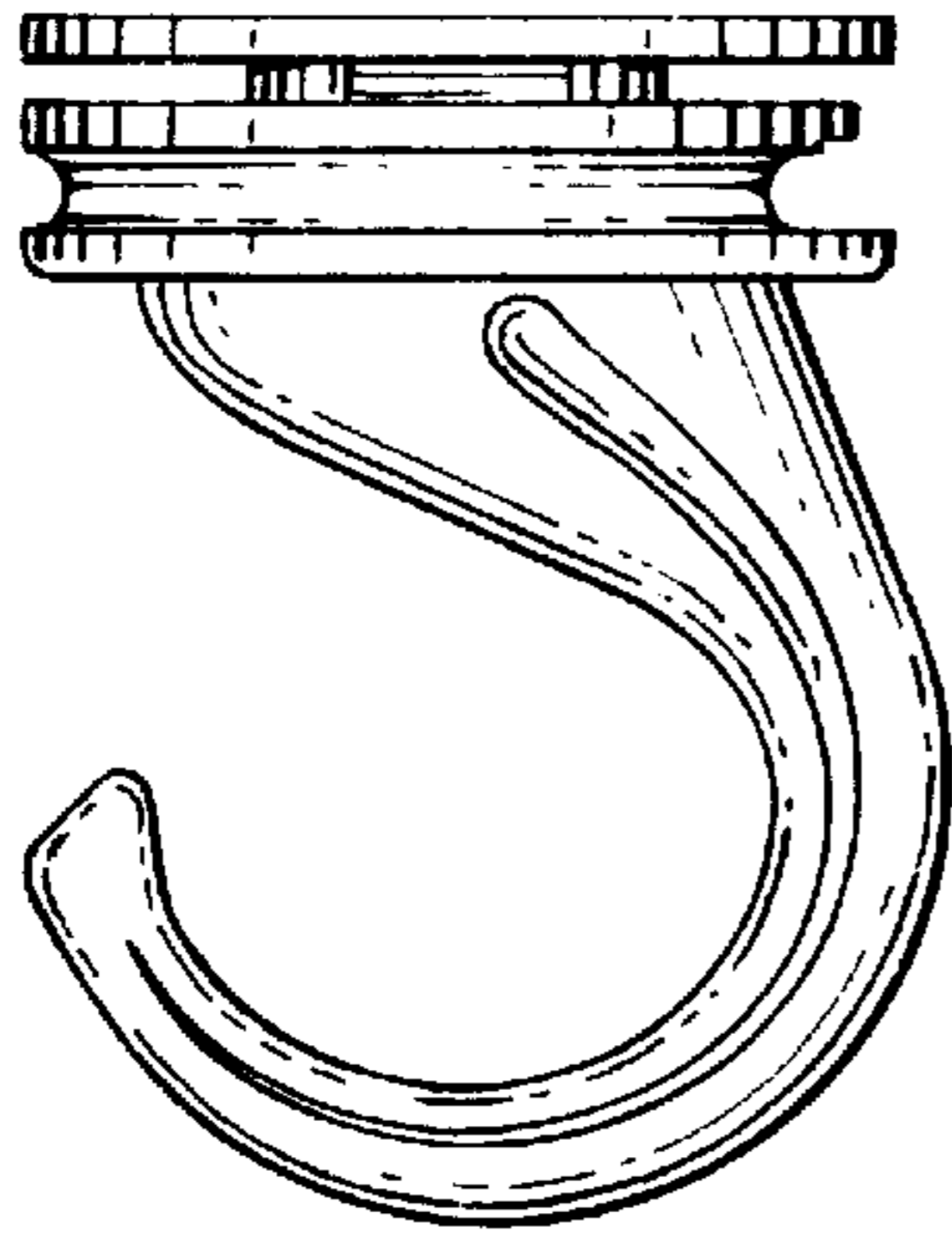

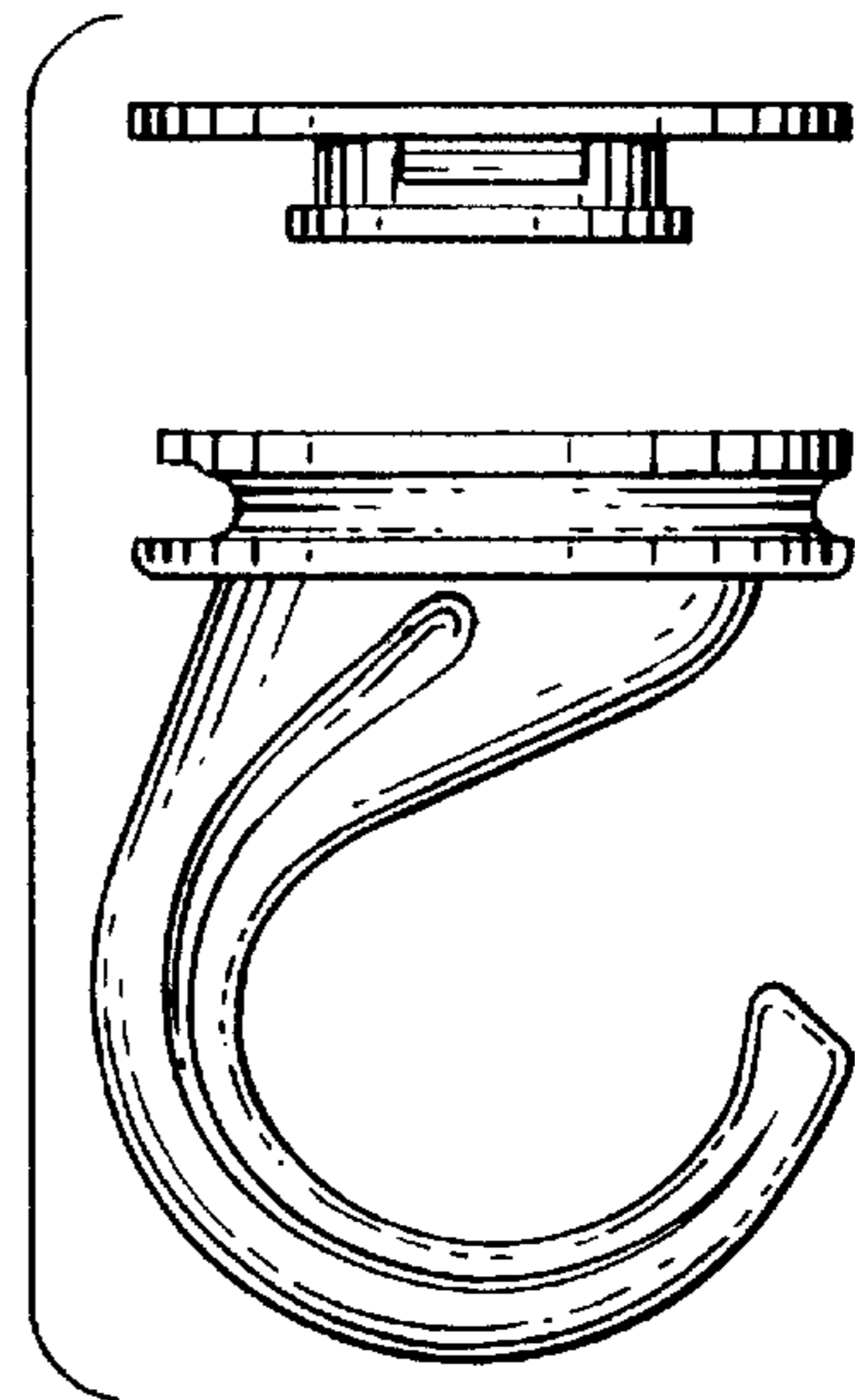

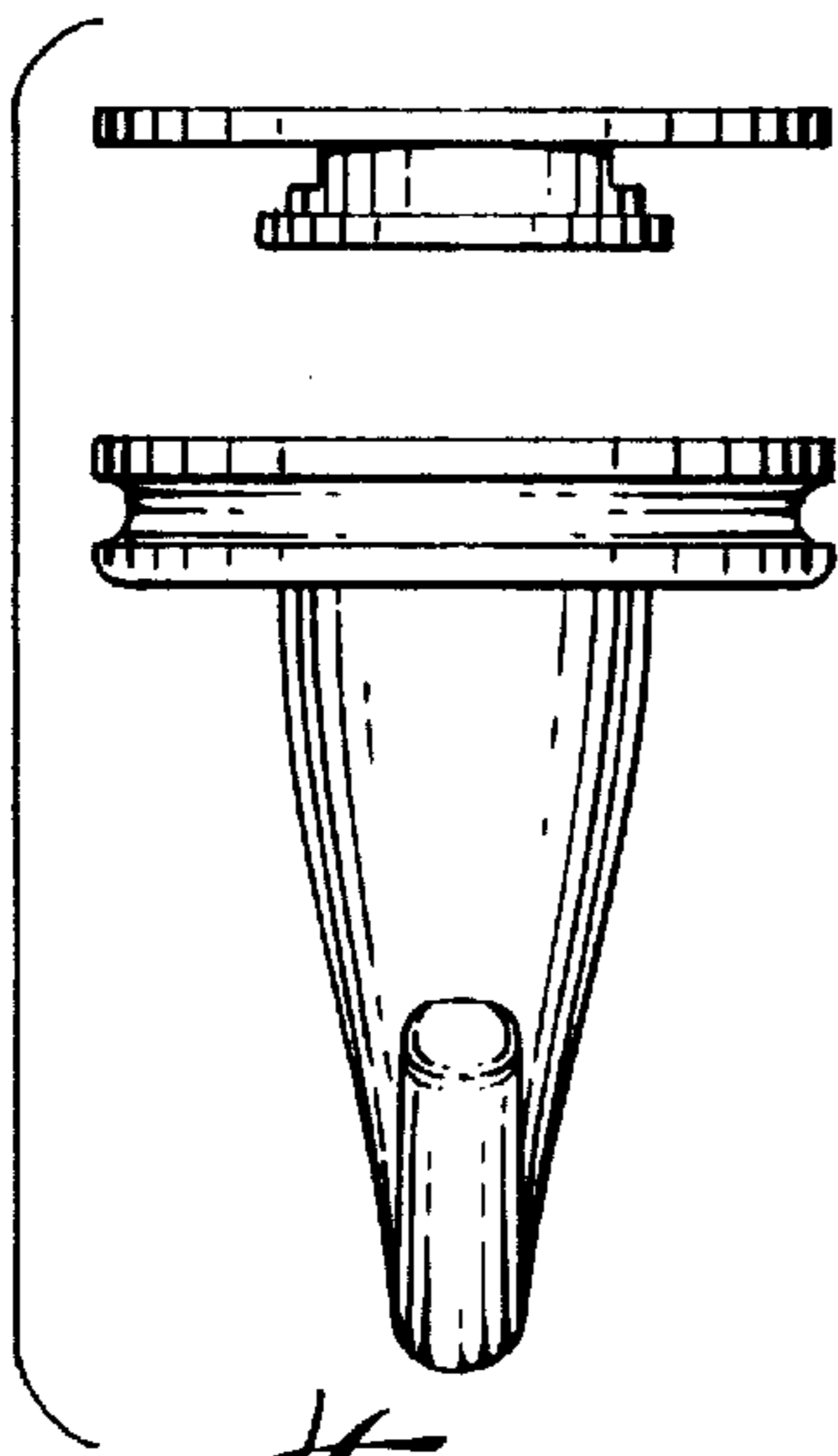

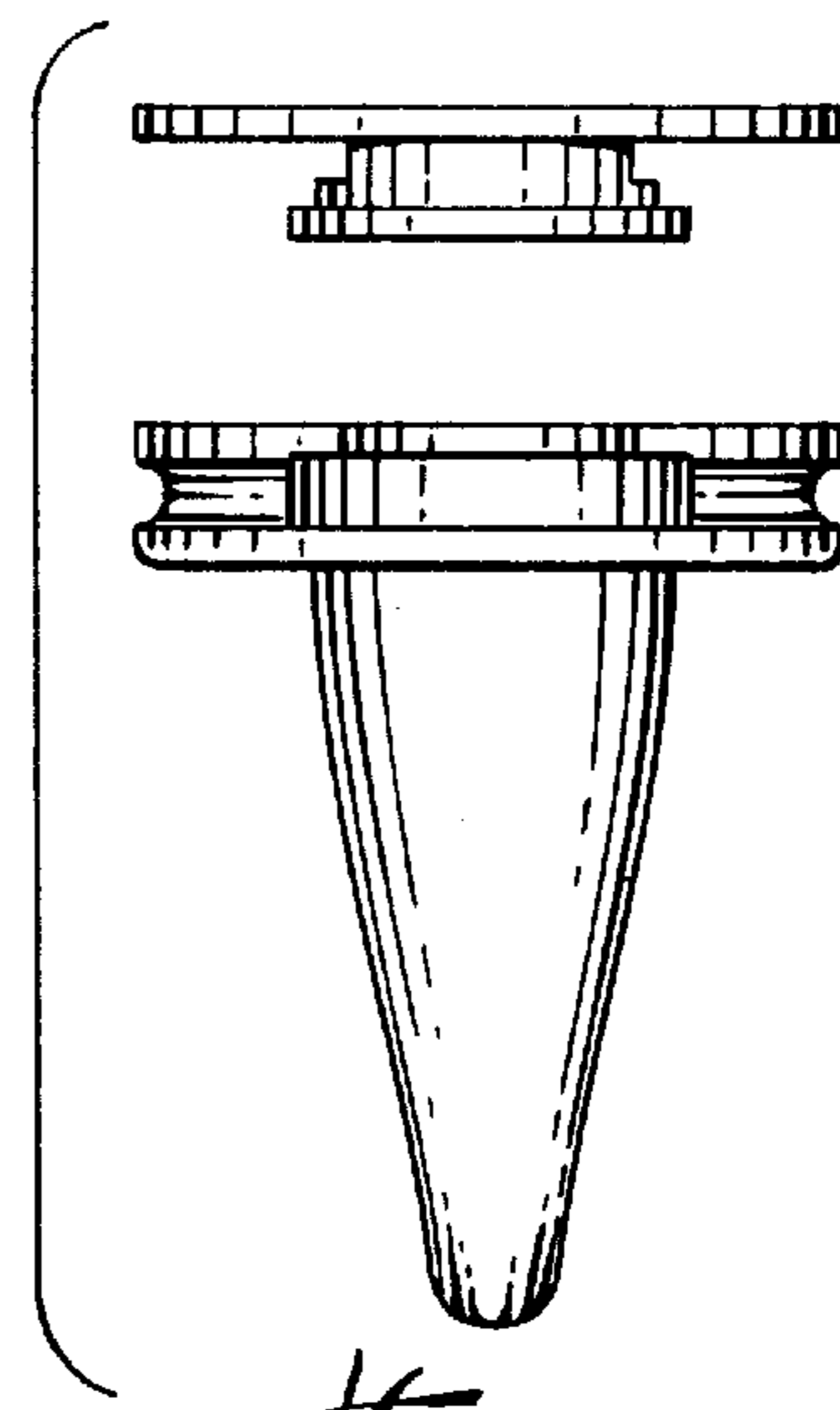

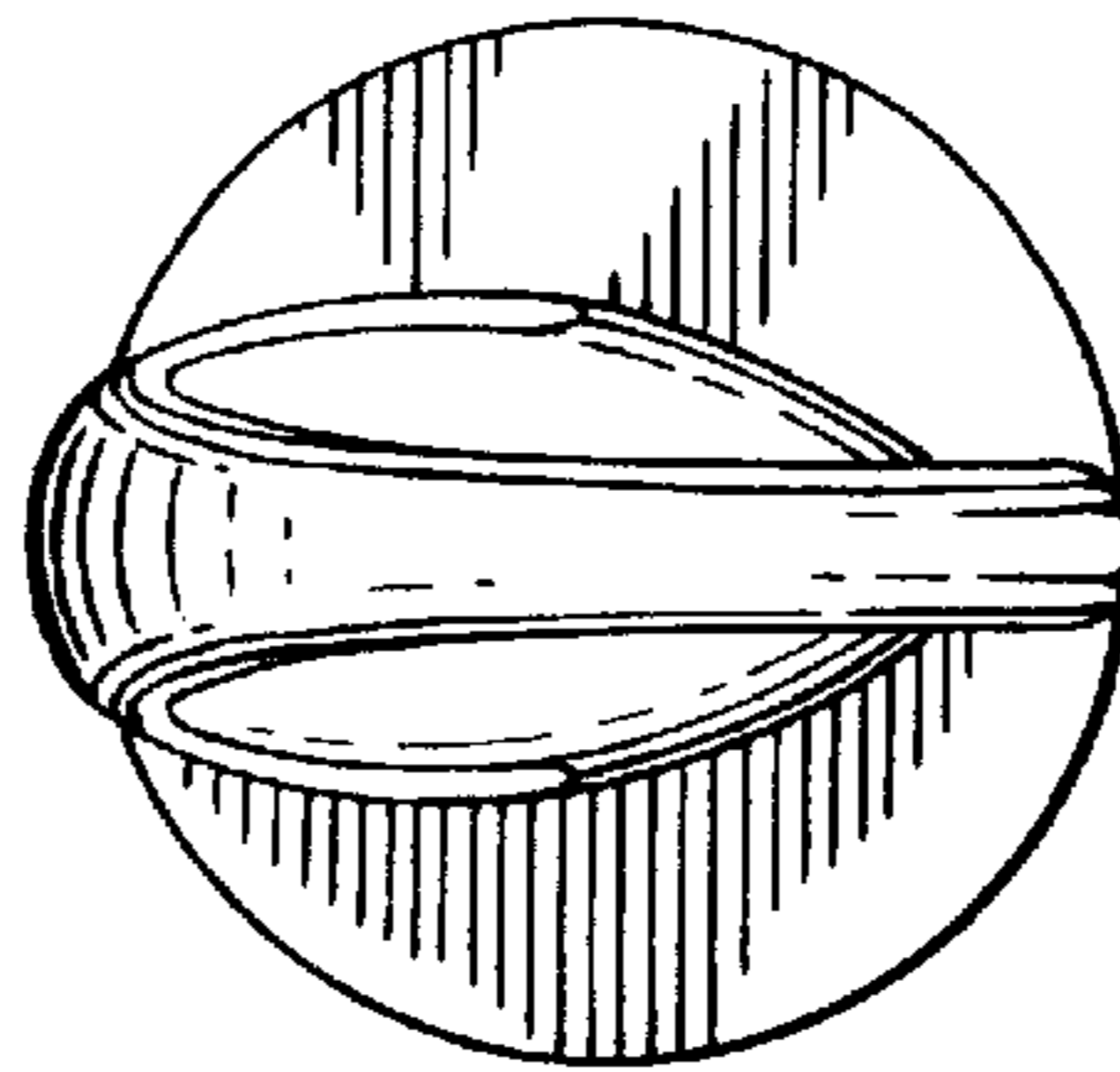
