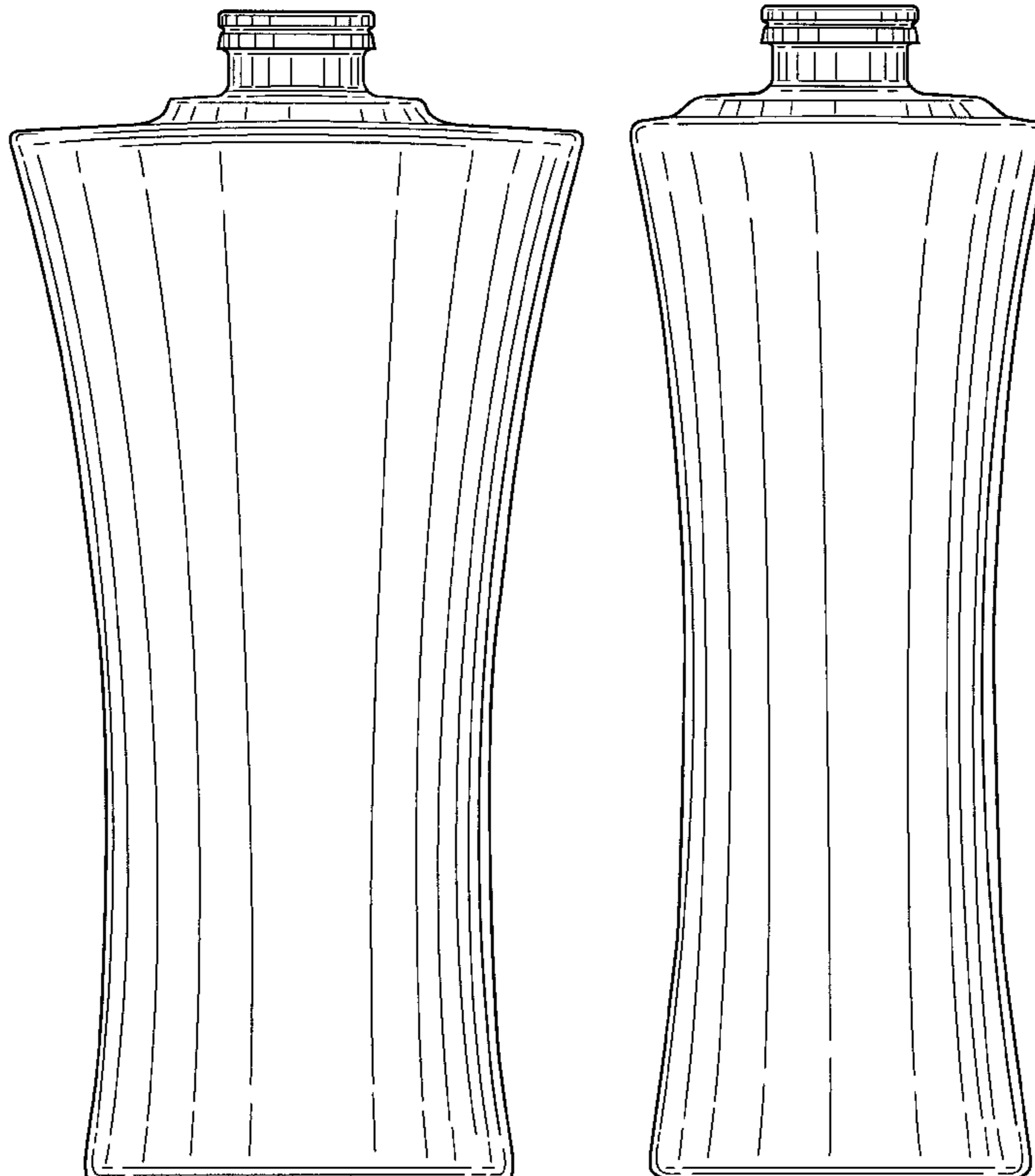
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of an opaque bottle embodying my design, the rear elevational view being a mirror image thereof; FIG. 2 is a right elevational view thereof, the left elevational view being a mirror image thereof; FIG. 3 is top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevational view of a second embodiment of a transparent bottle embodying my design, the rear elevational view being a mirror image thereof; FIG. 6 is a right elevational view thereof, the left elevational view being a mirror image thereof; FIG. 7 is top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

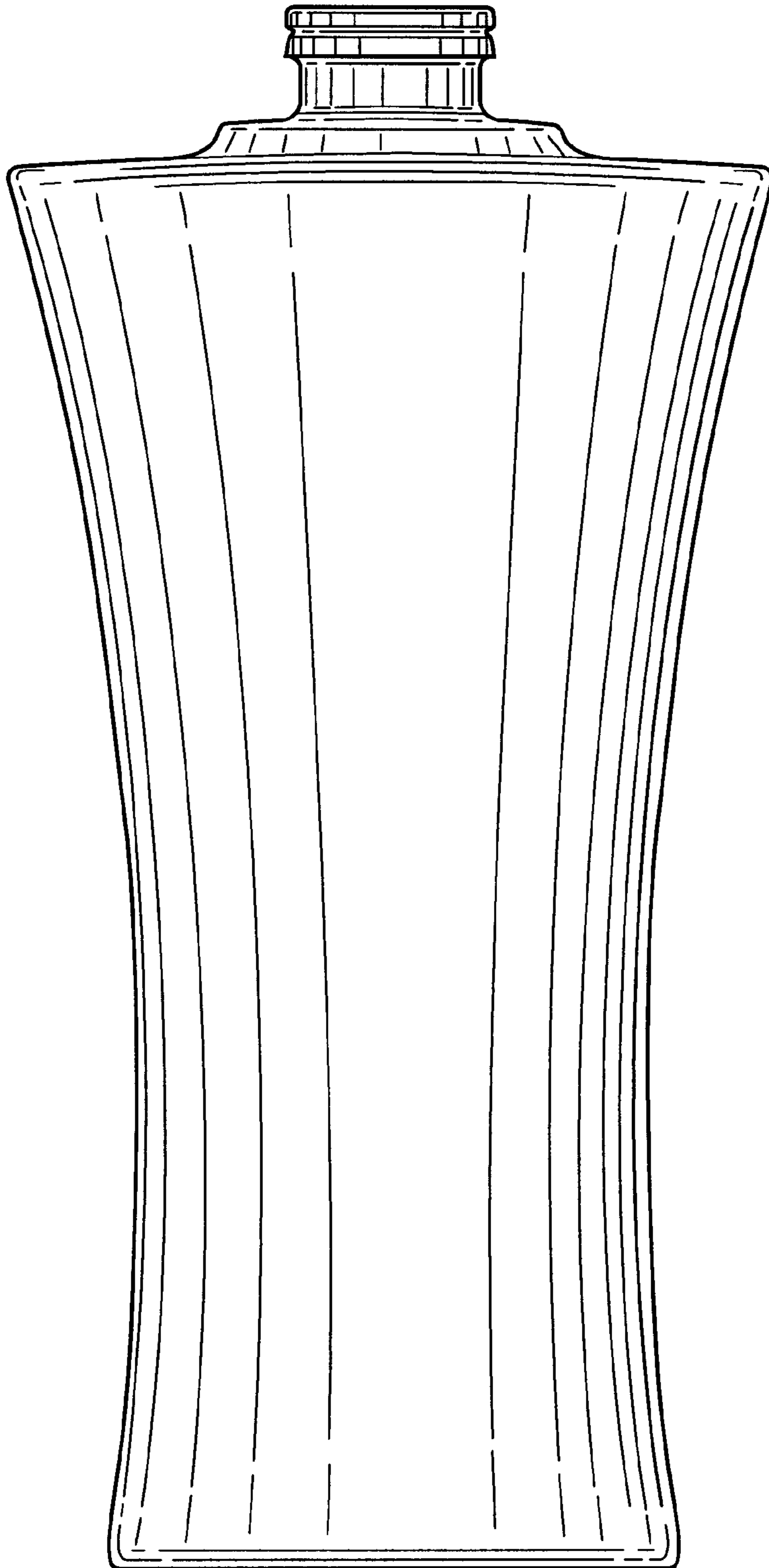

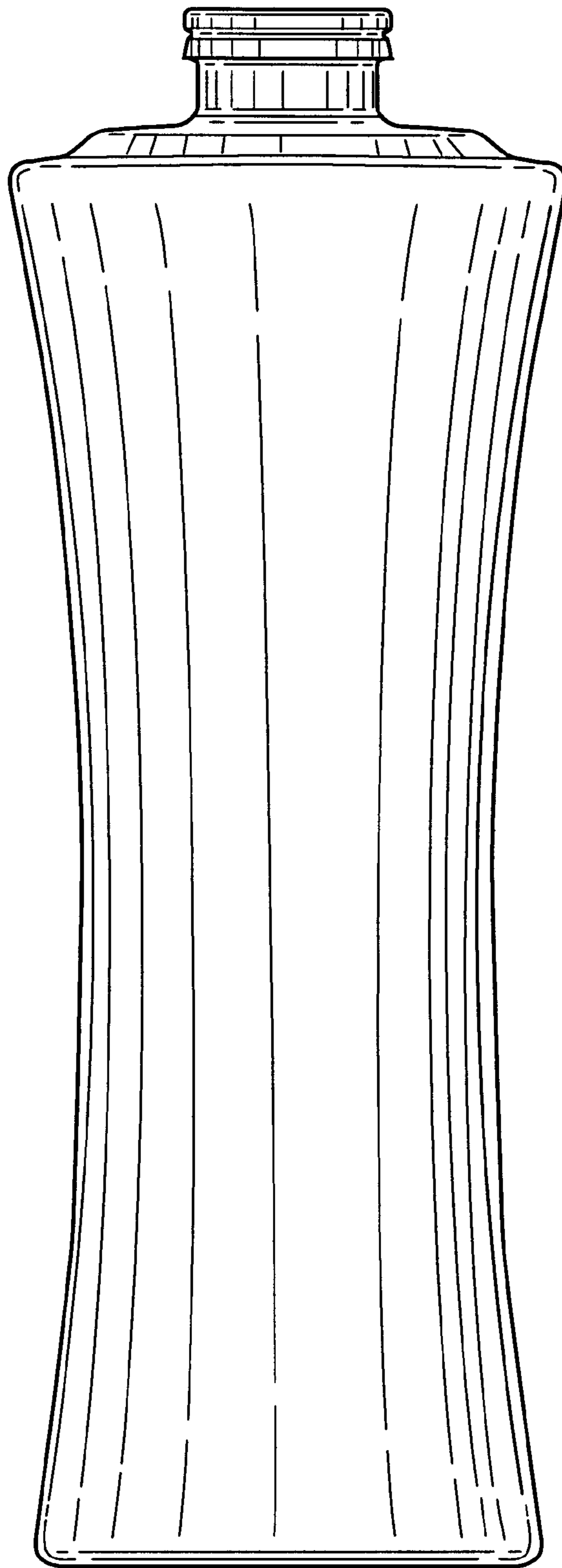

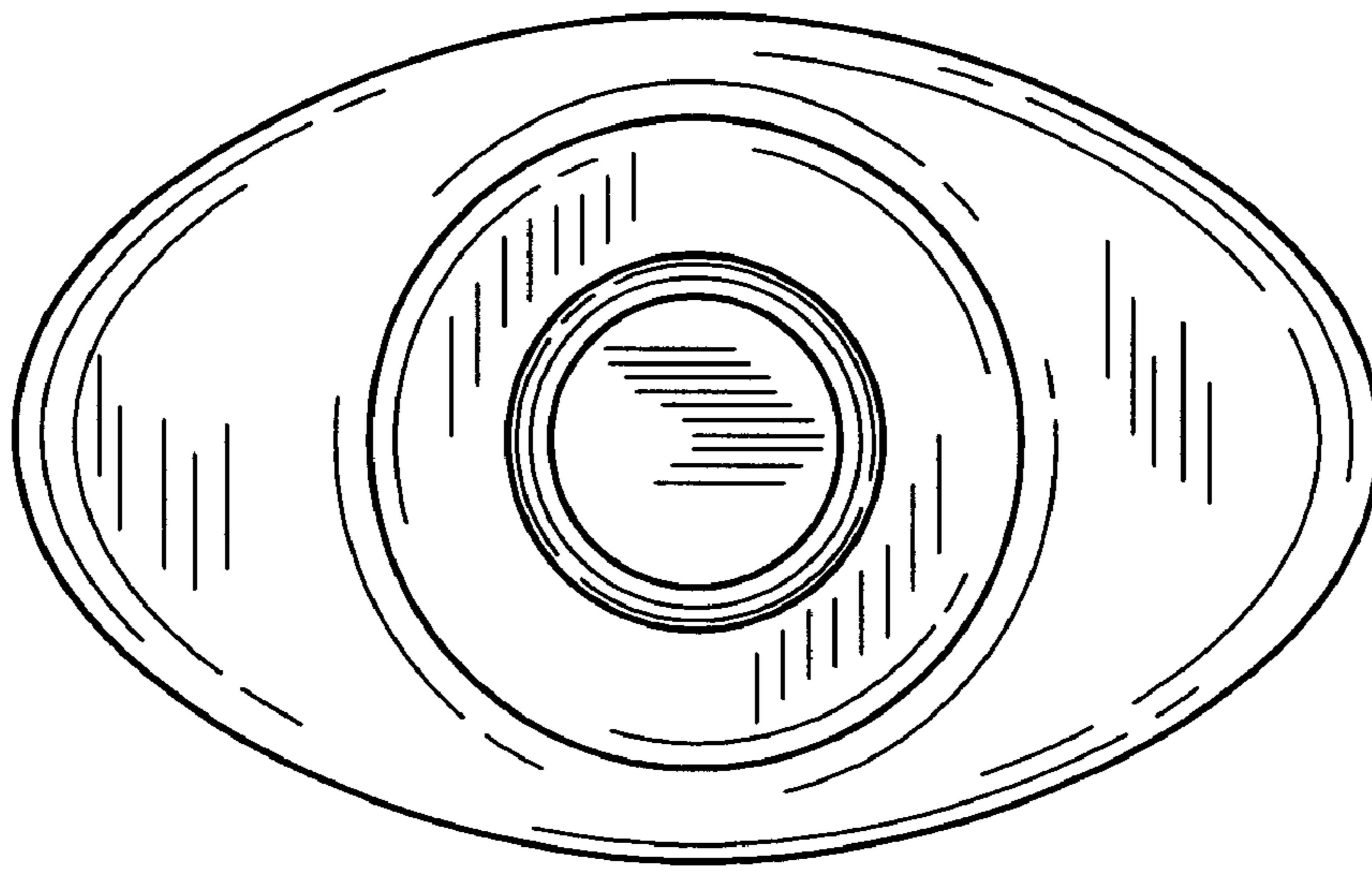

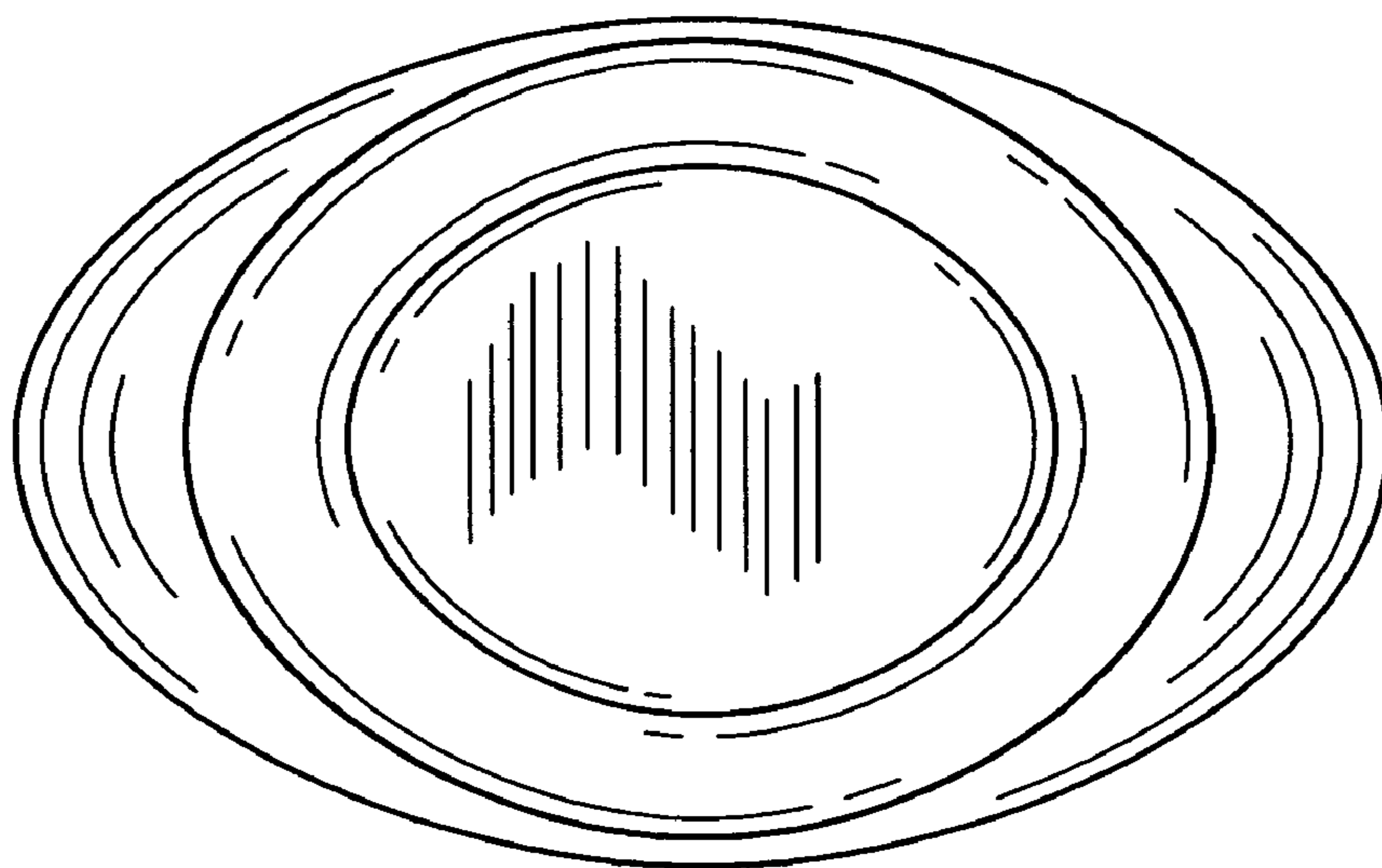

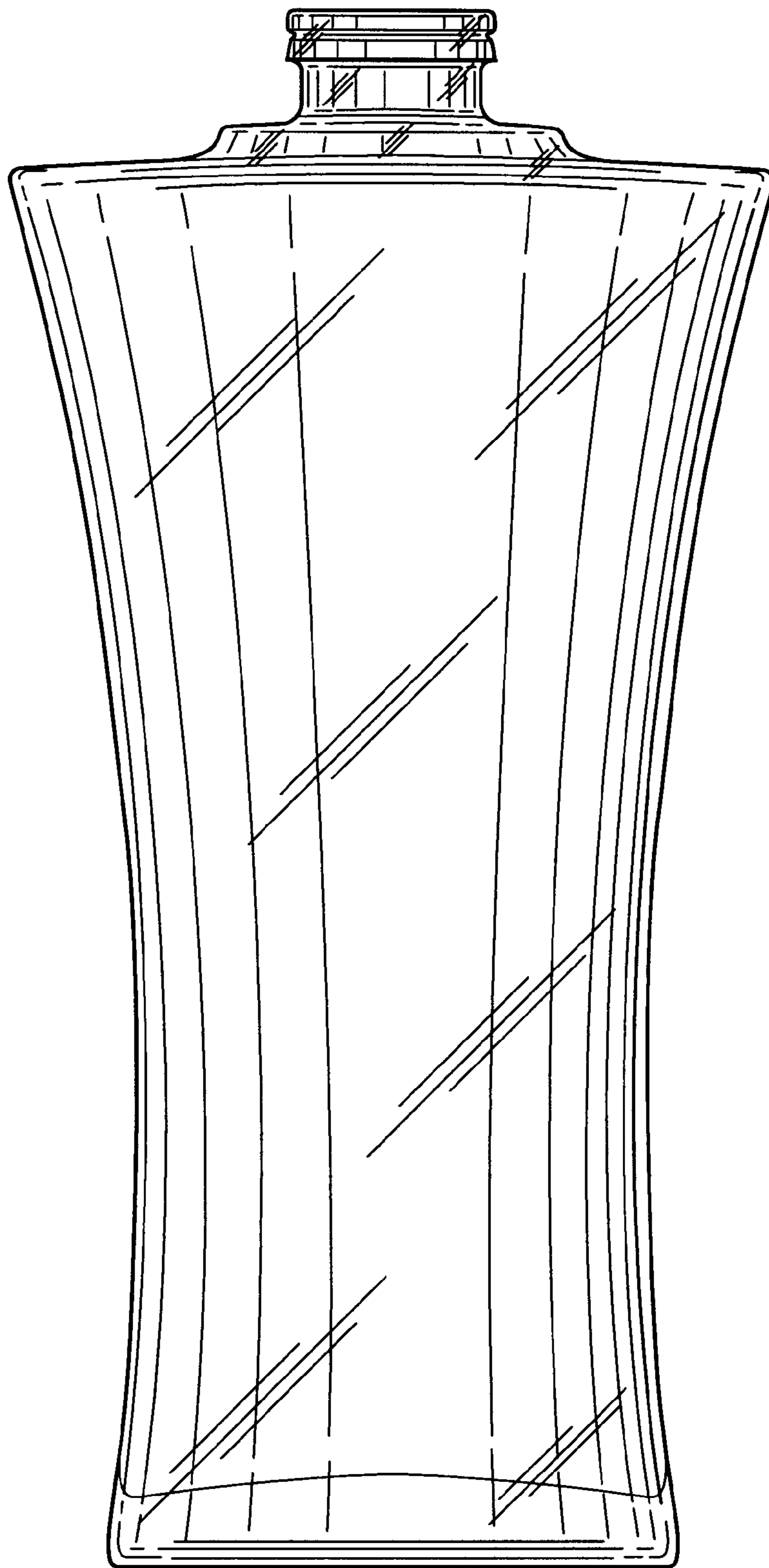

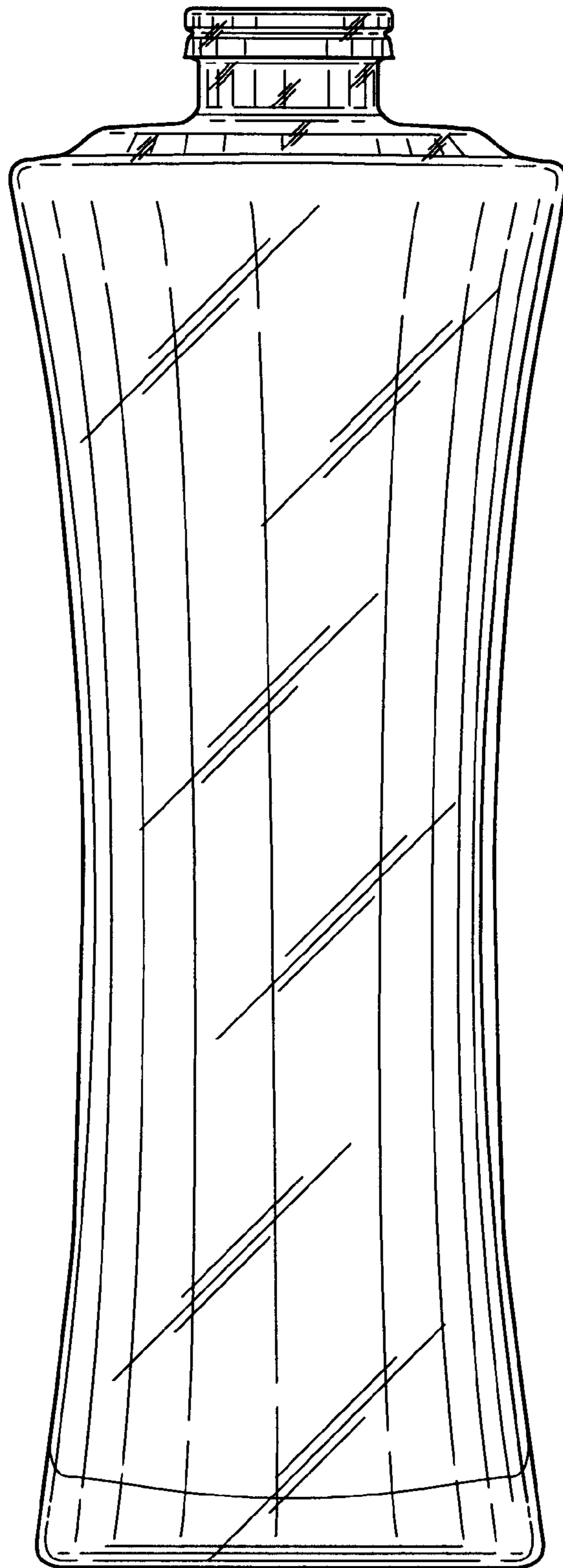

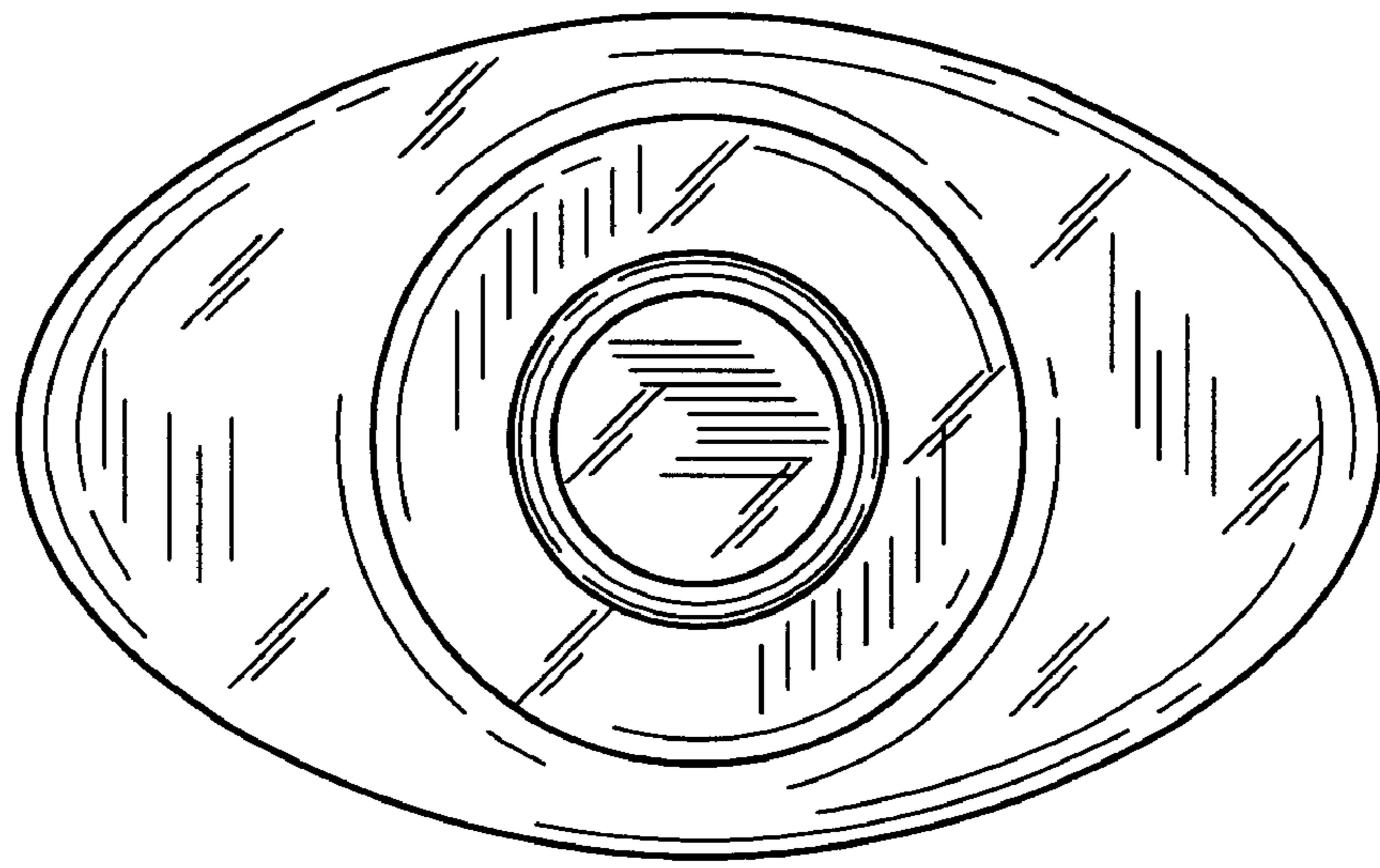

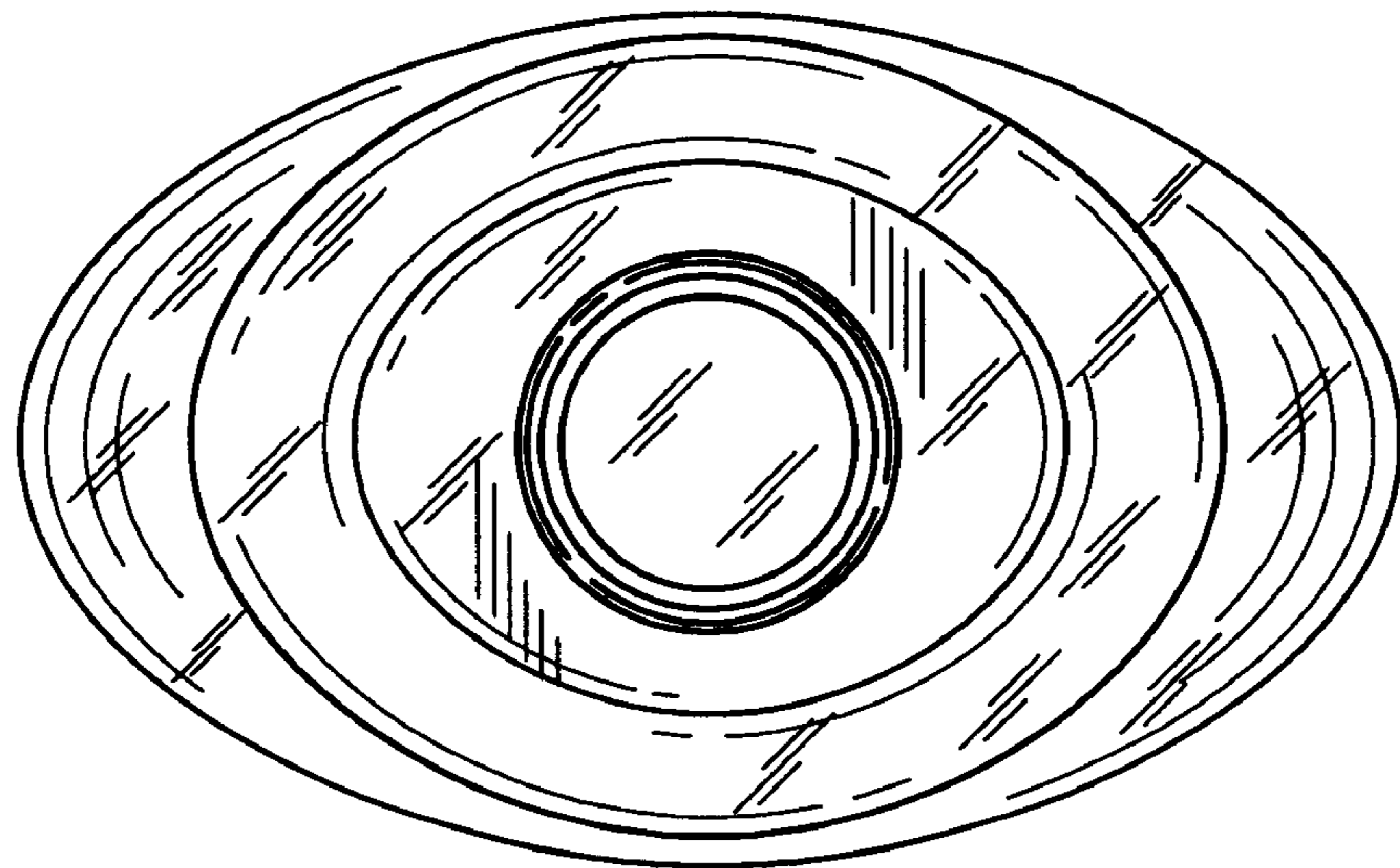
