The ornamental design for a container with closure, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of a container with closure, showing my new design, with the closure in place; FIG. 2 is a front side view thereof; FIG. 3 is a rear side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top side view thereof; and, FIG. 7 is a bottom side view thereof.

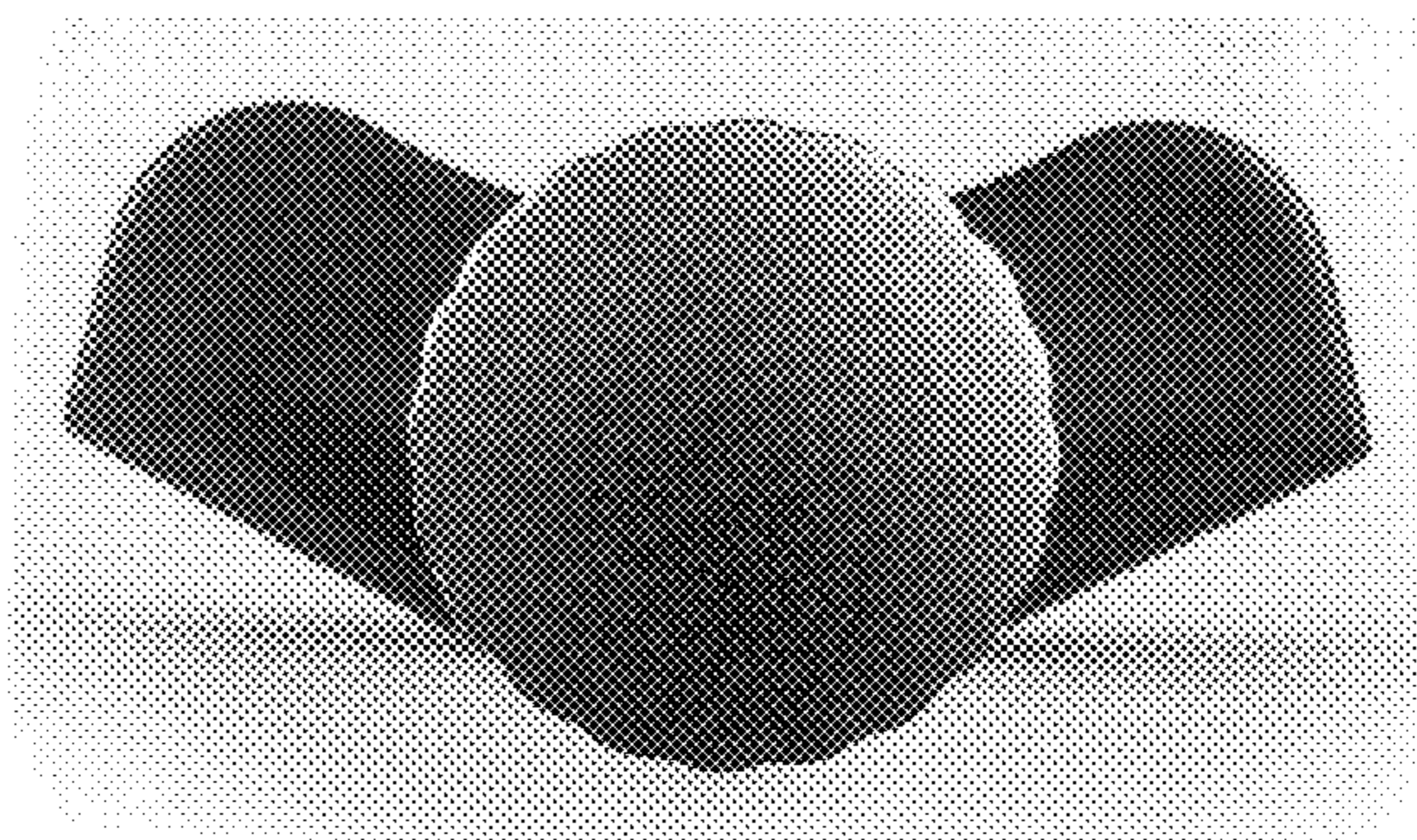

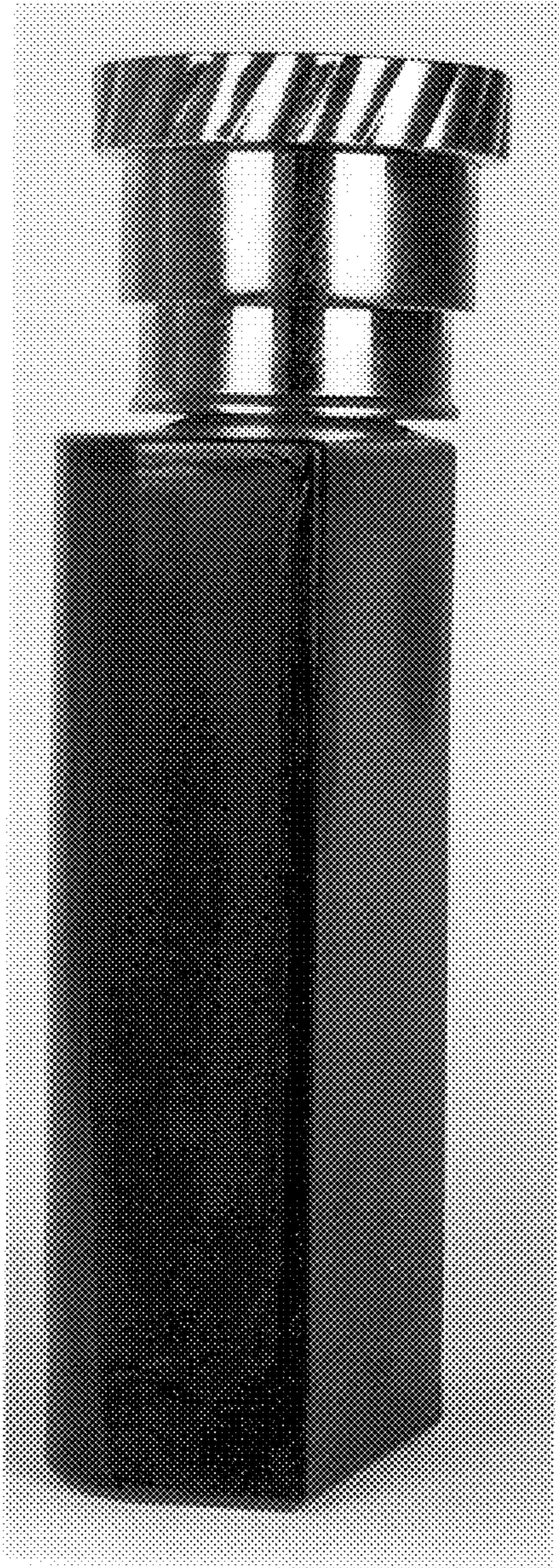

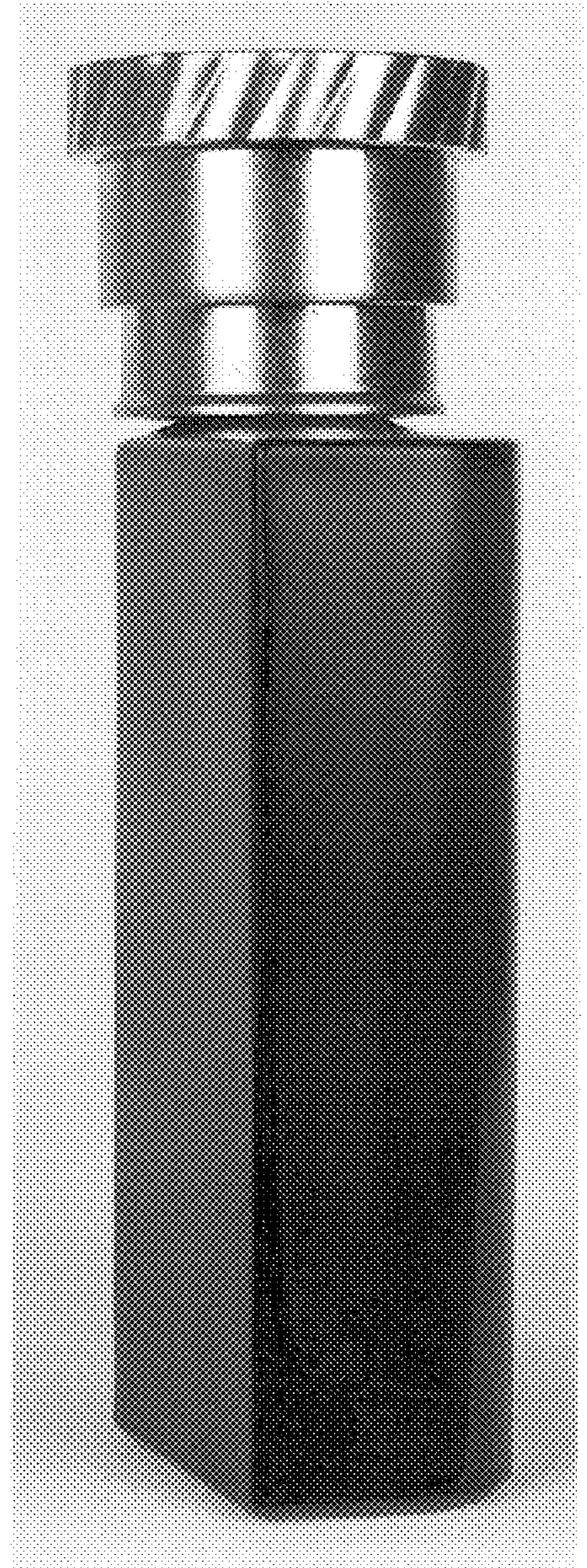

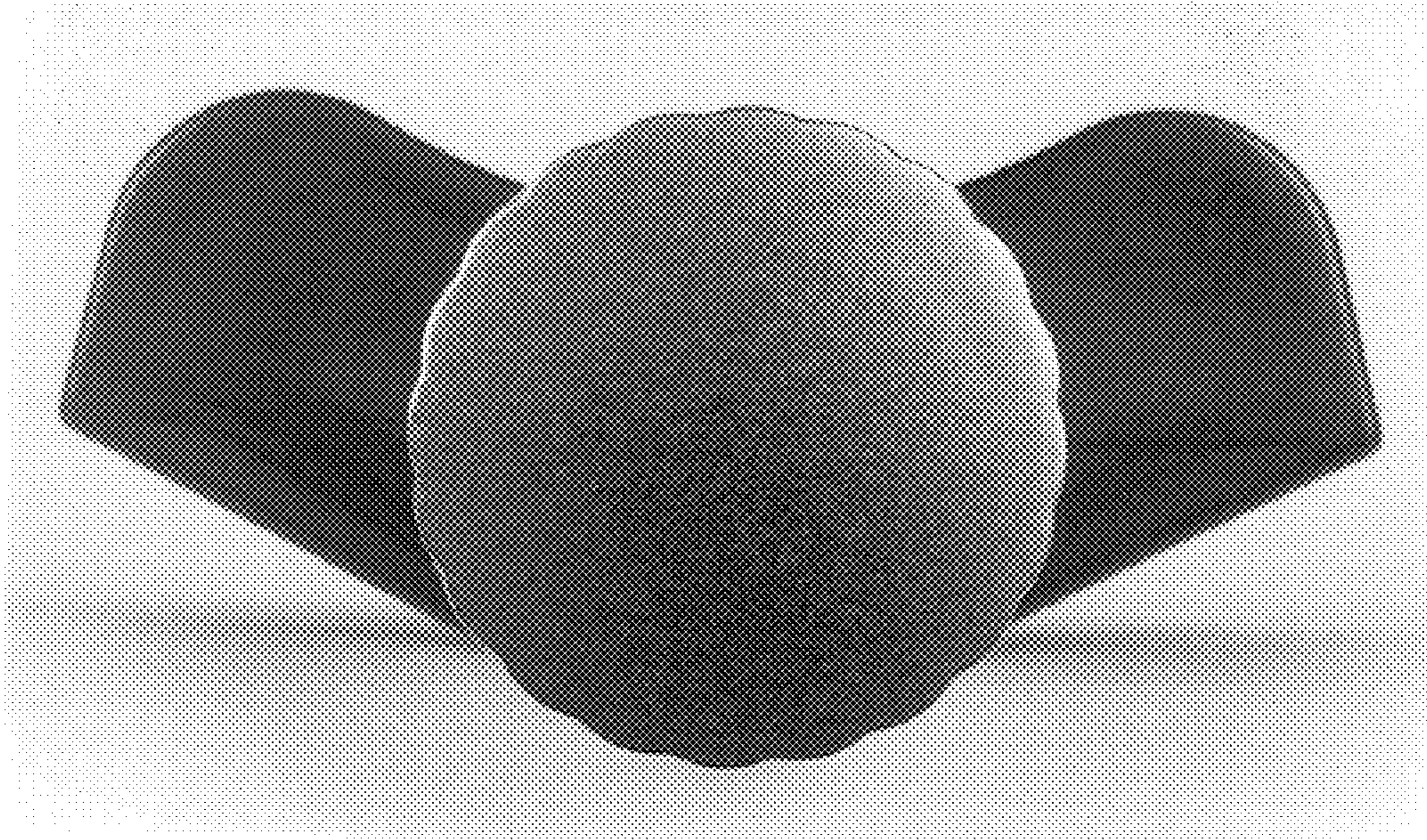

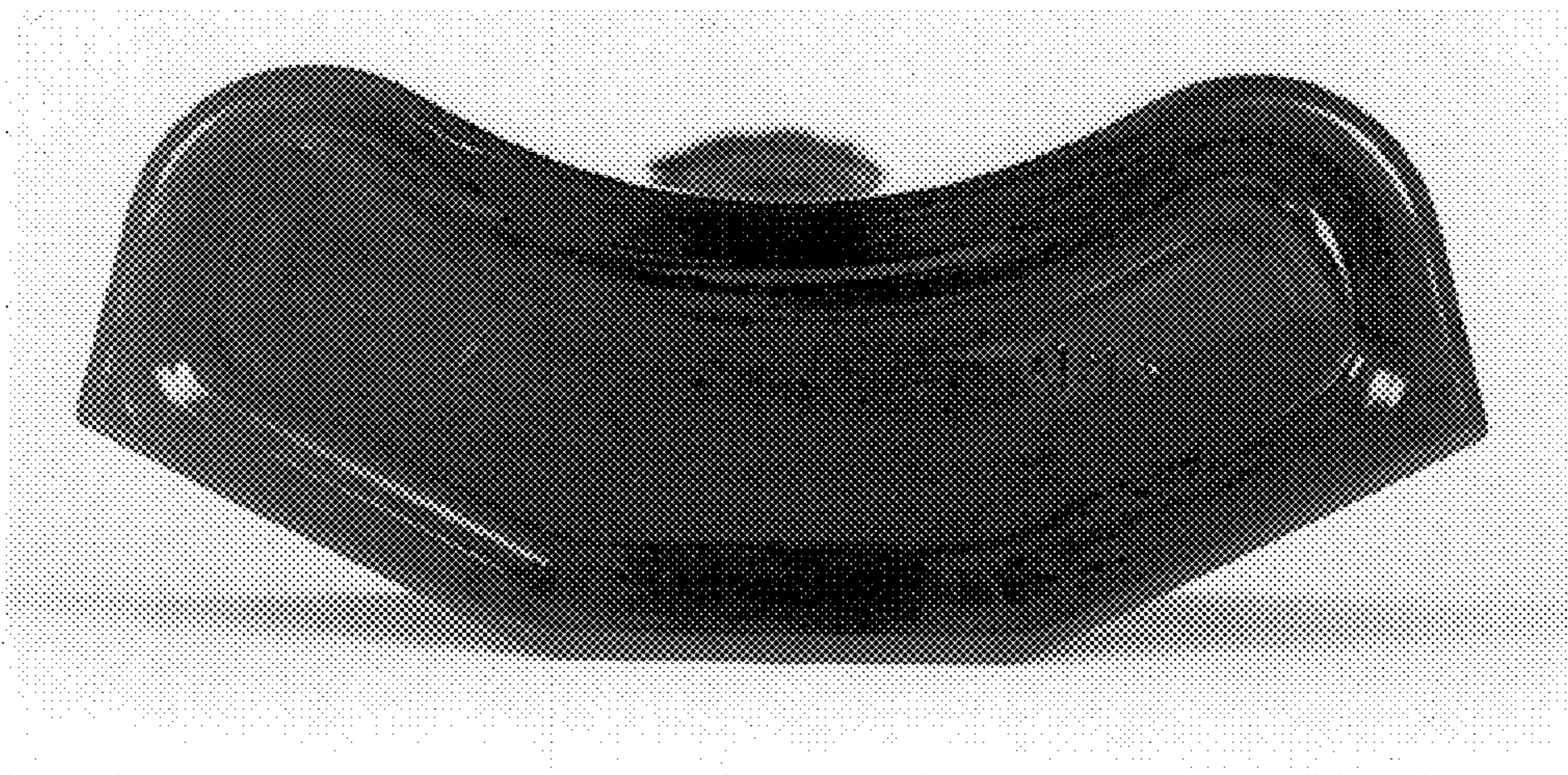
