FIG. 16 is a top plan view of the bowl of FIG. 15;

FIG. 17 is a bottom plan view of the bowl of FIG. 15; and,

FIG. 18 is a front view of the bowl of FIG. 15, the rear view, right side view, and left side view being mirror images thereof.

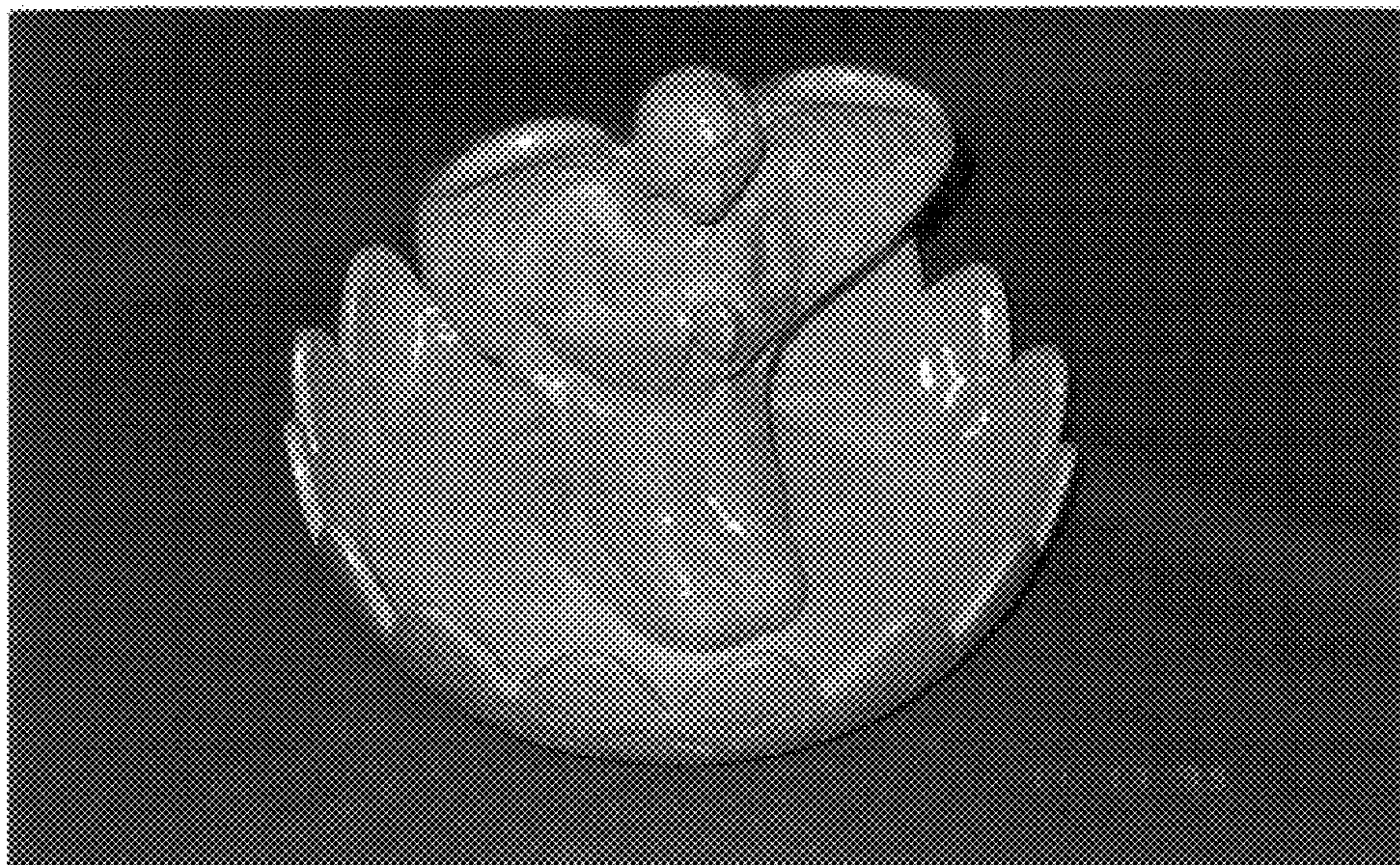

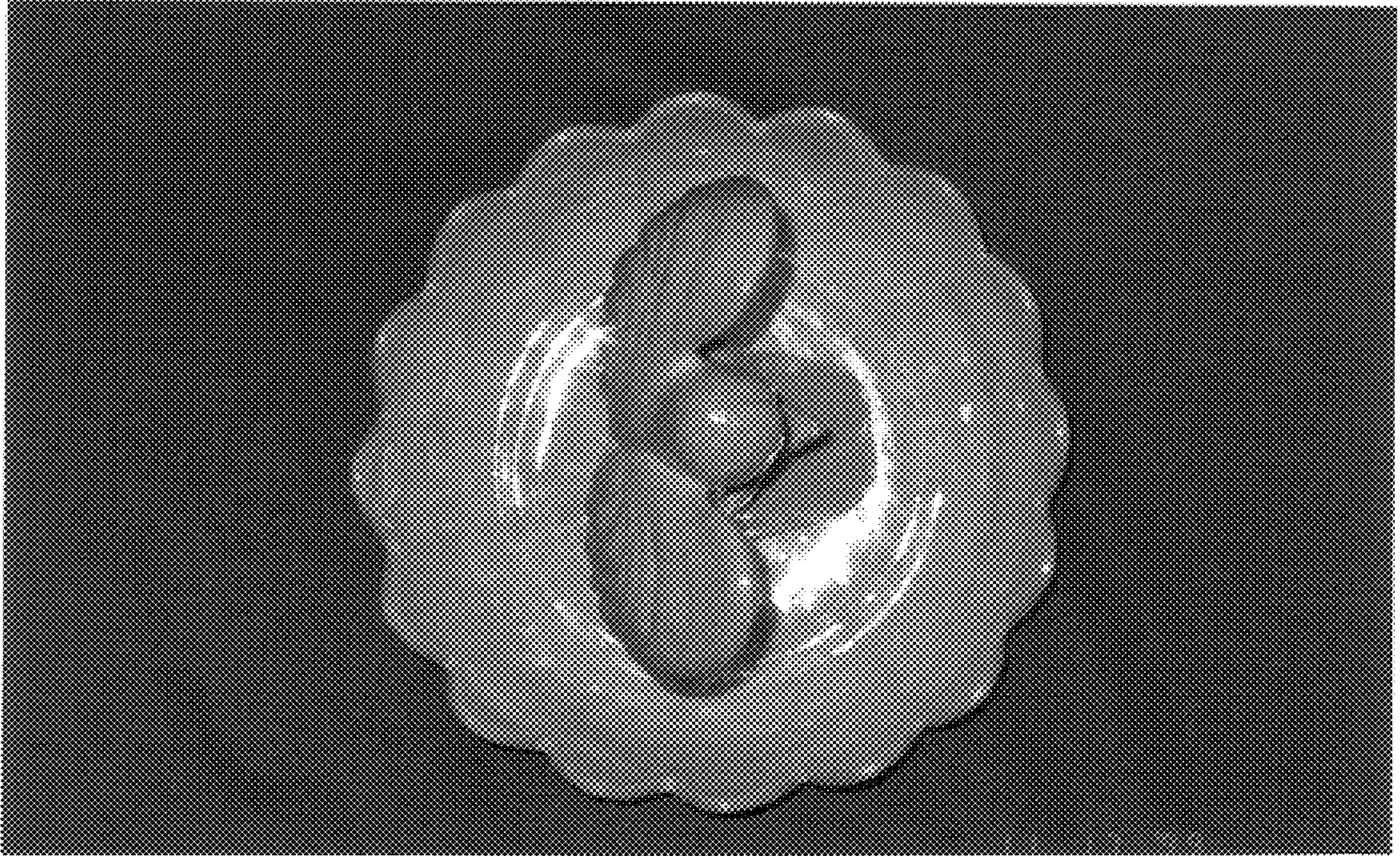

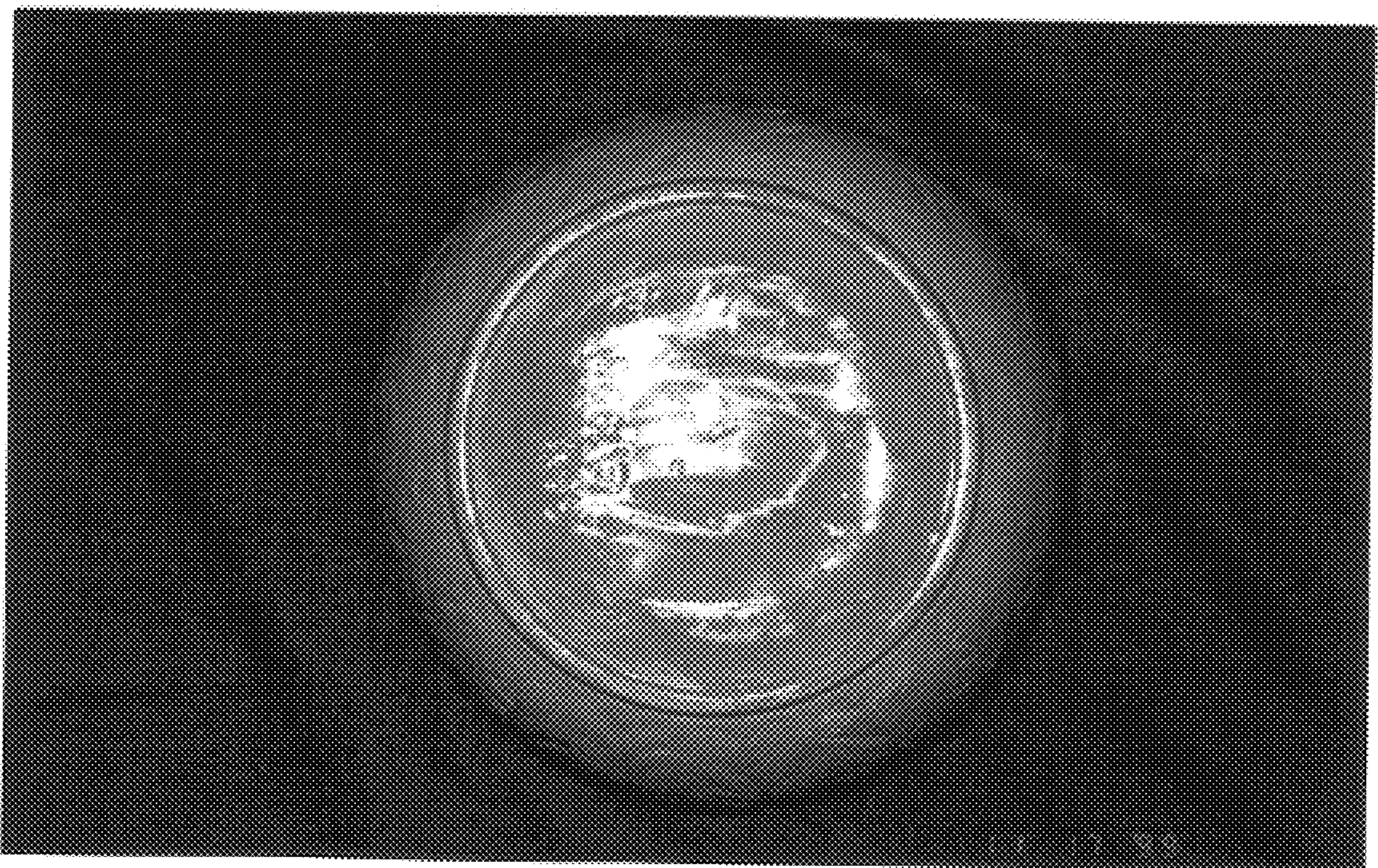

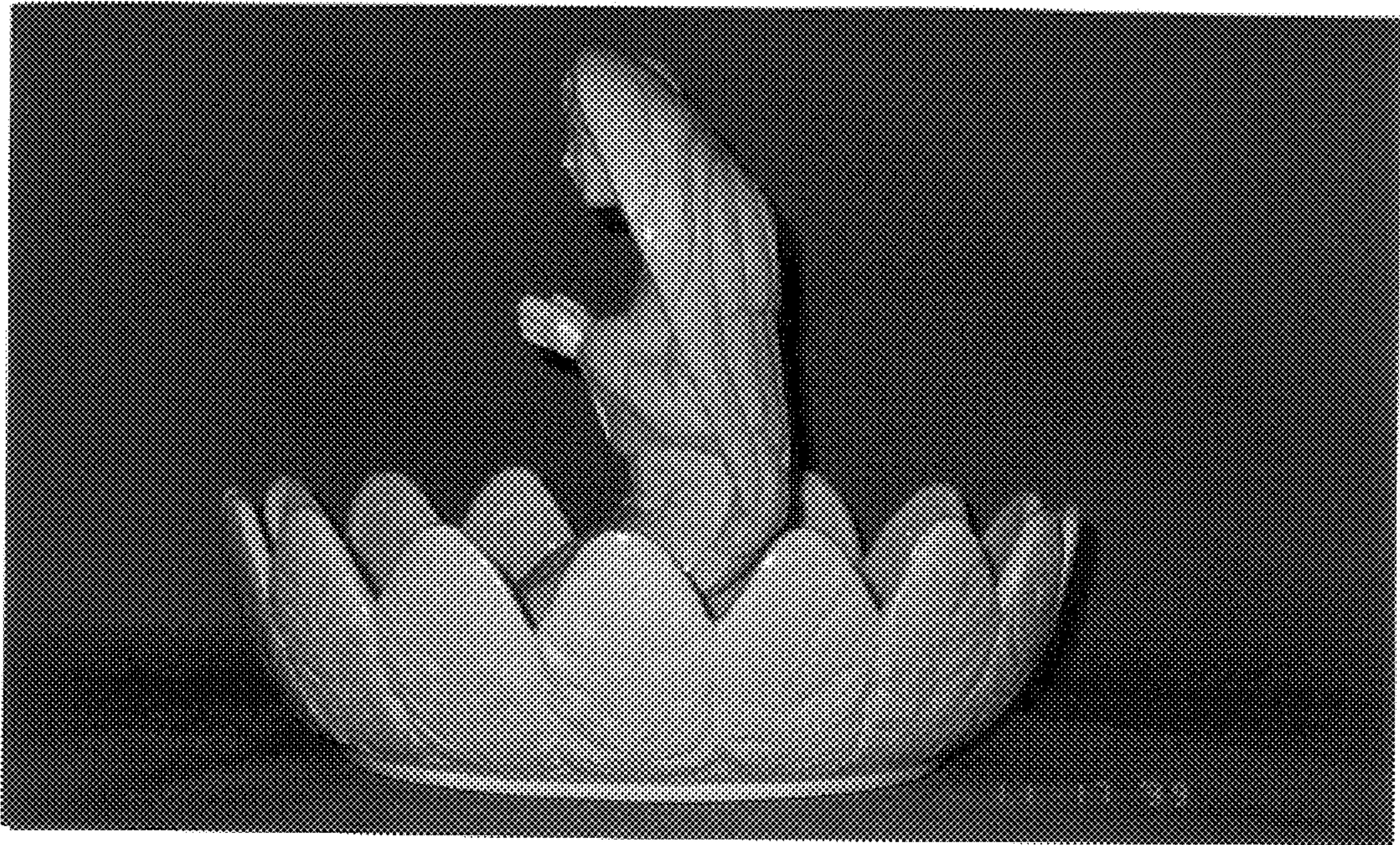

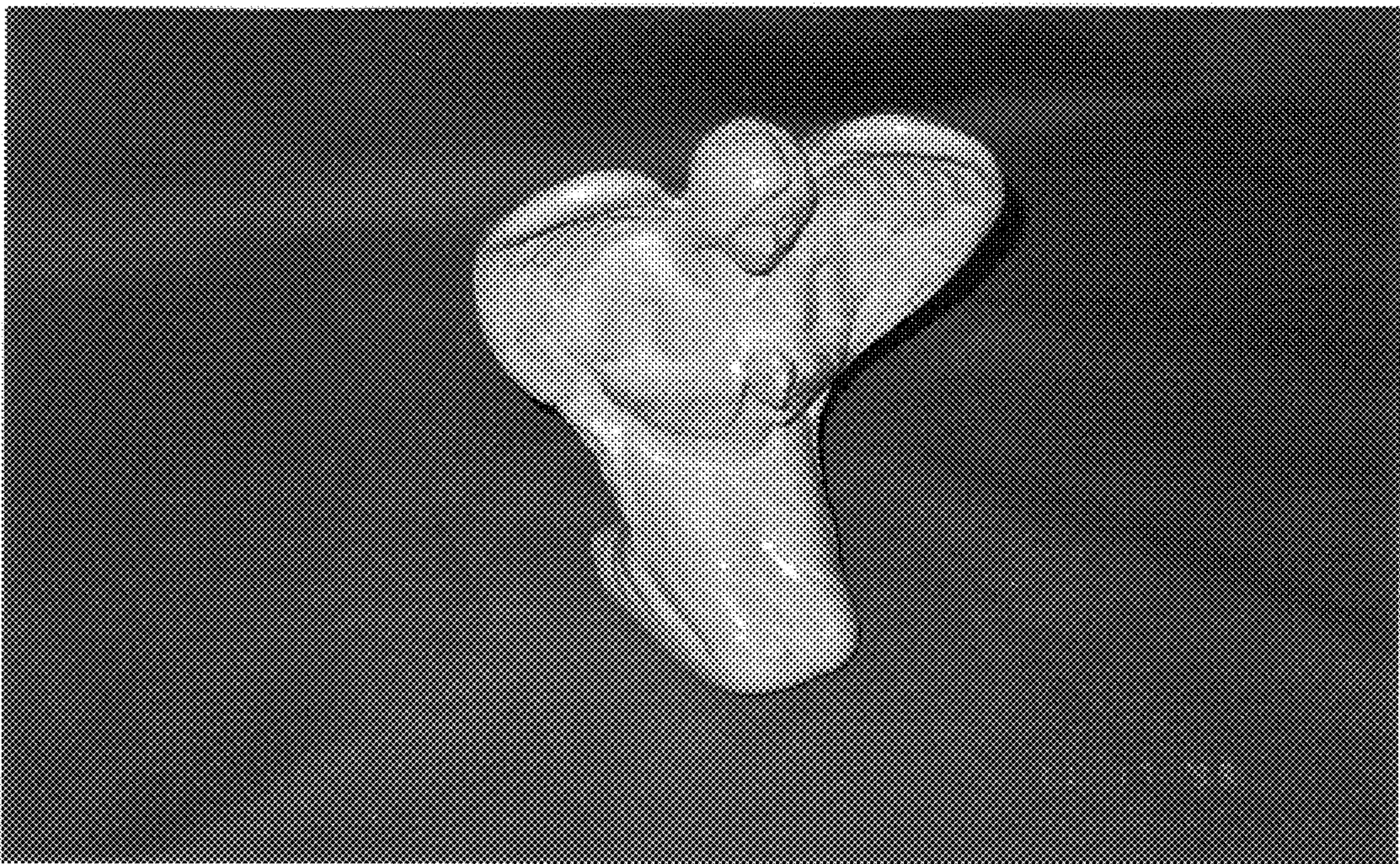

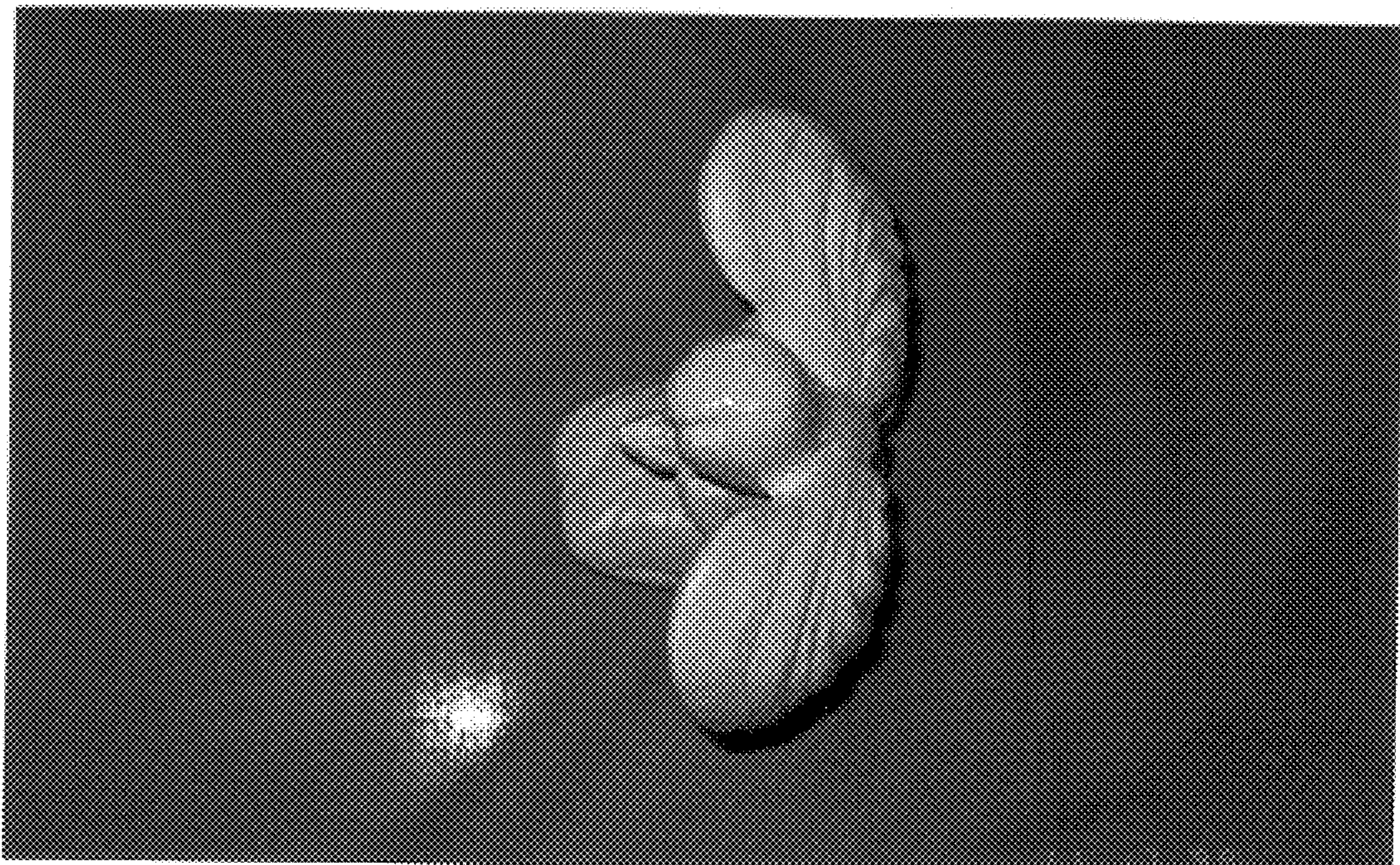

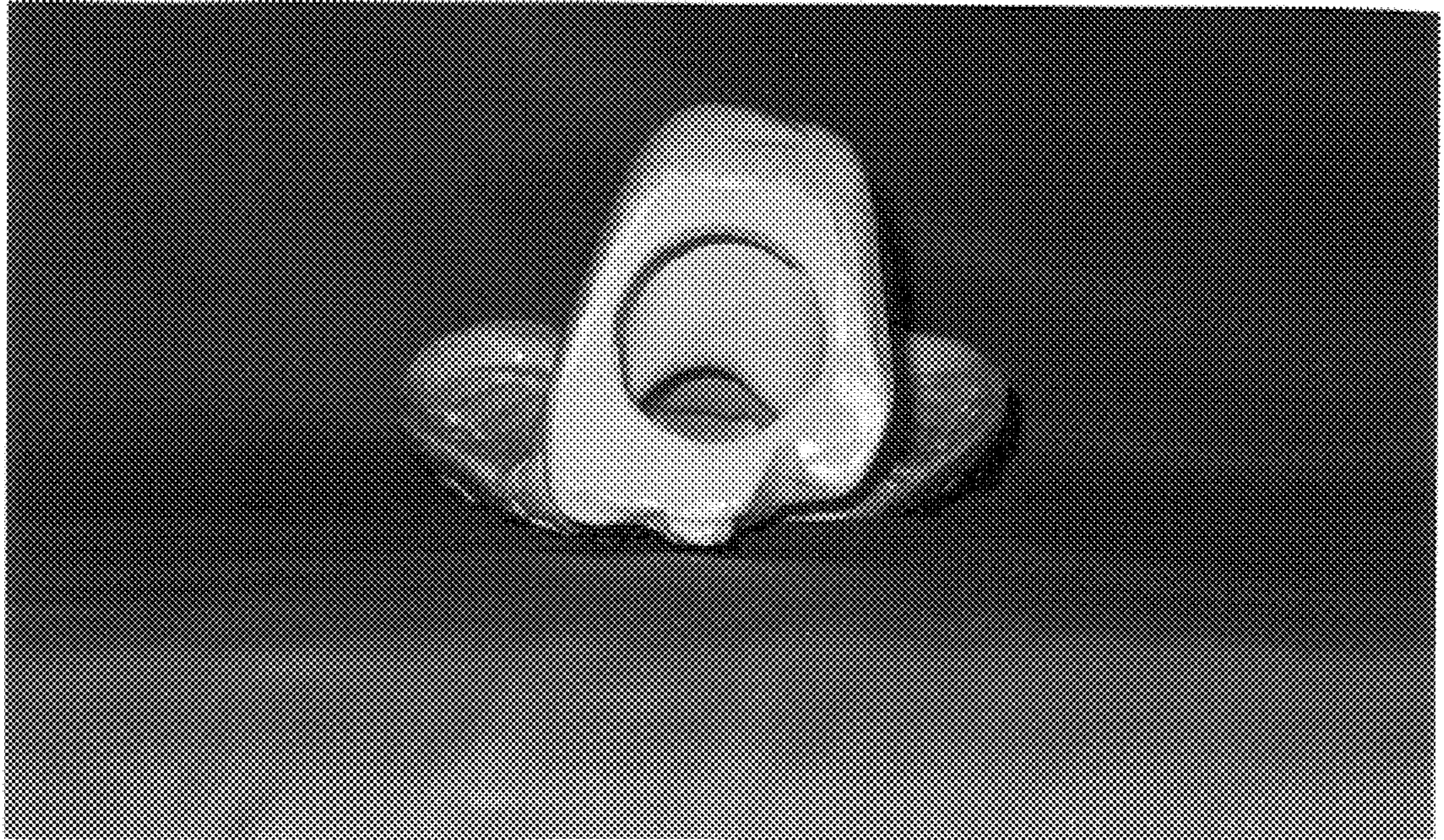

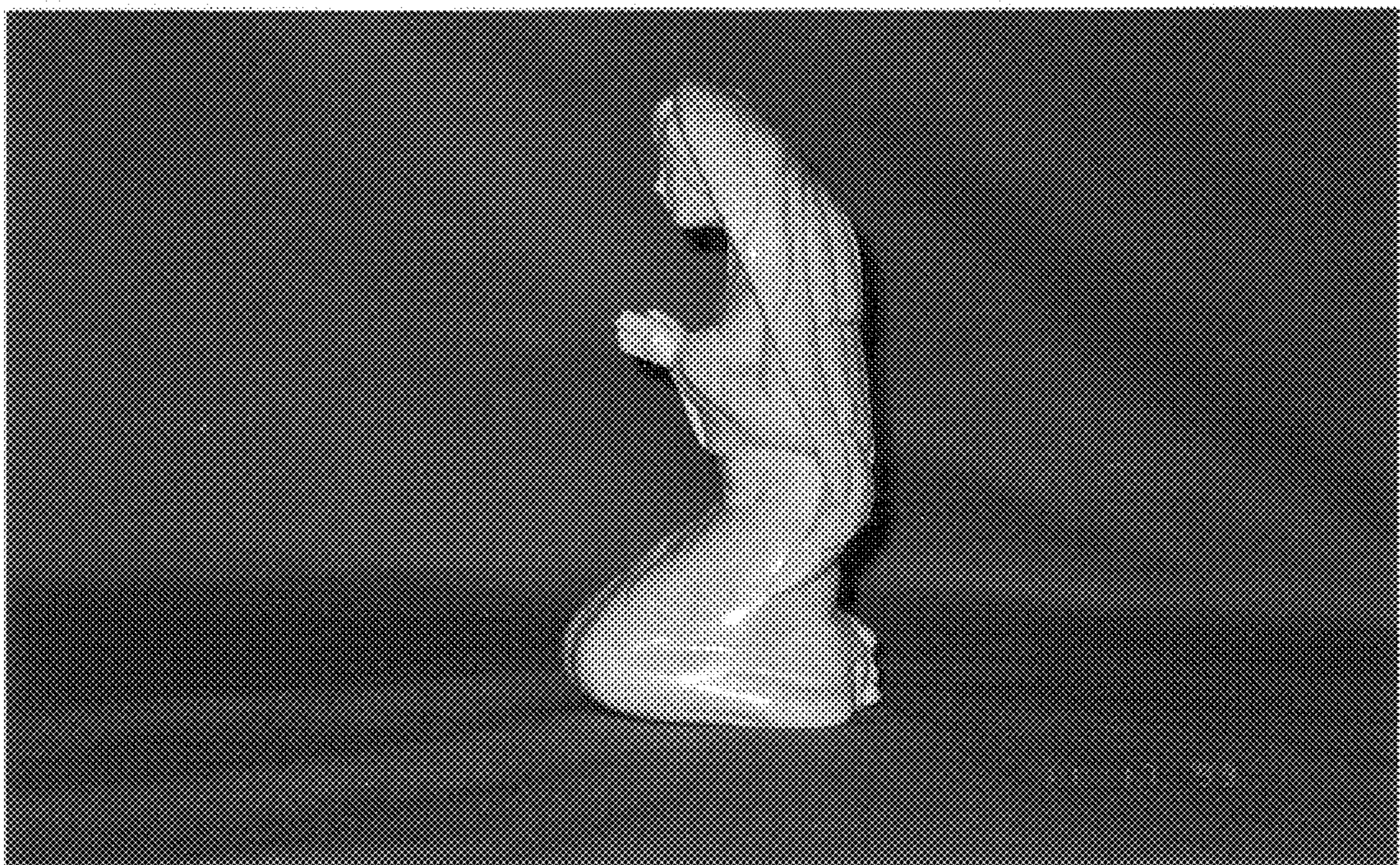

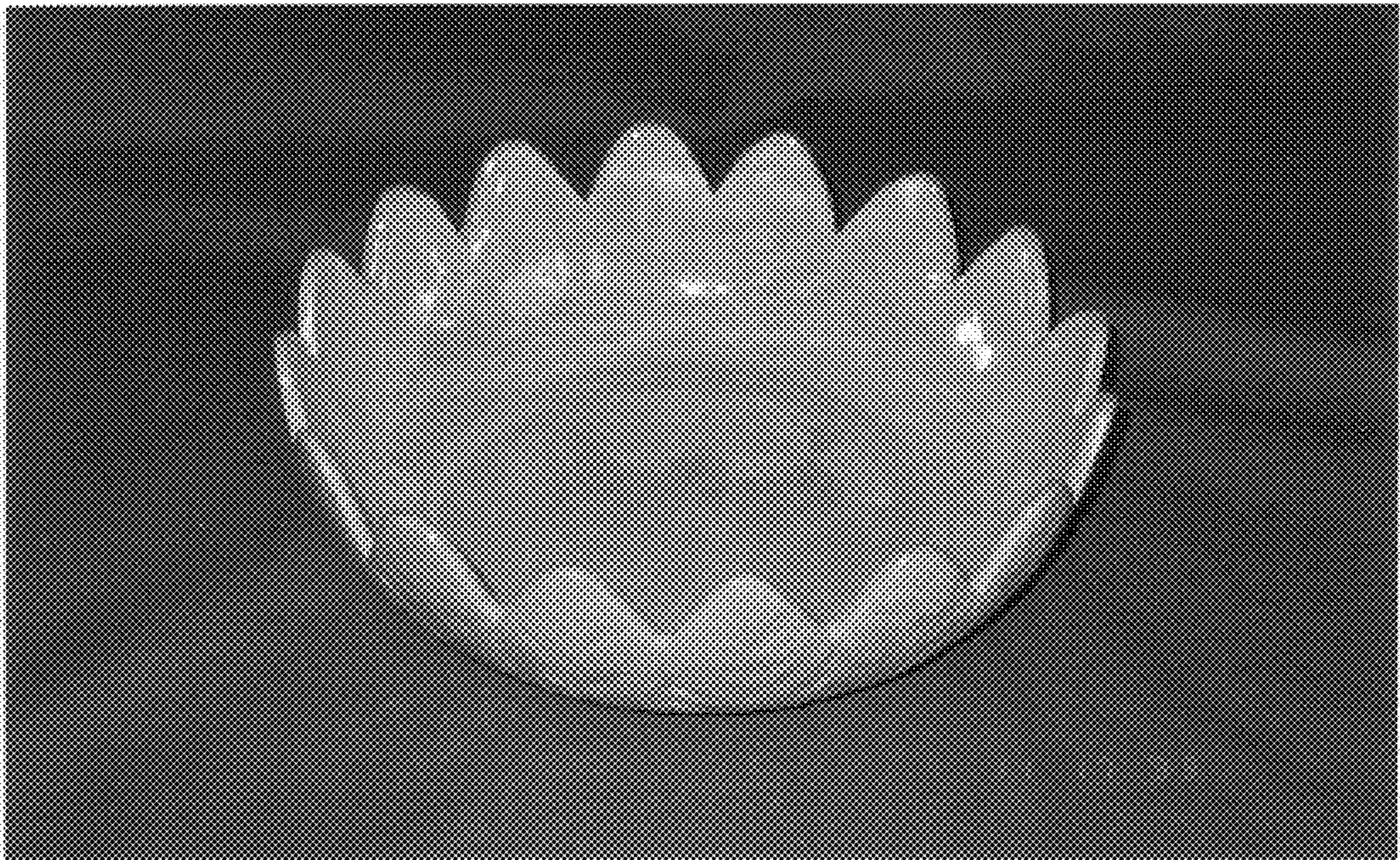

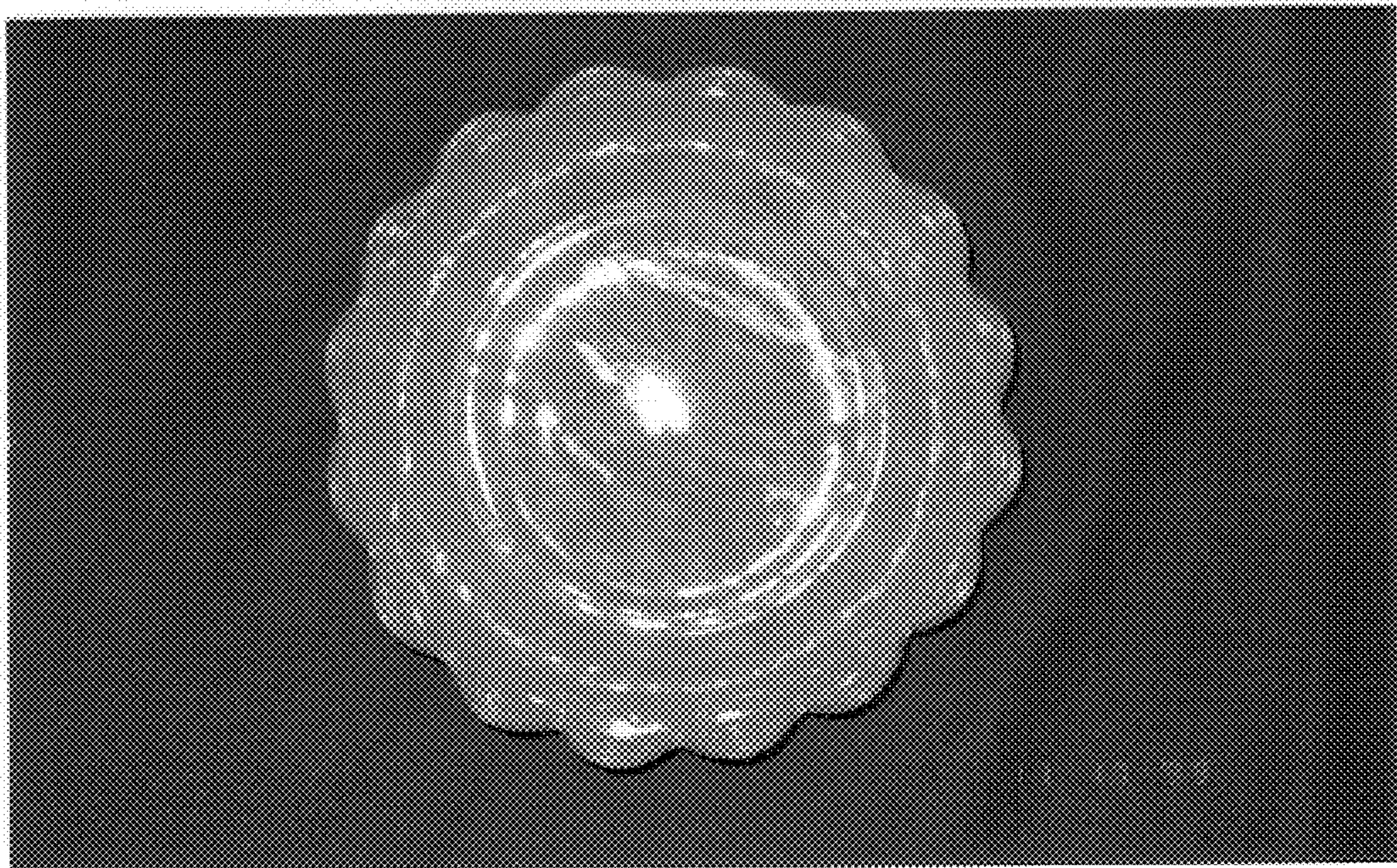

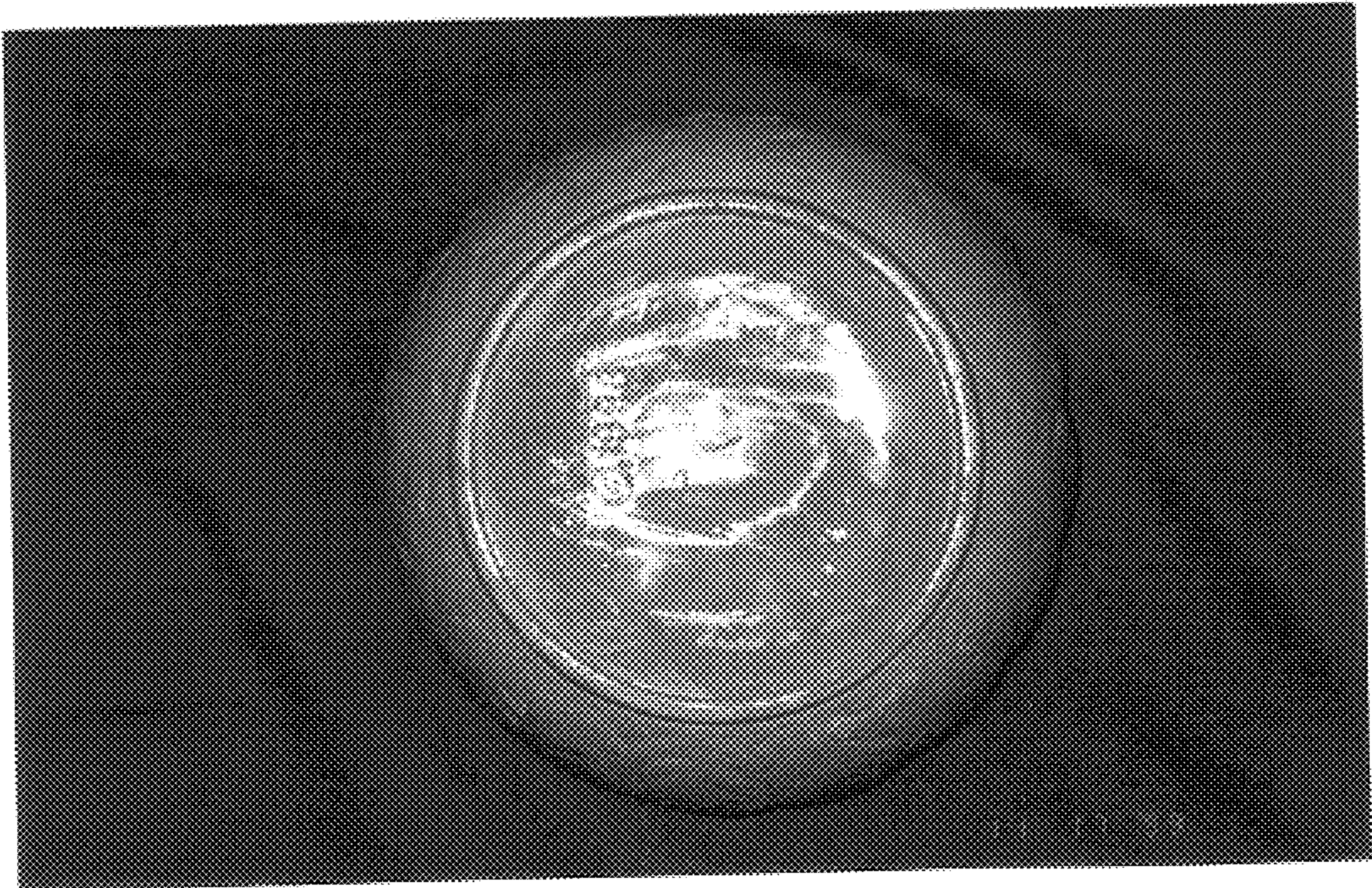

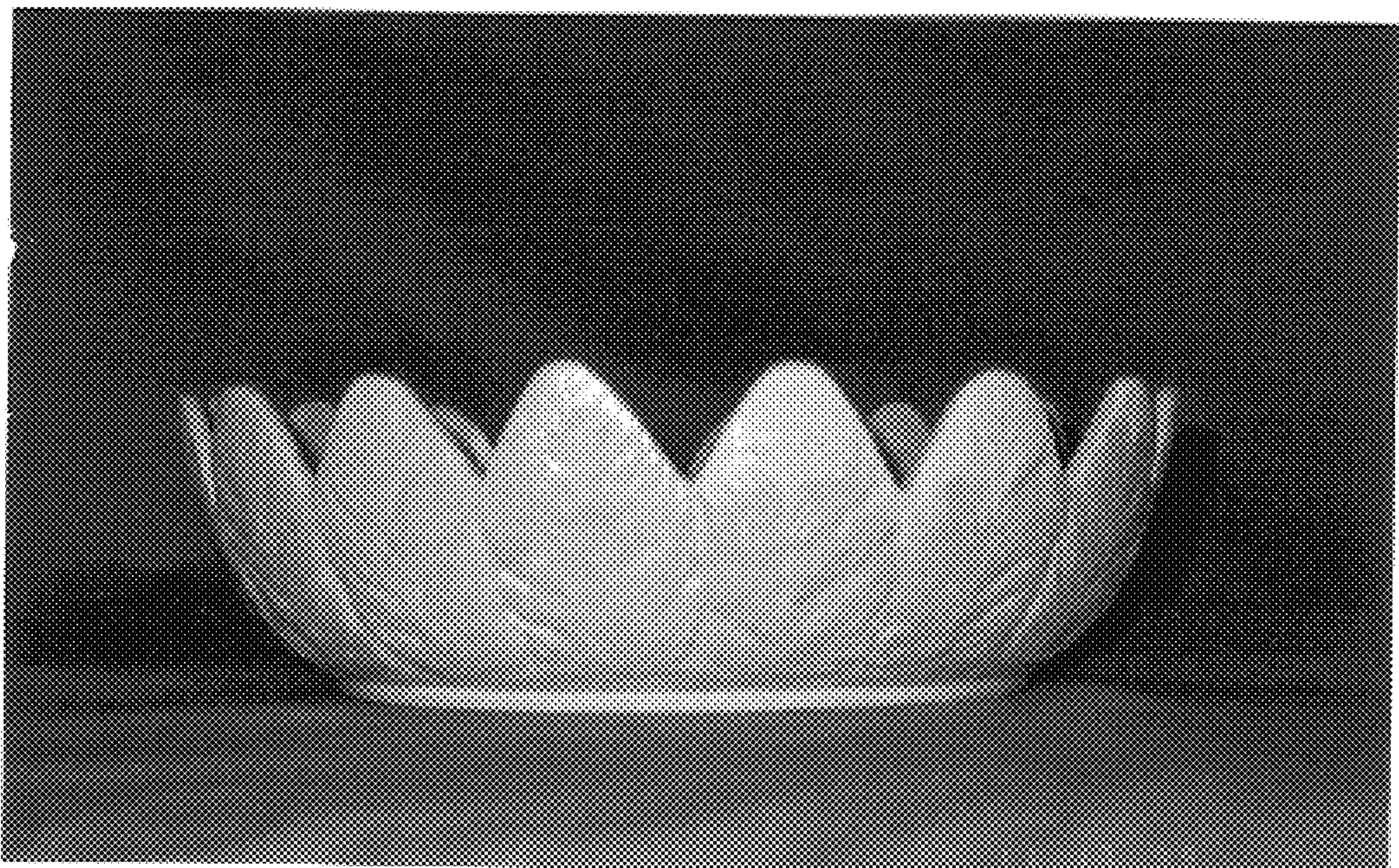
