(57) **CLAIM**

The ornamental design for a tire for automobile, as shown.

DESCRIPTION

FIG. 1 is a front view of a tire for automobile showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a perspective view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is an enlarged front view thereof;

FIG. 7 is a cross-sectional view taken along line 7—7 of FIG. 6;

FIG. 8 is a cross-sectional view taken along line 8—8 of FIG. 6; and,

FIG. 9 is a referential enlarged front view thereof showing a part of grooves with black color.

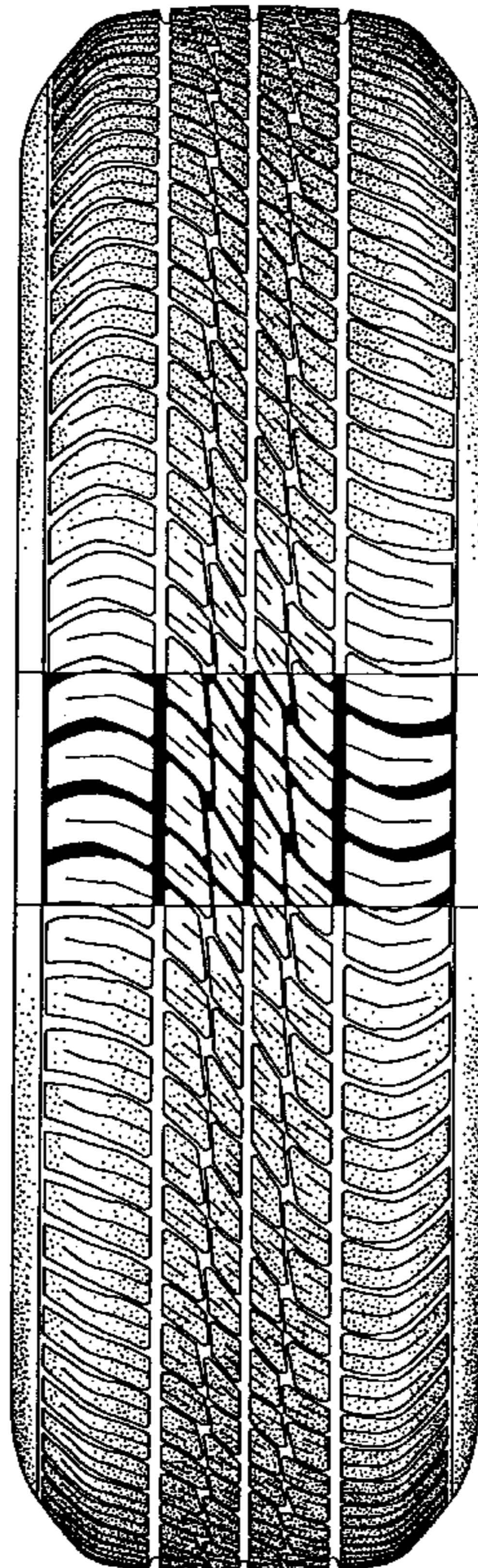

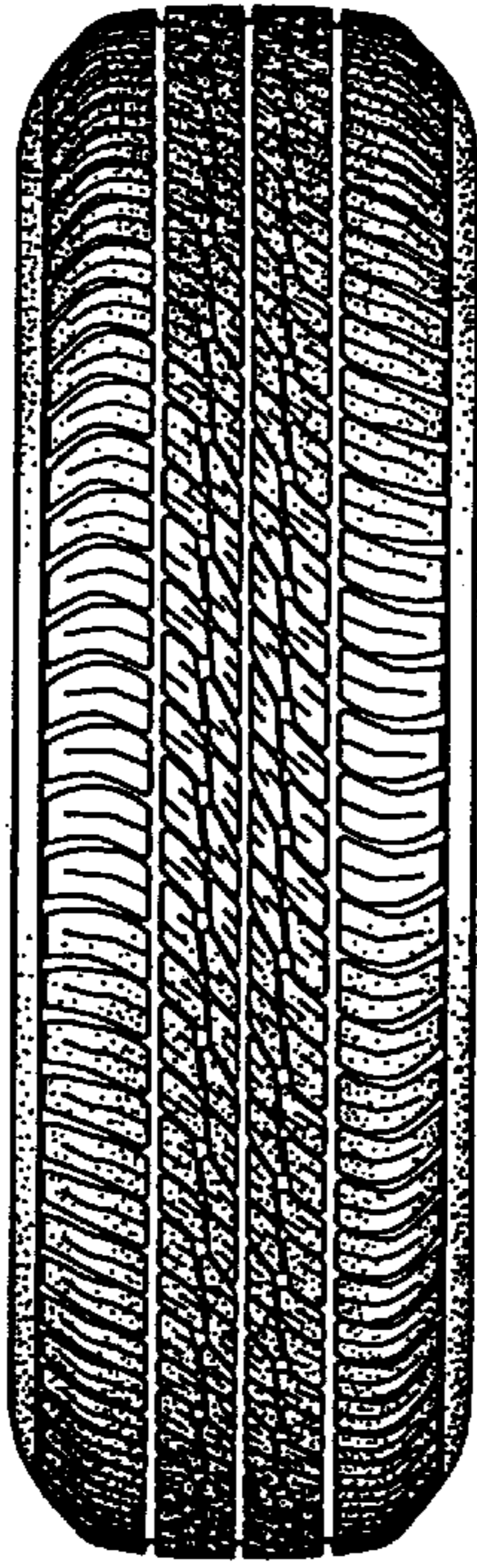

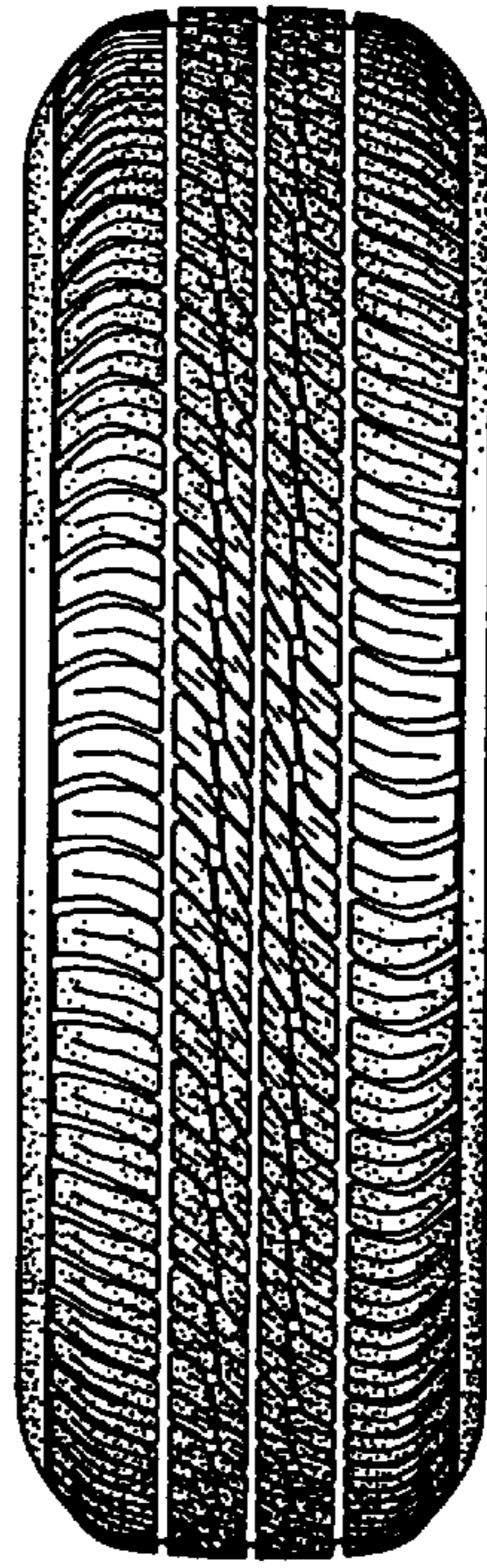

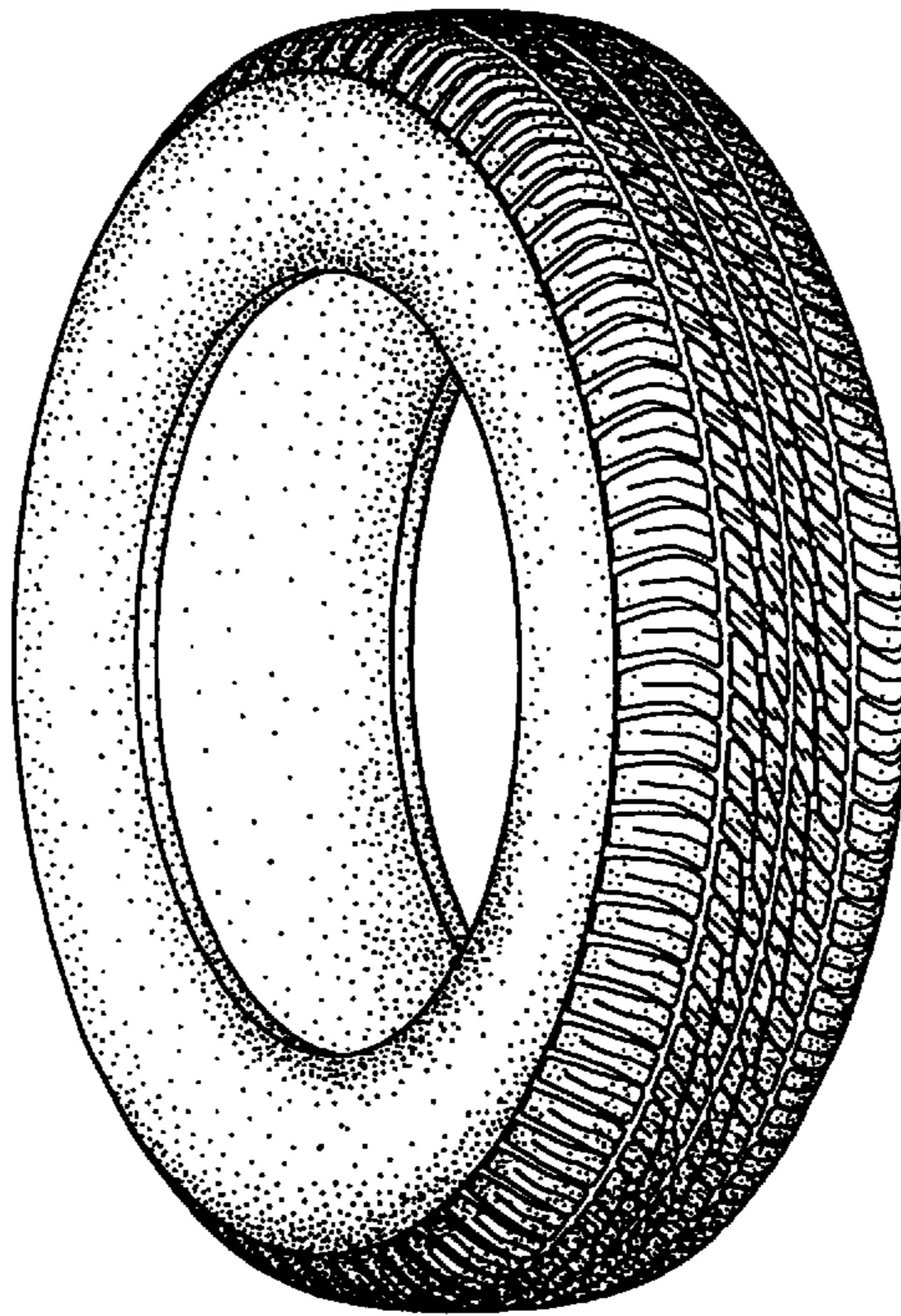

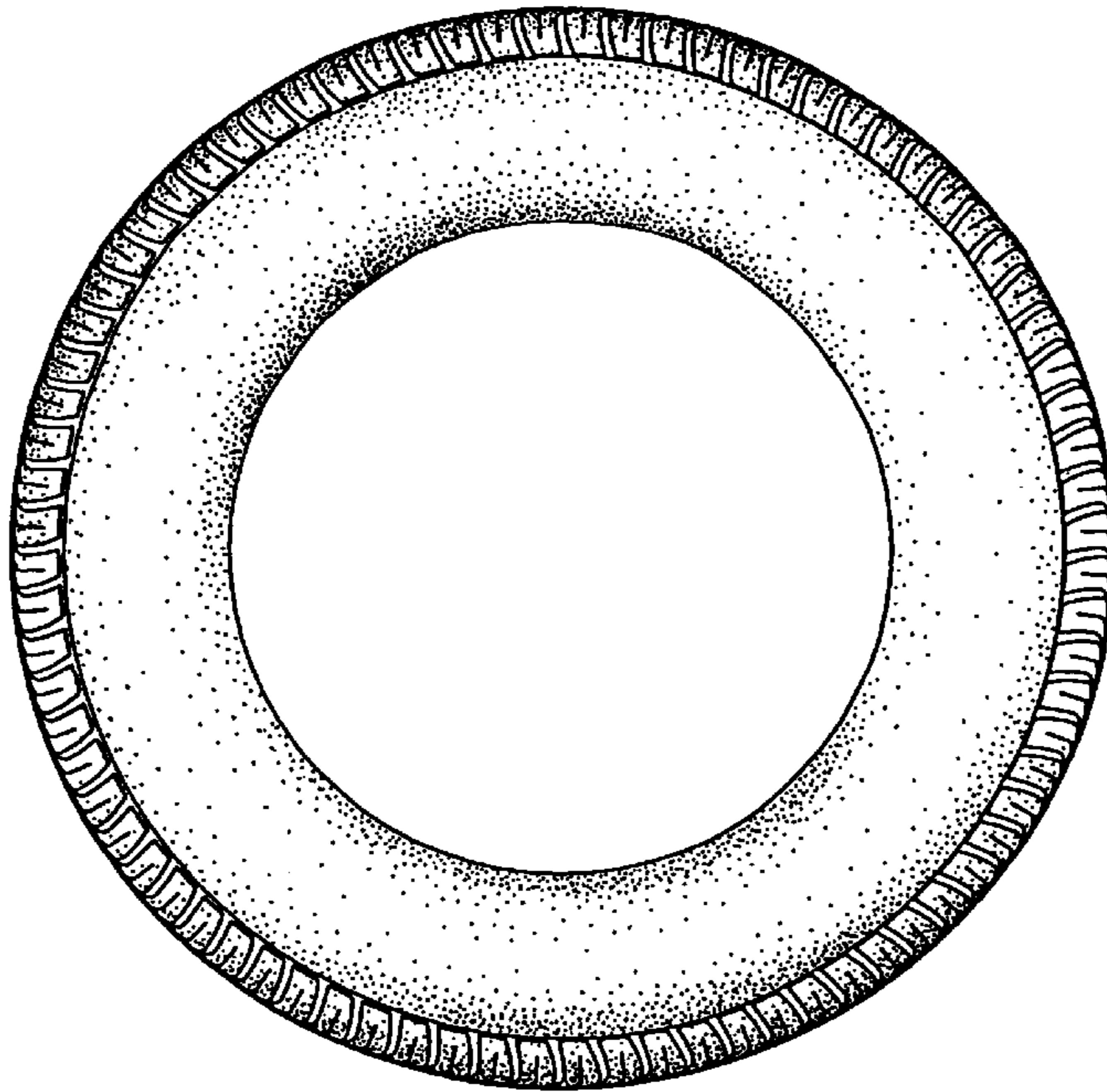

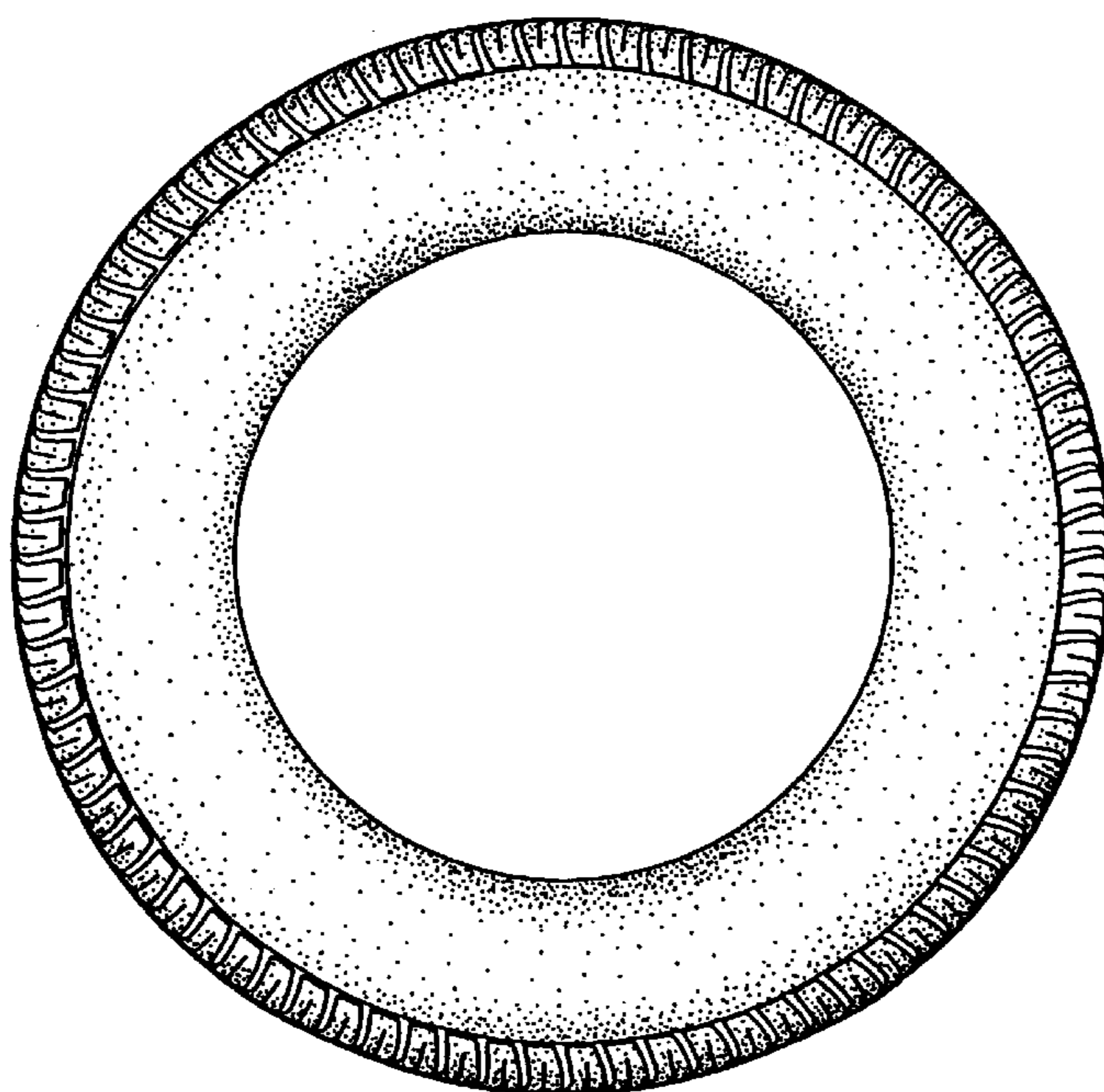

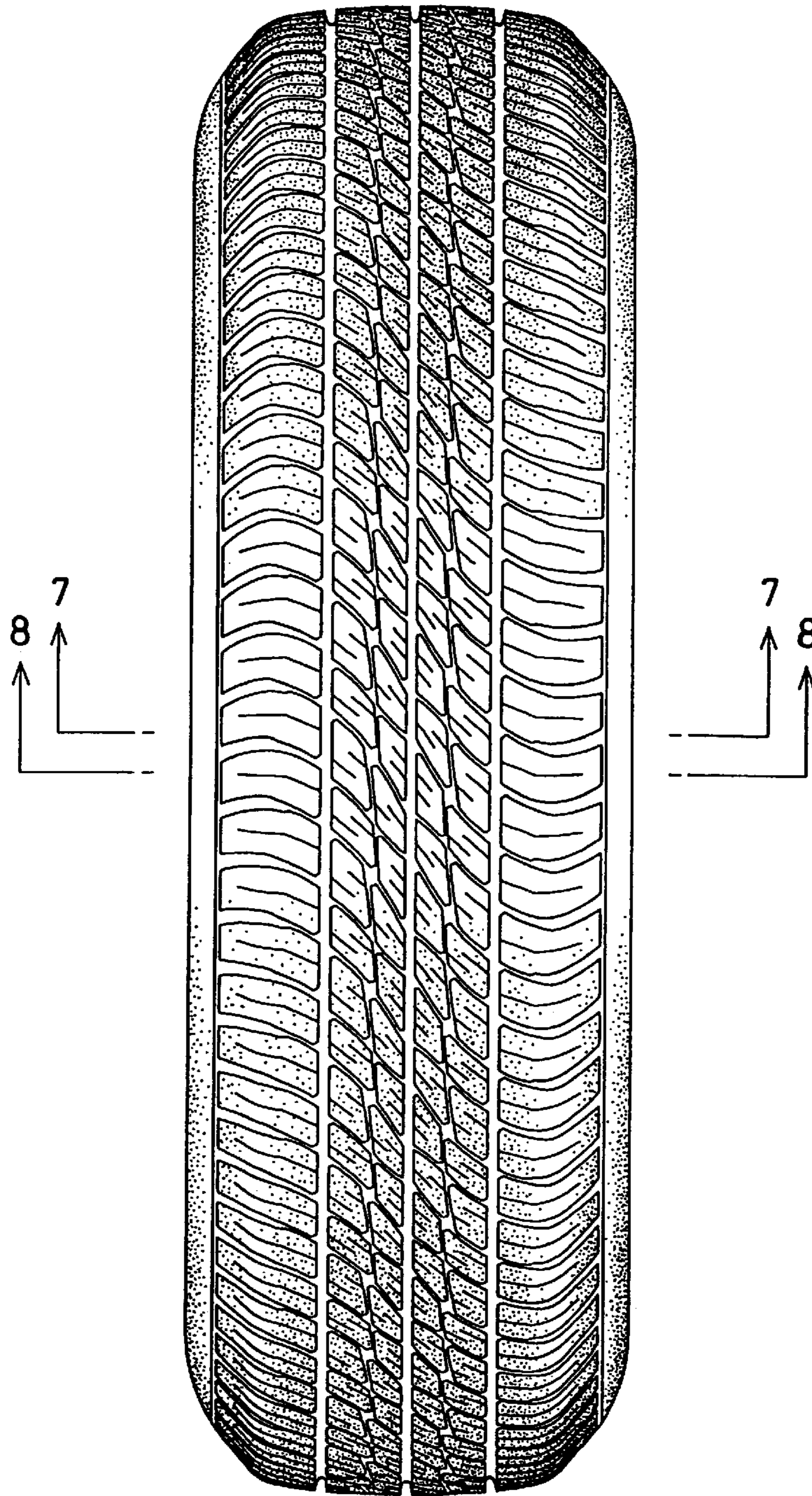

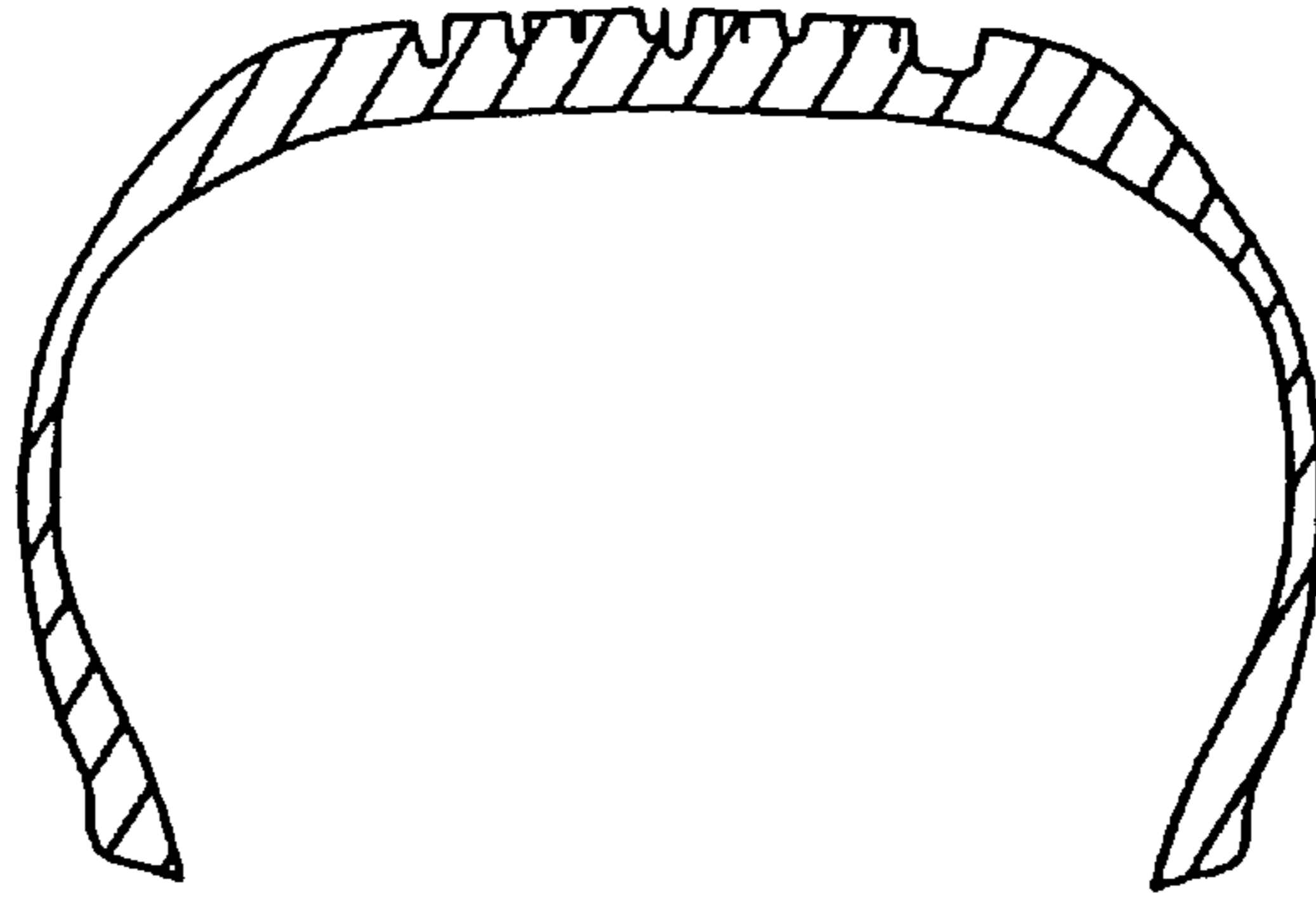

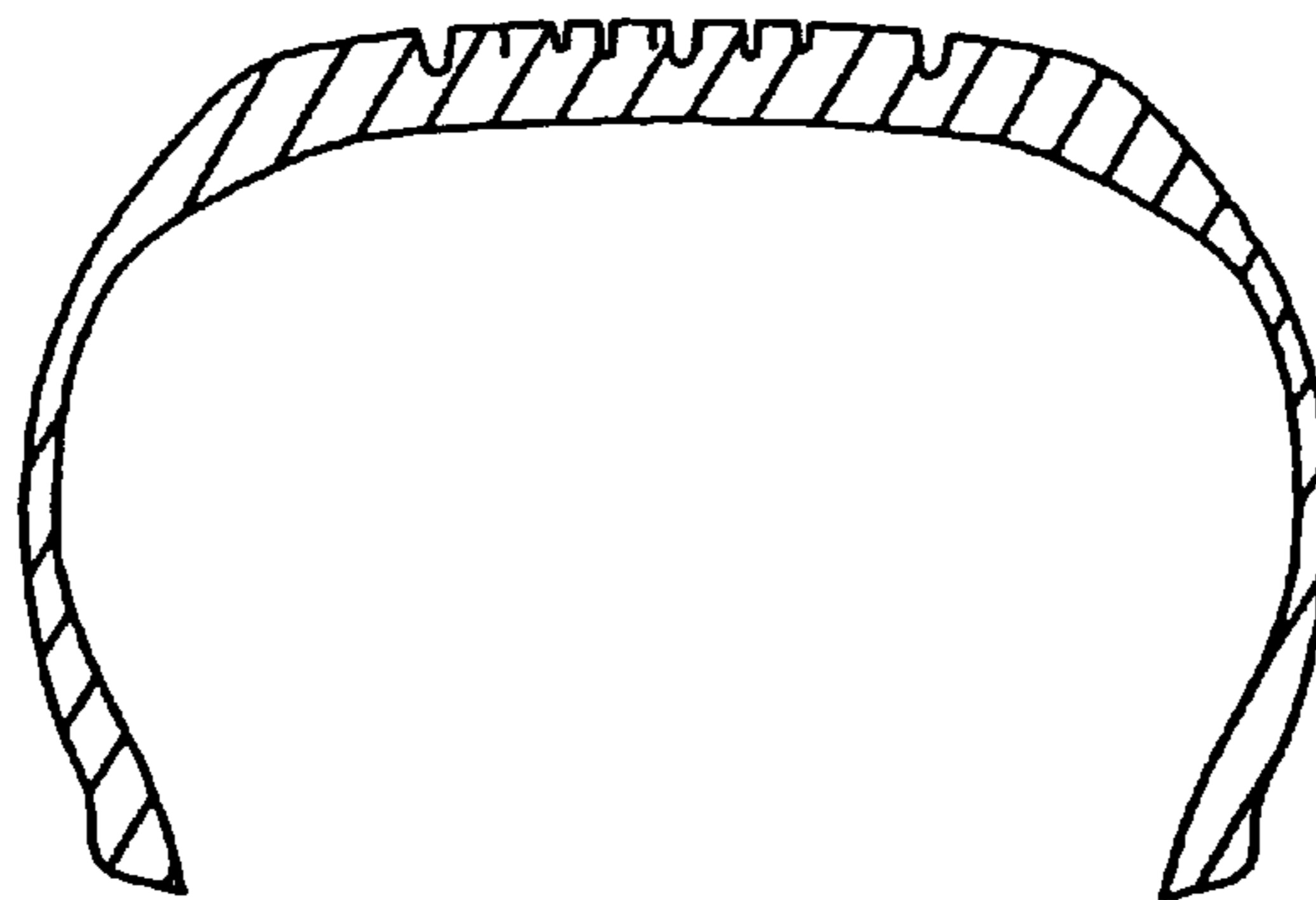
