FIG. 8 is a right side elevational view thereof in the open position. The broken lines are to illustrate an environment only and form no part of the claimed design.

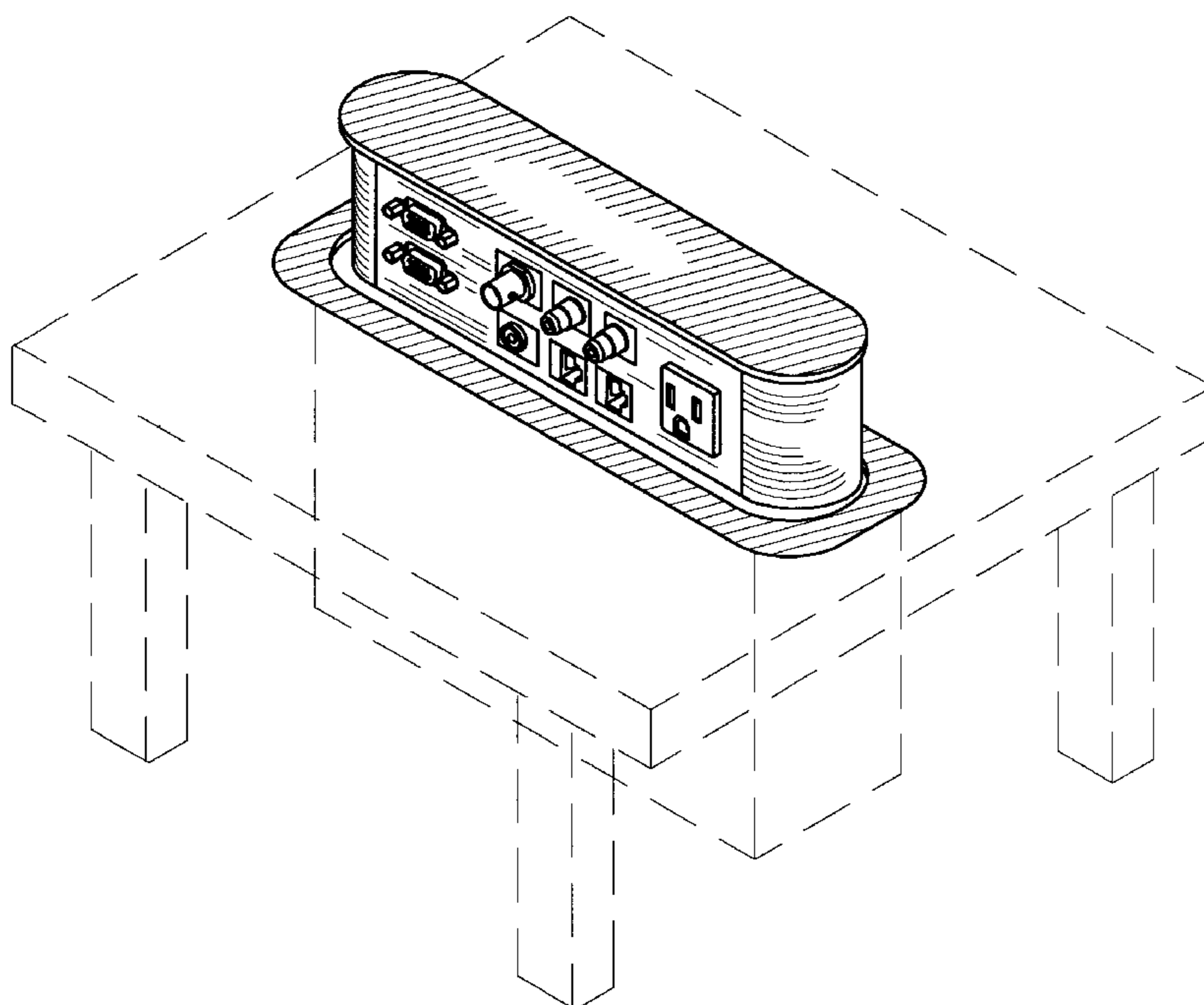
FIG. 9 is a left side elevational view thereof in the concealed position. The broken lines are to illustrate an environment only and form no part of the claimed design.

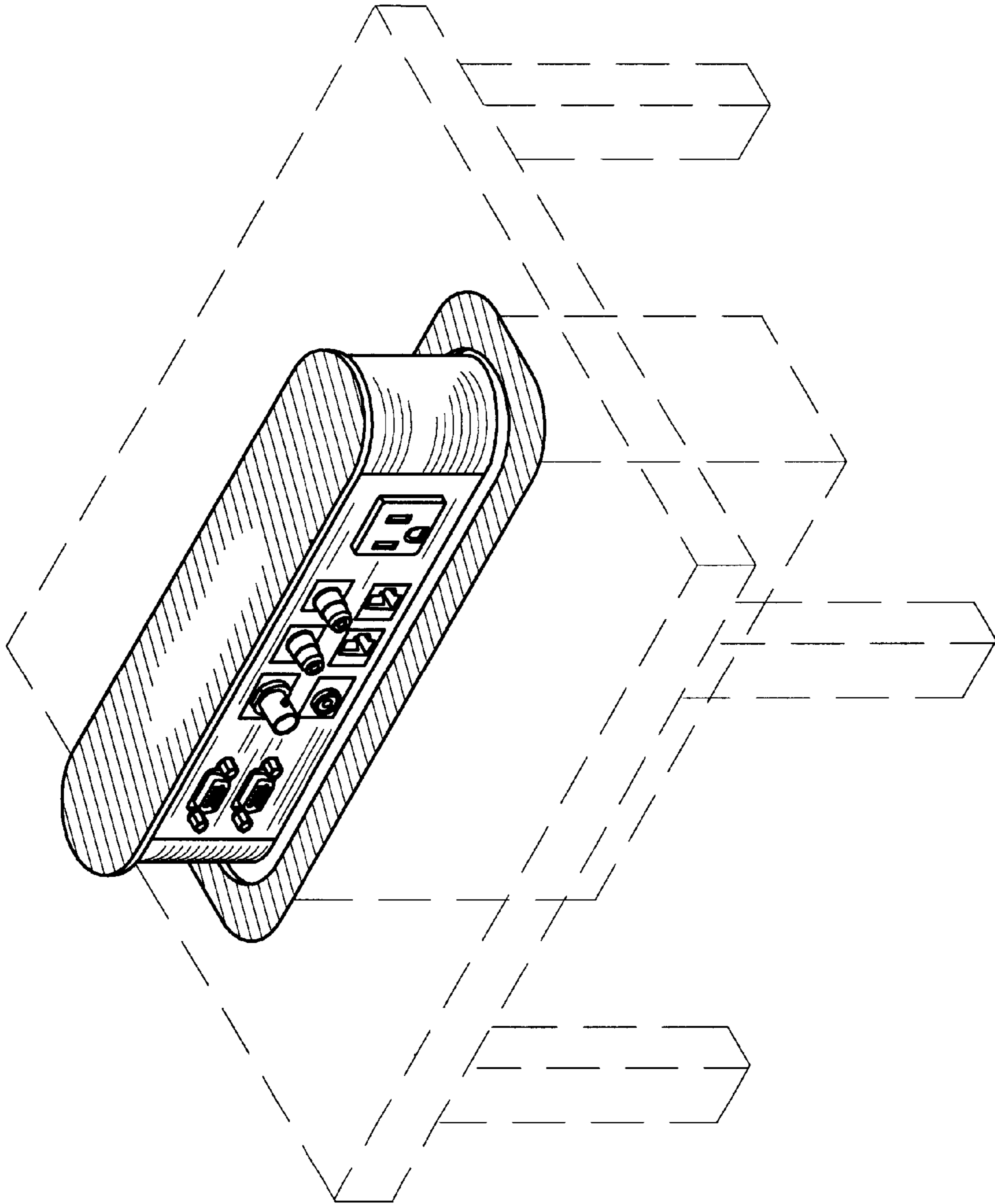

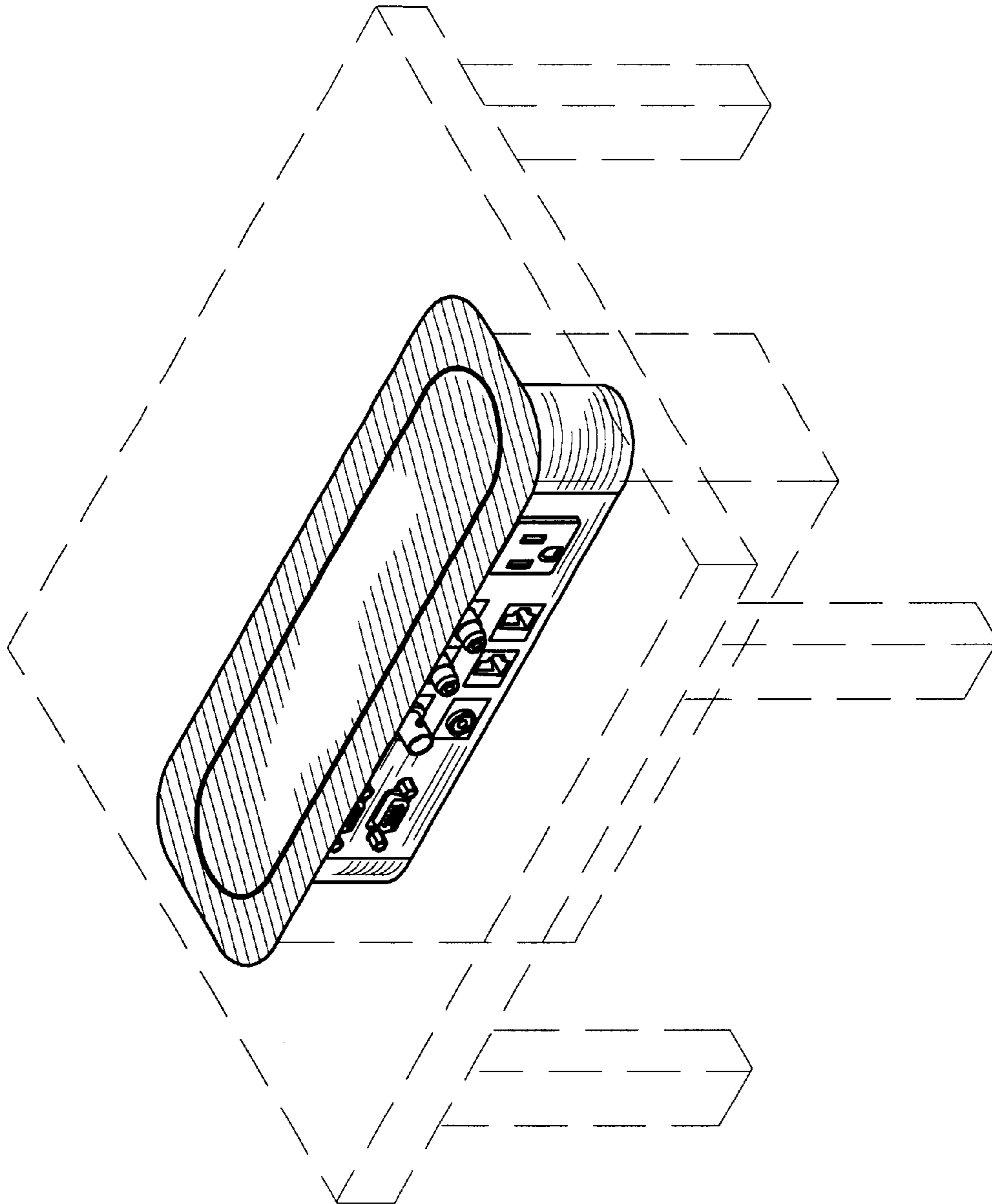

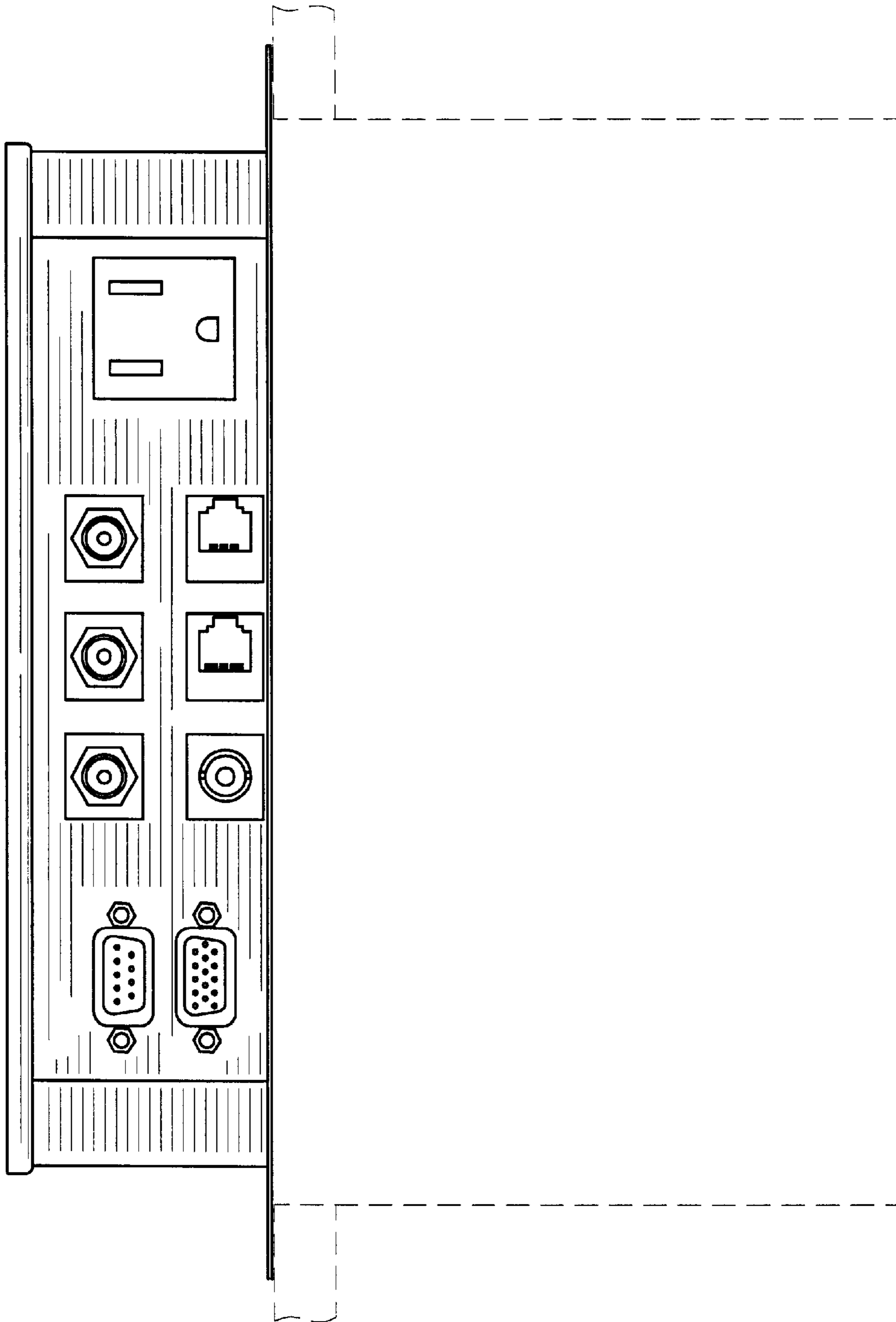

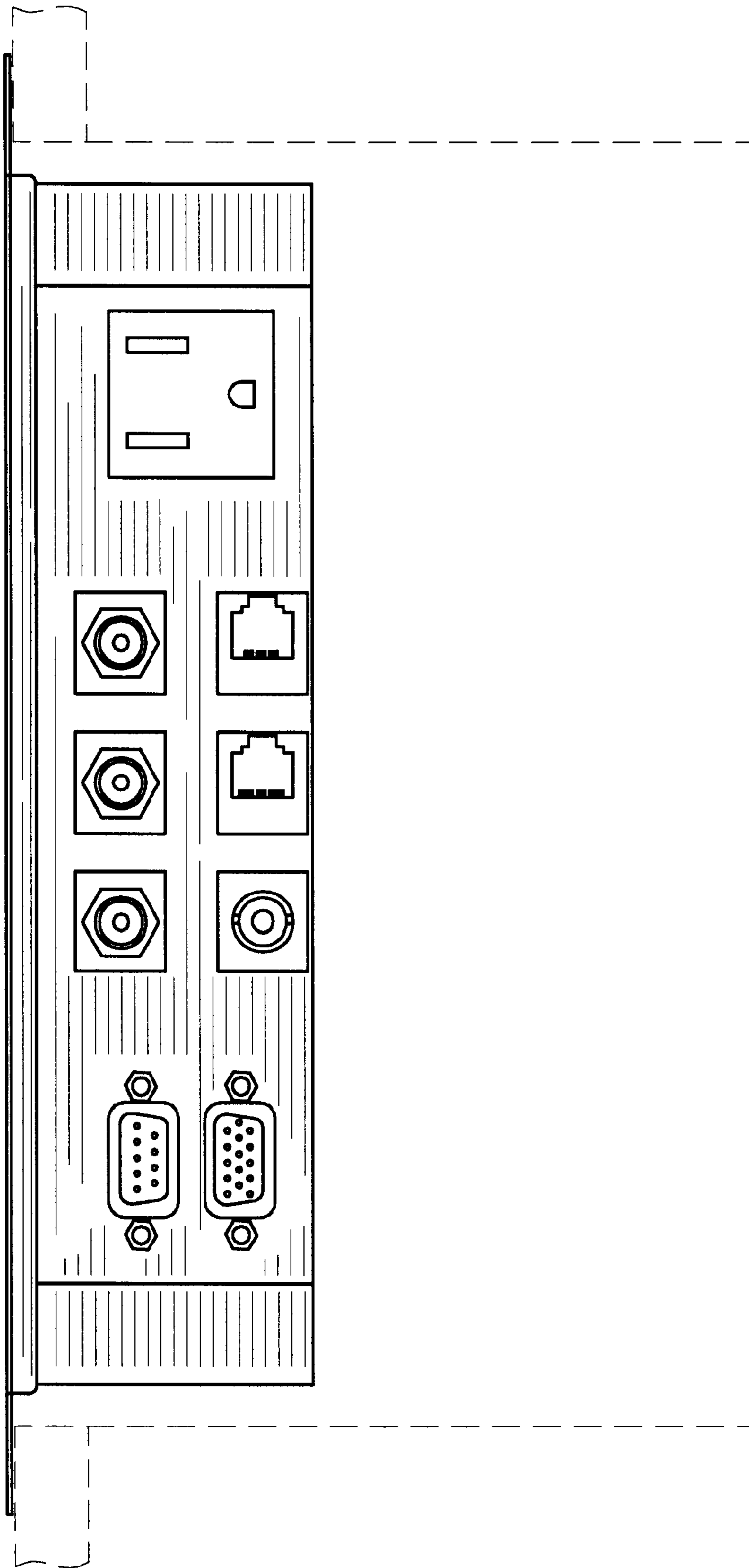

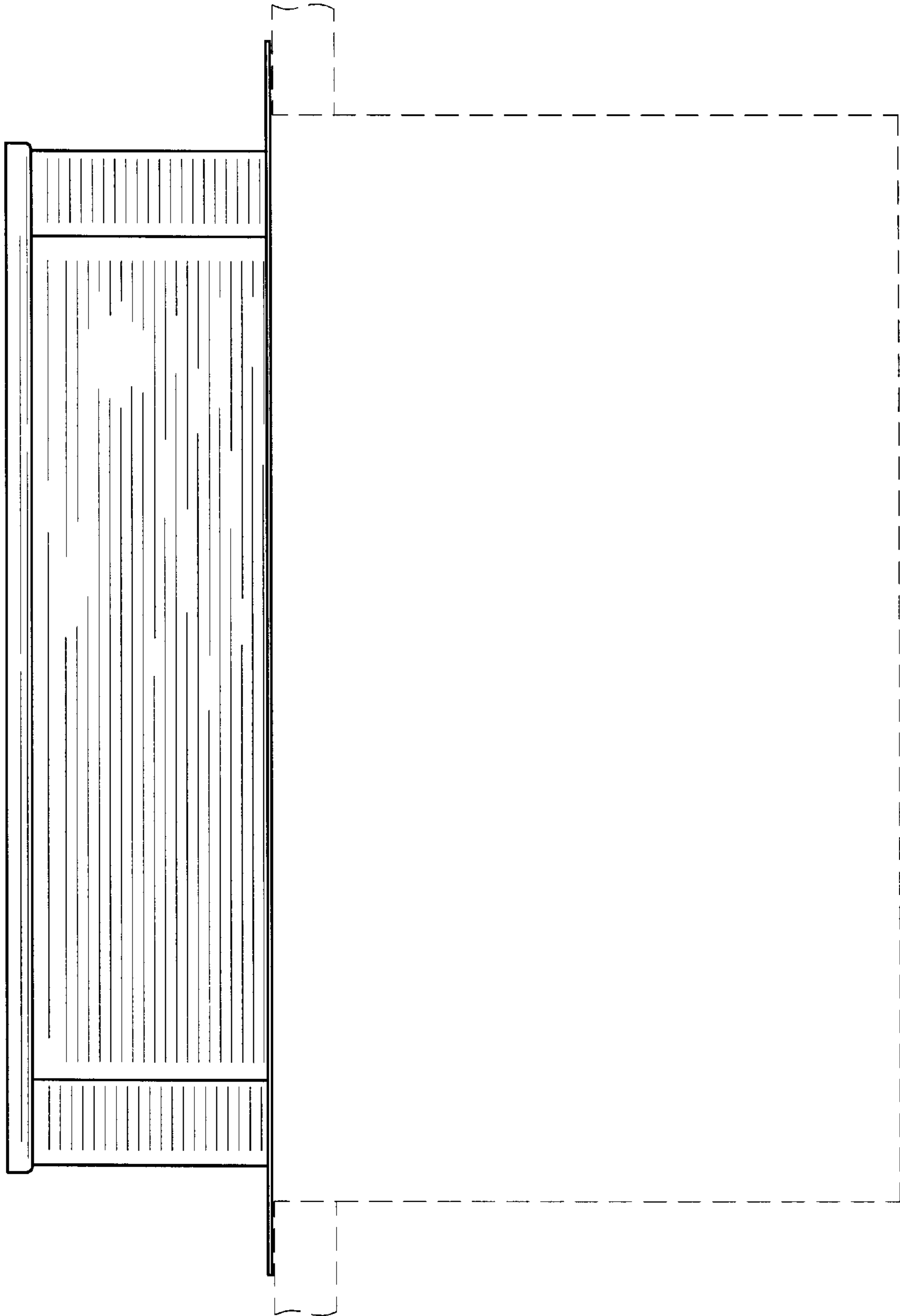

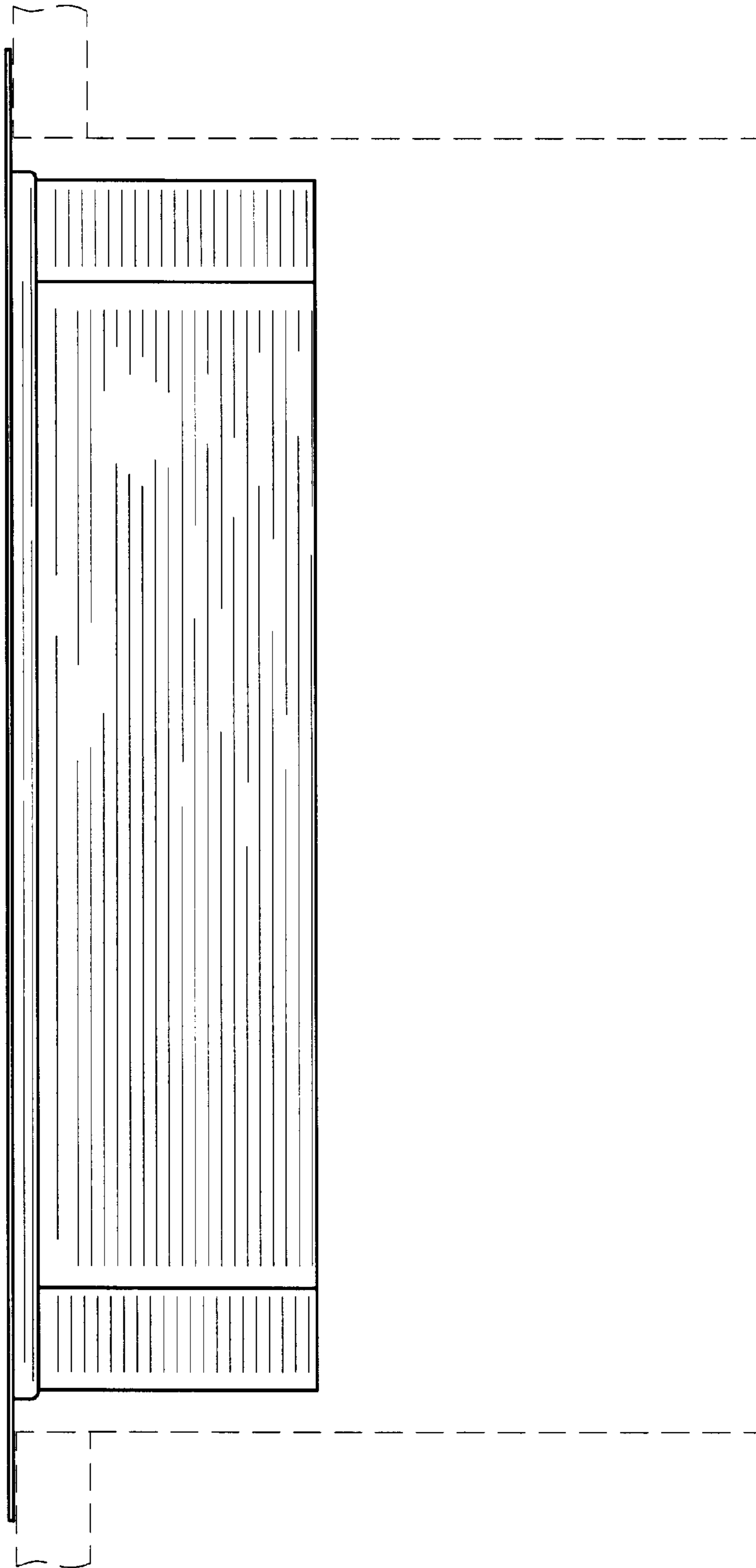

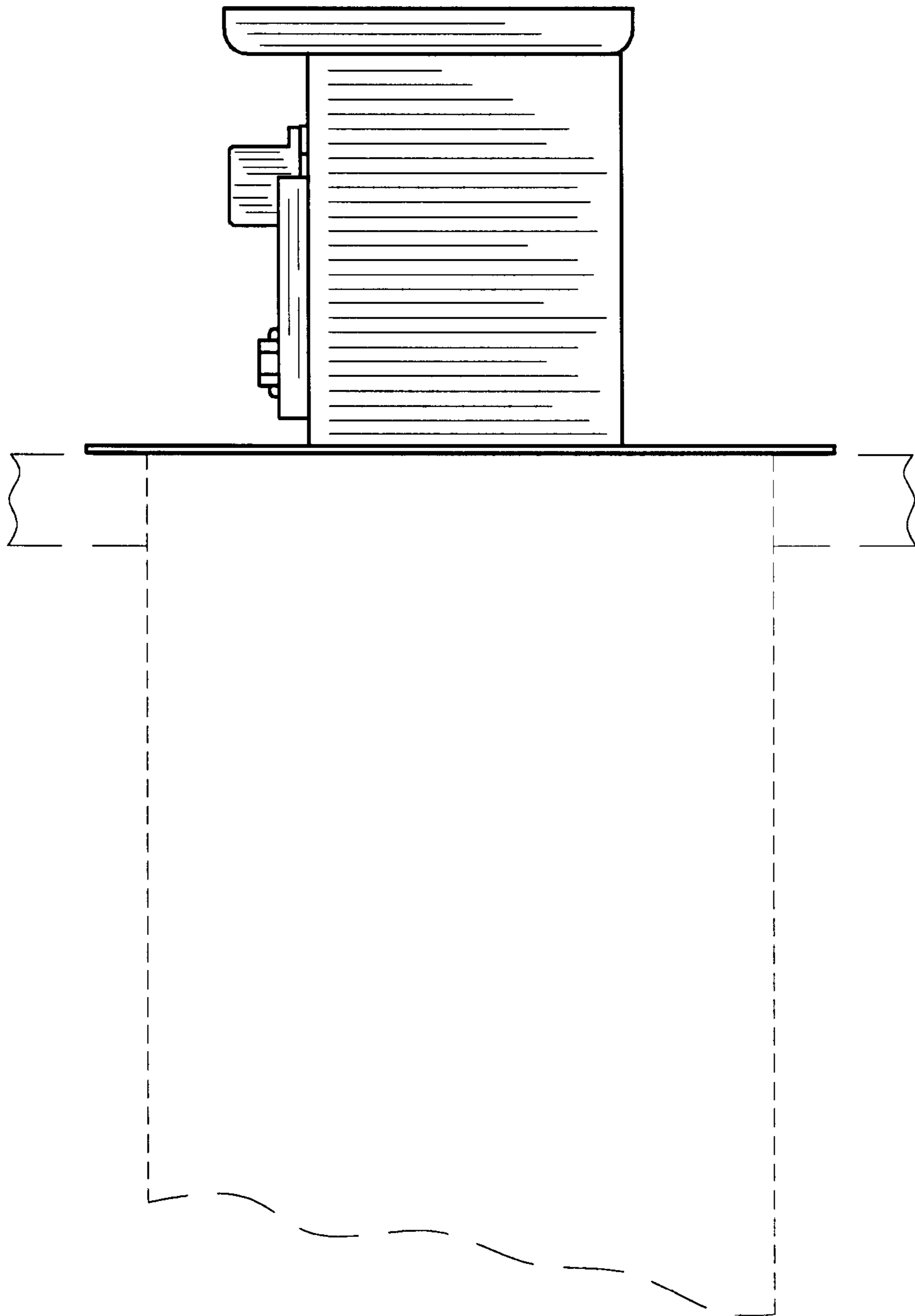

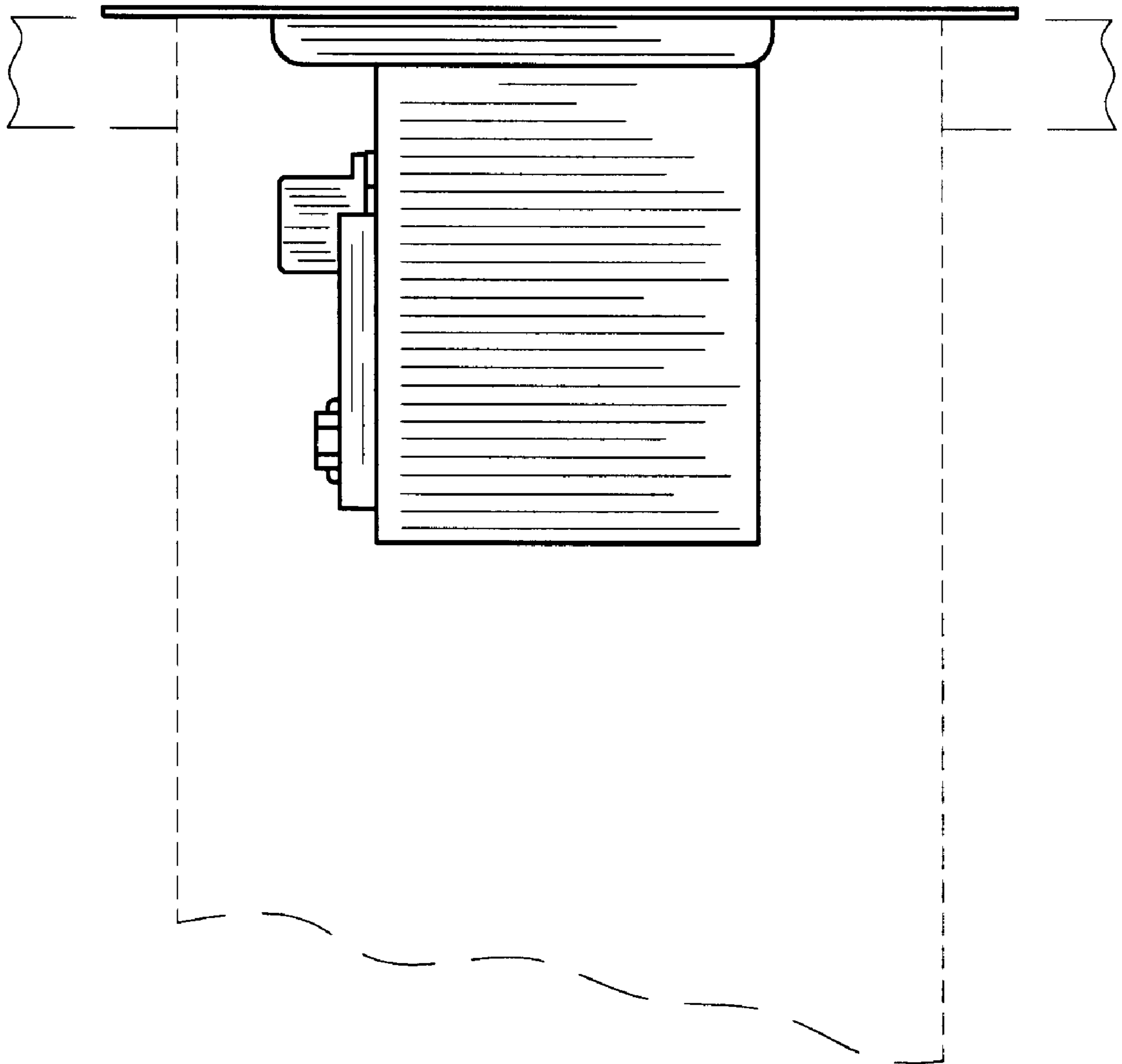

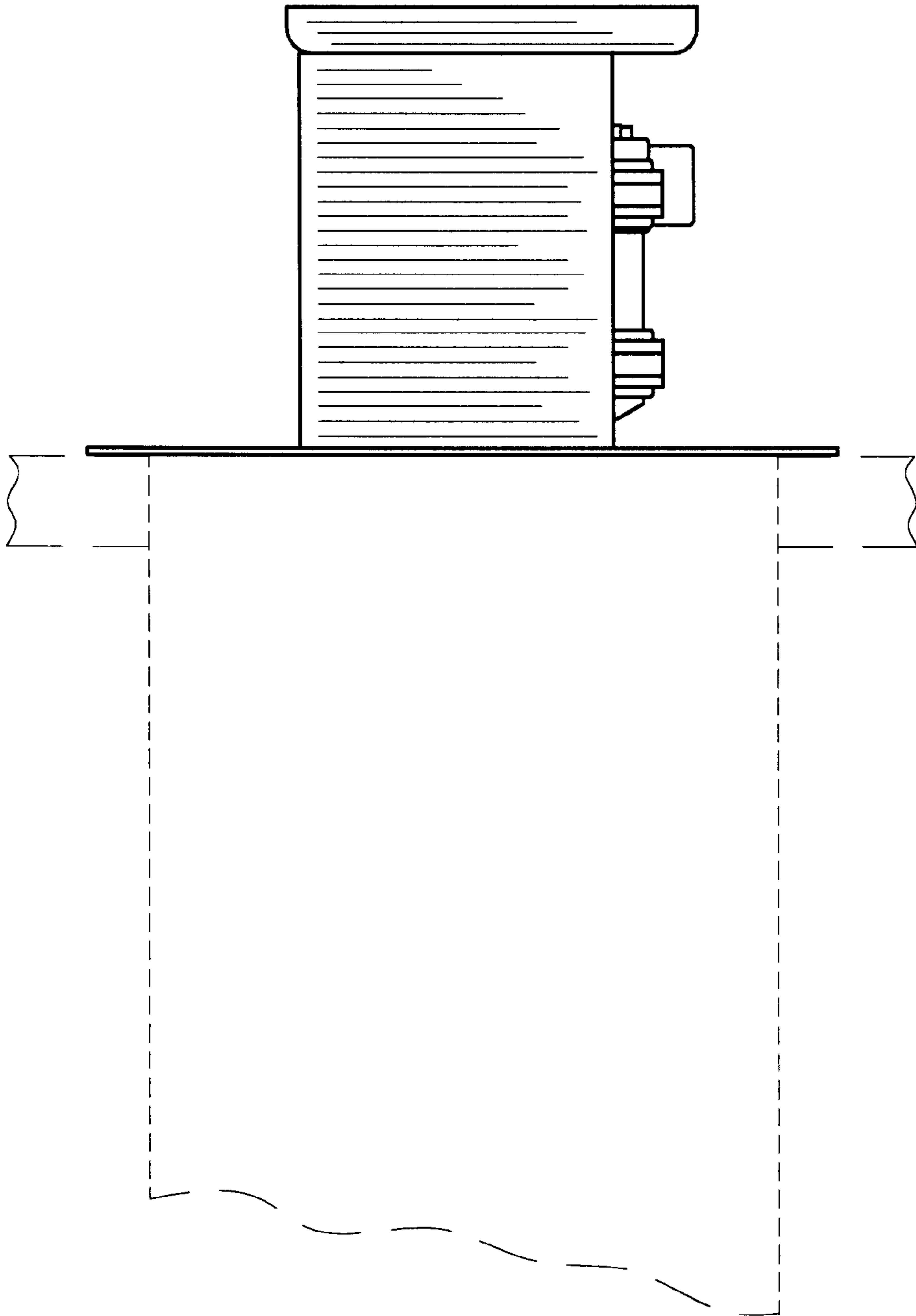

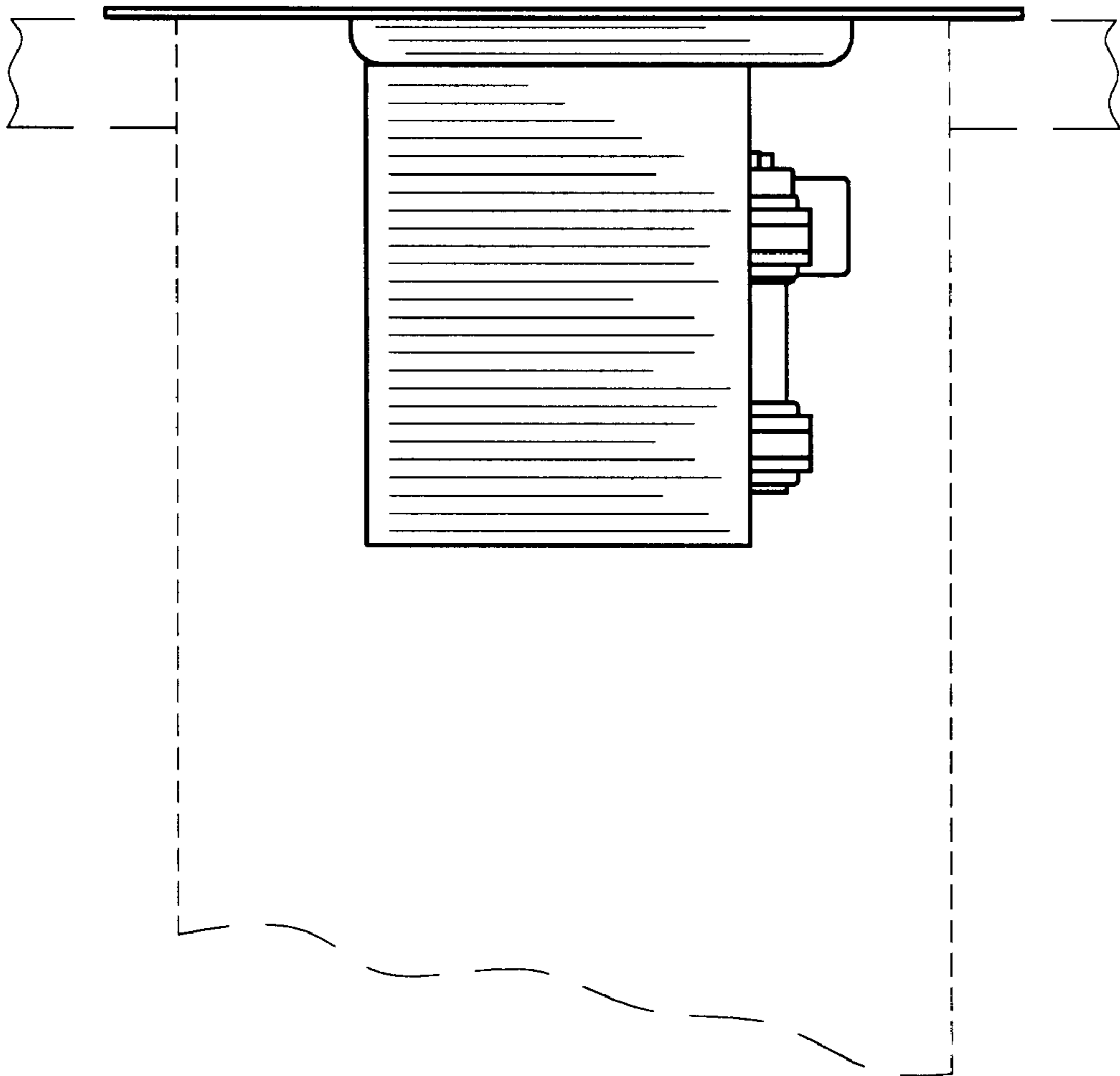

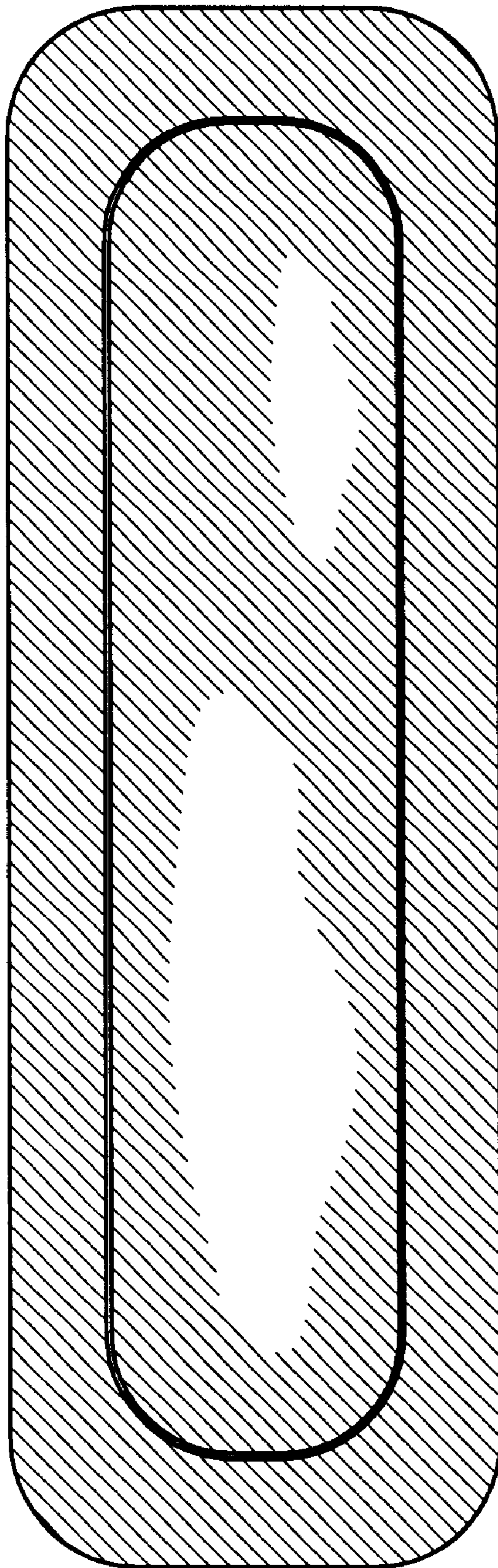
