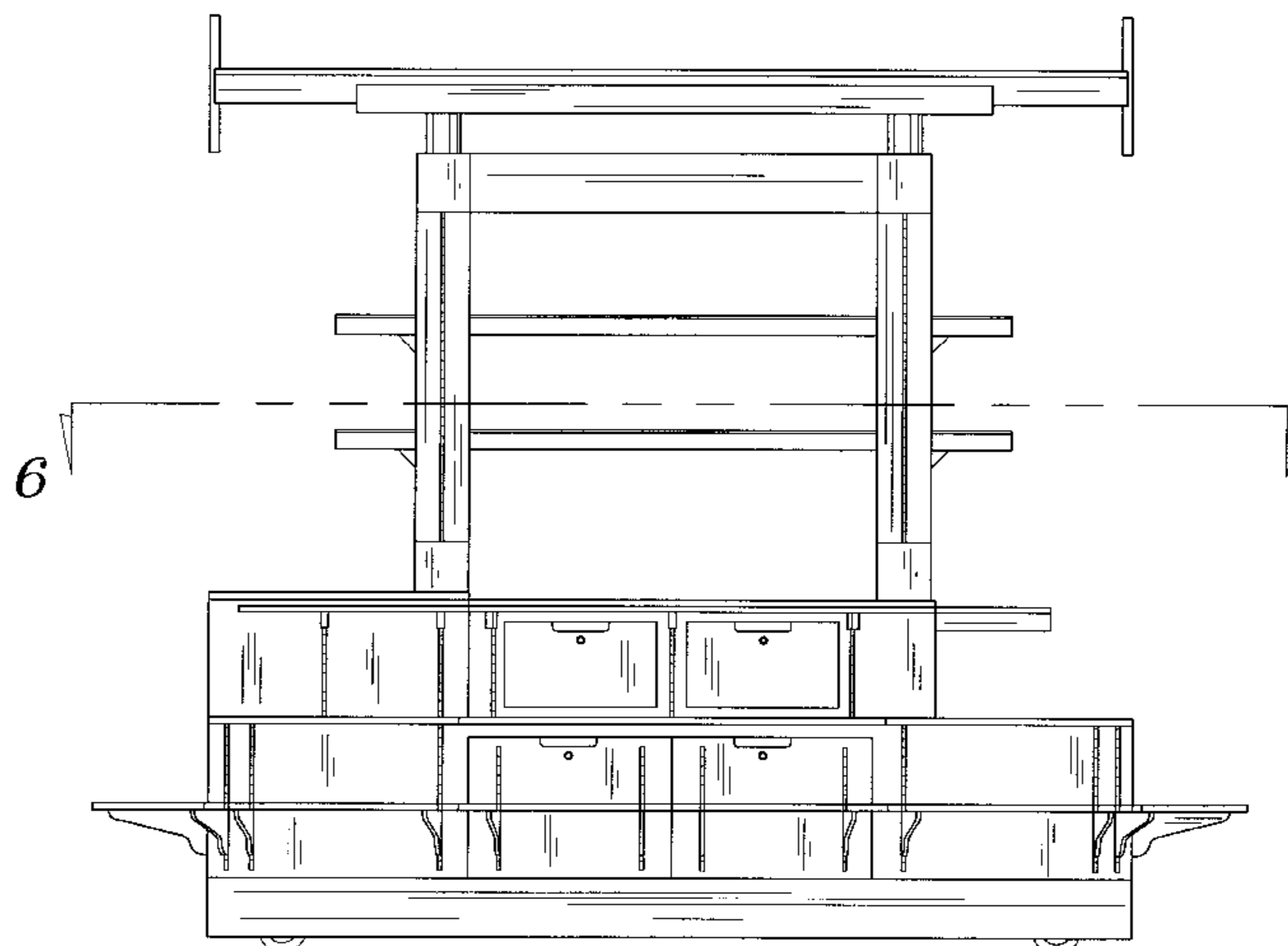
(57) **CLAIM**

The ornamental design for “kiosk”, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a kiosk showing my new design;
 FIG. 2 is a front elevational view thereof, the rear elevational view being identical thereto;
 FIG. 3 is a right side elevational view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof; and,
 FIG. 6 is a sectional view thereof taken generally along sectional lines 6—6 of FIG. 2.

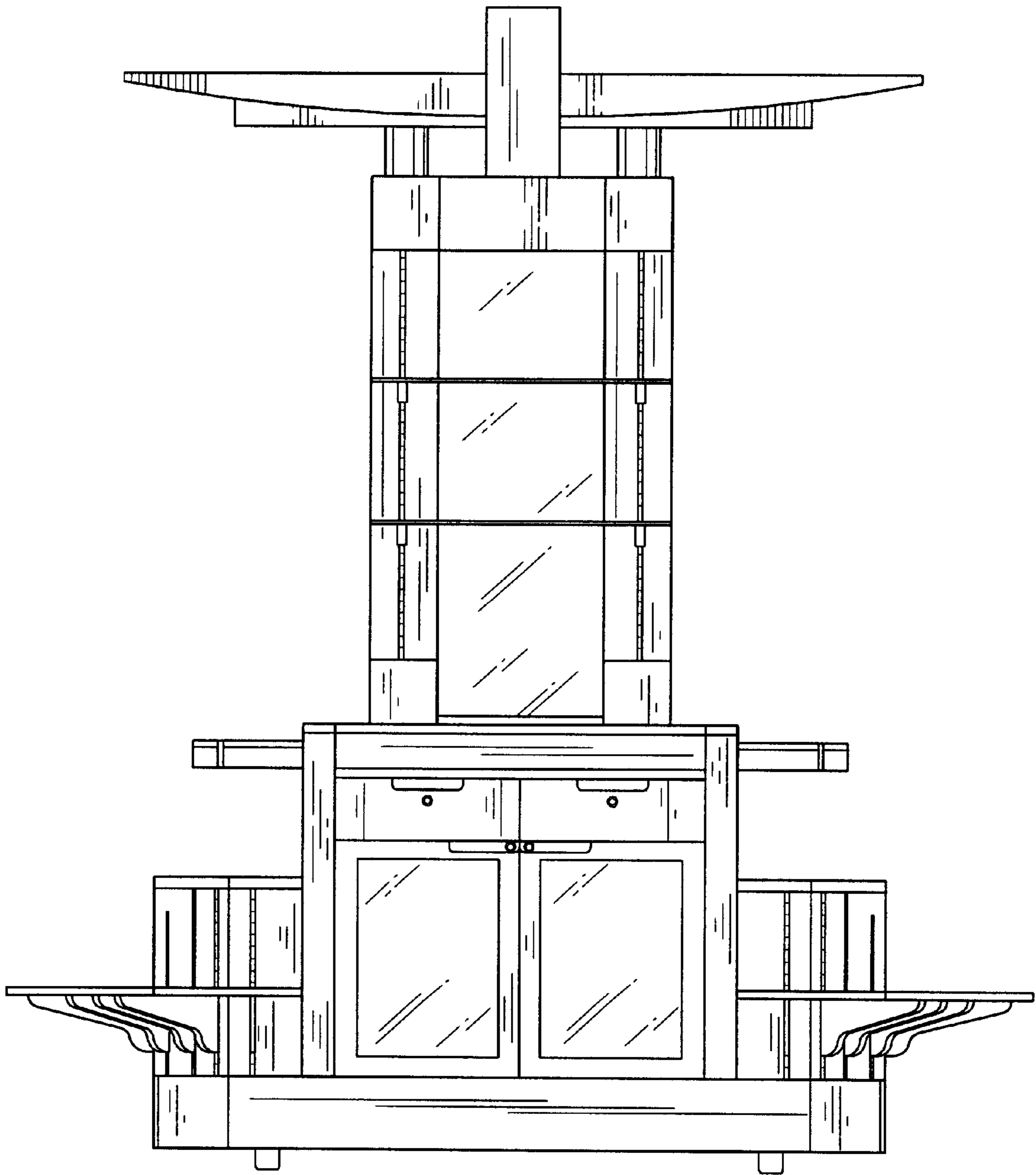
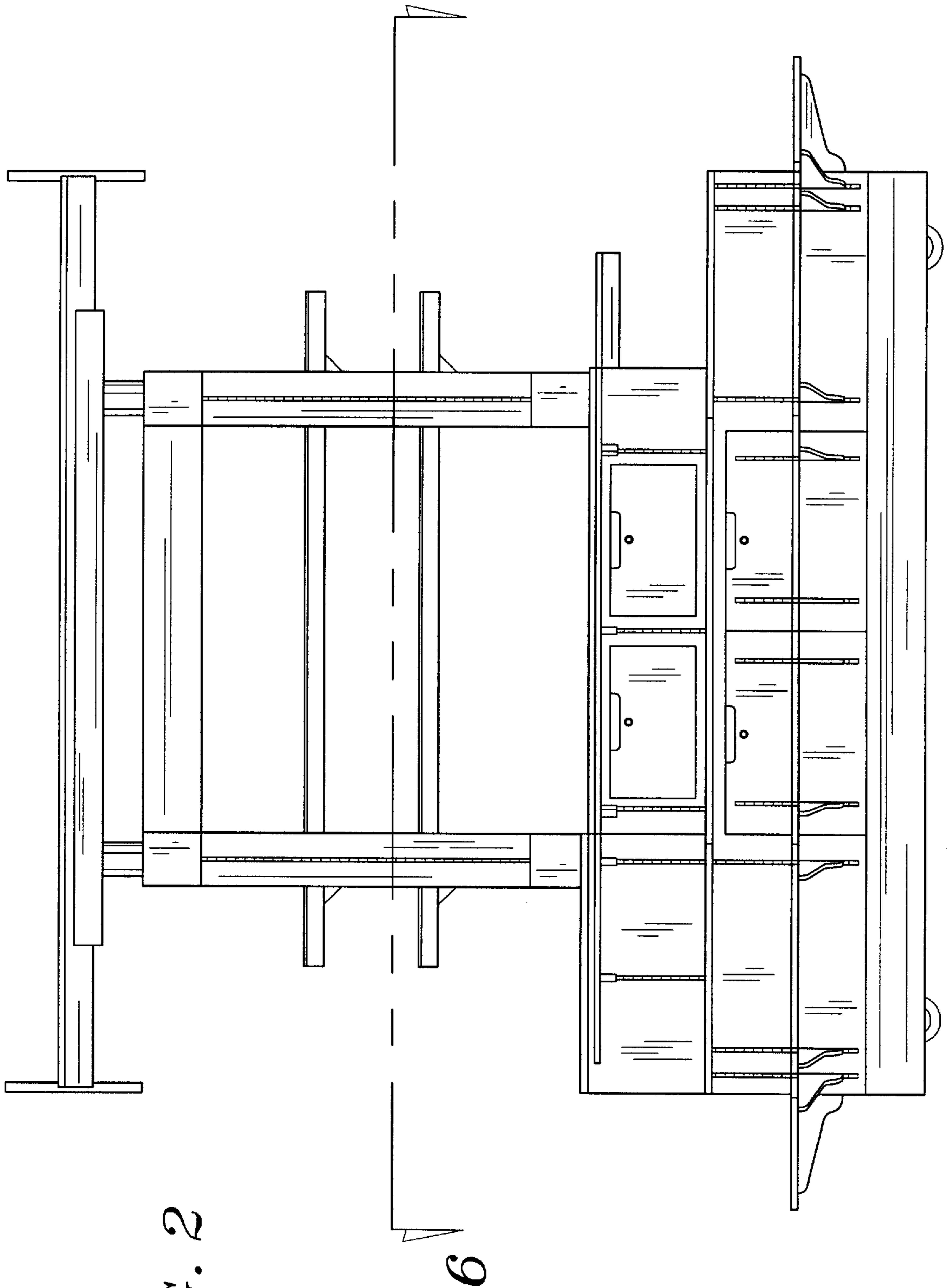

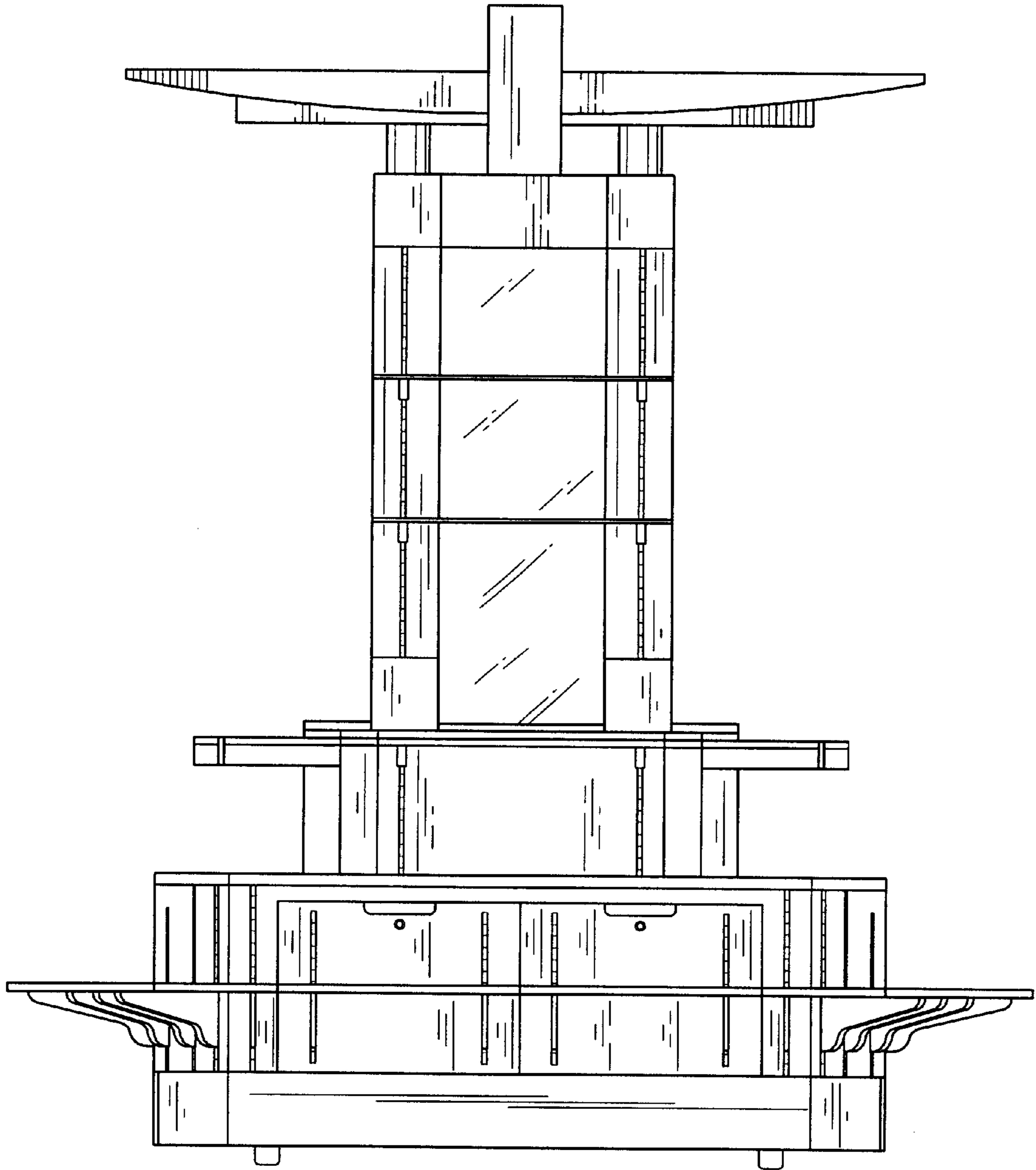

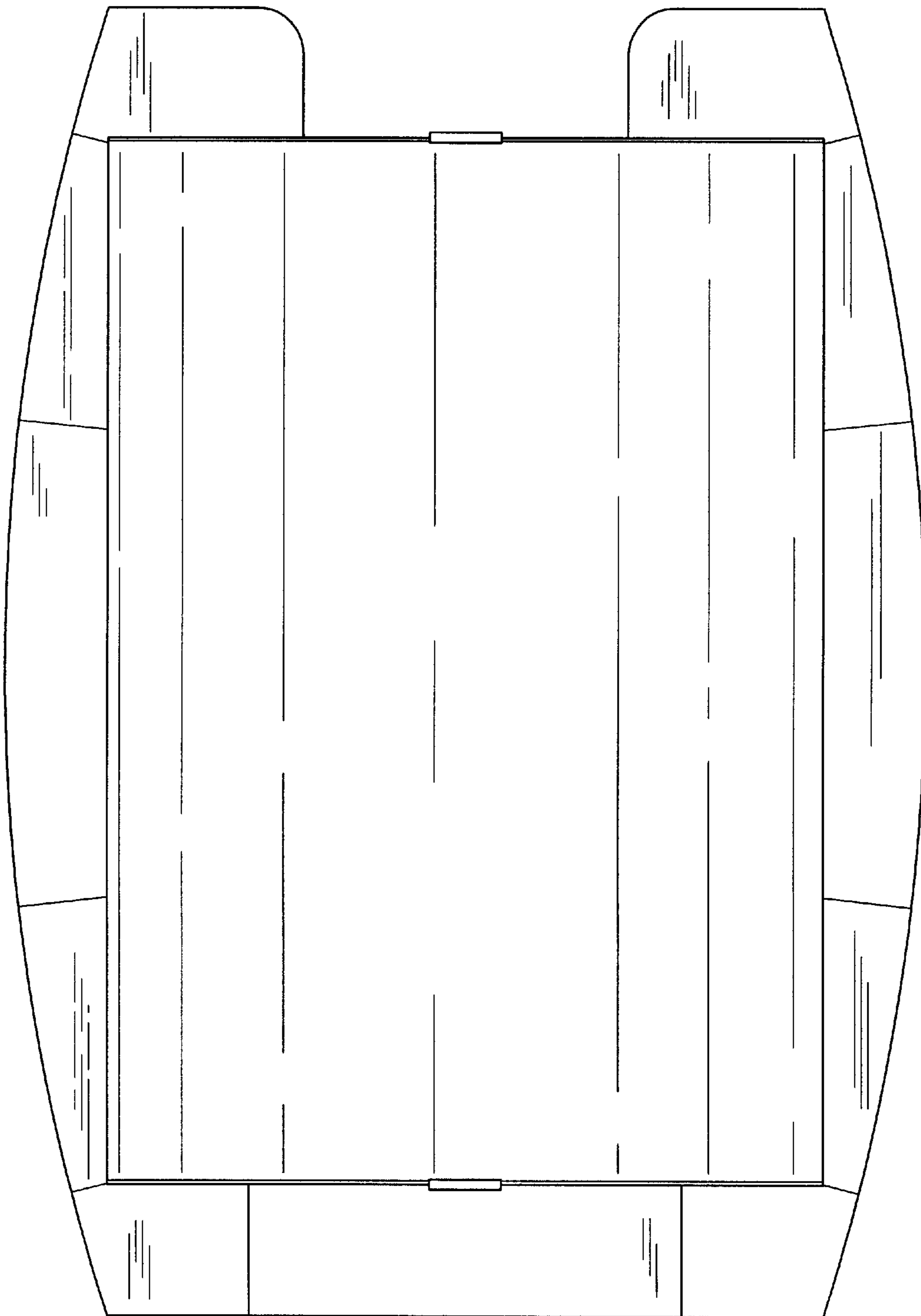

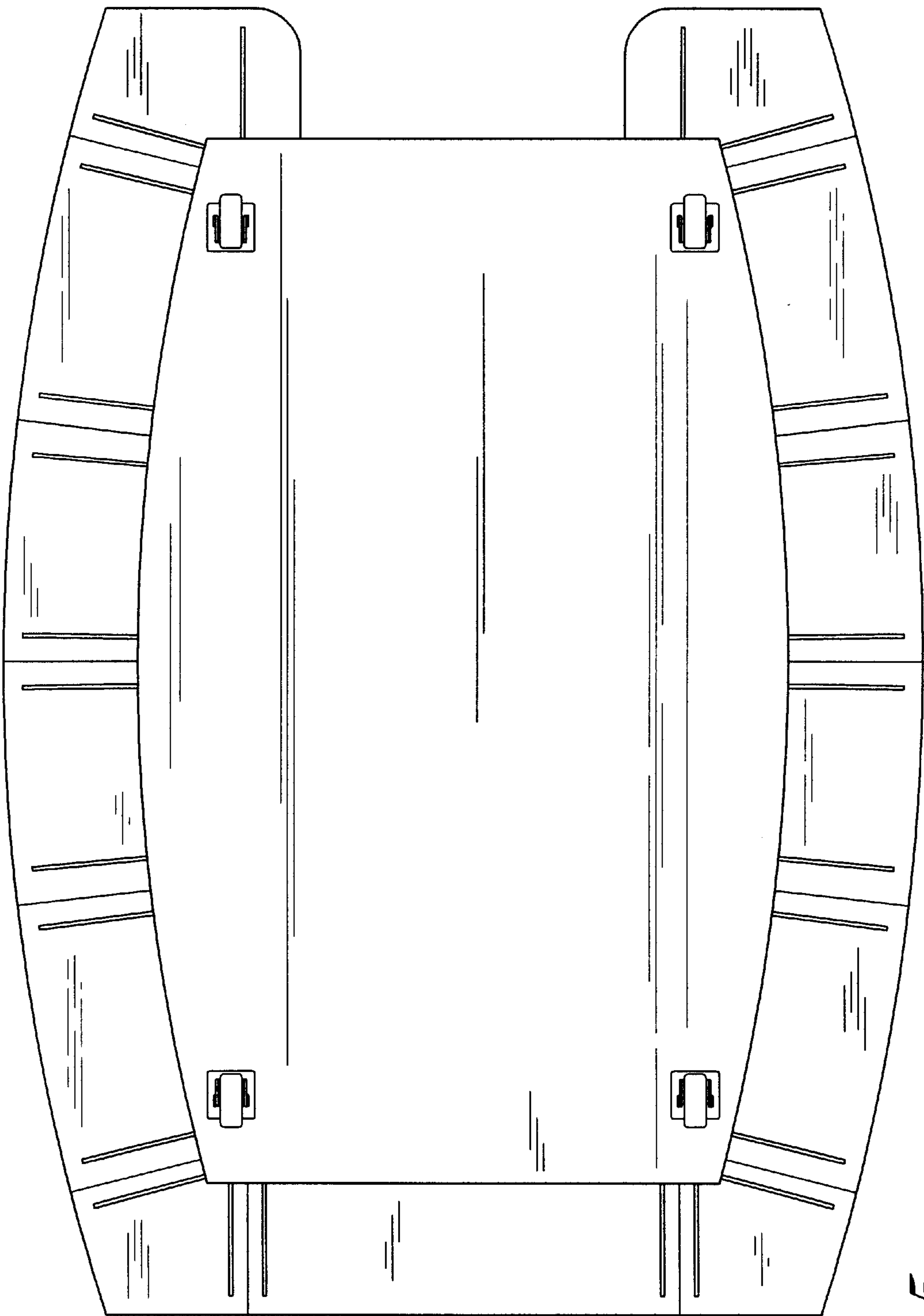

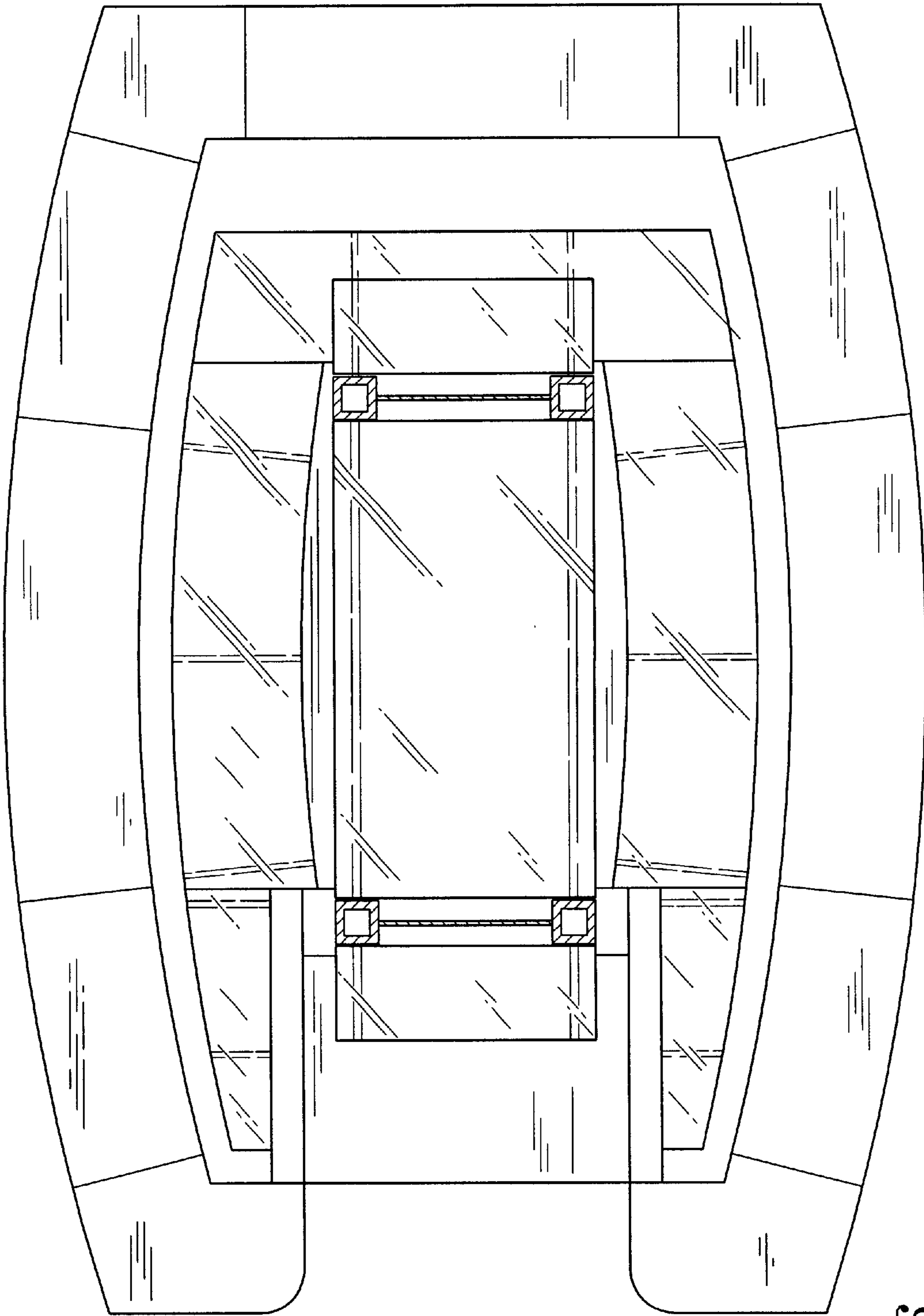
