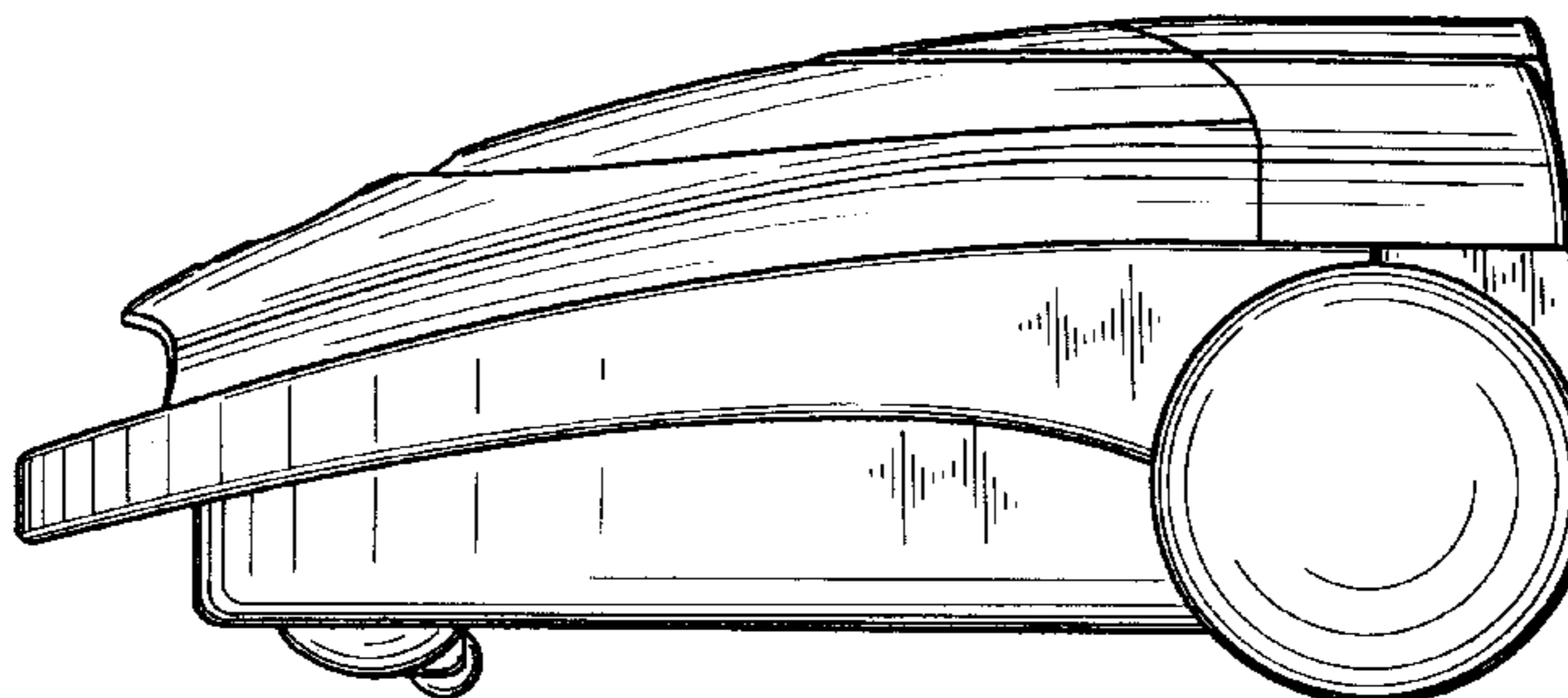
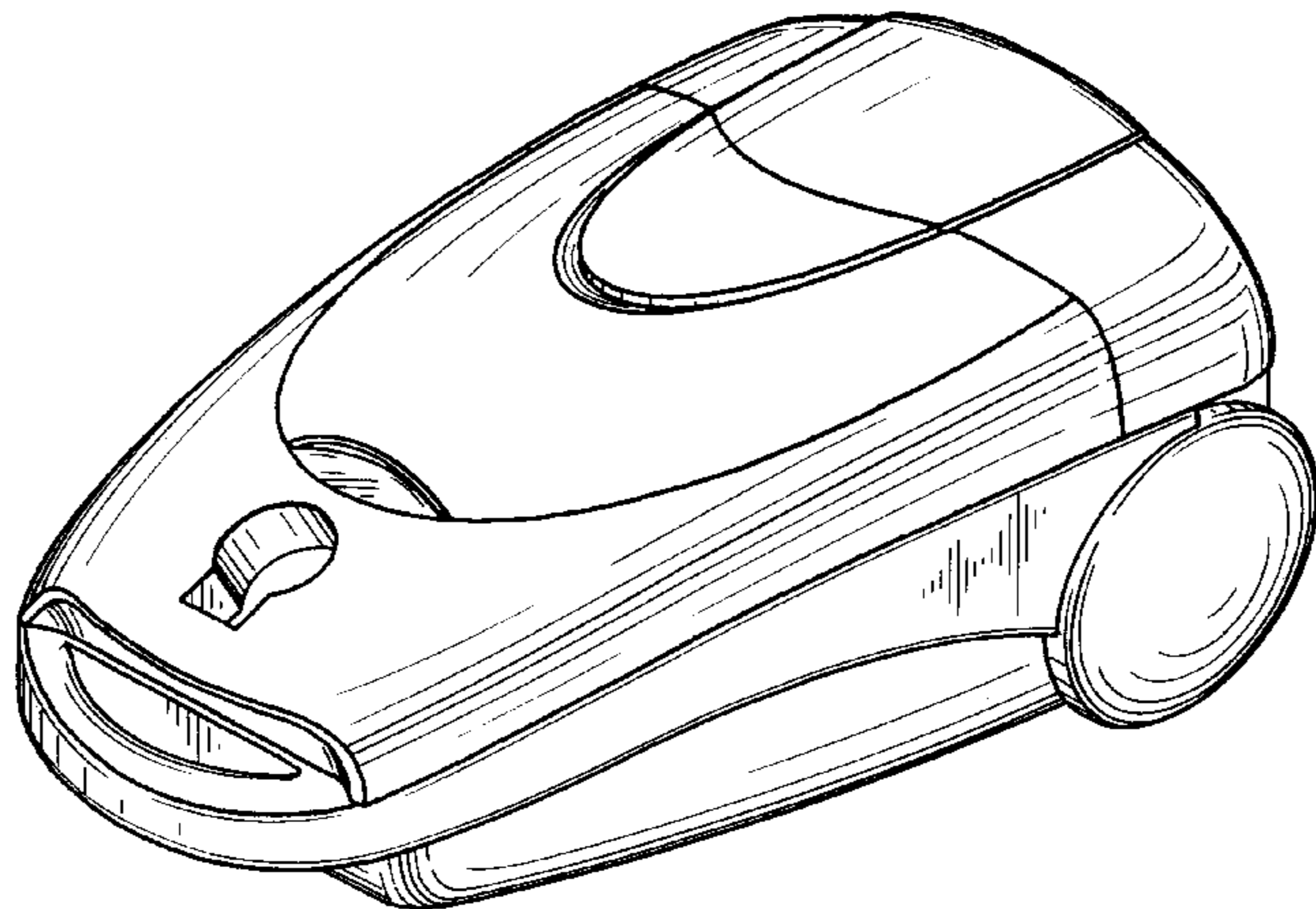
(57) **CLAIM**

The ornamental design for an electric vacuum cleaner, as shown and described.

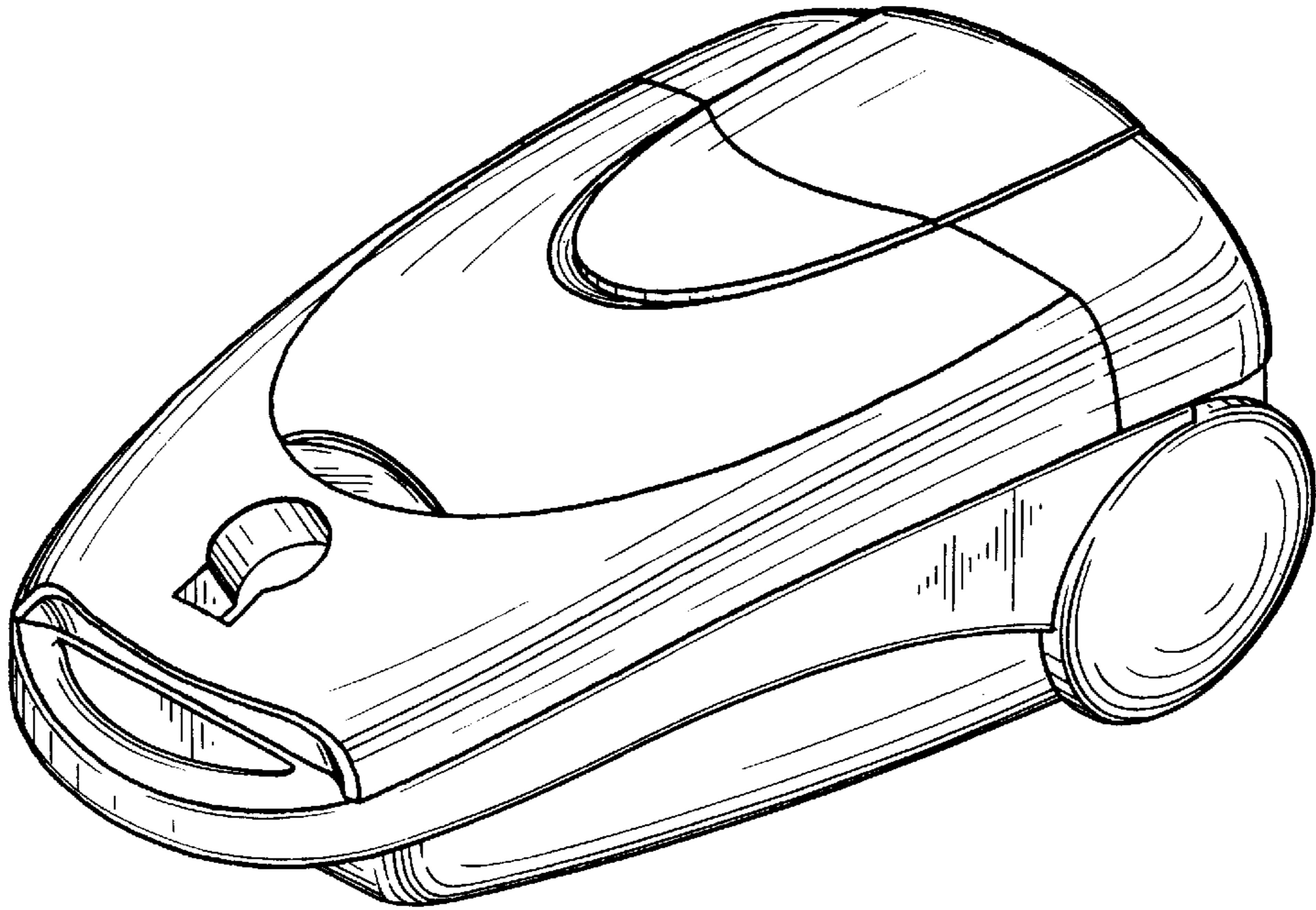
**DESCRIPTION**

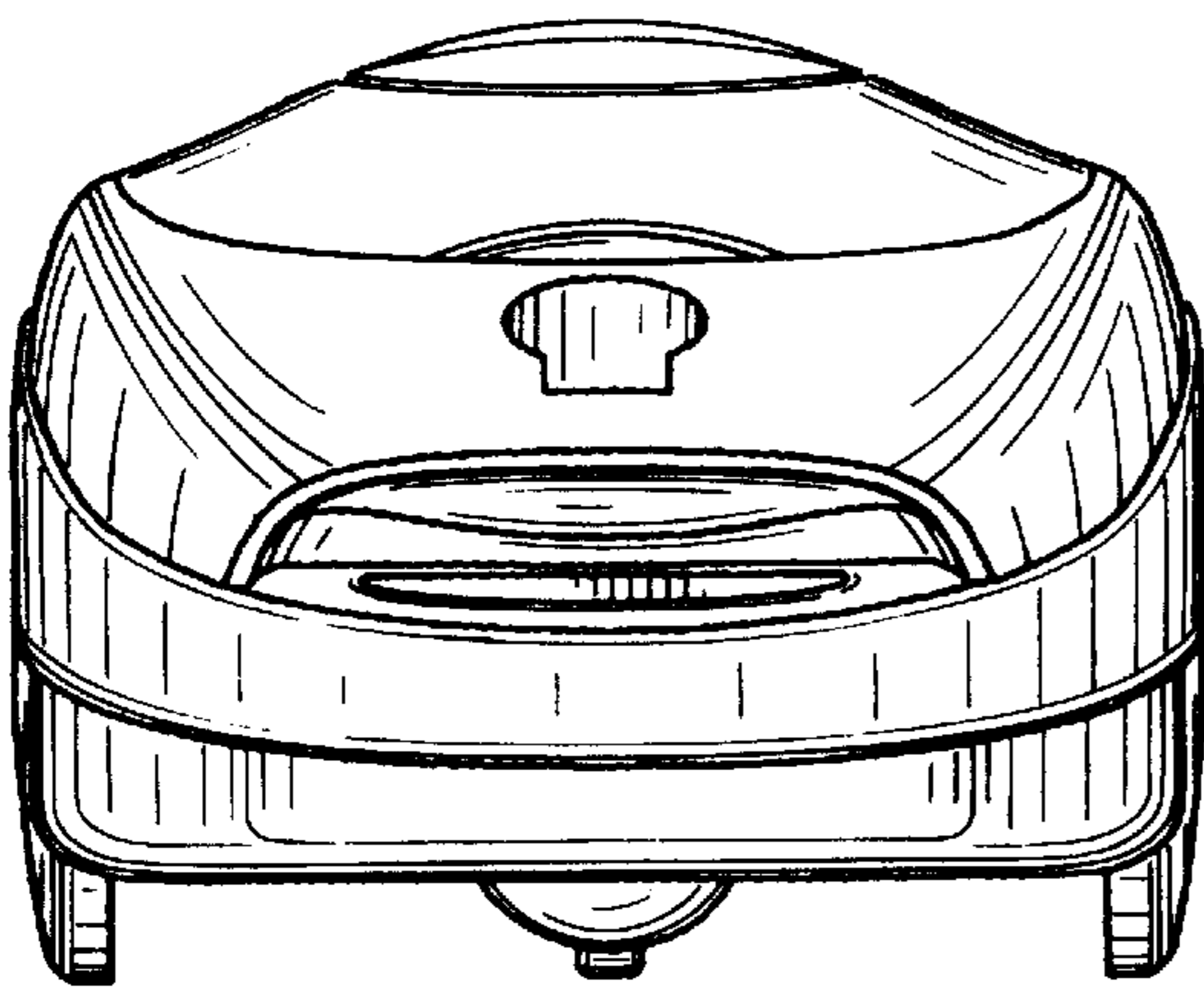

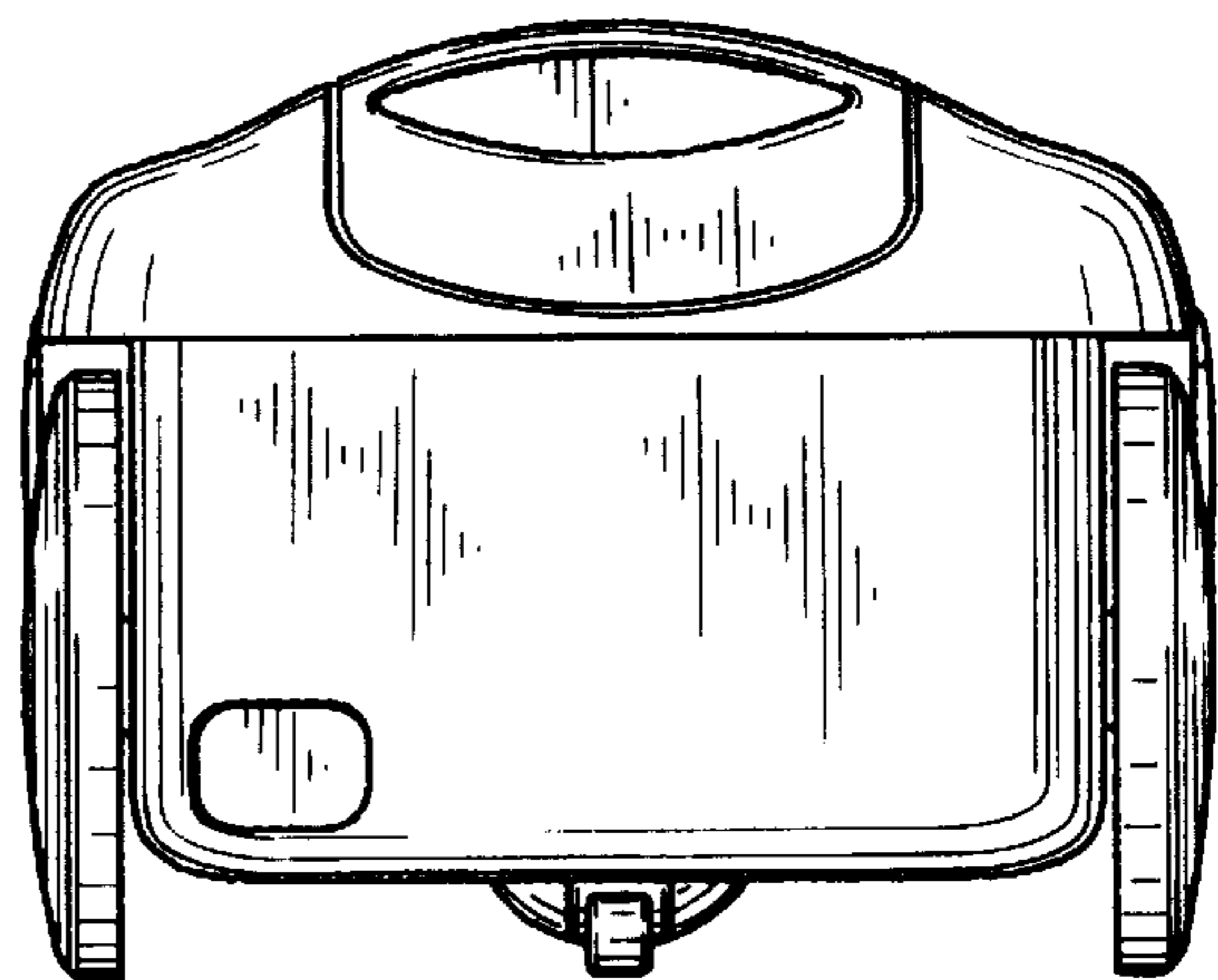

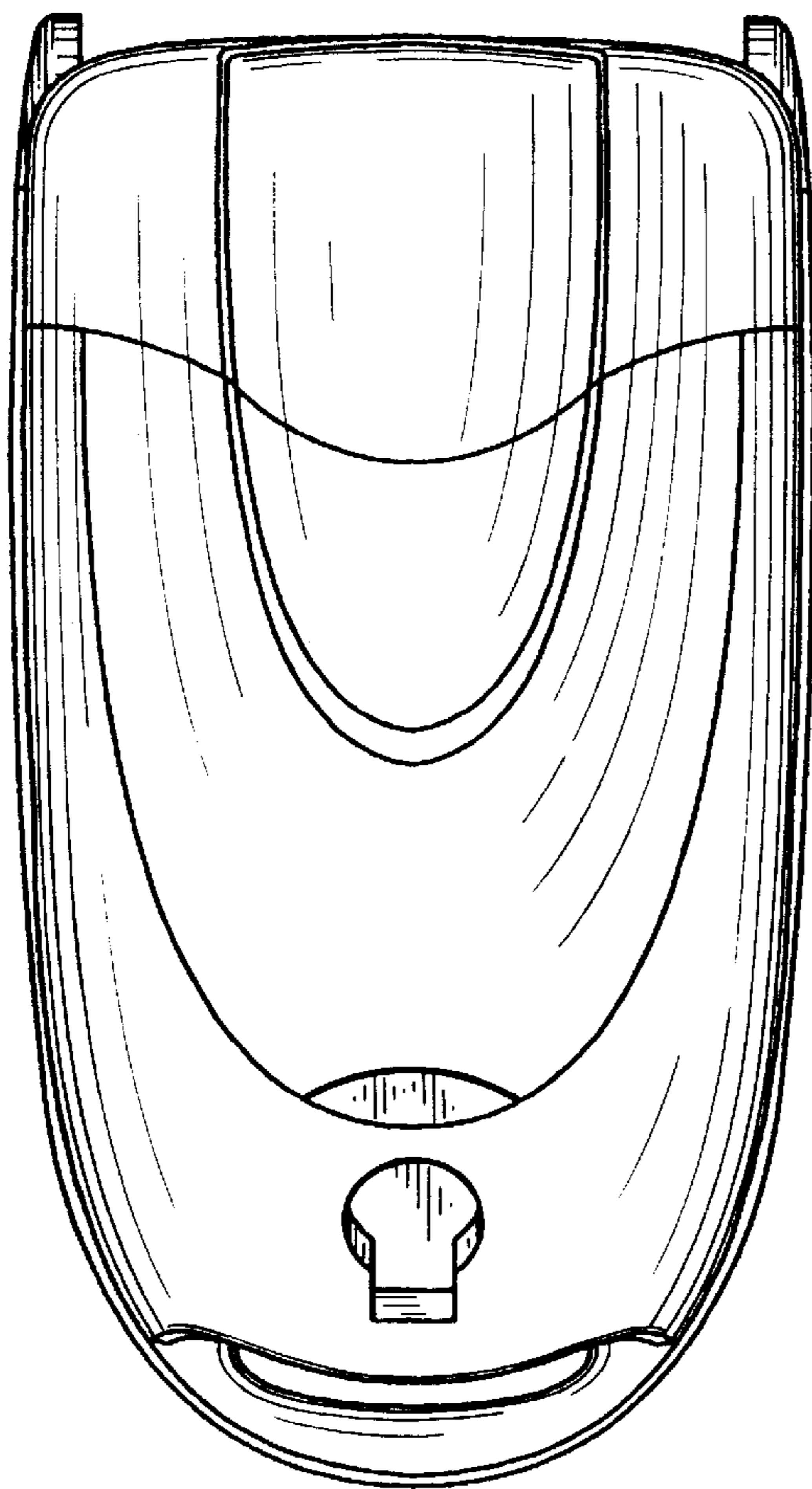

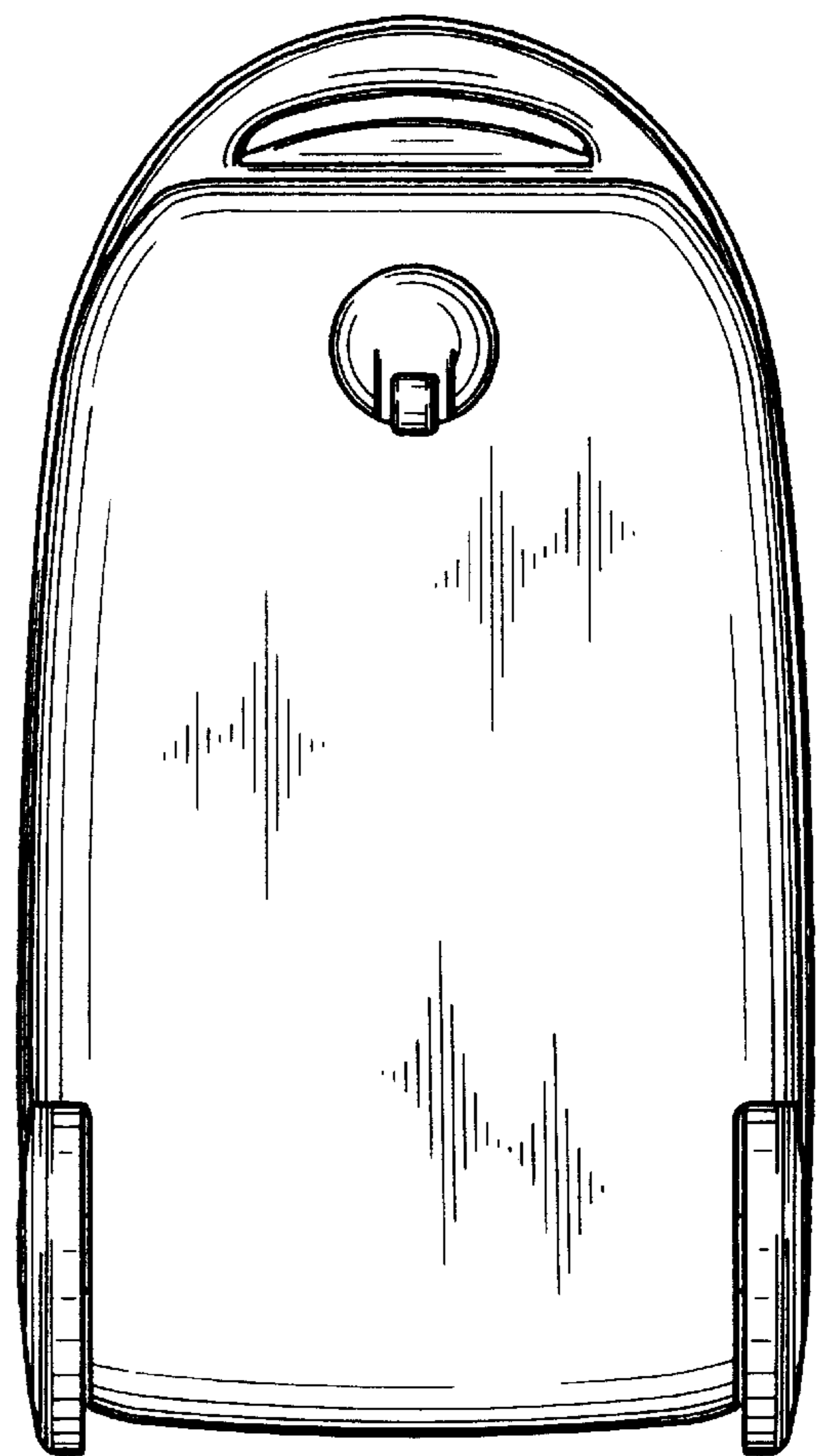

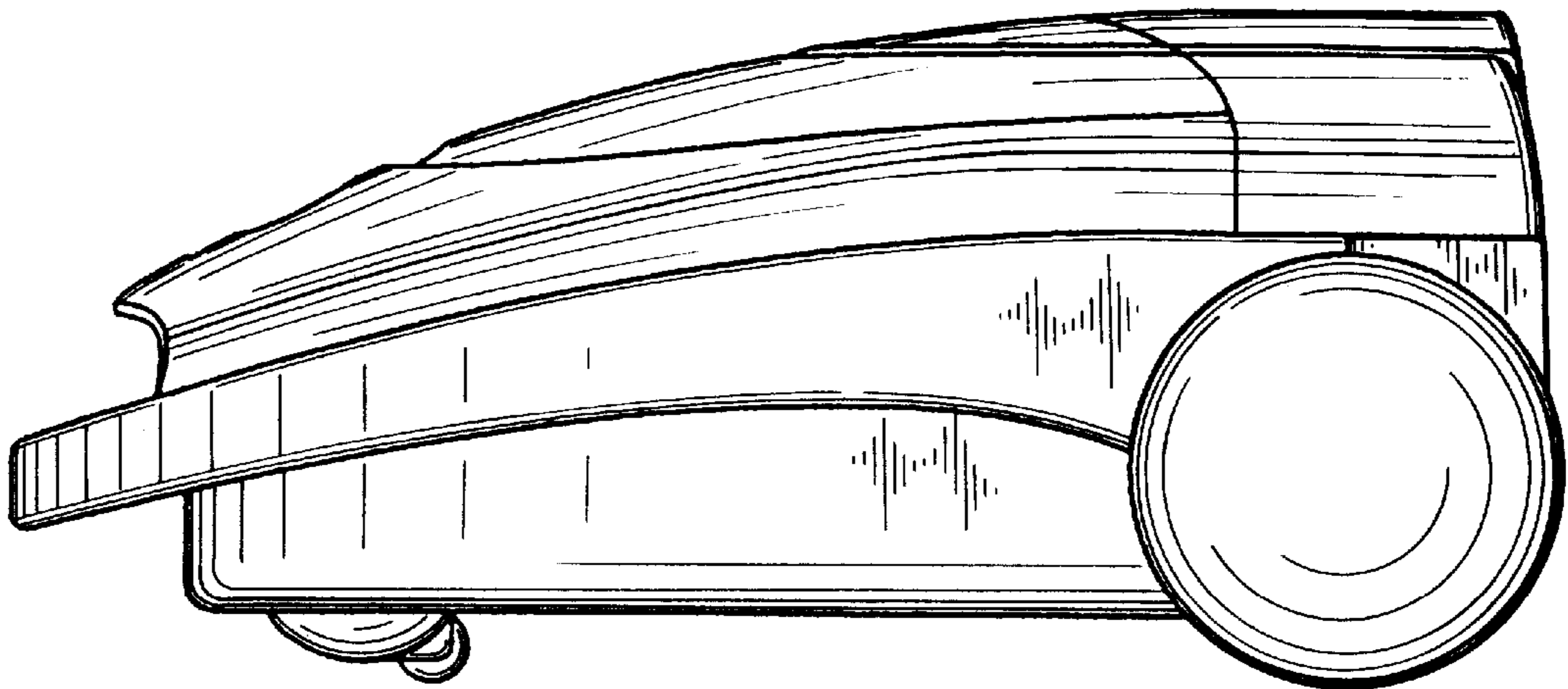
