The ornamental design for a bag for floor care apparatus, as shown and described.

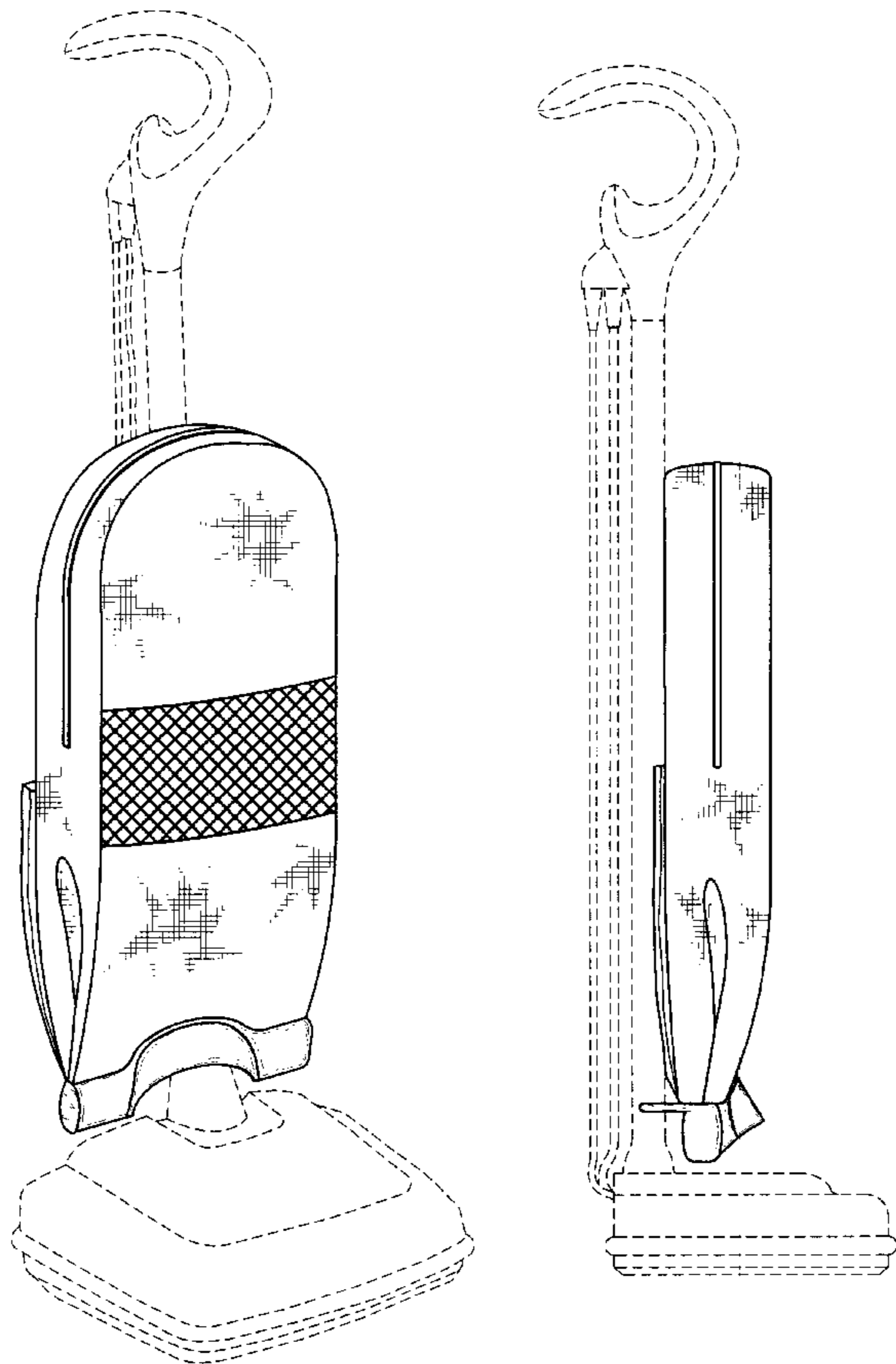
**DESCRIPTION**

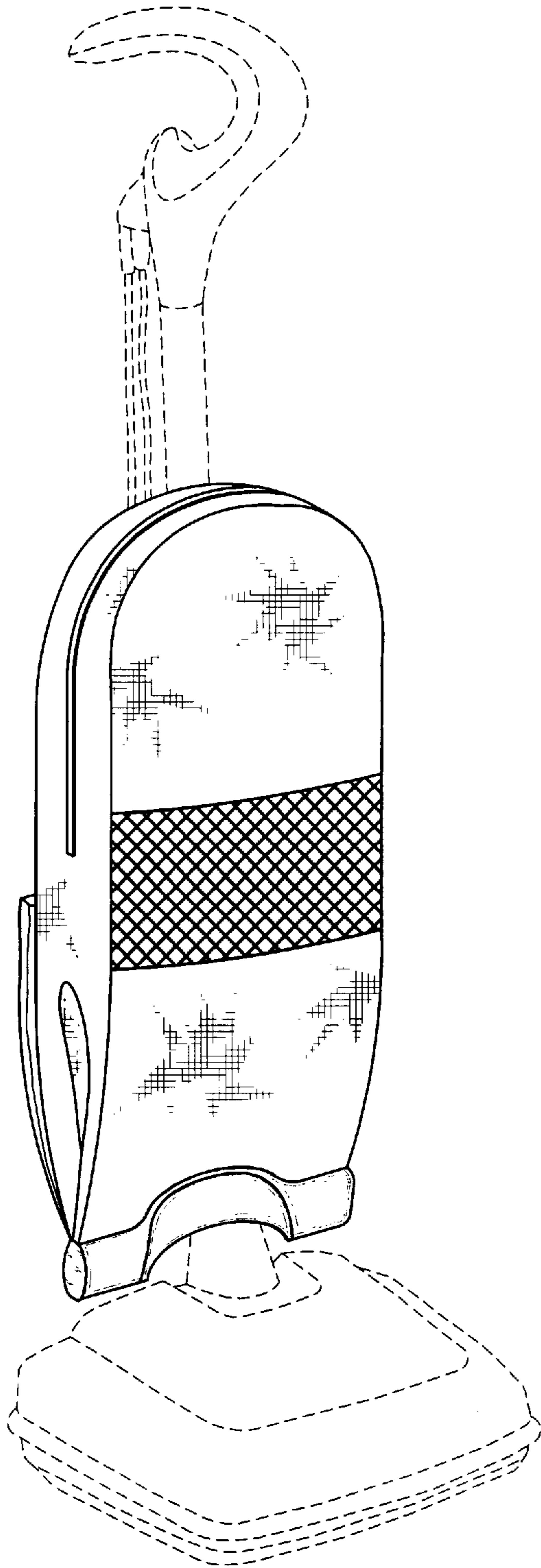

The crosshatch surface shading is understood to repeat throughout the indicated area.

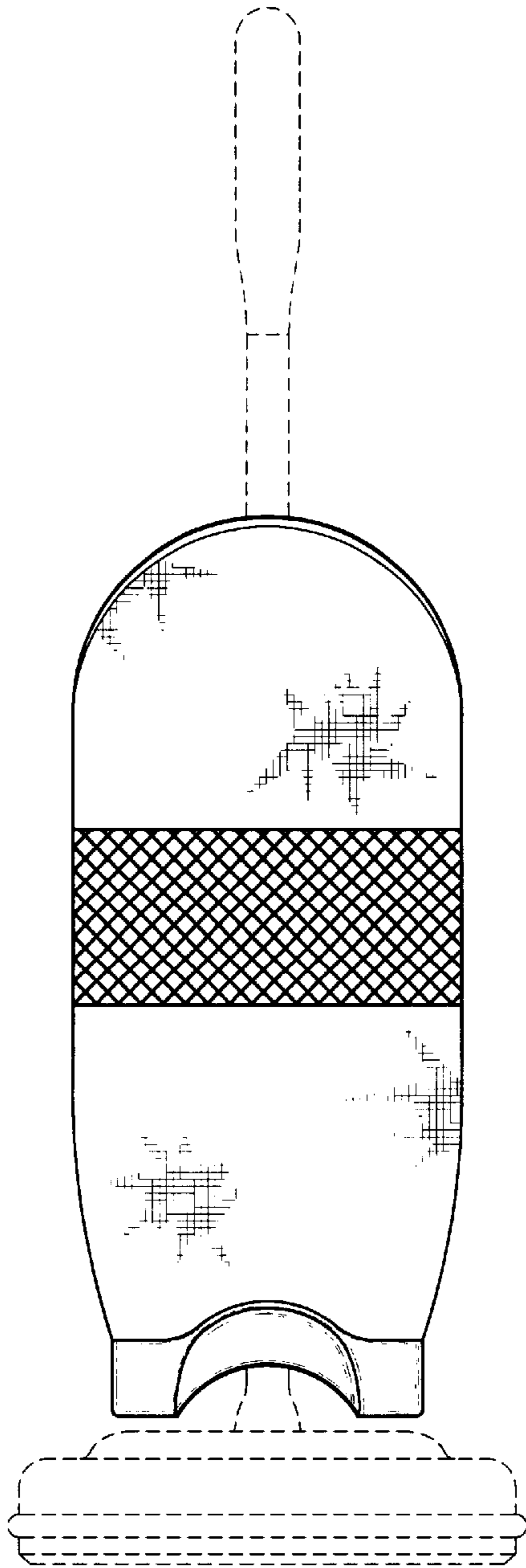
Portions of the accompanying drawings that appear in phantom lines are provided to illustrate the environment of the invention and do not form part of the invention as claimed.

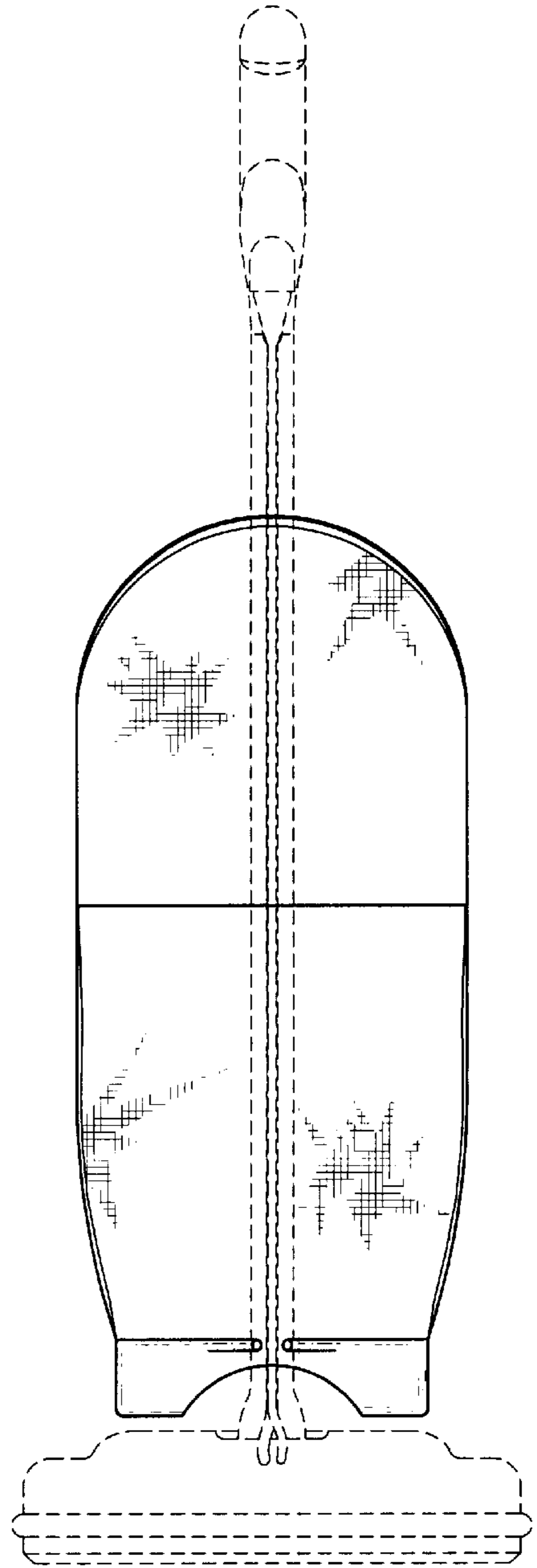




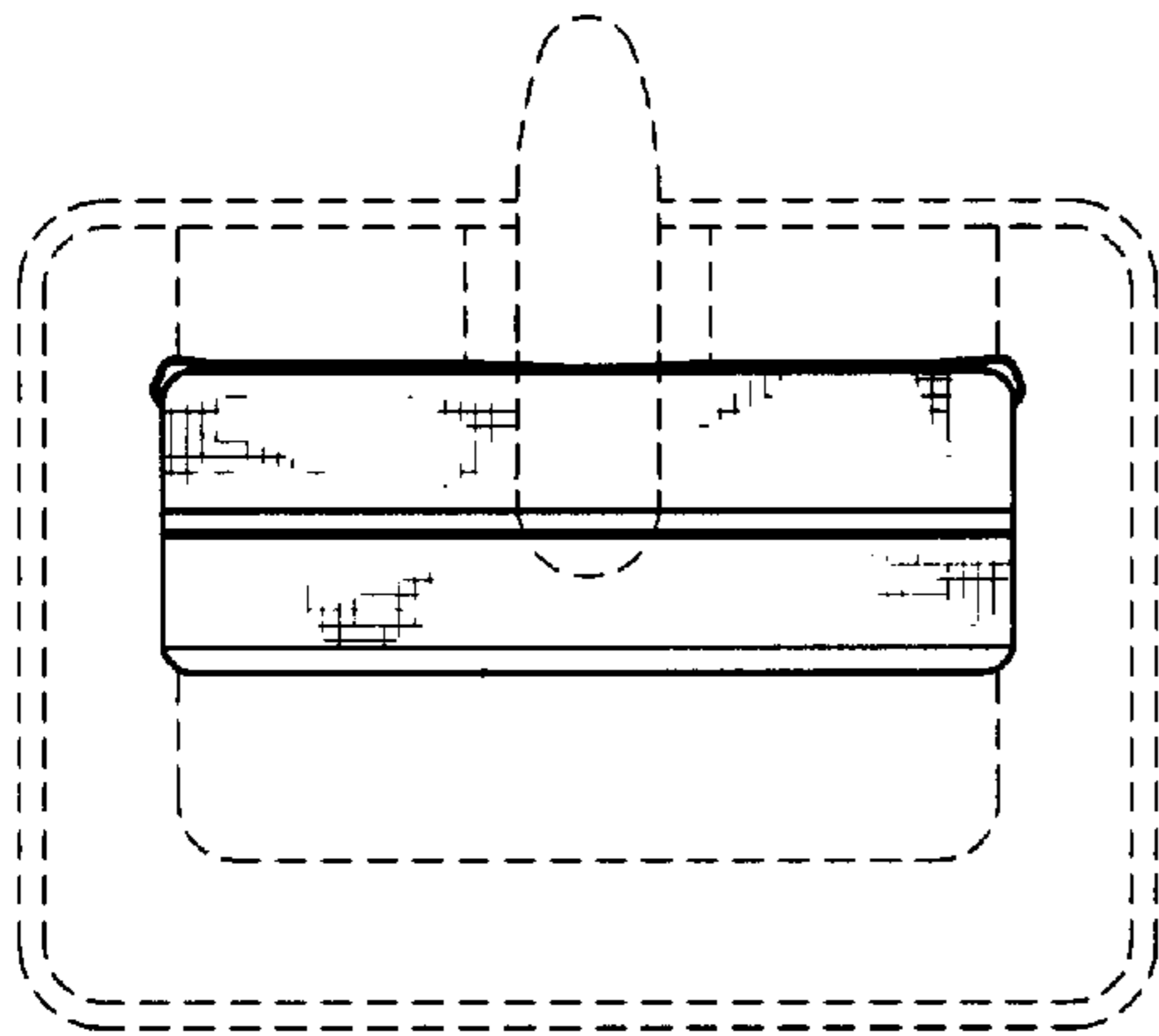

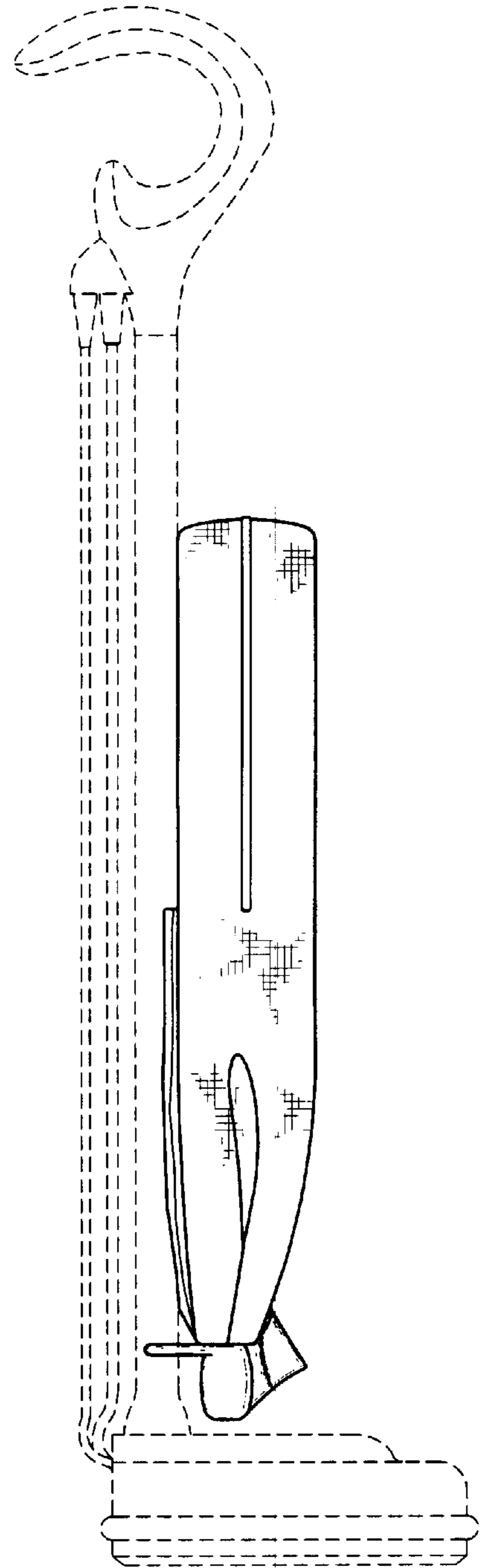
