FIG. 6 is a right-side elevational view thereof; and,

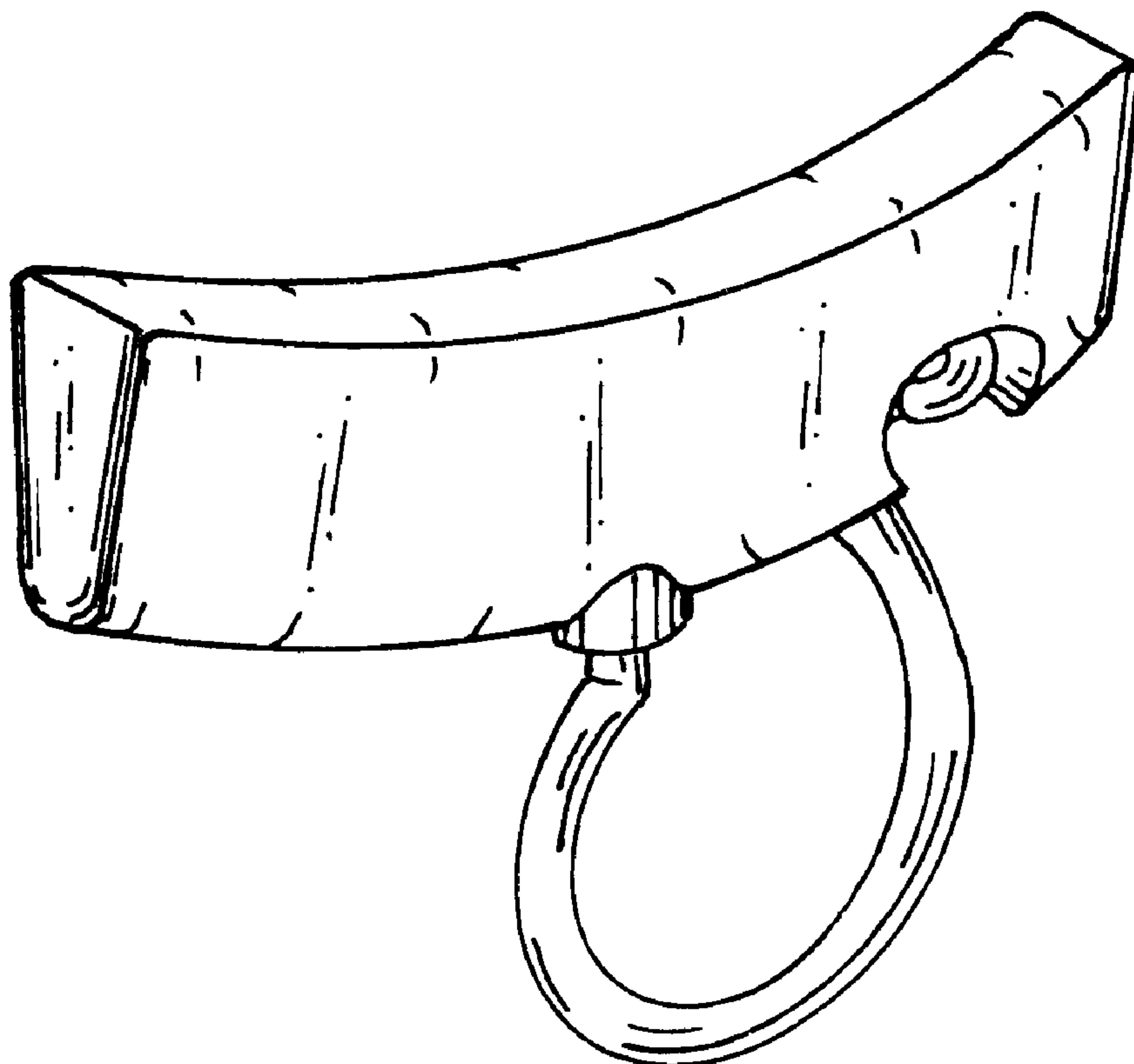
FIG. 7 is a bottom plan view thereof.

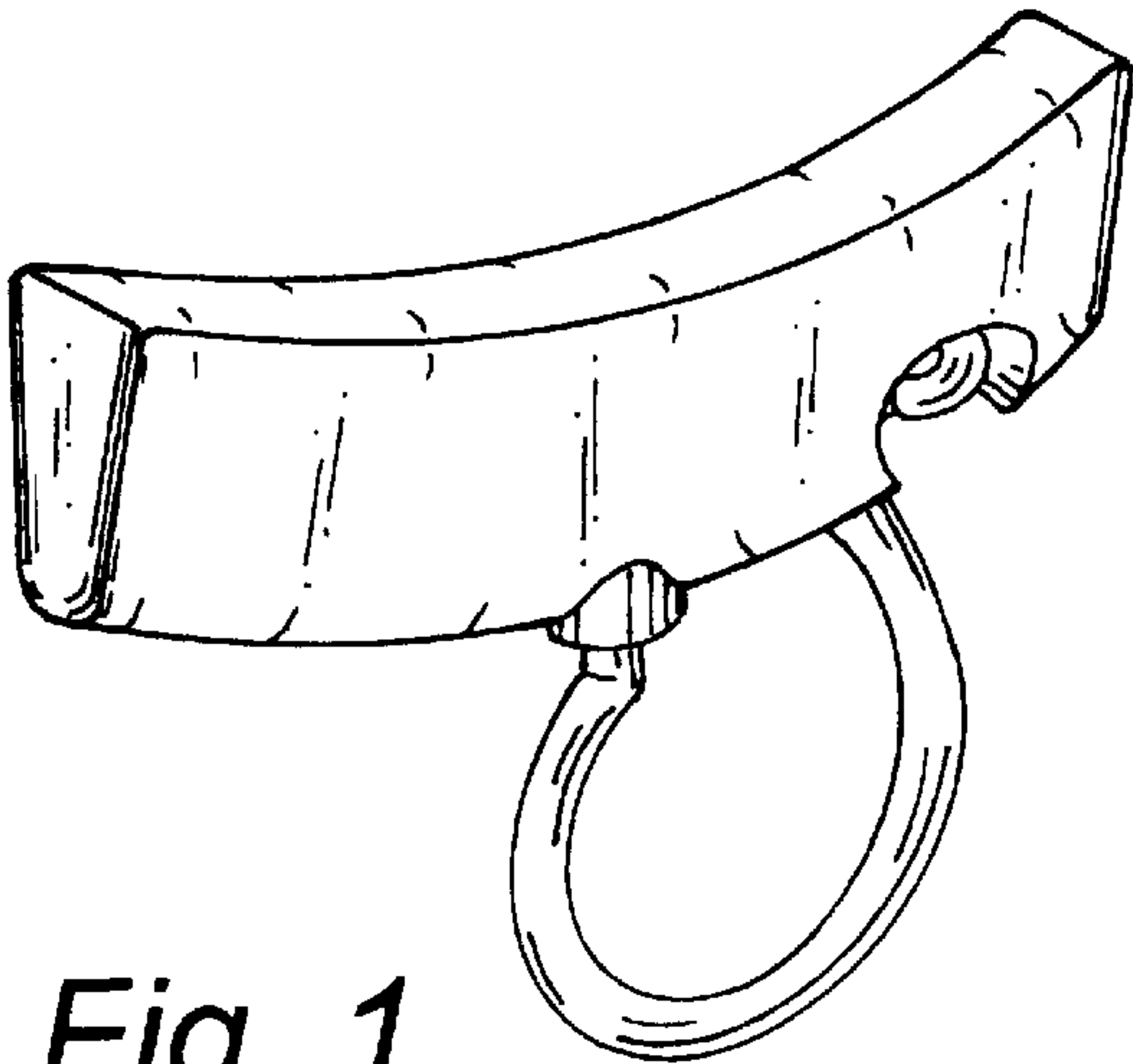

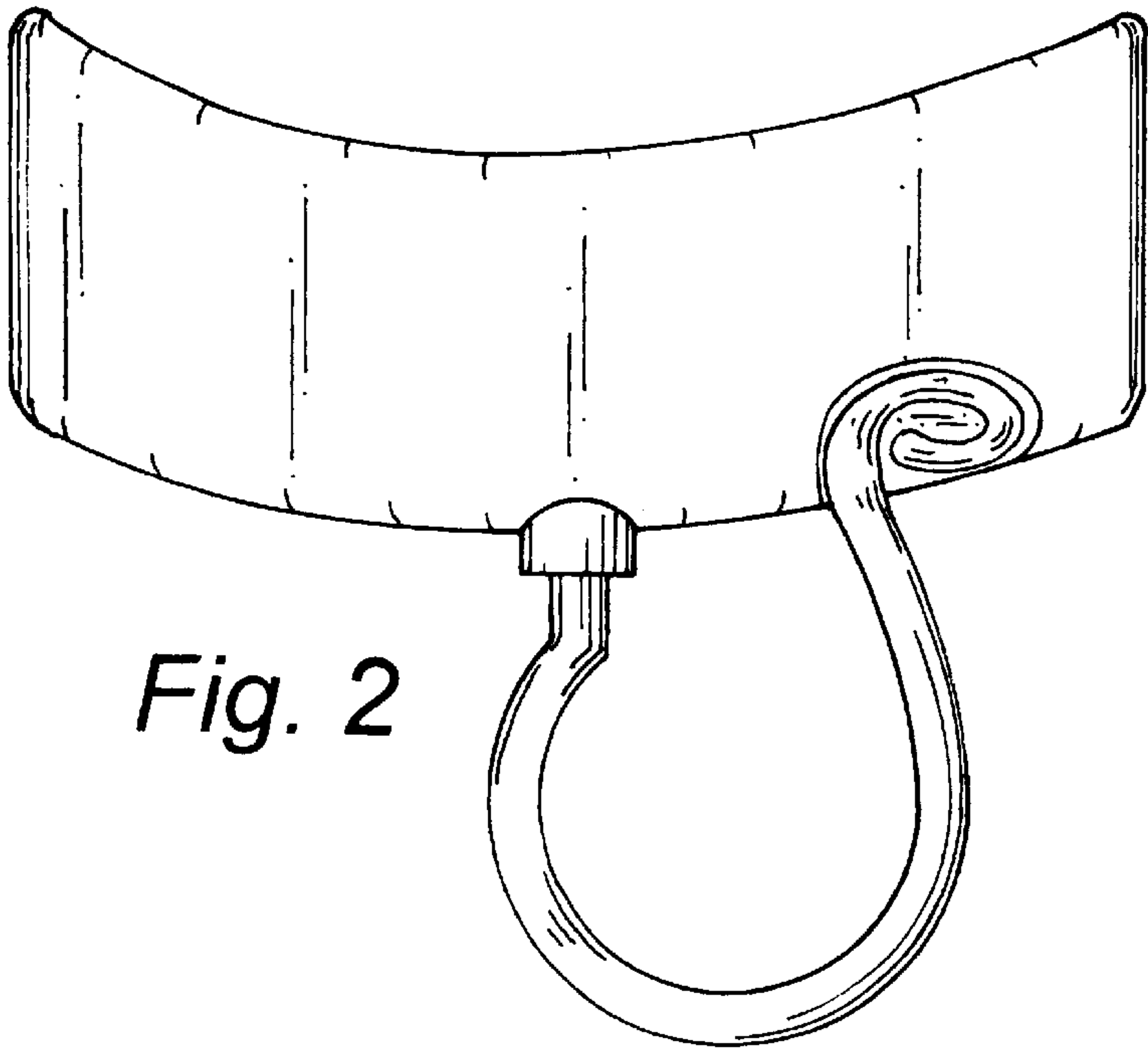

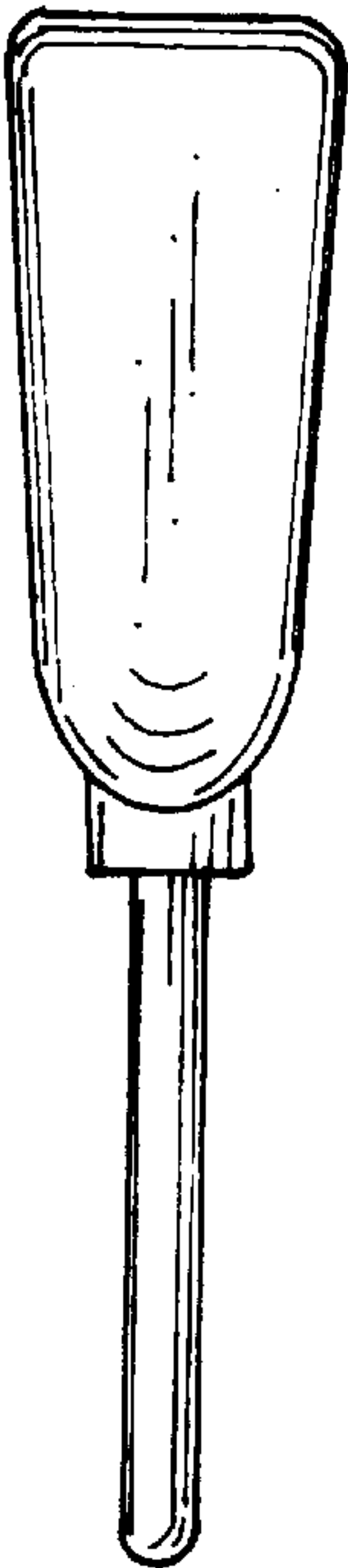

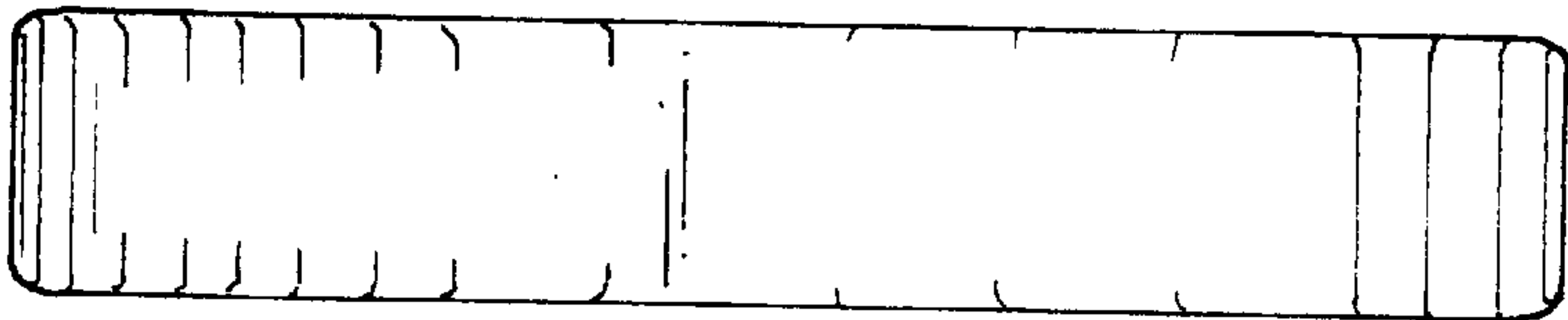
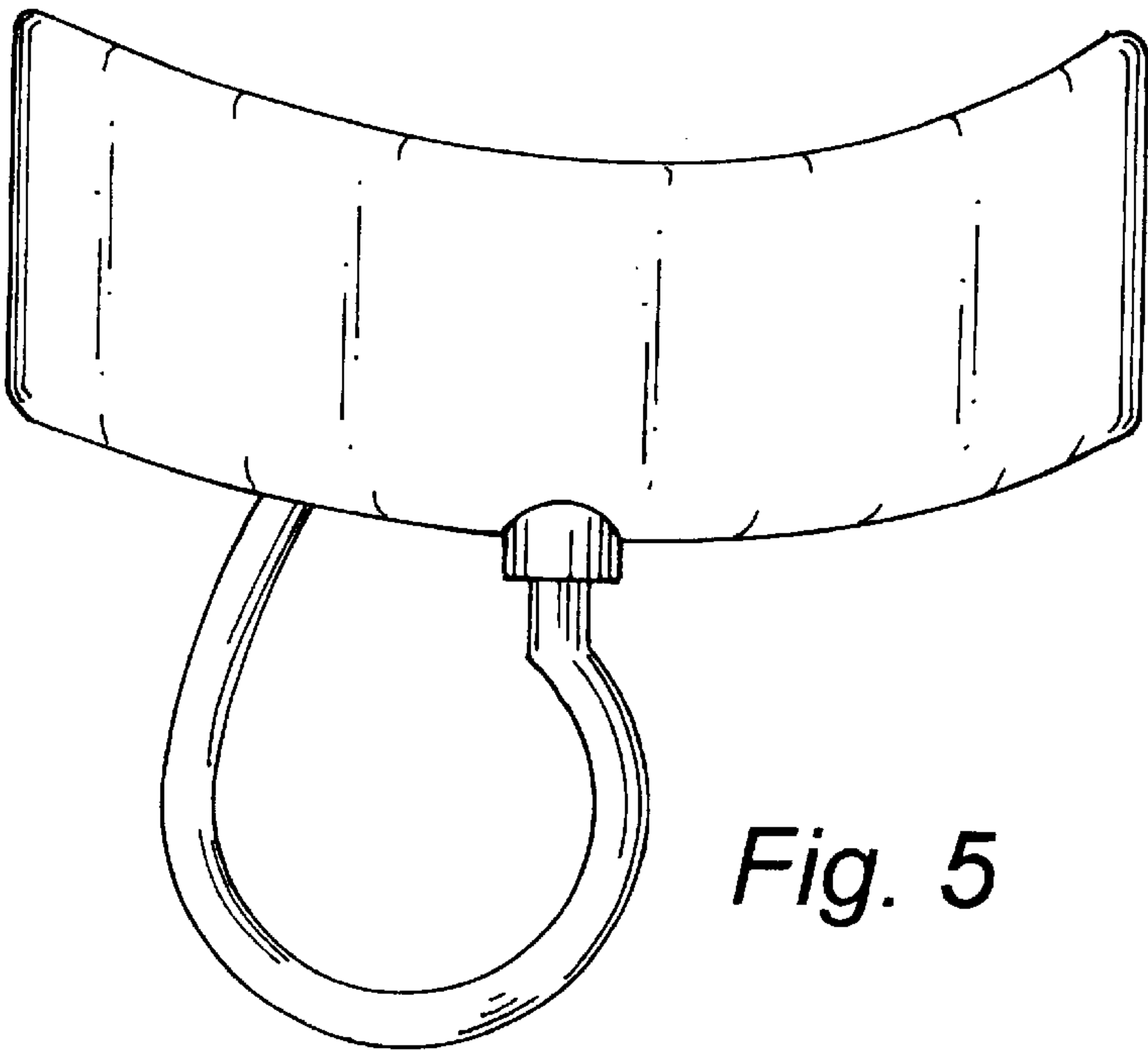
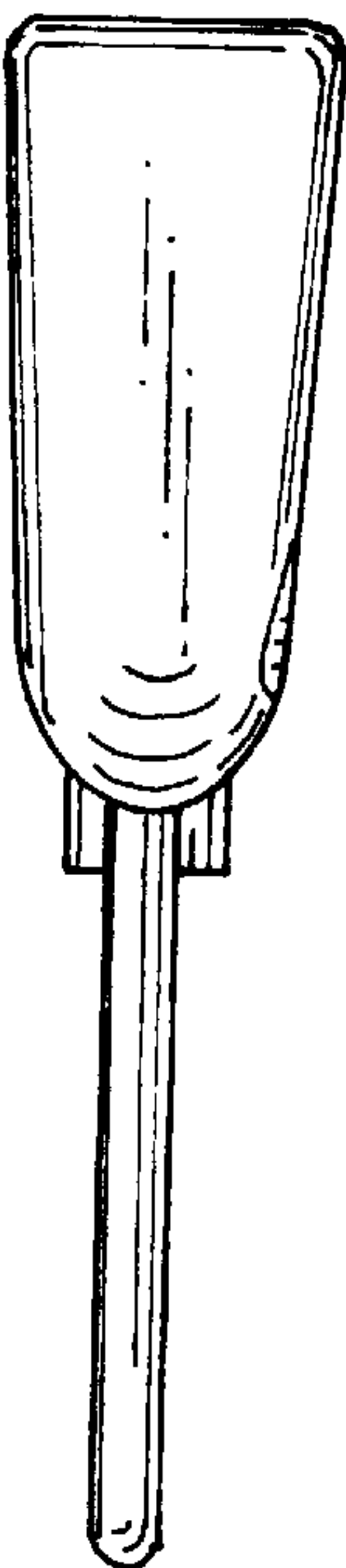


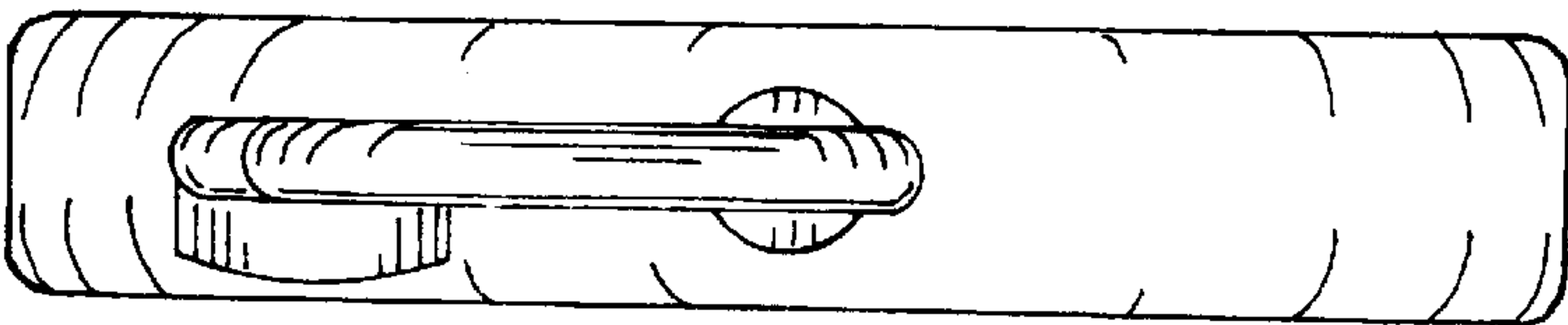
