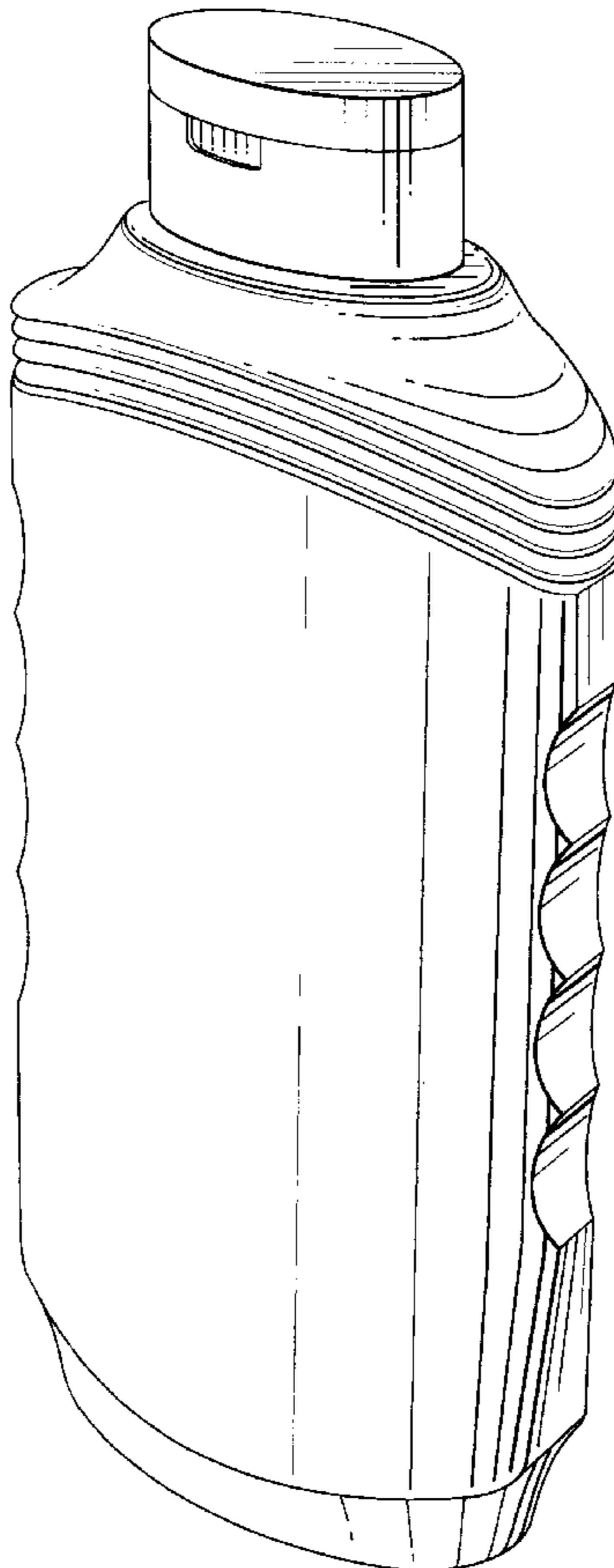
(57) **CLAIM**

The ornamental design for a oval cap container with side finger grips, as shown and described.

DESCRIPTION

- FIG. 1 is a perspective view of the container having side finger grips;
- FIG. 2 is a rear elevational view thereof;
- FIG. 3 is a side elevational view thereof as seen from the right hand side of FIG. 2;
- FIG. 4 is a side elevational view thereof as seen from the left hand side of FIG. 2;
- FIG. 5 is a front elevational view thereof;
- FIG. 6 is a top plan view thereof; and,
- FIG. 7 is a bottom plan view thereof.

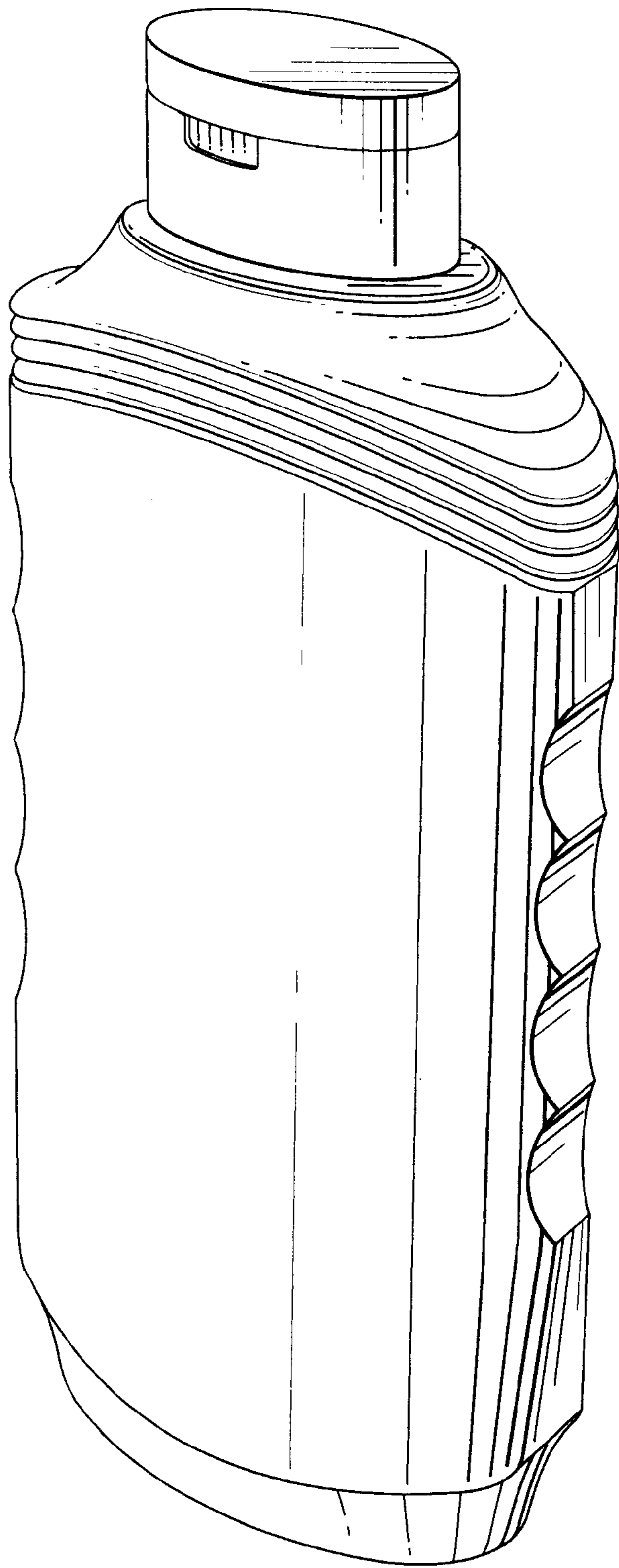

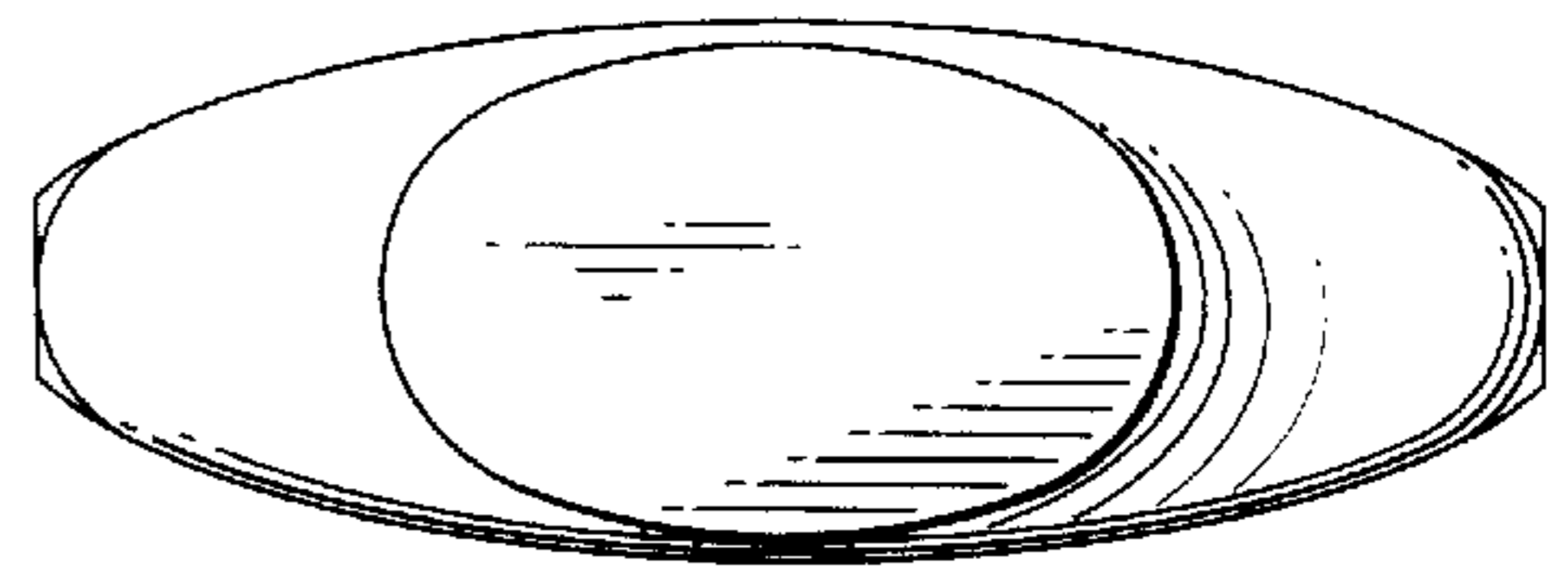

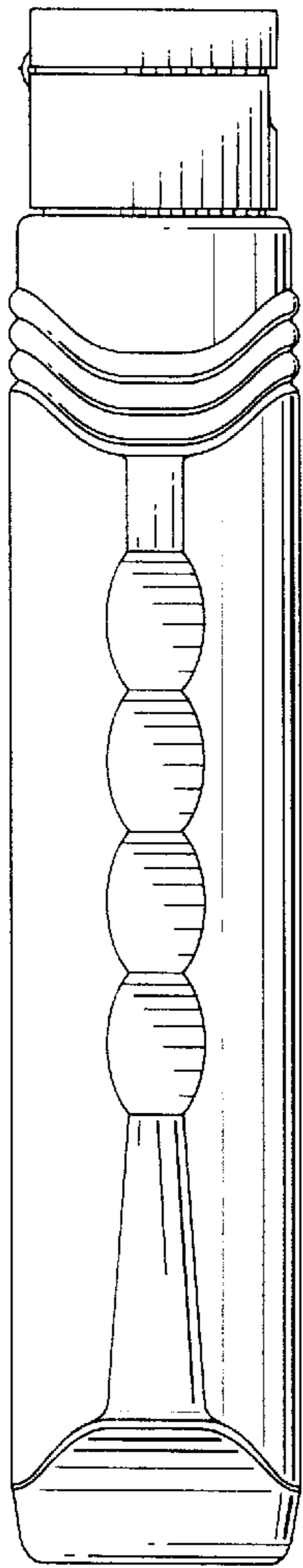

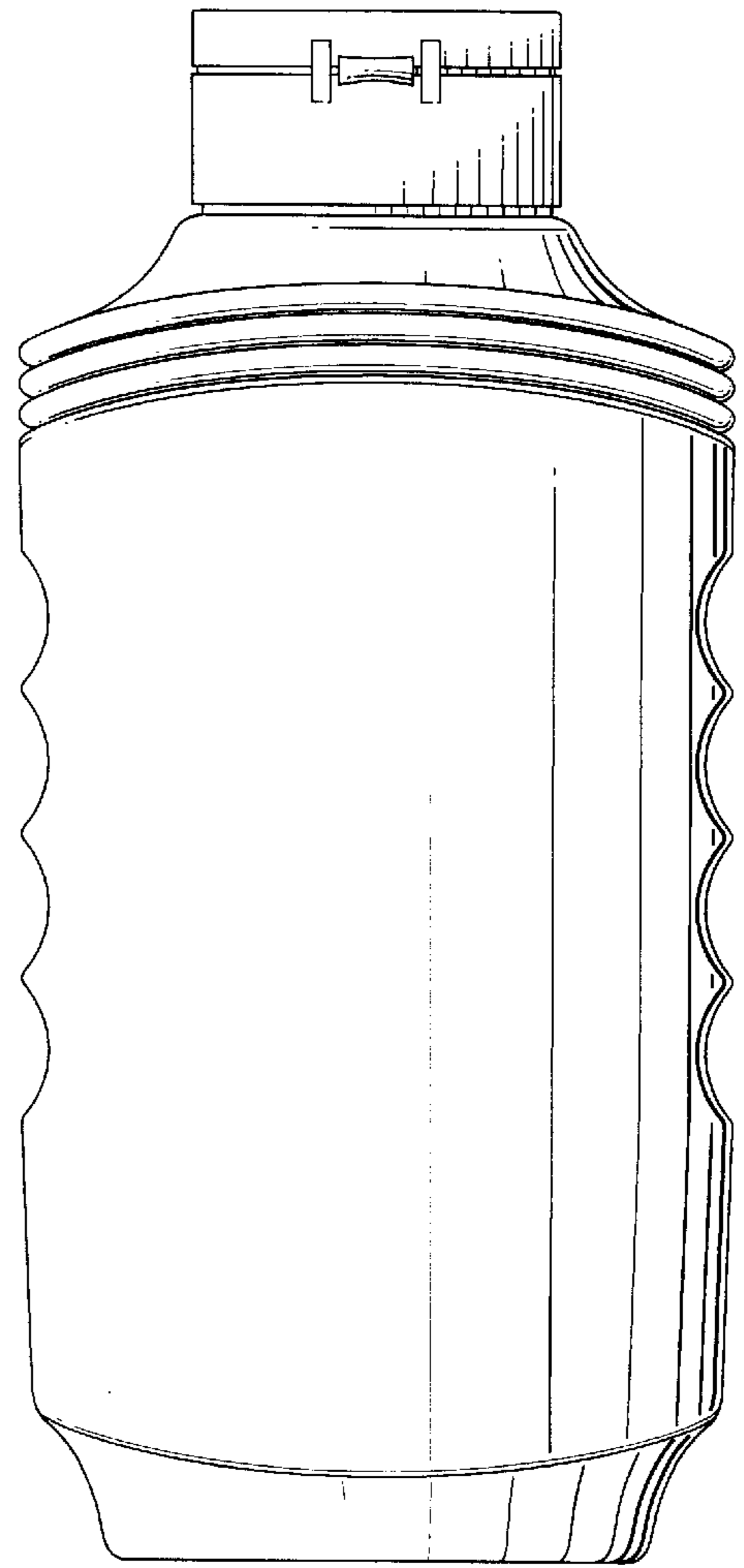

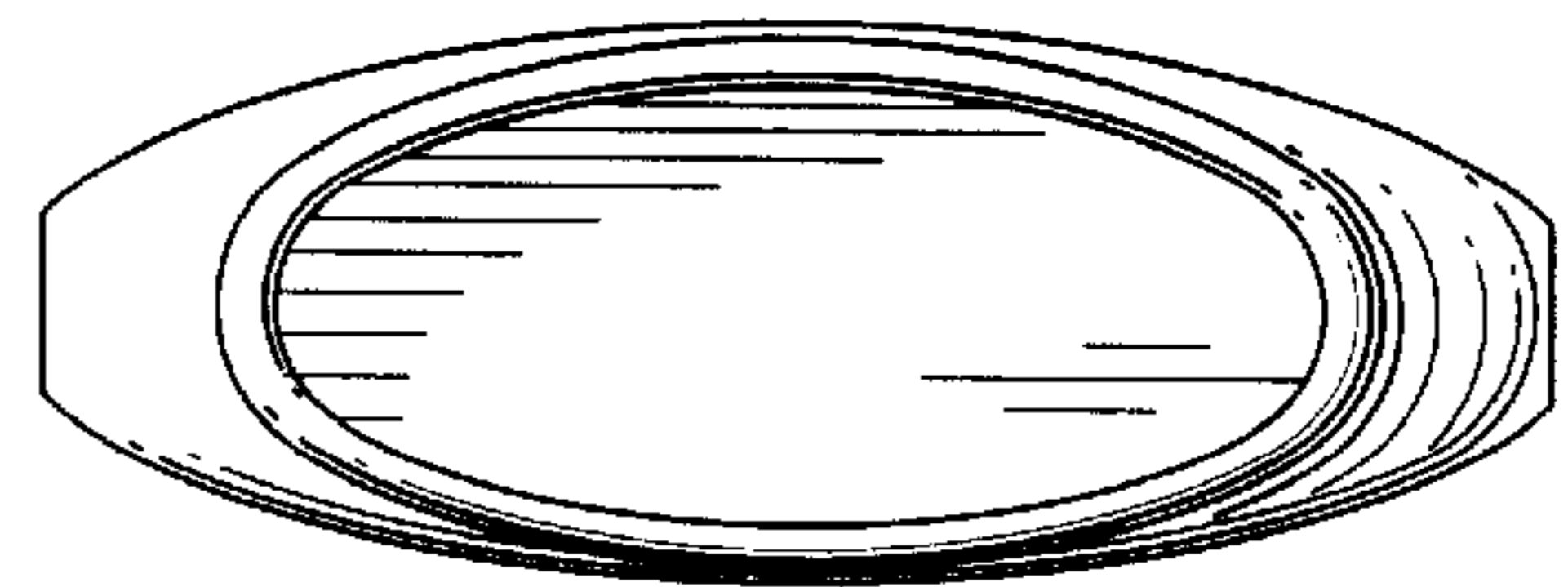

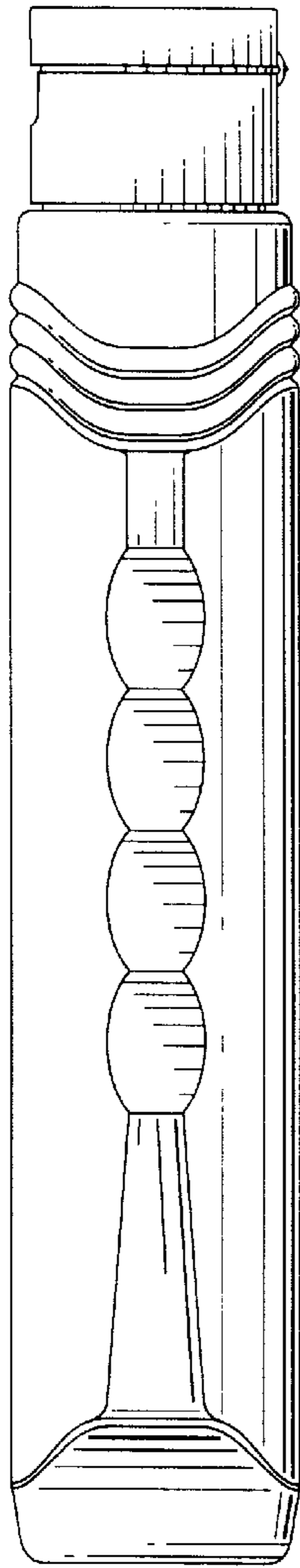

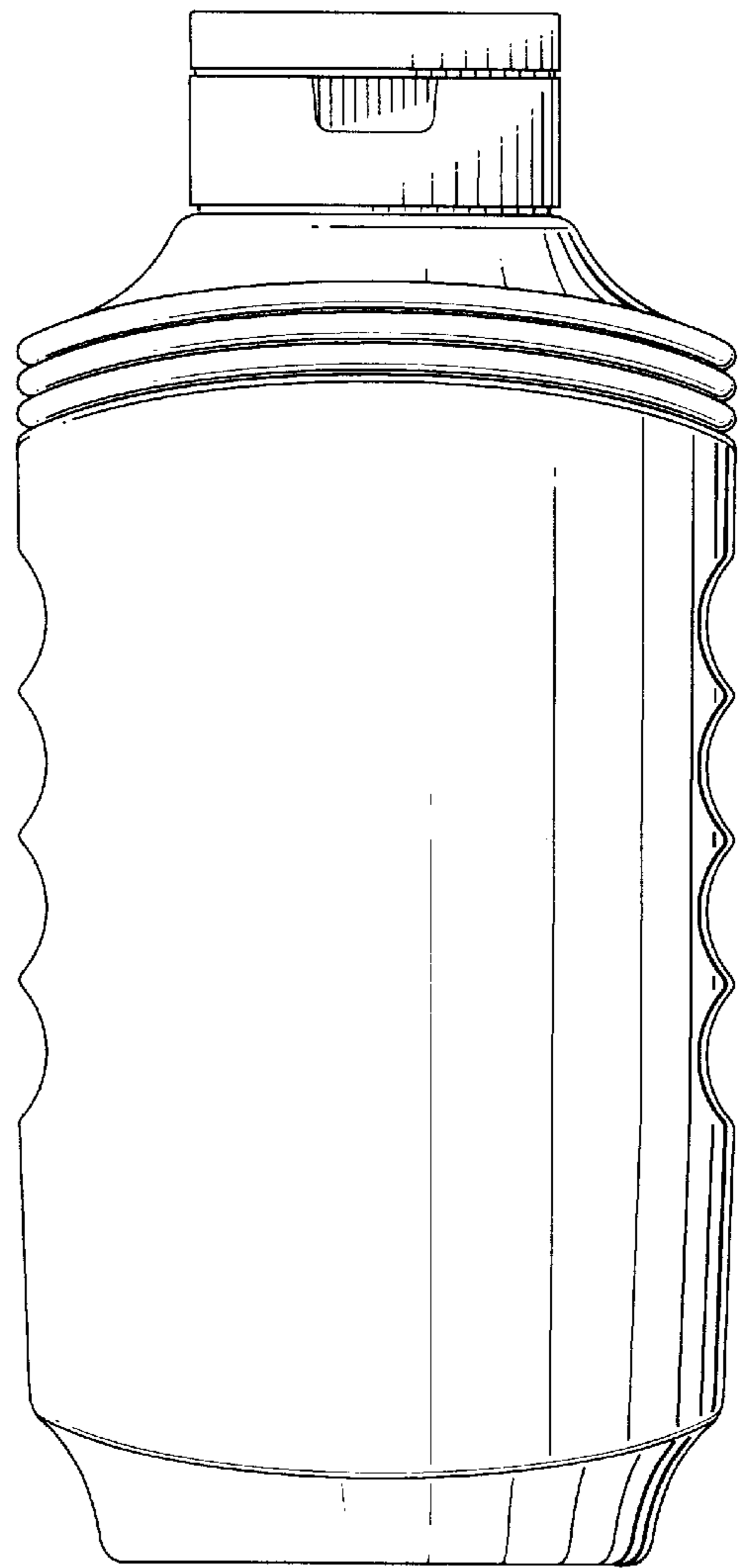
