The ornamental design for a cellular cordless telephone, as shown.

DESCRIPTION

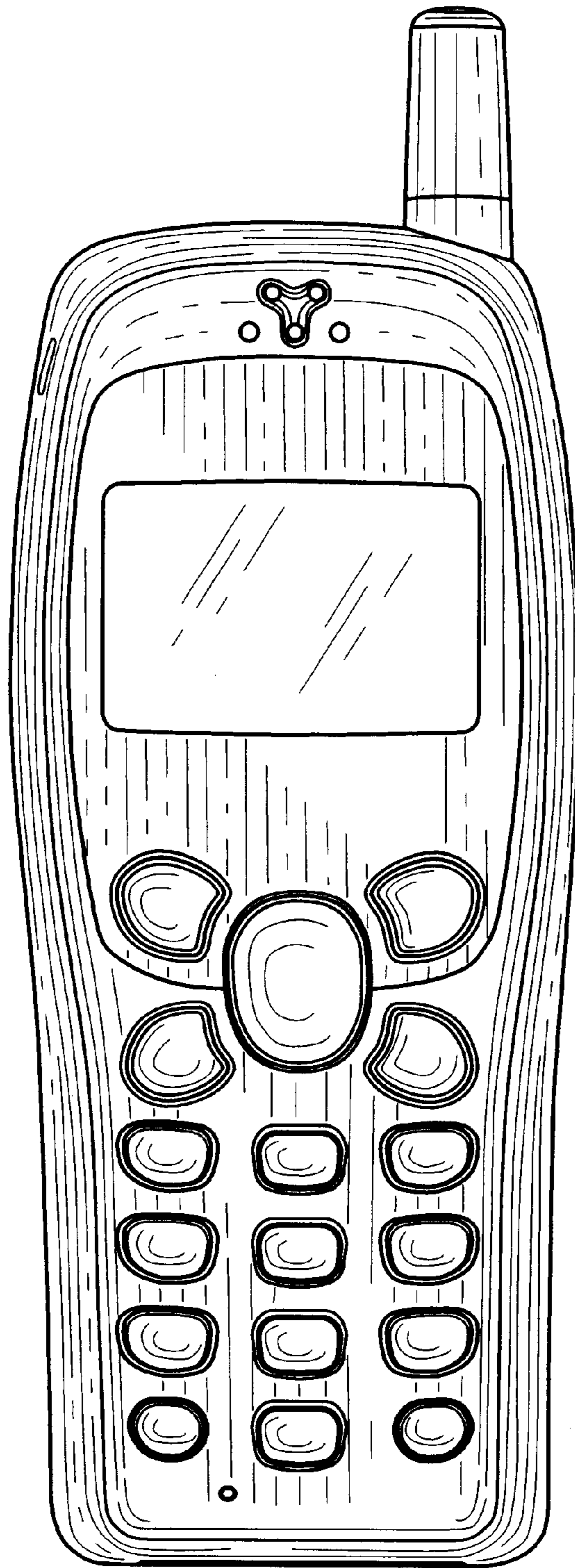

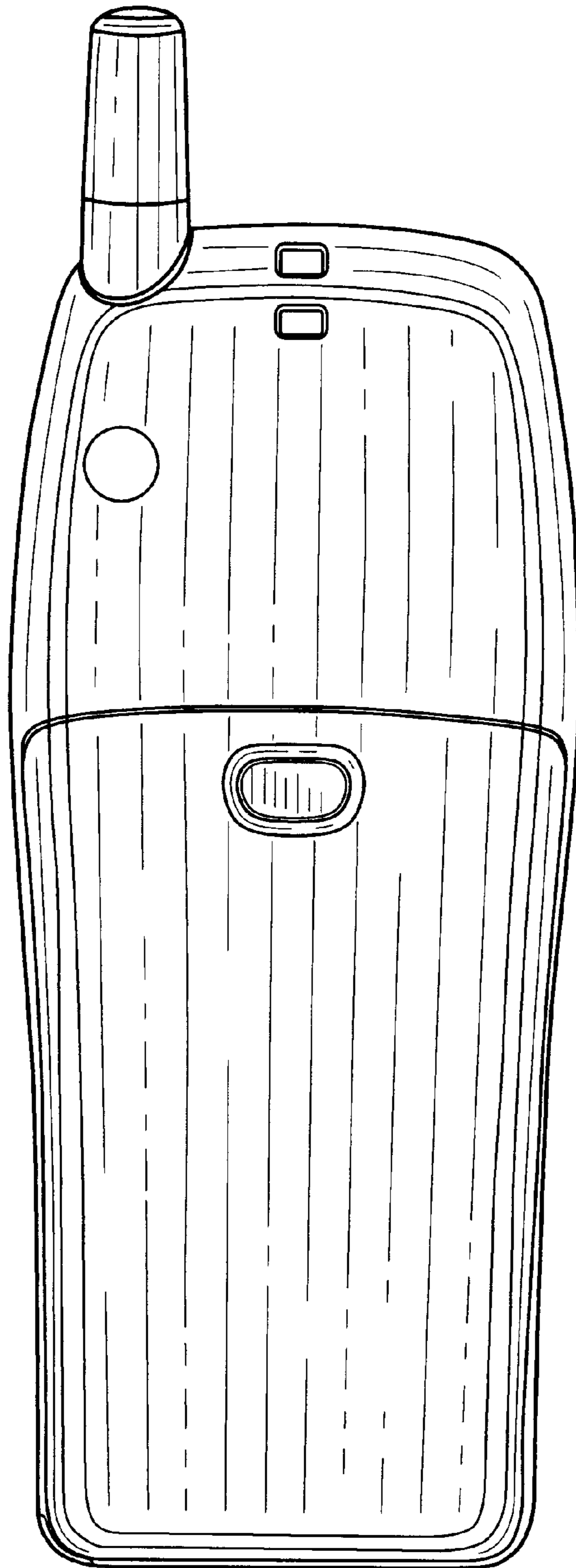

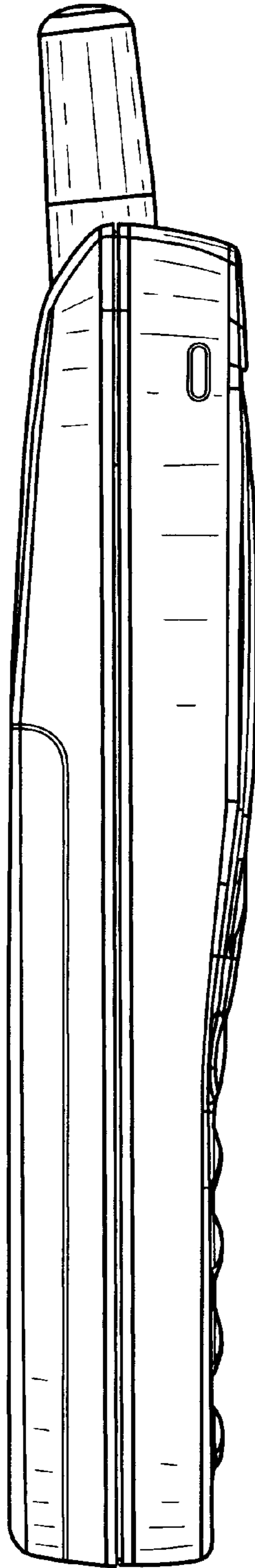

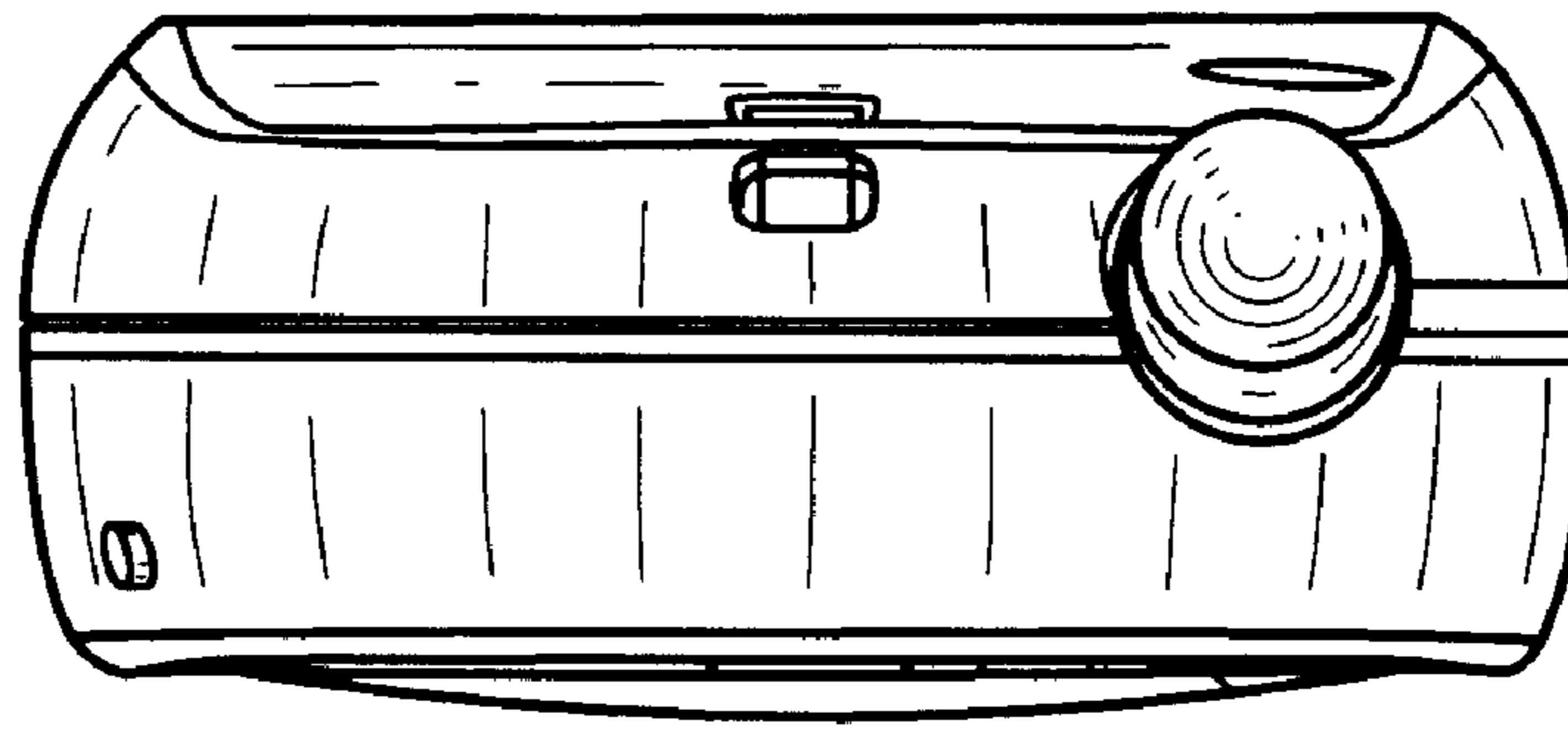

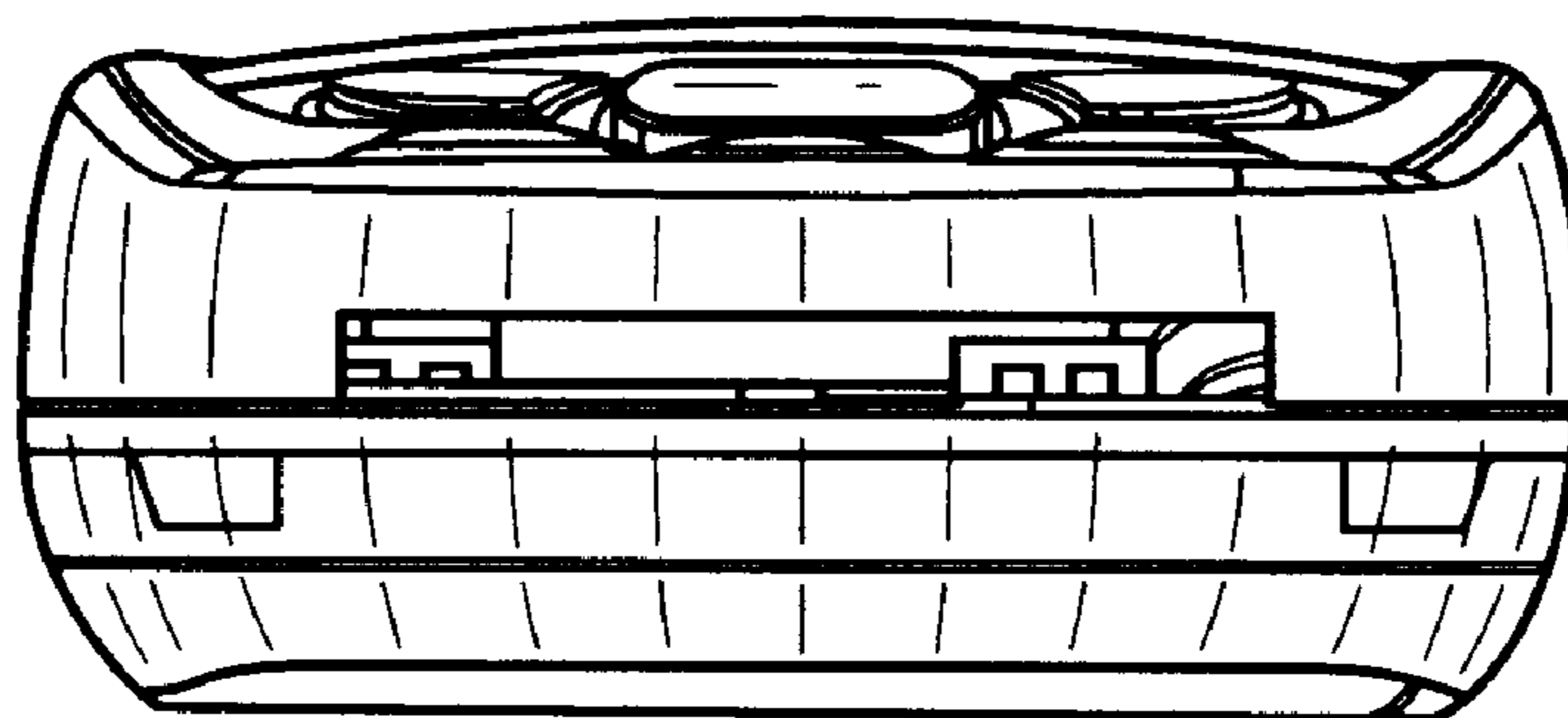
