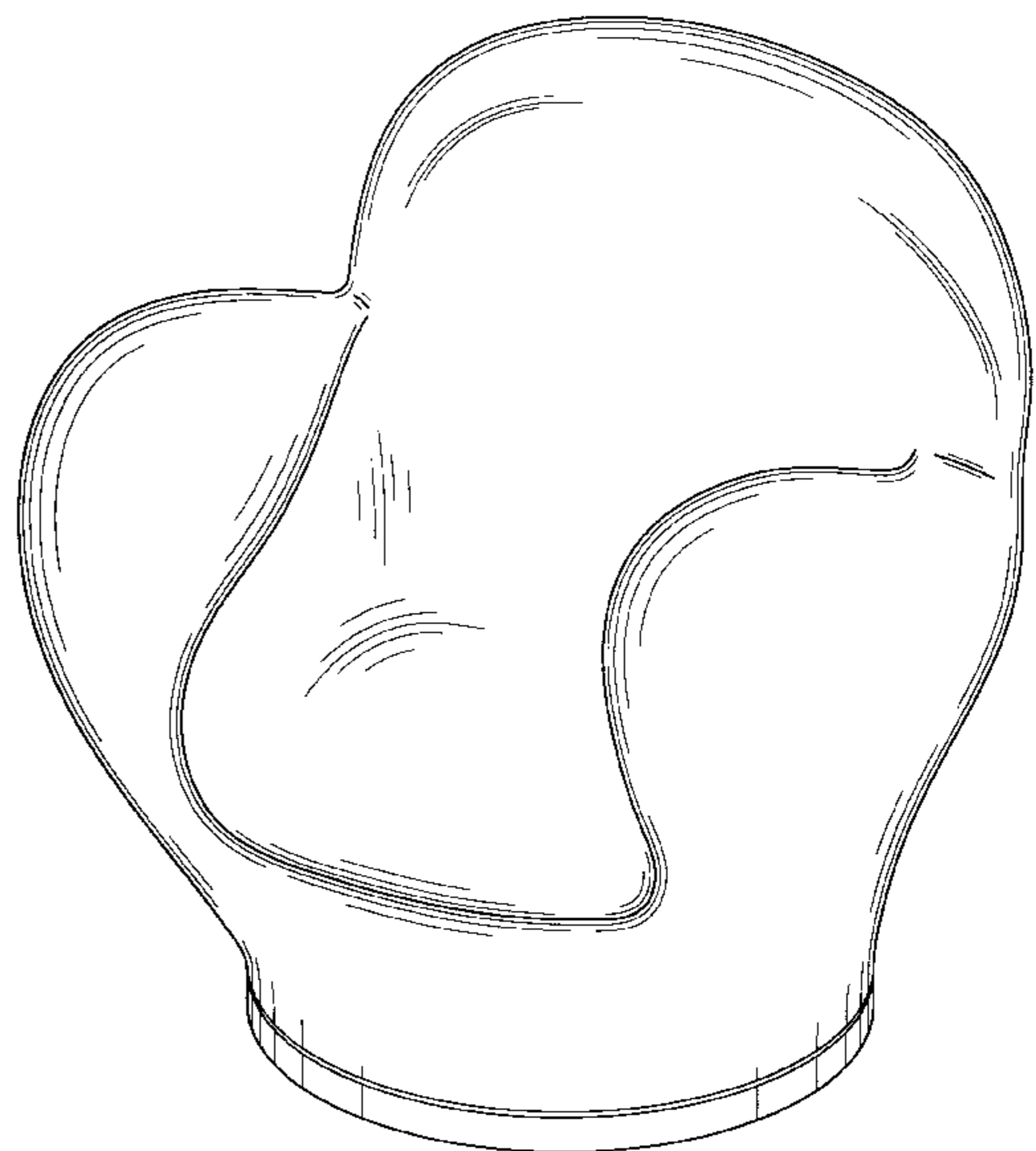
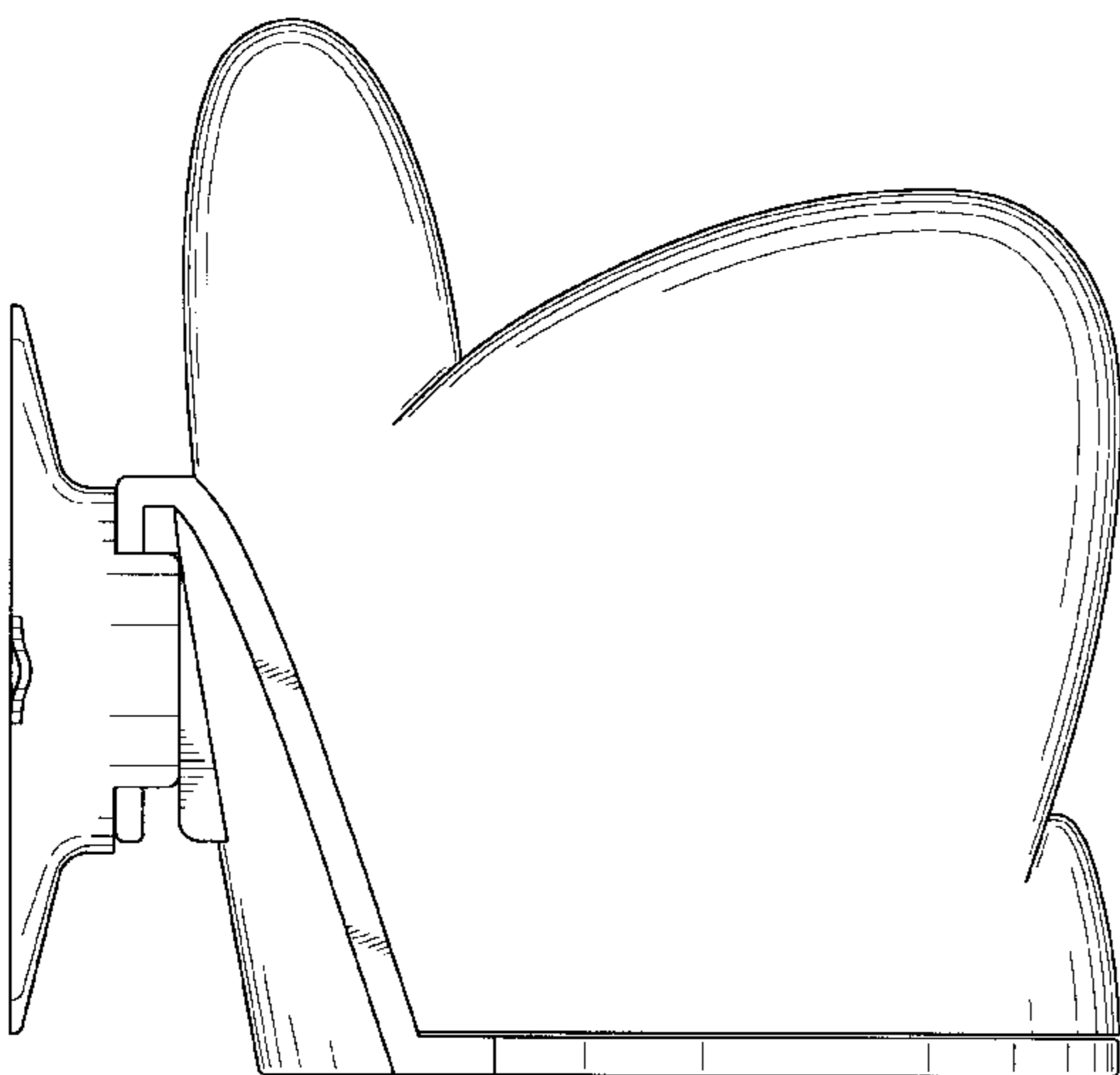
(57) **CLAIM**

The ornamental design for a chair shaped mobile phone holder with suction cup, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a chair shaped mobile phone holder with suction cup illustrating my new design; FIG. 2 is a rear elevational view of a chair shaped mobile phone holder with suction cup illustrating my new design; FIG. 3 is a right side elevational view of a chair shaped mobile phone holder with suction cup illustrating my new design; FIG. 4 is a left side elevational view of a chair shaped mobile phone holder with suction cup illustrating my new design; FIG. 5 is a top plan view of a chair shaped mobile phone holder with suction cup illustrating my new design; FIG. 6 is a bottom plan view of a chair shaped mobile phone holder with suction cup illustrating my new design; and, FIG. 7 is a perspective view from the upper left front of a chair shaped mobile phone holder with suction cup illustrating my new design.

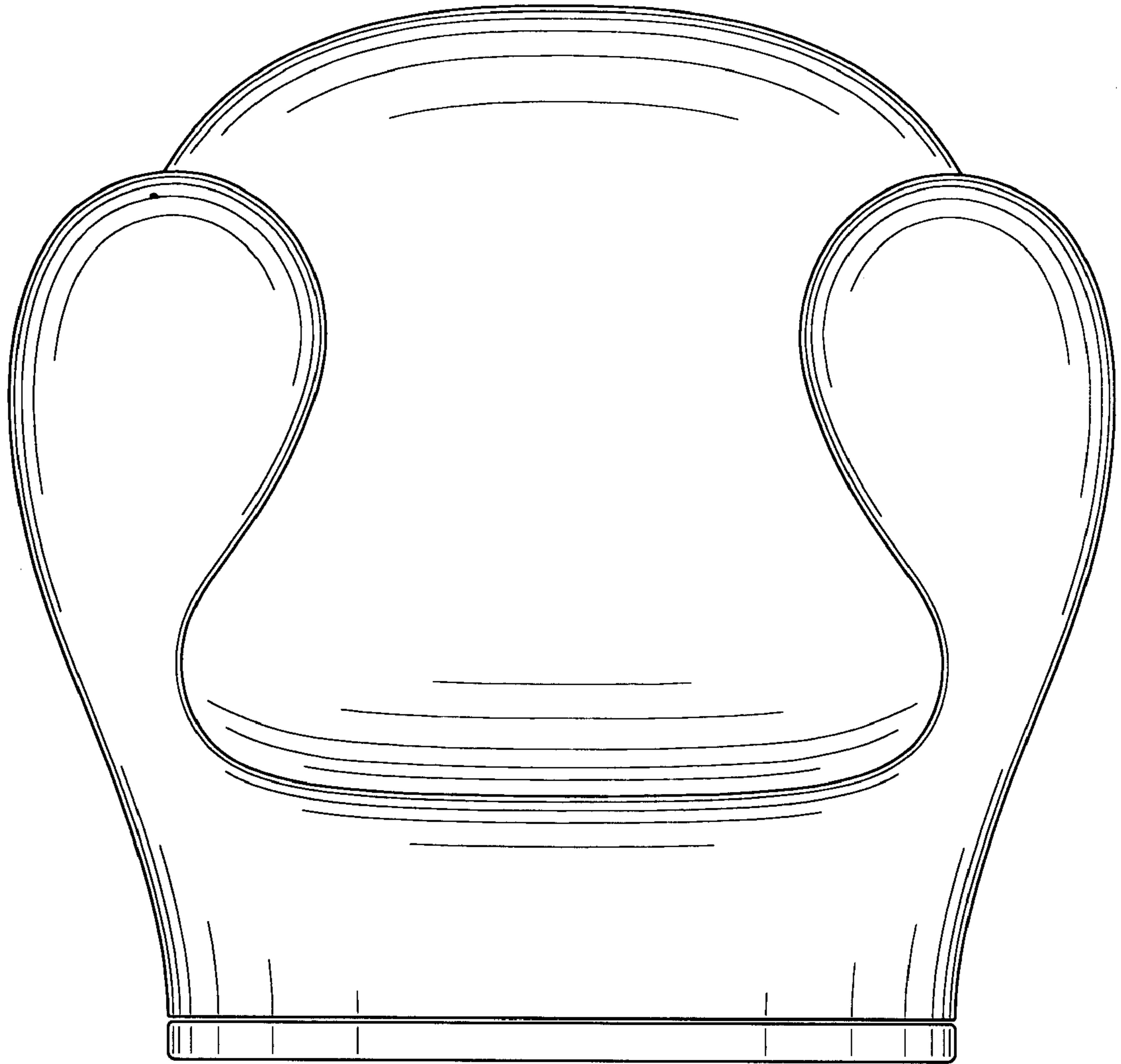

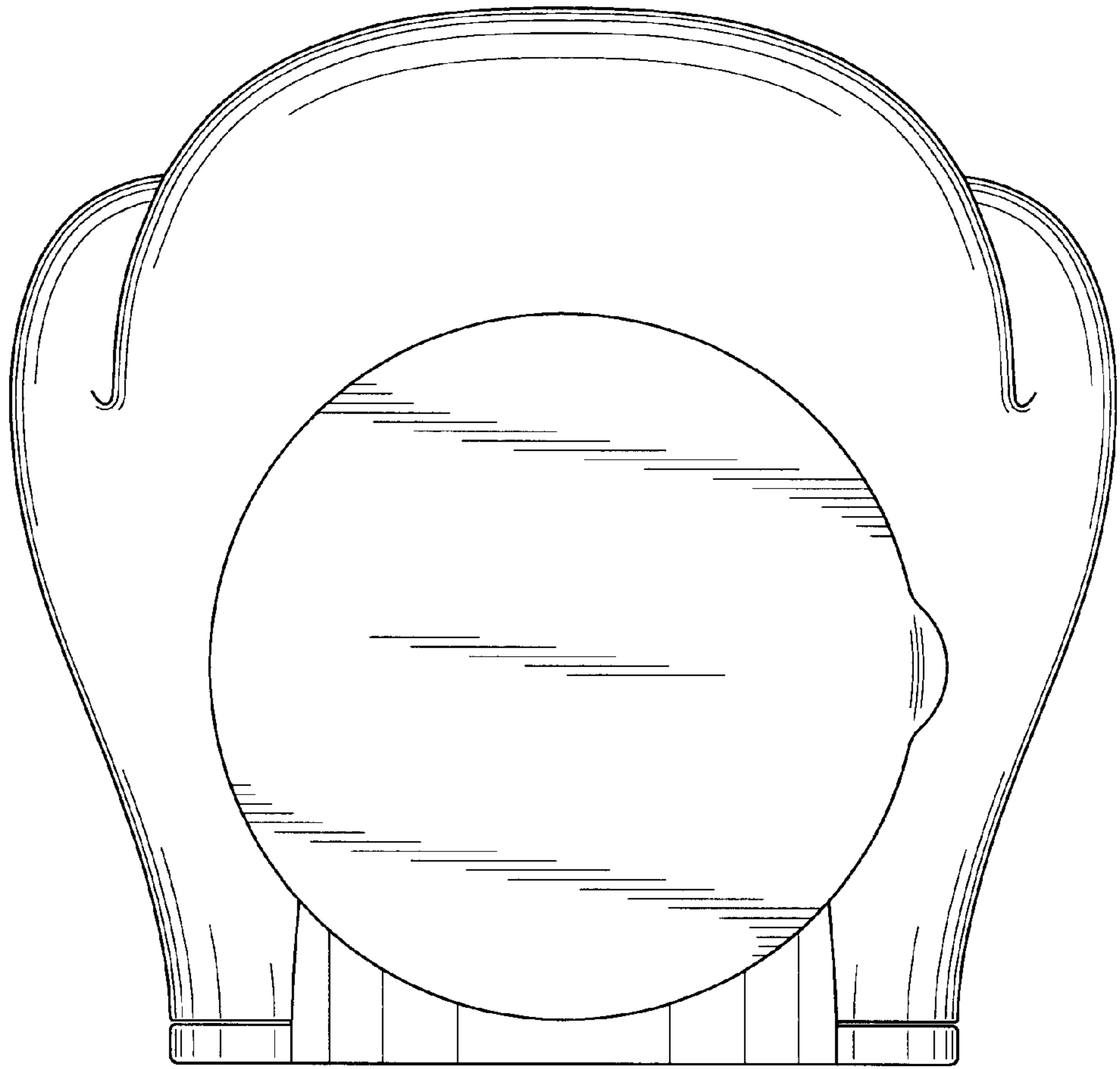

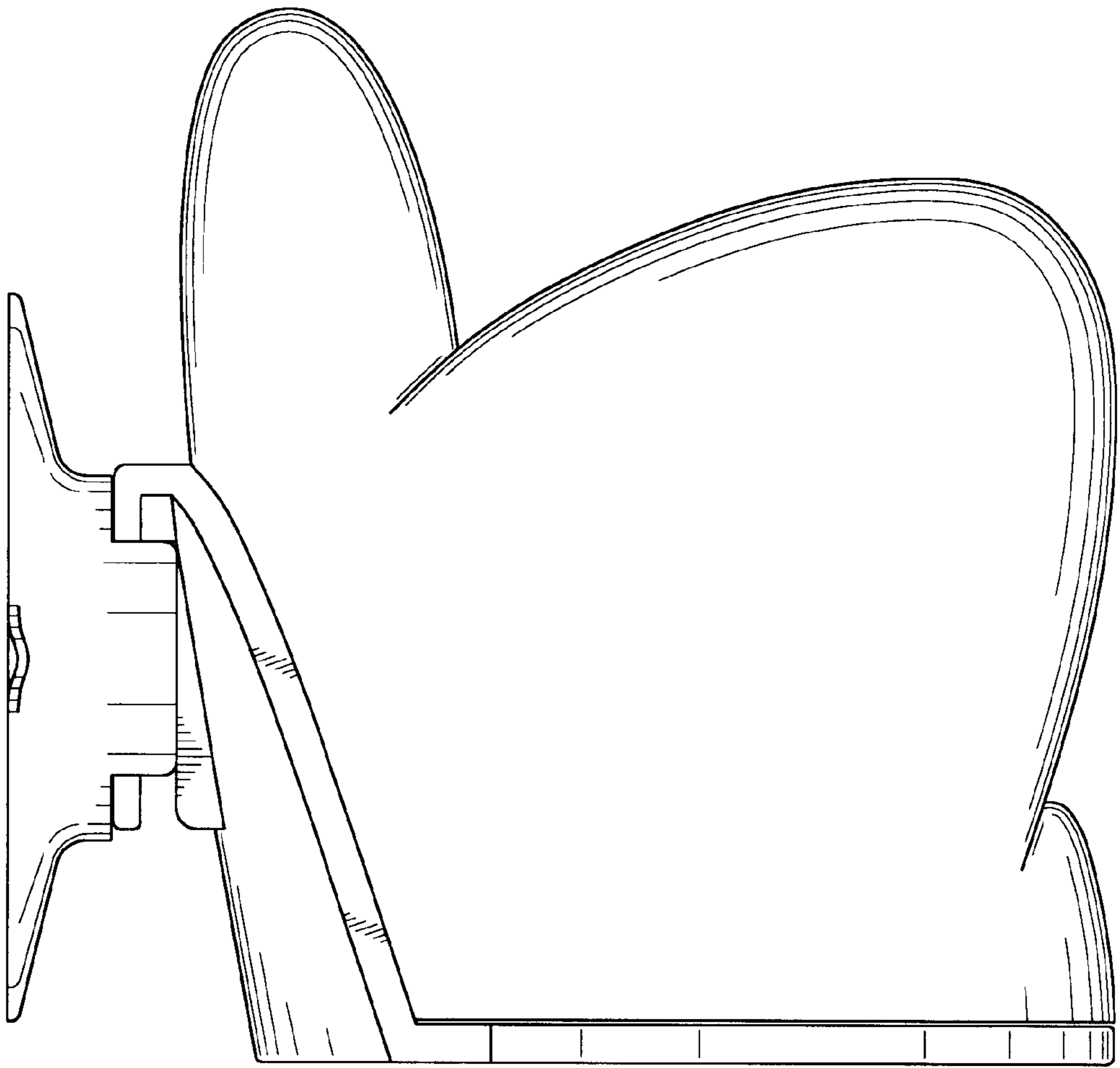

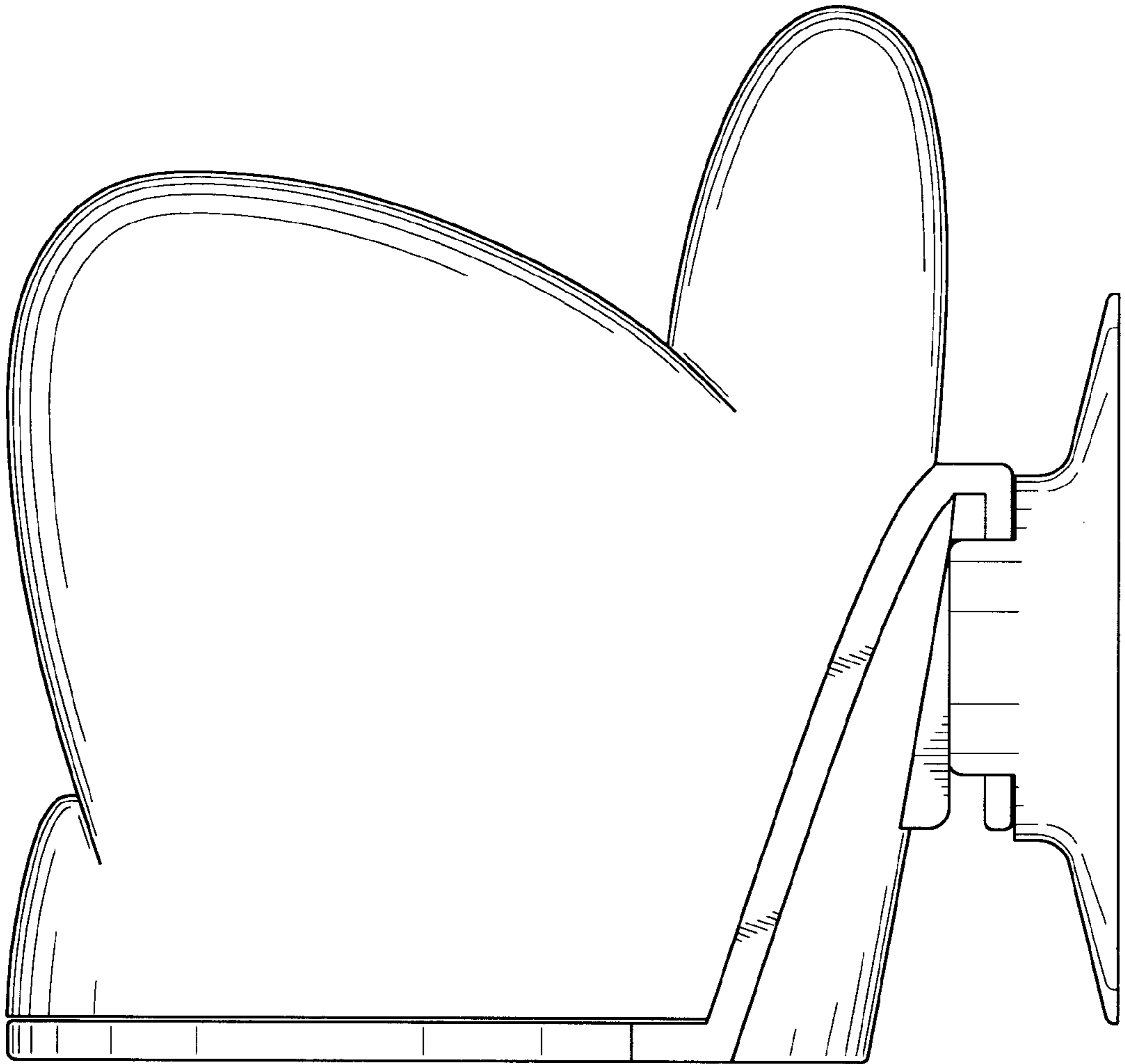

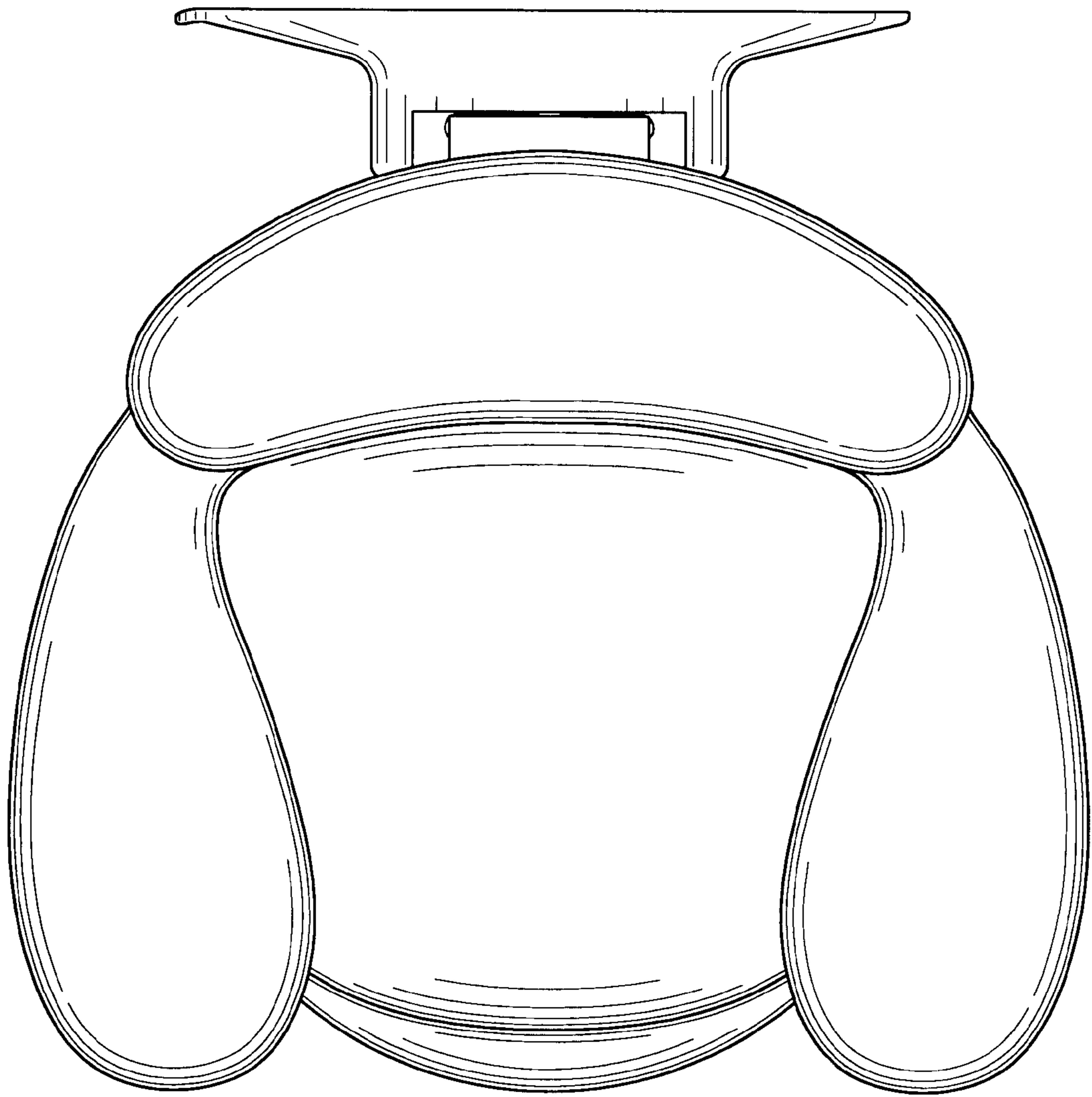

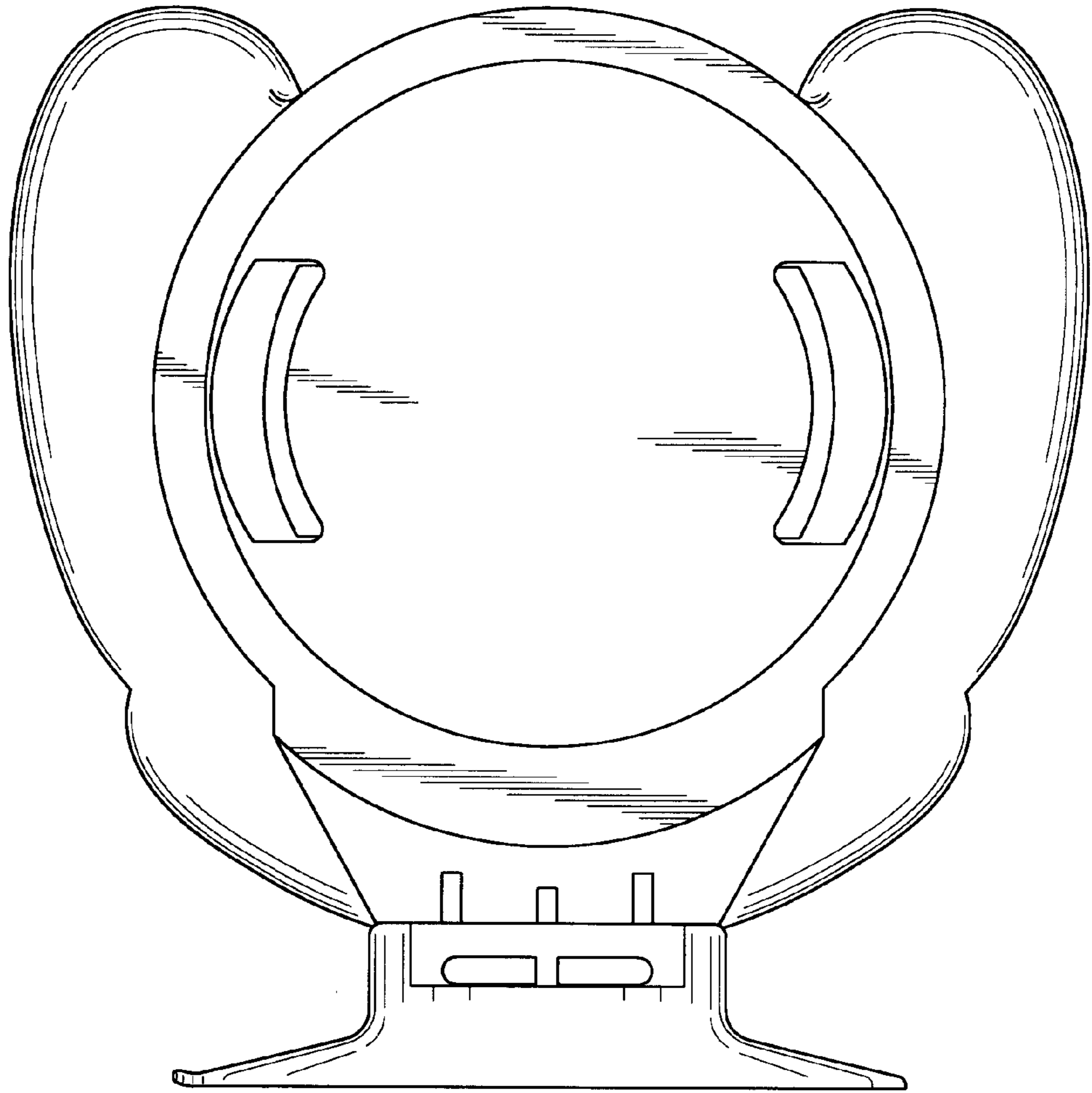
