DESCRIPTION

FIG. 18 is a bottom plan view thereof;

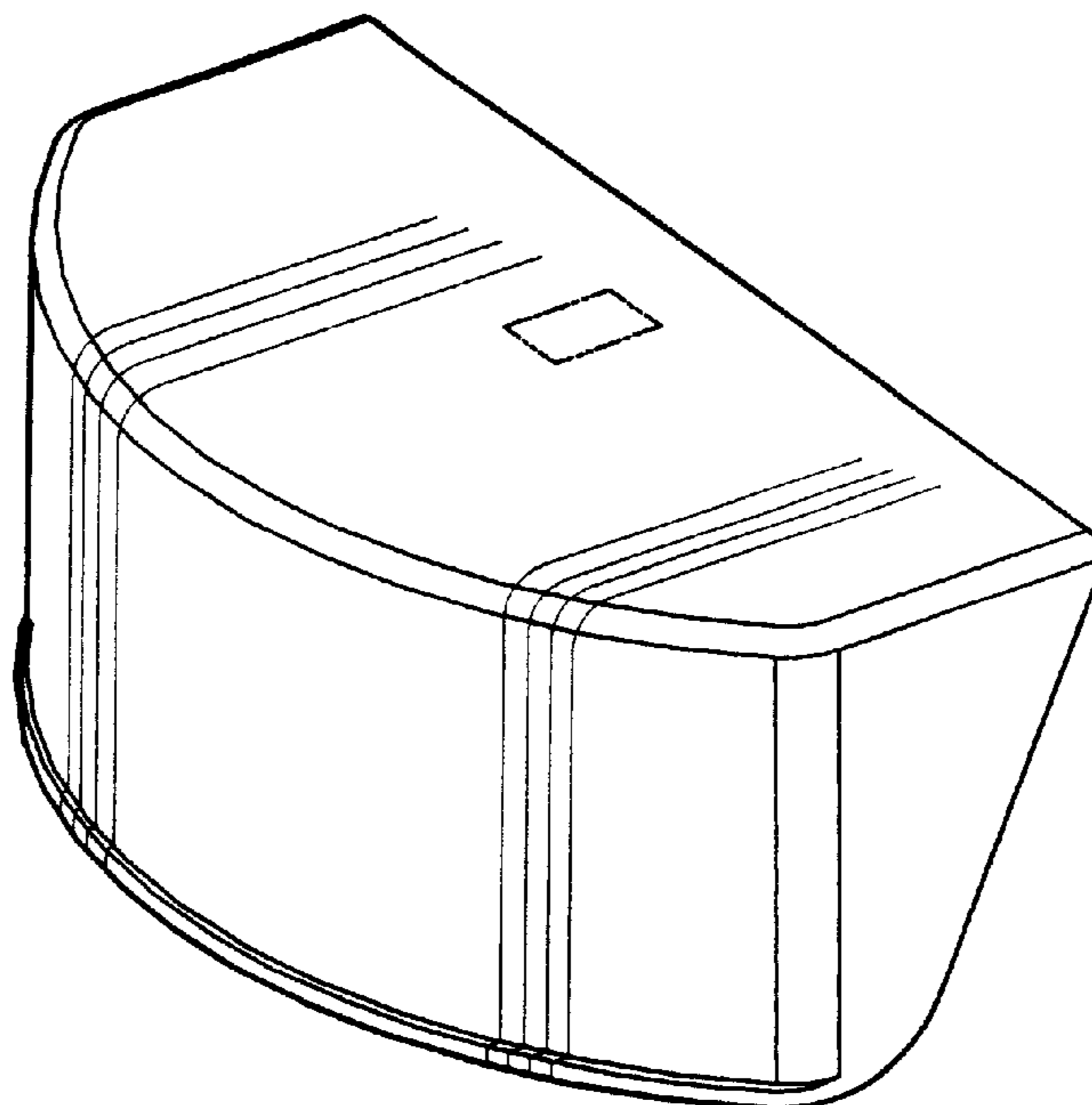
FIG. 19 is a left side view thereof;

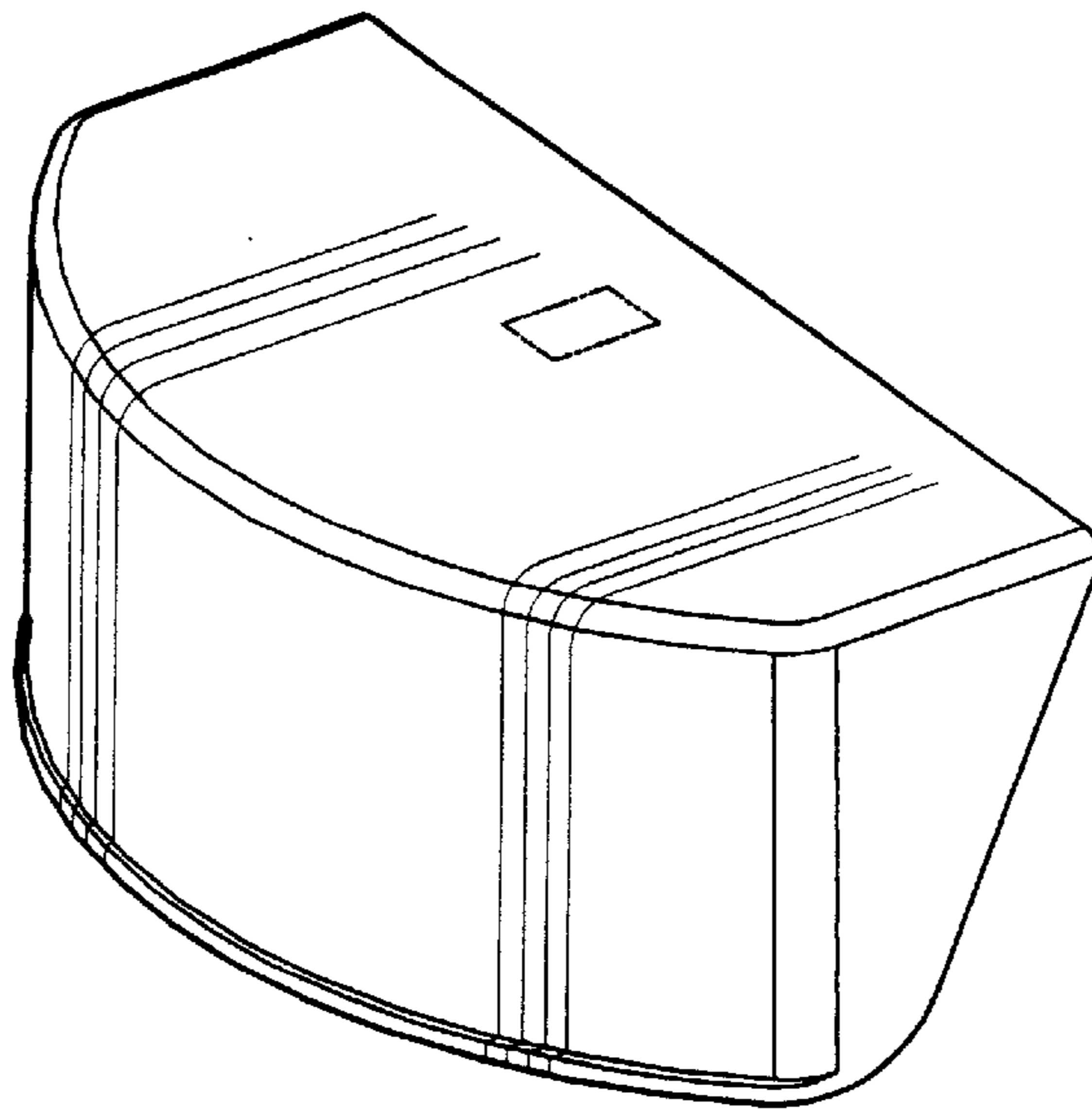

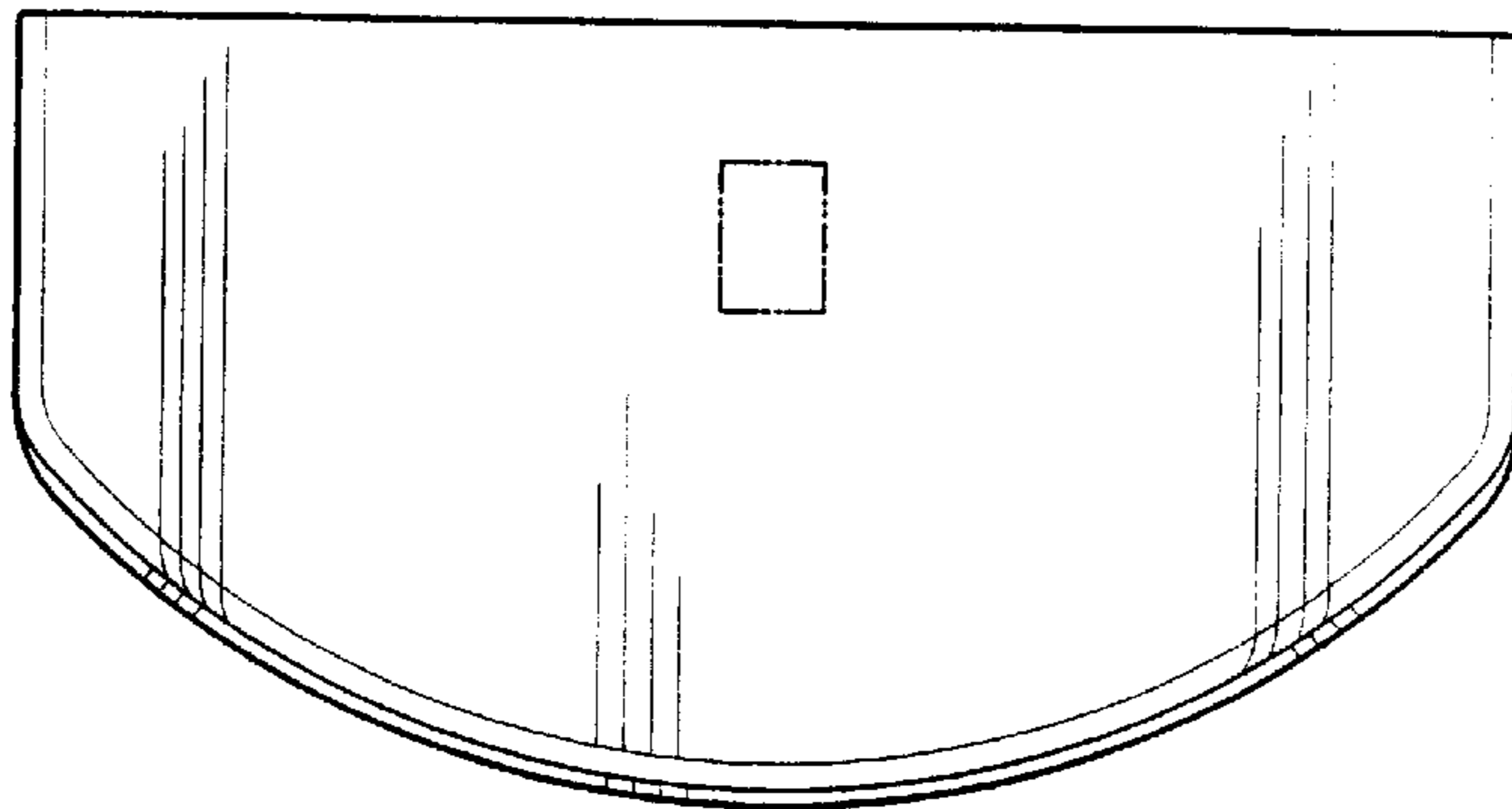

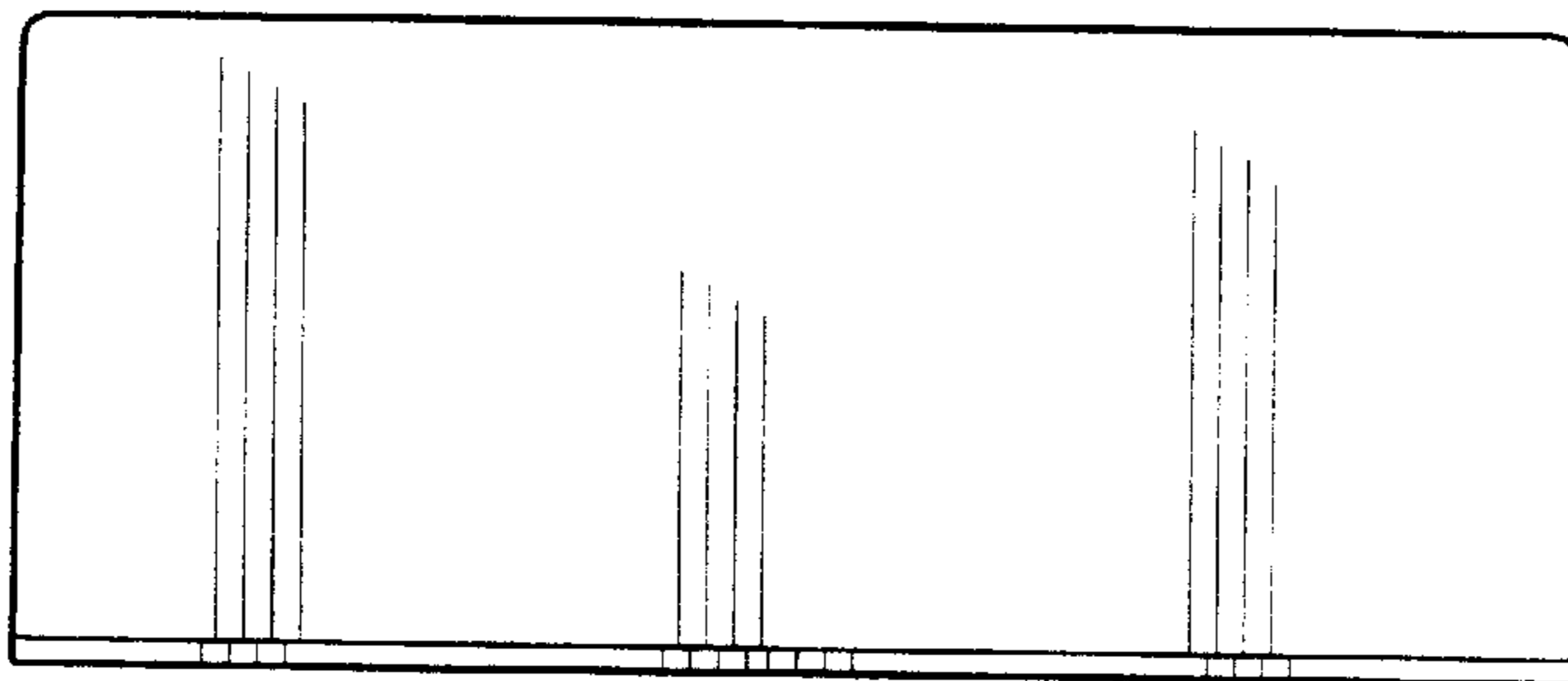

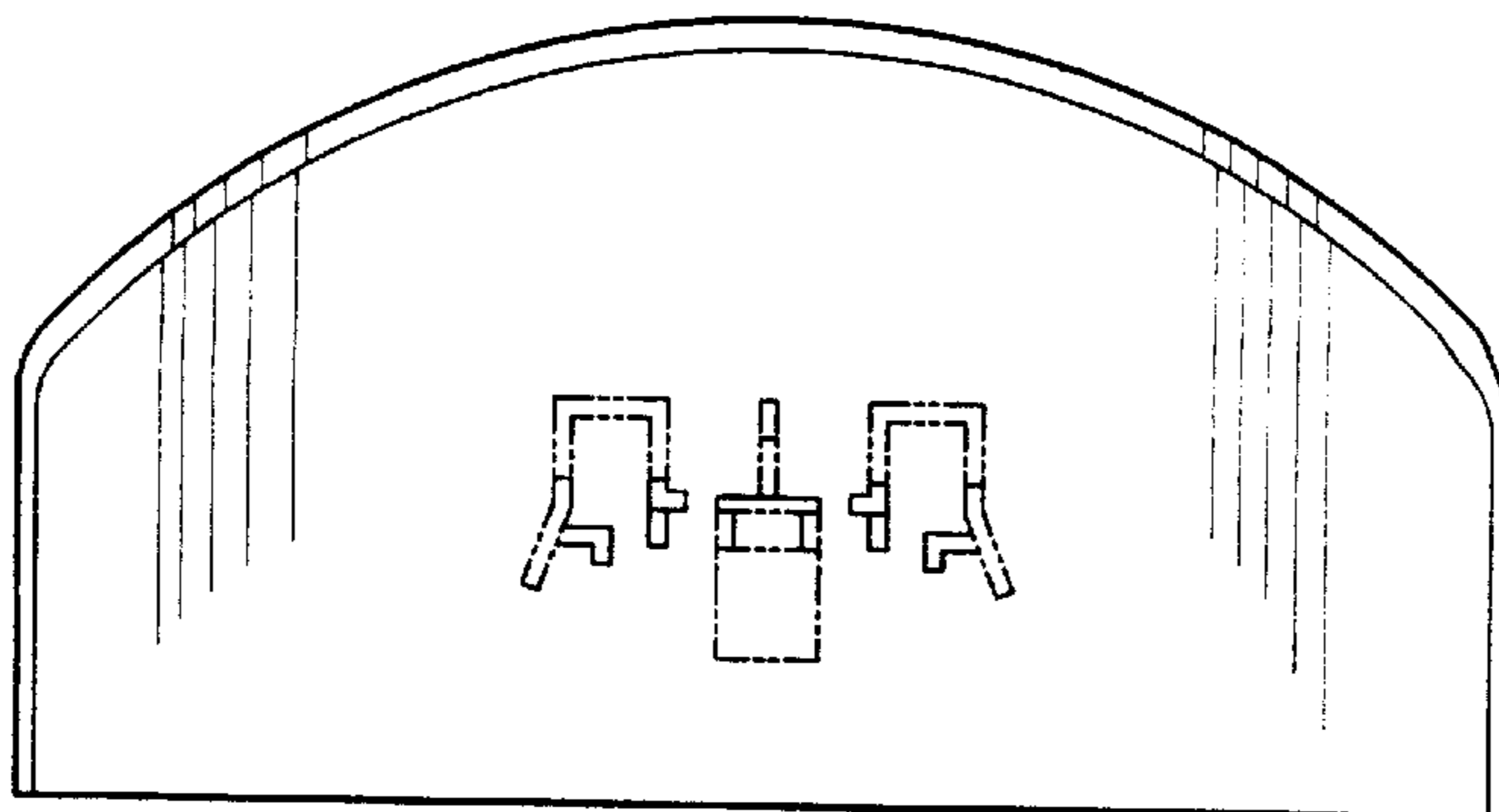

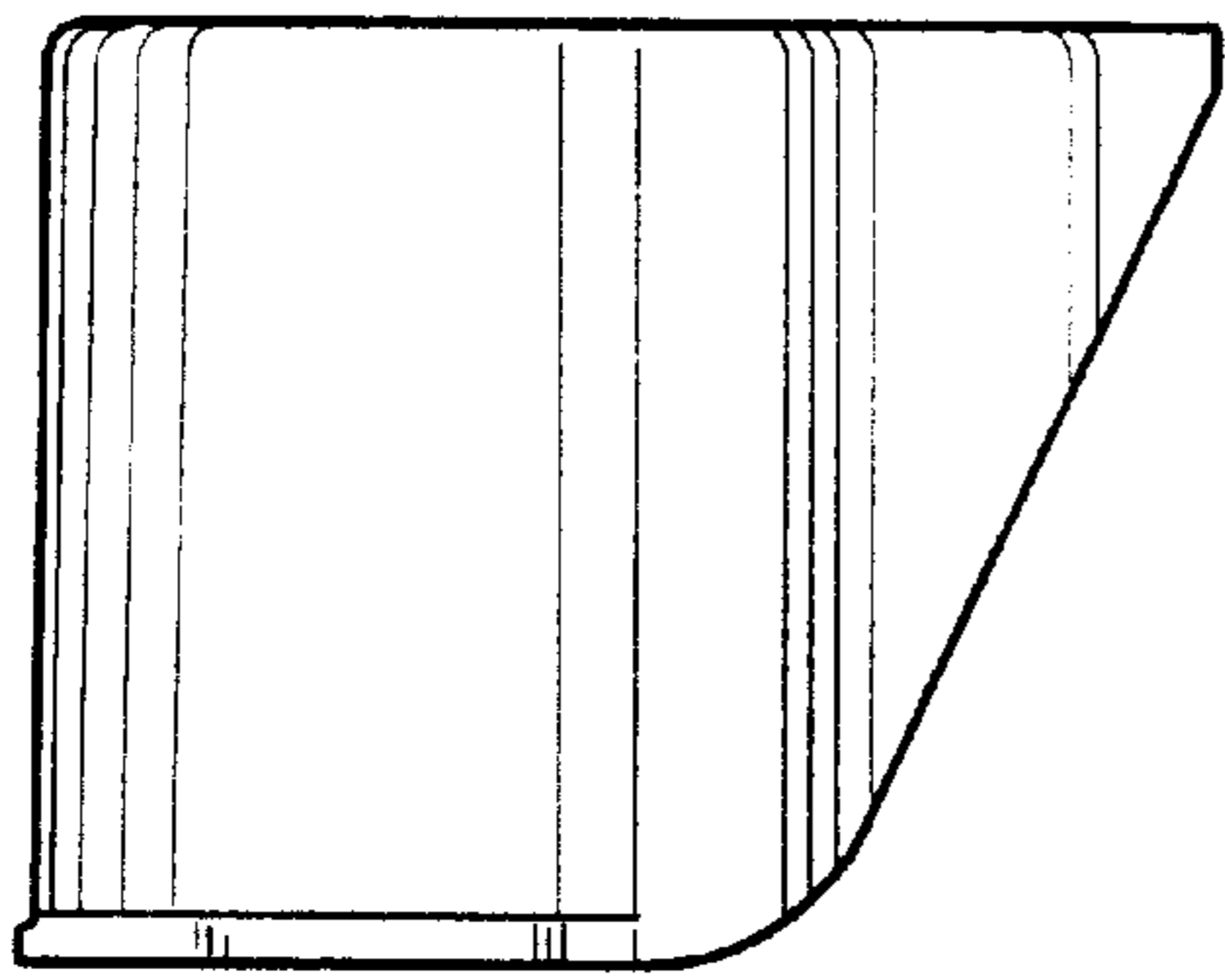

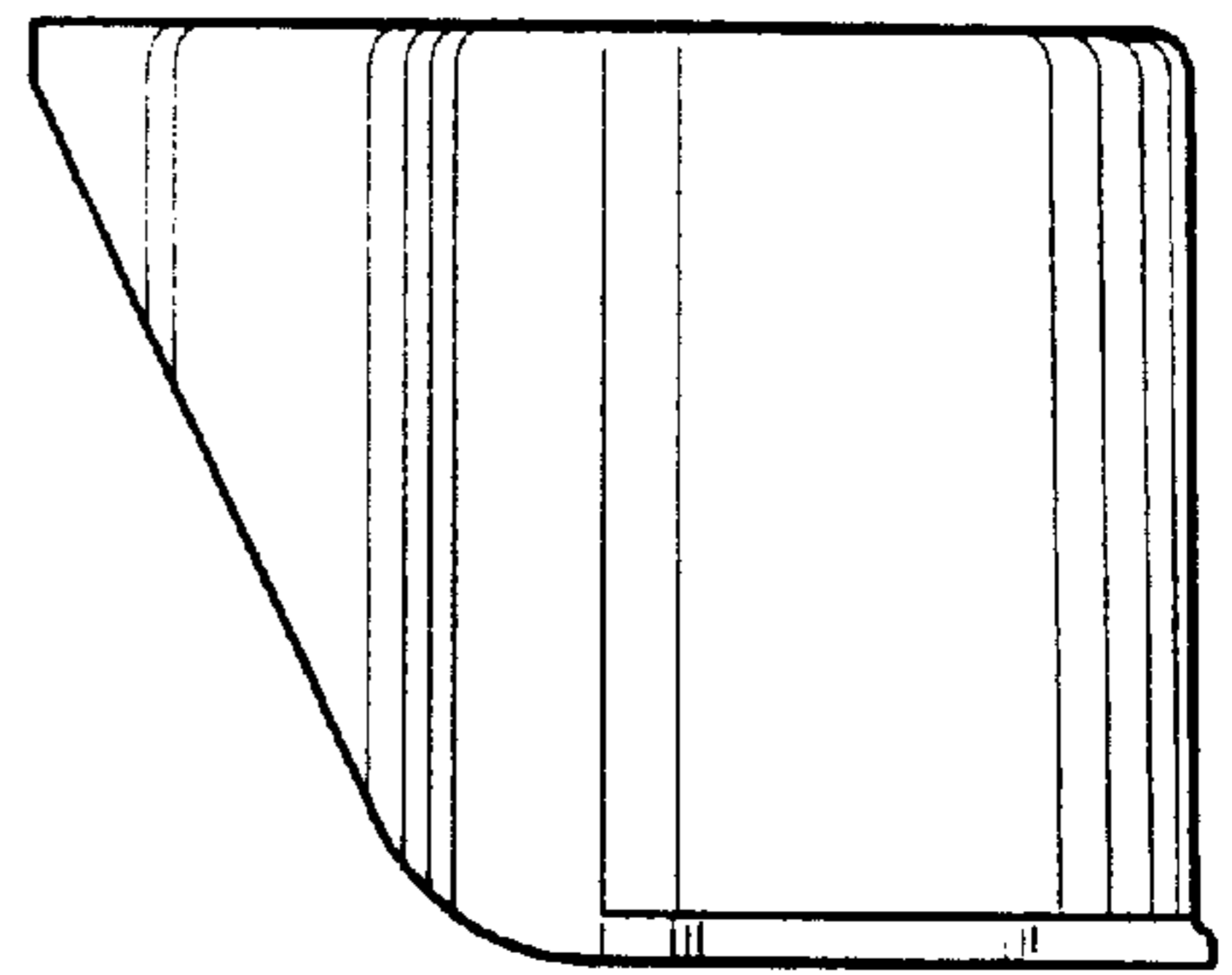

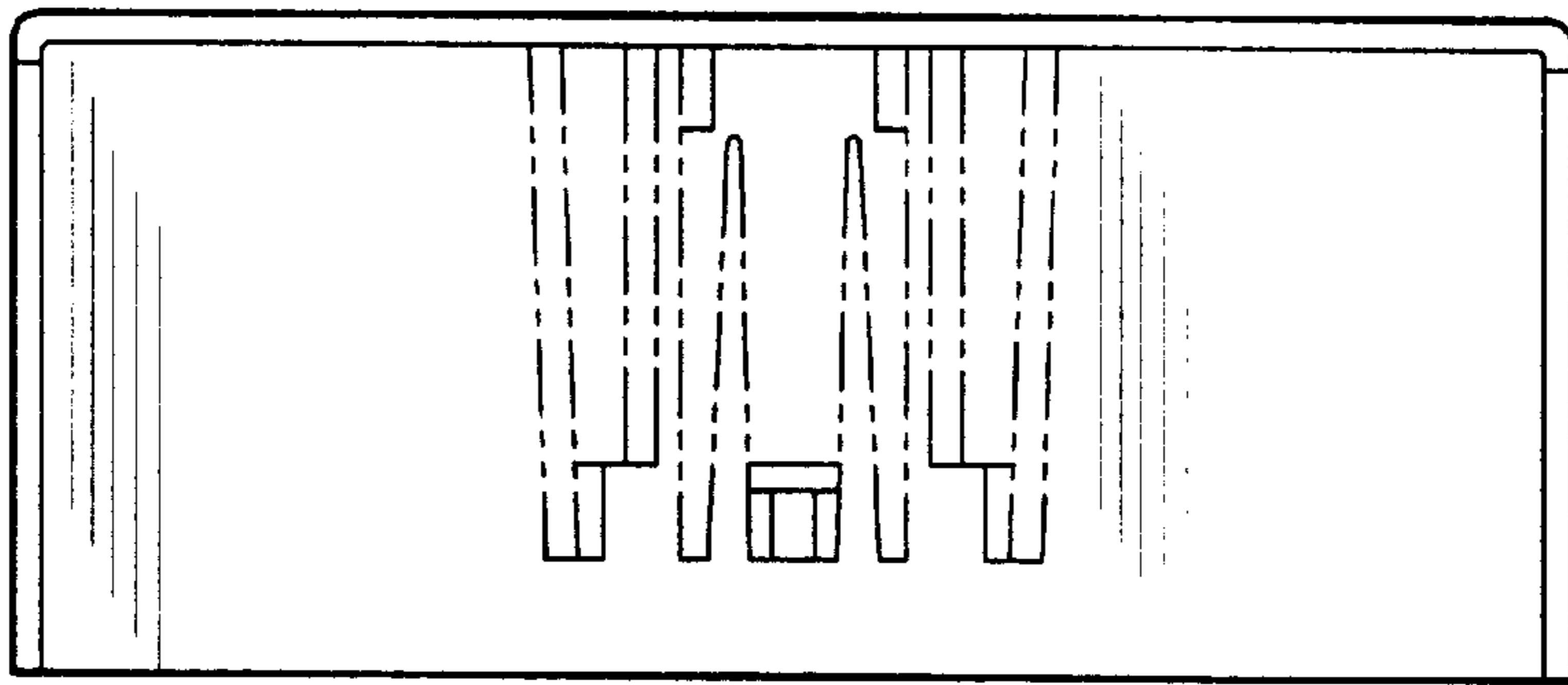

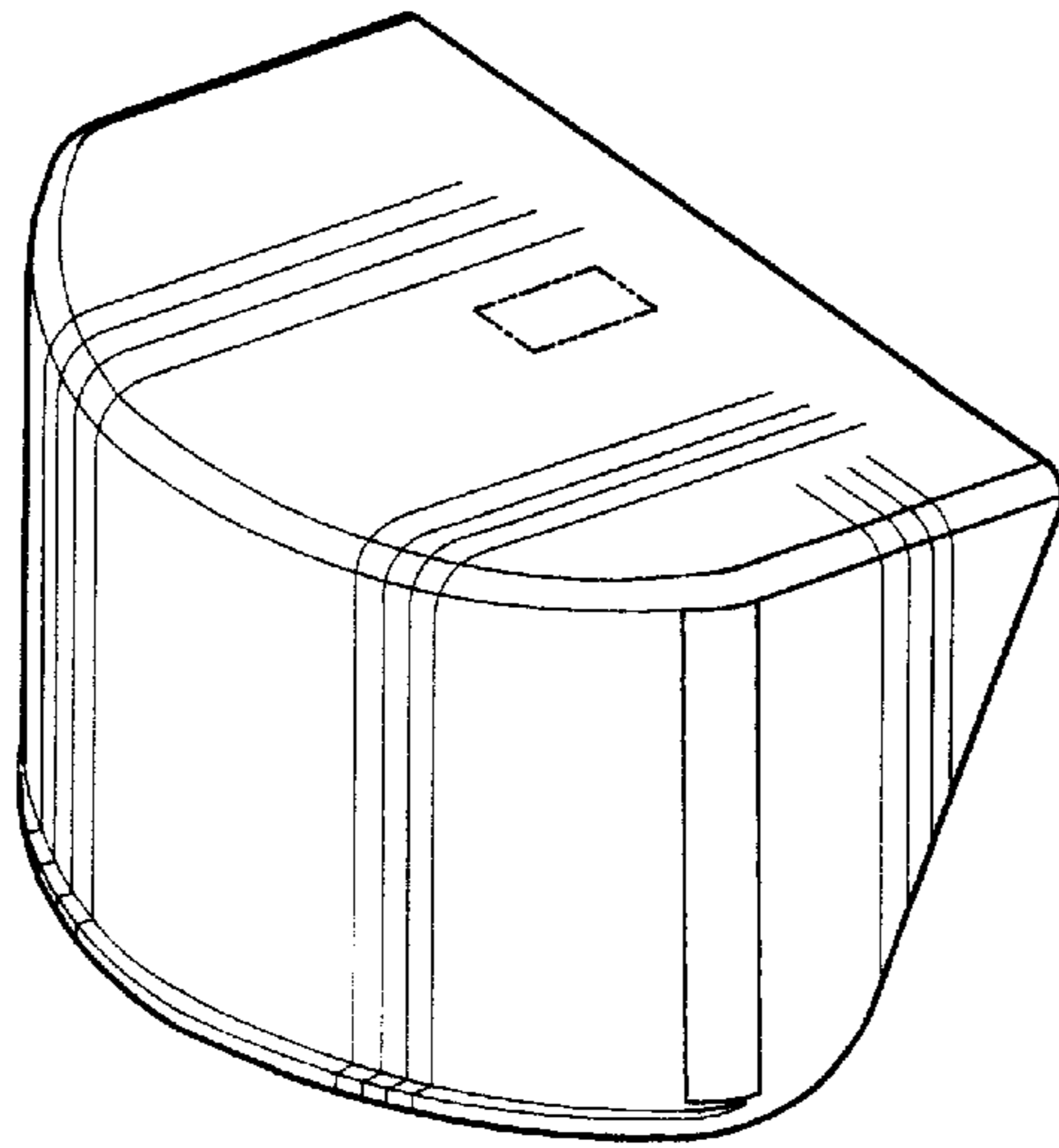

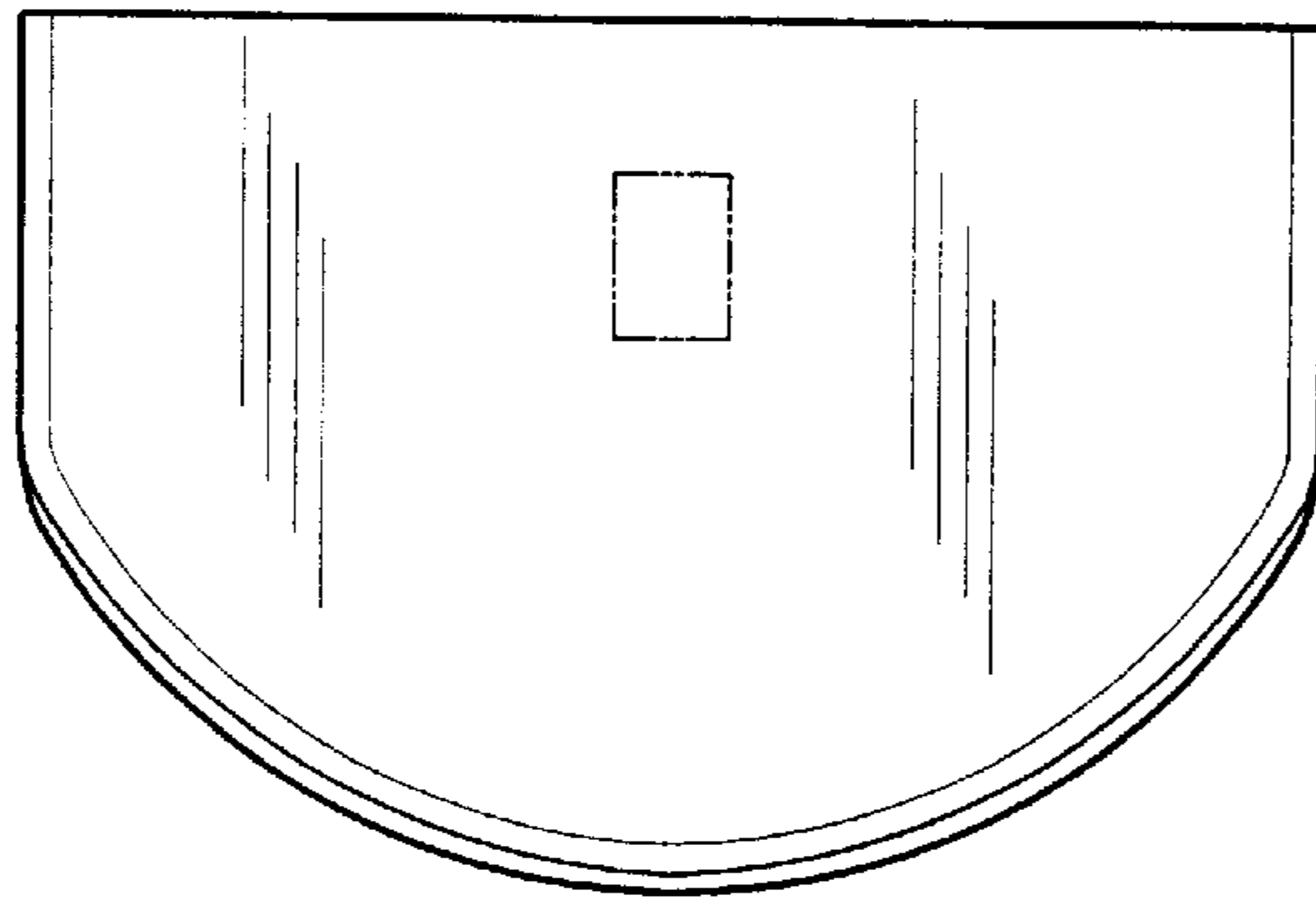

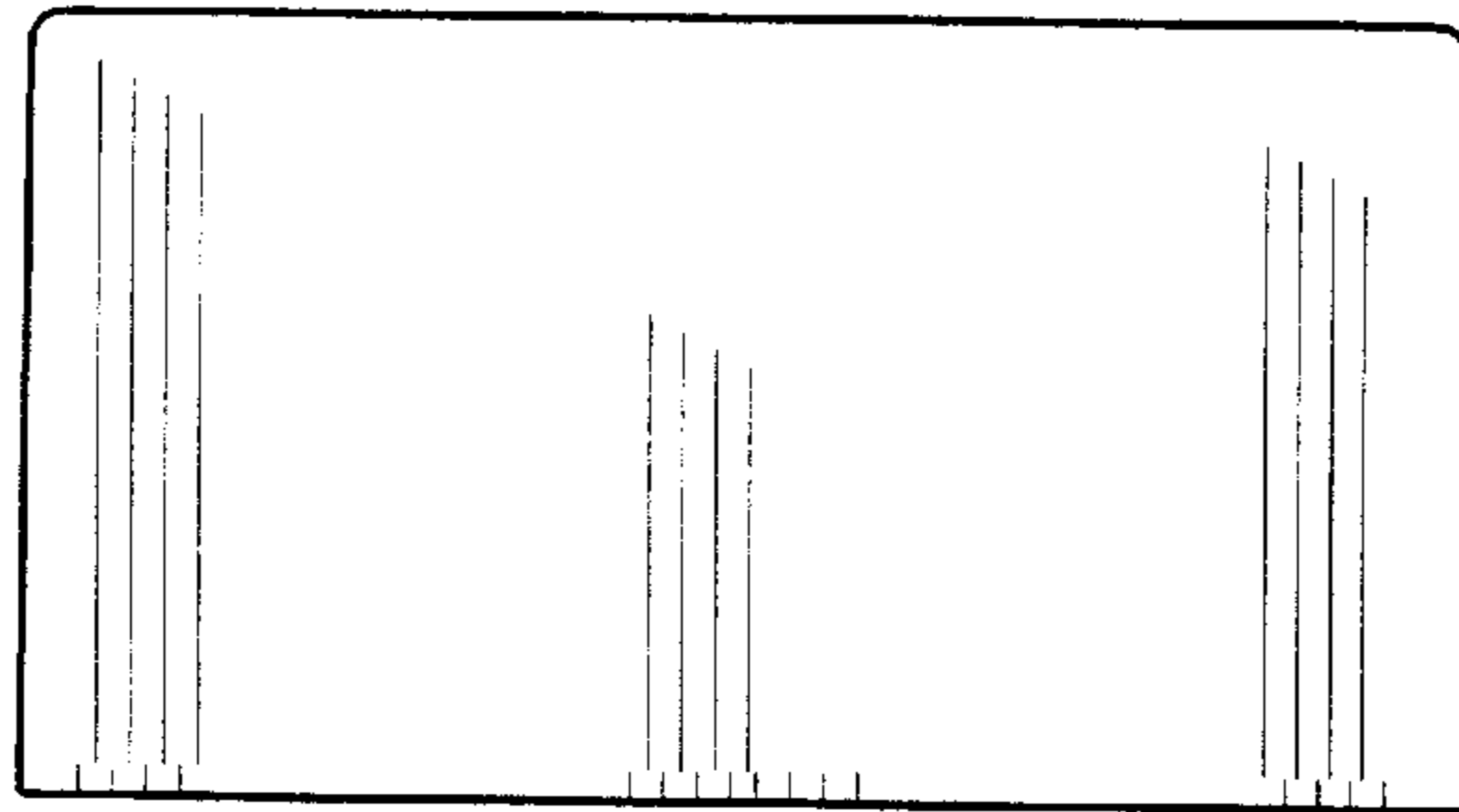

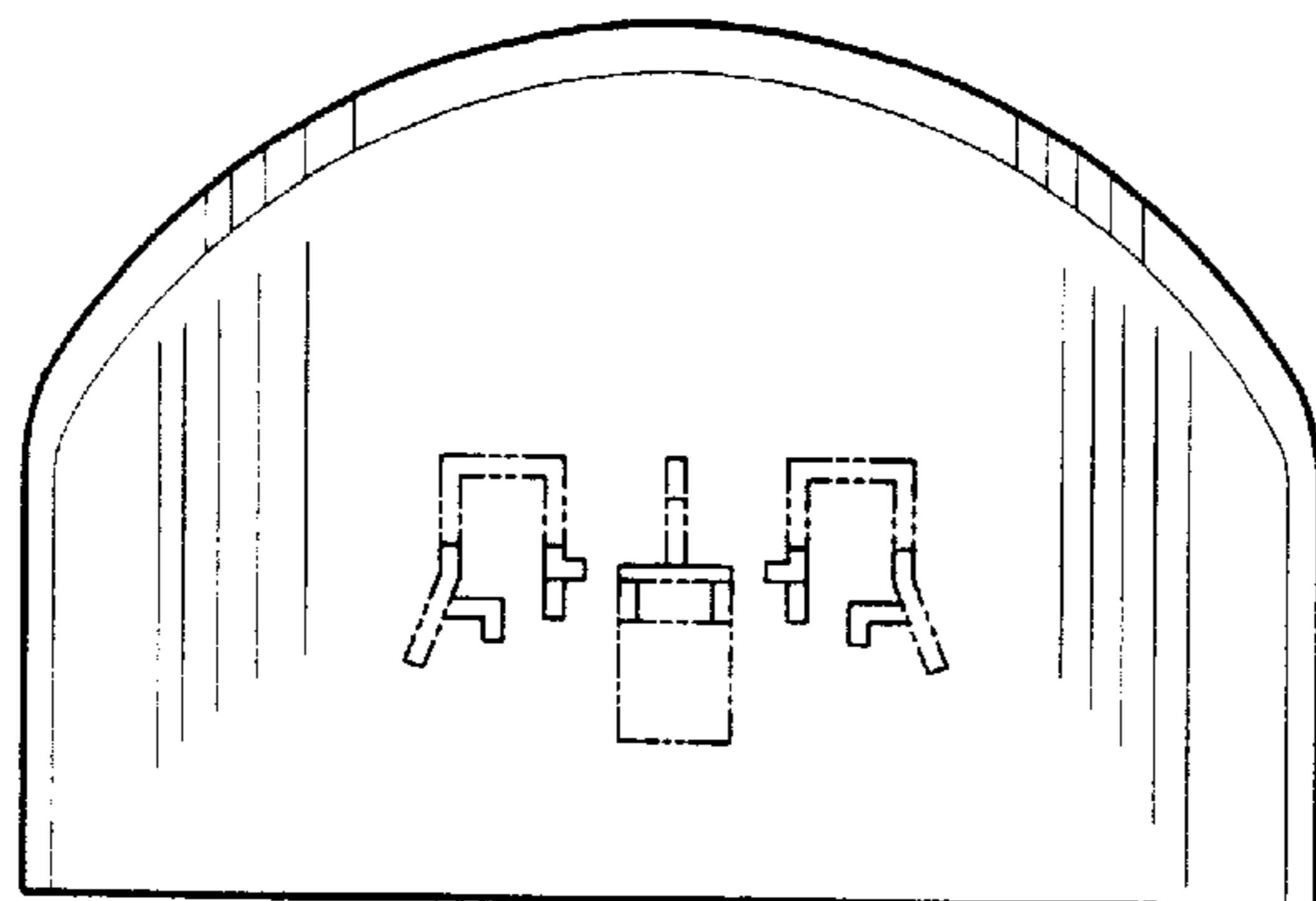

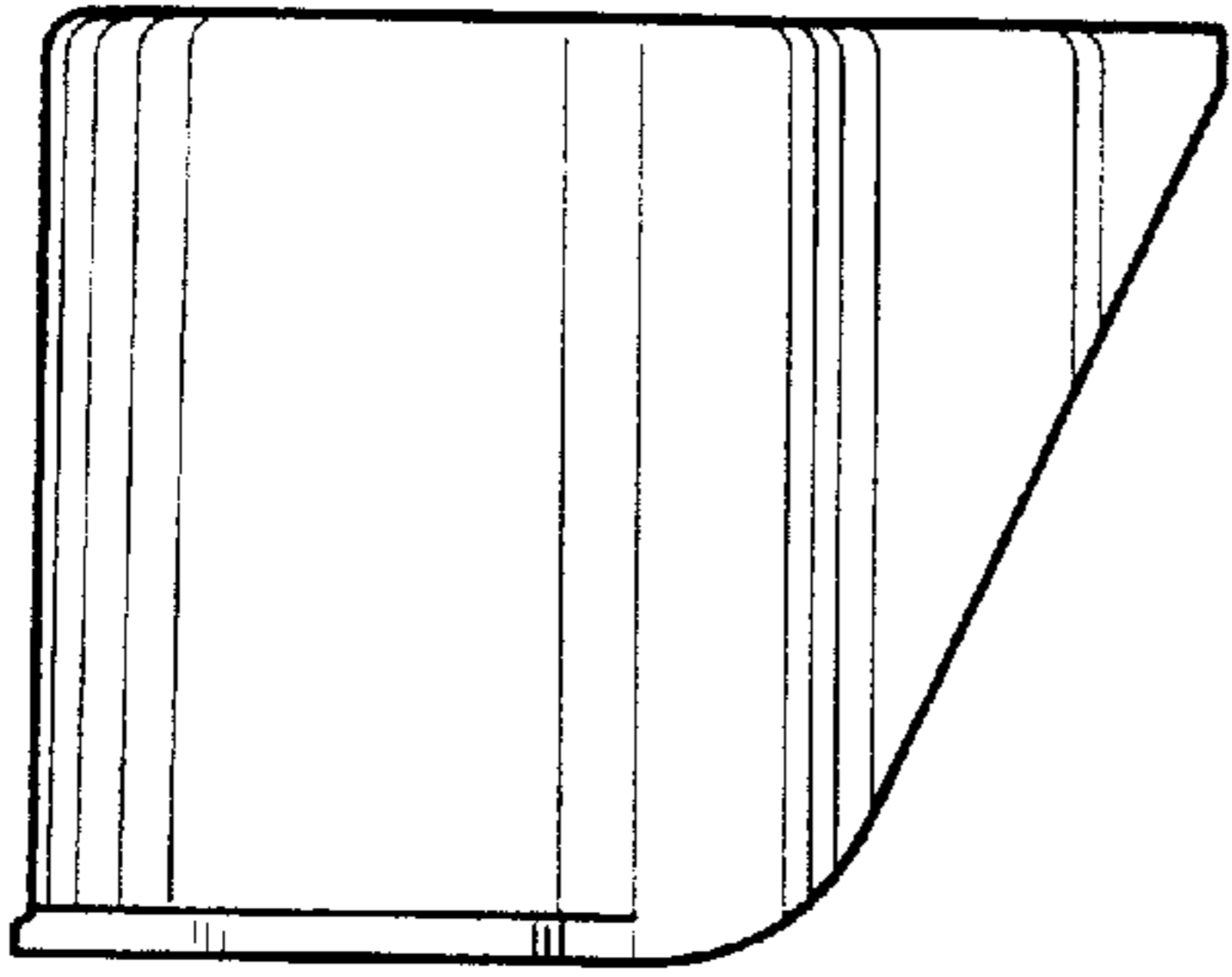

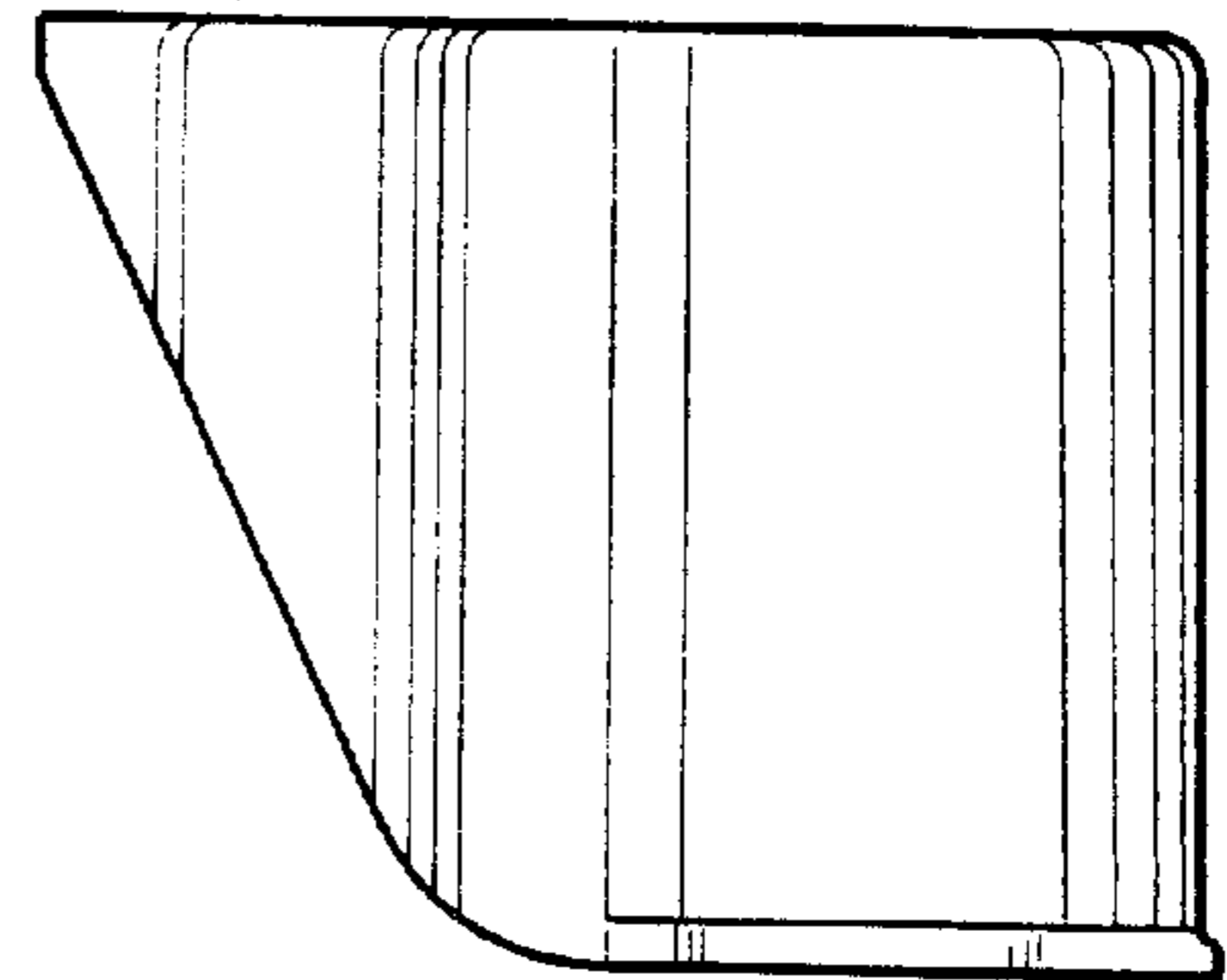

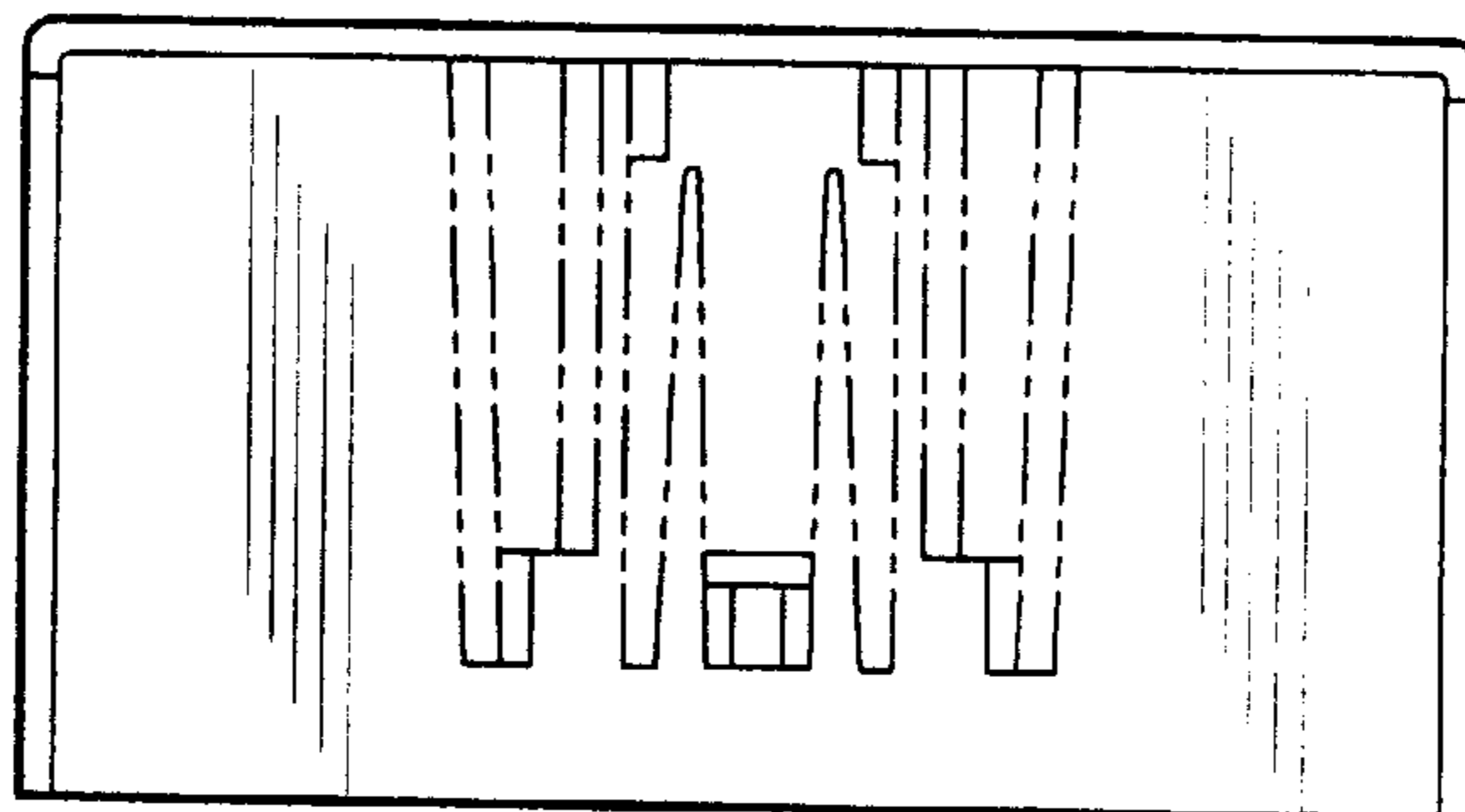

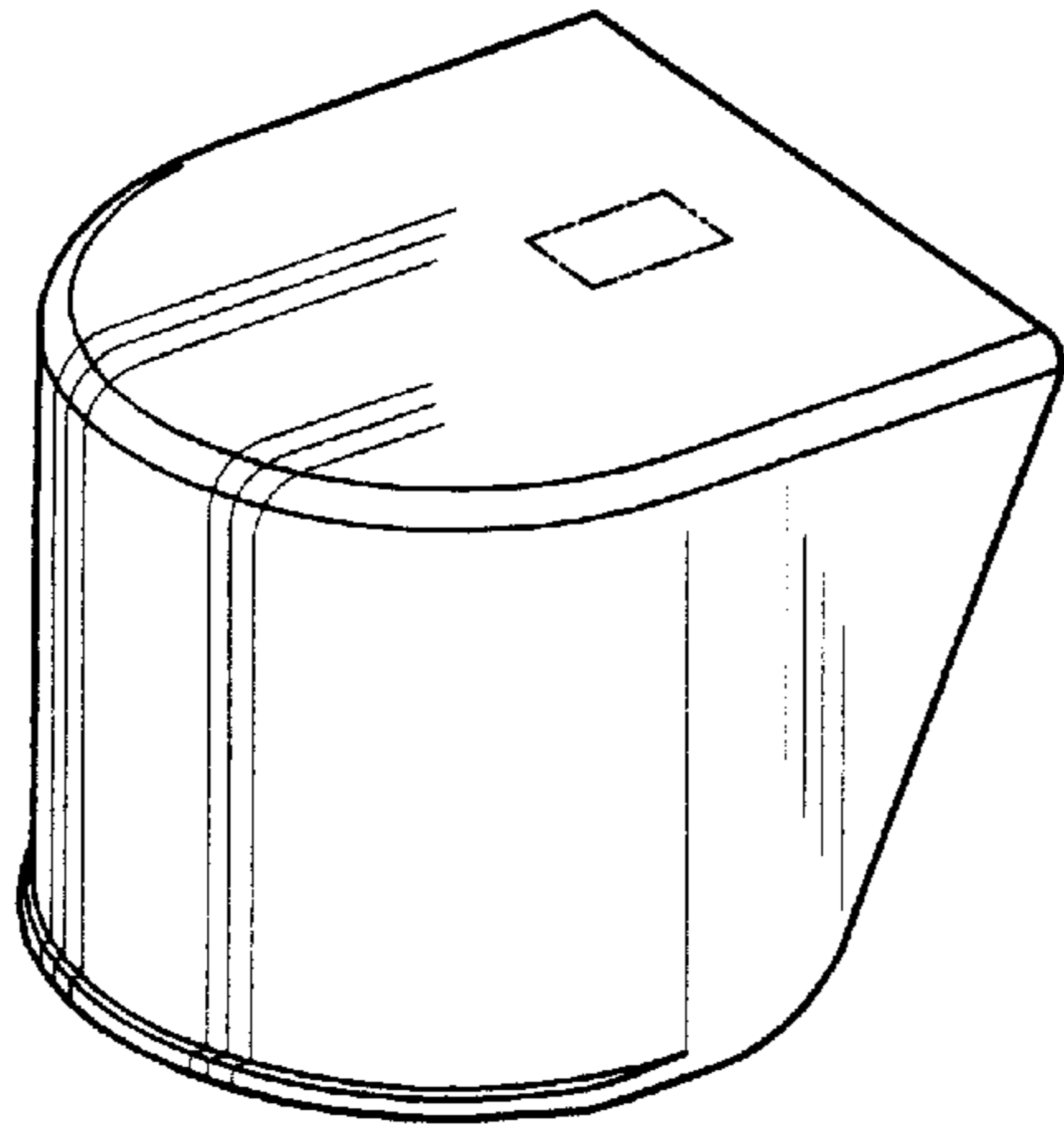

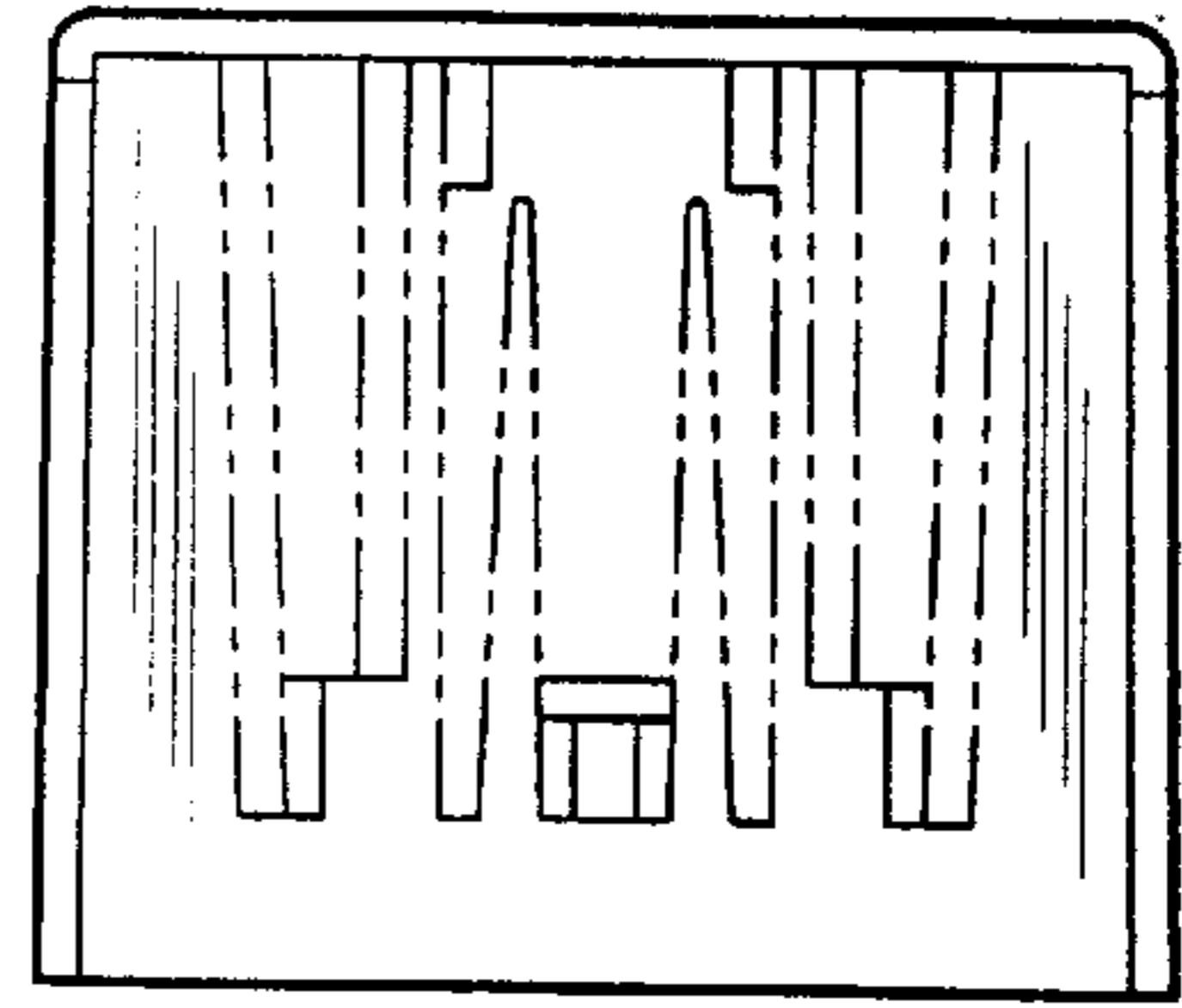

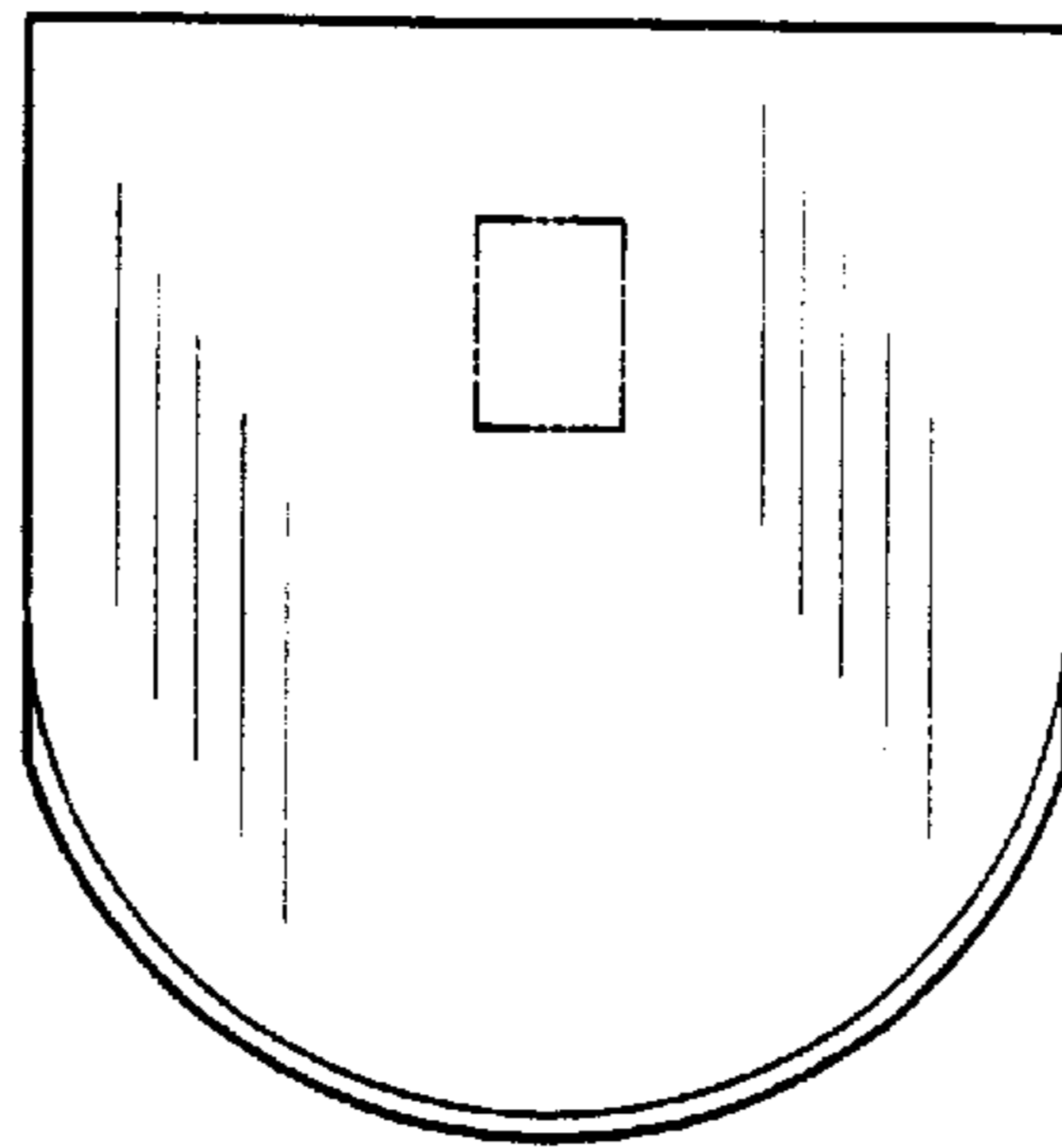

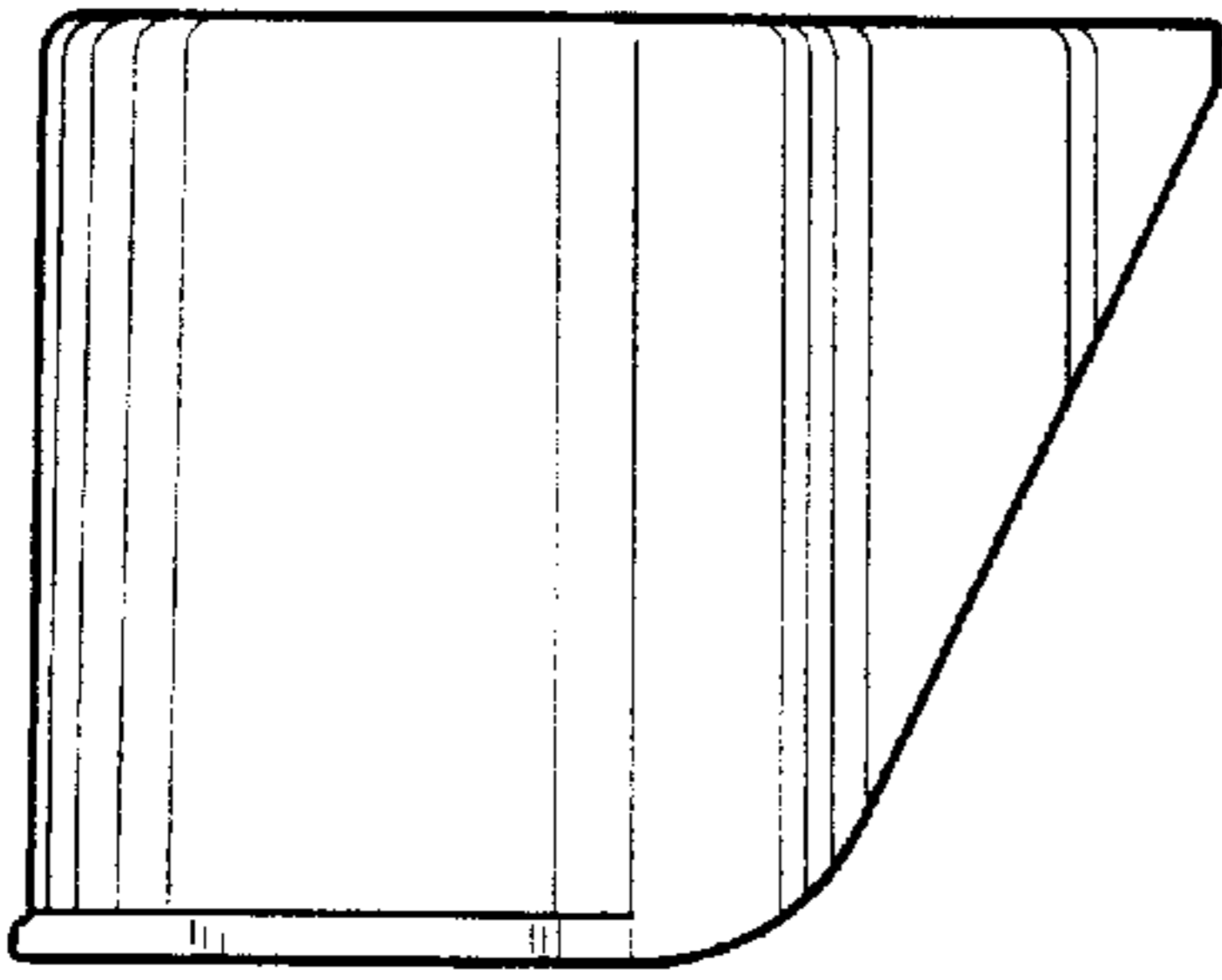

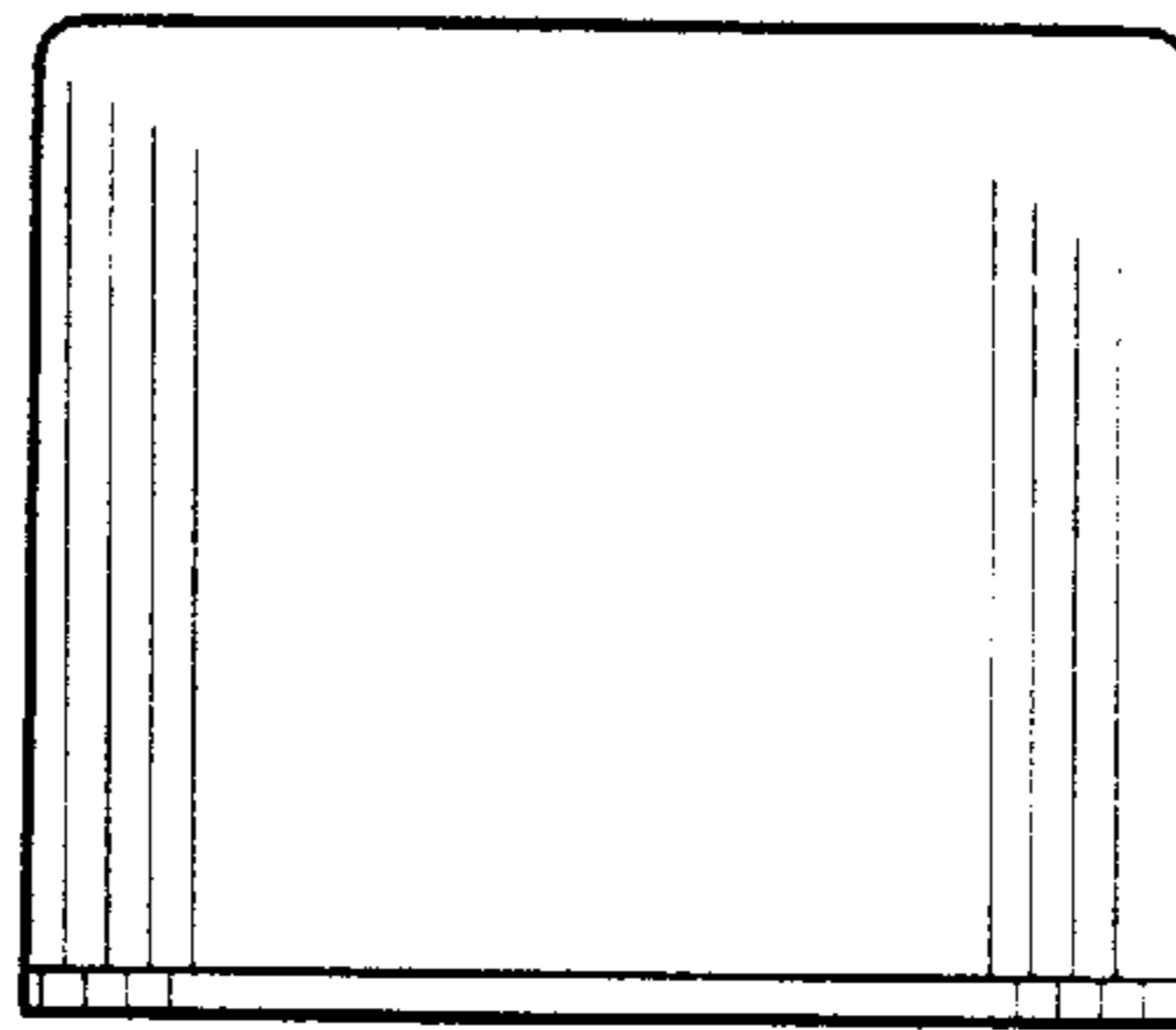

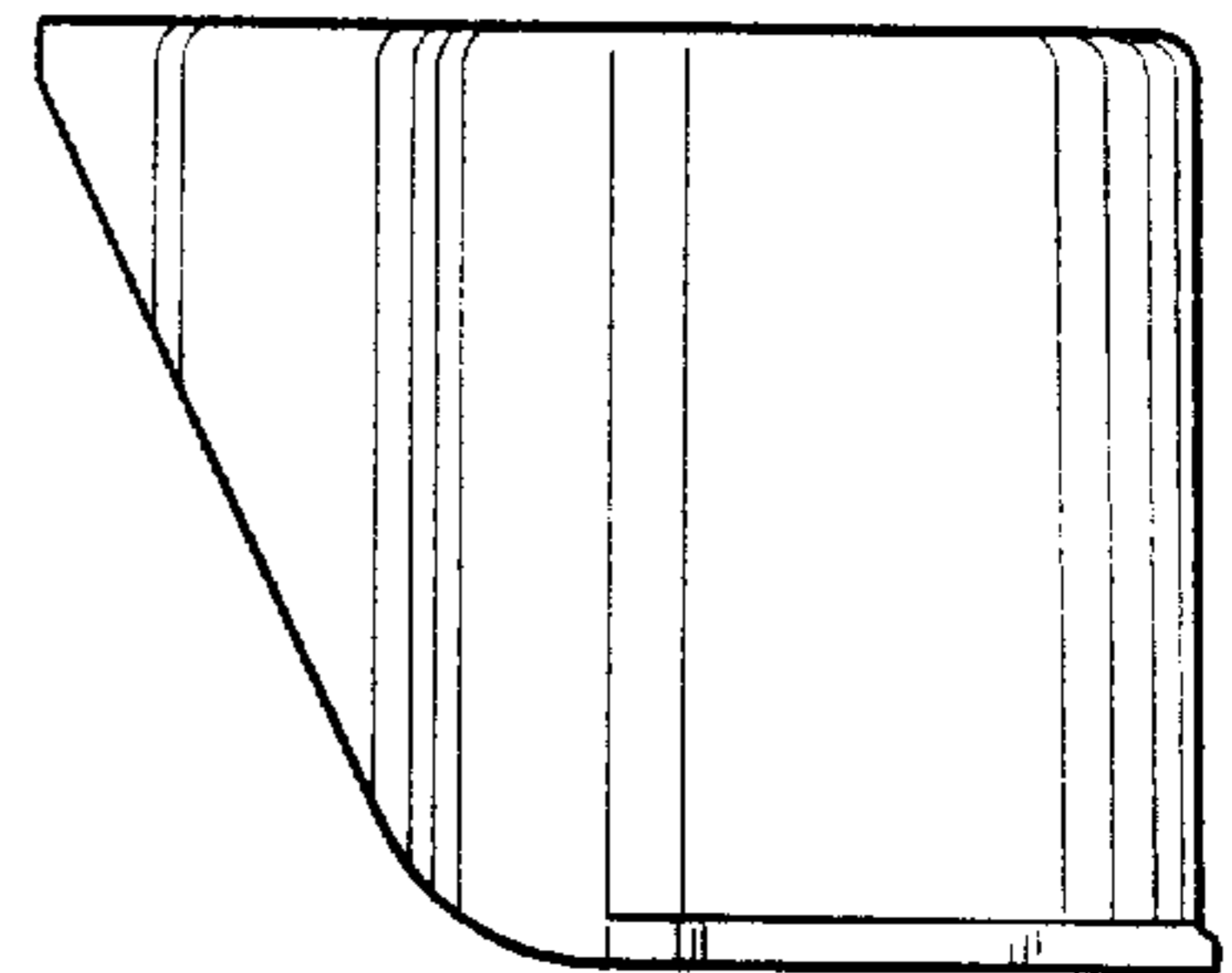

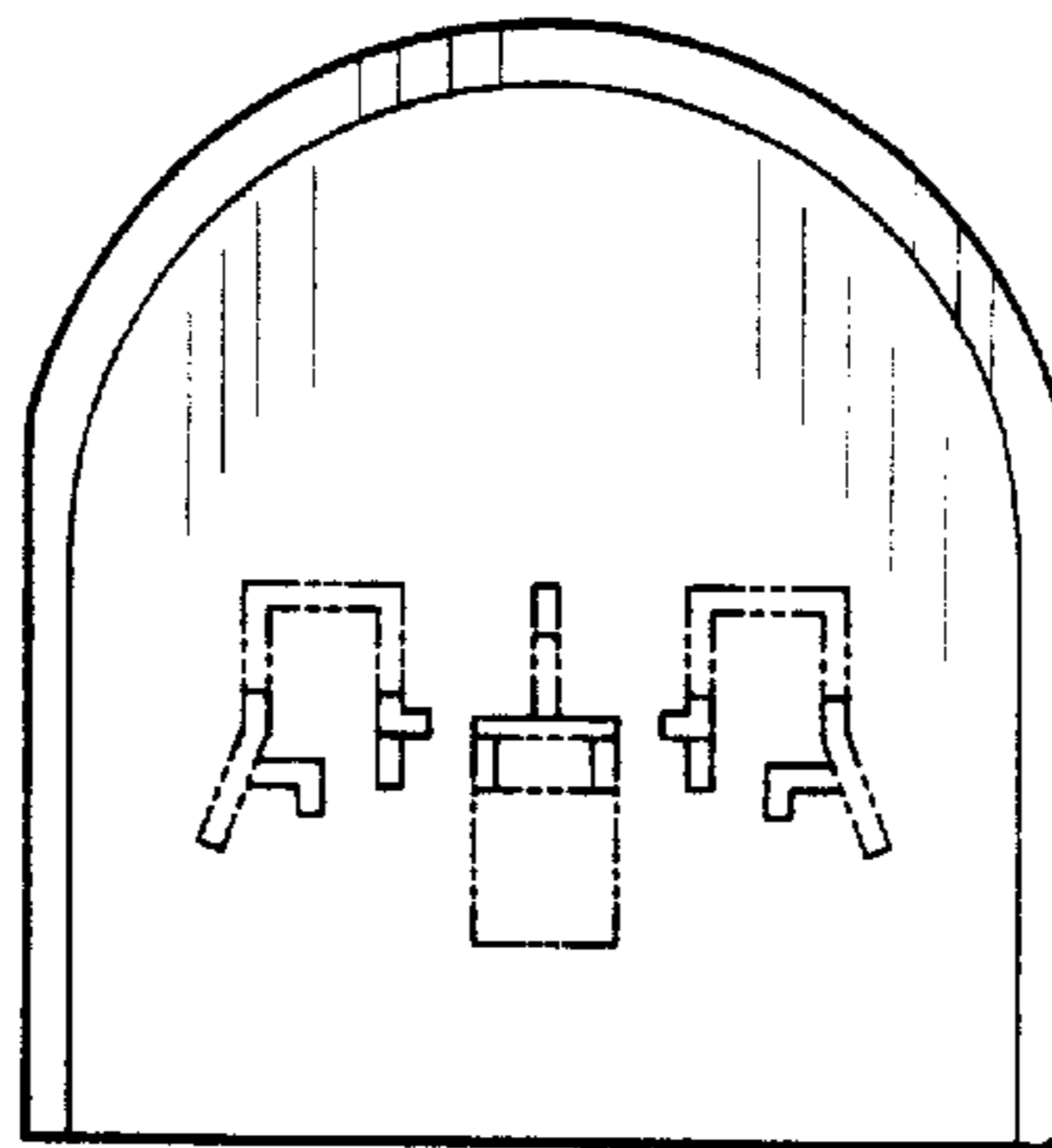

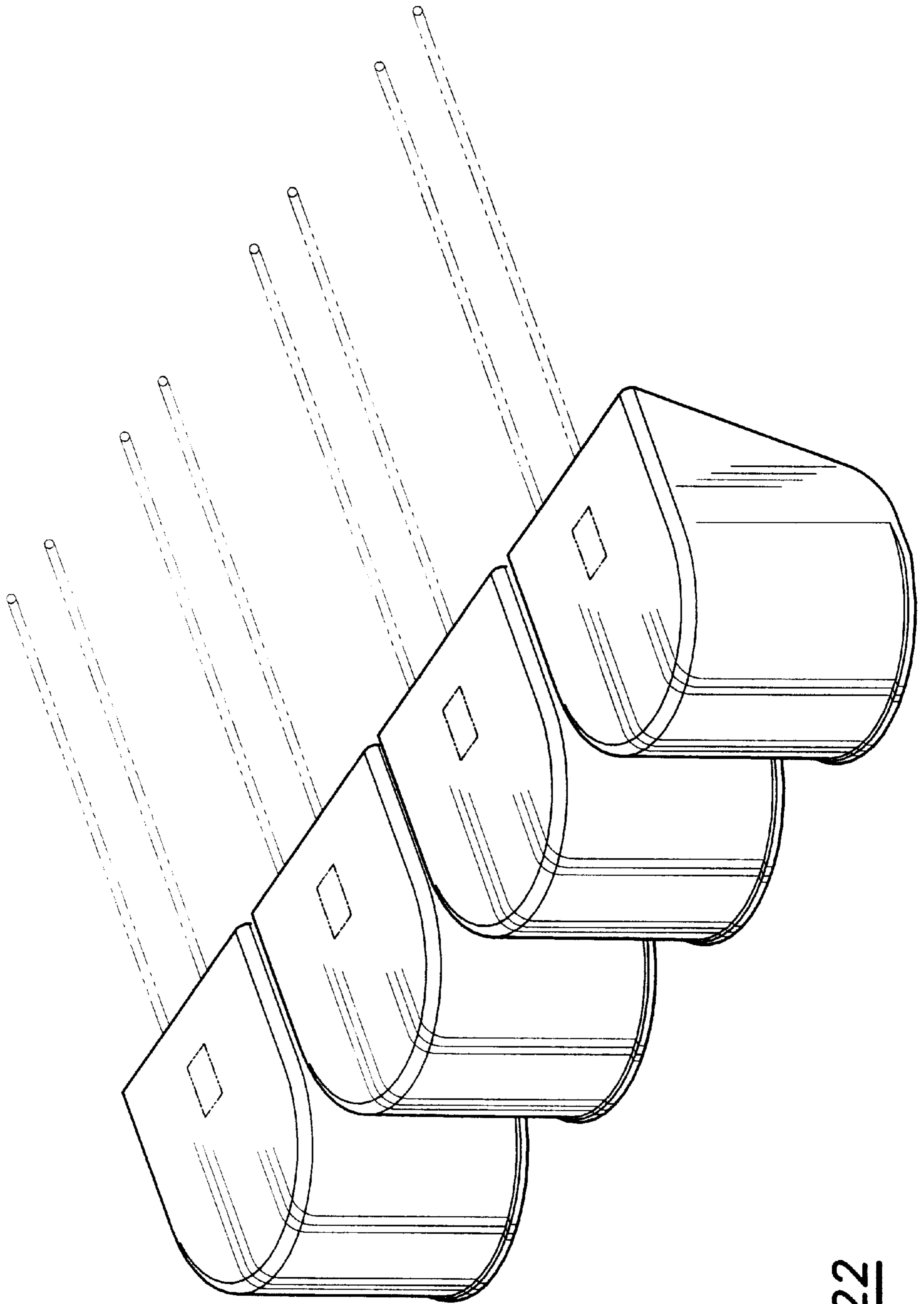
