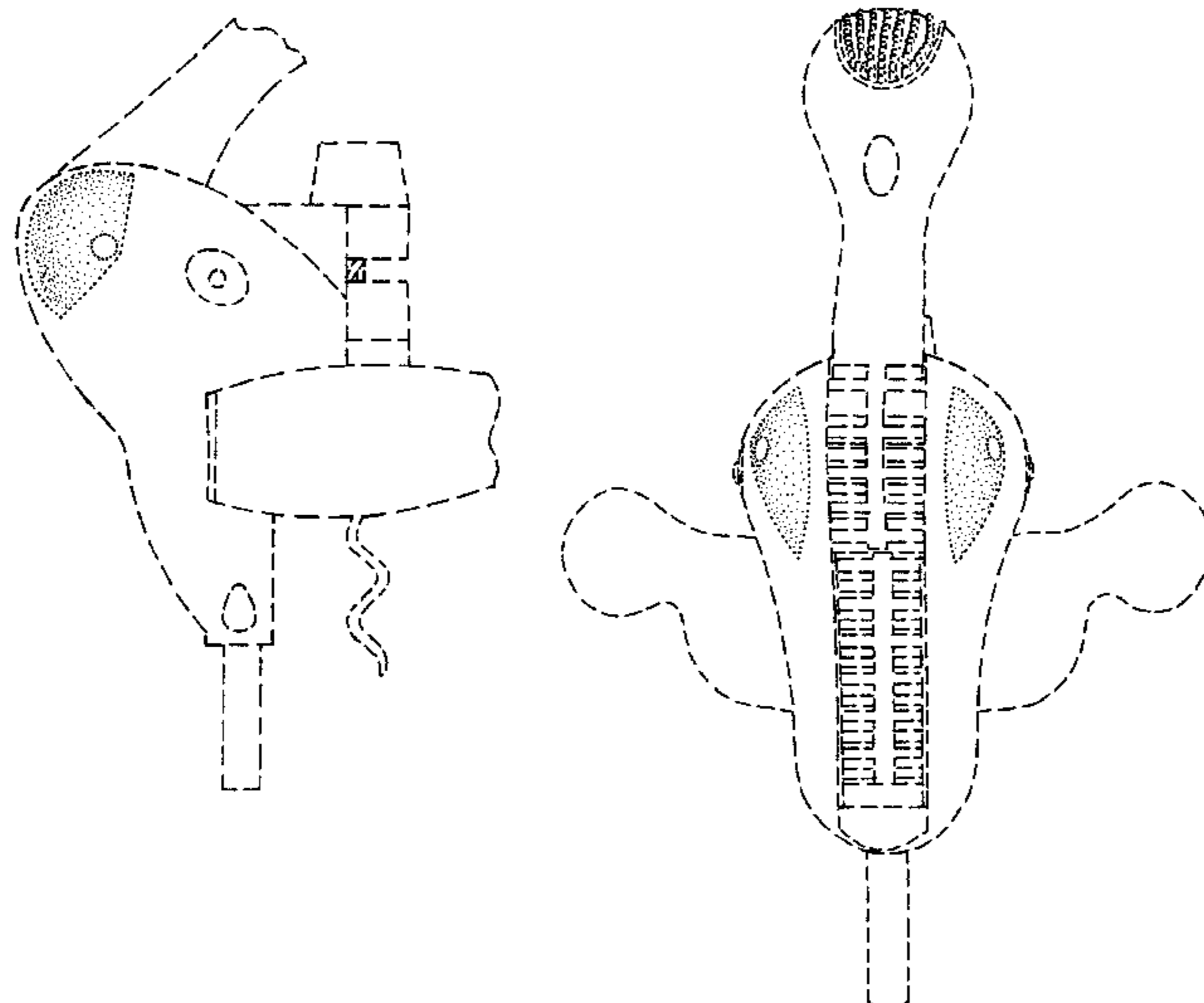
(57) **CLAIM**

The ornamental design for portion of cork extractor, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side and rear perspective view of a portion of cork extractor showing my new design;  
FIG. 2 is a partial right side view thereof, the left side view being a mirror image;  
FIG. 3 is a front perspective view thereof; and,  
FIG. 4 is a top perspective view thereof.  
The dashed lines shown in the figures represent environmental subject matter and form no part of the claimed design. The dotted lines shown in the figures represent the border between claimed subject matter and unclaimed environmental subject matter and form no part of the claimed design.

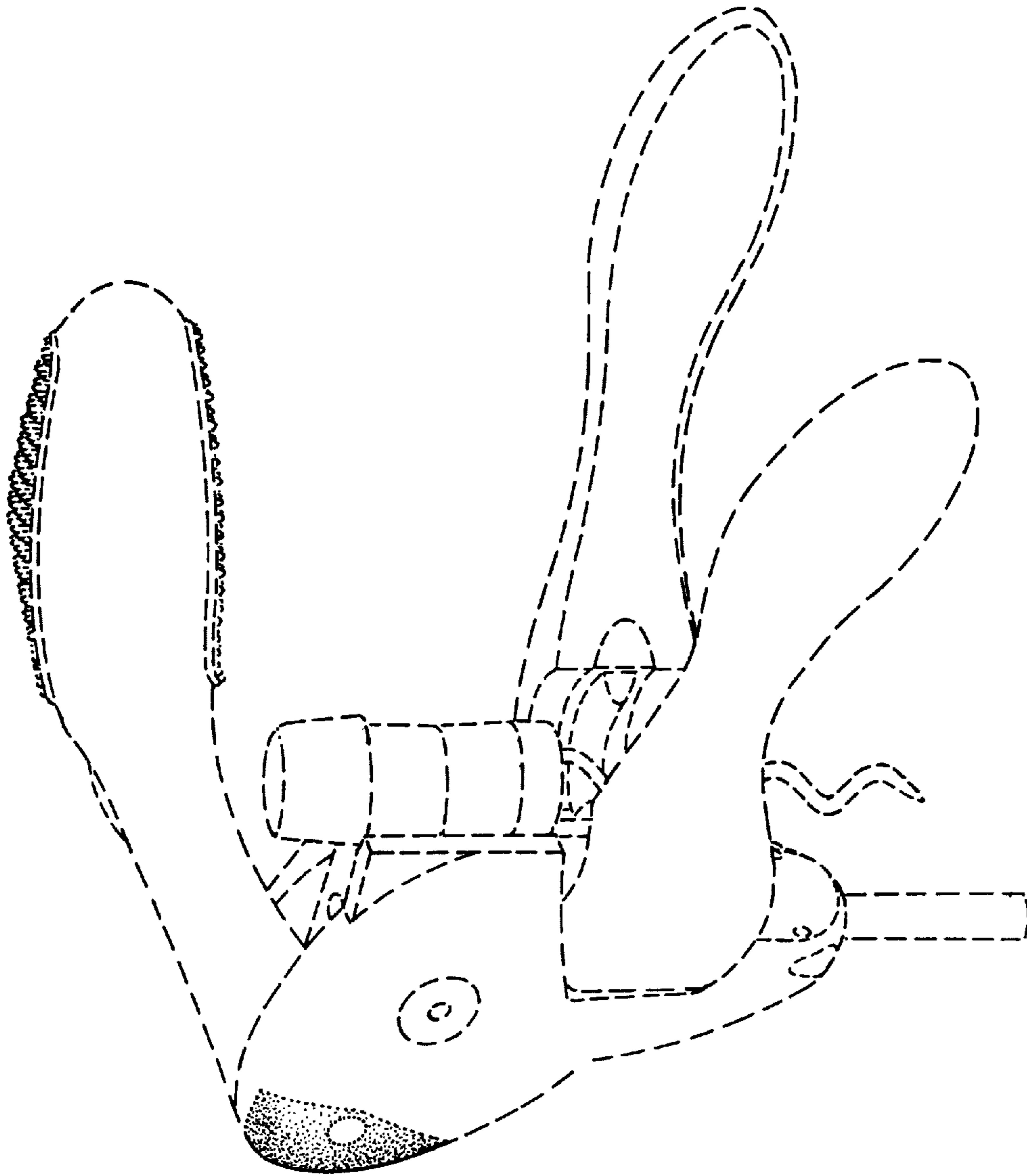

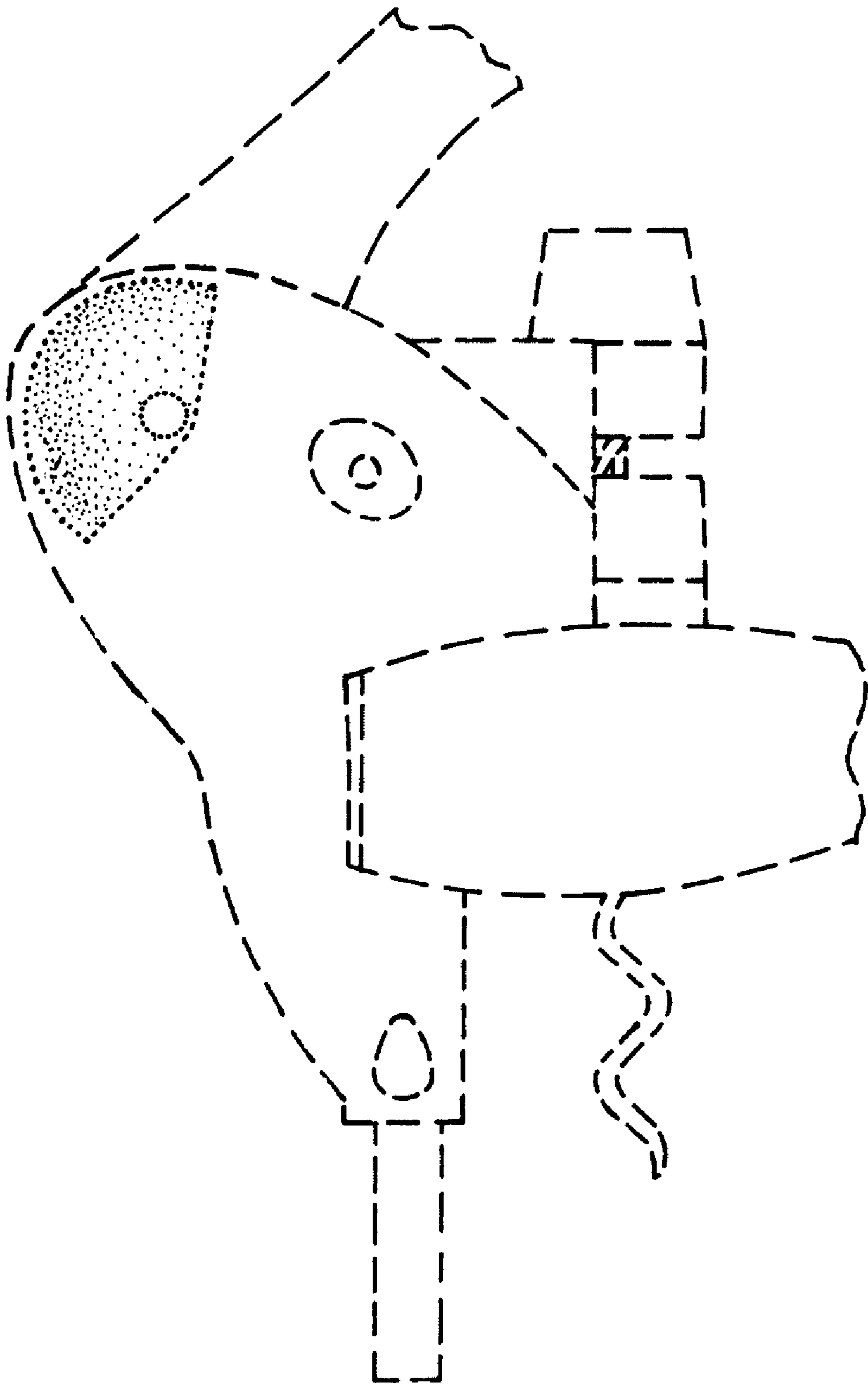

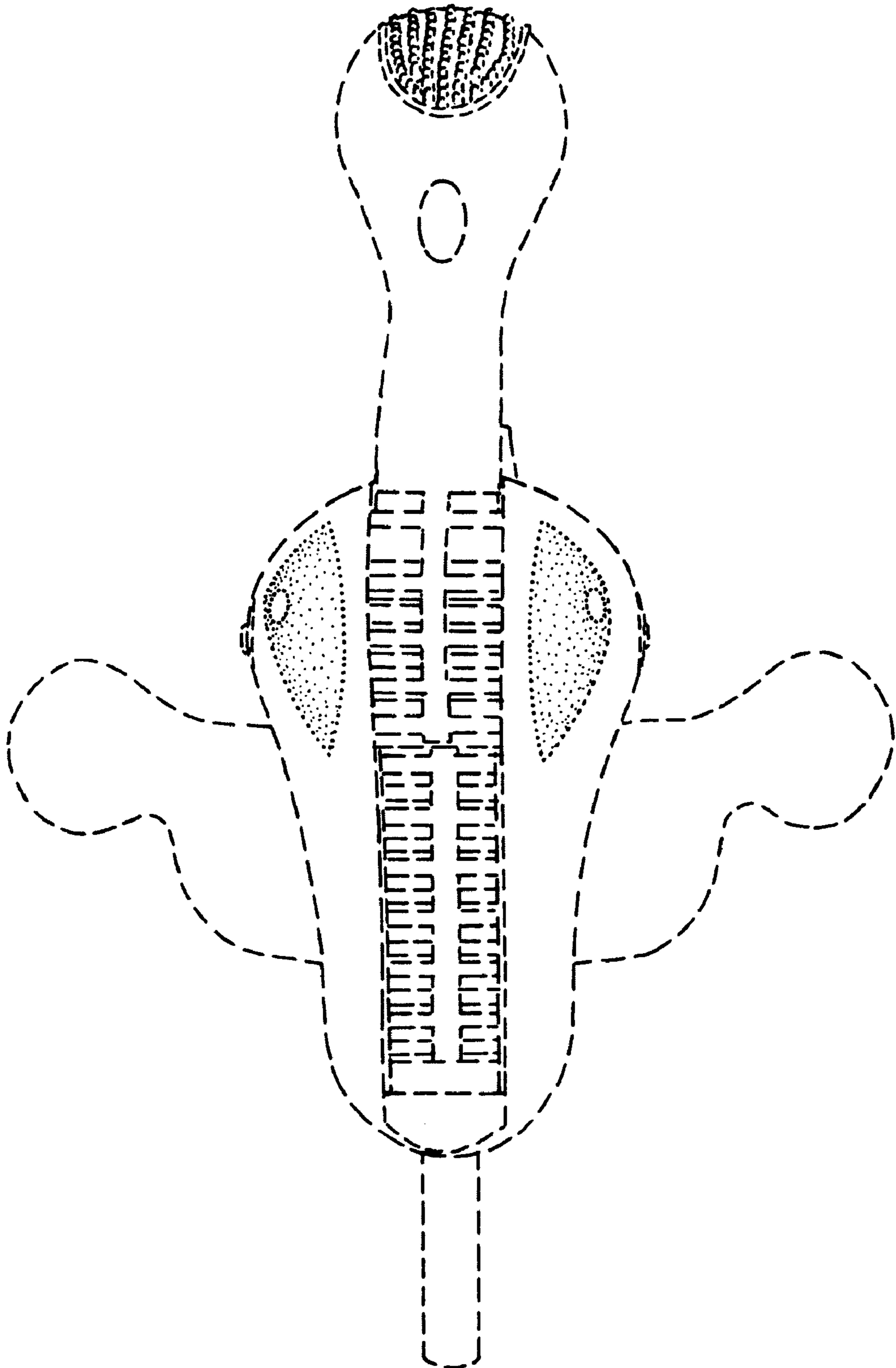

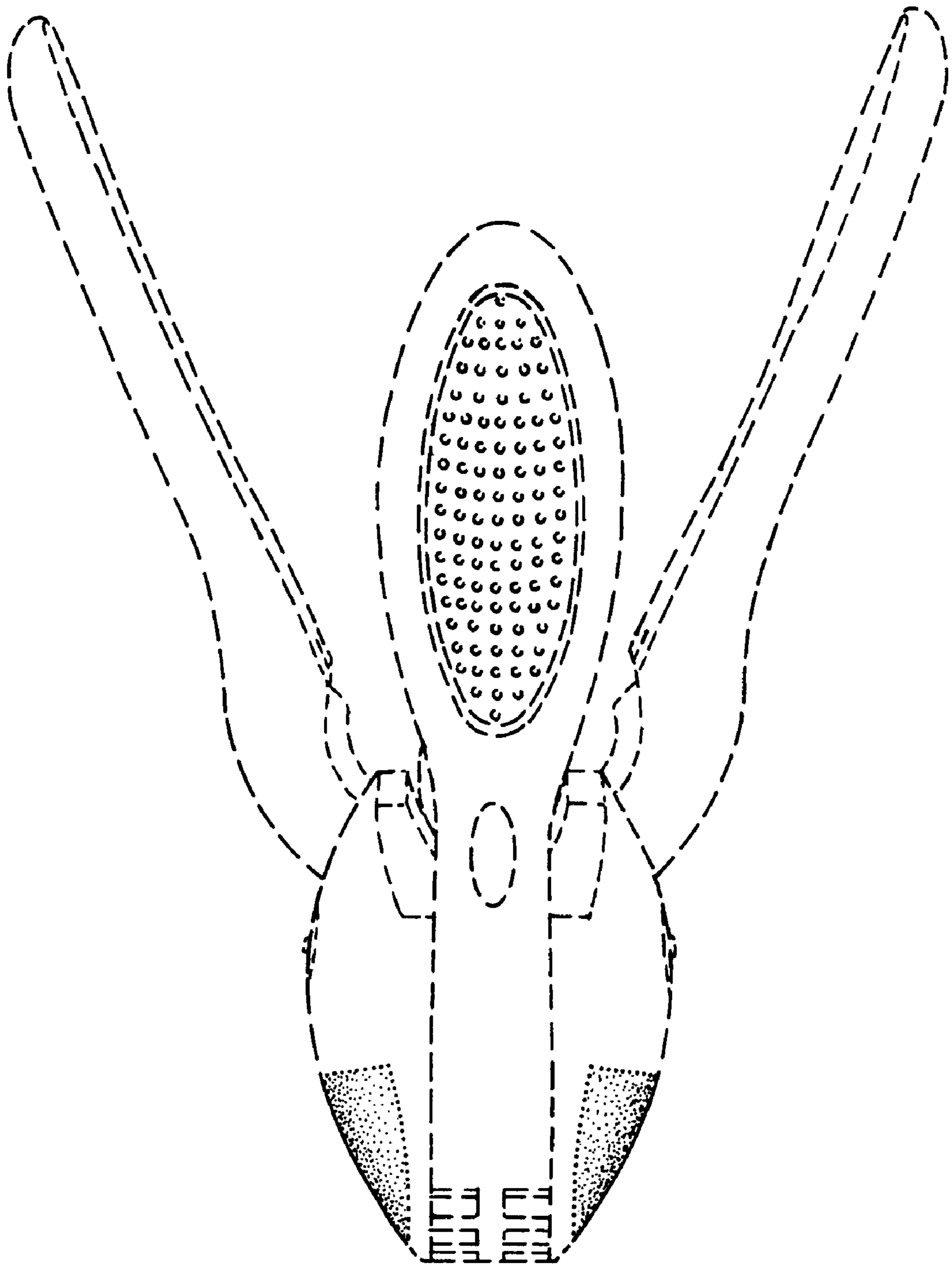
