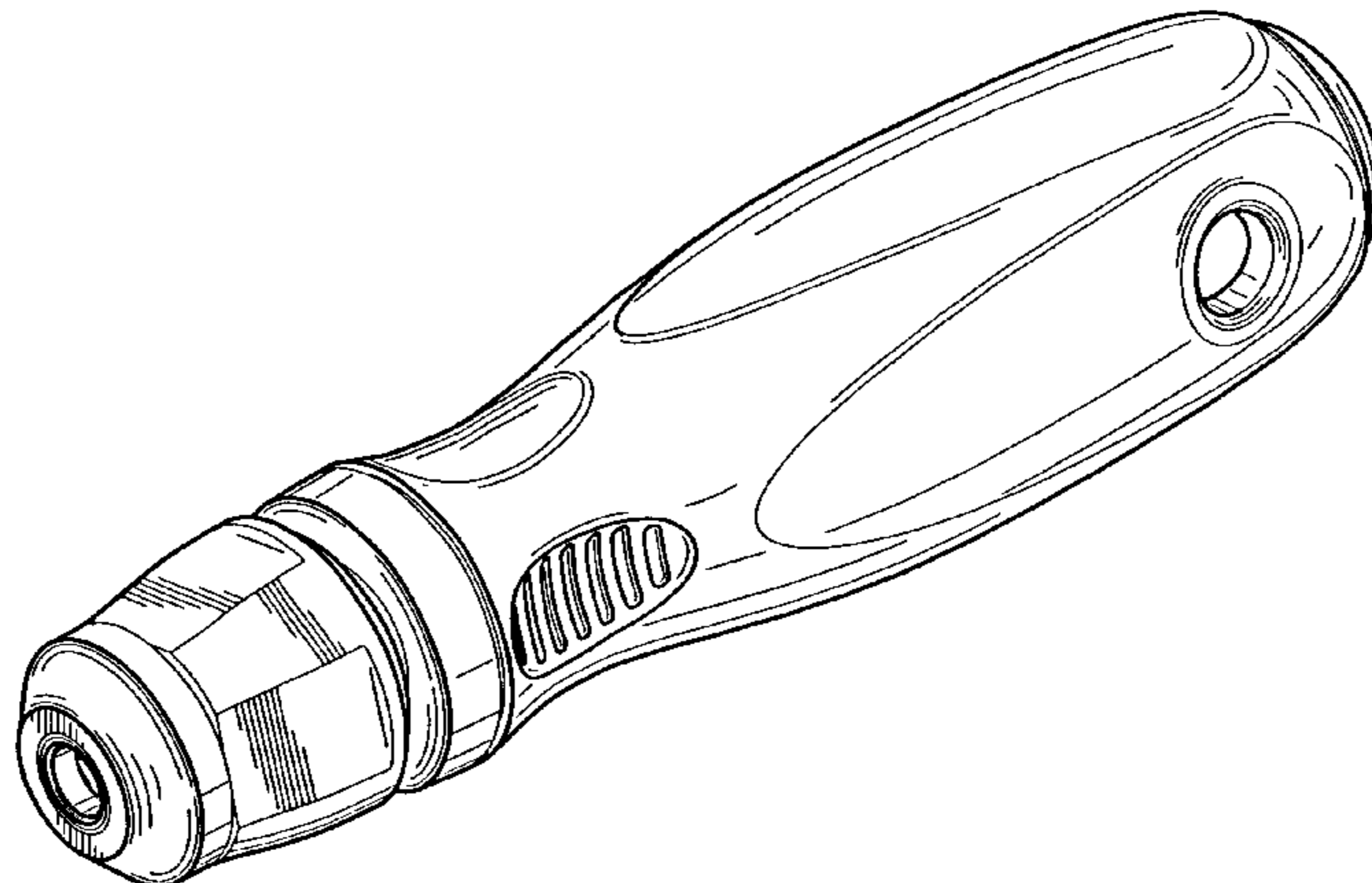
(57) **CLAIM**

The ornamental design for a hand held tool, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hand held tool; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a side view thereof, both side views are identical; FIG. 5 is a front view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a front perspective view of a second embodiment of a hand held tool; FIG. 8 is a top view thereof; FIG. 9 is a bottom view thereof; FIG. 10 is a side view thereof, both side views are identical; FIG. 11 is a front view thereof; and, FIG. 12 is a rear view thereof.

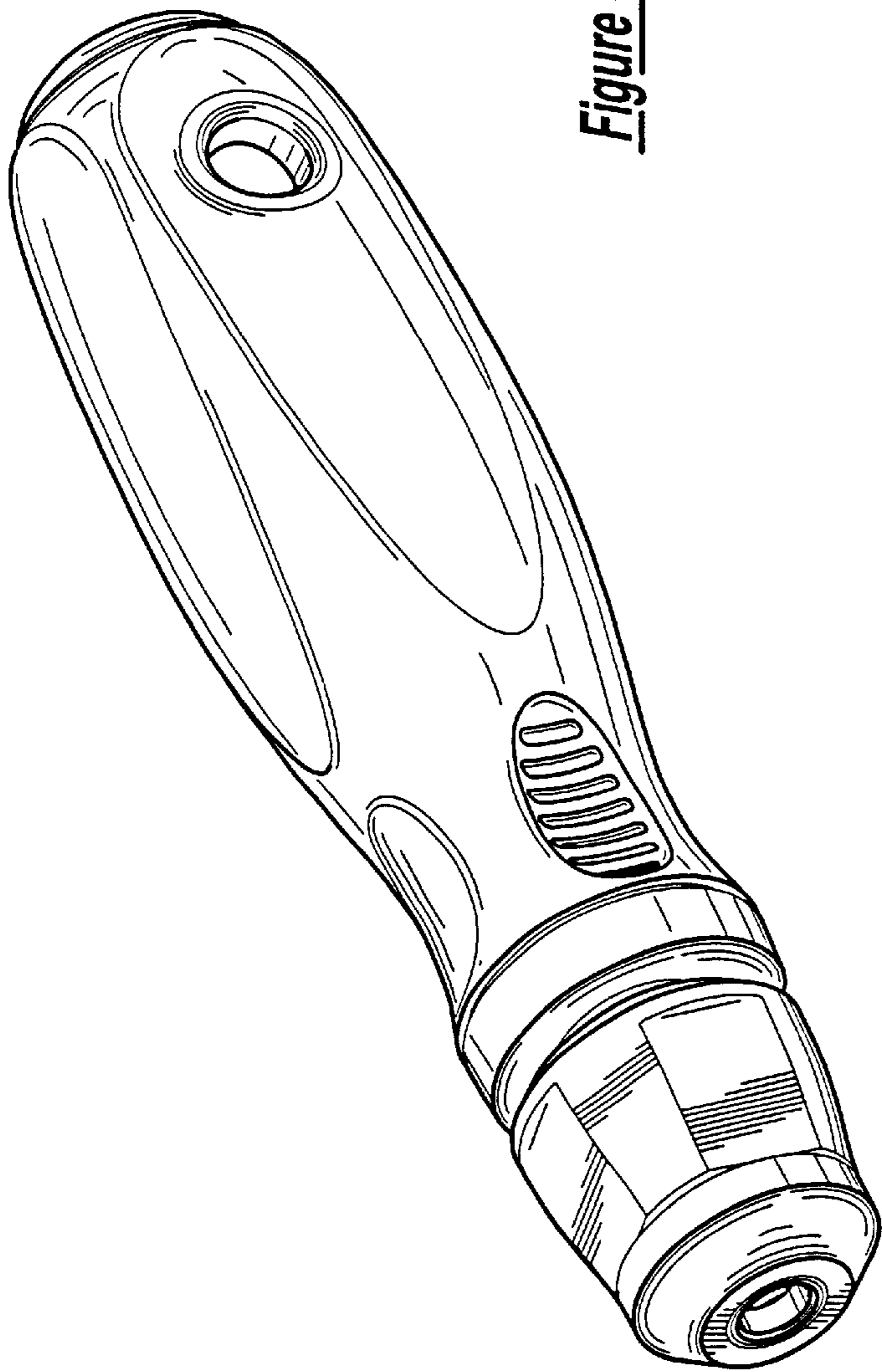

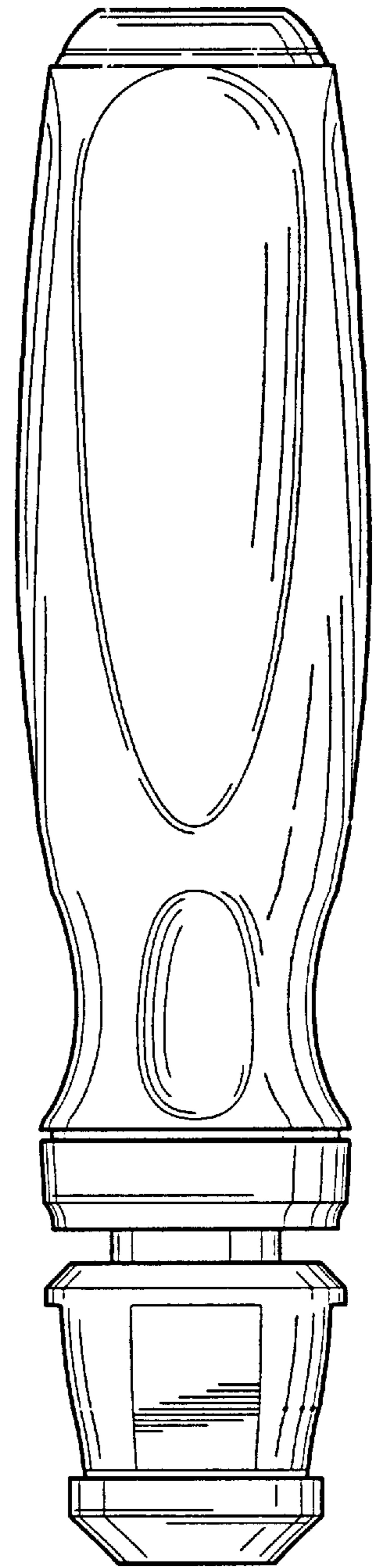

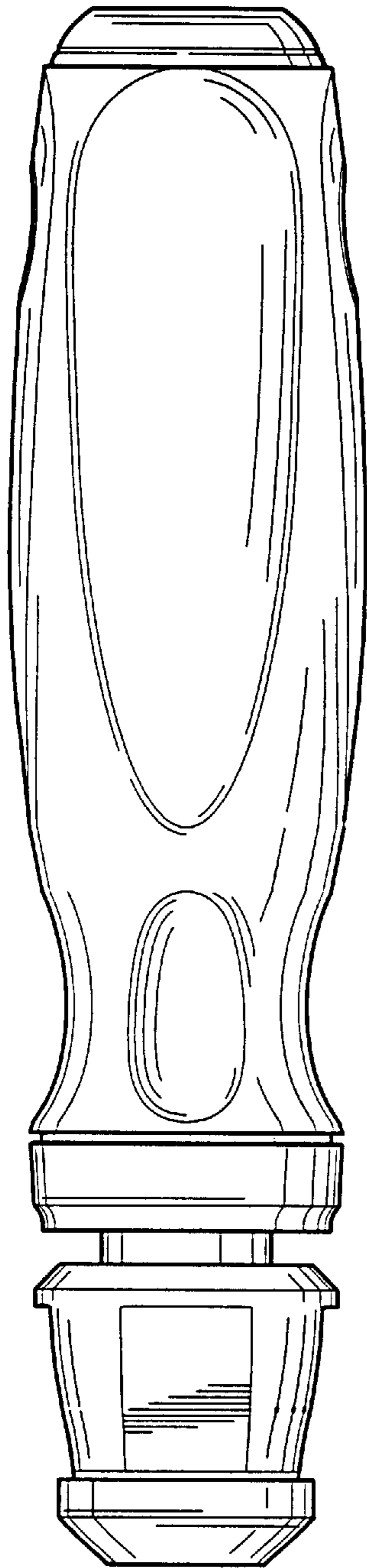

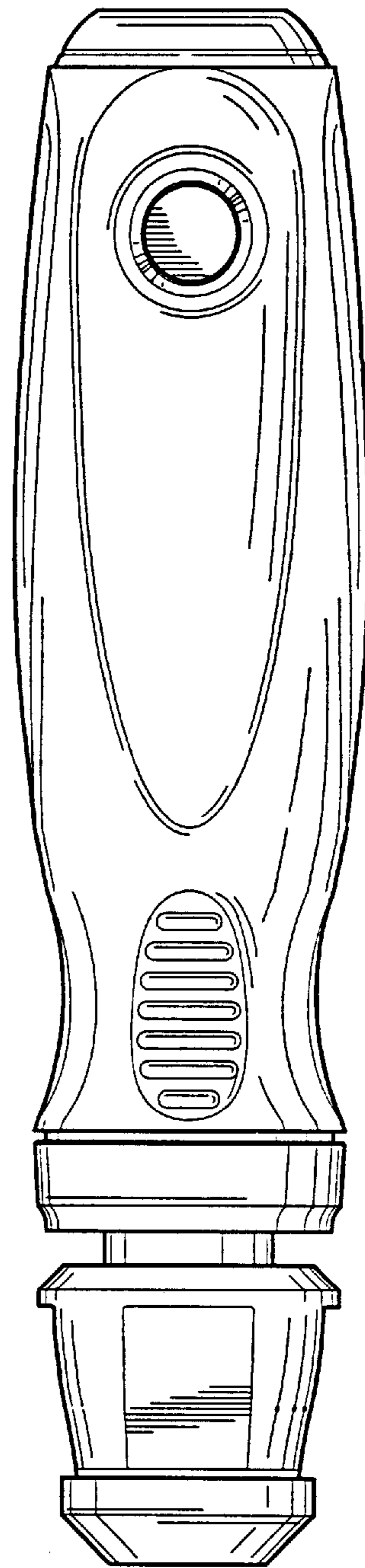

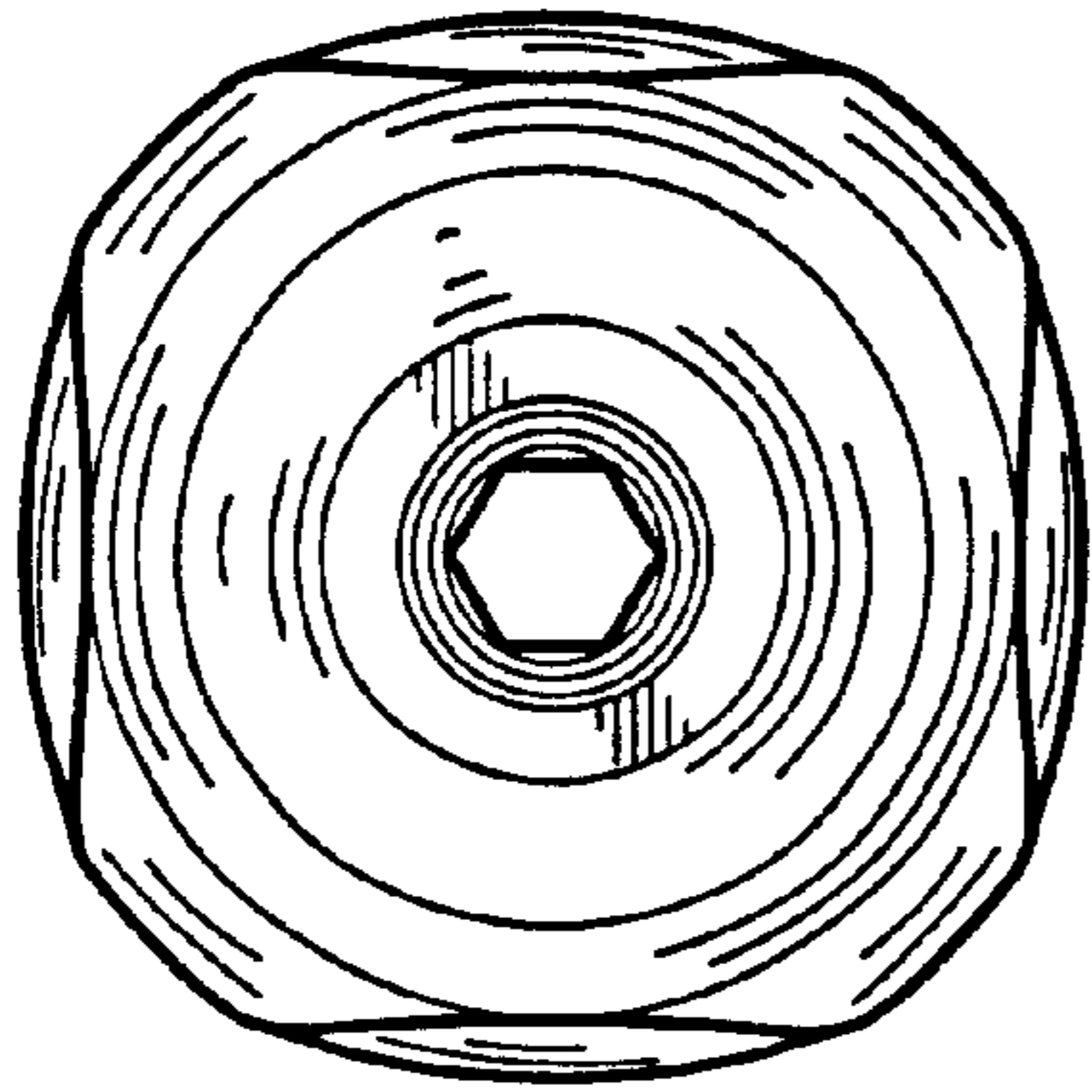

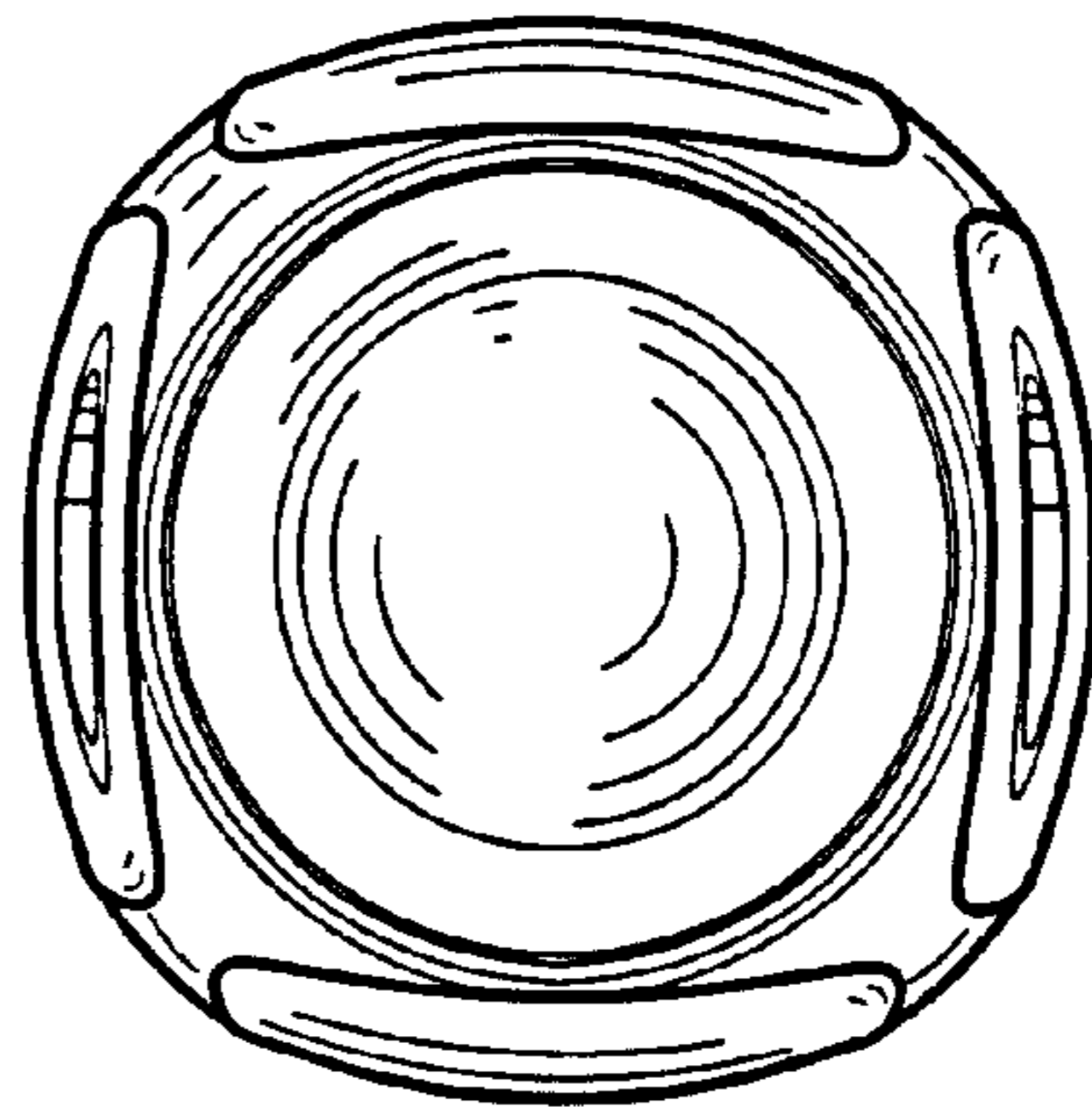

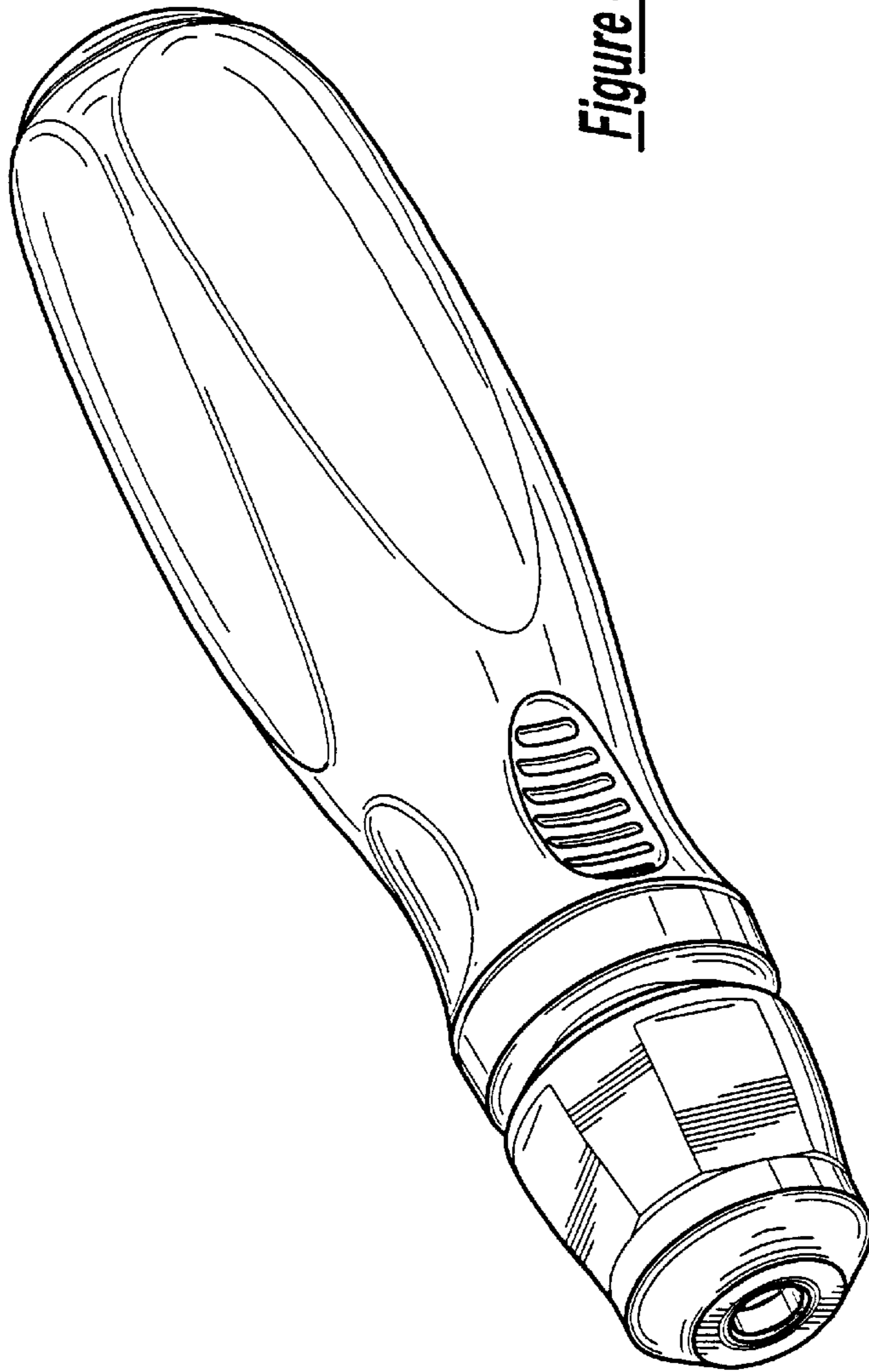

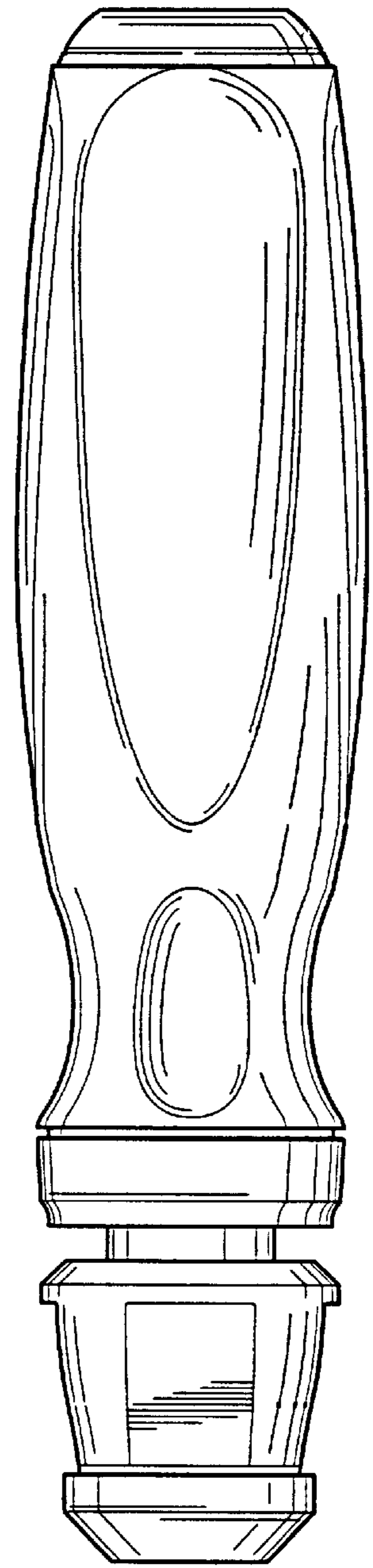

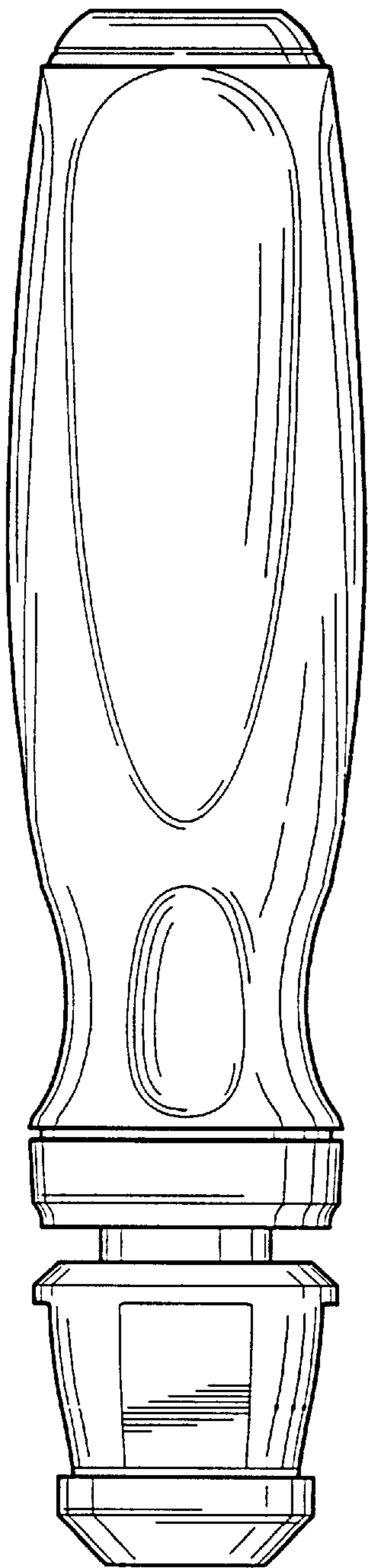

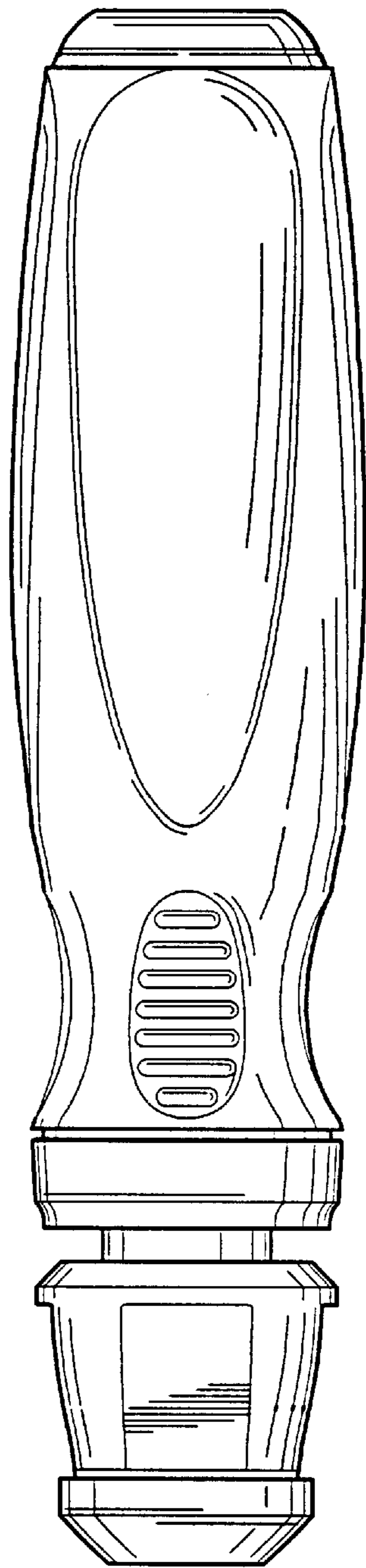

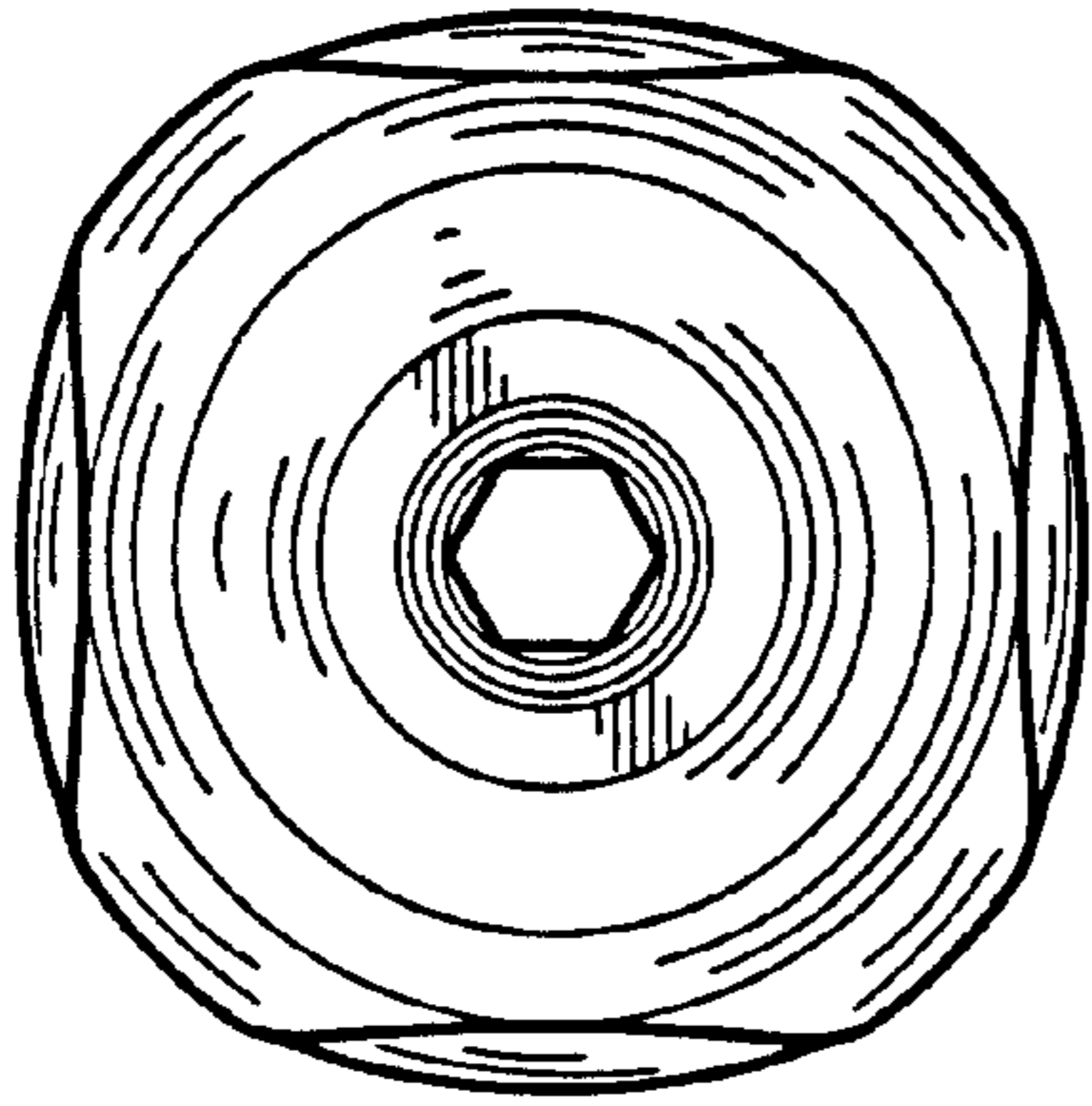

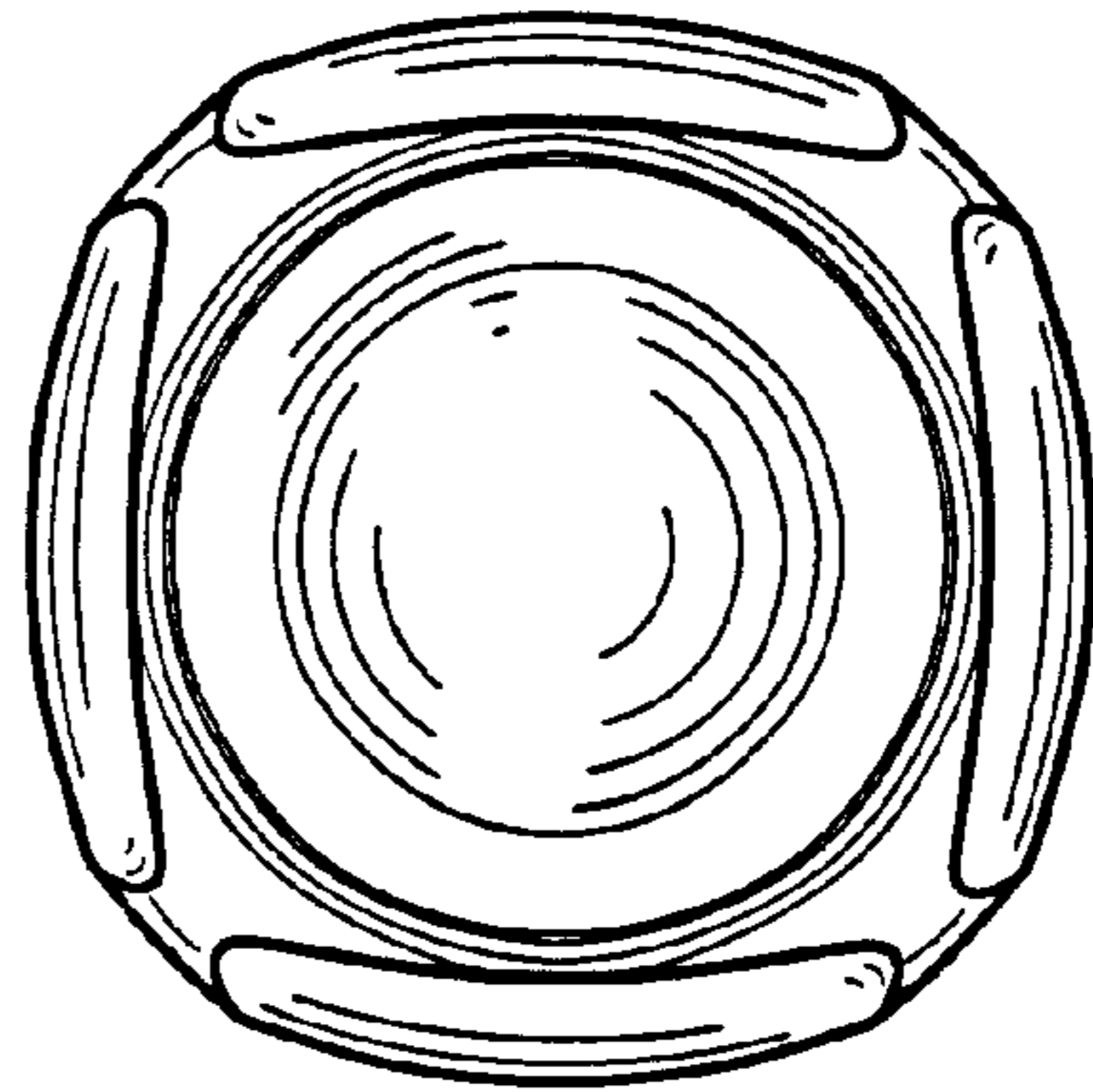
