FIG. 13 is a rear elevational view thereof; and,

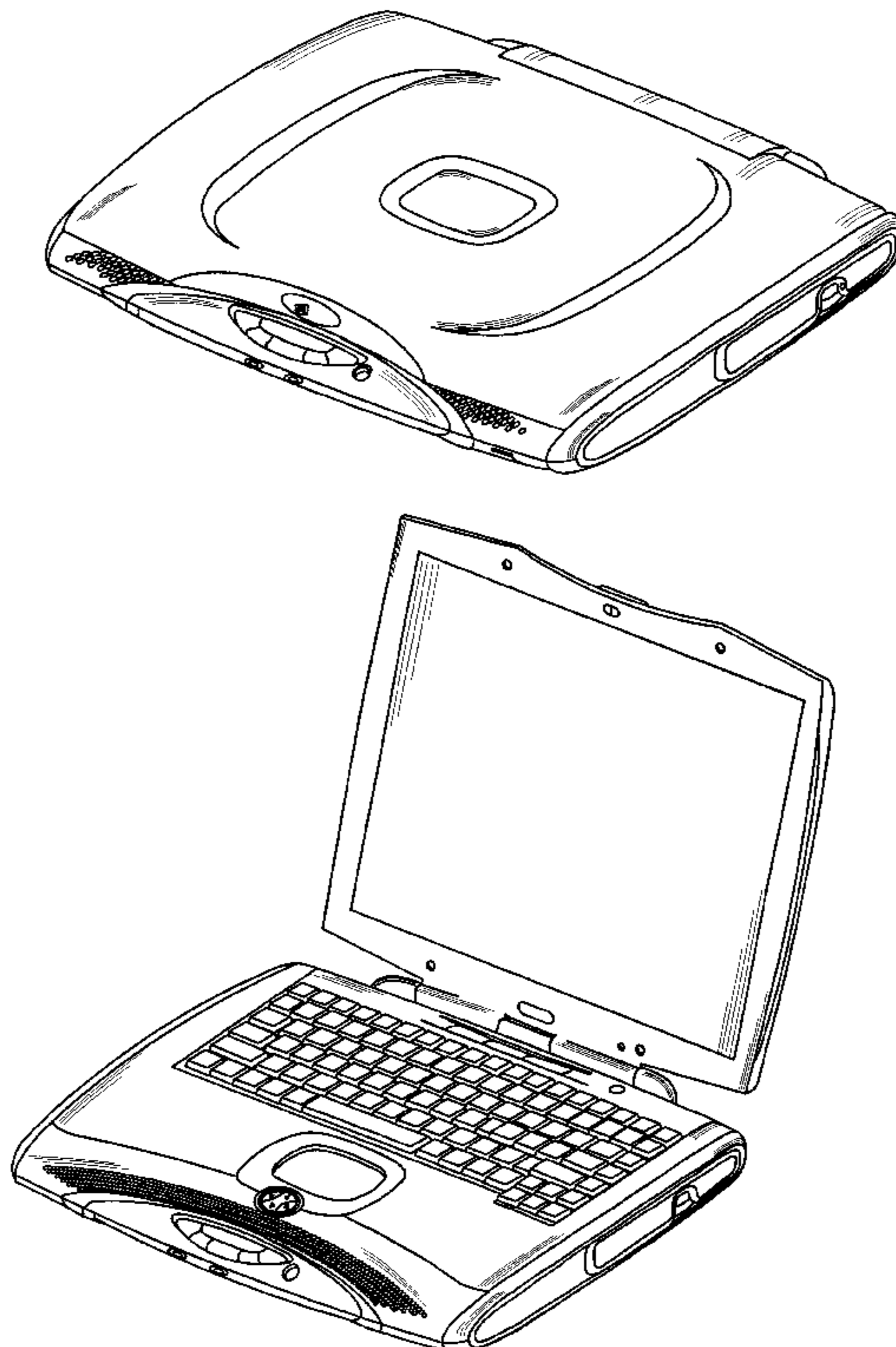
FIG. 14 is a bottom view thereof.

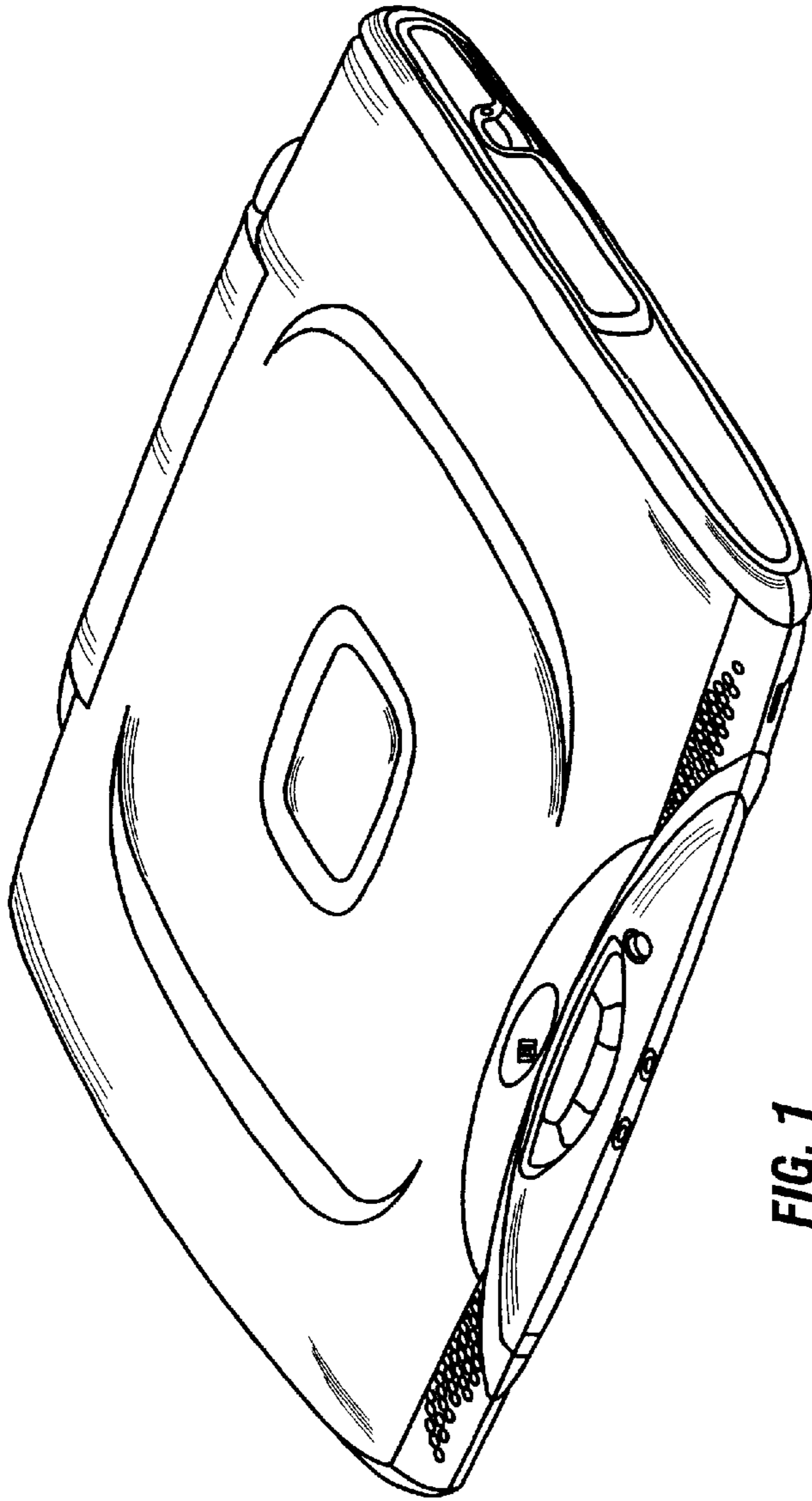

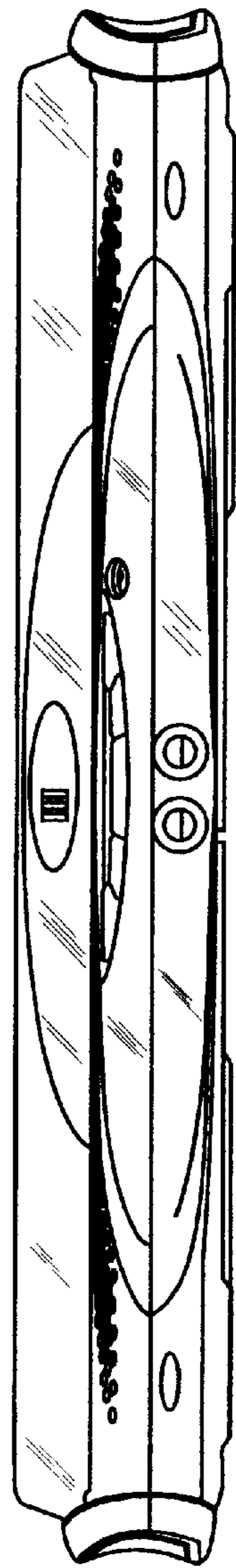

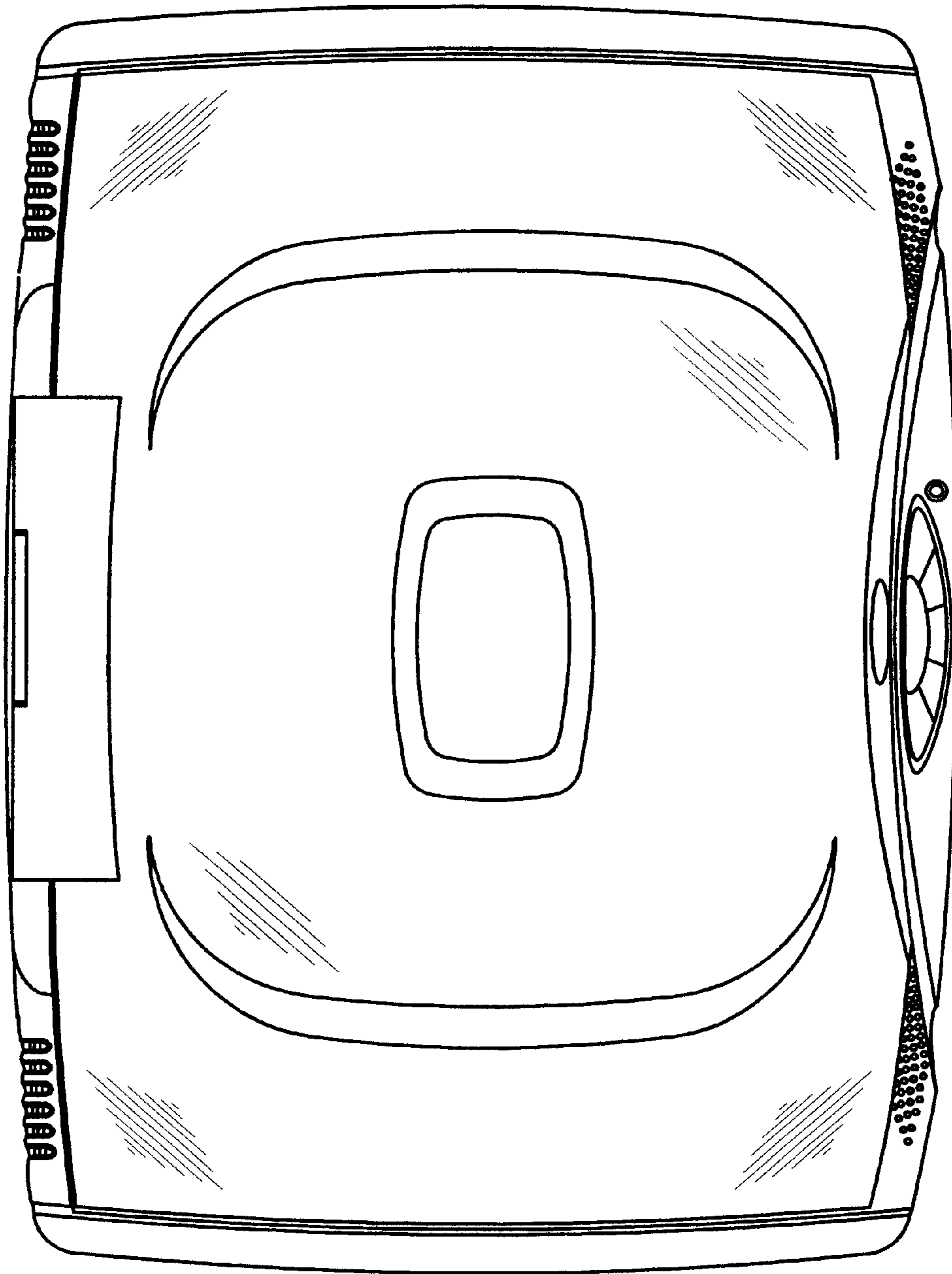

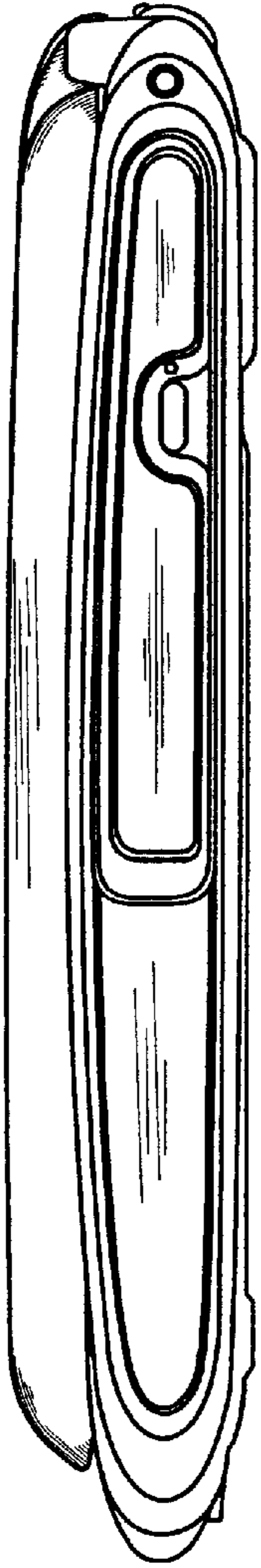

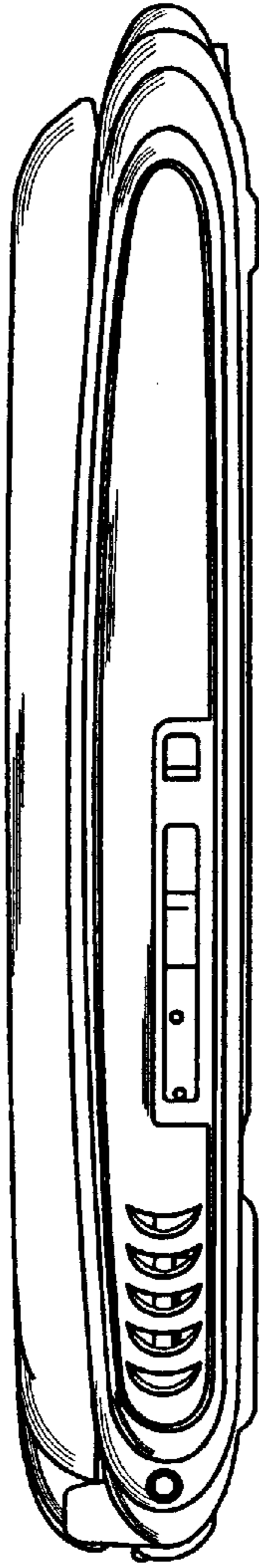

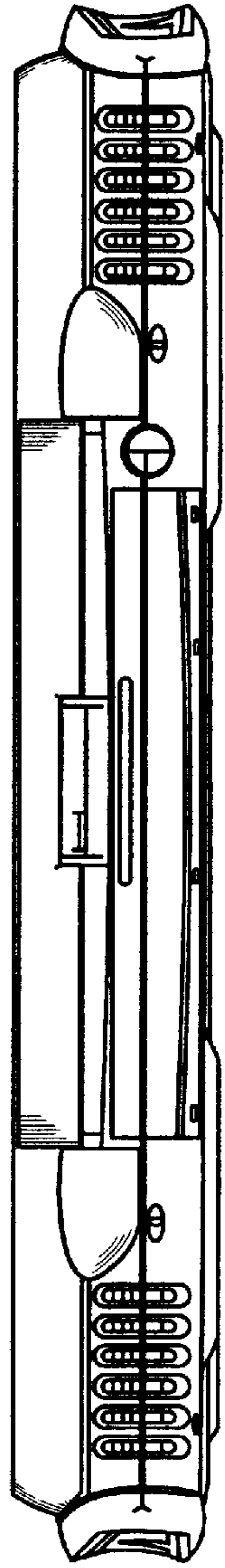

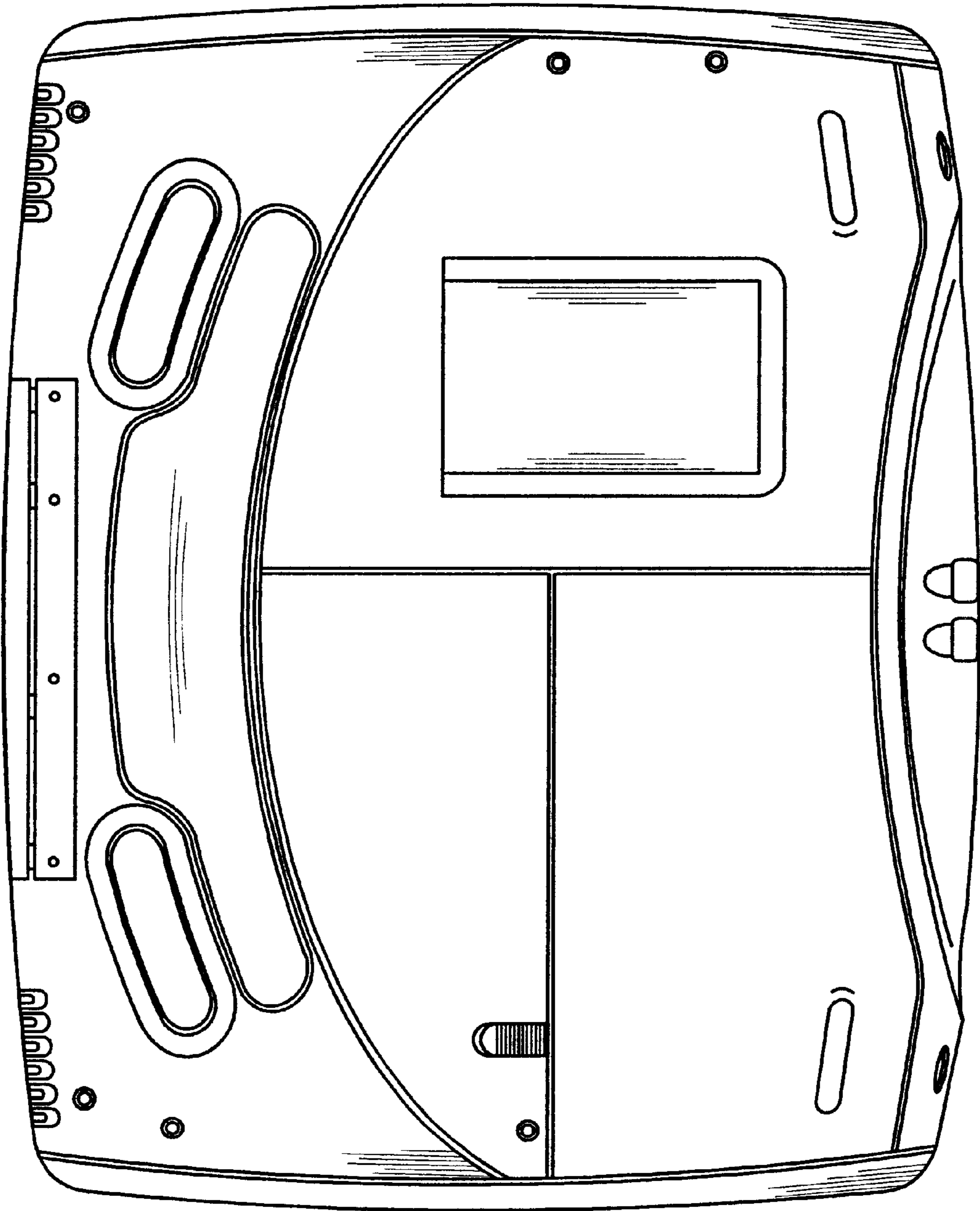

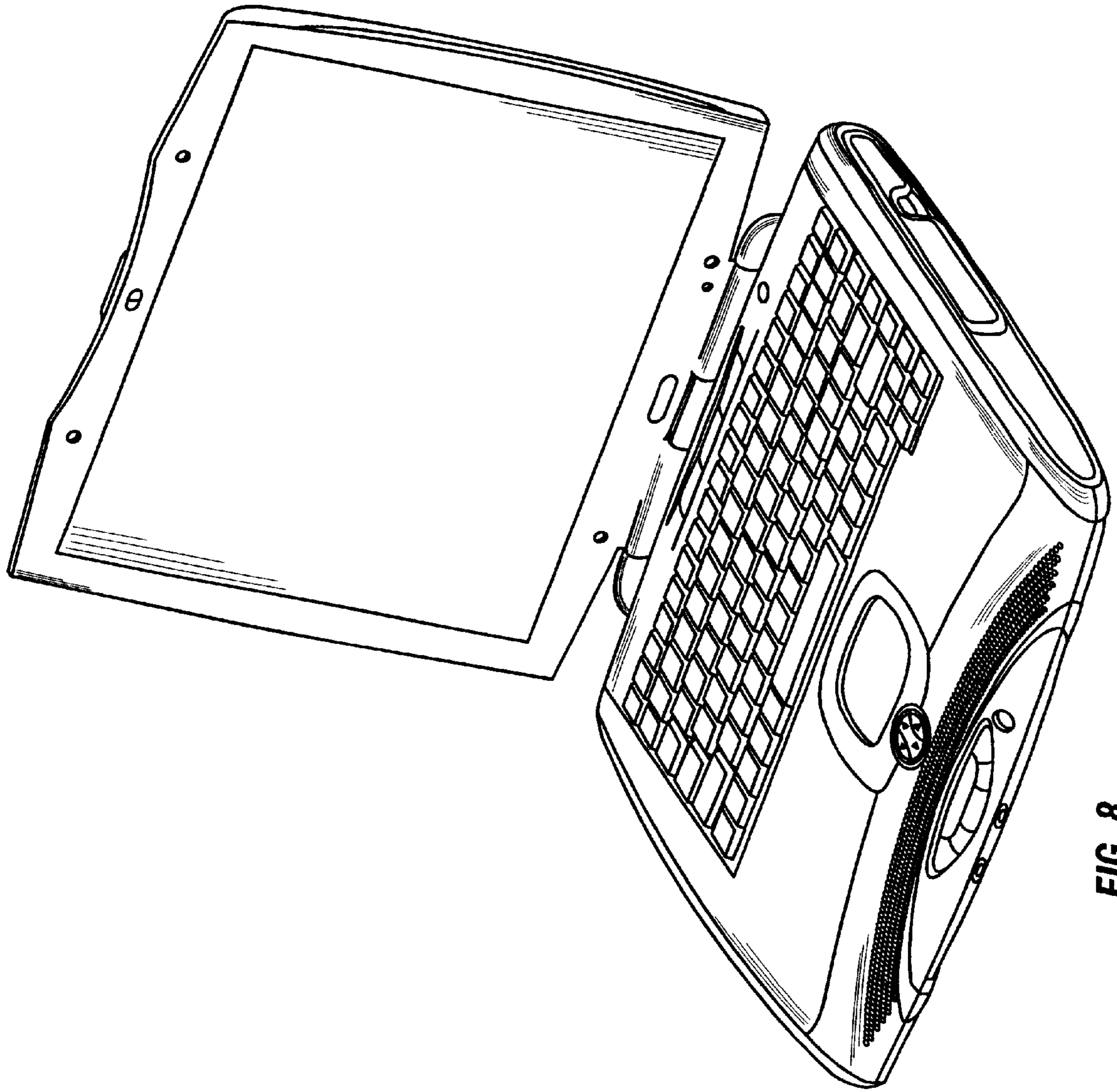

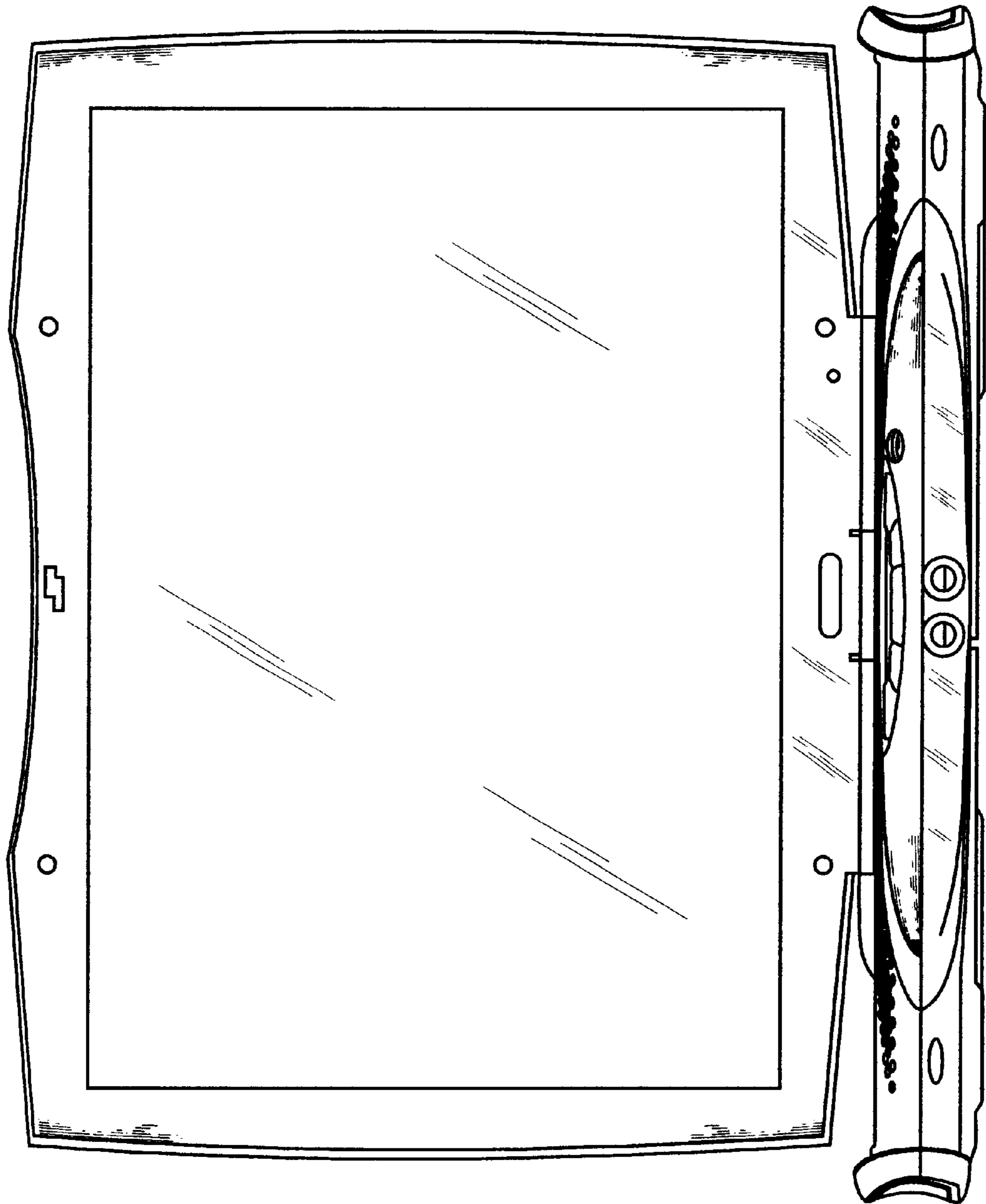

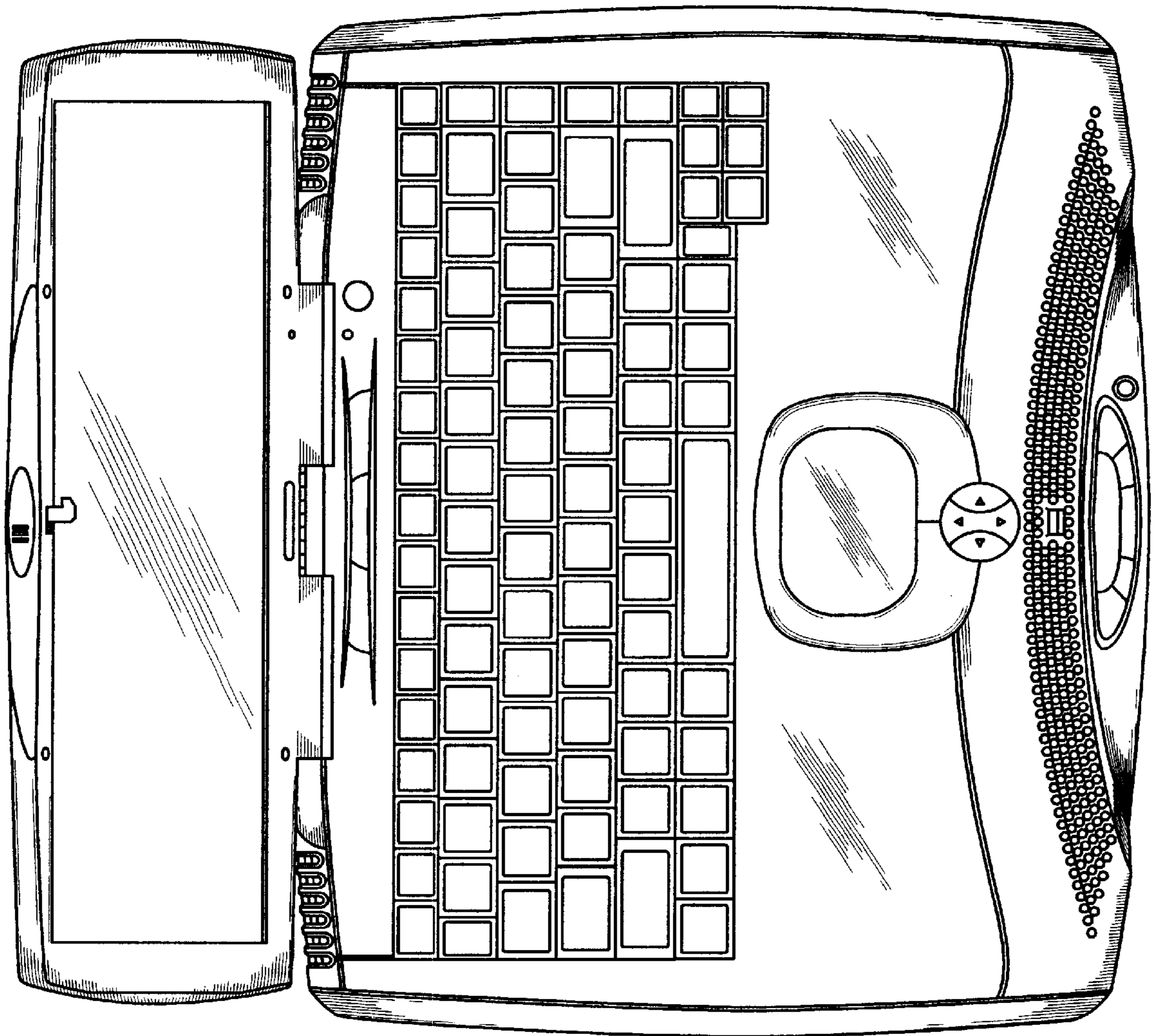

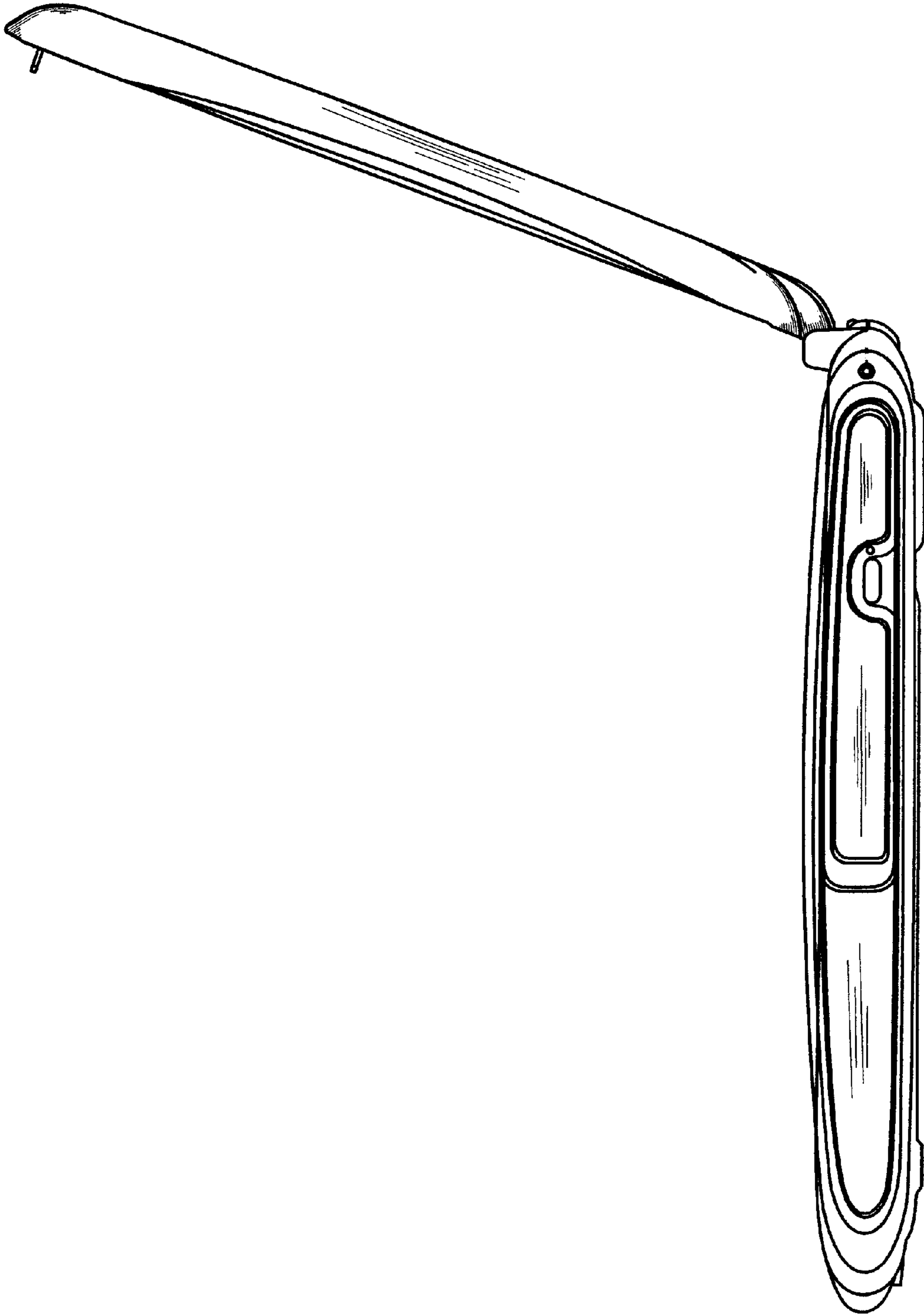

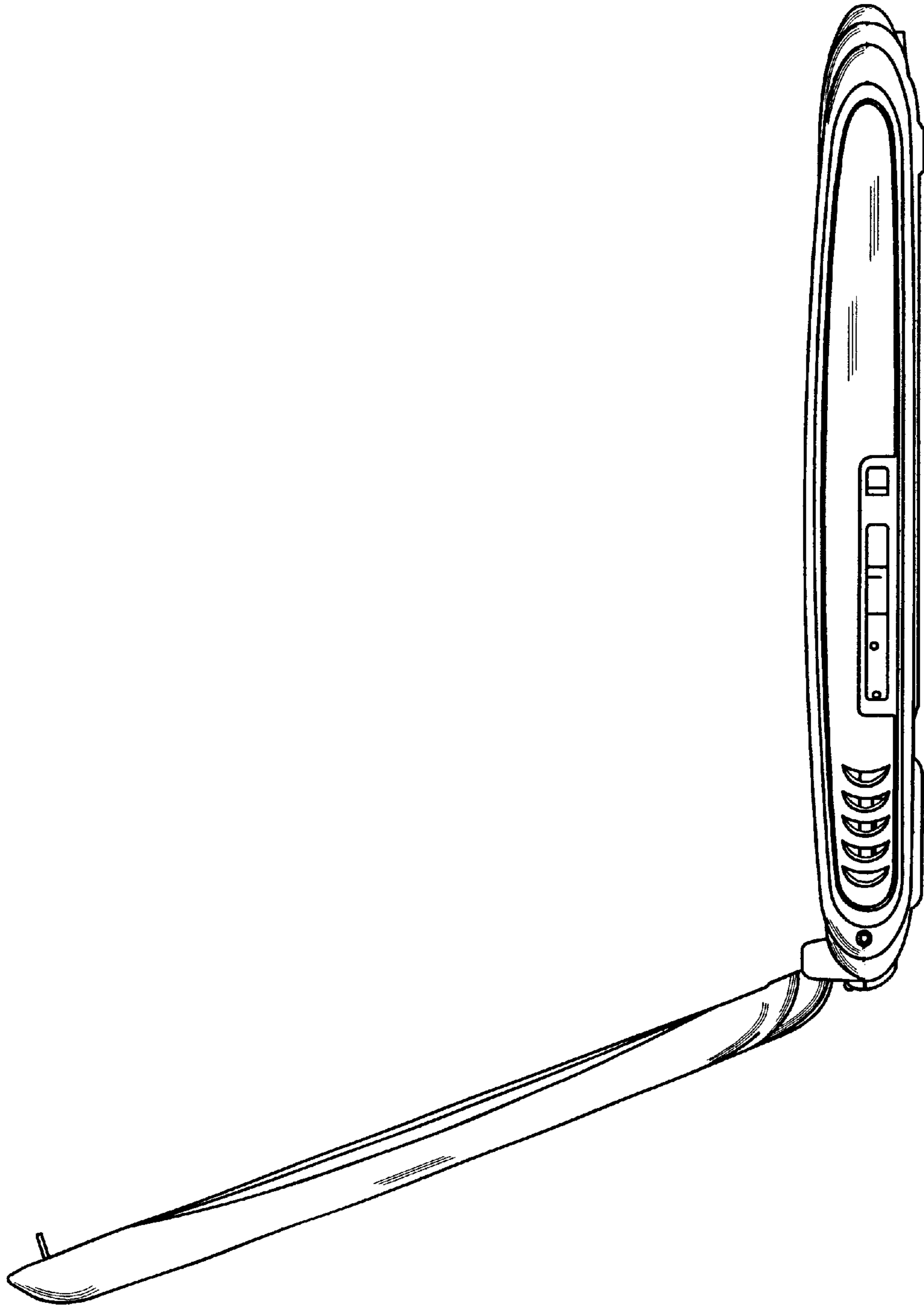

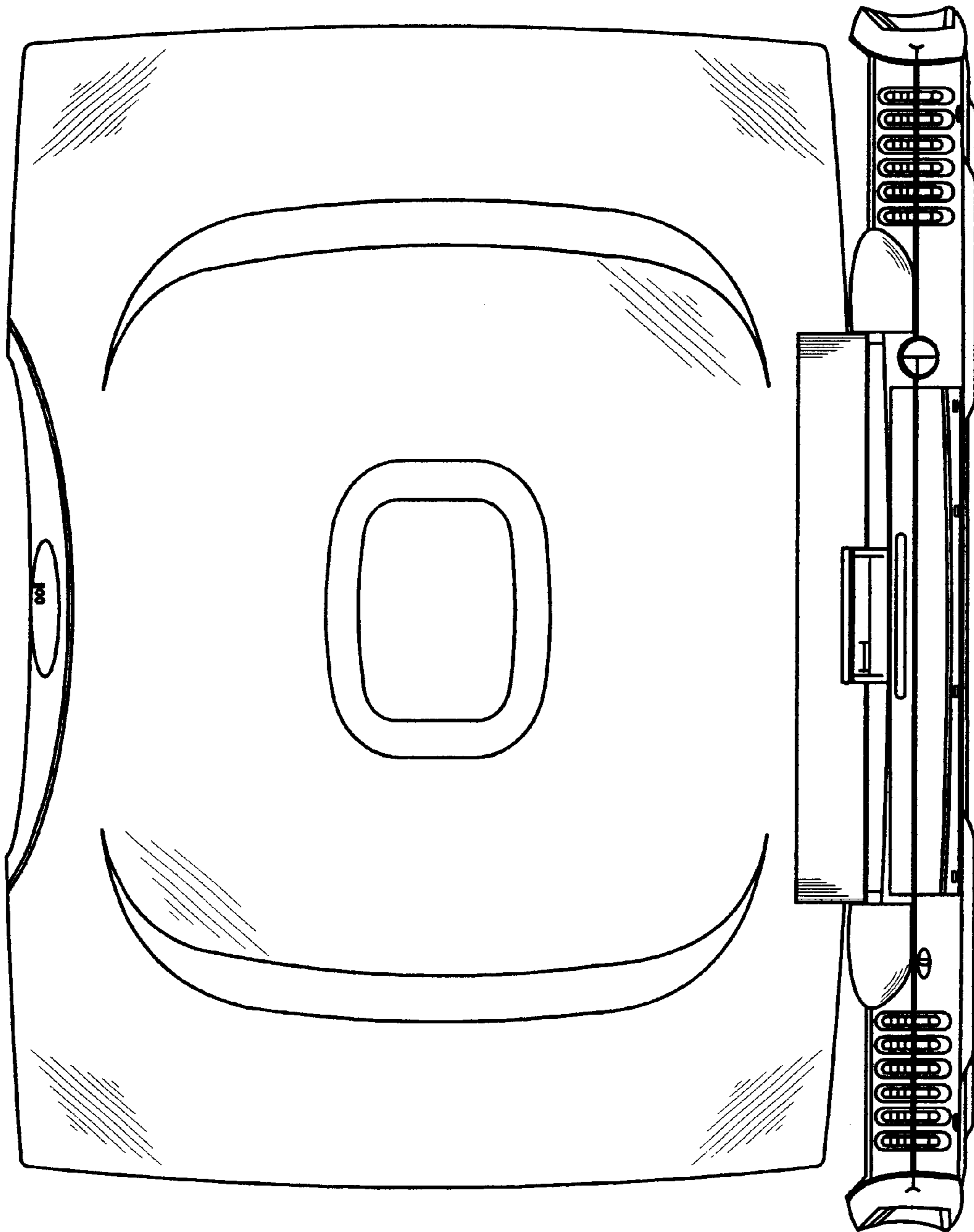

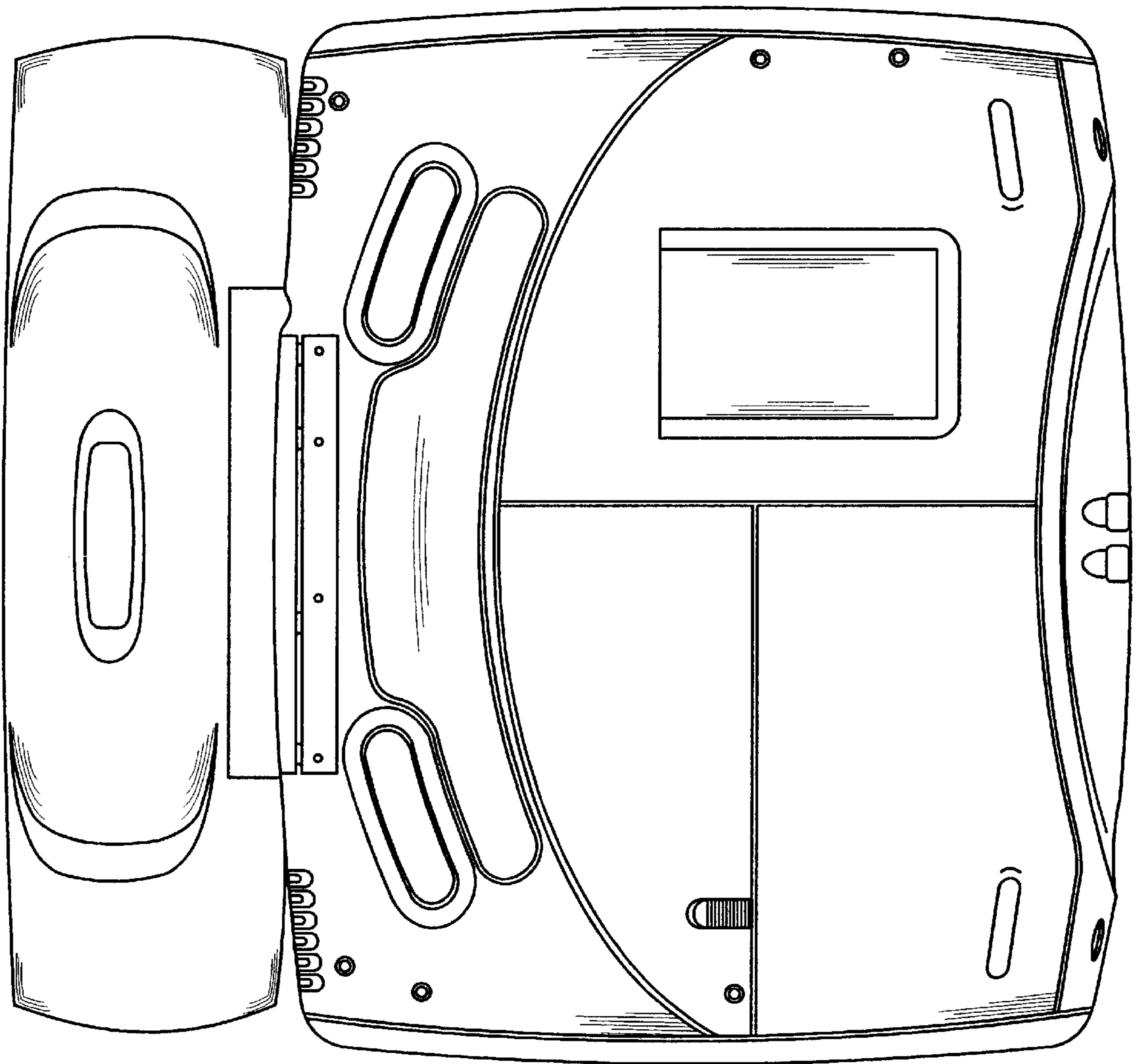
