(57) **CLAIM**

We claim the ornamental design for a skate frame, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom view of a skate frame, showing our new design;

FIG. 2 is a right side view thereof, the left side being a mirror image of the right side;

FIG. 3 is a top view thereof;

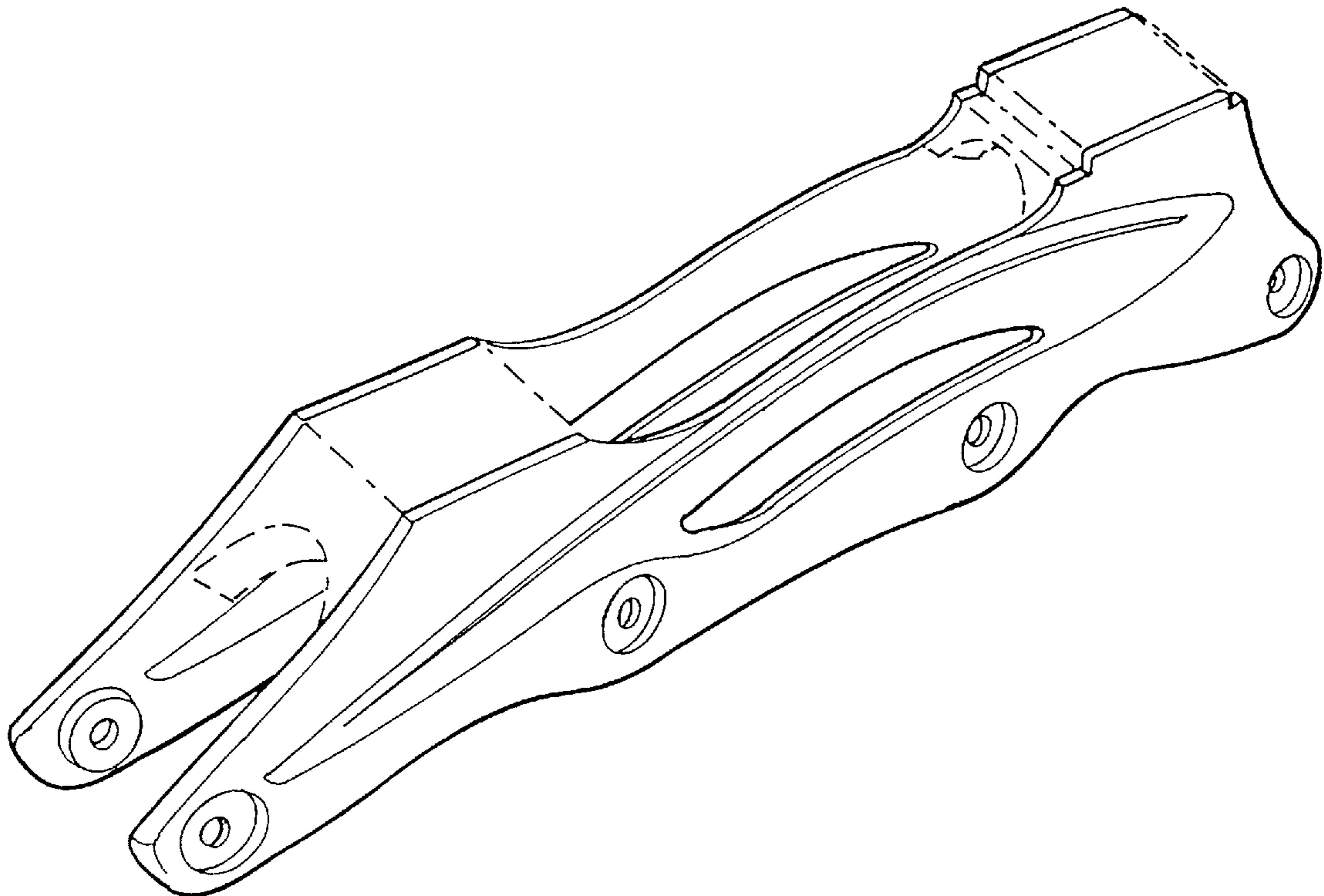
FIG. 4 is a rear end view thereof;

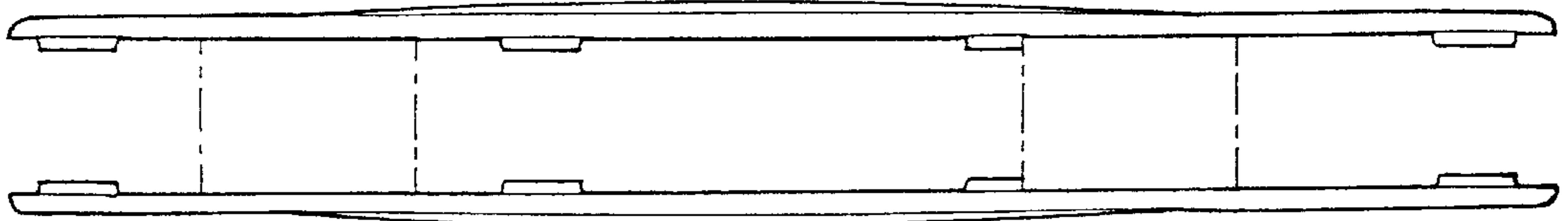

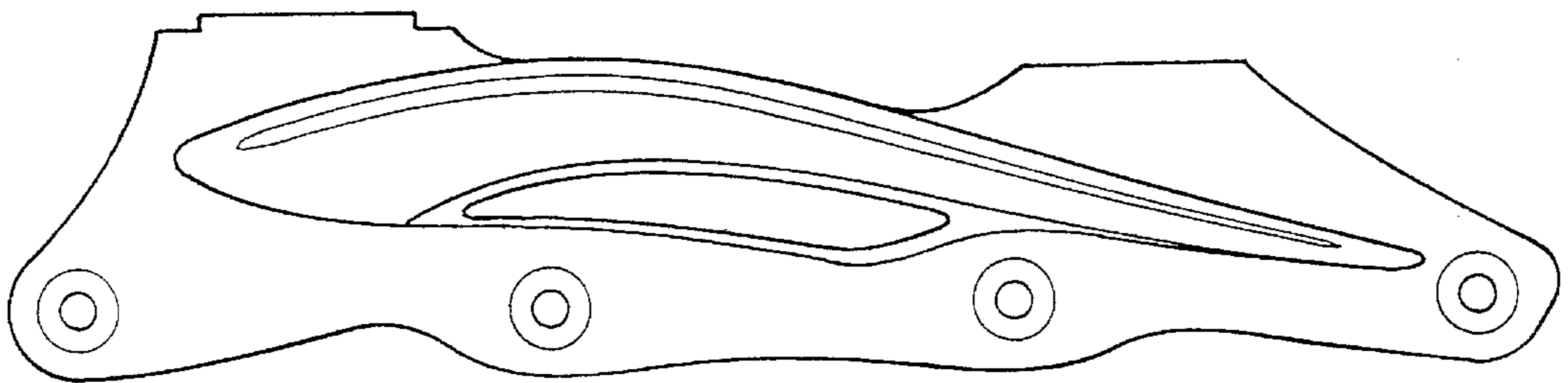

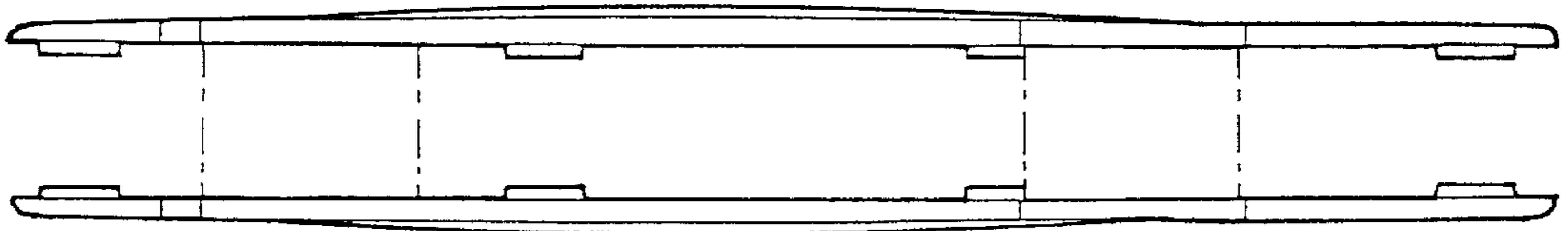

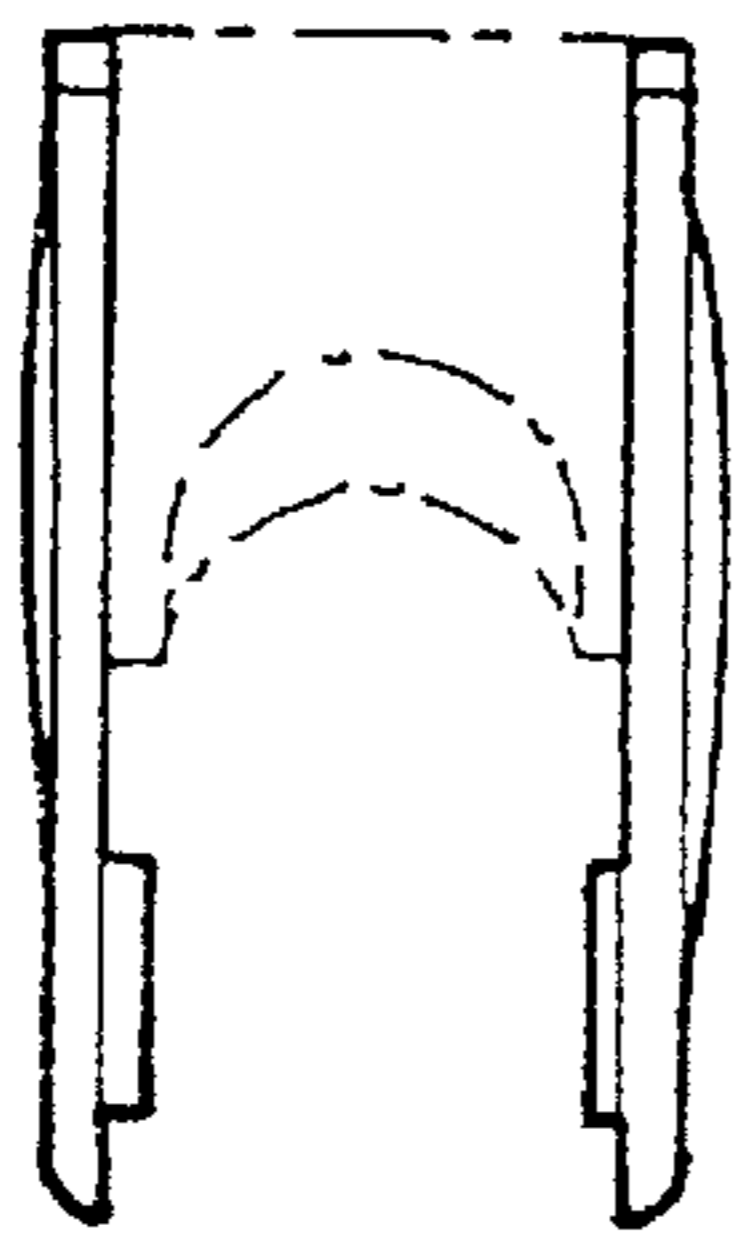

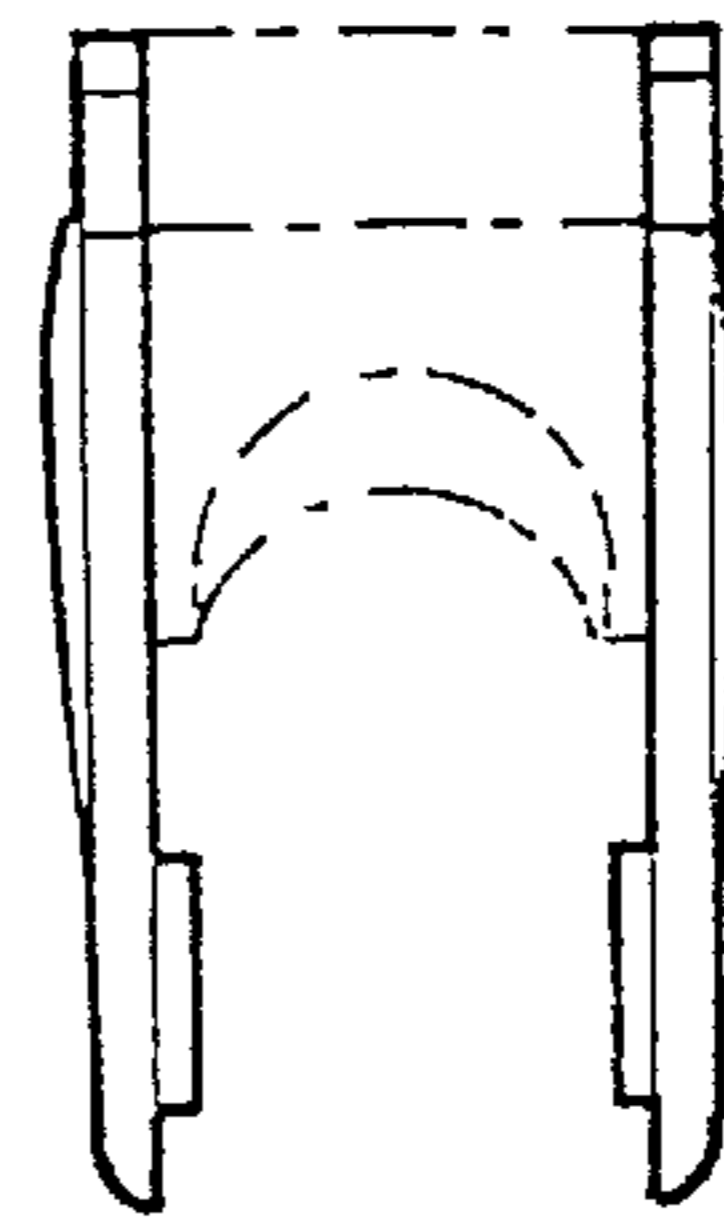

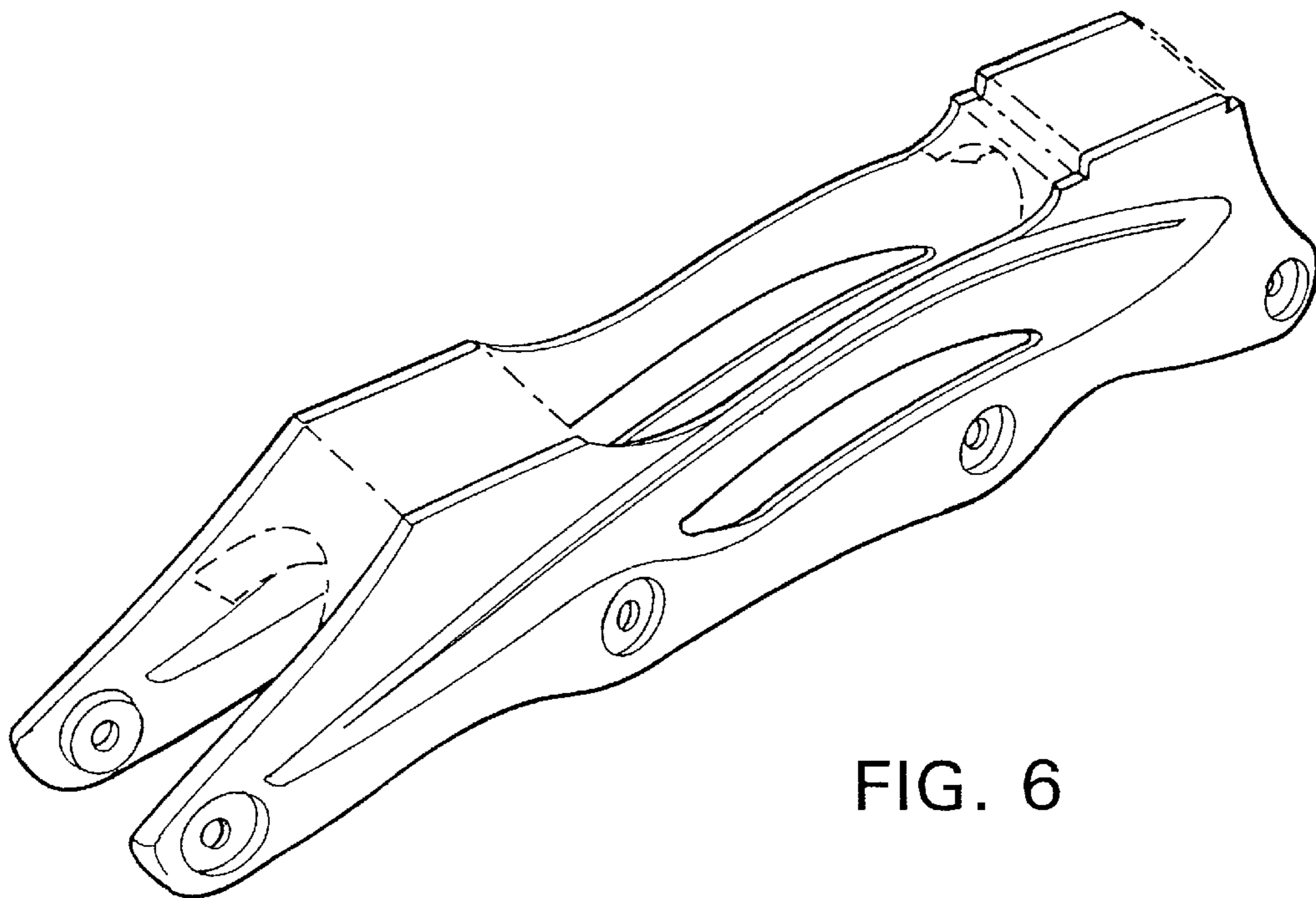
