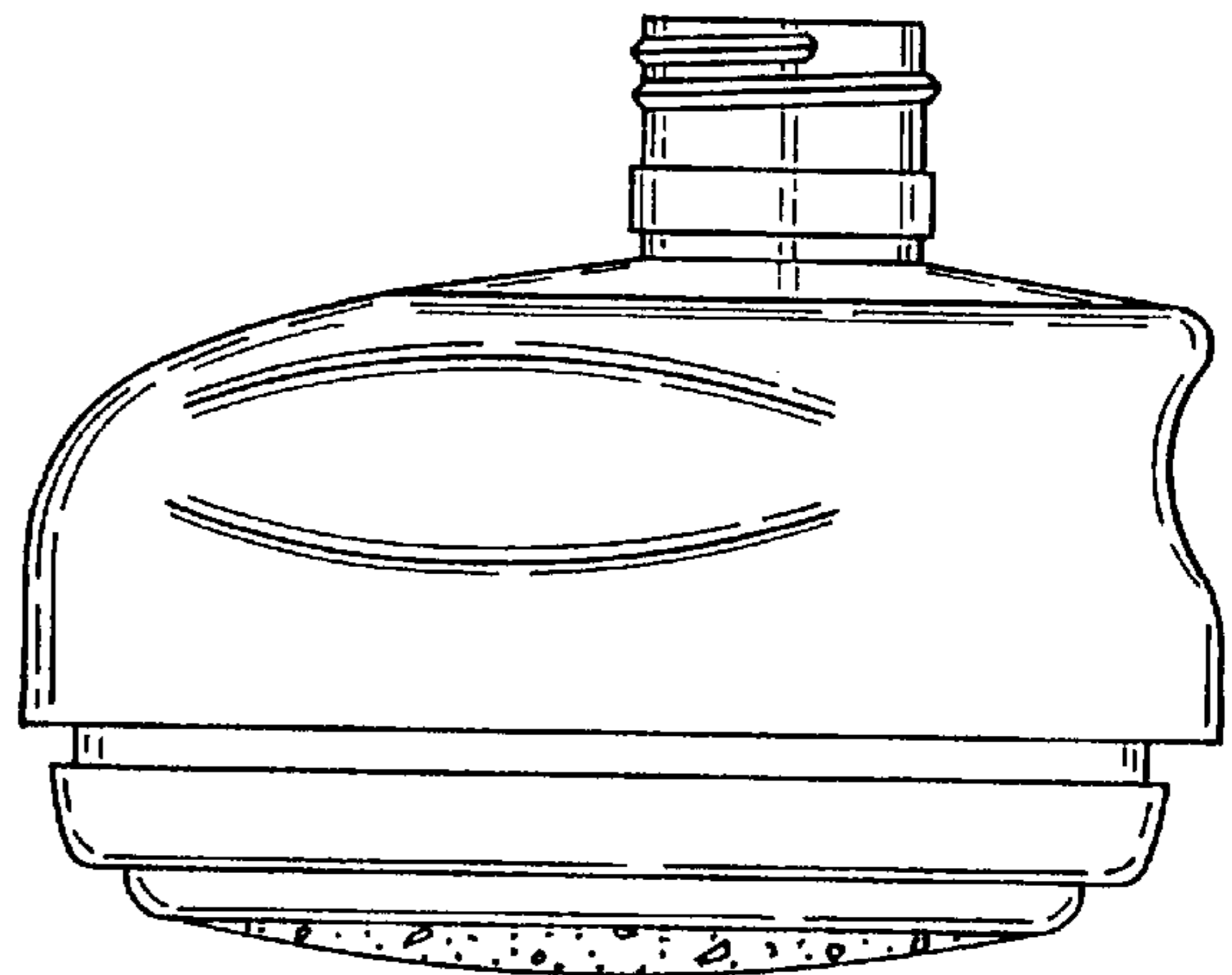
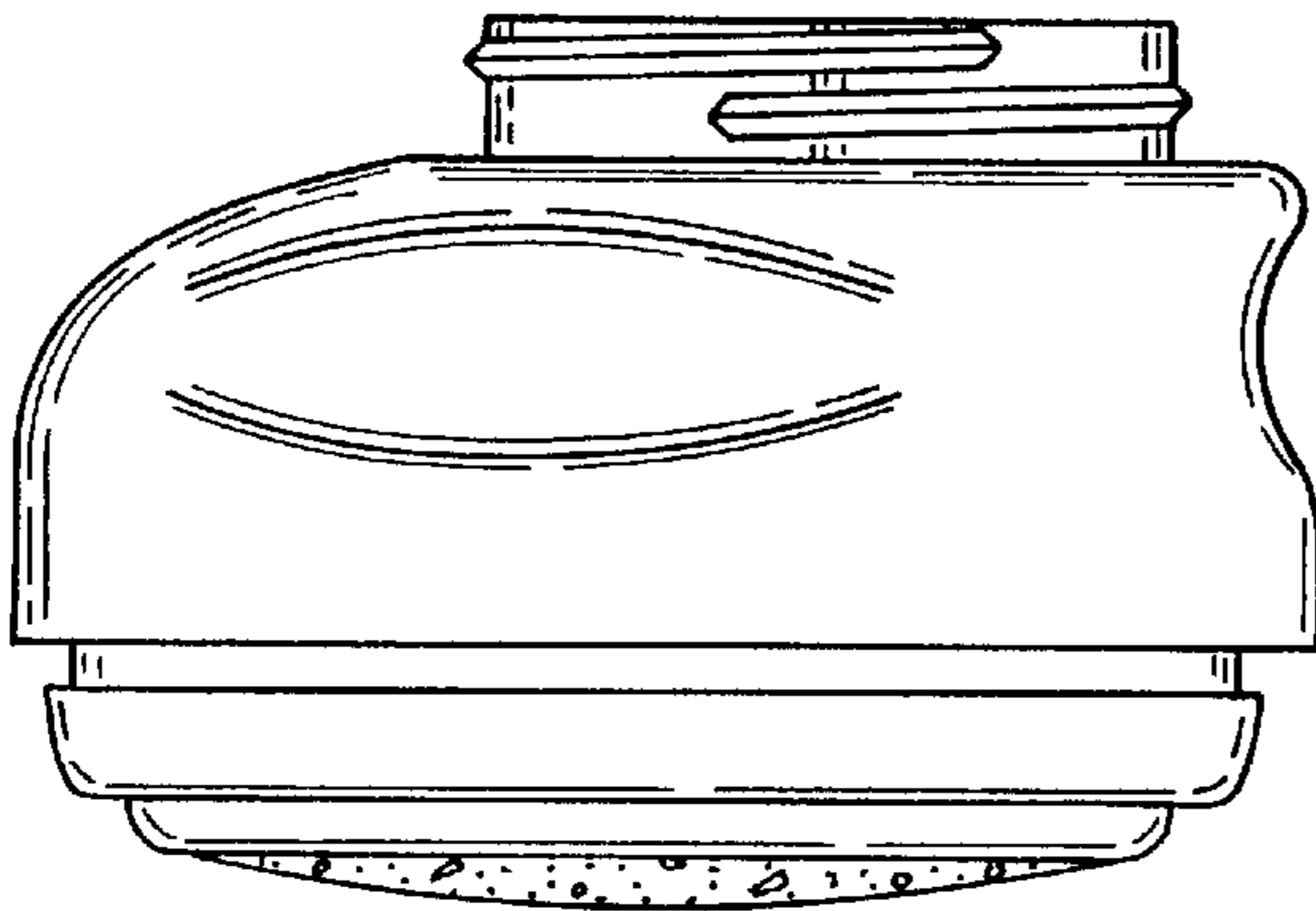
(57) **CLAIM**

The ornamental design for a palm held liquid and lotion applicator, as shown and described.

DESCRIPTION

FIG. 1 illustrates a top perspective view of a first embodiment the palm held liquid and lotion applicator showing my new and ornamental design,
 FIG. 2 illustrates side view, the opposite side being a mirror-image thereof;
 FIG. 3 illustrates a bottom plan view thereof;
 FIG. 4 illustrates a top plan thereof;
 FIG. 5 is a perspective view of the cover for a palm held liquid and lotion applicator drawn separately for purposes of illustration;
 FIG. 6 illustrates a top plan view thereof;
 FIG. 7 illustrates a side view thereof;
 FIG. 8 illustrates the cover as mounted on the applicator of FIG. 1;
 FIG. 9 illustrates a top perspective view of a second embodiment showing my ornamental design;
 FIG. 10 illustrates a side view, the opposites side being a mirror-image thereof;
 FIG. 11 illustrates a bottom plan view thereof; and,

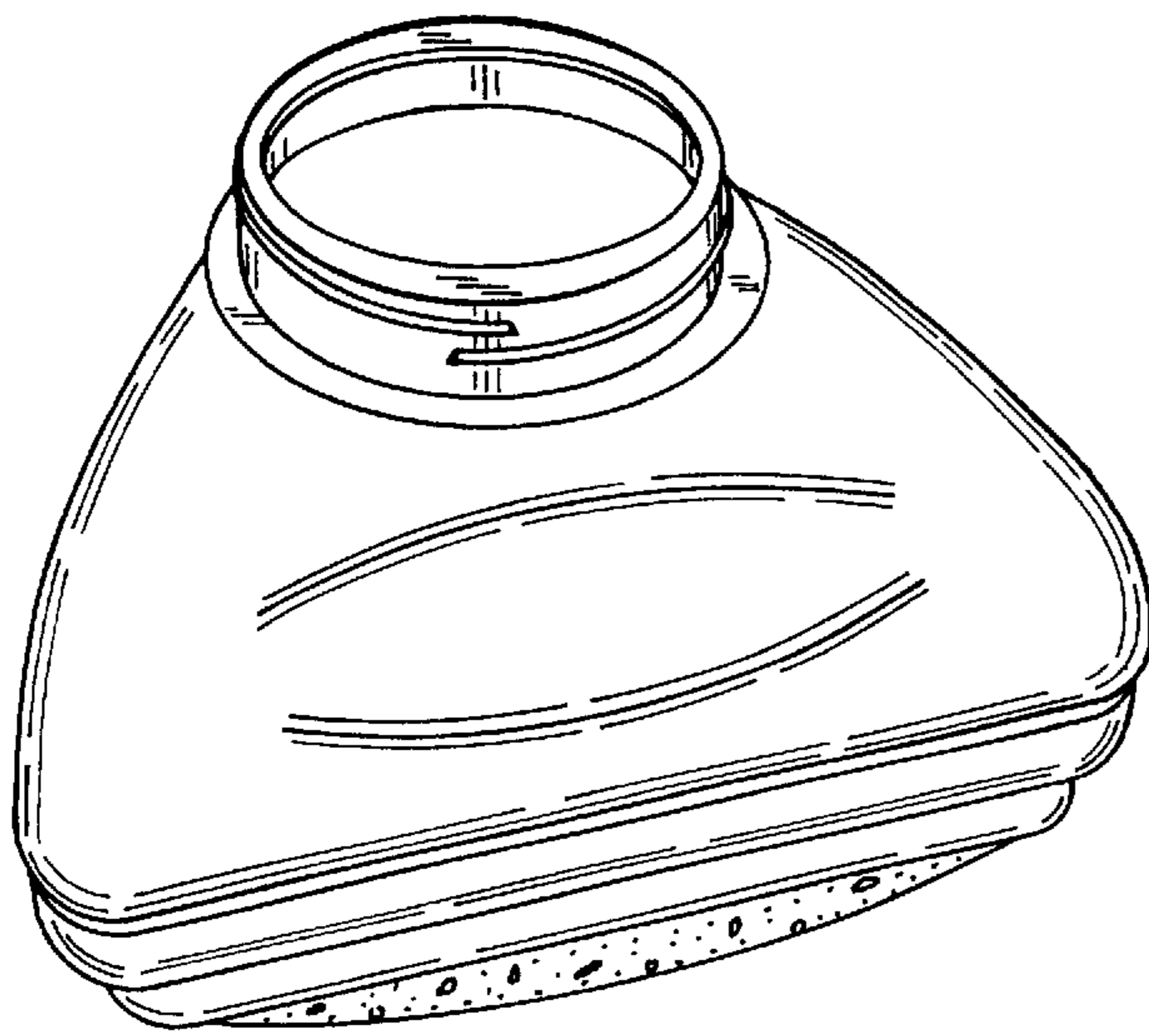

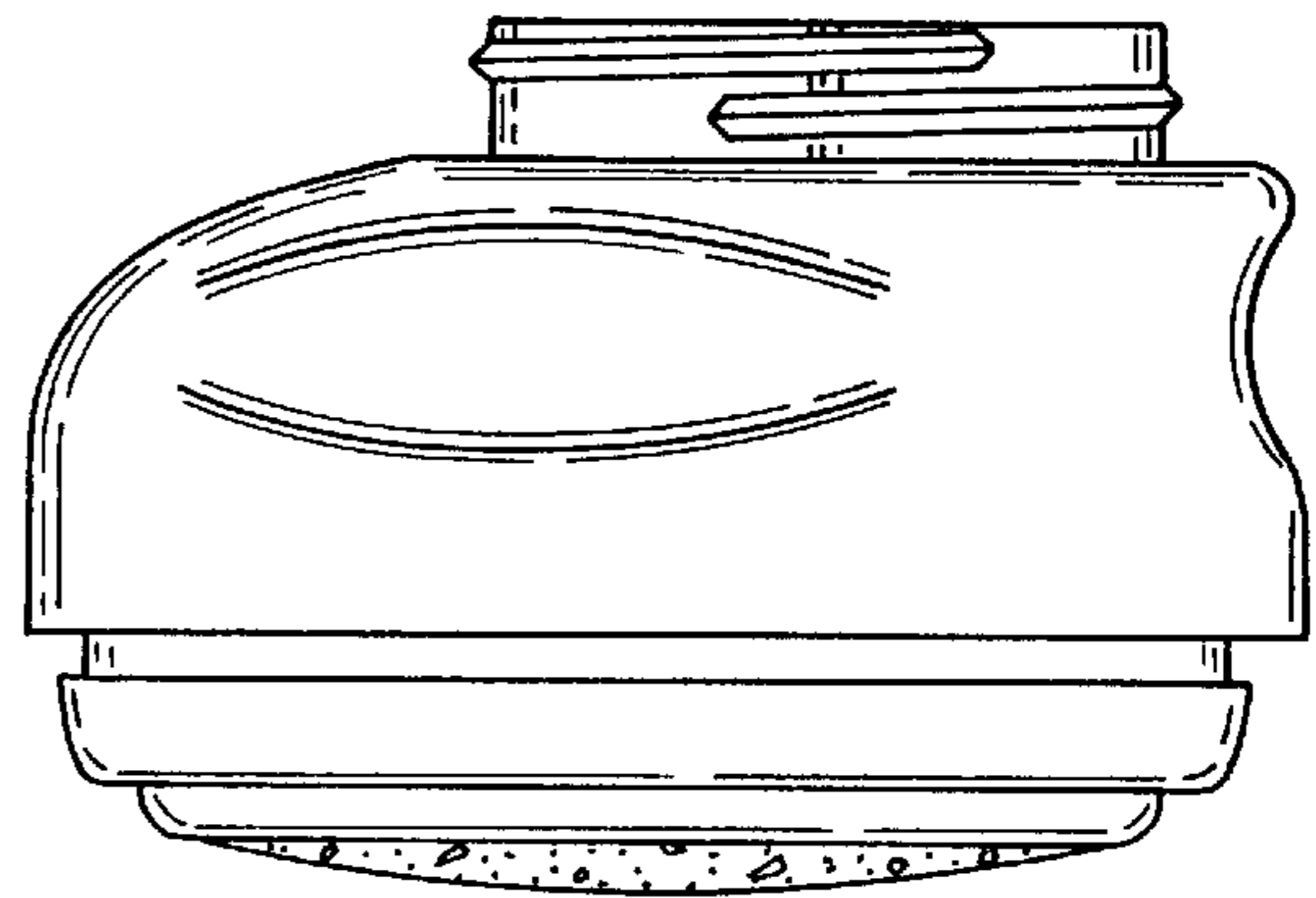

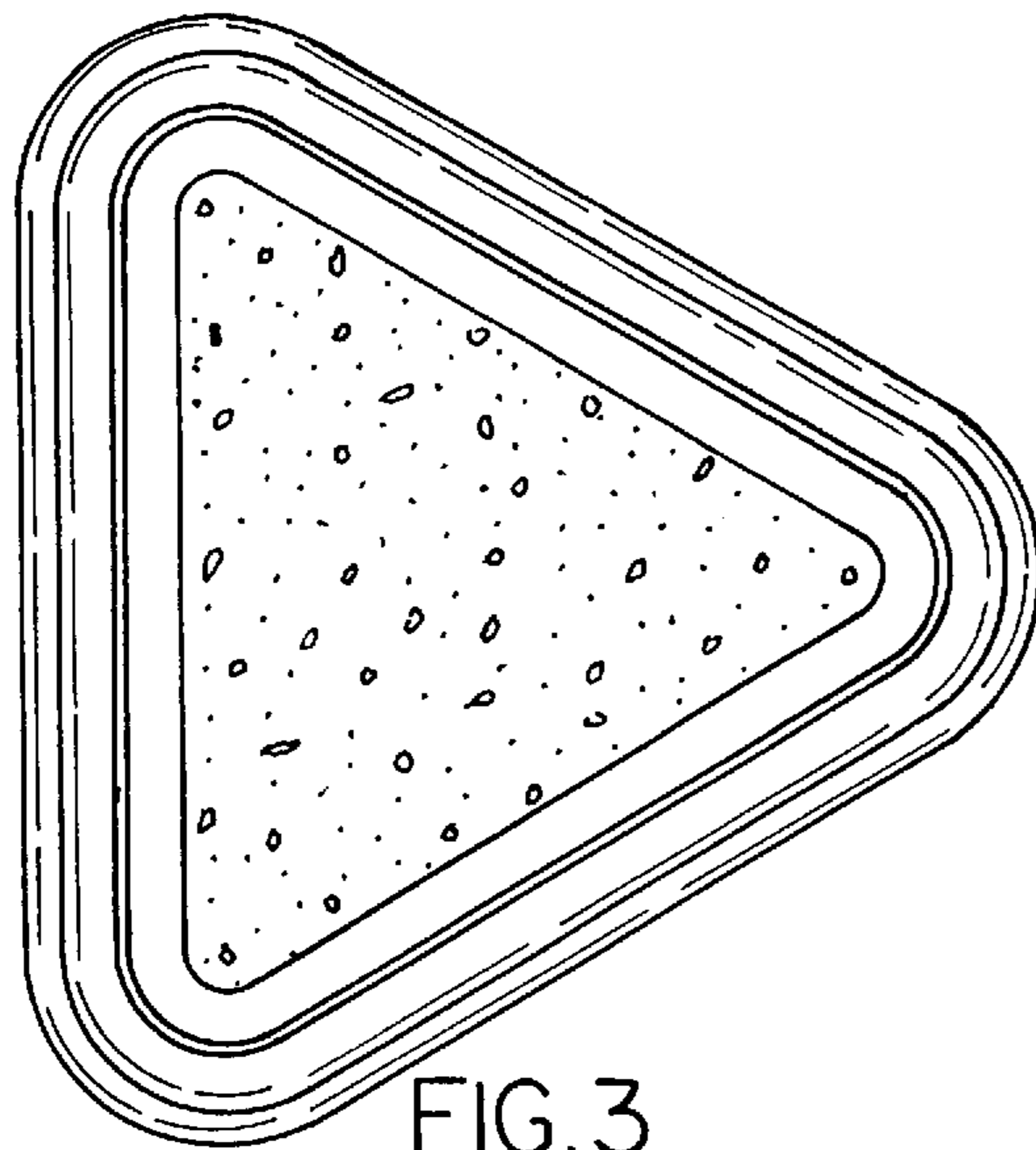

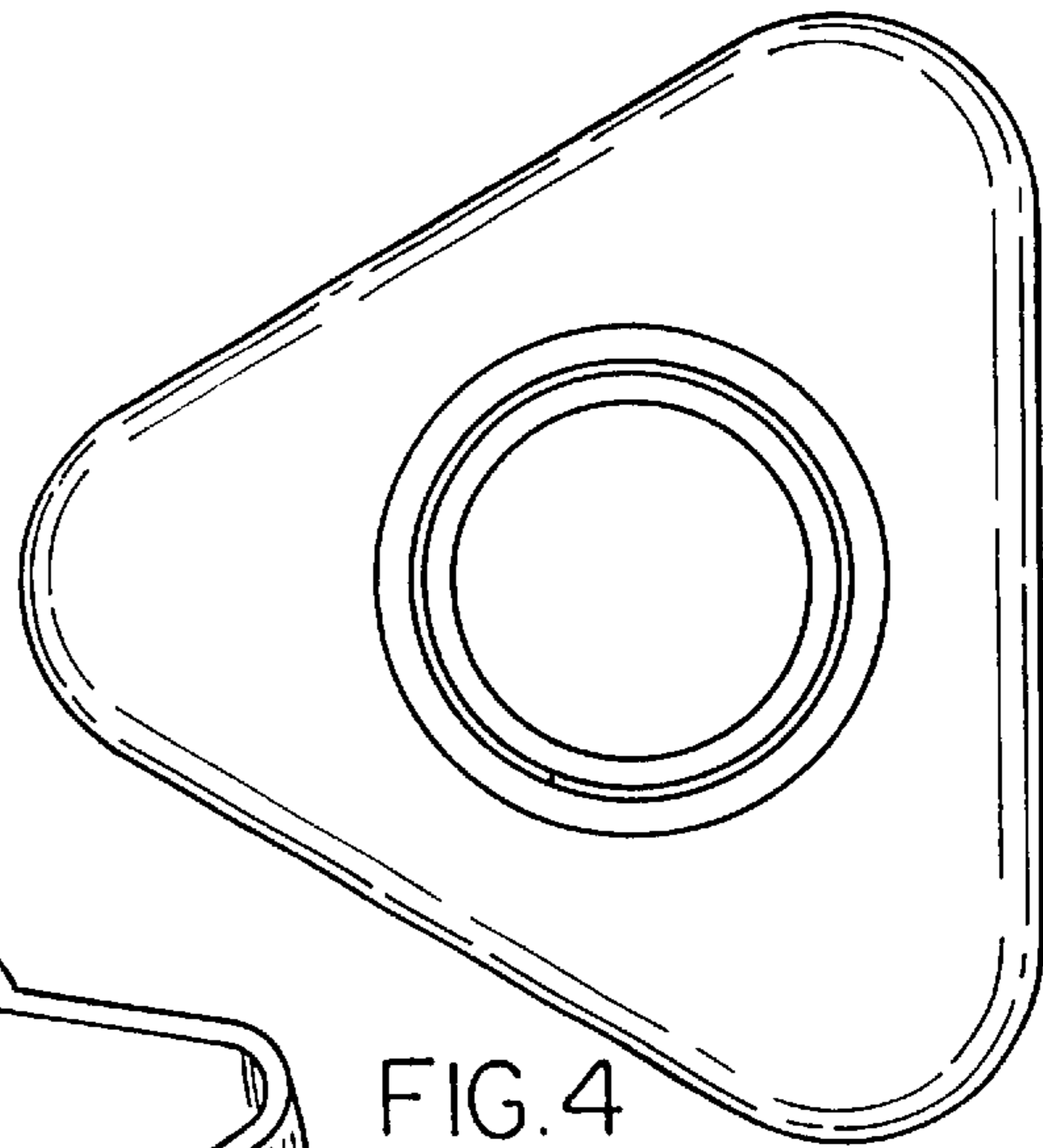

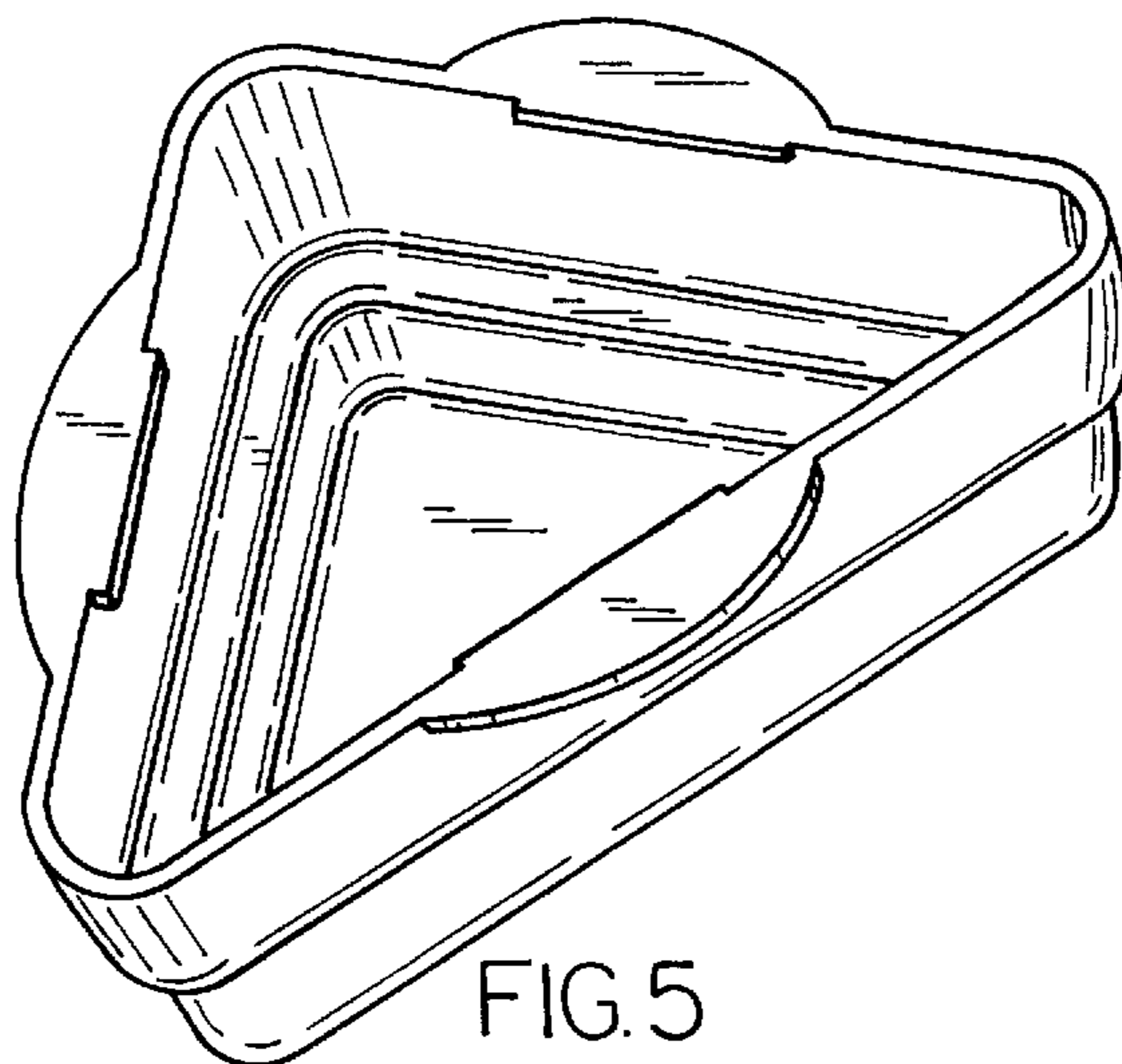

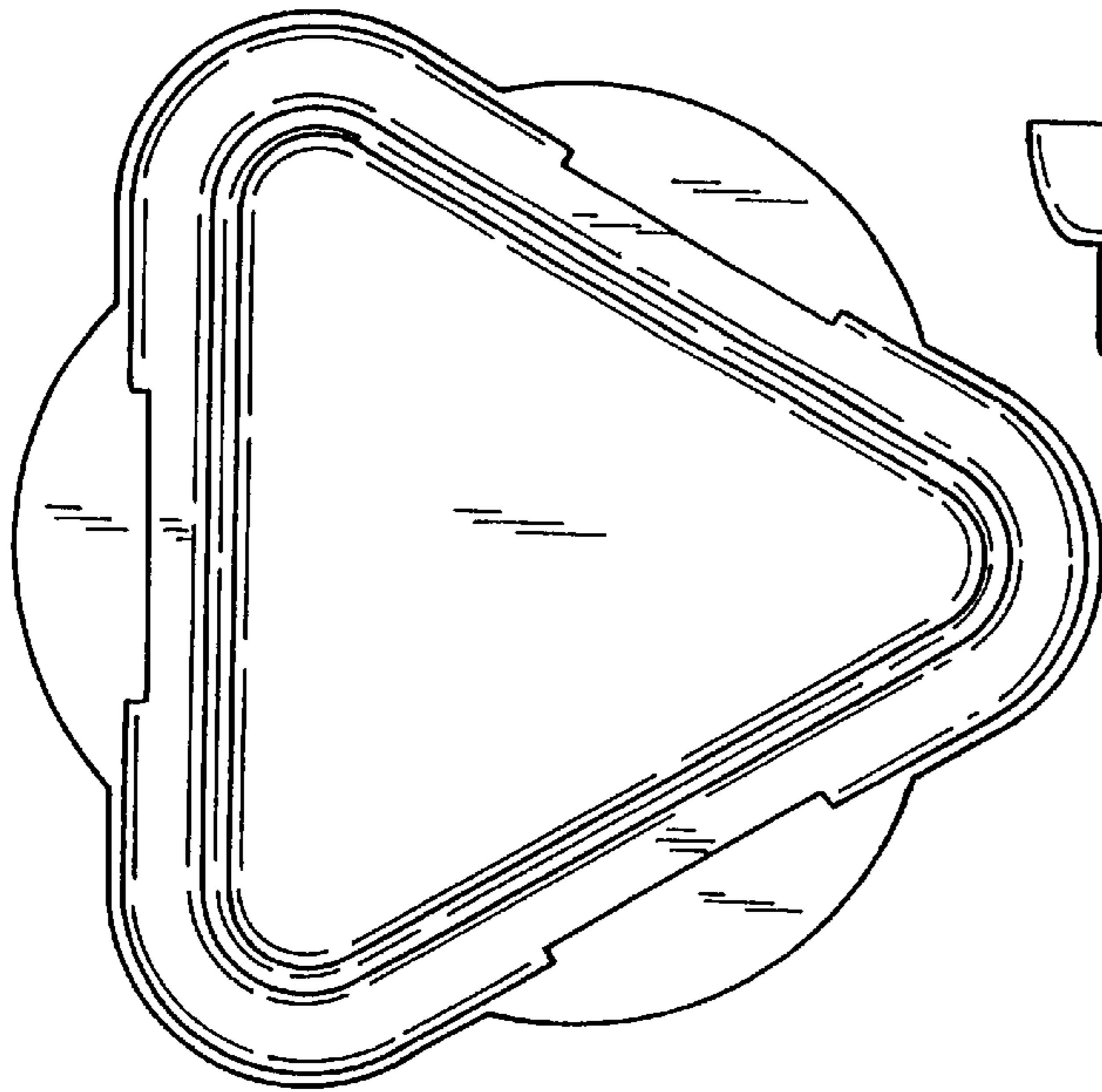

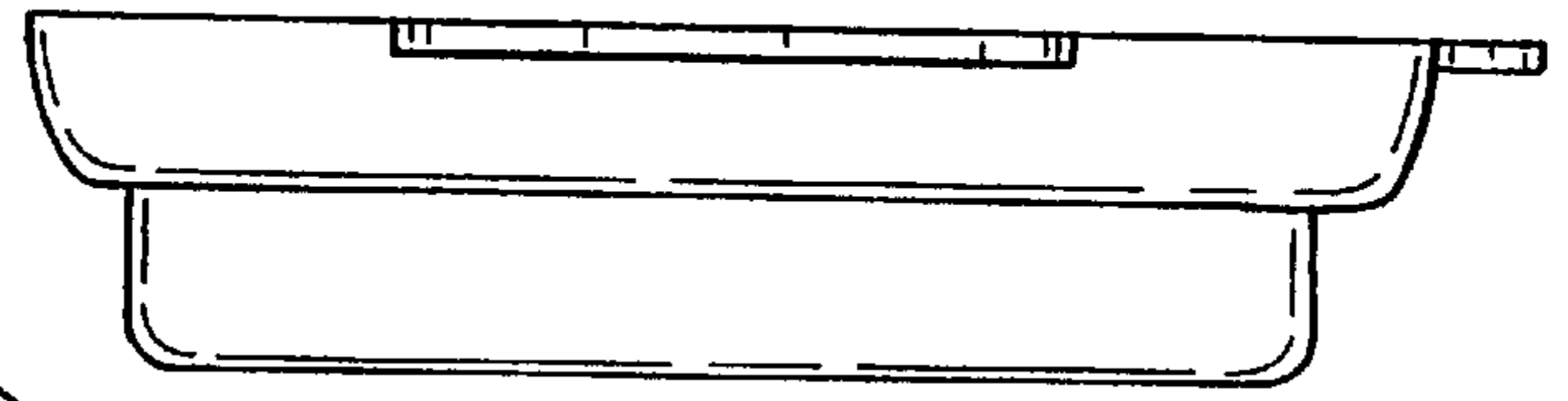

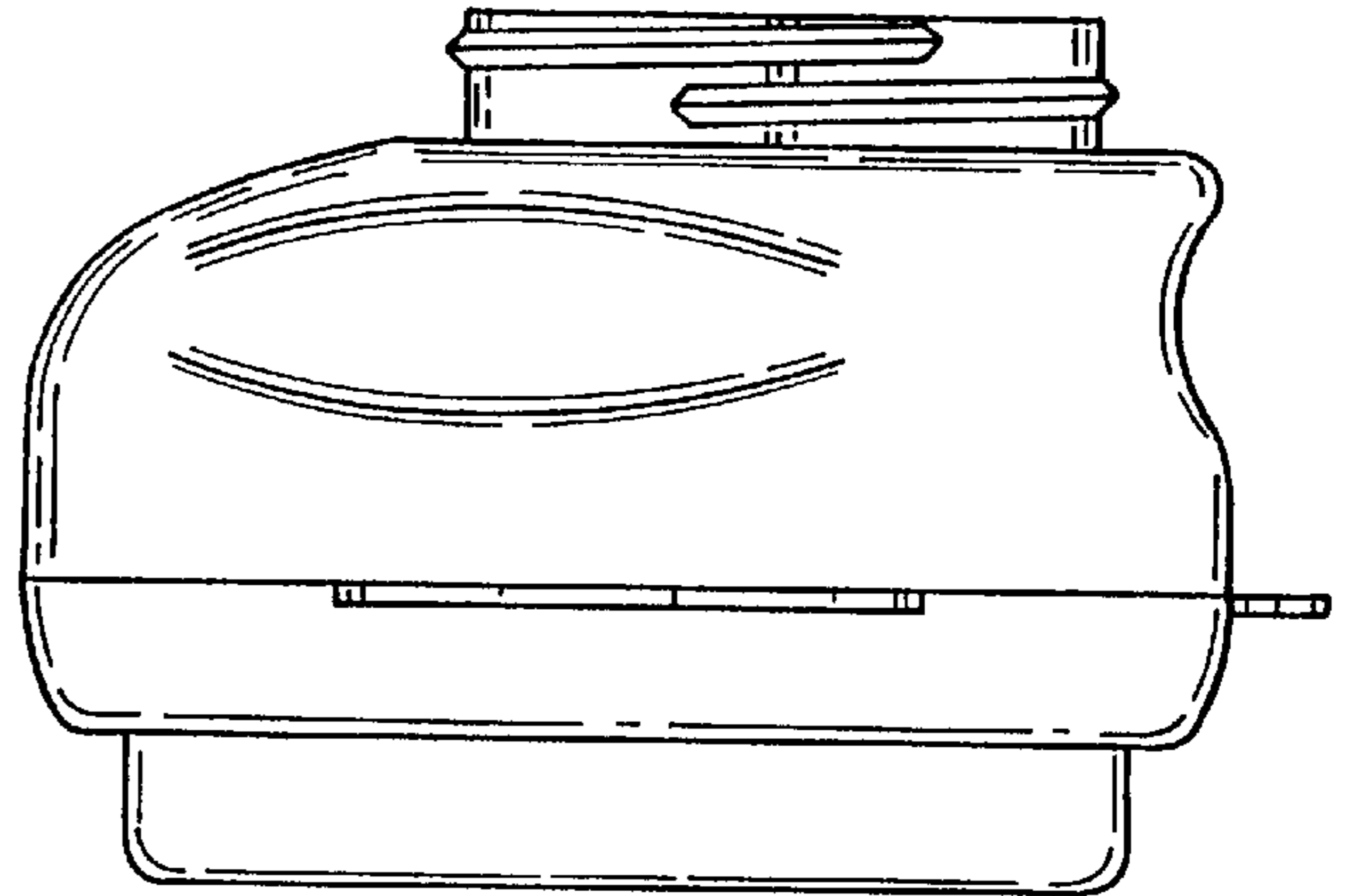

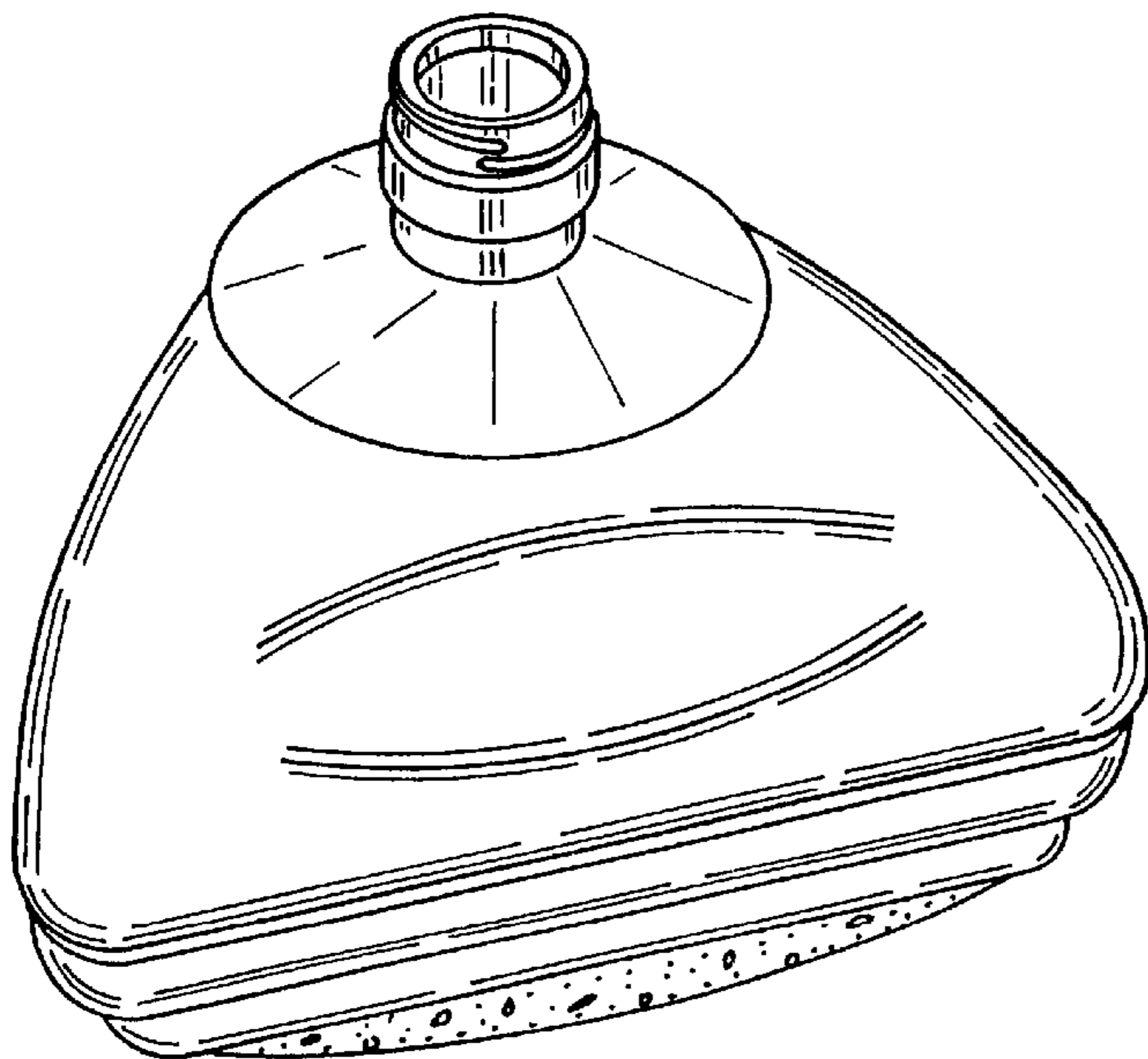

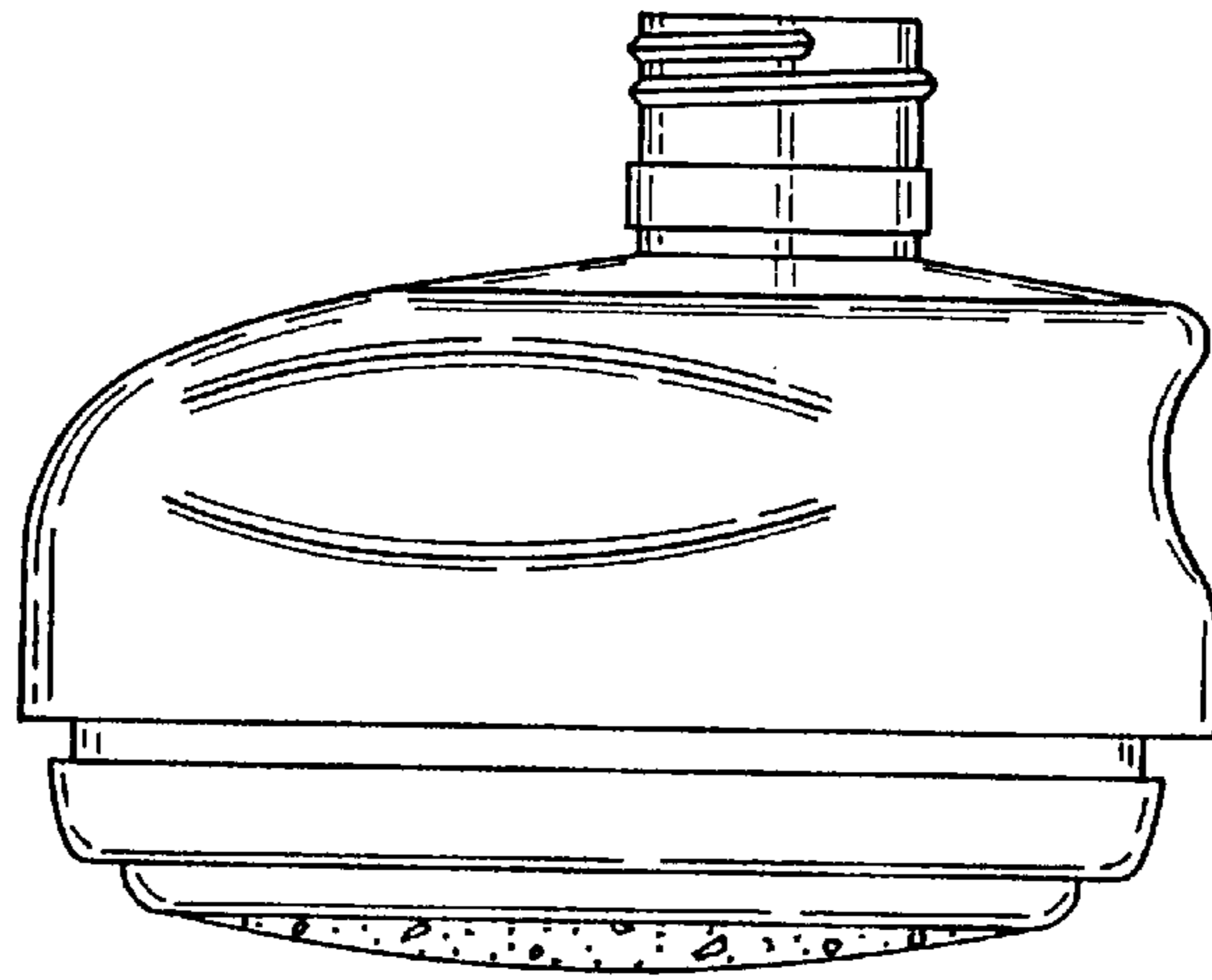

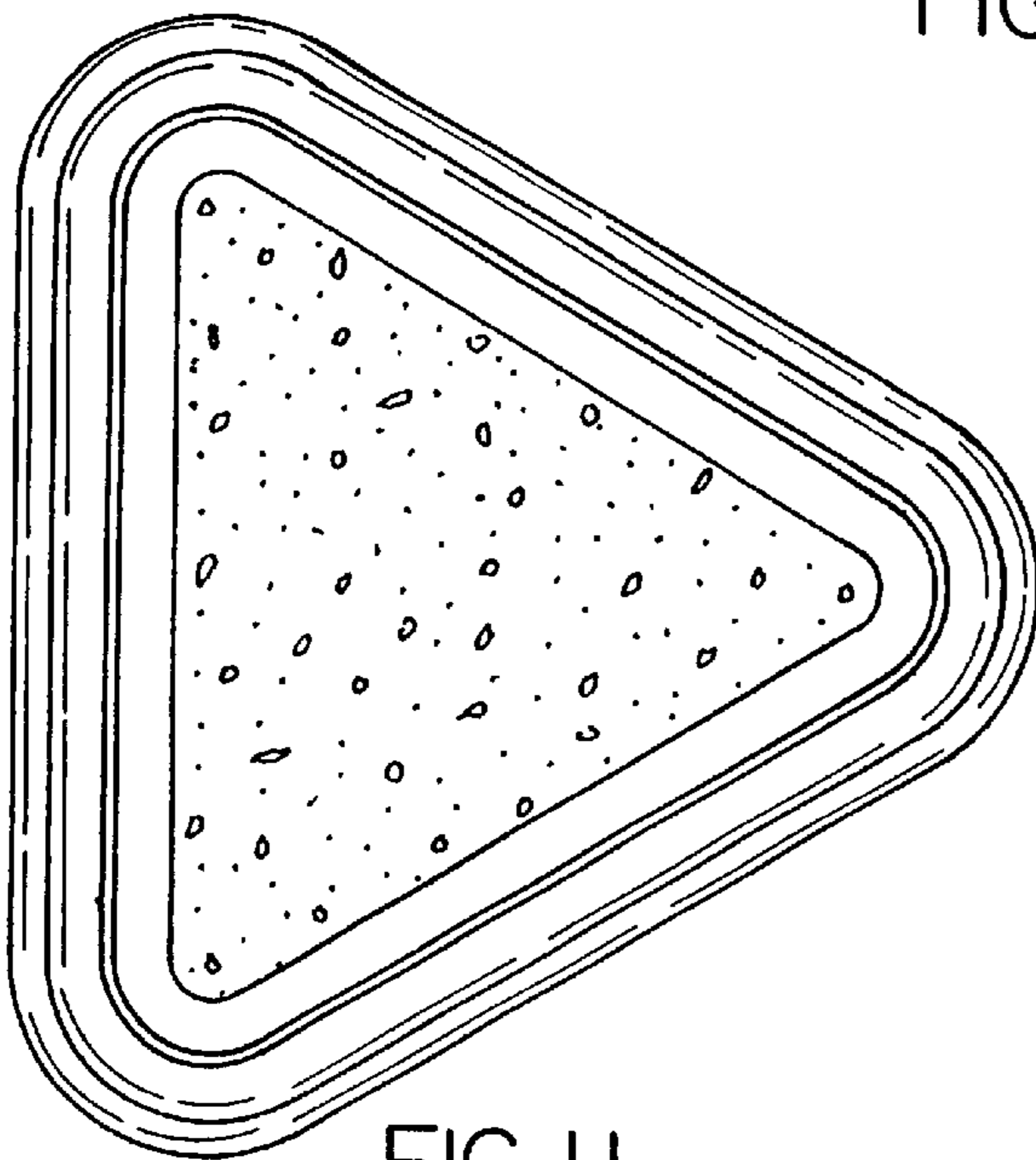

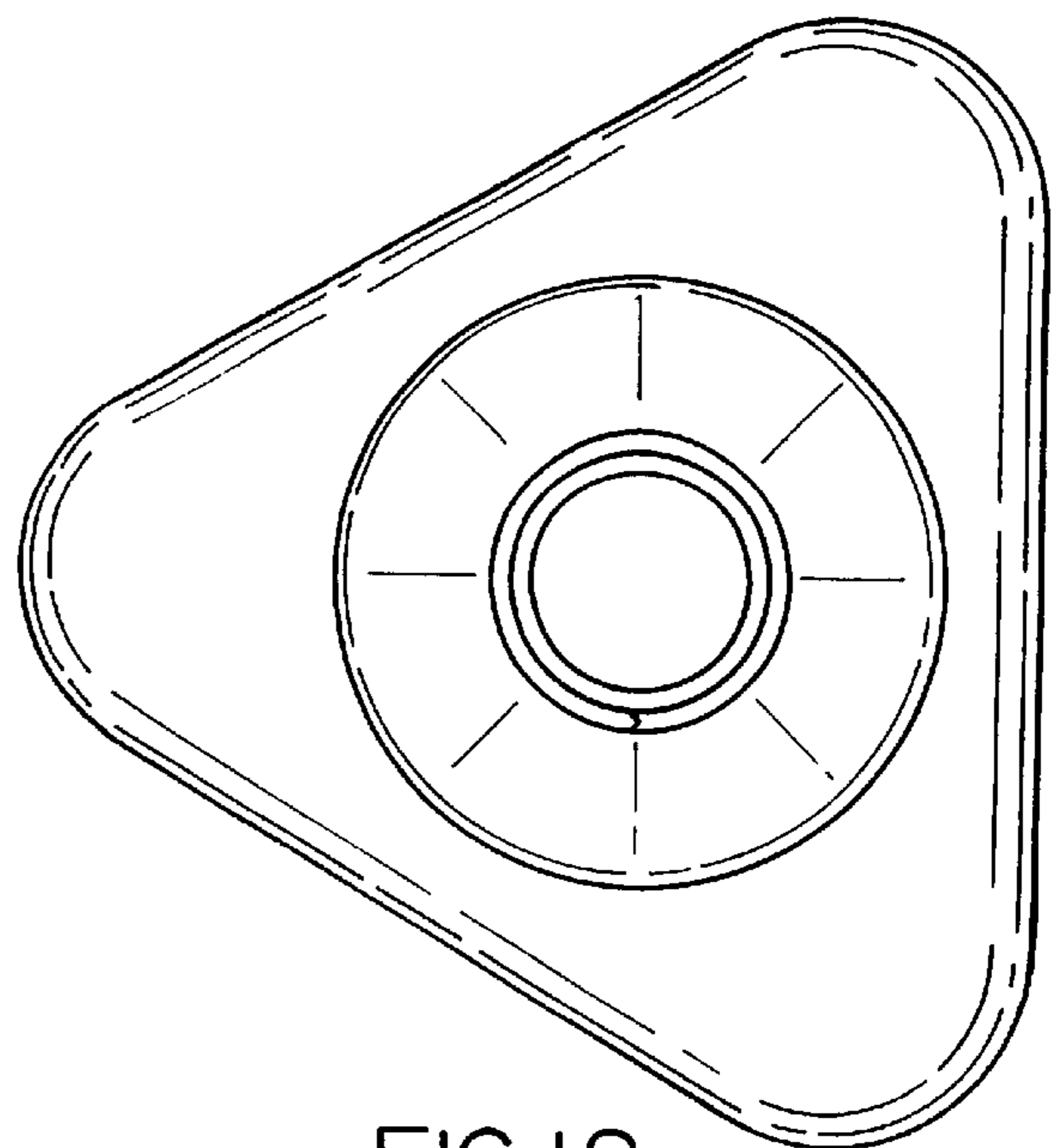
