(57) **CLAIM**

The ornamental design for a clutch, as shown and described.

**DESCRIPTION**

FIG. 1 is perspective view of a first embodiment of the clutch in a folded configuration showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a perspective view of the clutch in an open configuration with a broken line representation of keys and card slots for the clutch forming no part of the claimed design;

FIG. 7 is a front elevational view thereof;

FIG. 8 is a right side elevational view thereof;

FIG. 9 is a top plan view thereof;

FIG. 10 is a rear elevational view thereof;

FIG. 11 is a perspective view of a second embodiment of the clutch in the open configuration with a broken line representation of a connector, a speaker and a zipper for the clutch forming no part of the claimed design;

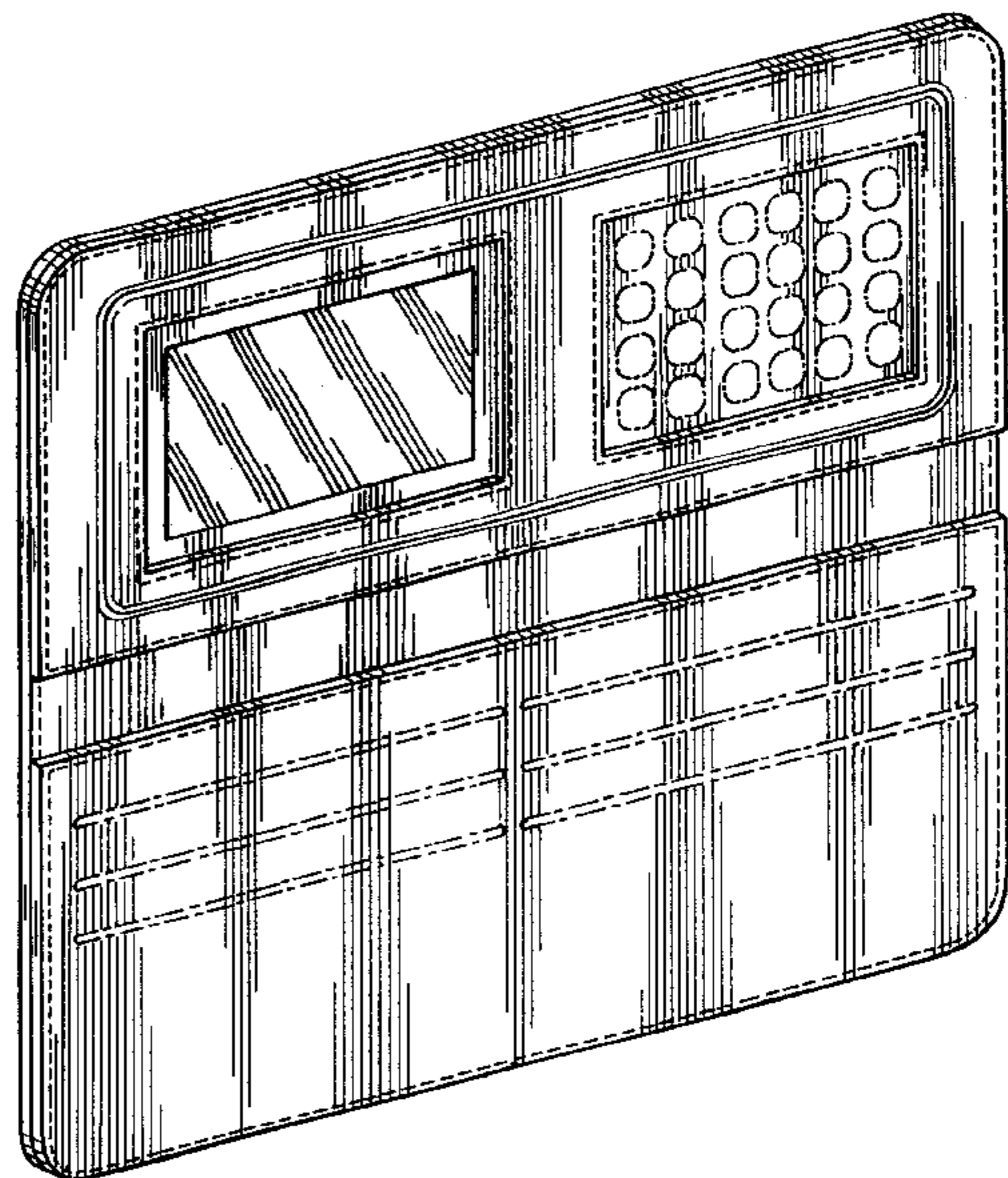
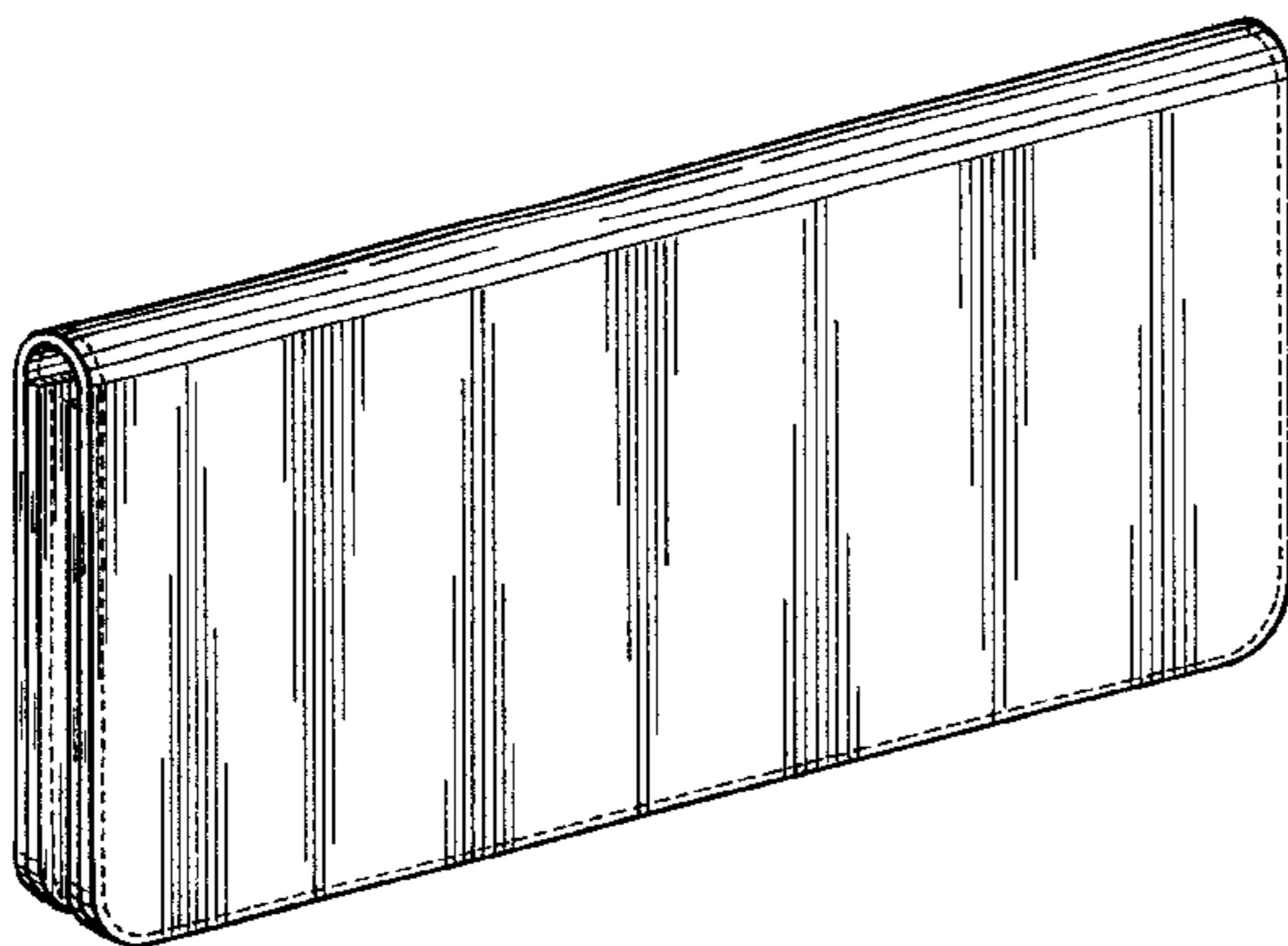
FIG. 12 is a front elevational view thereof;

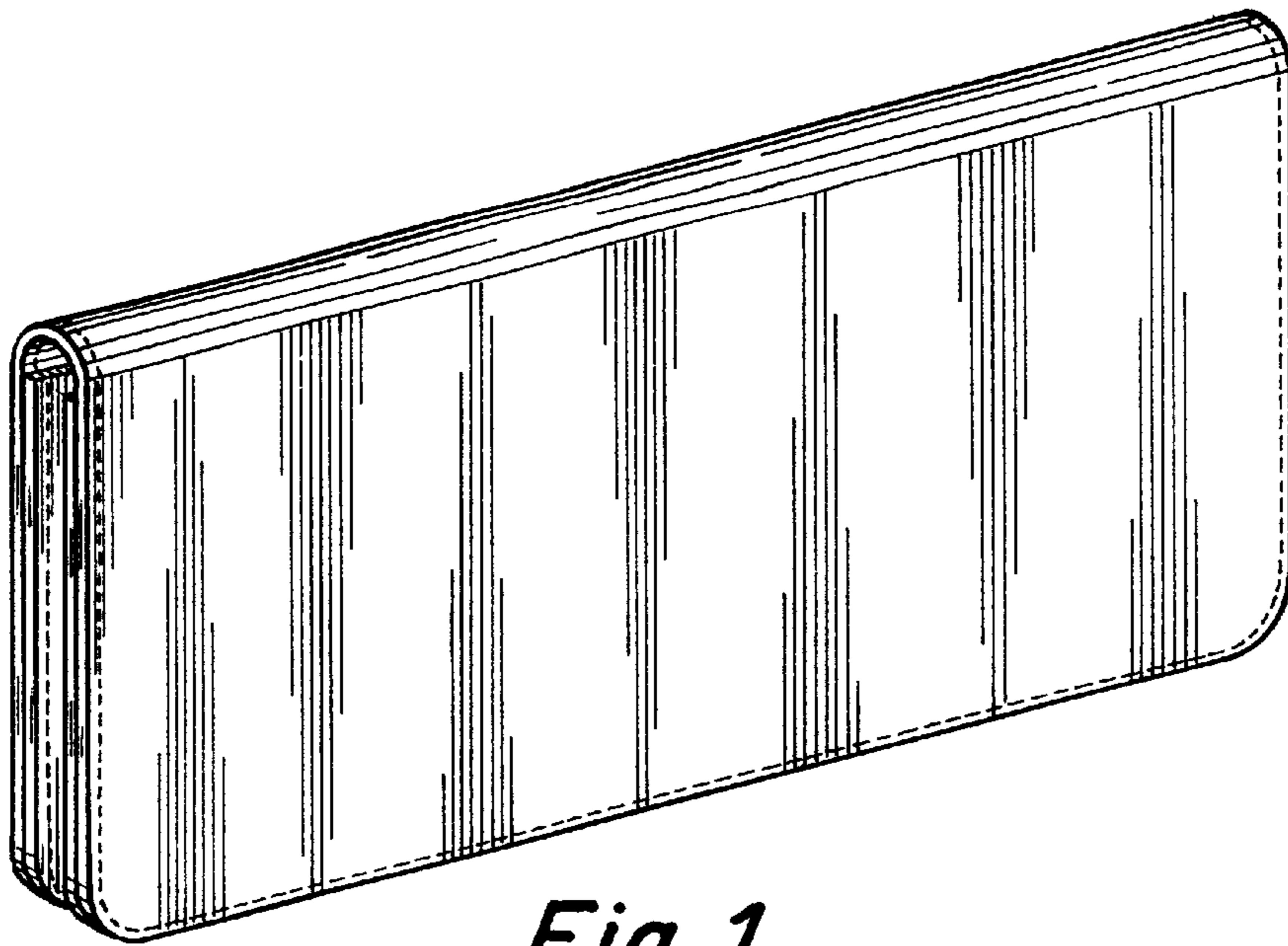
FIG. 13 is a right side elevational view thereof; and,

FIG. 14 is a top plan view thereof.

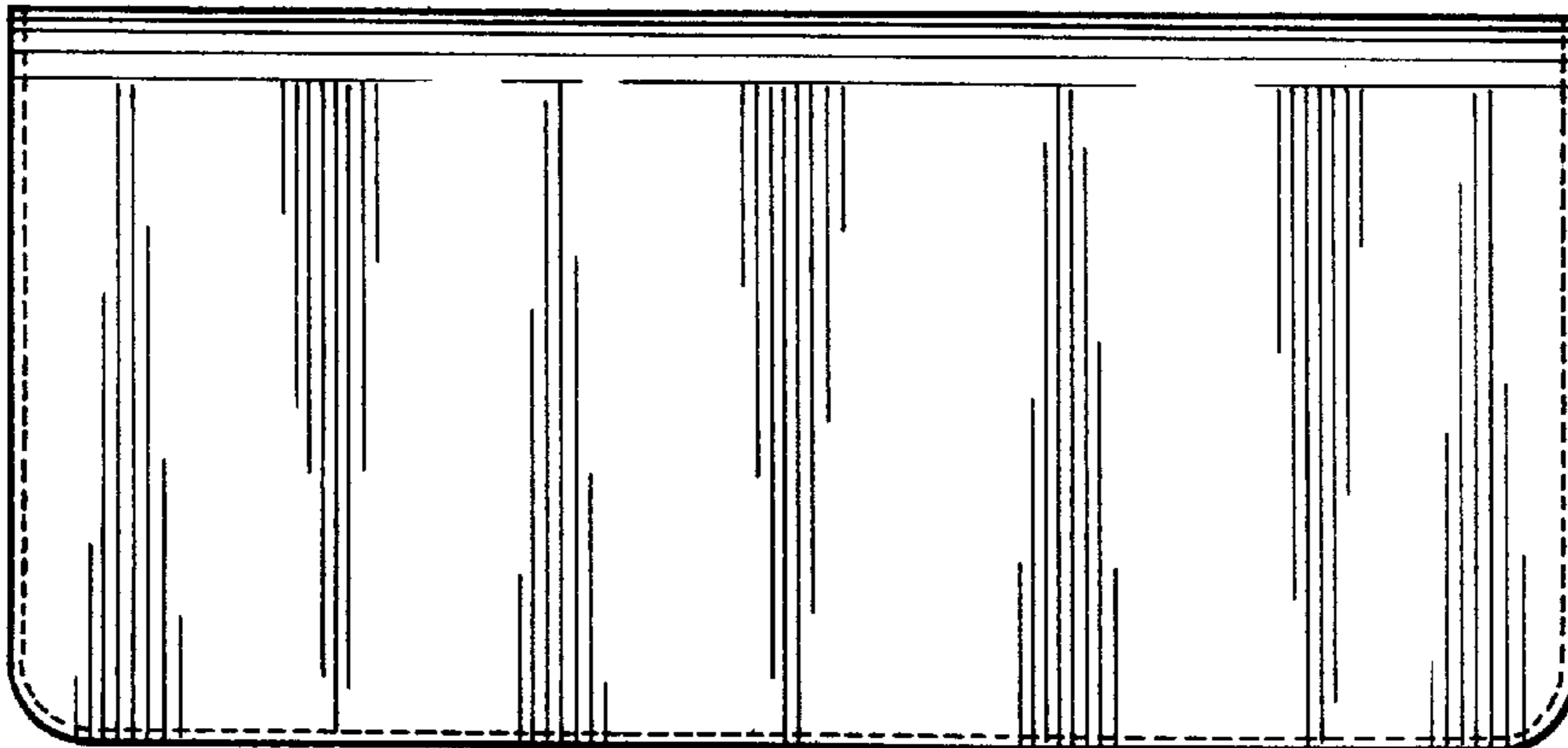
The exterior surface of the second embodiment of the clutch is not shown in the drawings or described in the specification and is understood to form no part of this embodiment of the claimed design.

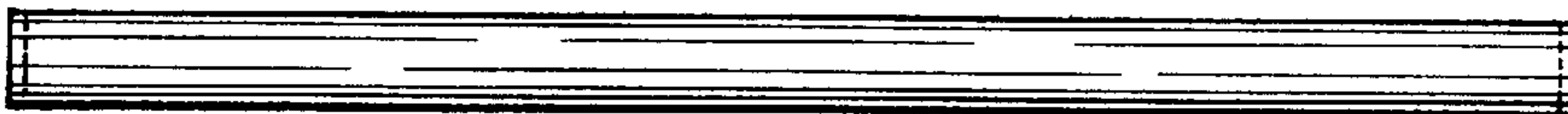

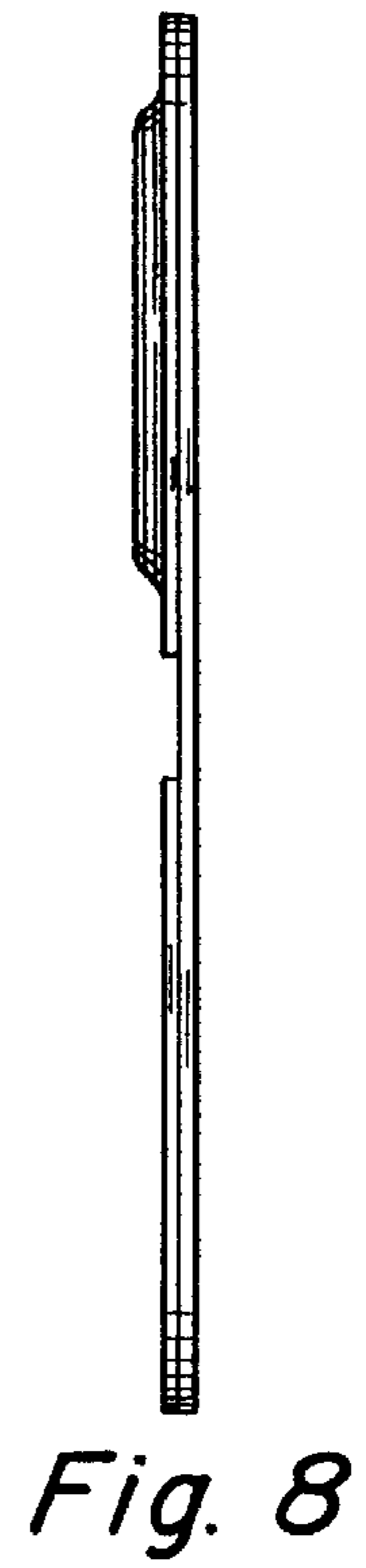
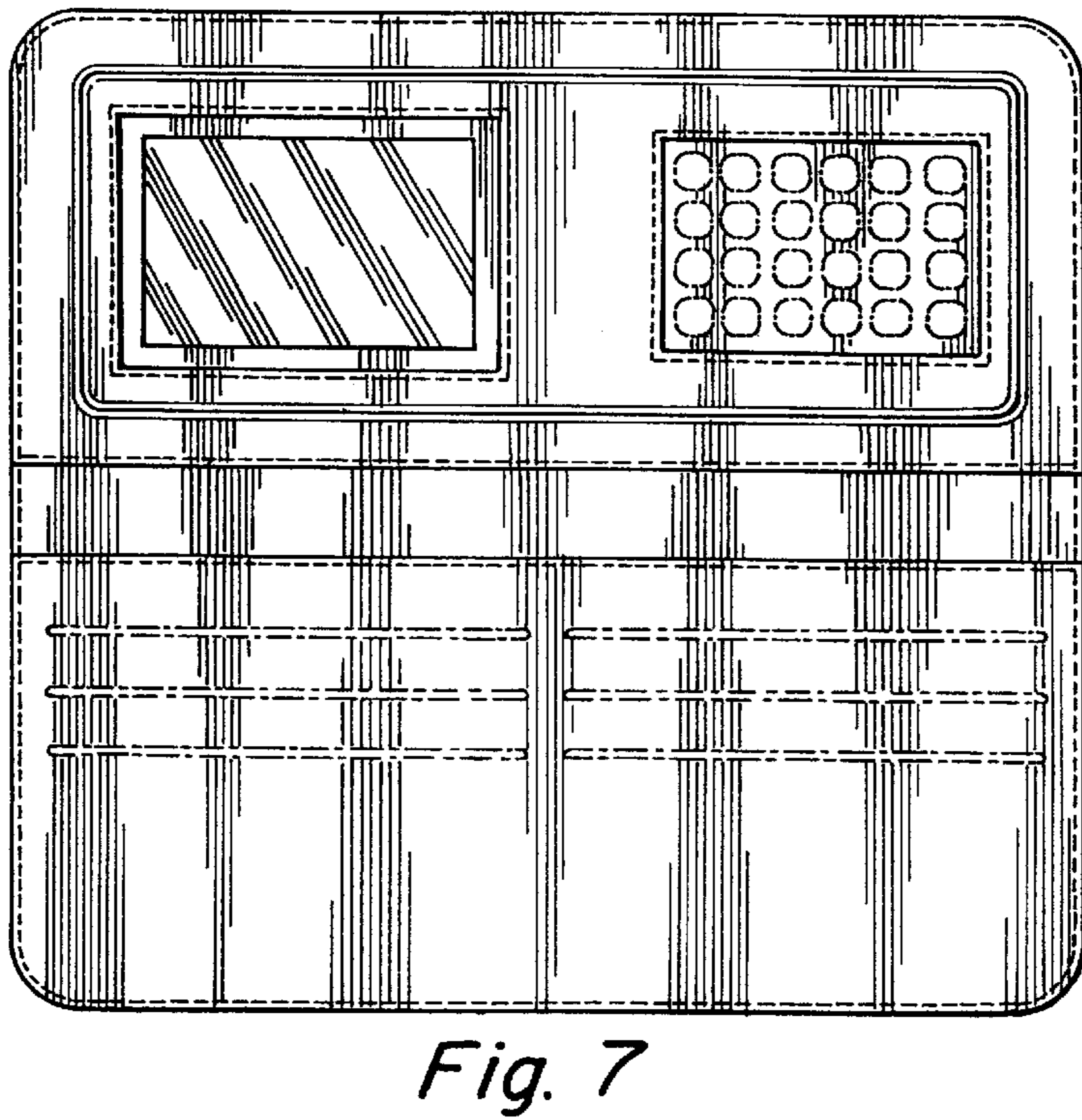
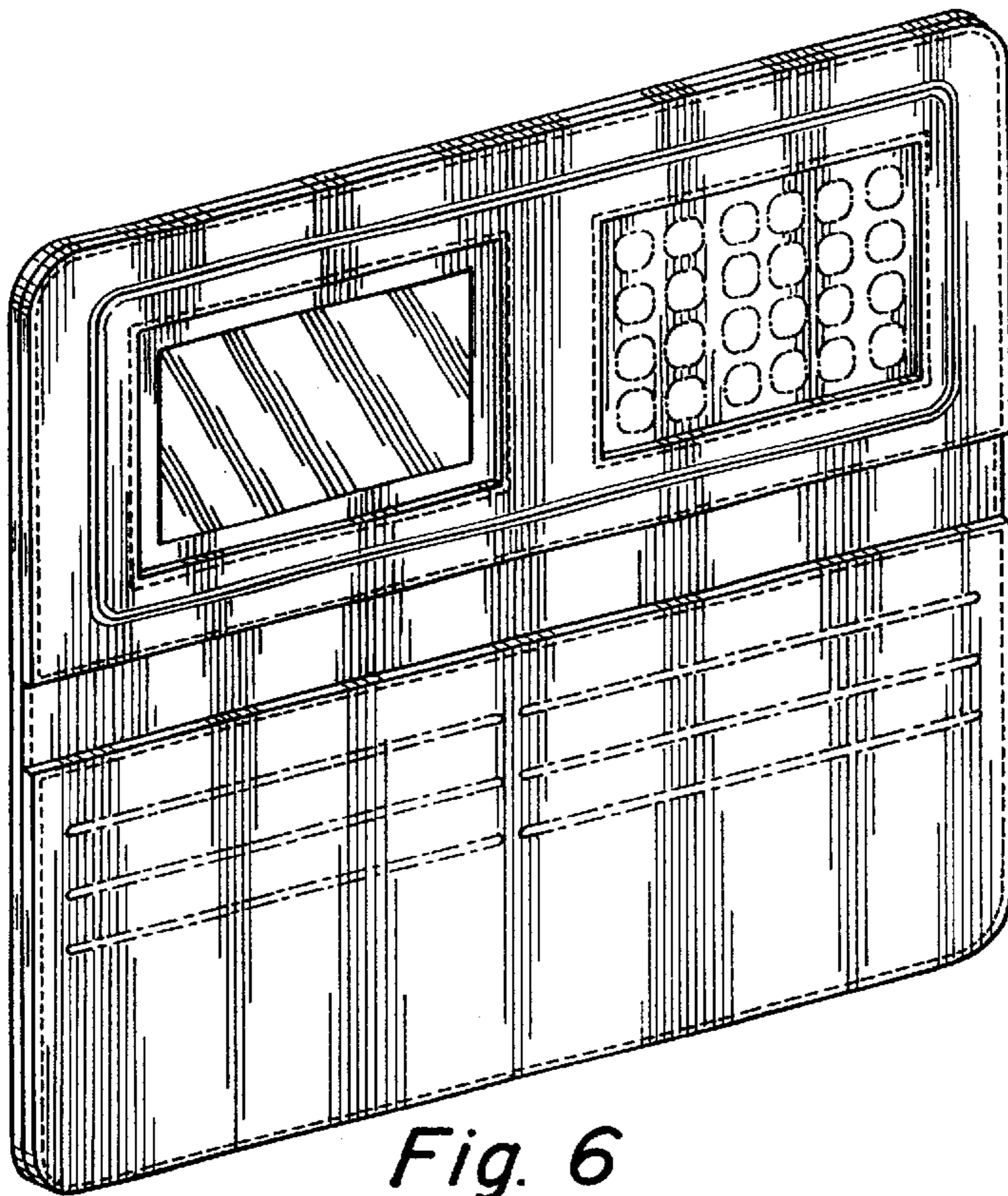

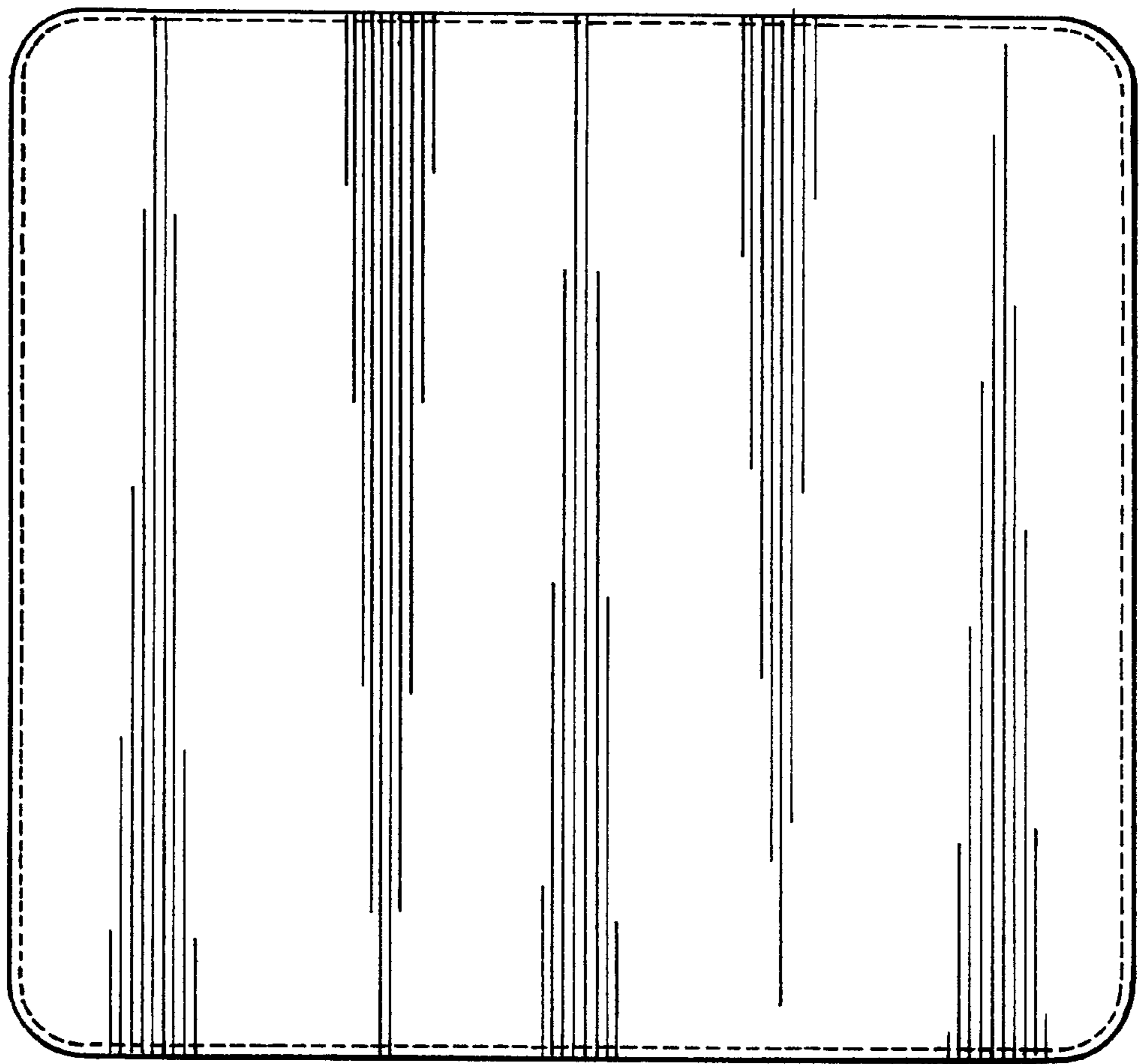

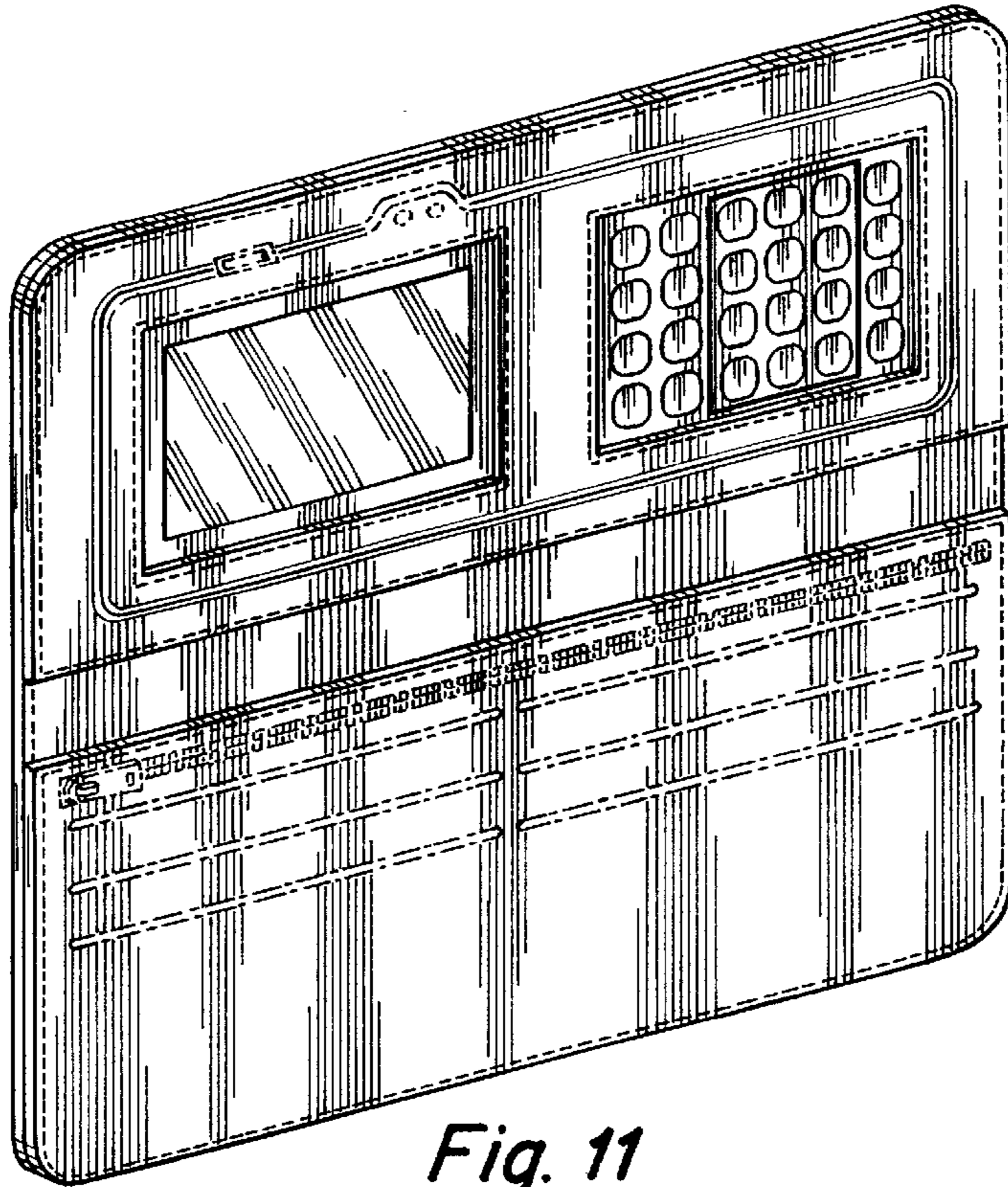

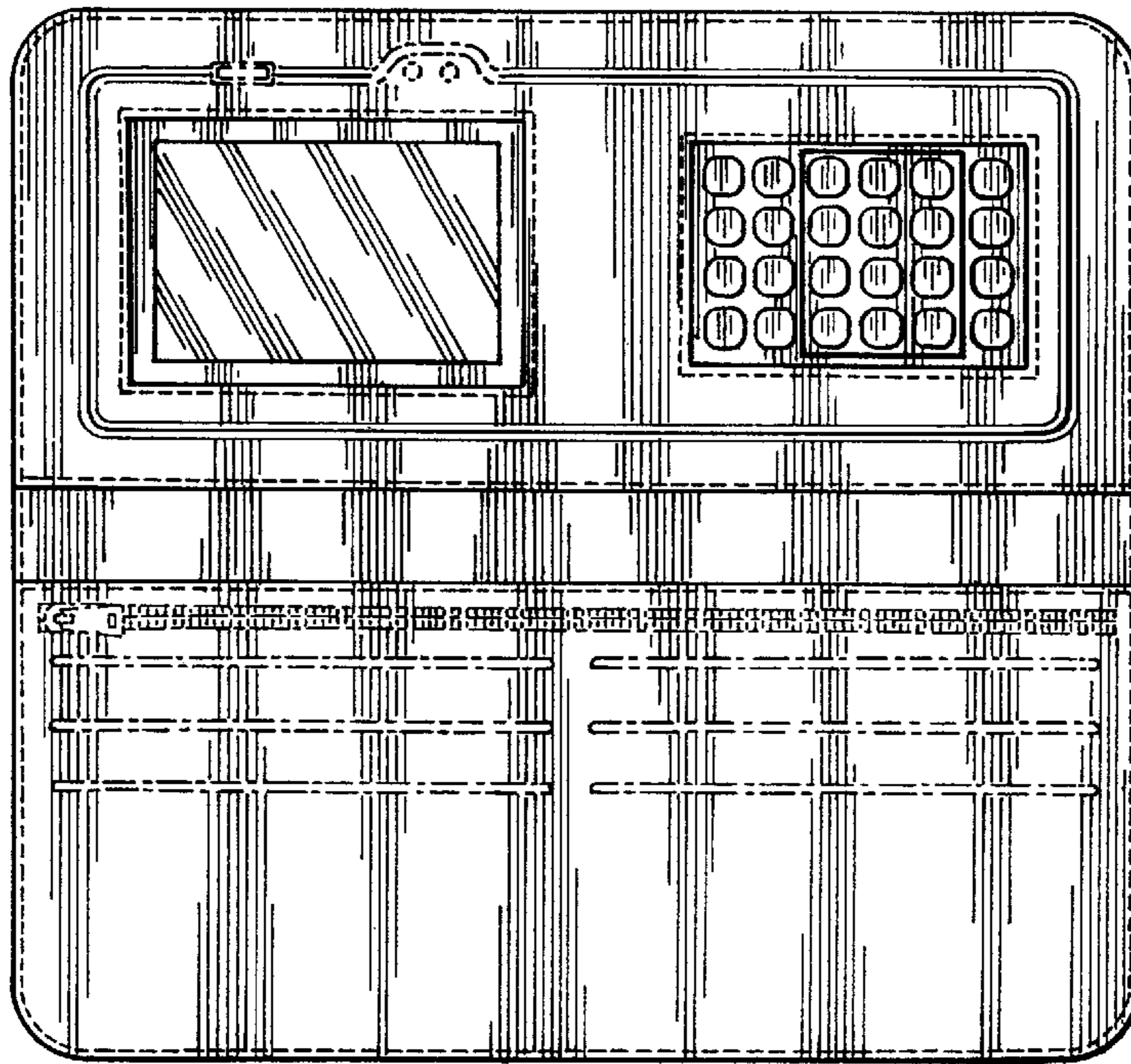

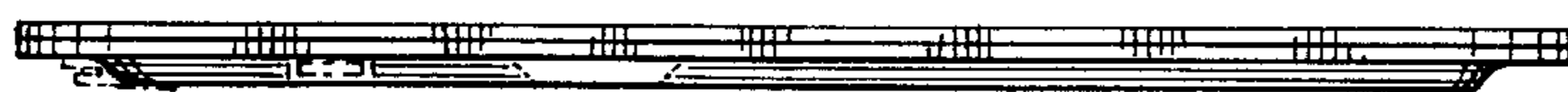
