(57) **CLAIM**

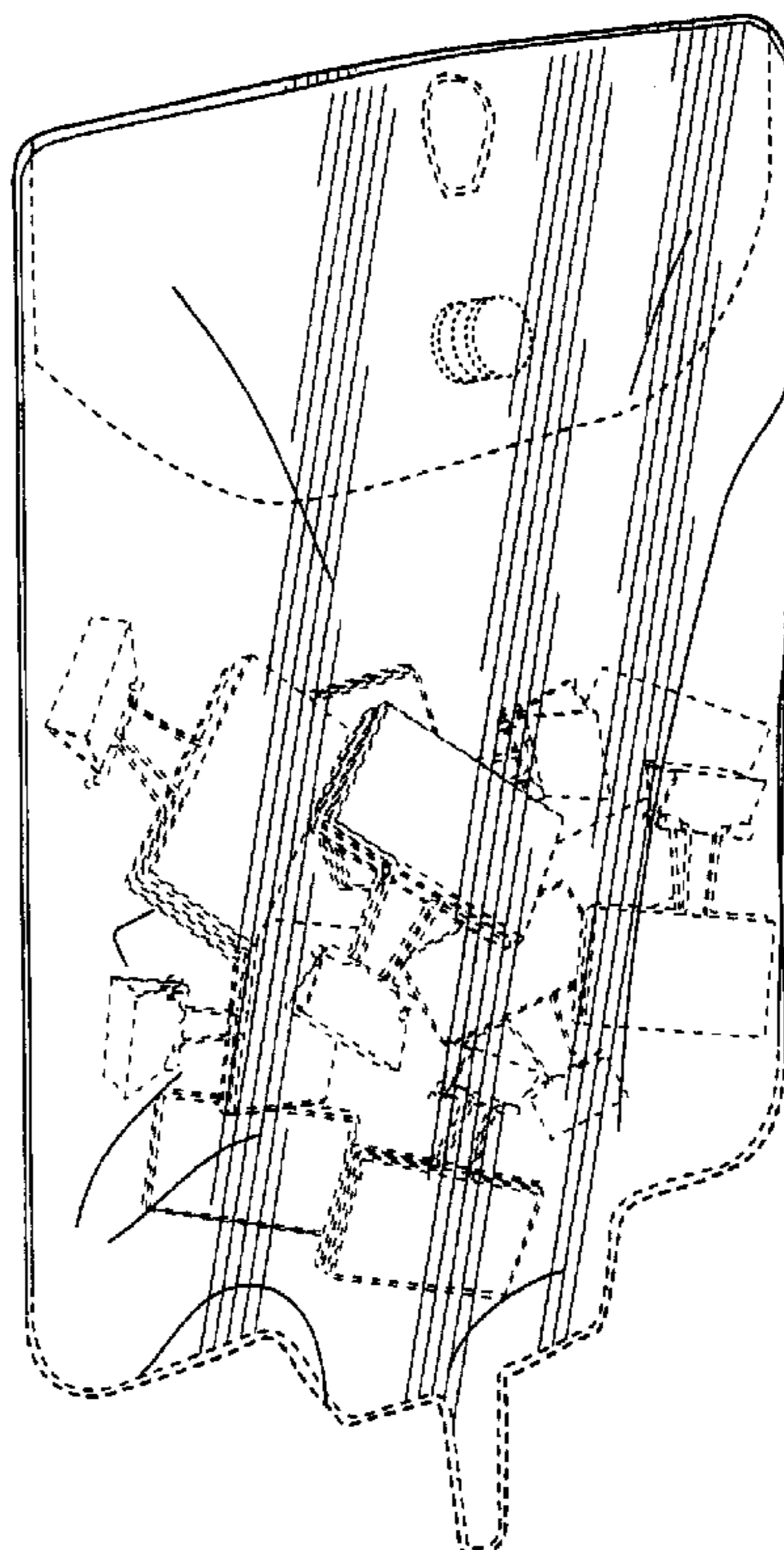
The ornamental design for a promotional intravenous fluid bag storage compartment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a promotional intravenous fluid bag storage compartment, showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a side elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a side elevational view thereof, opposite that shown in FIG. 4; FIG. 7 is a rear elevational view thereof; FIG. 8 is a perspective view of a second embodiment of my design of a promotional intravenous fluid bag storage compartment; FIG. 9 is a front elevational view of the embodiment of FIG. 8; FIG. 10 is a top plan view of the embodiment of FIG. 8; FIG. 11 is a side elevational view of the embodiment of FIG. 8; FIG. 12 is a bottom plan view of the embodiment of FIG. 8; FIG. 13 is a side elevational view of the embodiment of FIG. 8, opposite that shown in FIG. 11; and, FIG. 14 is a rear elevational view of the embodiment of FIG. 8.

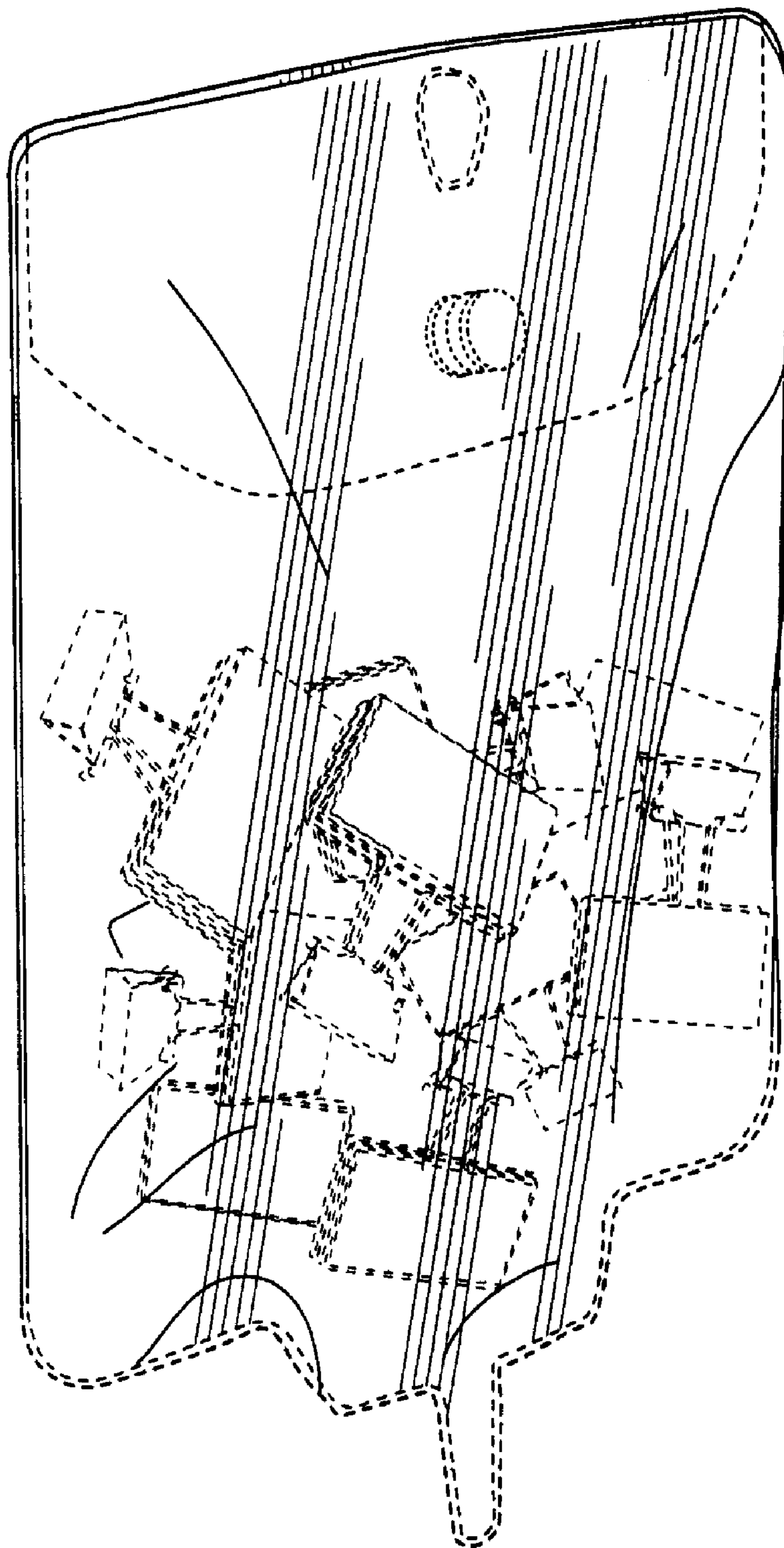

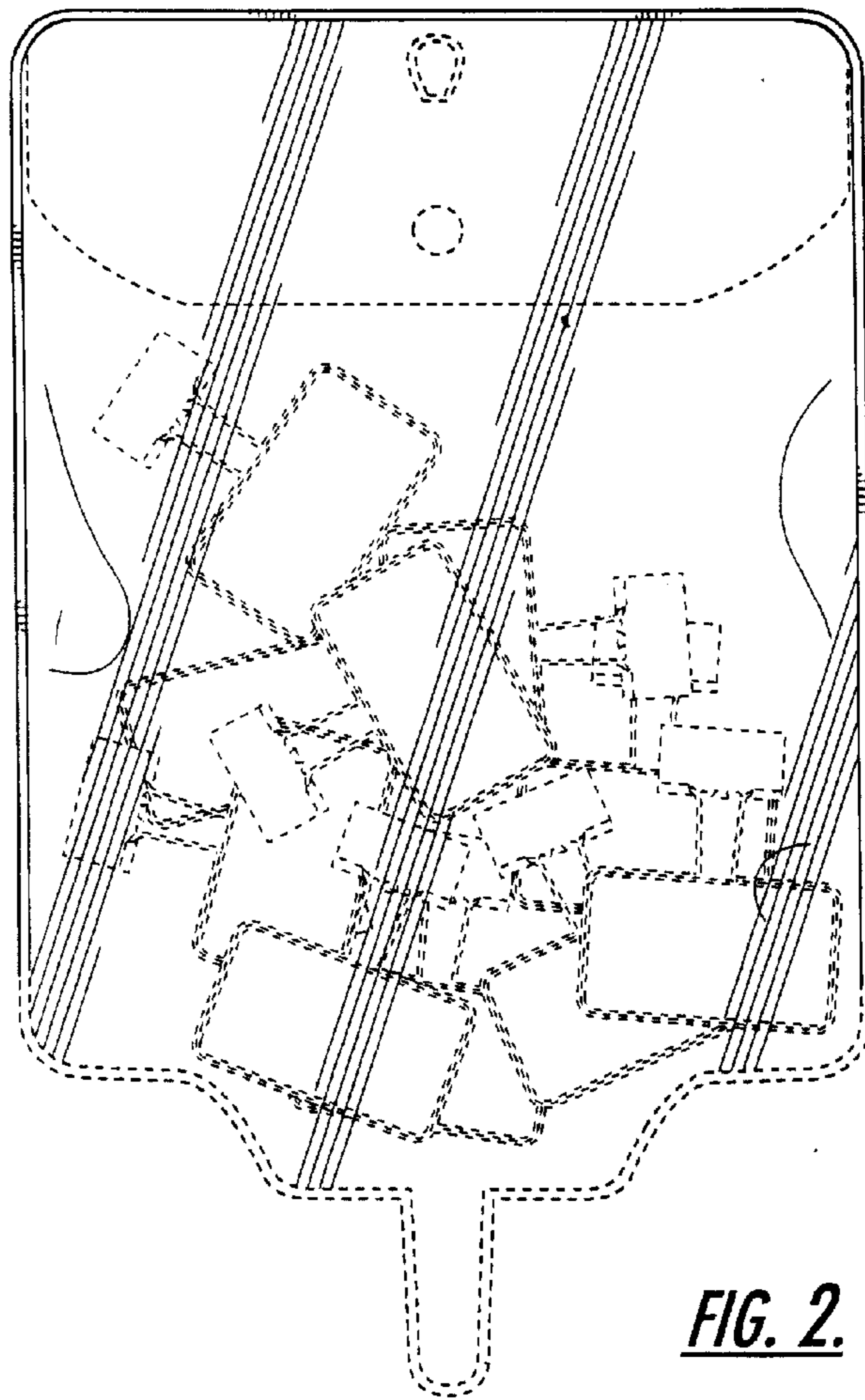

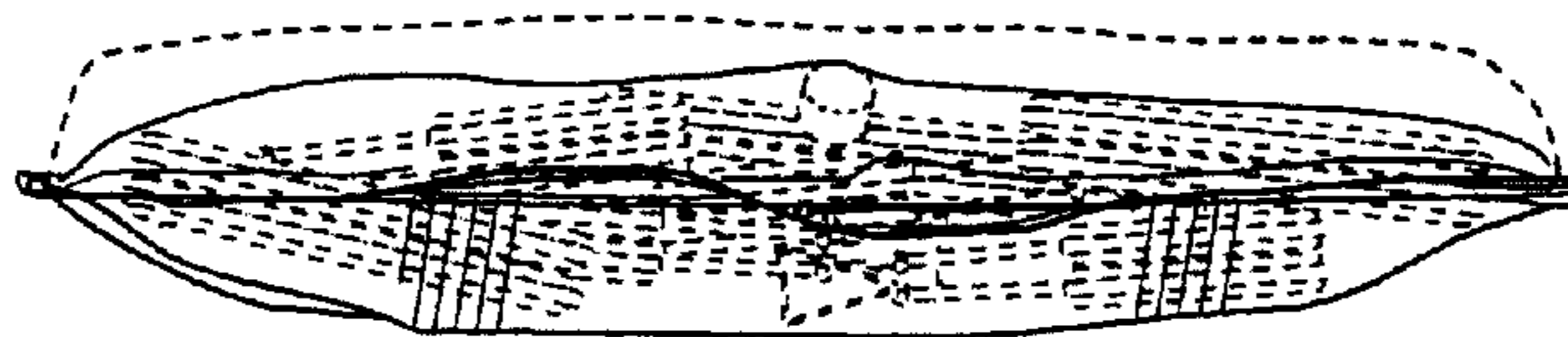

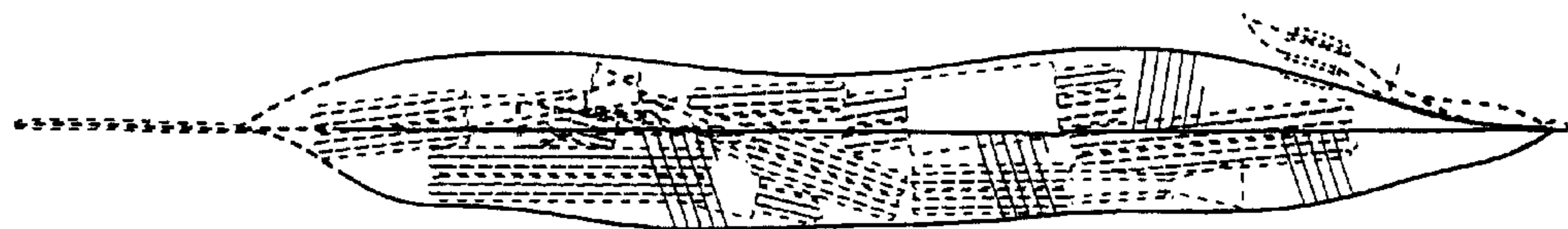

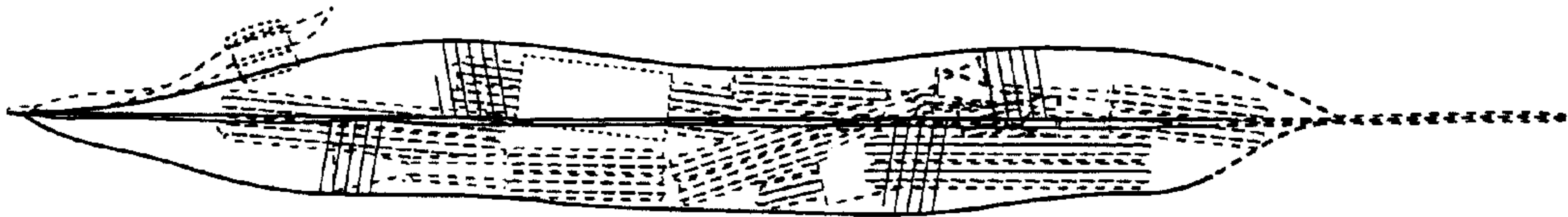

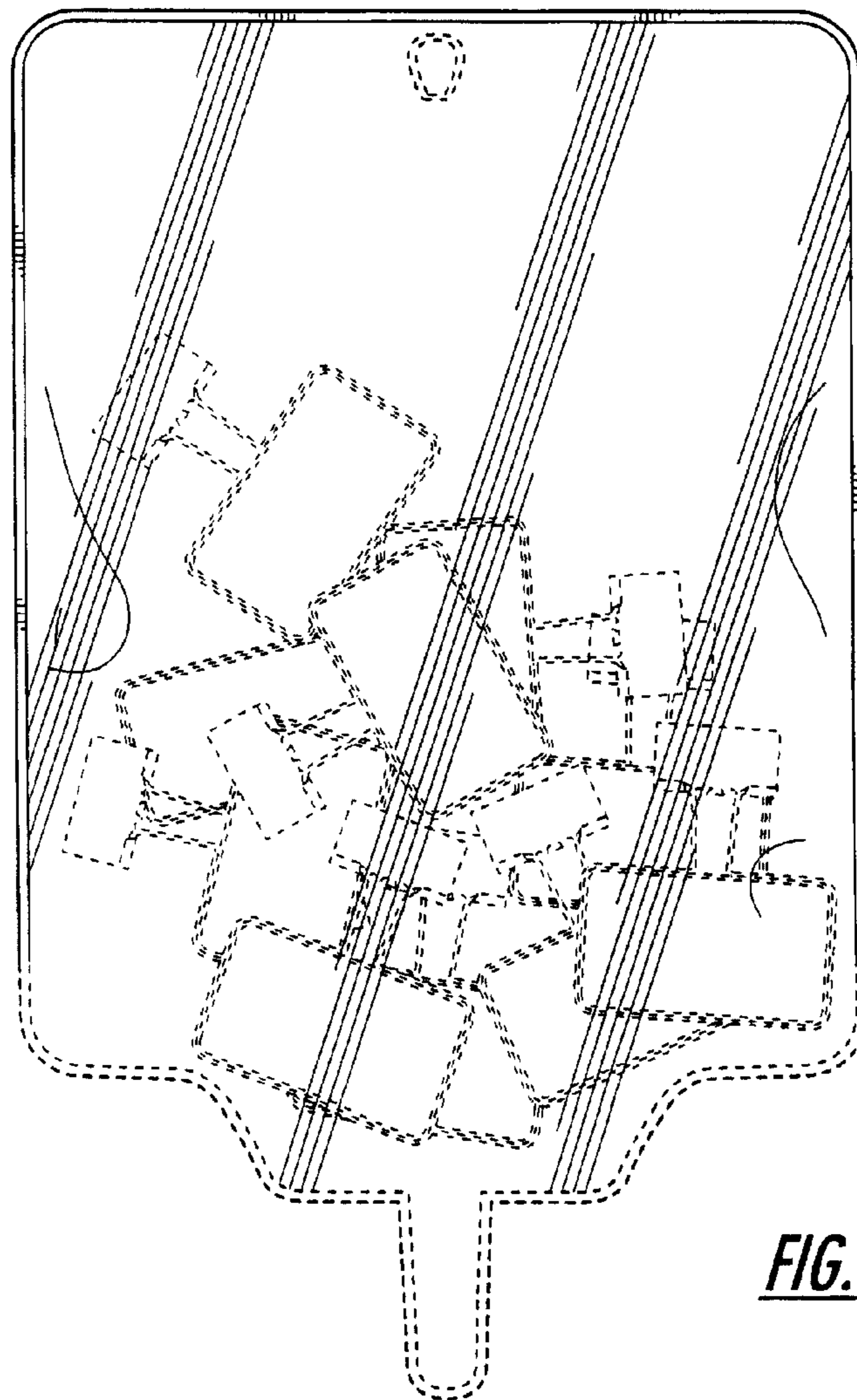

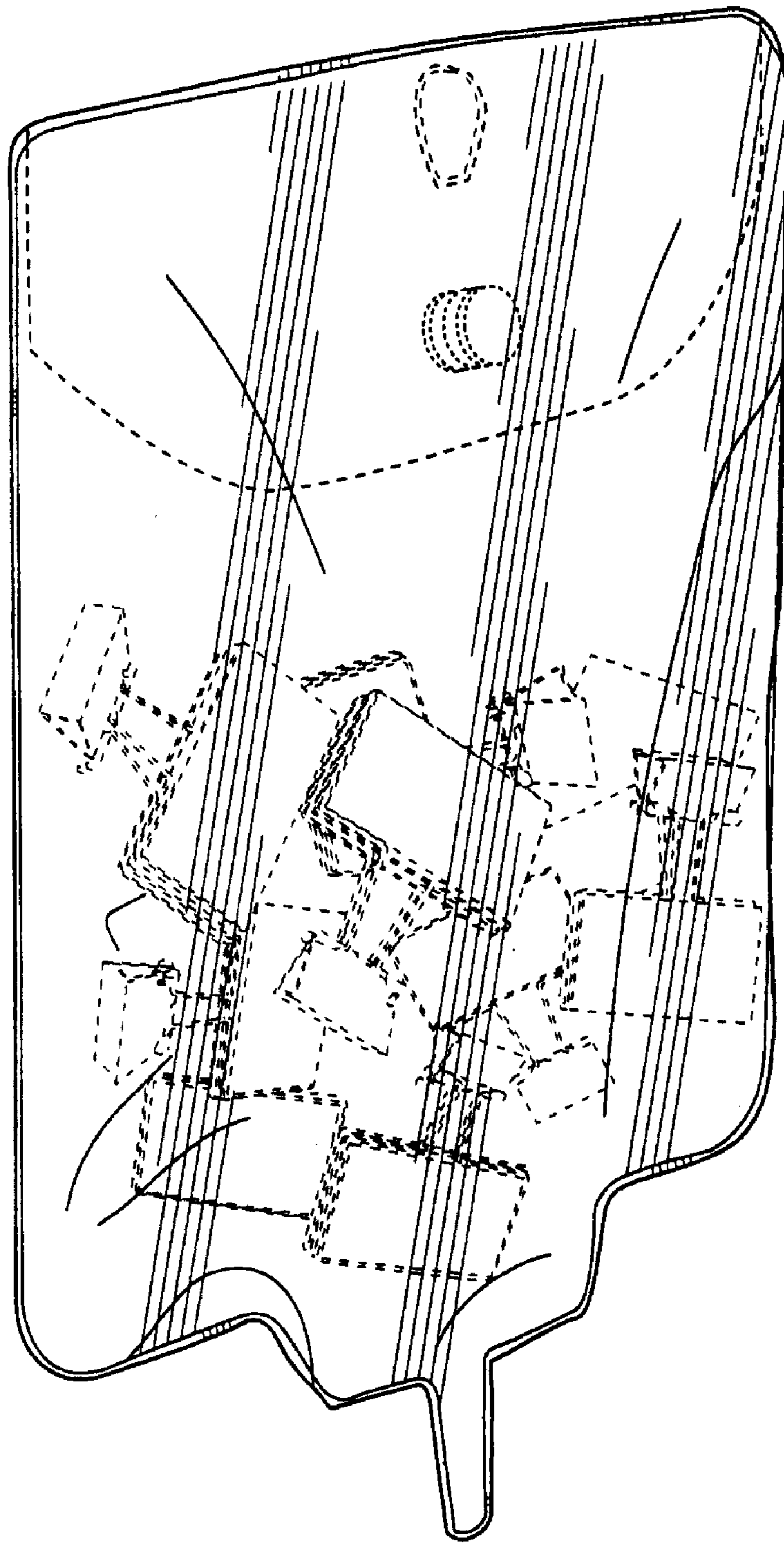

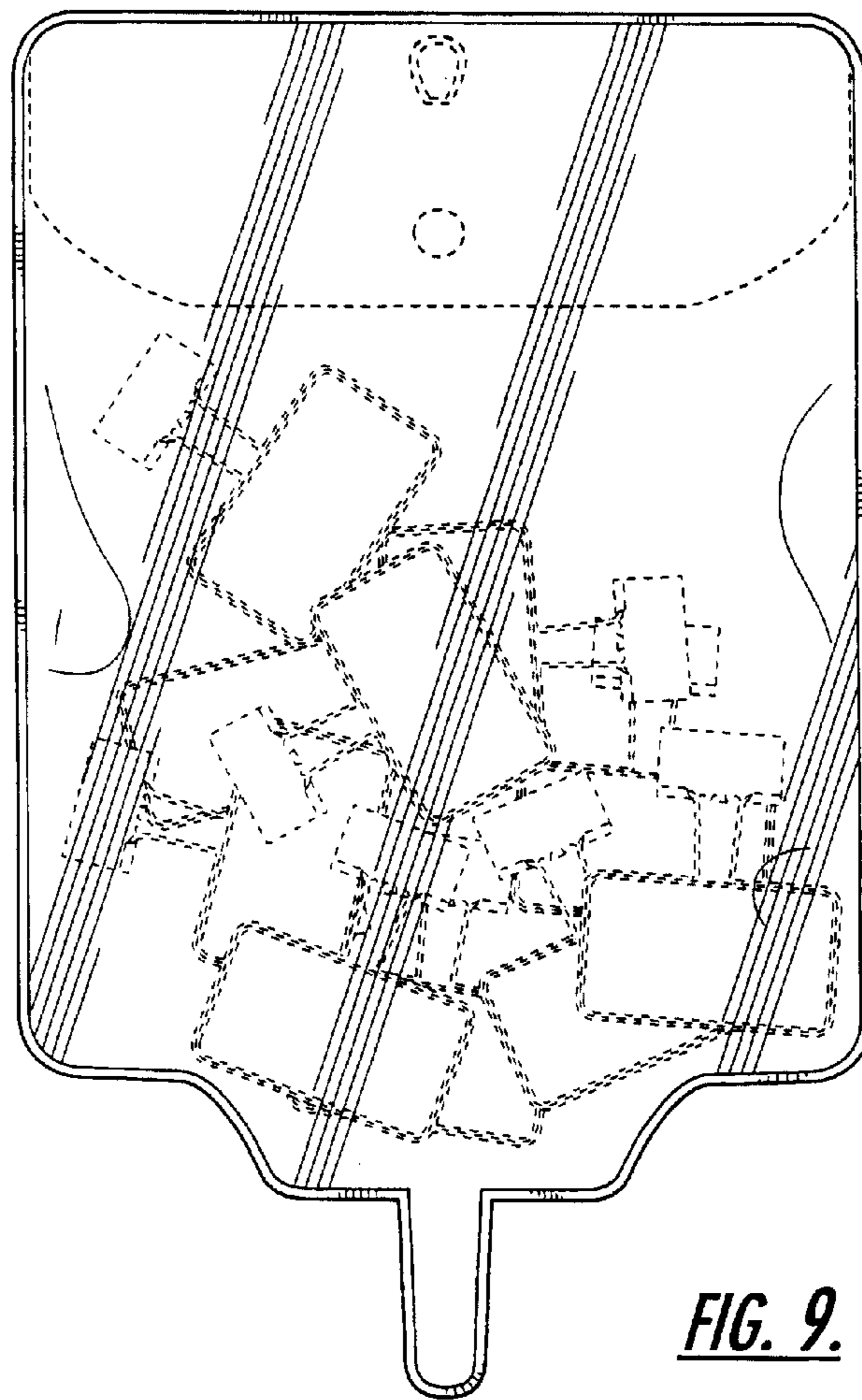

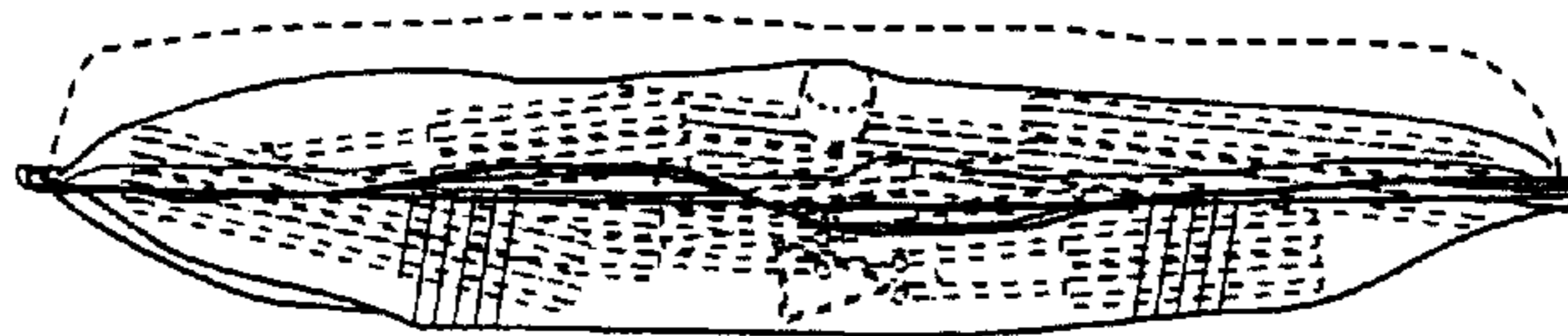

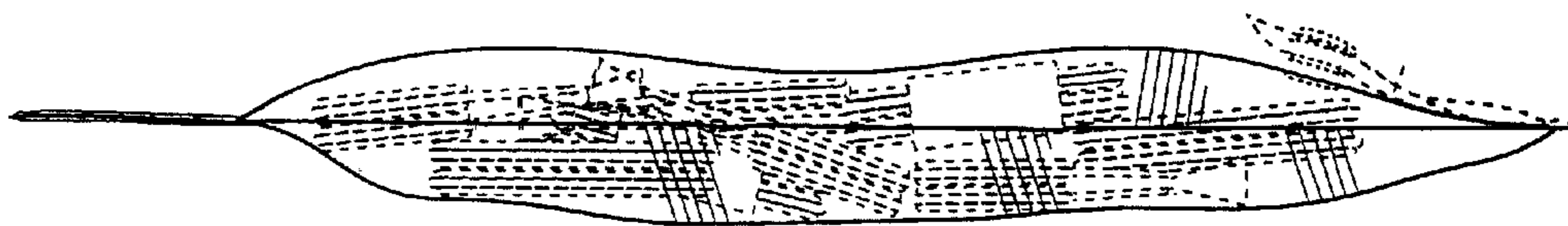

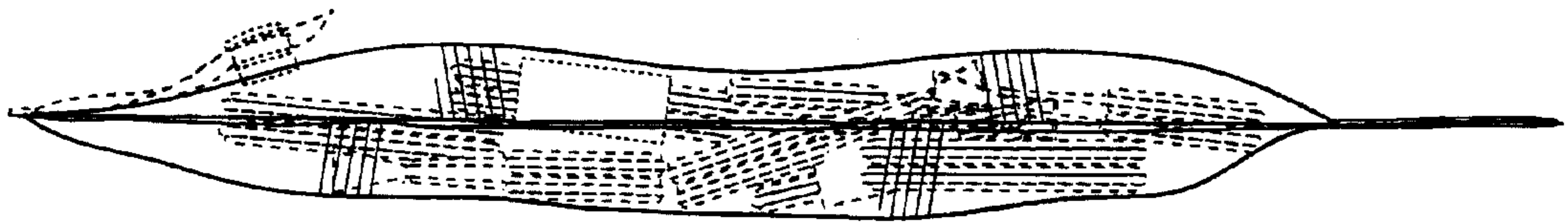

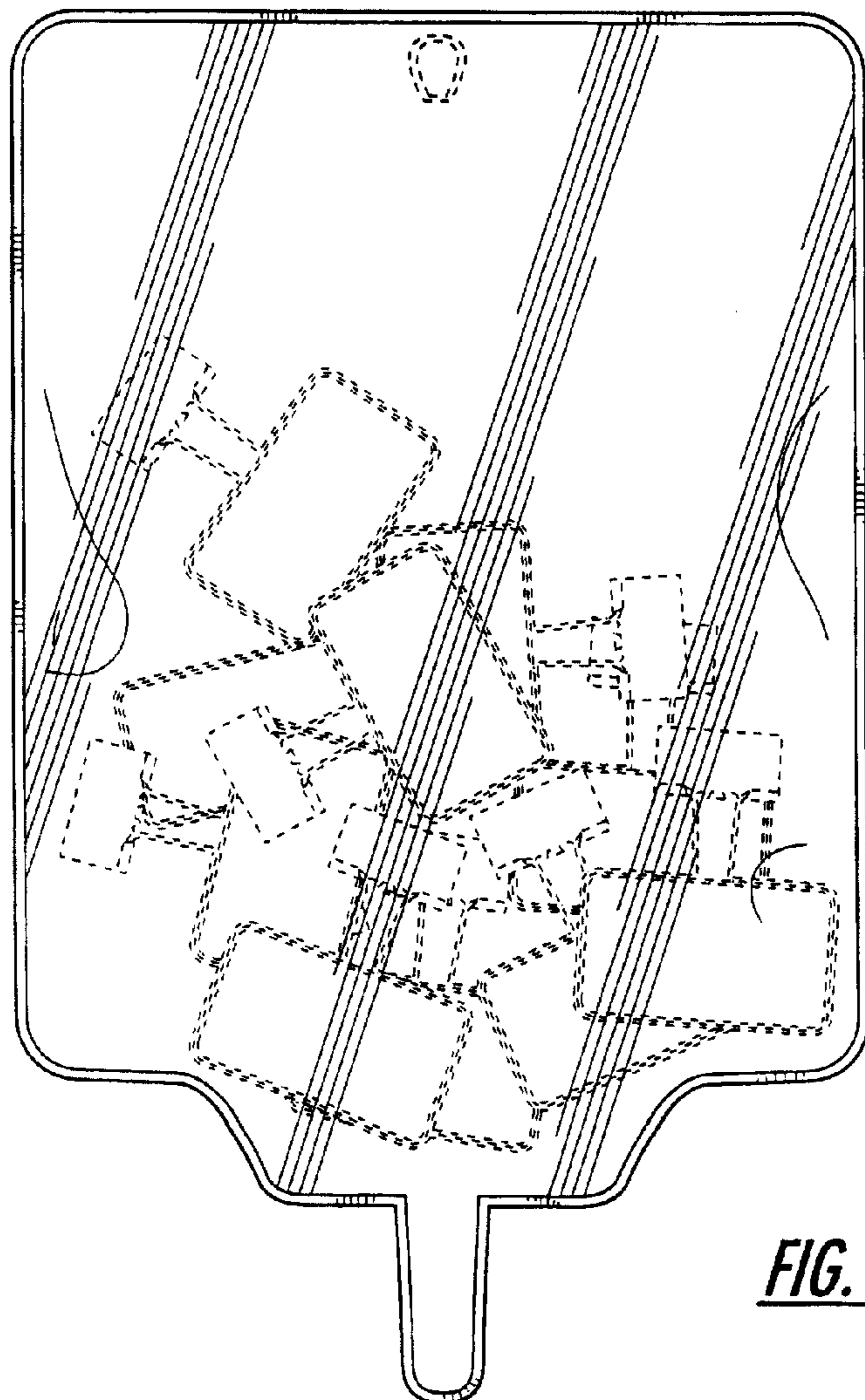
