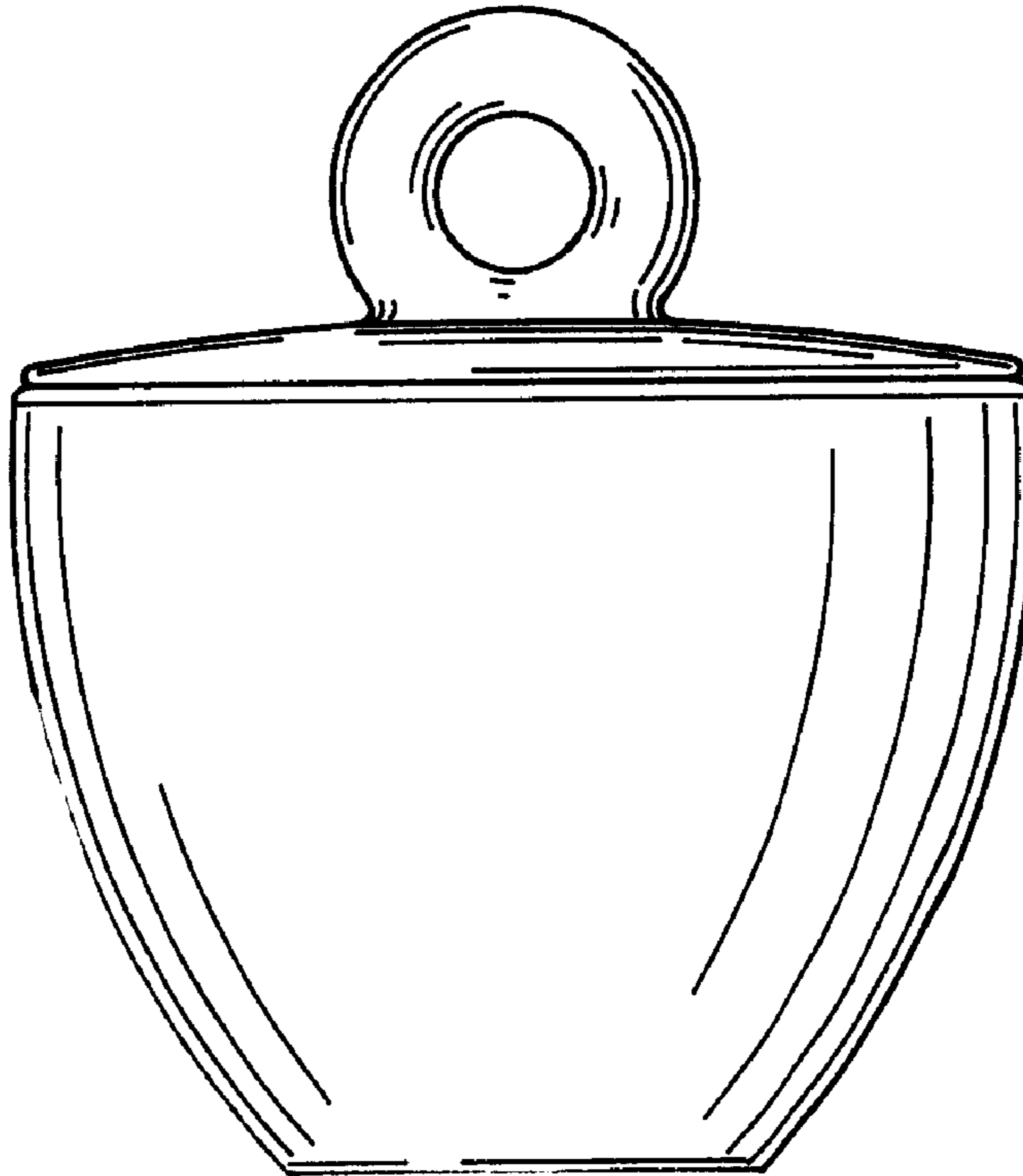
(57) **CLAIM**

The ornamental design for a sugar bowl and its lid, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a sugar bowl and its lid embodying my new design;
 FIG. 2 is a top plan view of the sugar bowl and its lid;
 FIG. 3 is a side elevational view of a sugar bowl and its lid with the lid removed for ease of illustration;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a side elevational view of a sugar bowl and its lid with the bowl removed for ease of illustration;
 FIG. 7 is a side elevational view perpendicular to FIG. 6;
 FIG. 8 is a top plan view thereof; and,
 FIG. 9 is a bottom plan view thereof.

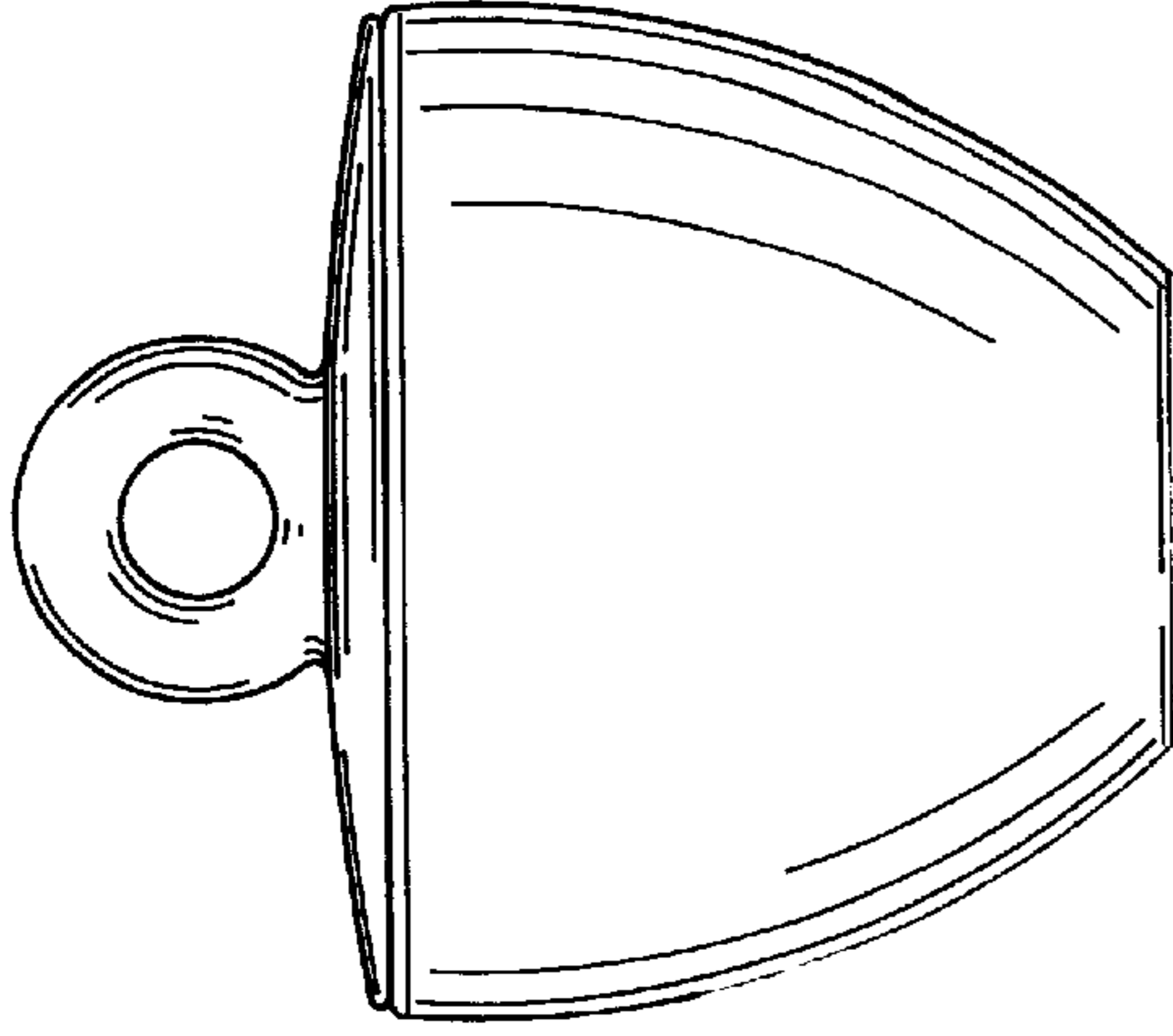

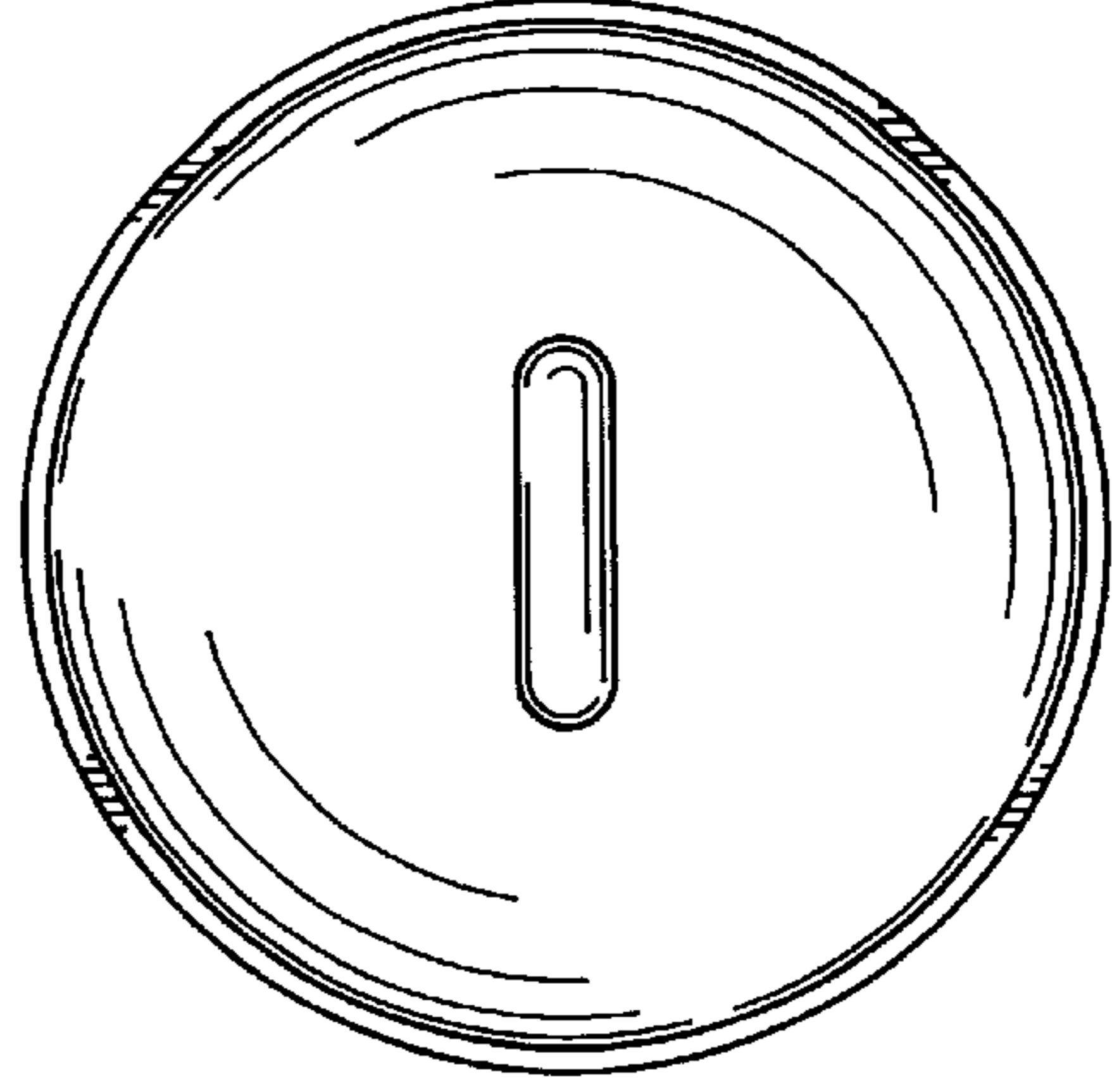

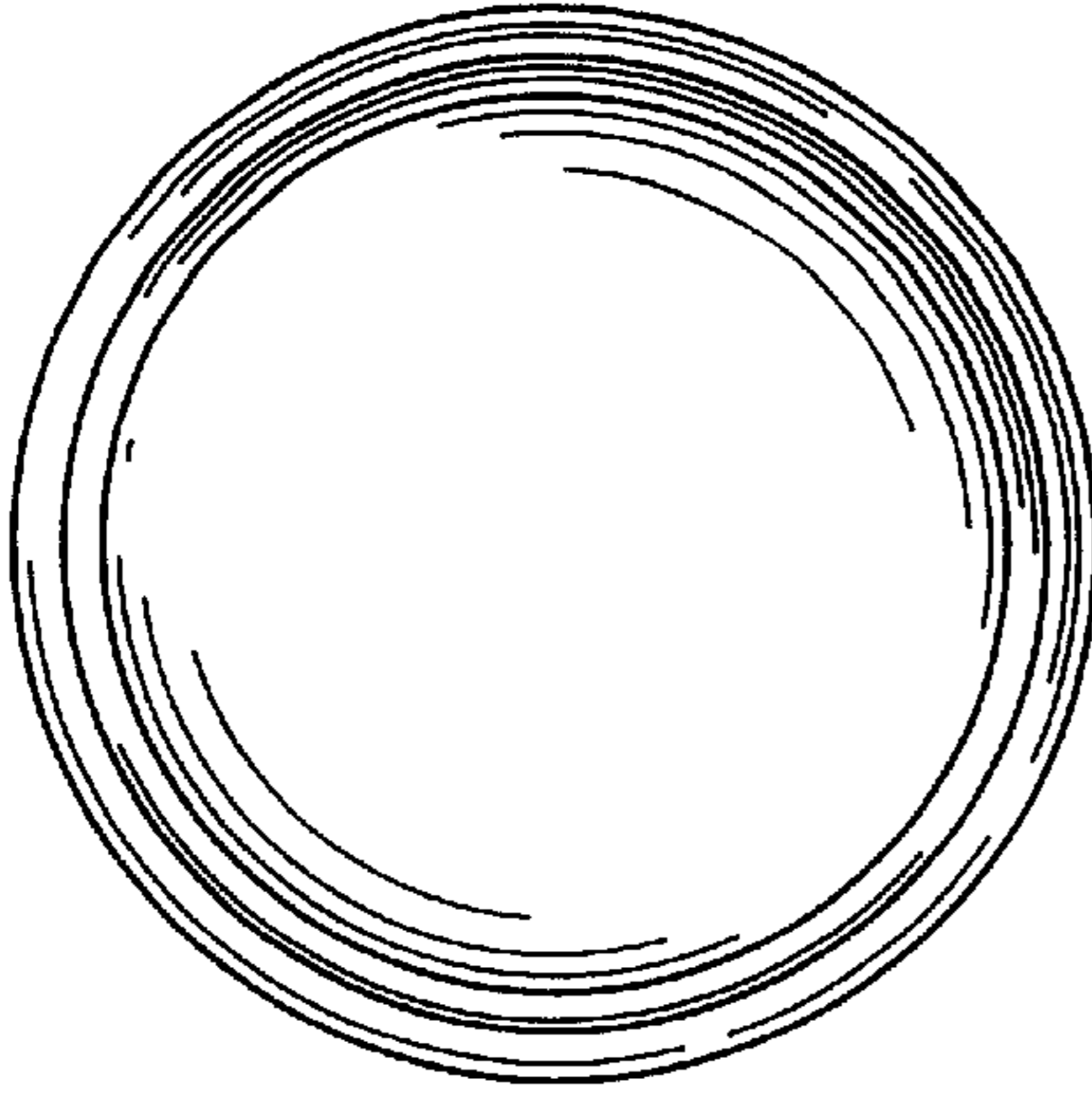

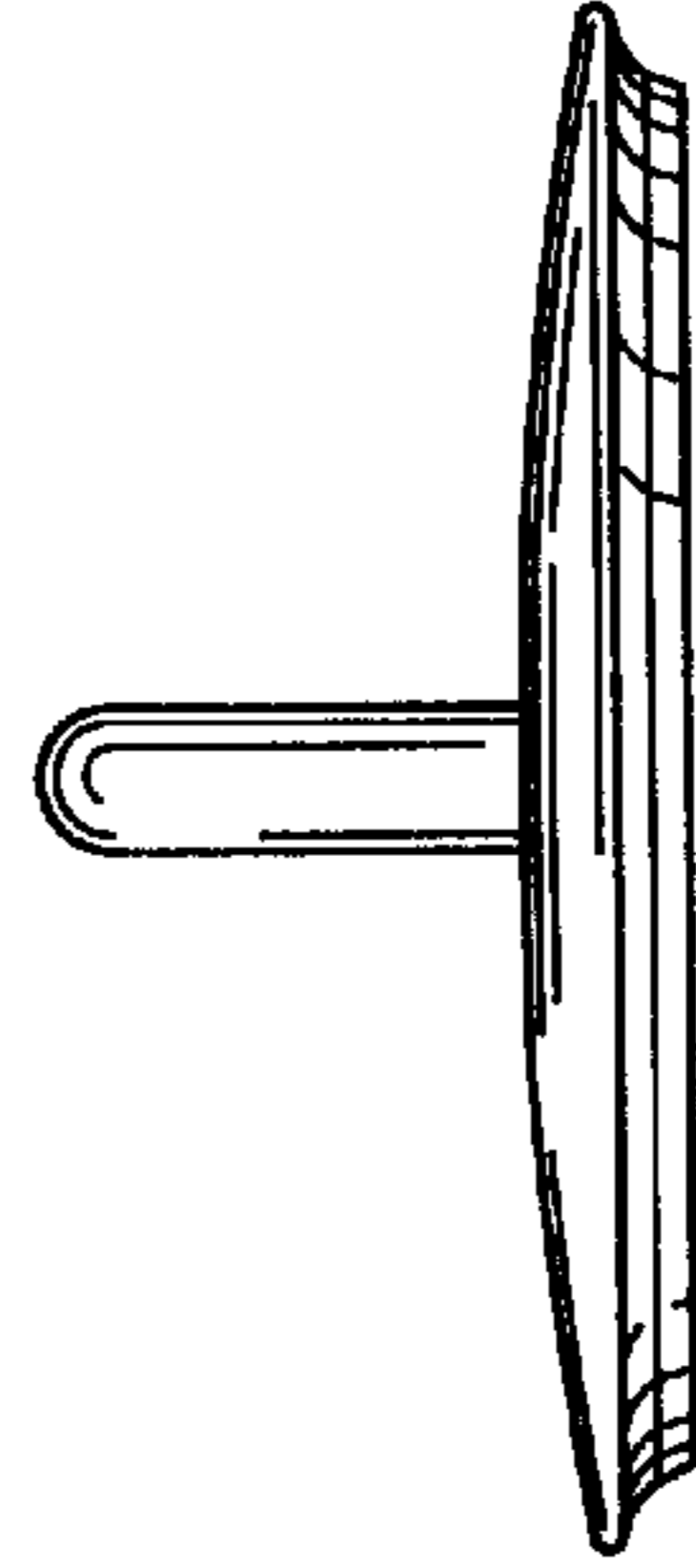

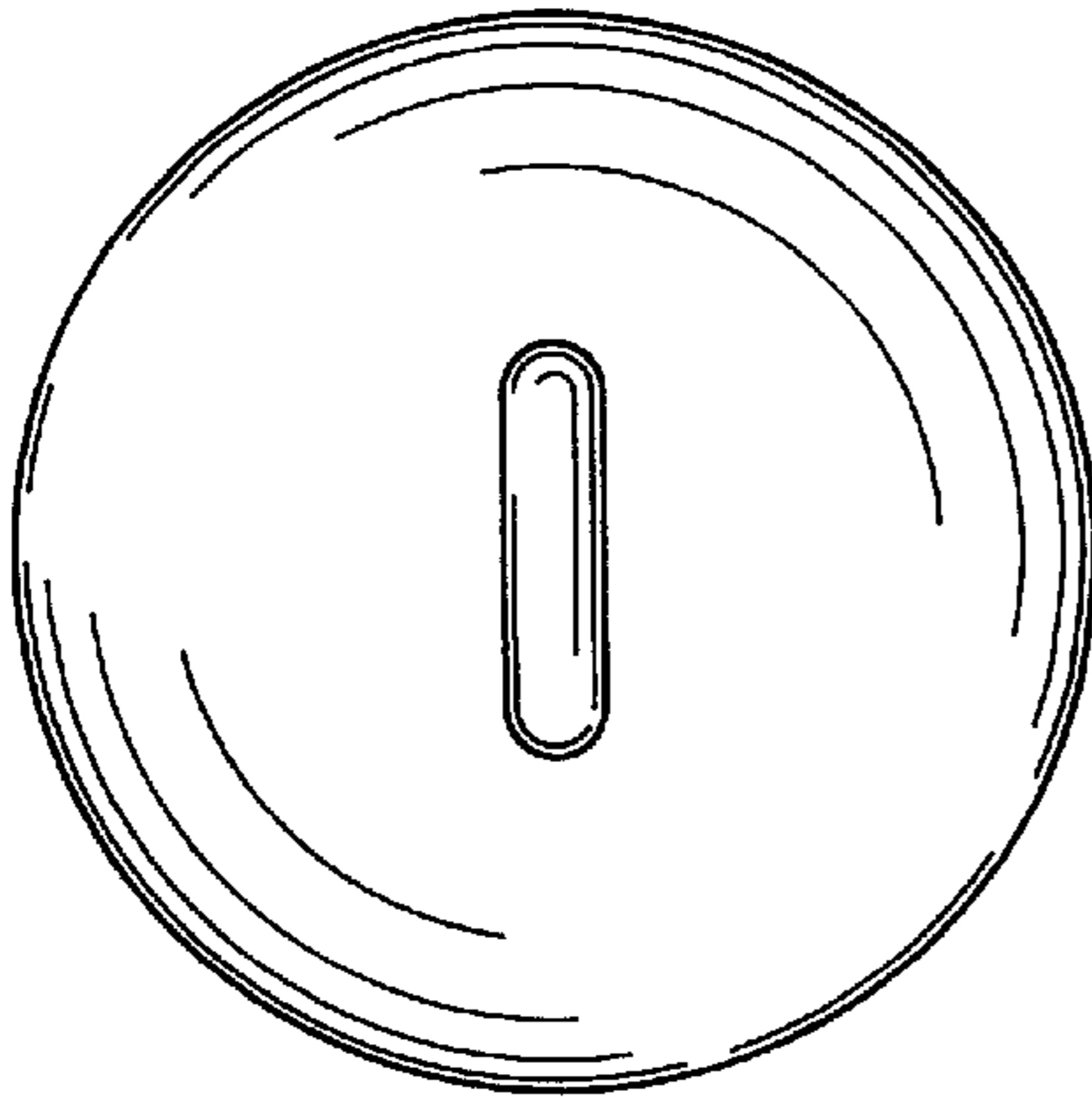

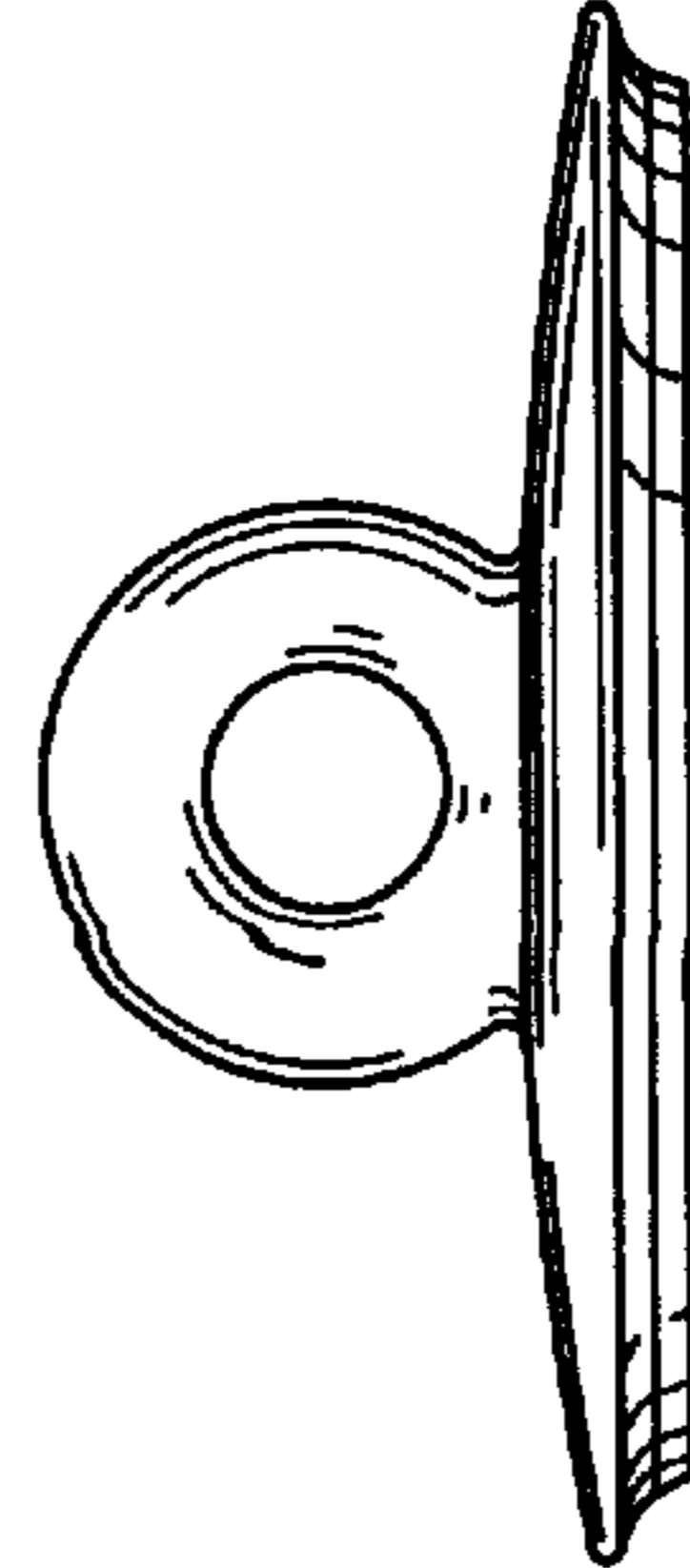

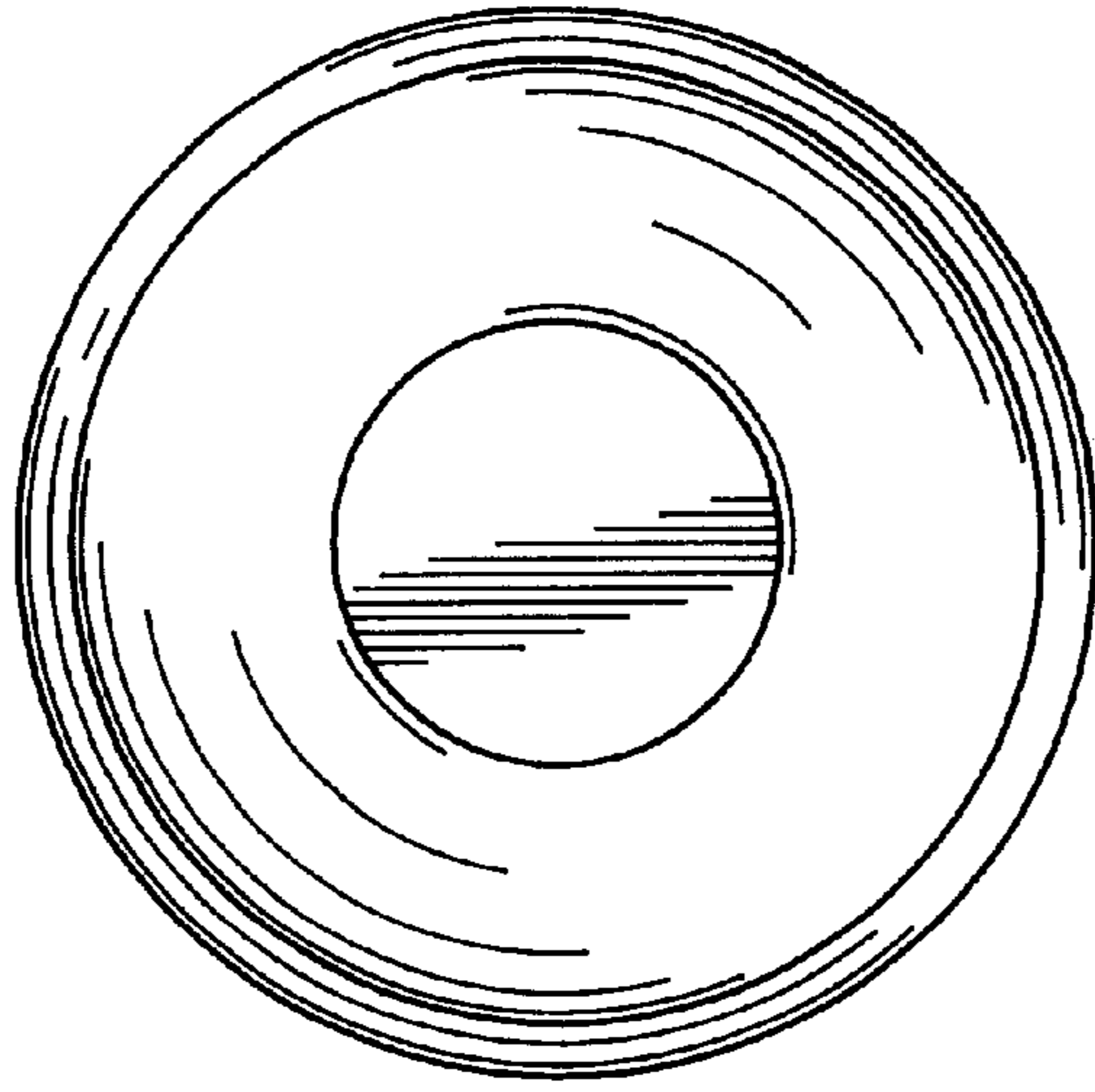

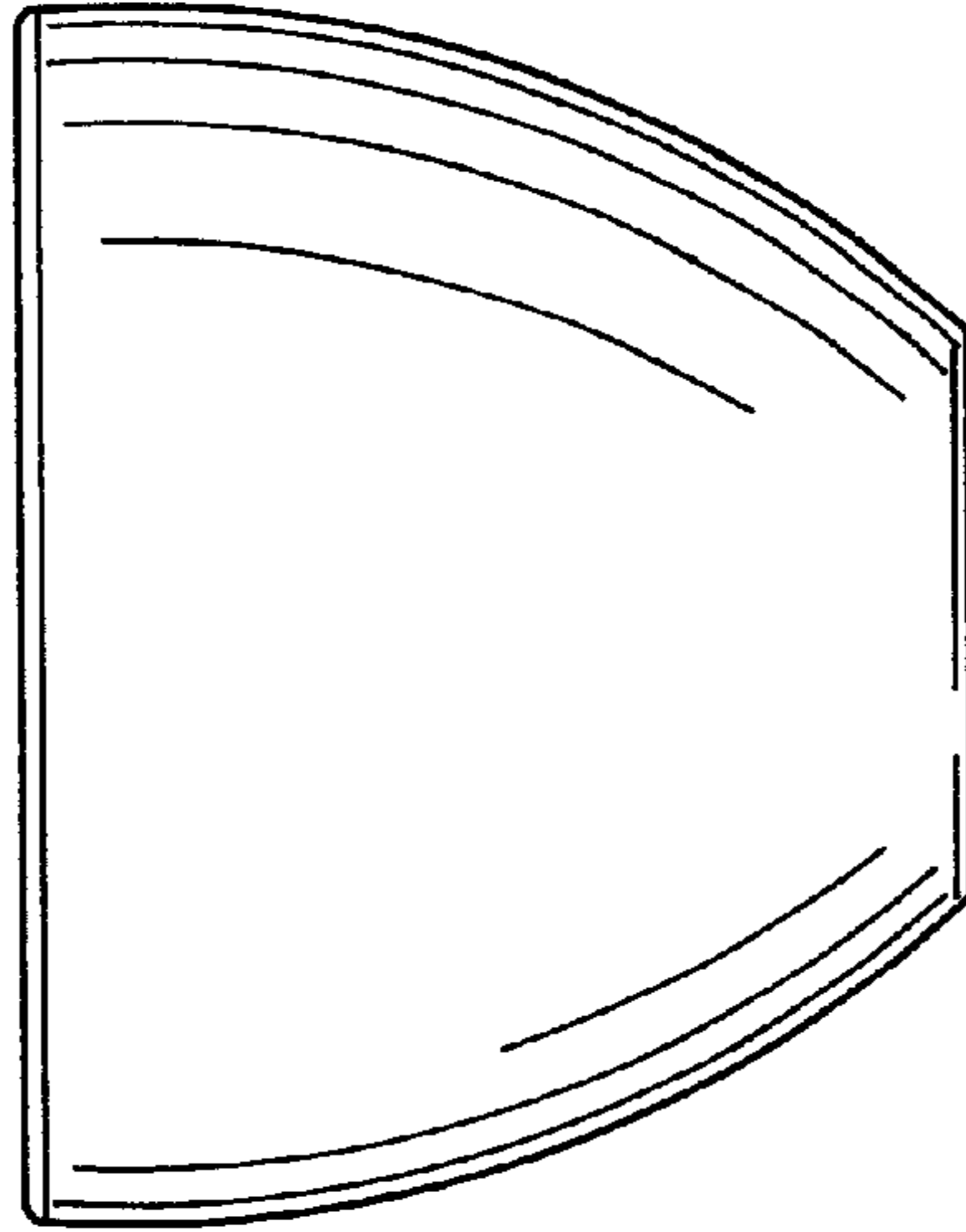

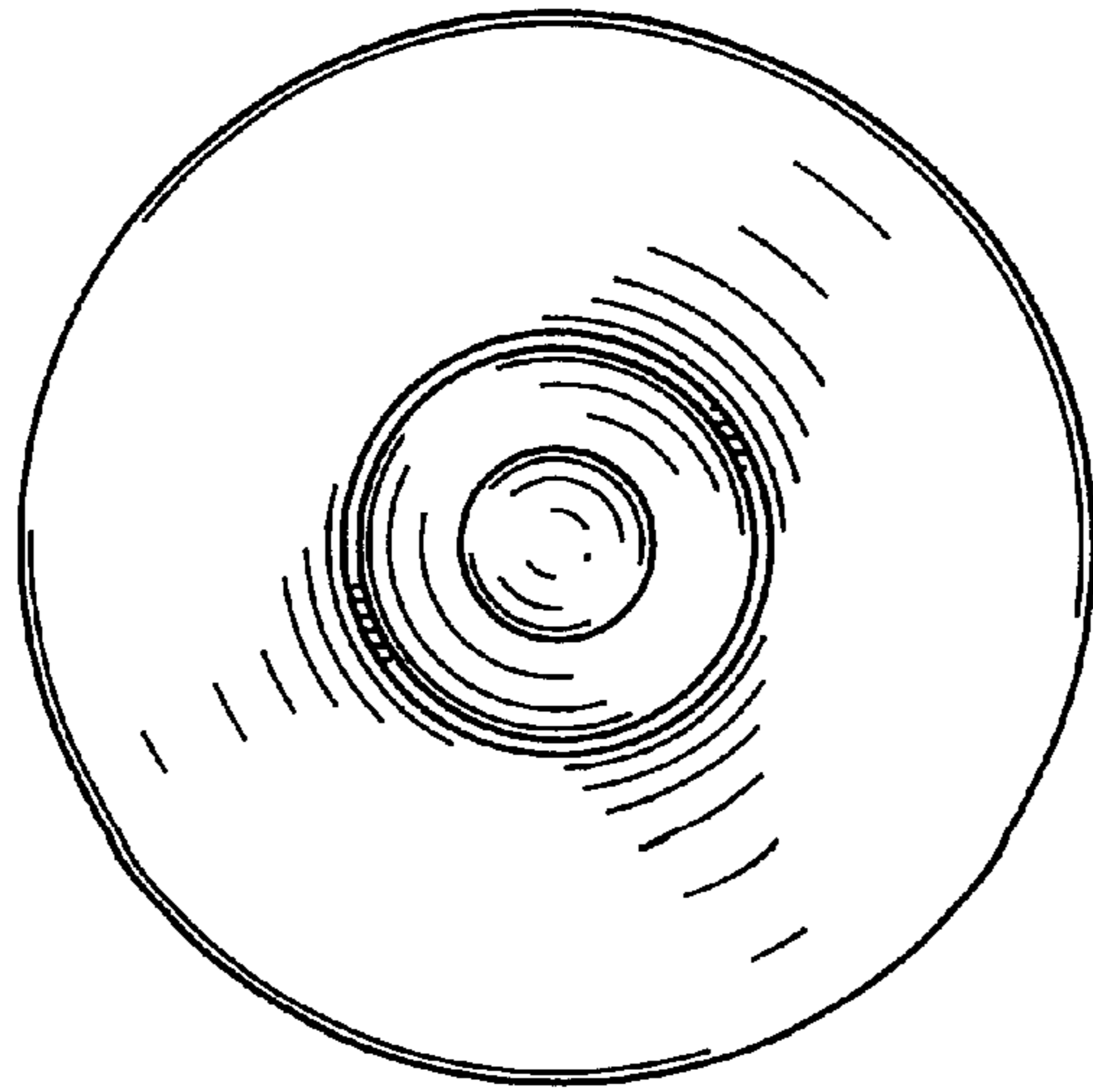
