(57) **CLAIM**

The ornamental design for a handle for a multipurpose hand tool, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view from the upper left end of a handle for a multipurpose hand tool, showing my new design;

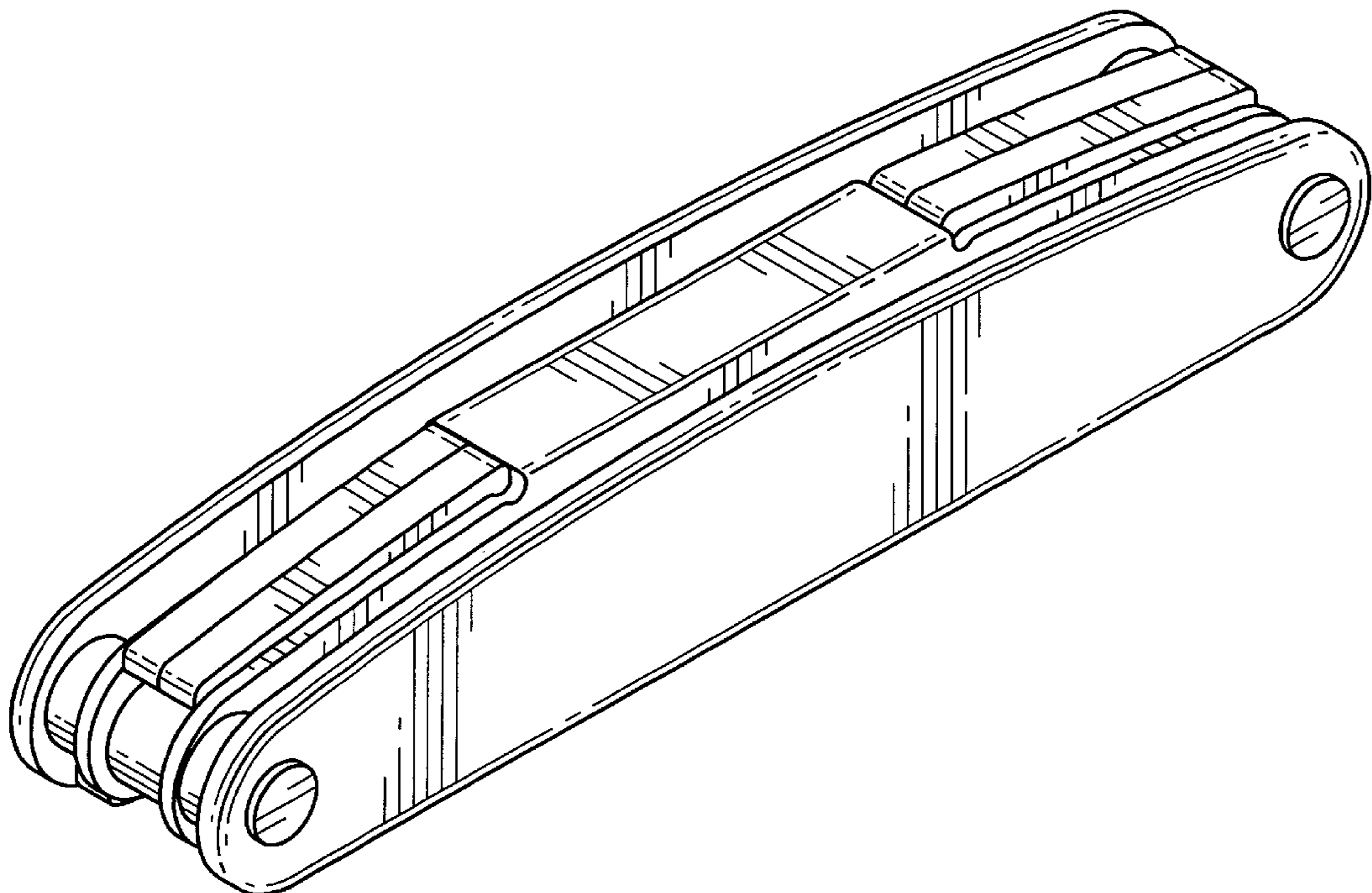
FIG. 2 is a side elevational view thereof, the opposite side elevational view thereof being identical with FIG. 2;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof; and,

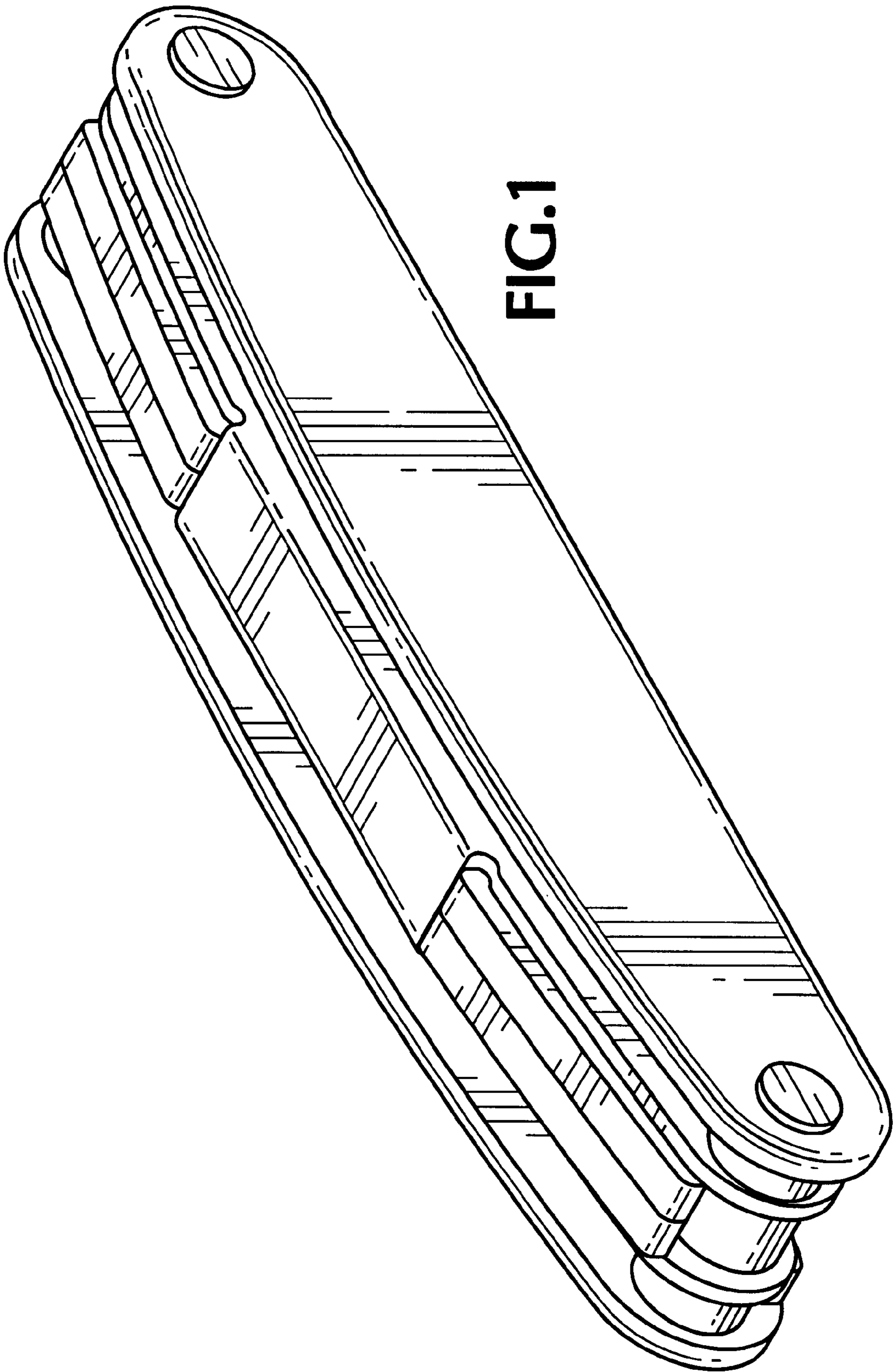

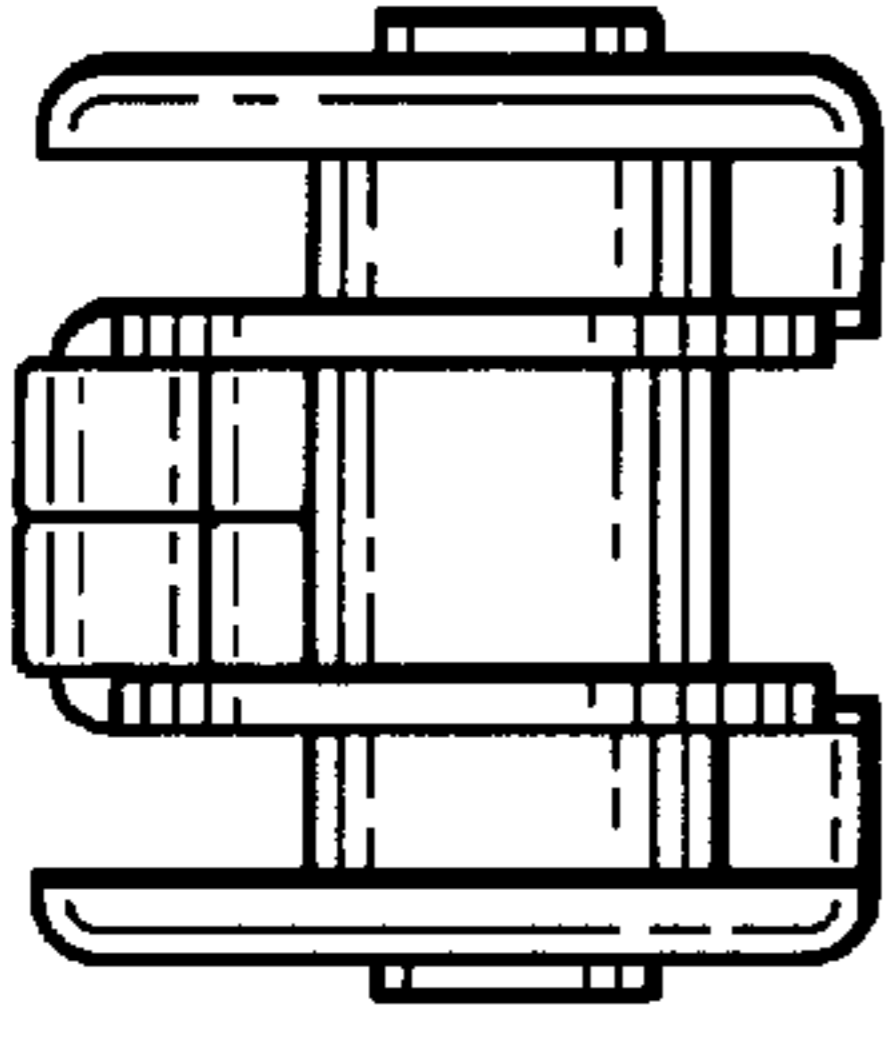

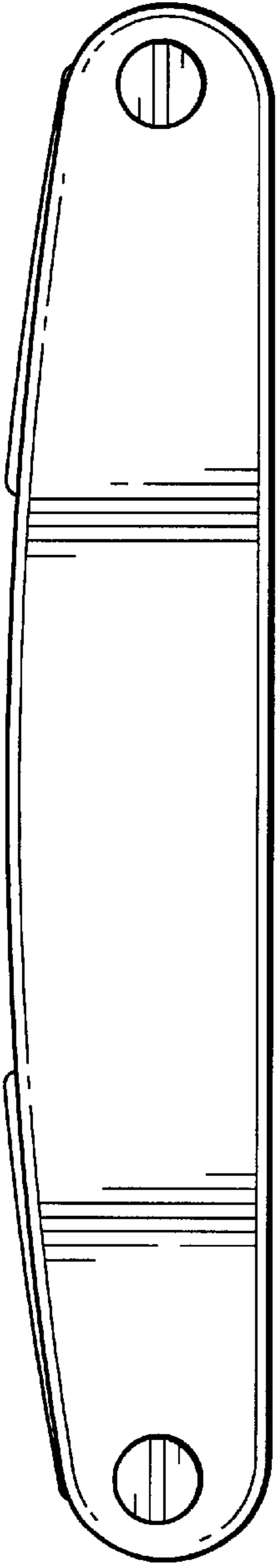

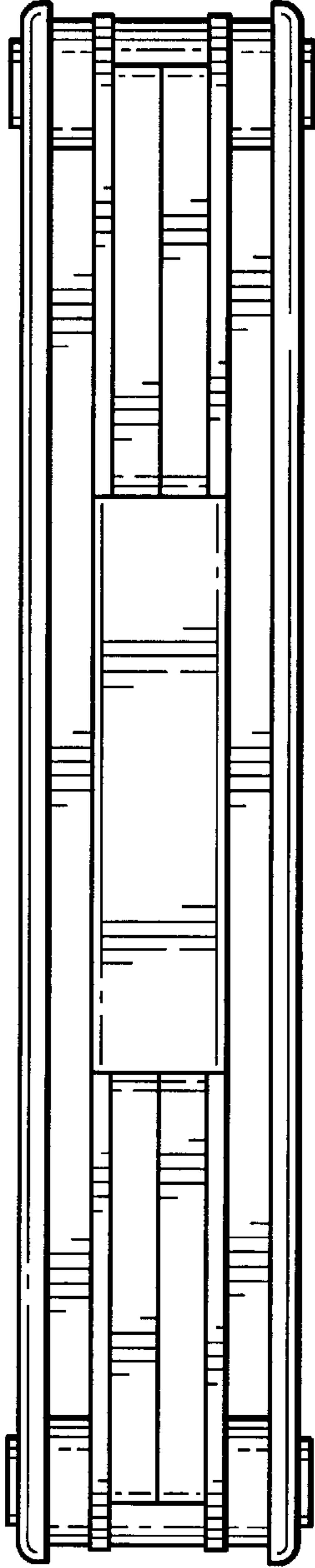

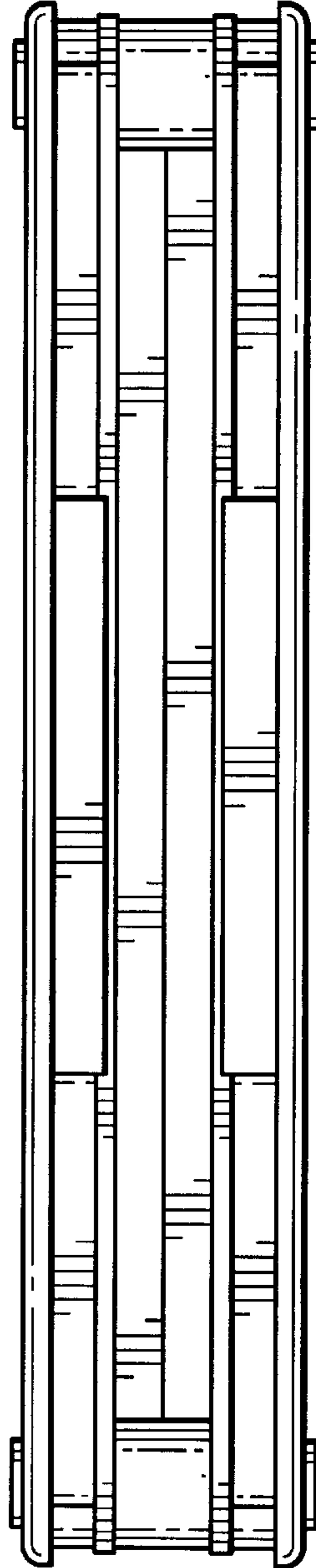
