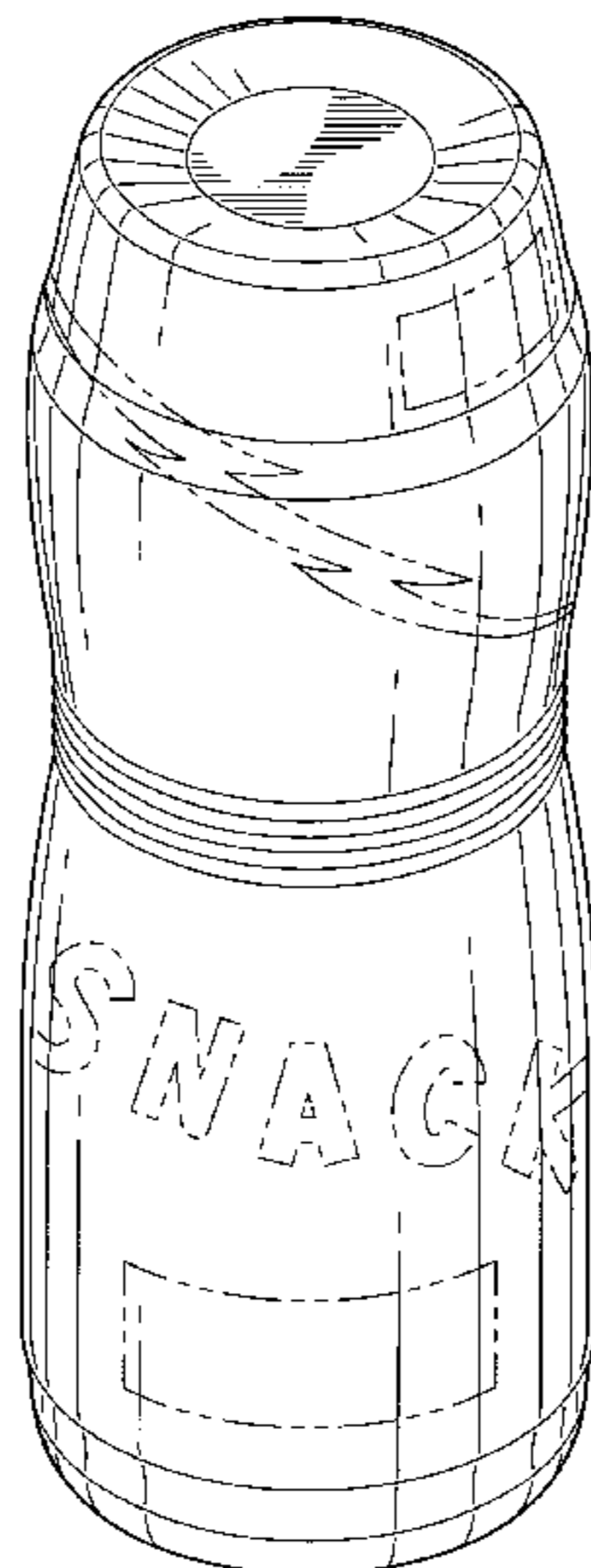
(57) **CLAIM**

The ornamental design for a consumables container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the consumables container of the present invention;
FIG. 2 is a side view in elevation of the consumables container of FIG. 1, all side views being identical with the exception of the broken line showing of unclaimed indicia.
FIG. 3 is a top plan view of the consumables container of FIG. 1; and,
FIG. 4 is a bottom view of the consumables container of FIG. 1.
The broken line showing of indicia in FIG. 1 is for environmental purposes only and forms no part for the claimed design.

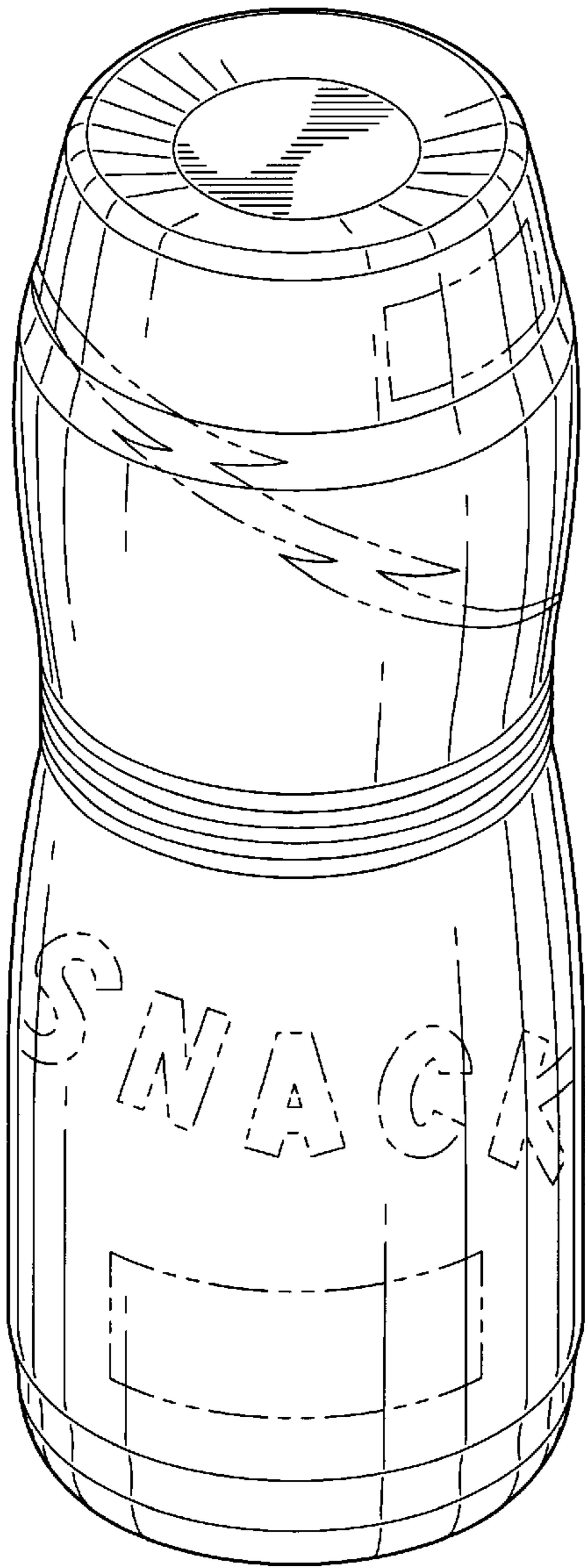

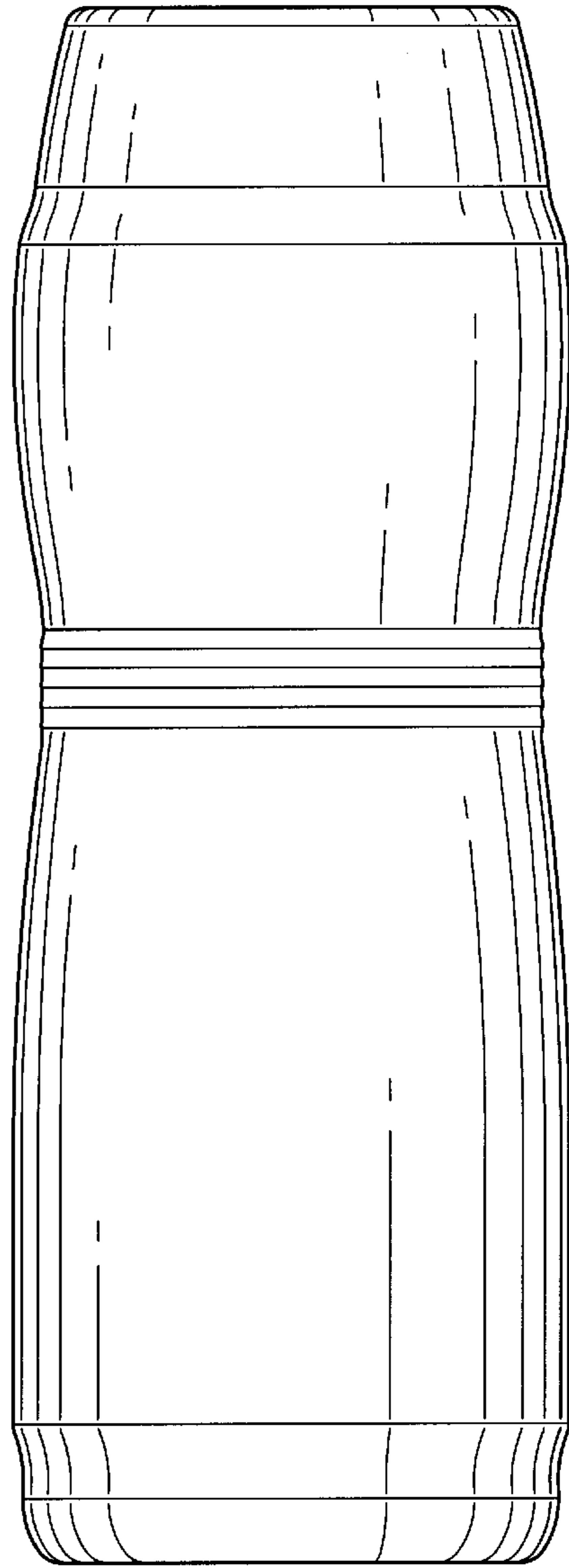

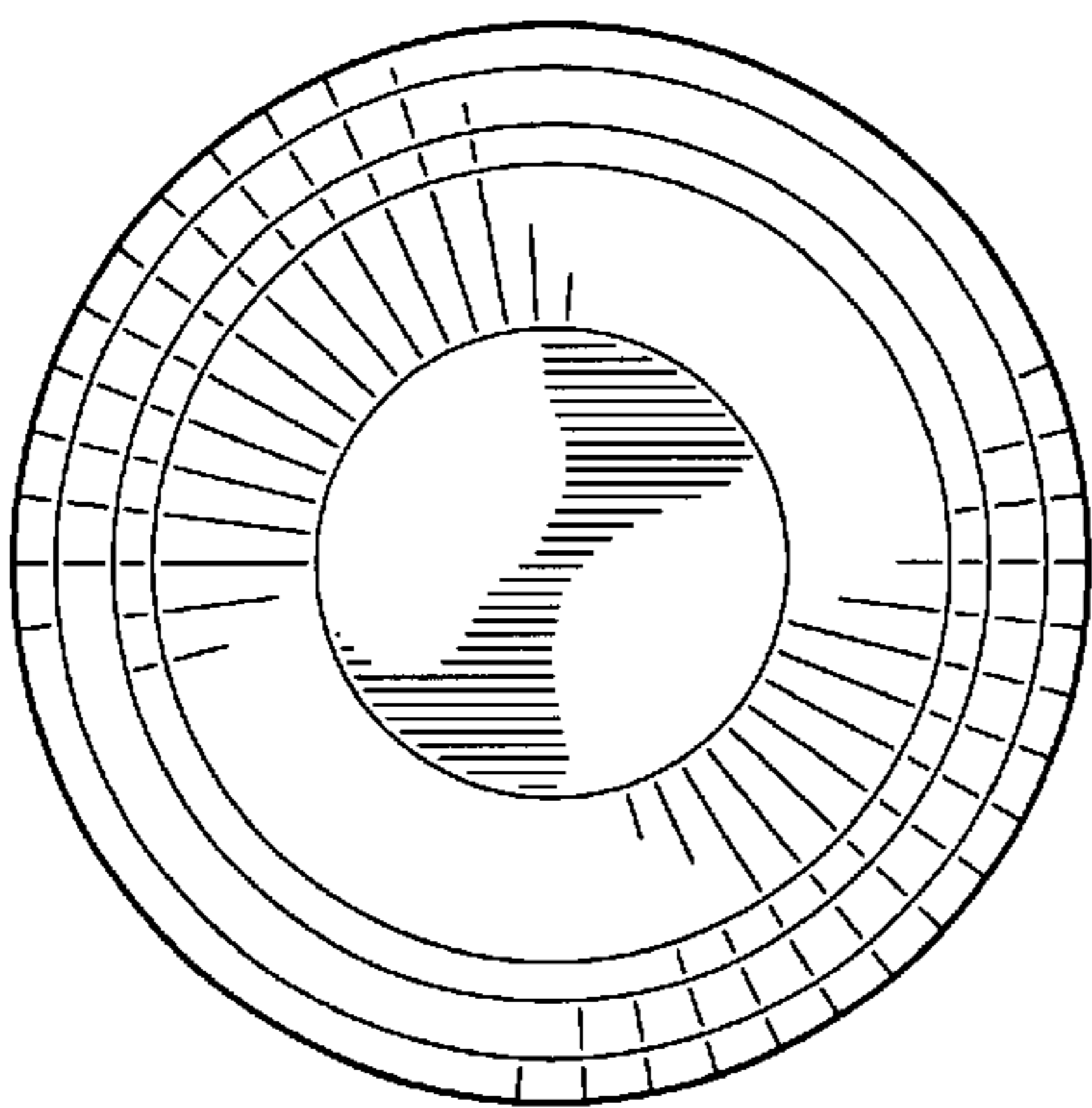

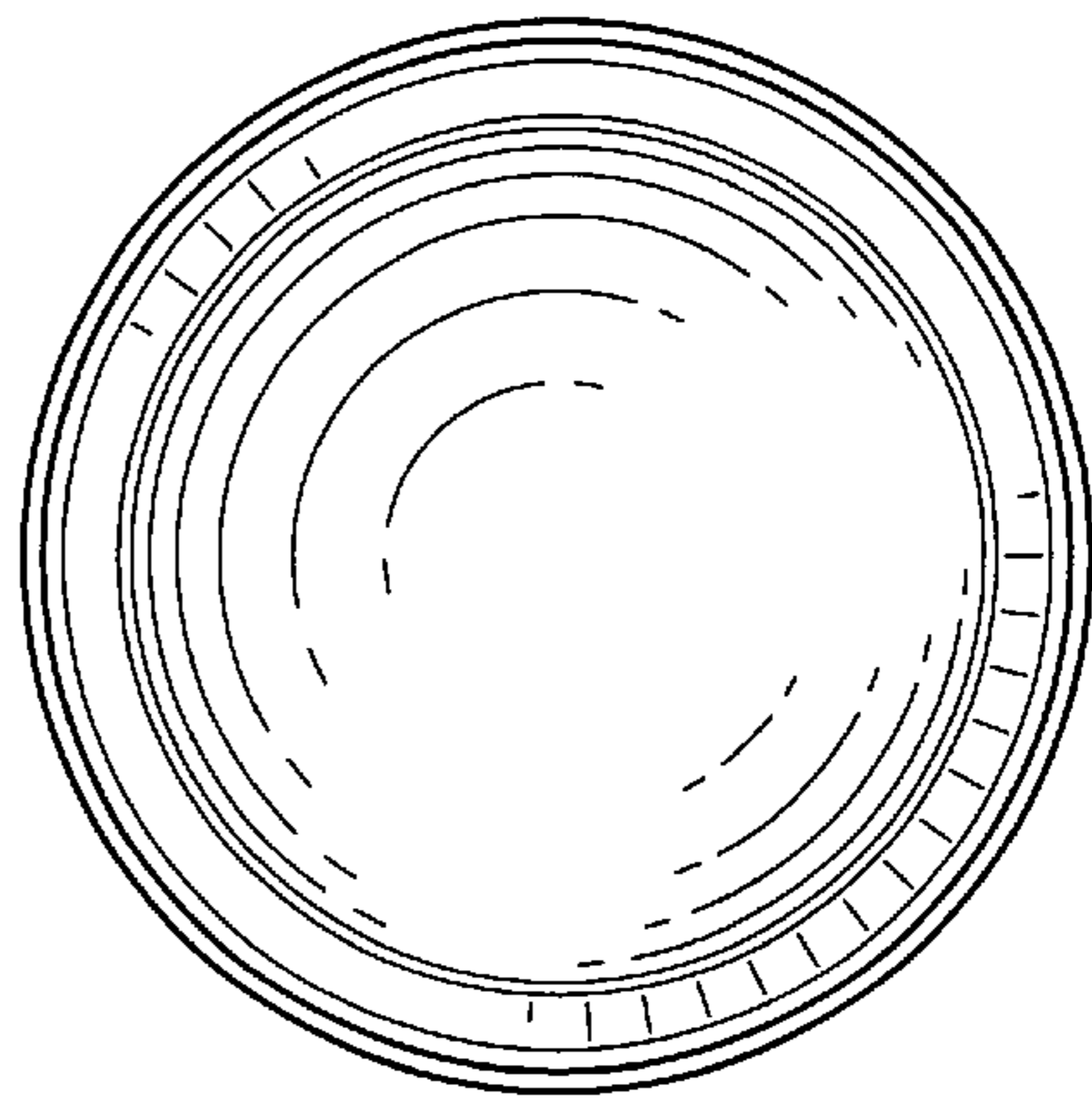
