(57) **CLAIM**

The ornamental design for the vehicle floor mat, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a vehicle floor mat showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right-side elevational view thereof, with the left-side elevational view being a mirror image thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a reduced bottom plan view thereof;

FIG. 6 is a cross-sectional view thereof taken along line 6—6 of FIG. 1.

FIG. 7 is a top plan view of a second embodiment of a vehicle floor mat showing my new design;

FIG. 8 is a front elevational view thereof;

FIG. 9 is a right-side elevational view thereof, with the left-side elevational view thereof being a mirror image;

FIG. 10 is a rear elevational view thereof.

FIG. 11 is a top plan view of a third embodiment of the vehicle floor mat showing my new design;

FIG. 12 is a front elevational view thereof;

FIG. 13 is a rear elevational view thereof; and,

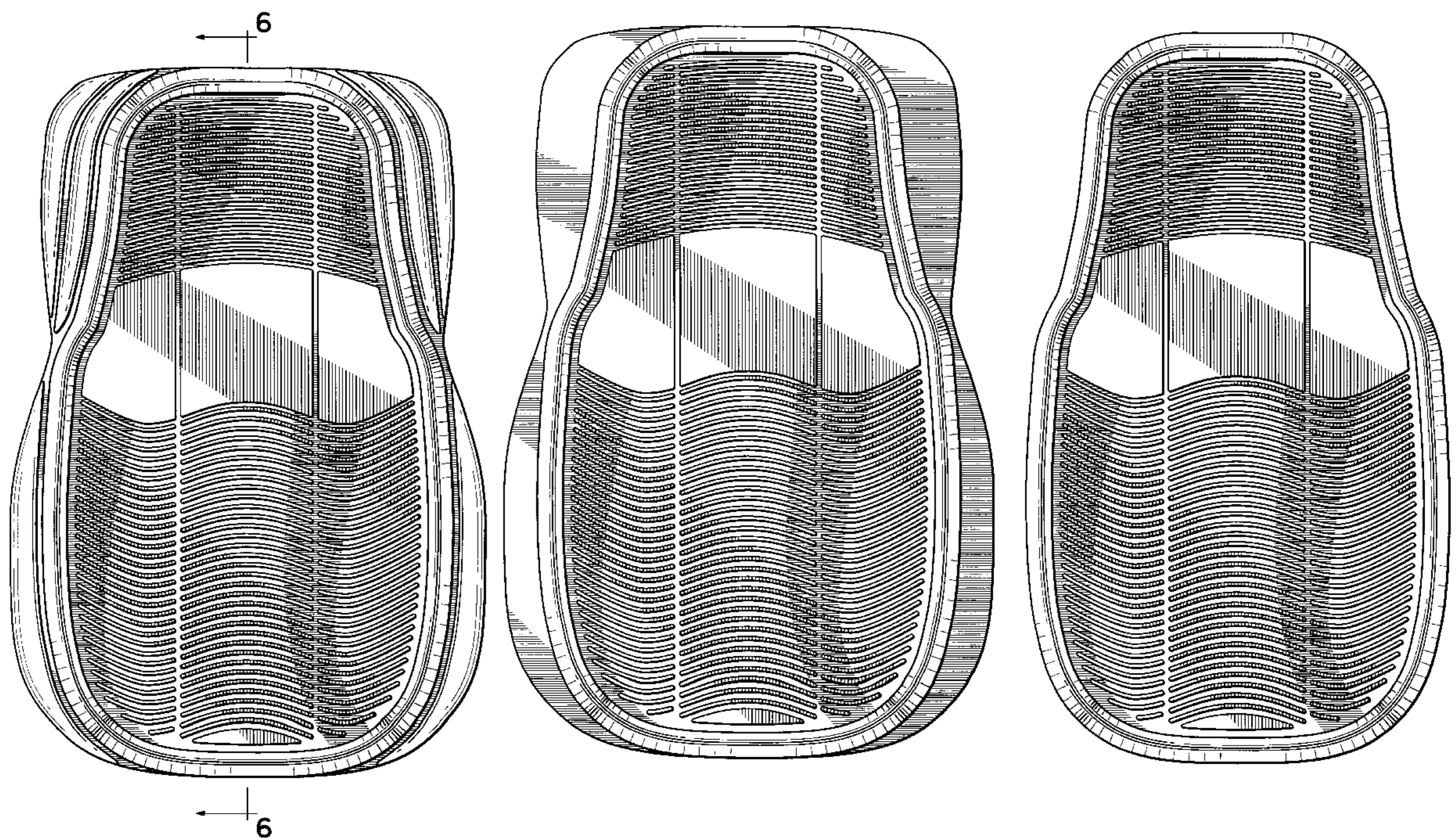
FIG. 14 is a reduced bottom plan view thereof.

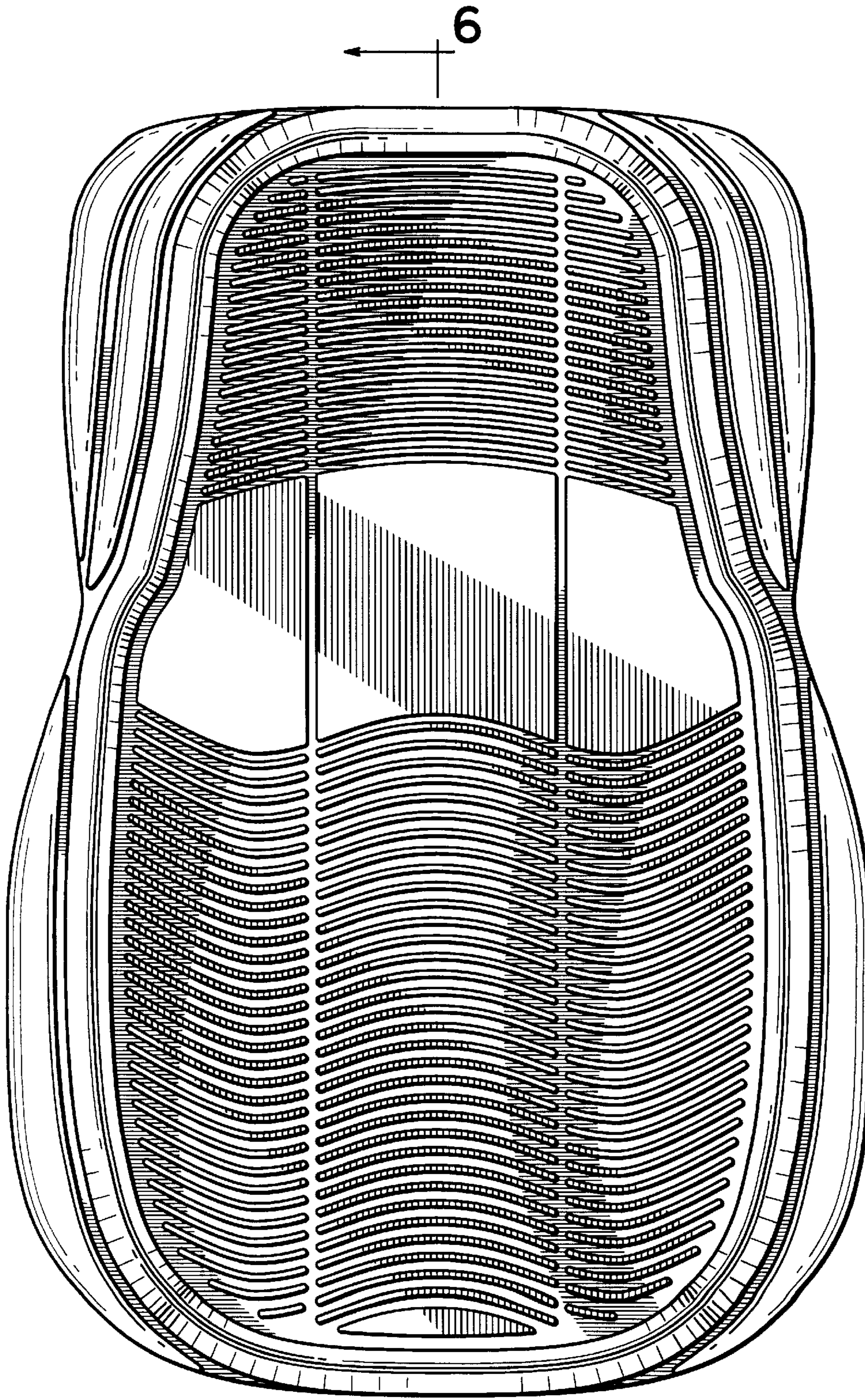
The right-side elevational view thereof is identical to FIG. 9; and

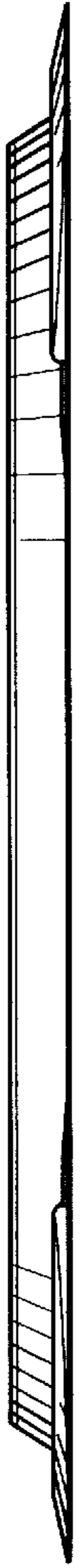

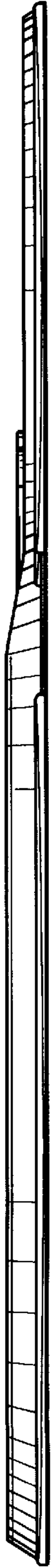

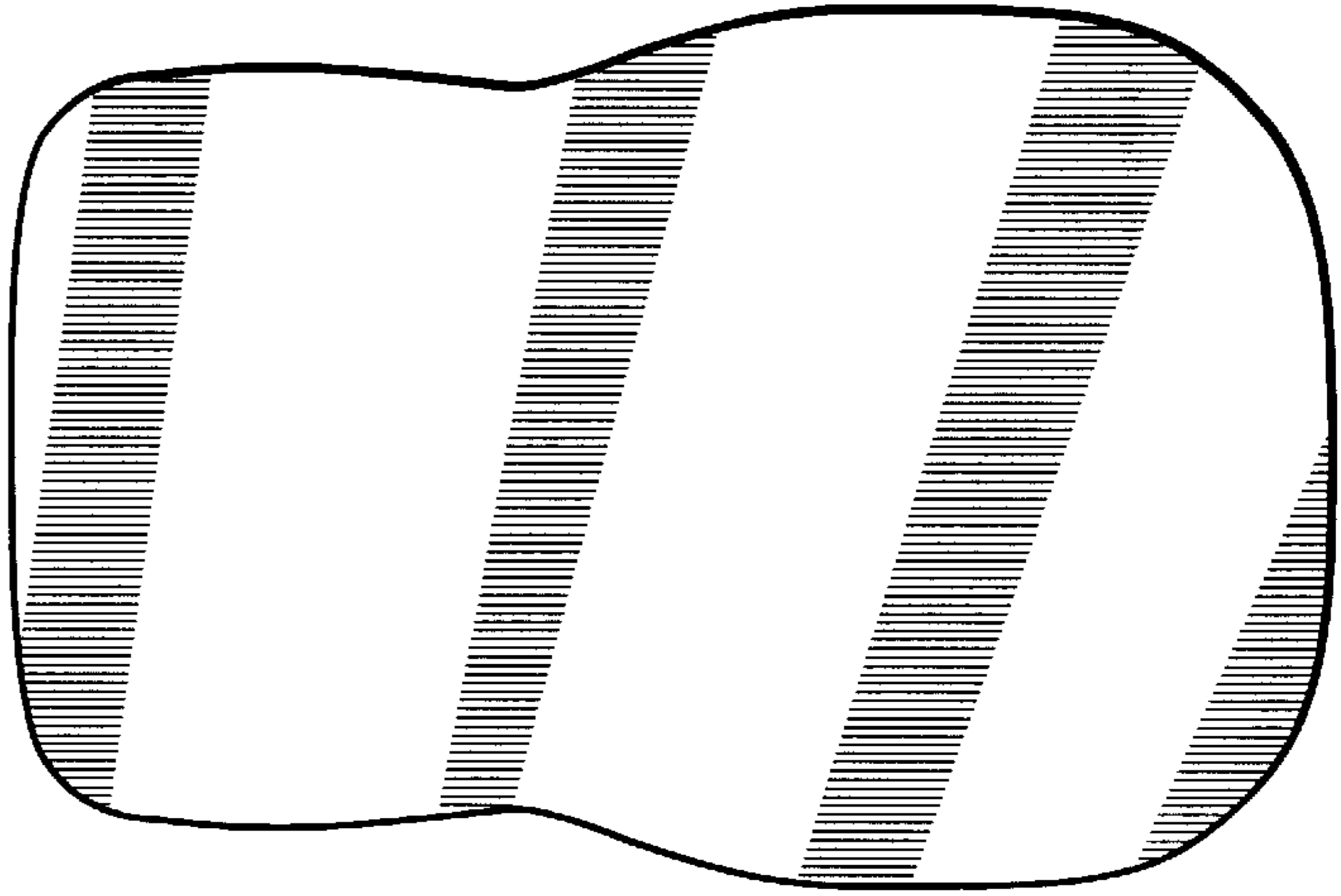

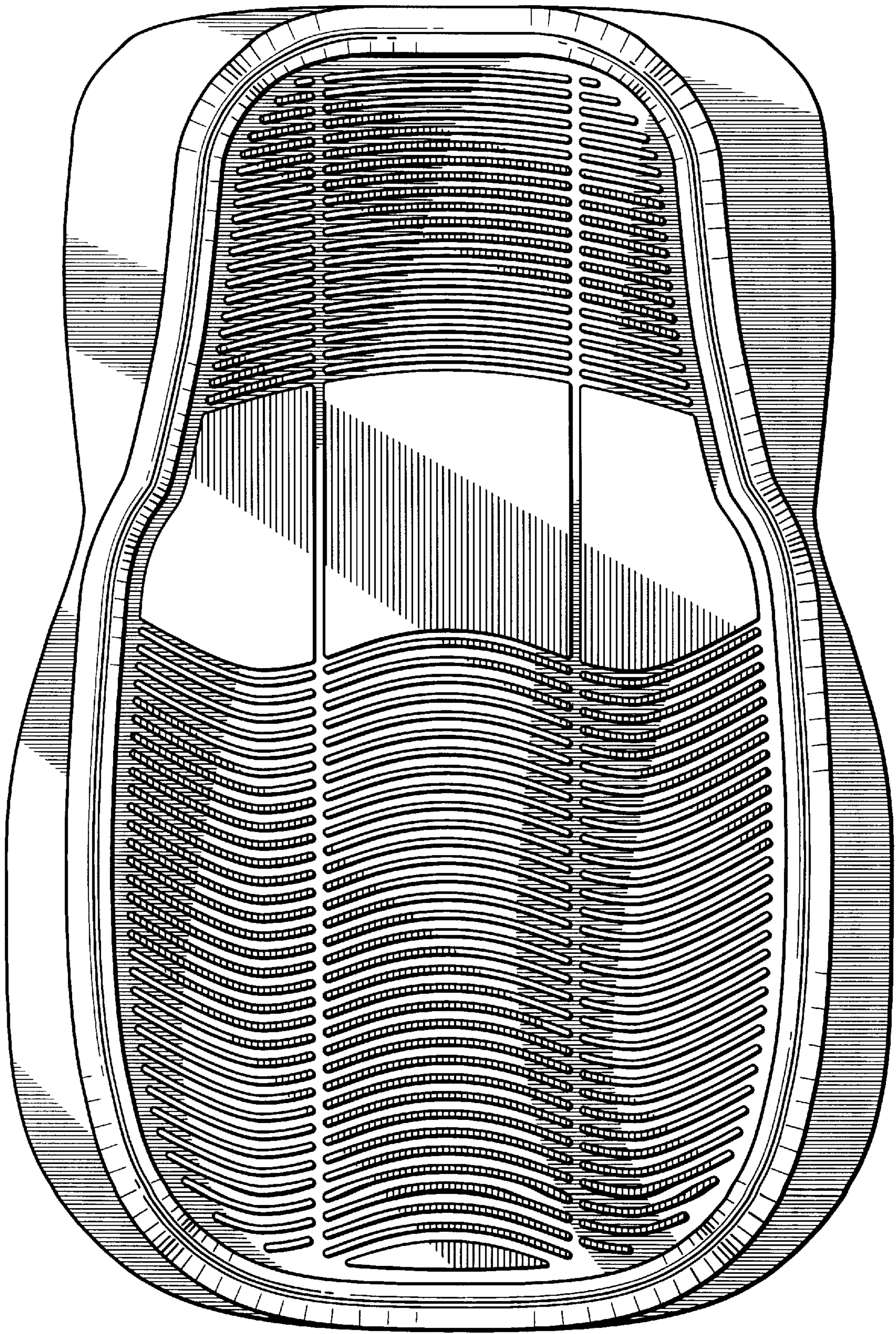

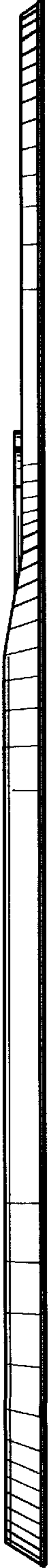

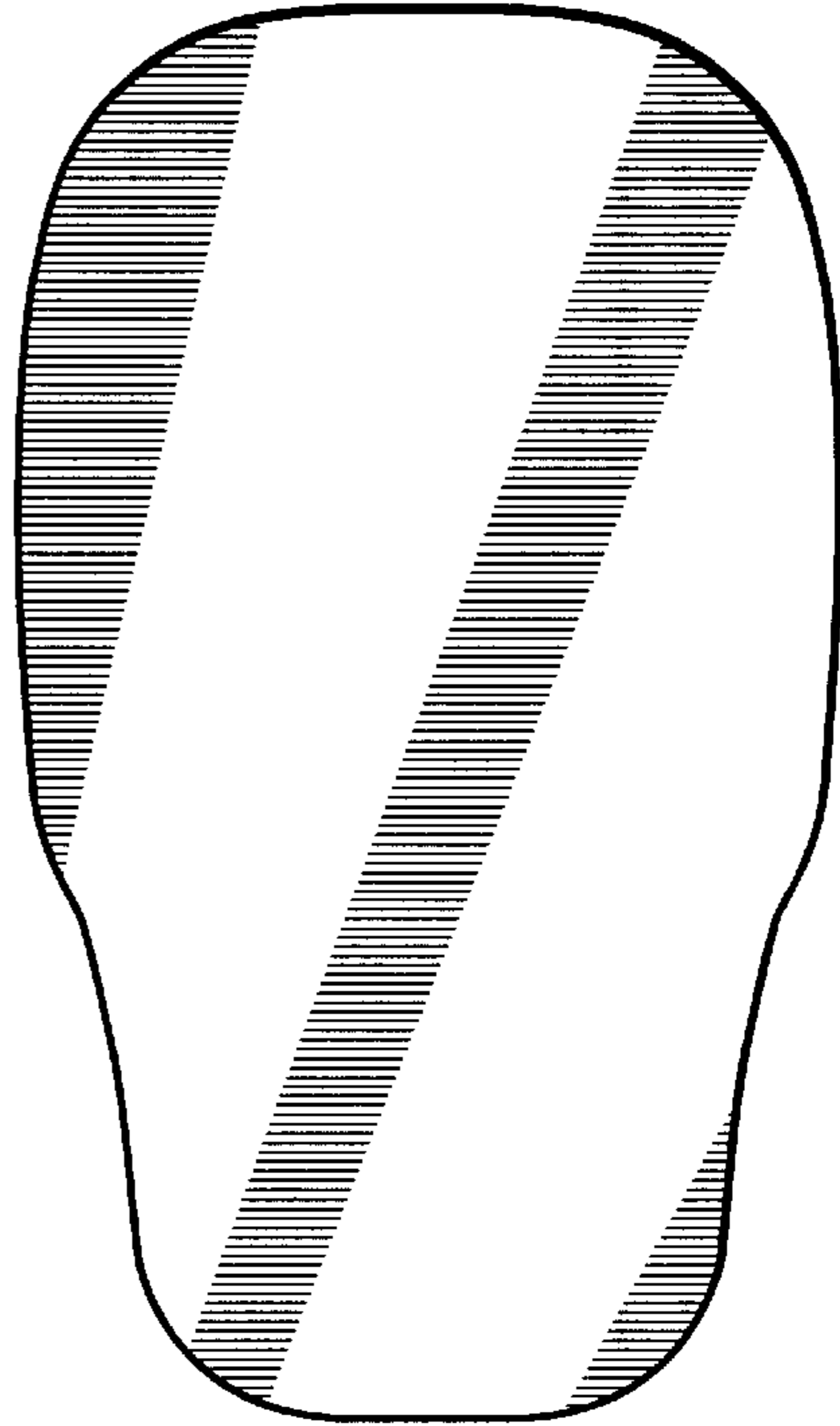

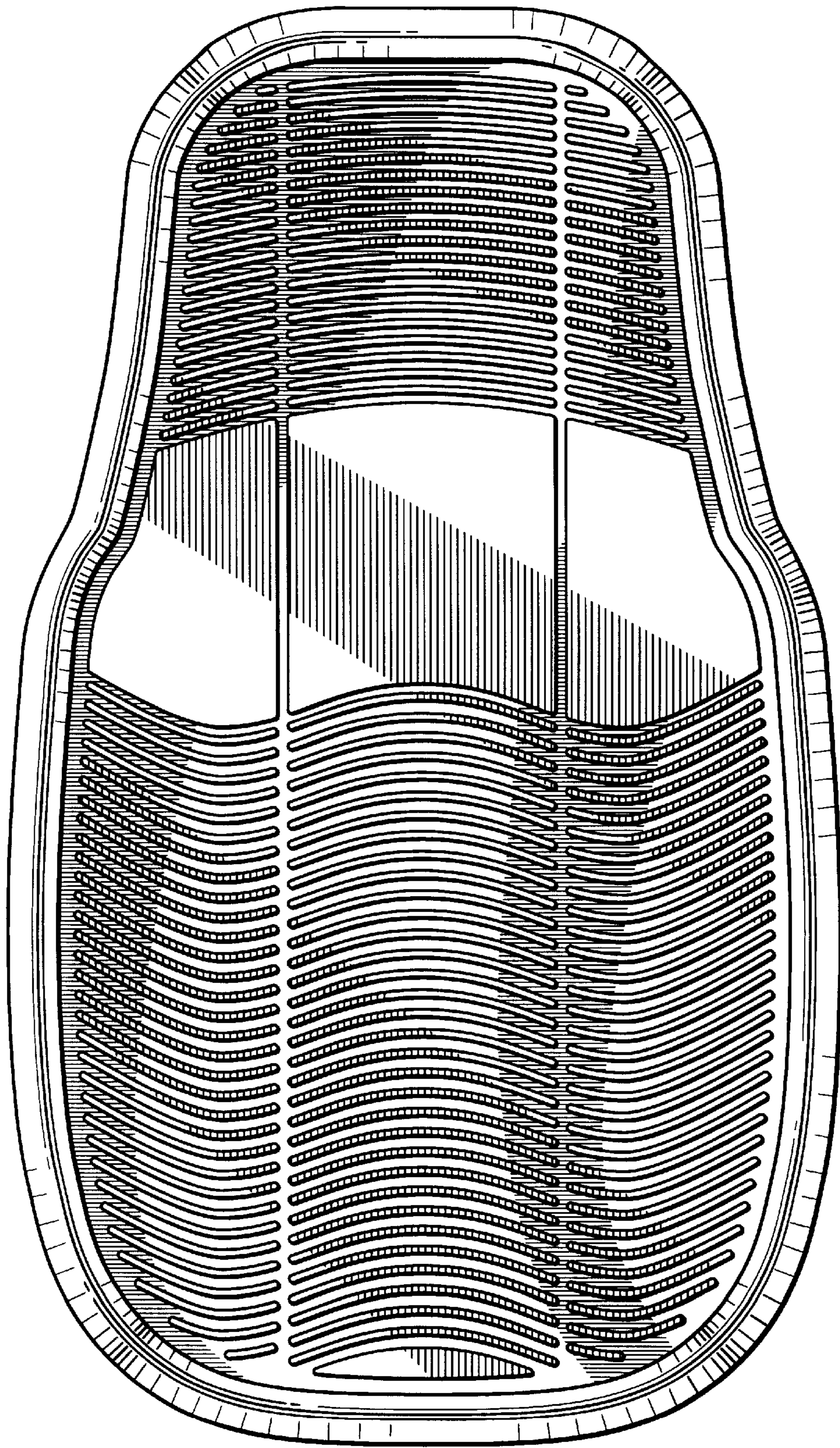
