(57) **CLAIM**

The ornamental design for a tag reader writer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a tag reader writer showing our new design;

FIG. 2 is a top plan view of FIG. 1;

FIG. 3 is a bottom plan view of FIG. 1;

FIG. 4 is a front elevational view of FIG. 1;

FIG. 5 is a rear elevational view of FIG. 1;

FIG. 6 is a left side elevational view of FIG. 1;

FIG. 7 is a right side elevational view of FIG. 1;

FIG. 8 is a perspective view of a second embodiment of a tag reader writer showing our new design; and,

FIG. 9 is a front elevational view of FIG. 8.

The top plan, bottom plan, rear elevational, left side elevational and right side elevational views of the second embodiment are respectively identical to the respective corresponding views of the first embodiment.

The broken lines of FIGS. 8 and 9 are shown for illustrative purposes only and form no part of the claimed design.

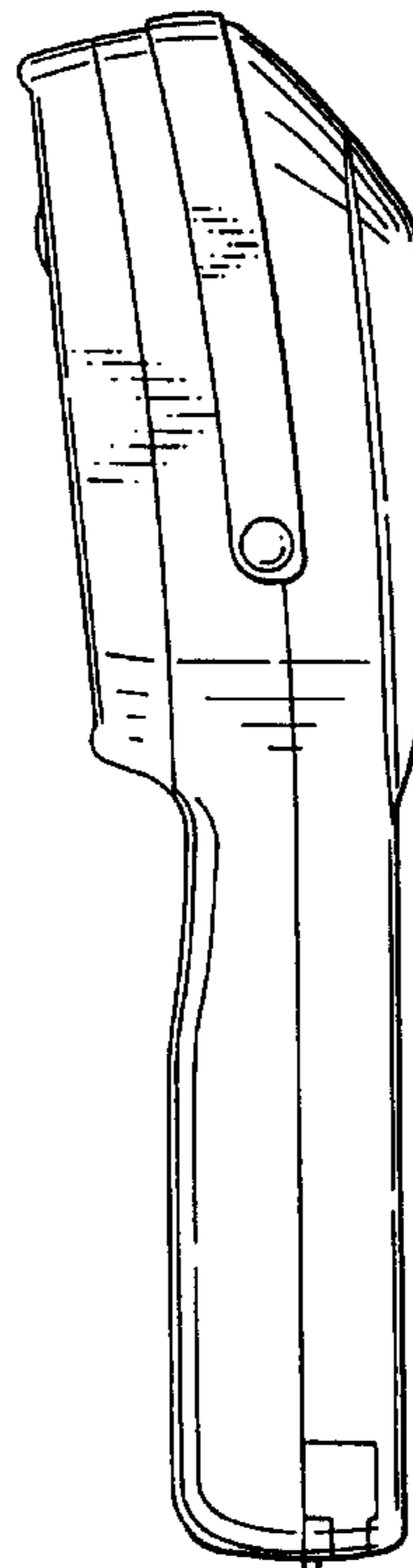
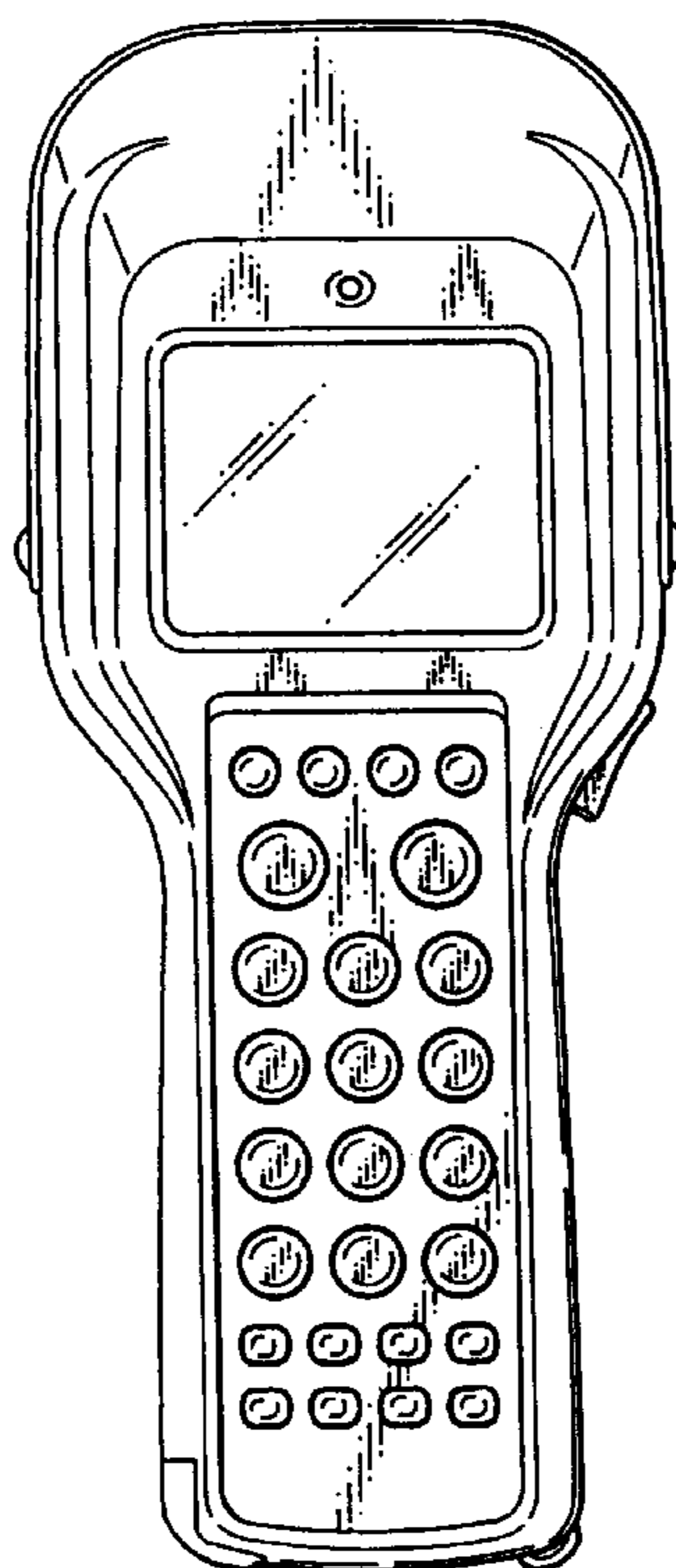

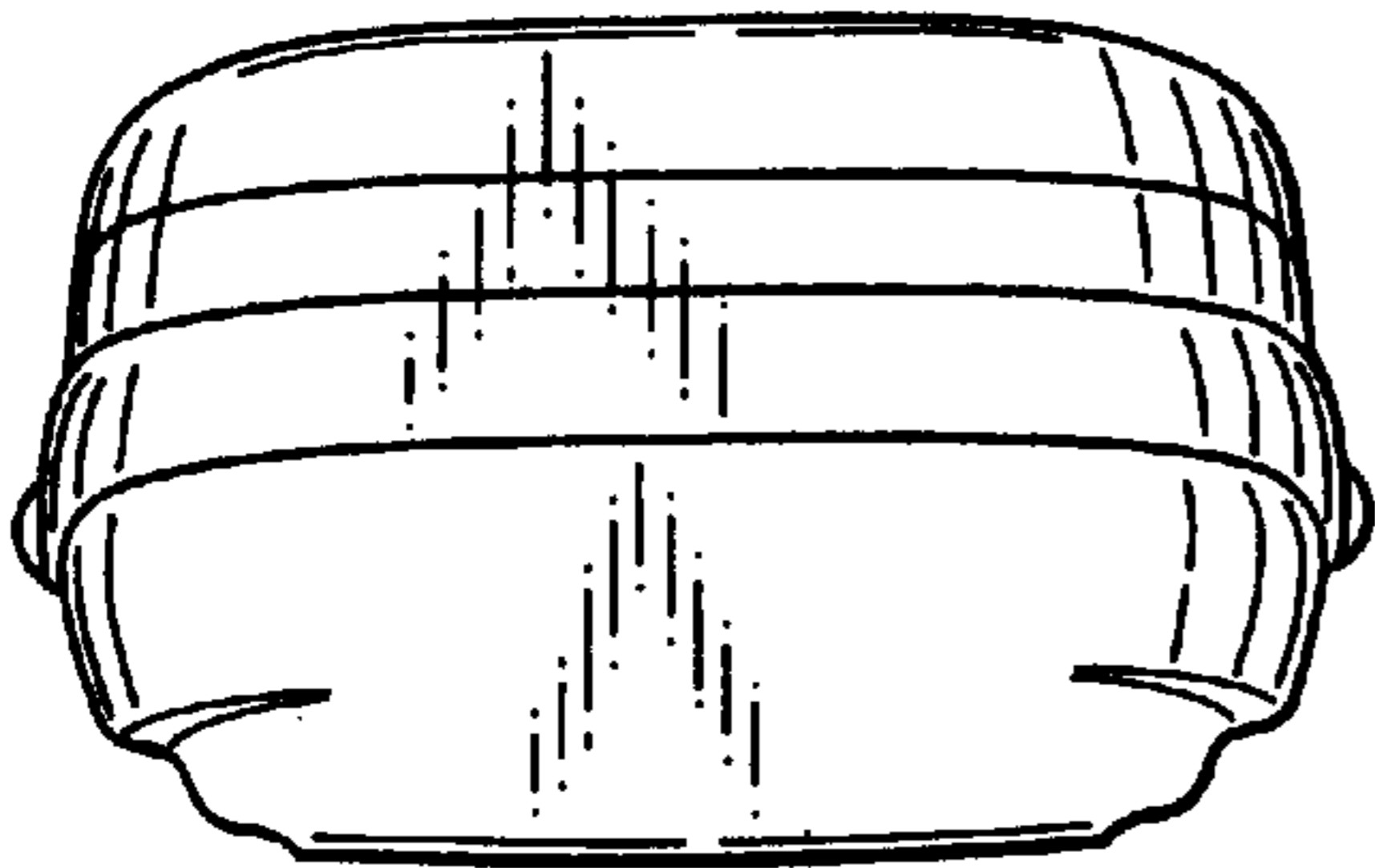

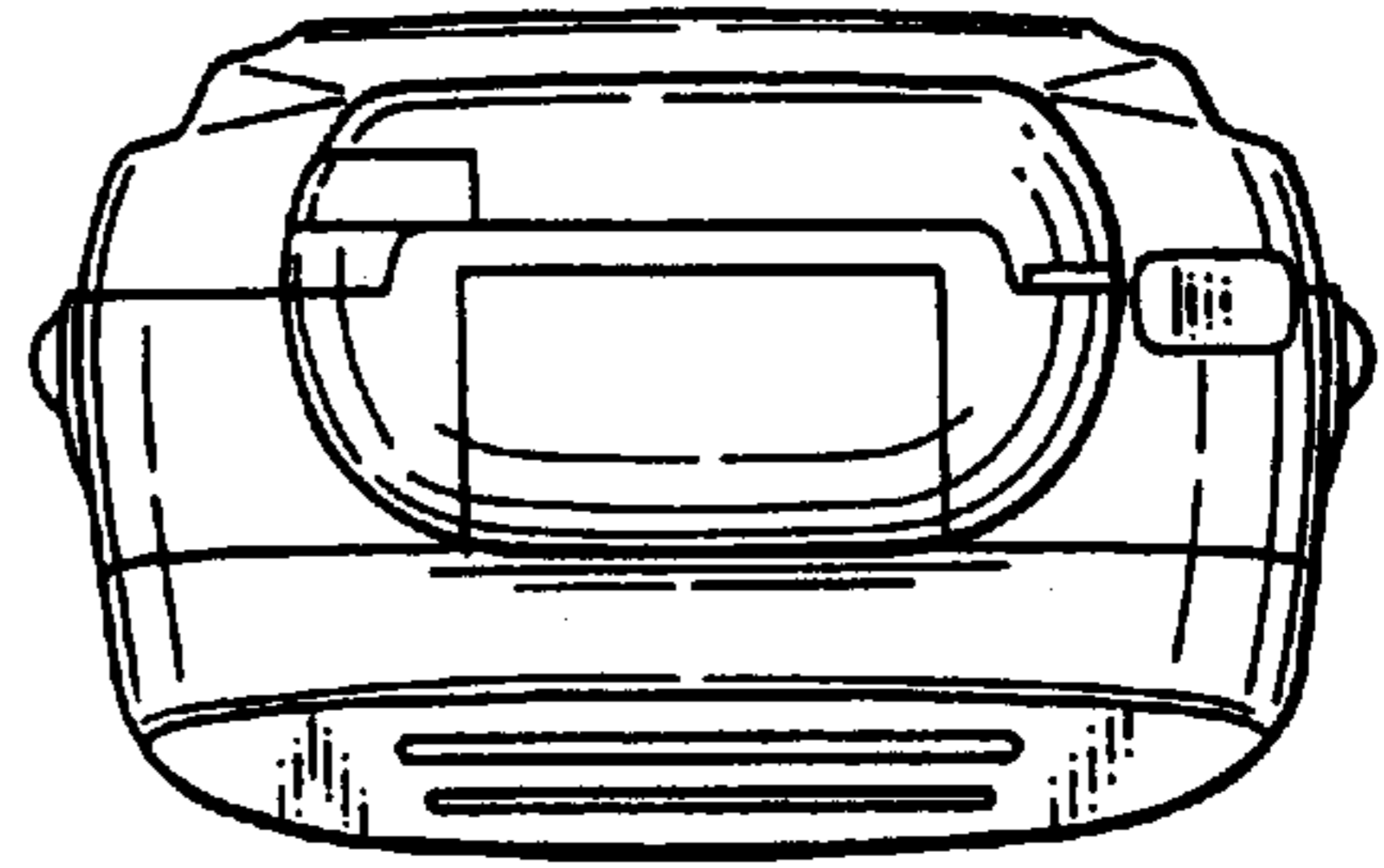

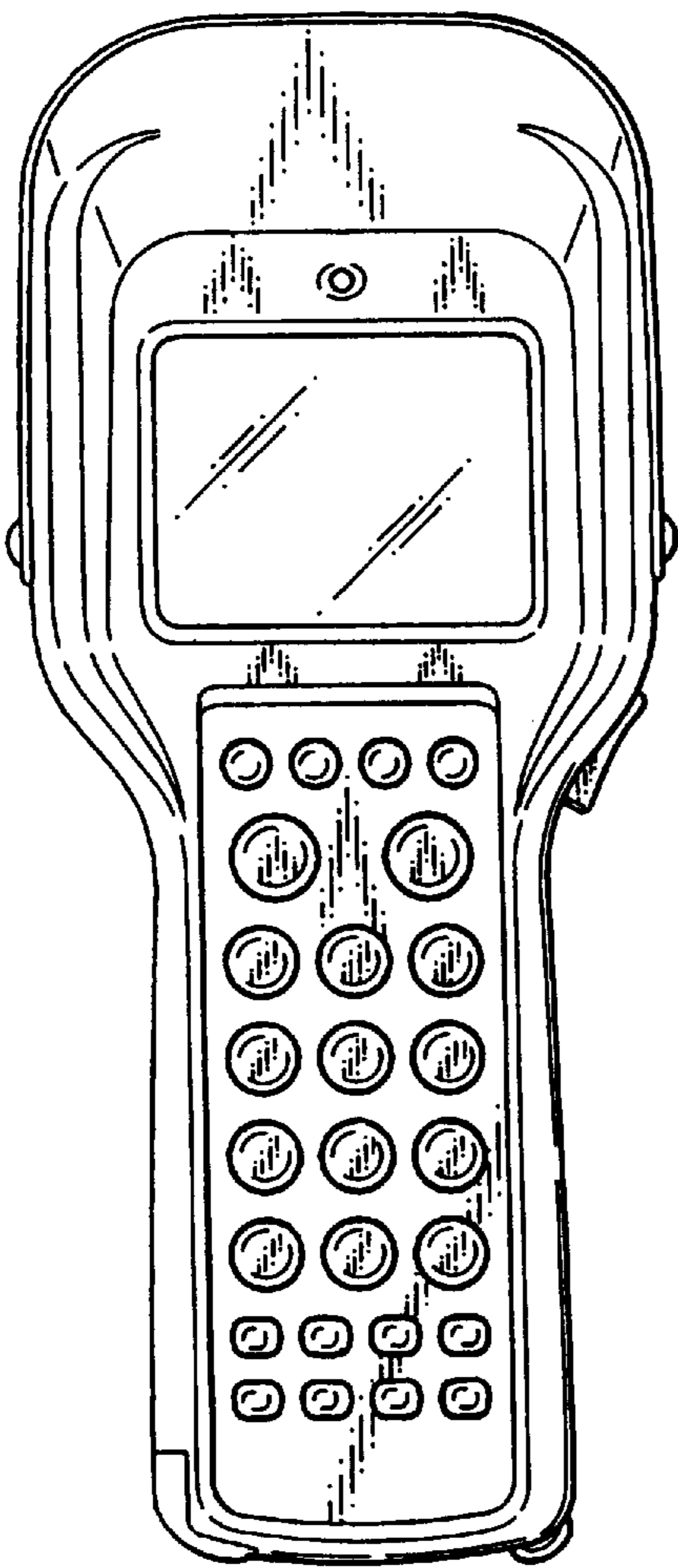

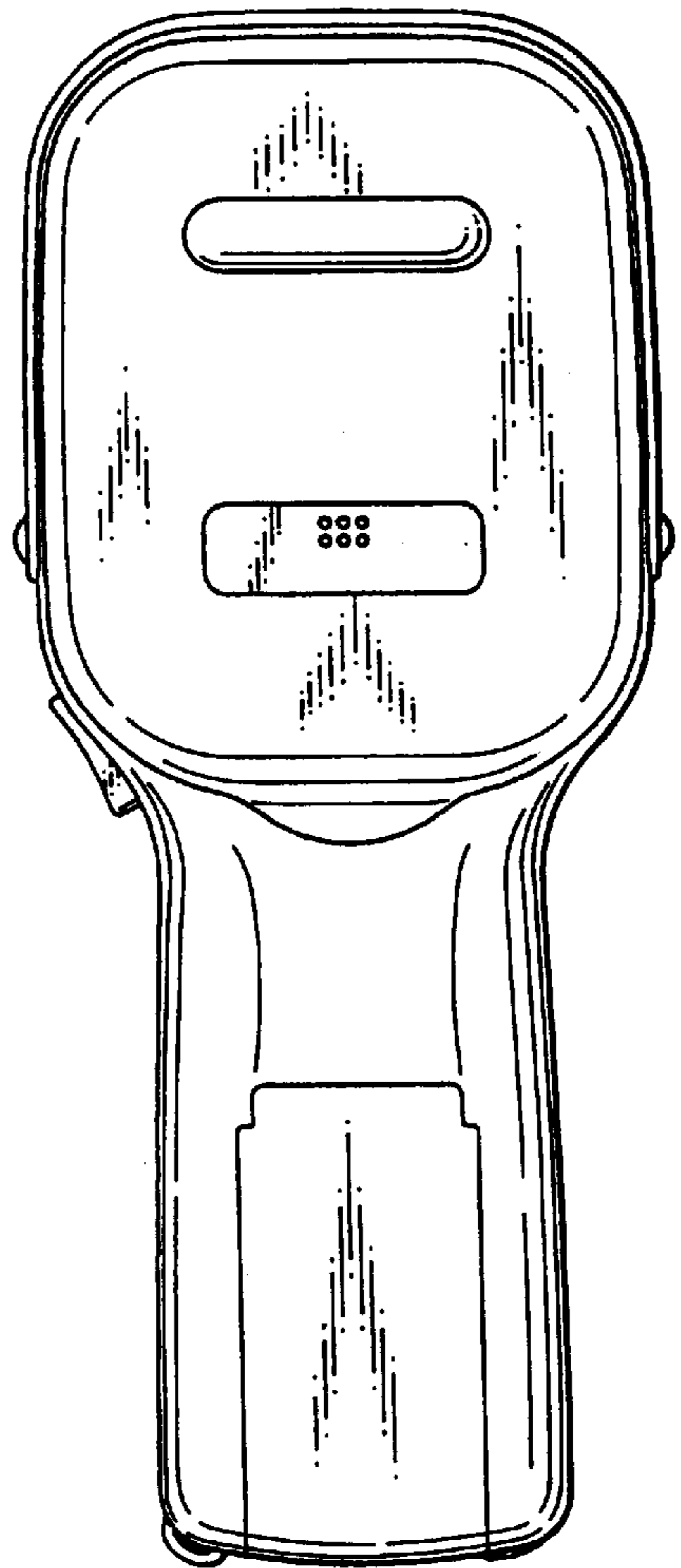

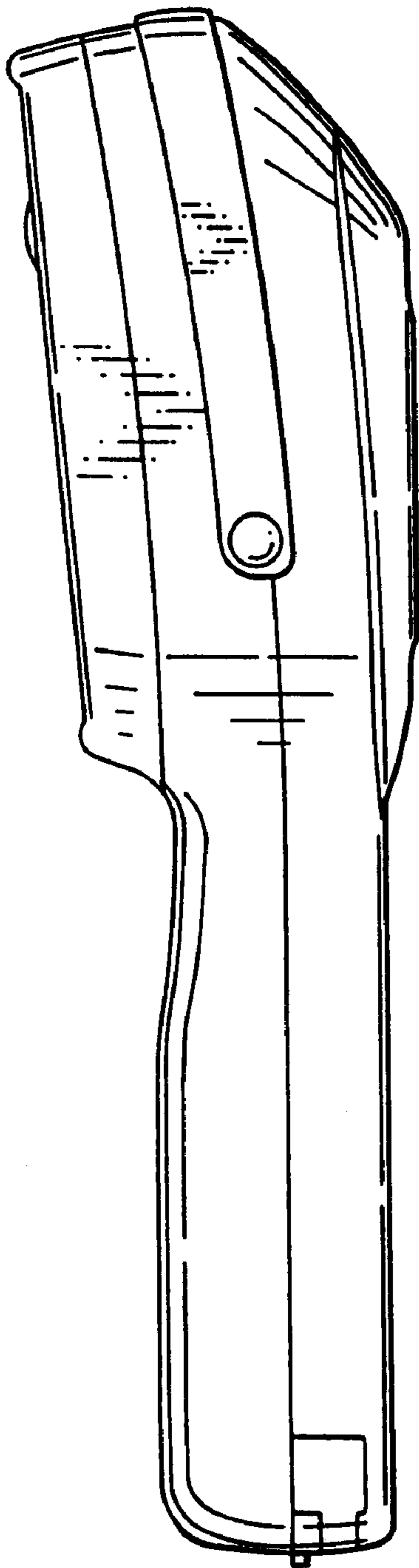

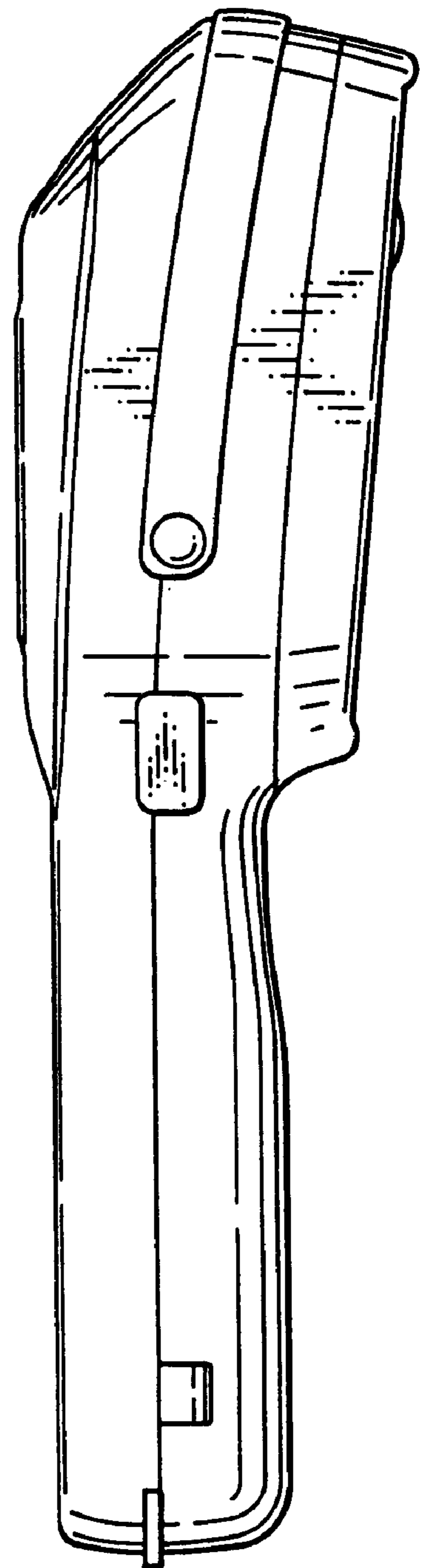

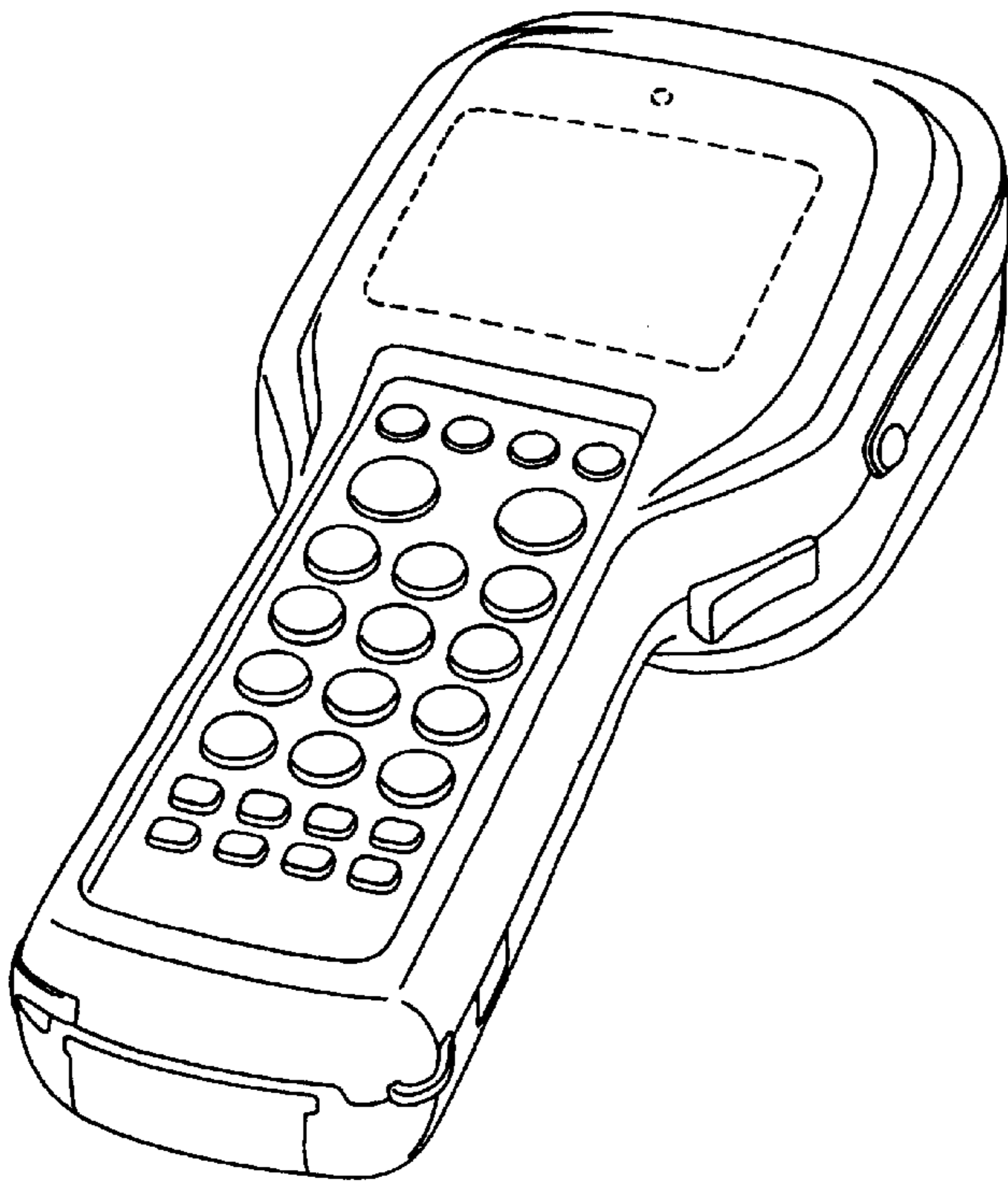
