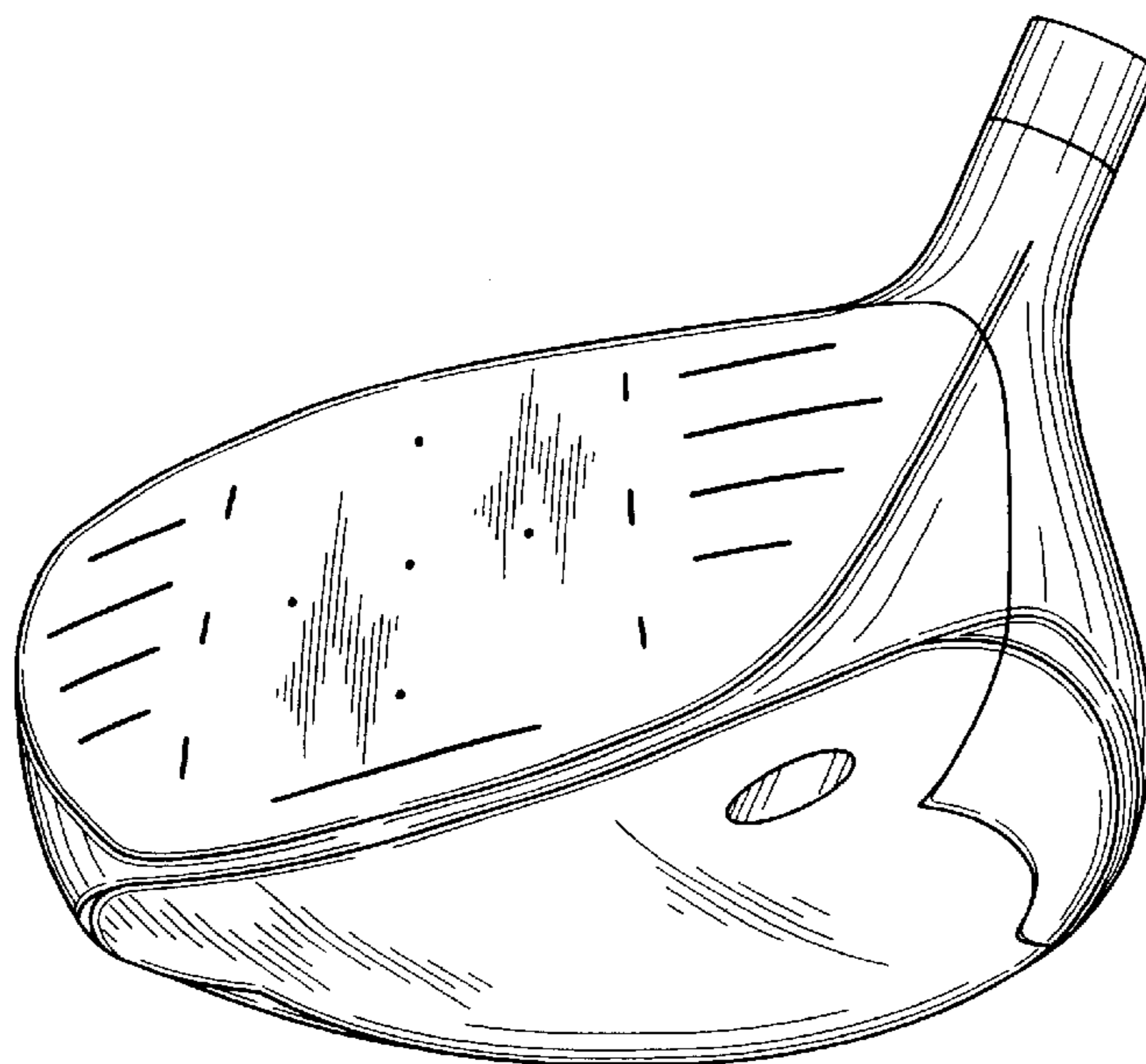
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

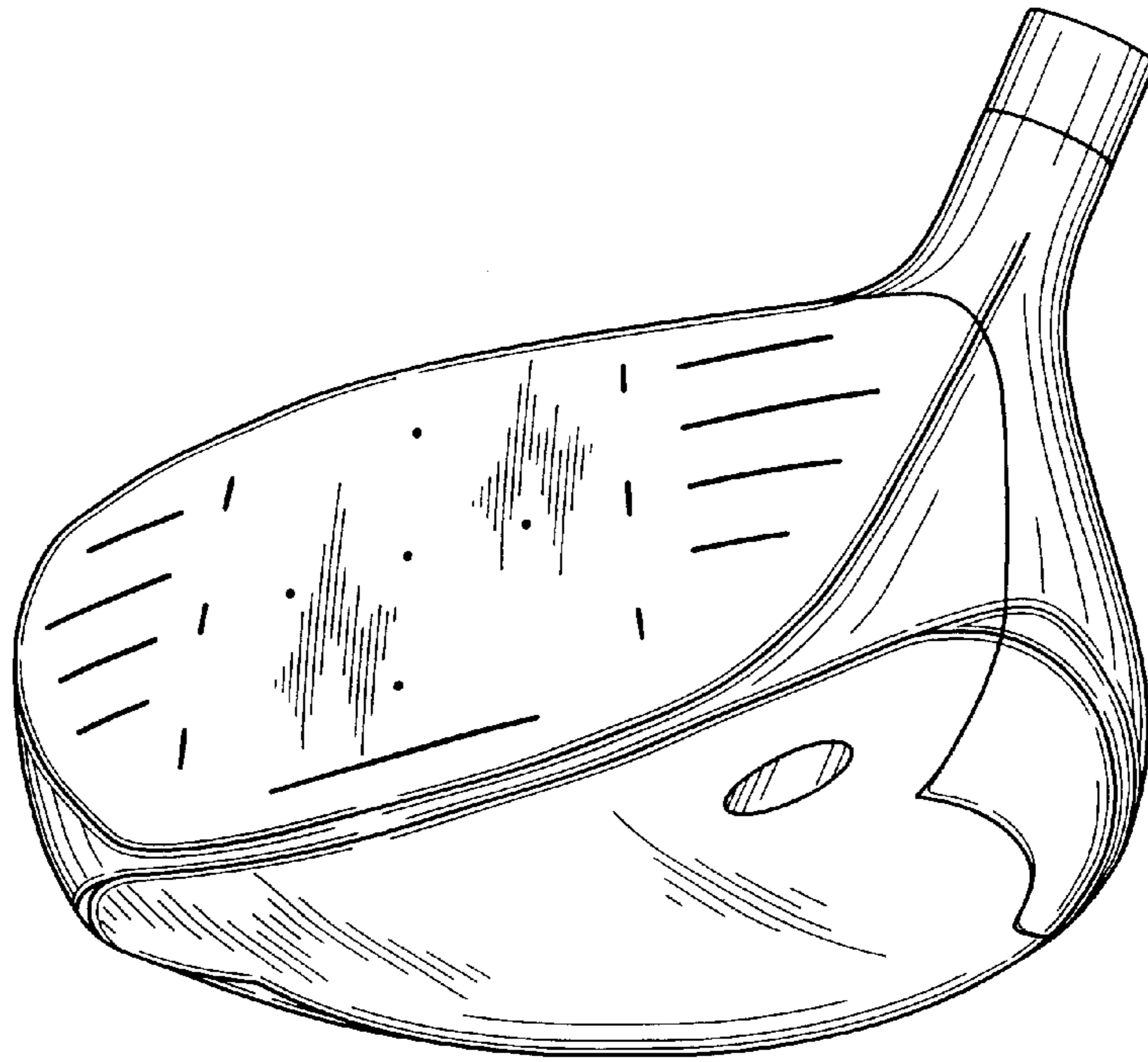
**DESCRIPTION**

 FIG. 7 is a bottom plan view of the golf club head according to the invention.

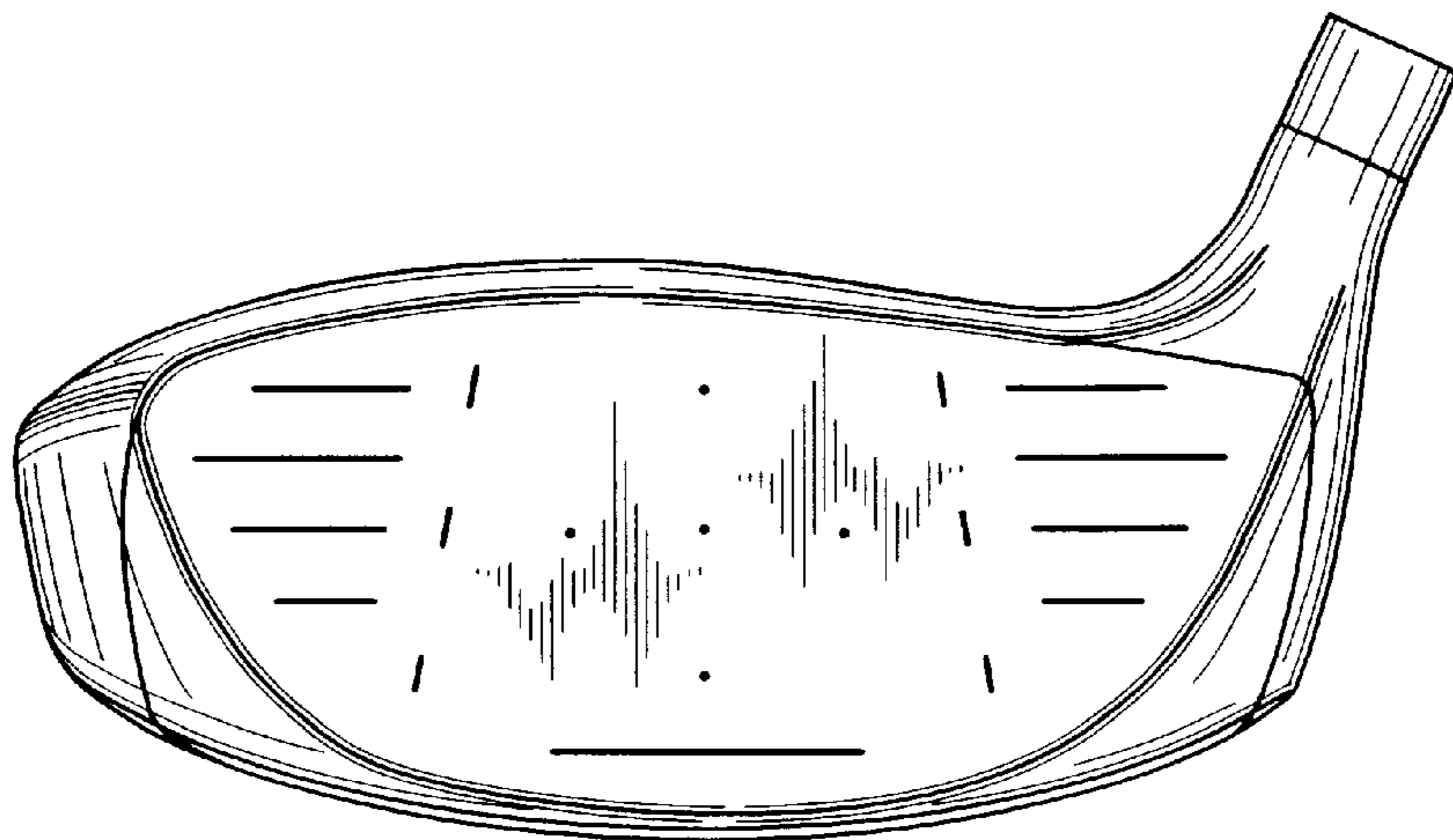

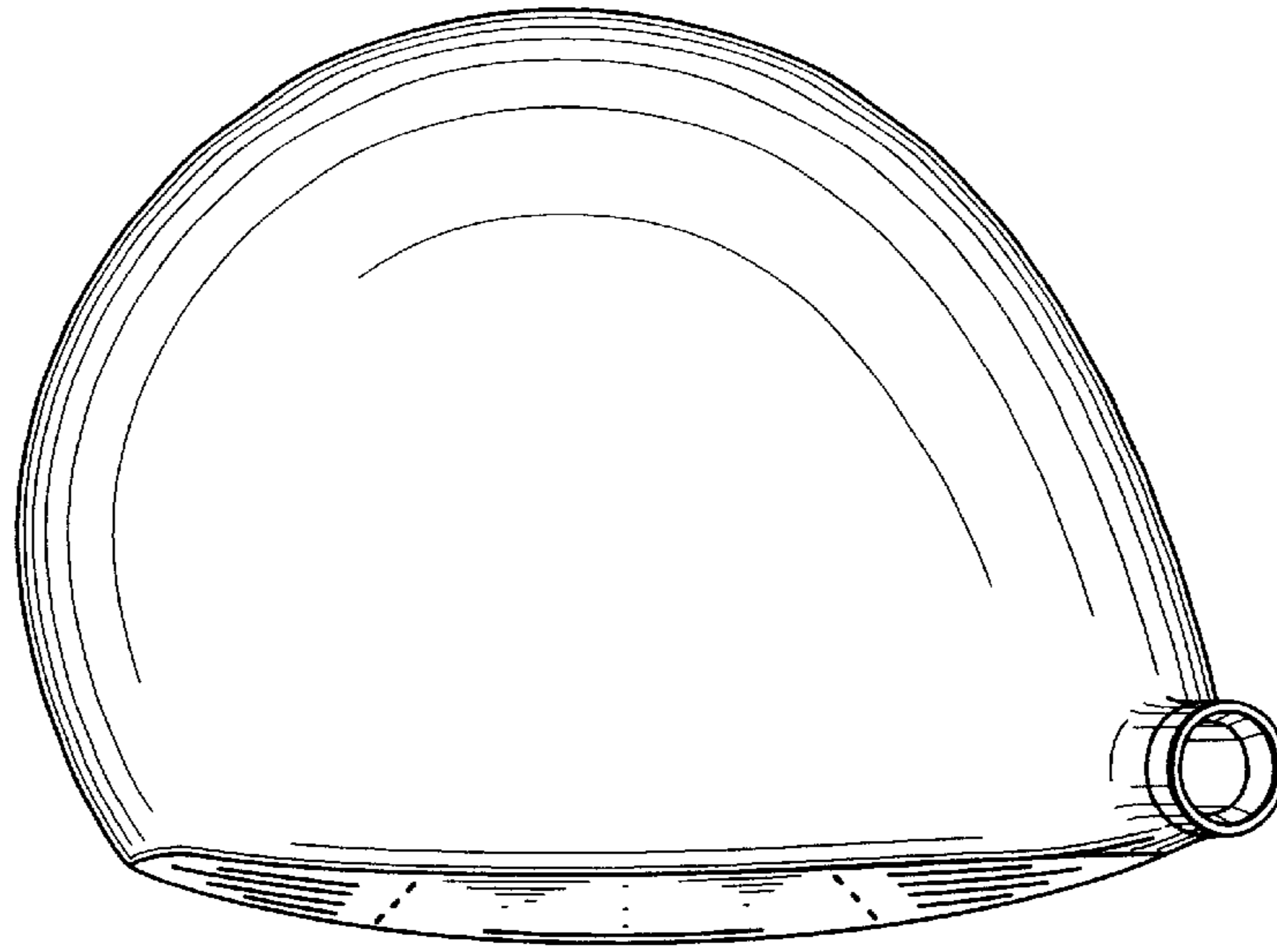

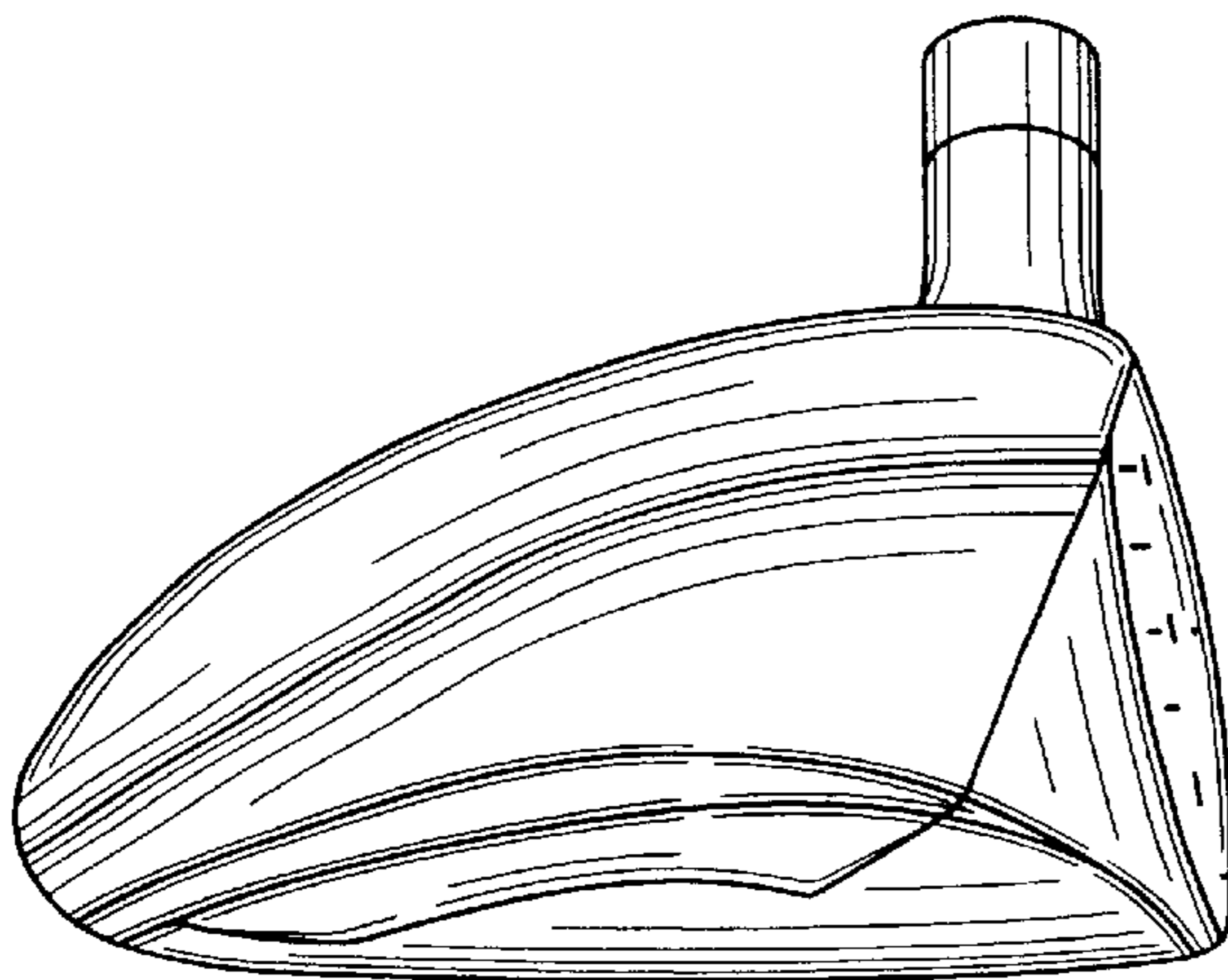

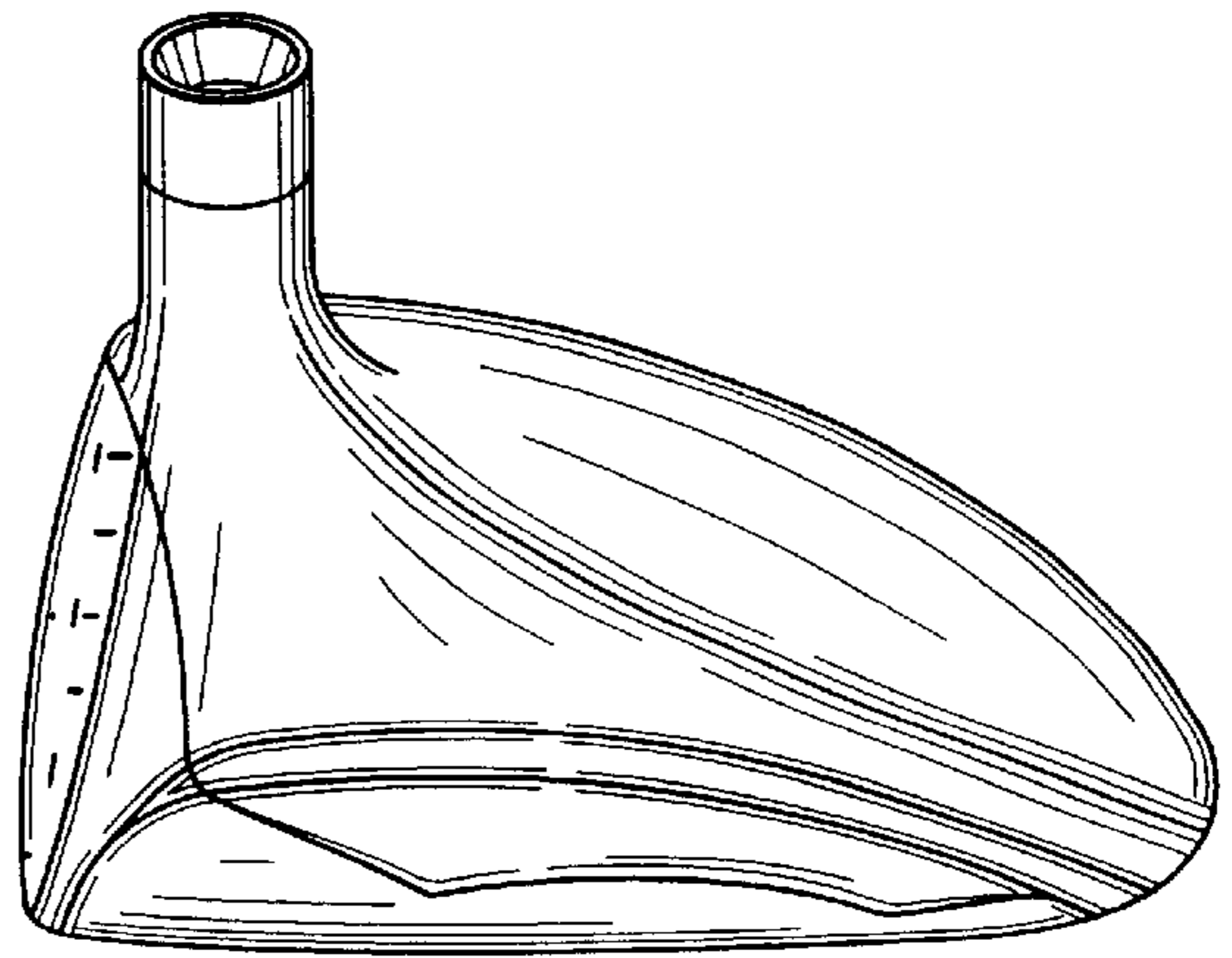

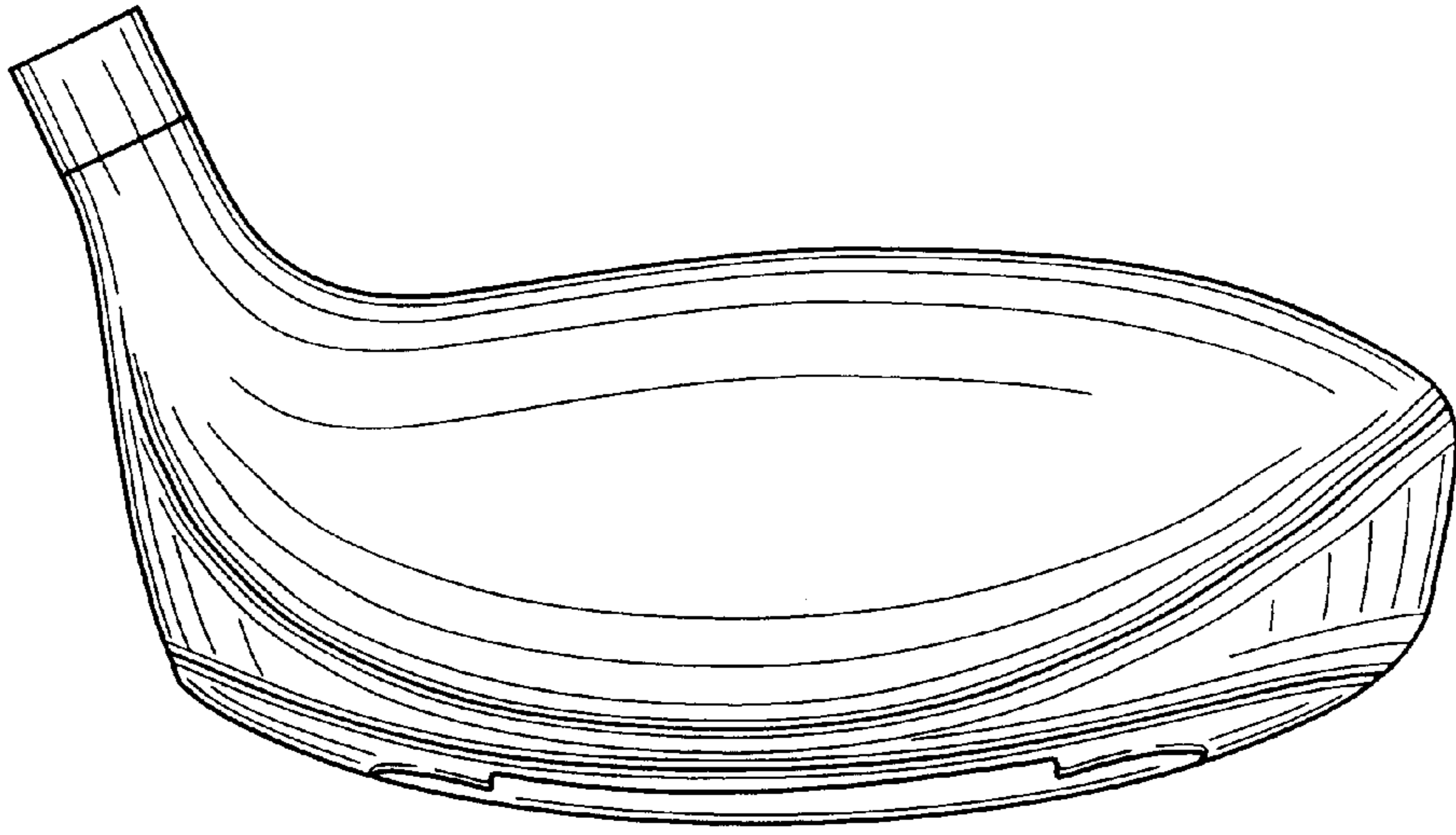
