(57) **CLAIM**

The ornamental design for a golf club head cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf club head cover in accordance with the present invention;

FIG. 2 is a top plan view of the golf club head cover shown in FIG. 1;

FIG. 3 is a first side elevational view of the golf club head cover shown in FIG. 1;

FIG. 4 is a front elevational view of the golf club head cover shown in FIG. 1;

FIG. 5 is a second side elevational view of the golf club head cover shown in FIG. 1;

FIG. 6 is a heel view of the golf club head cover shown in FIG. 1;

FIG. 7 is a bottom view of the golf club head cover shown in FIG. 1;

FIG. 8 is a perspective view of an alternate golf club head cover;

FIG. 9 is a top plan view of the golf club head cover shown in FIG. 8;

FIG. 10 is a first side elevational view of the golf club head cover shown in FIG. 8;

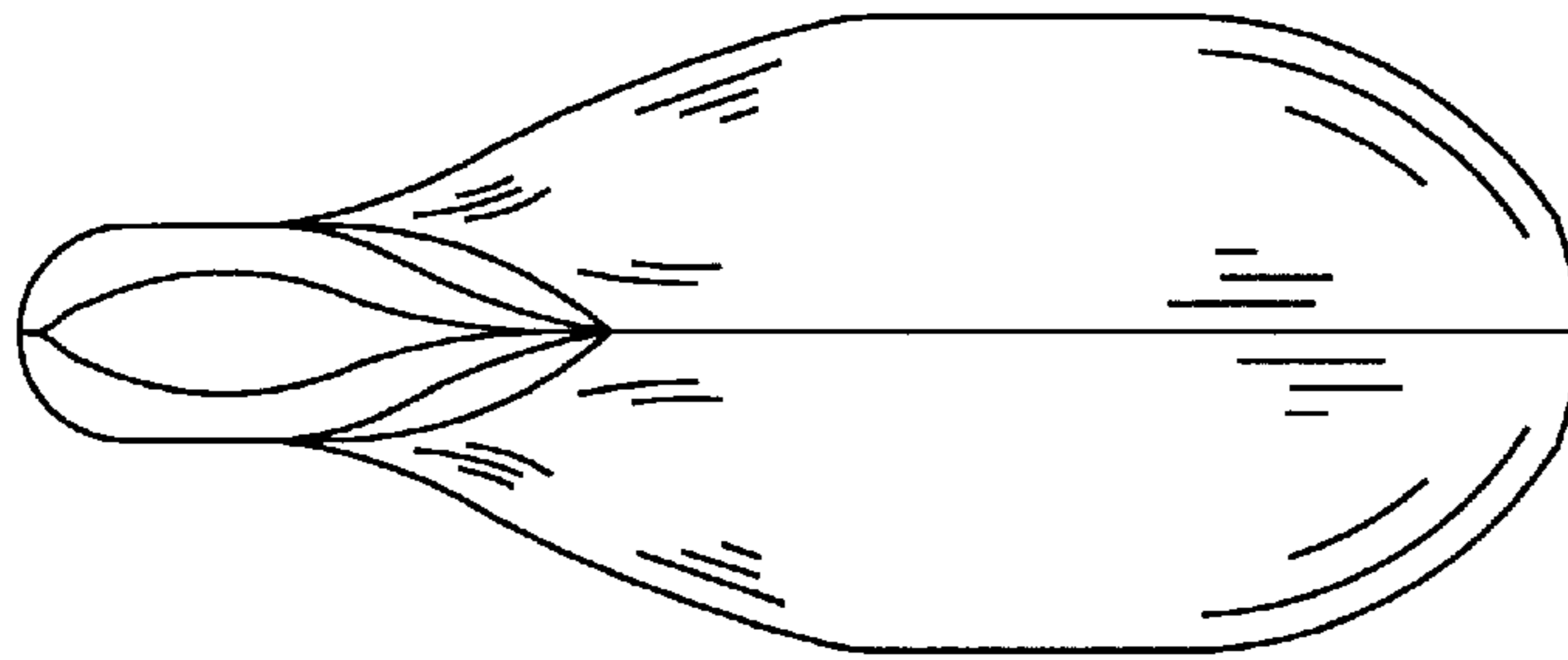

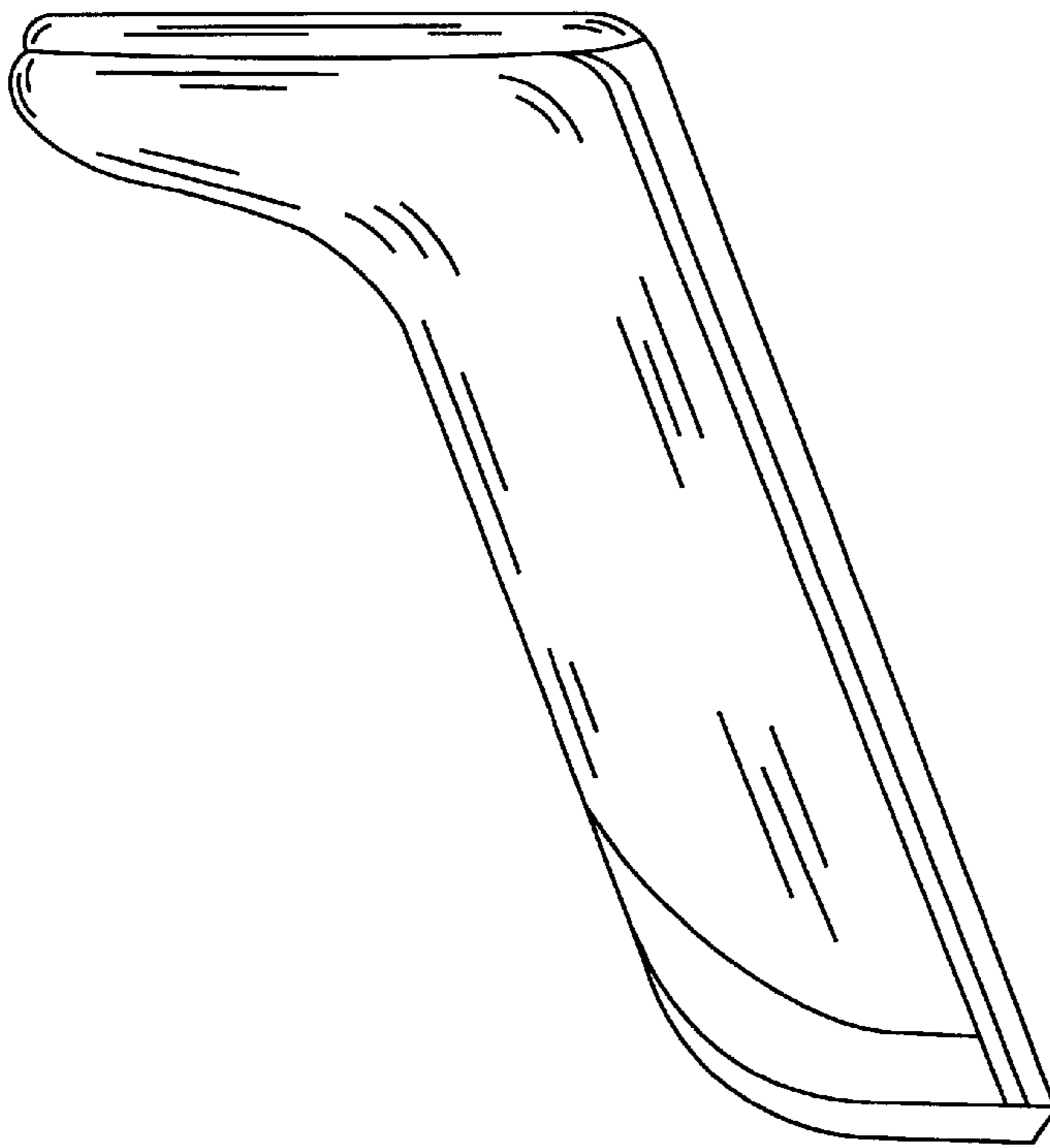

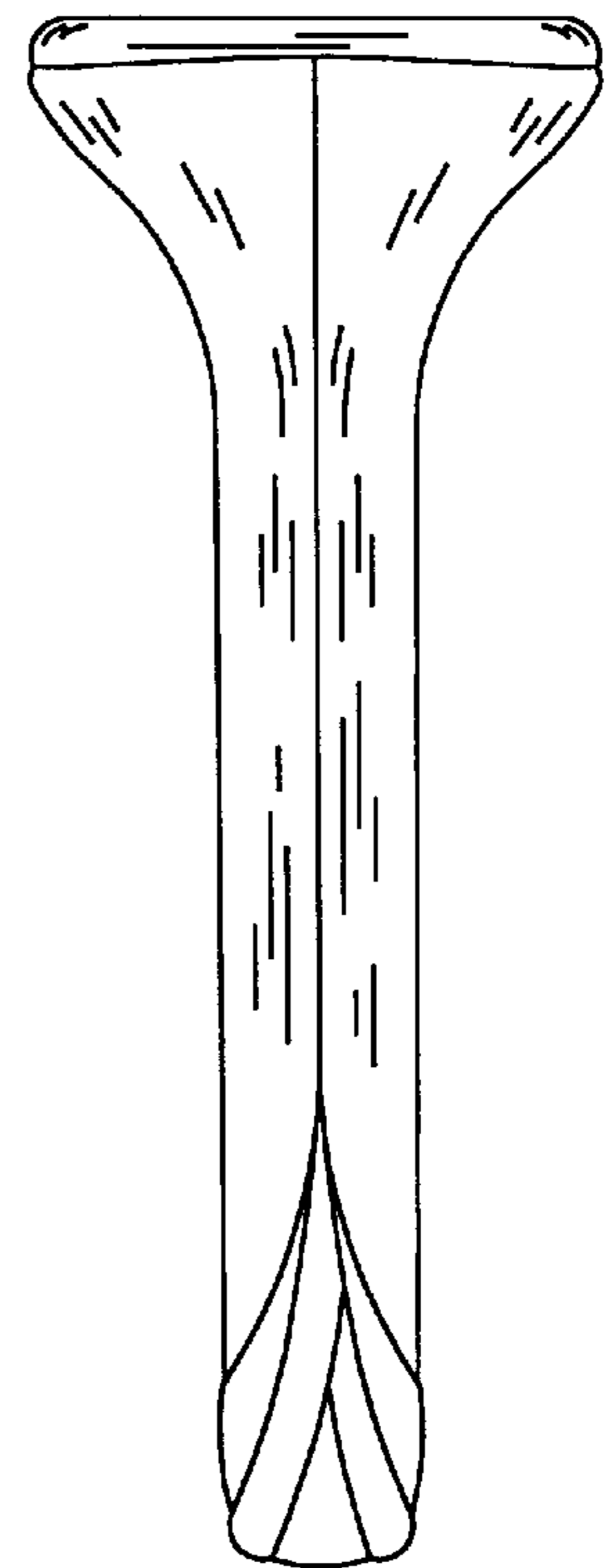

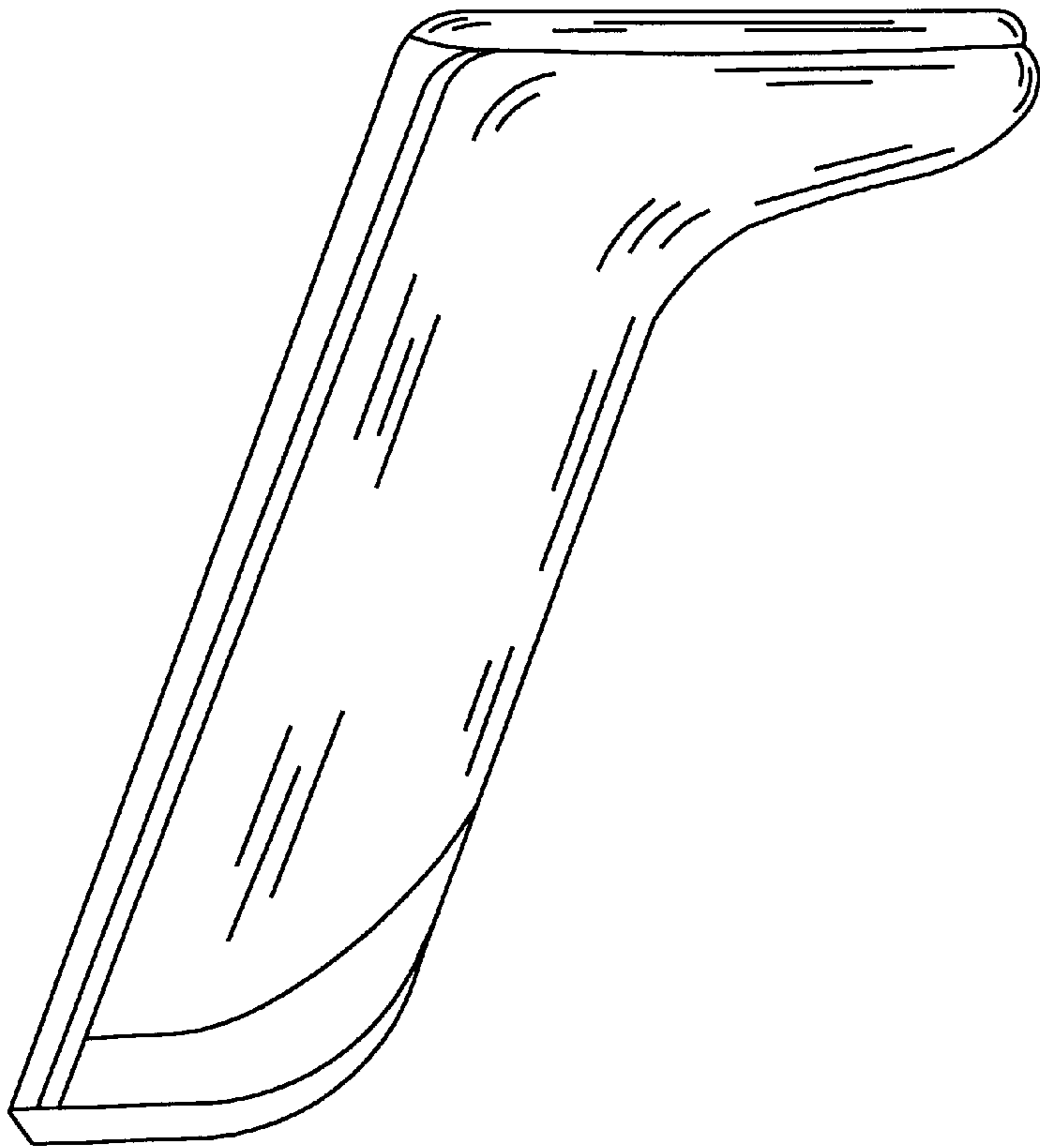

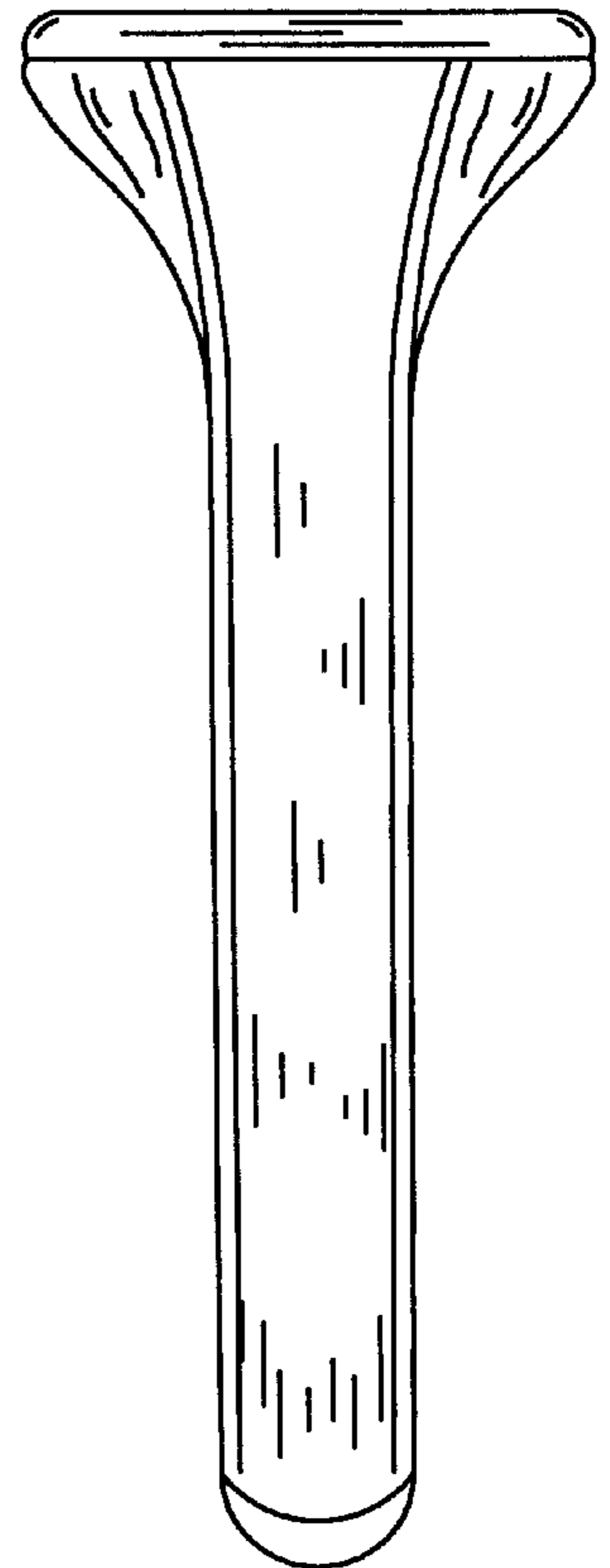

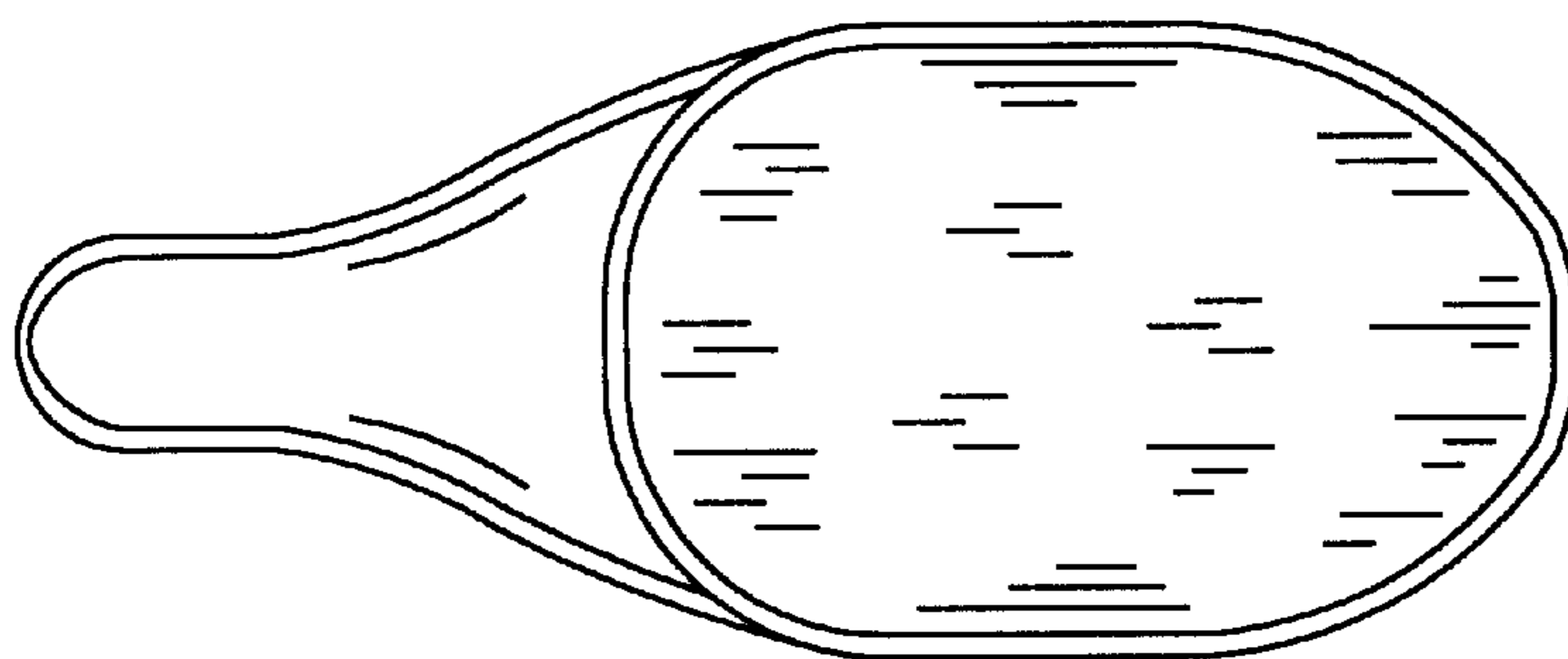

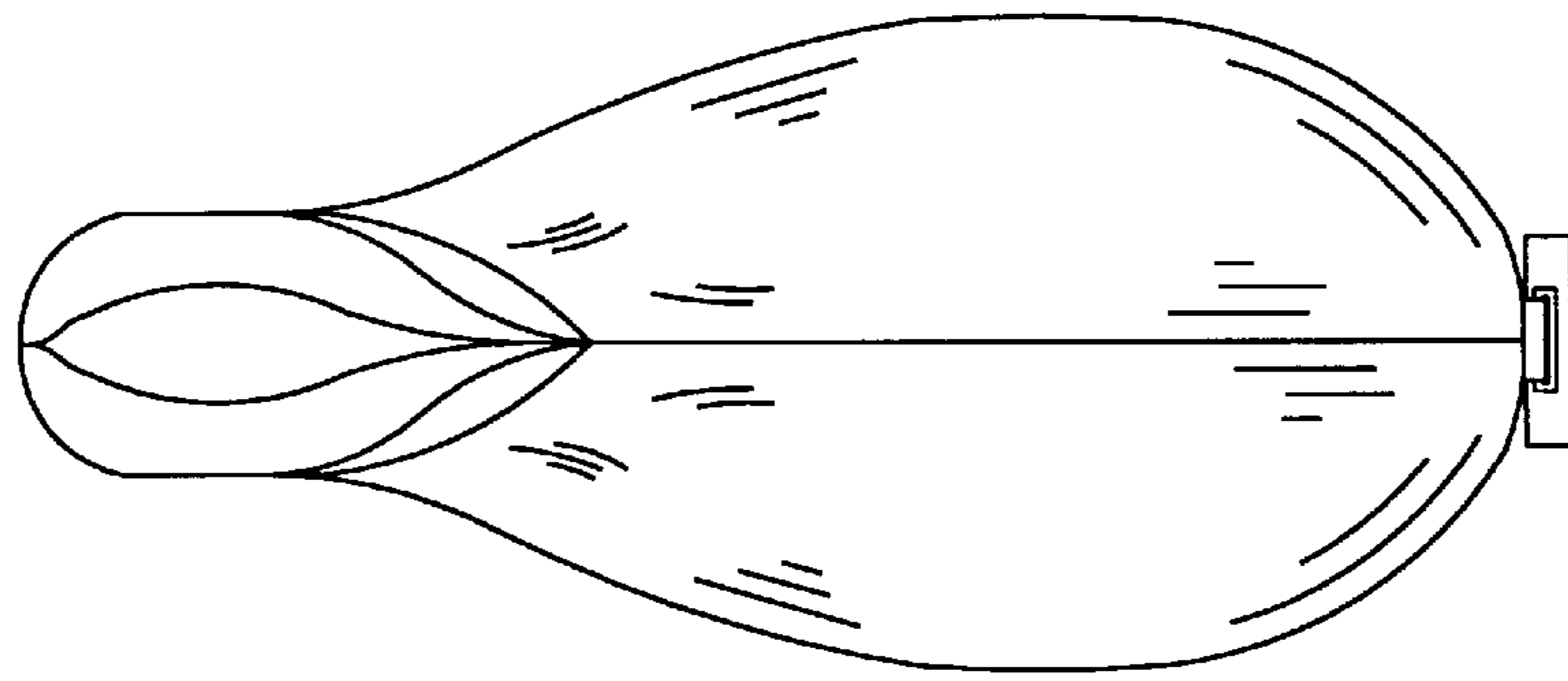

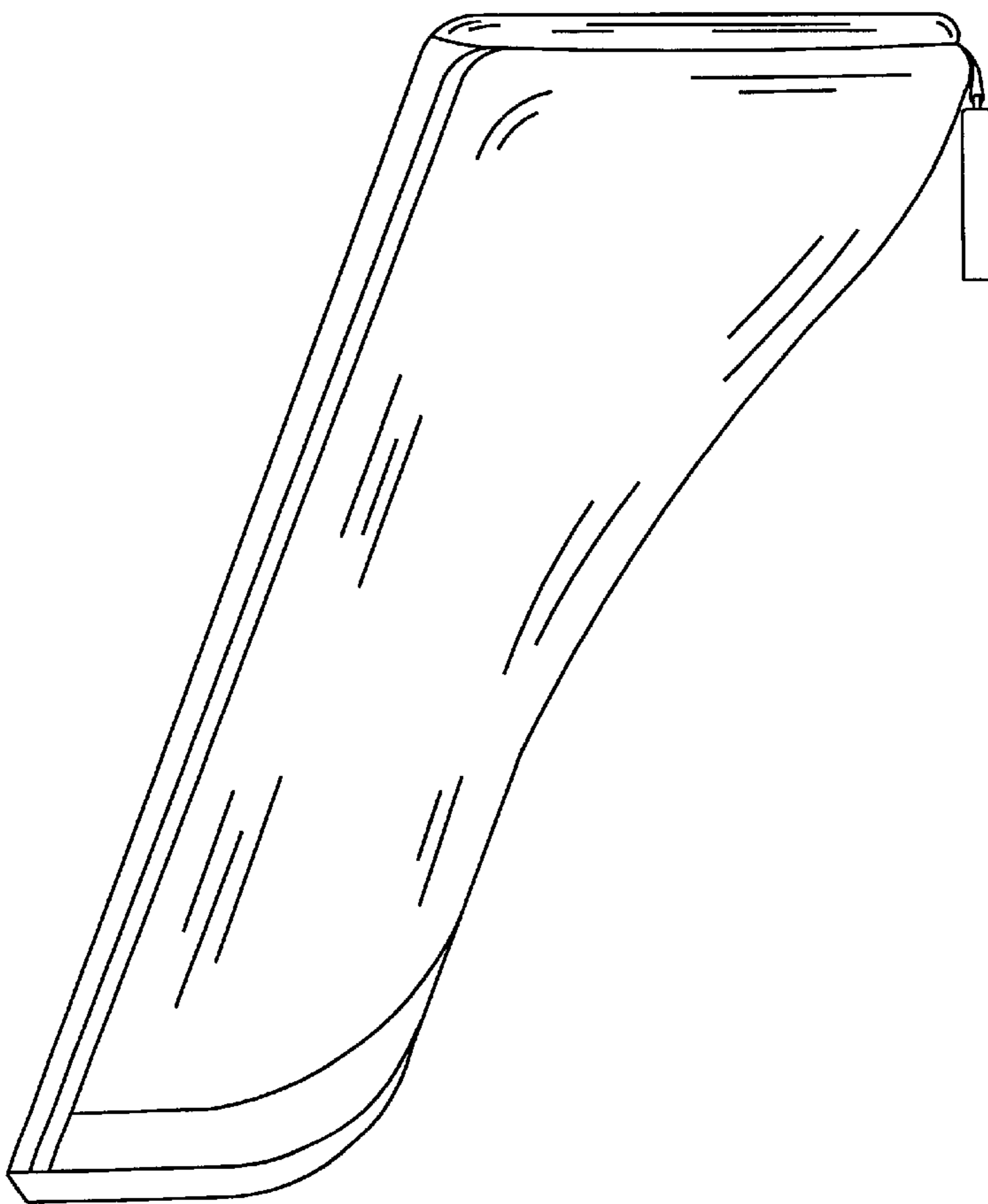

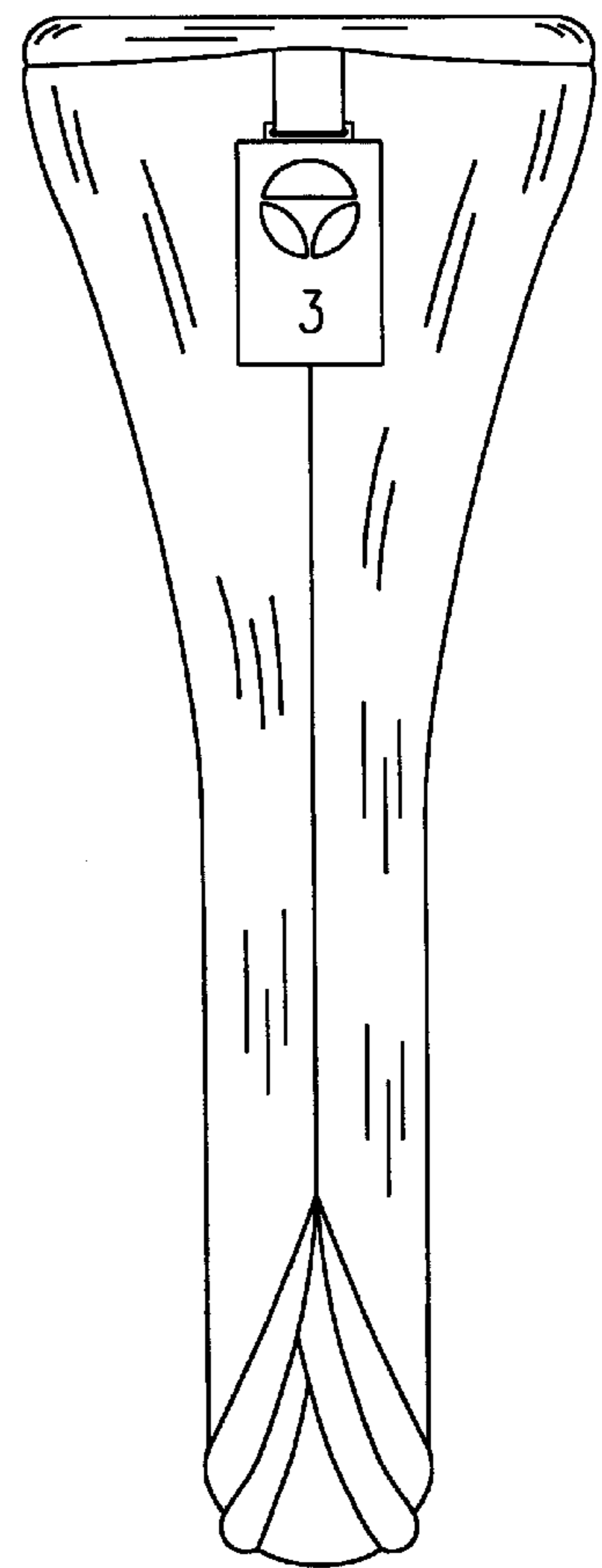

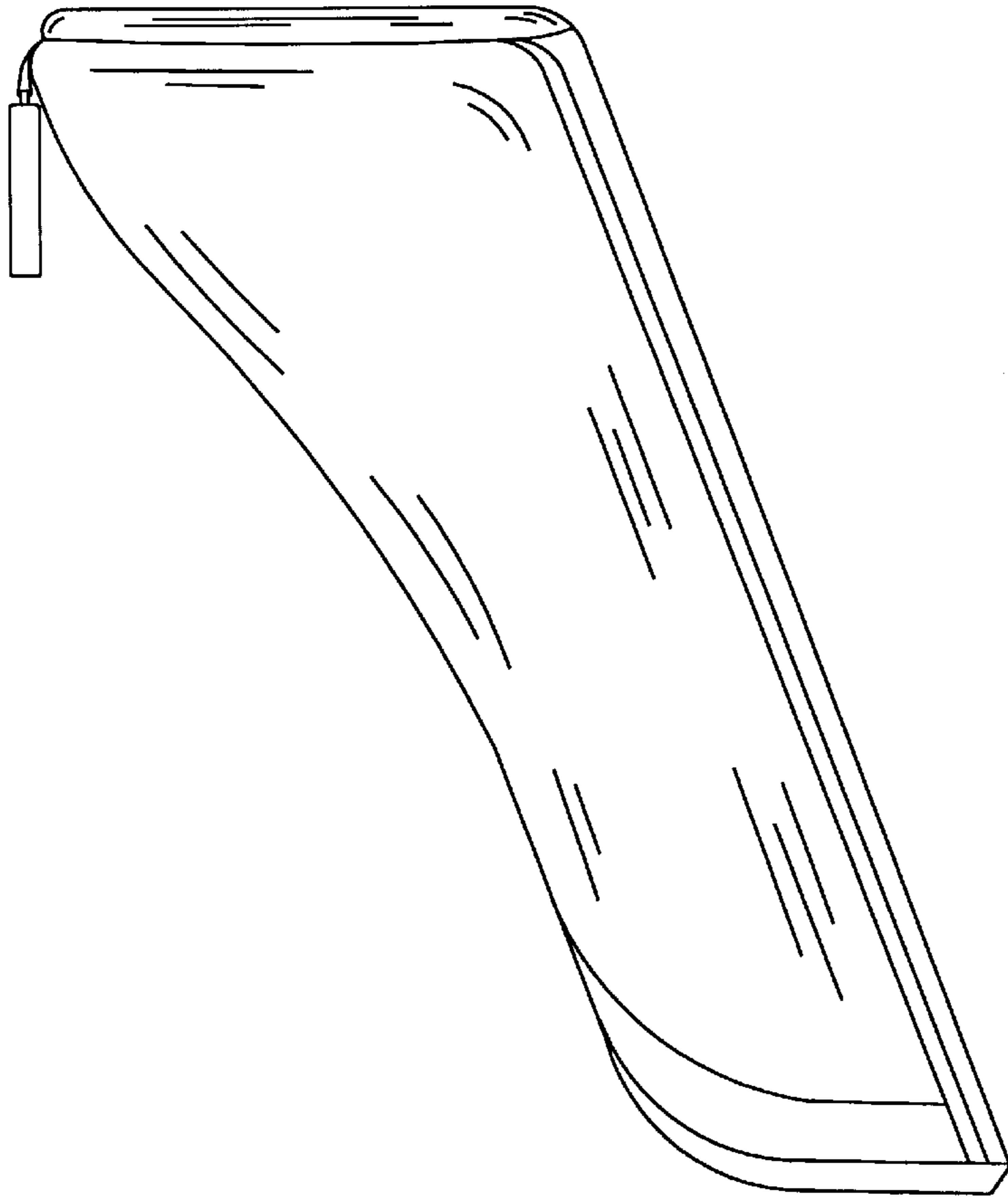

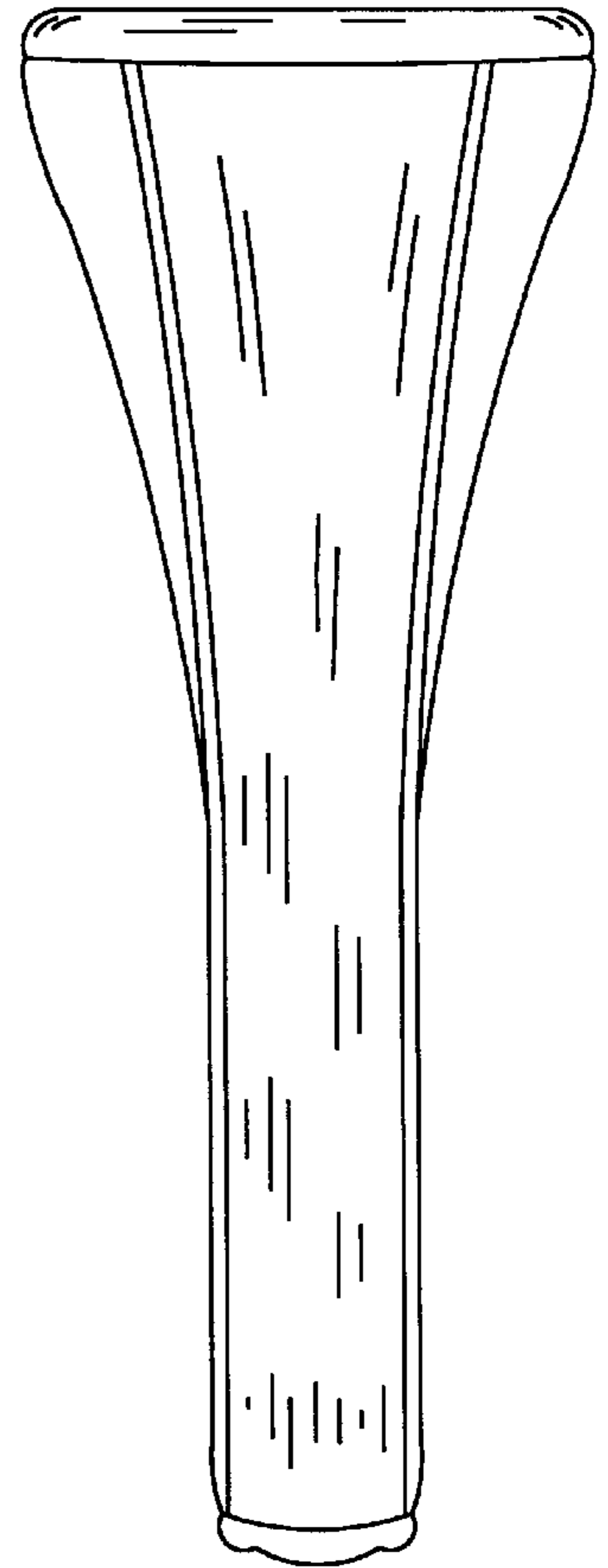

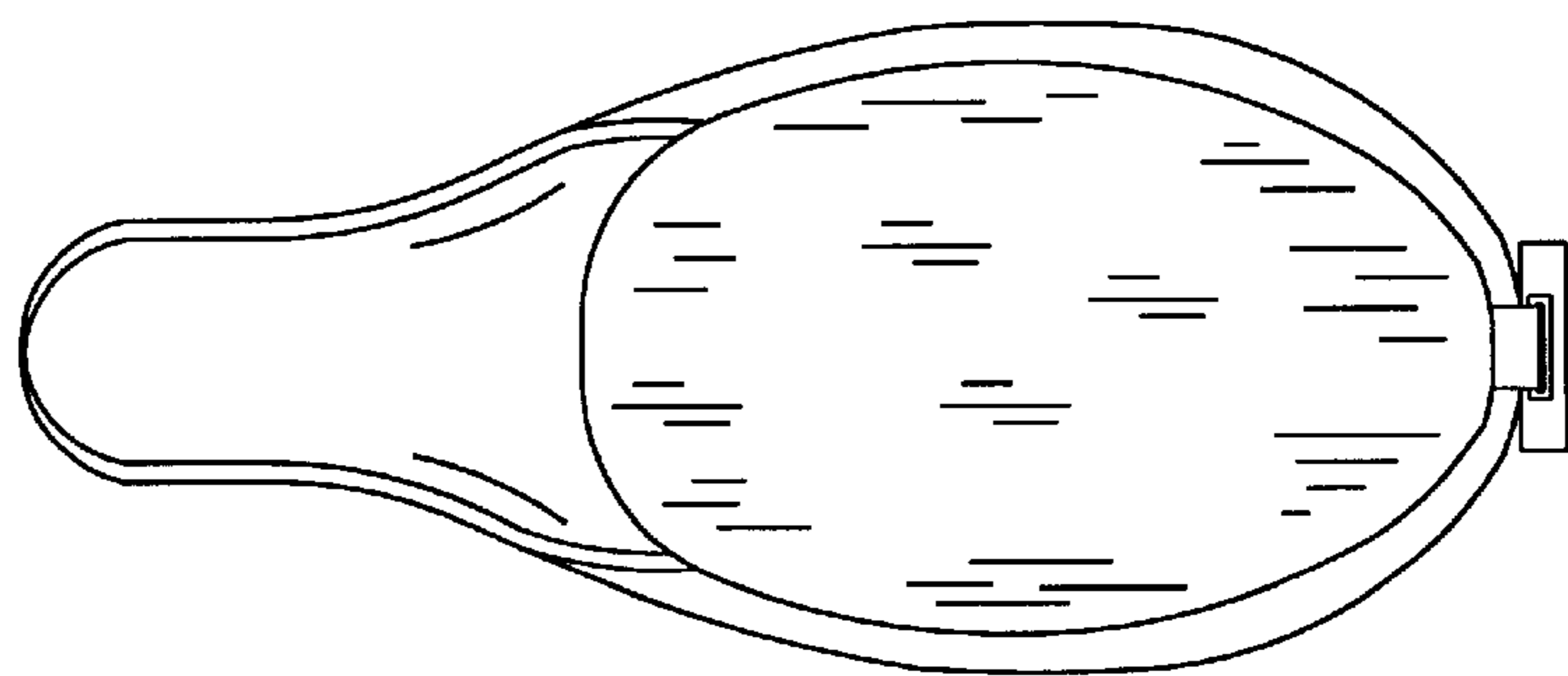

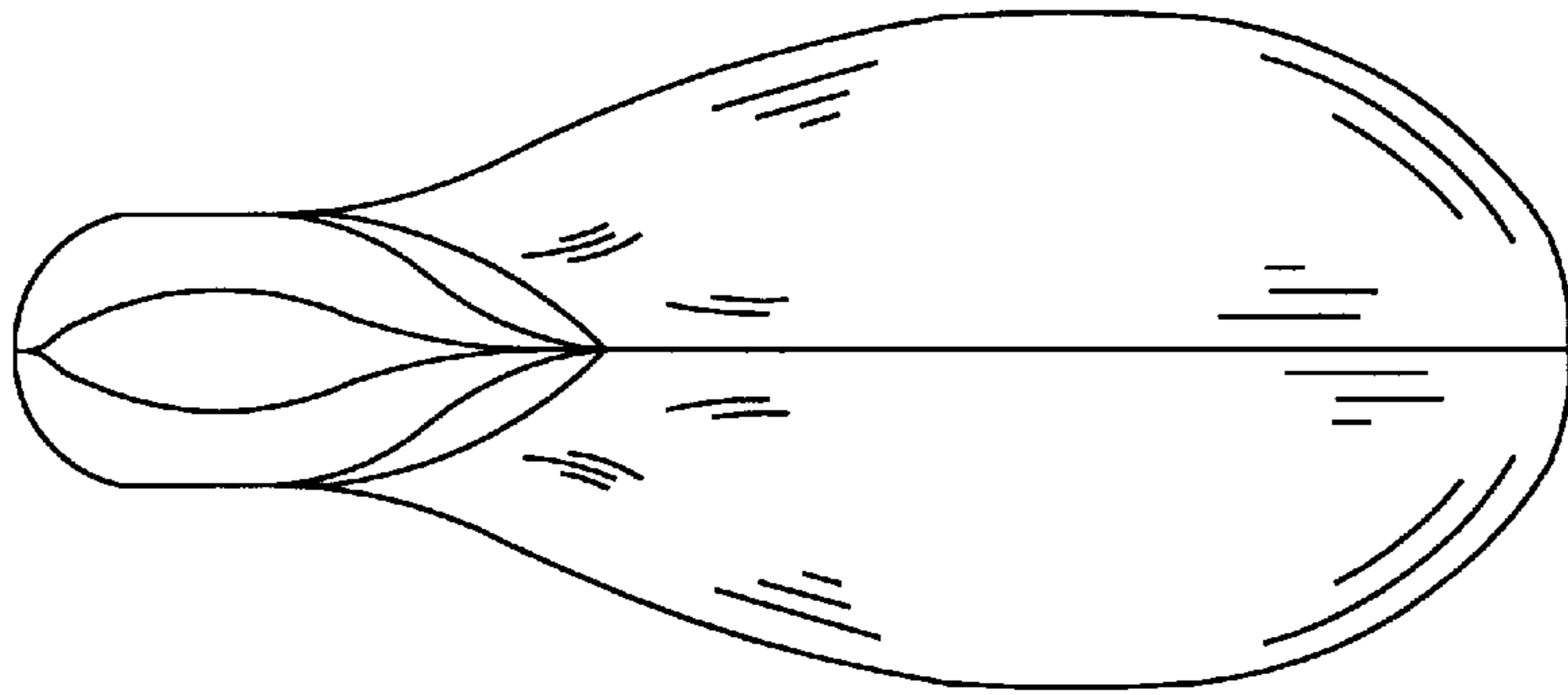

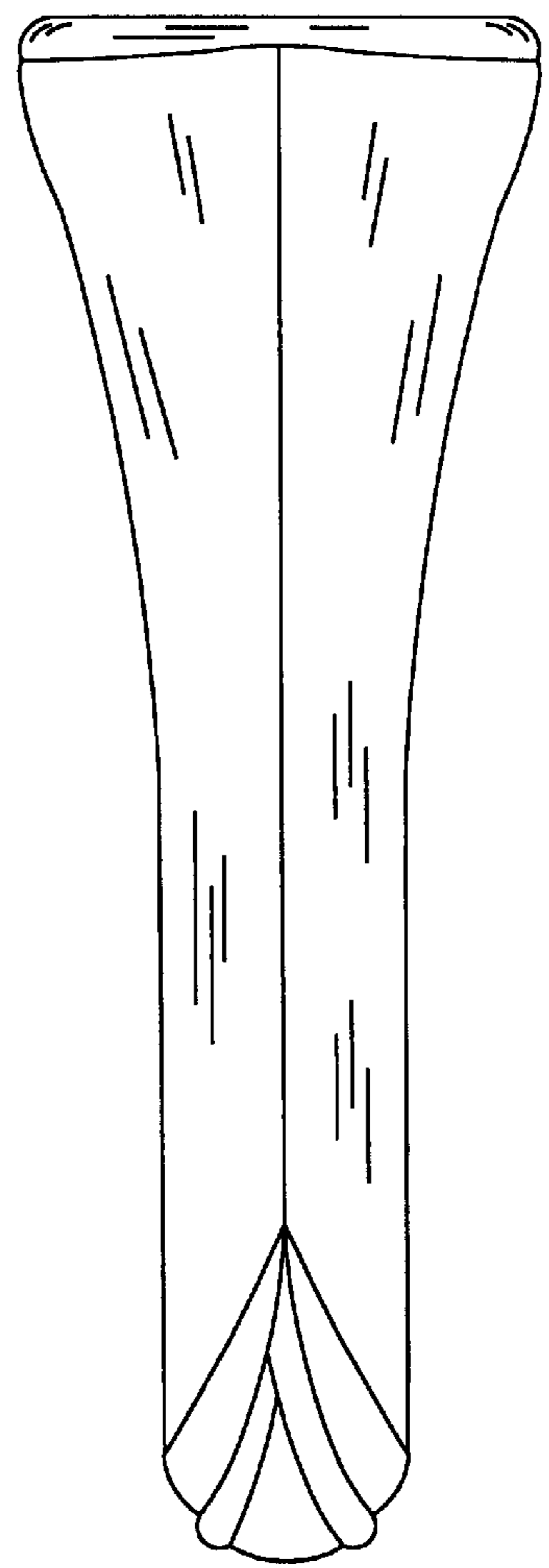

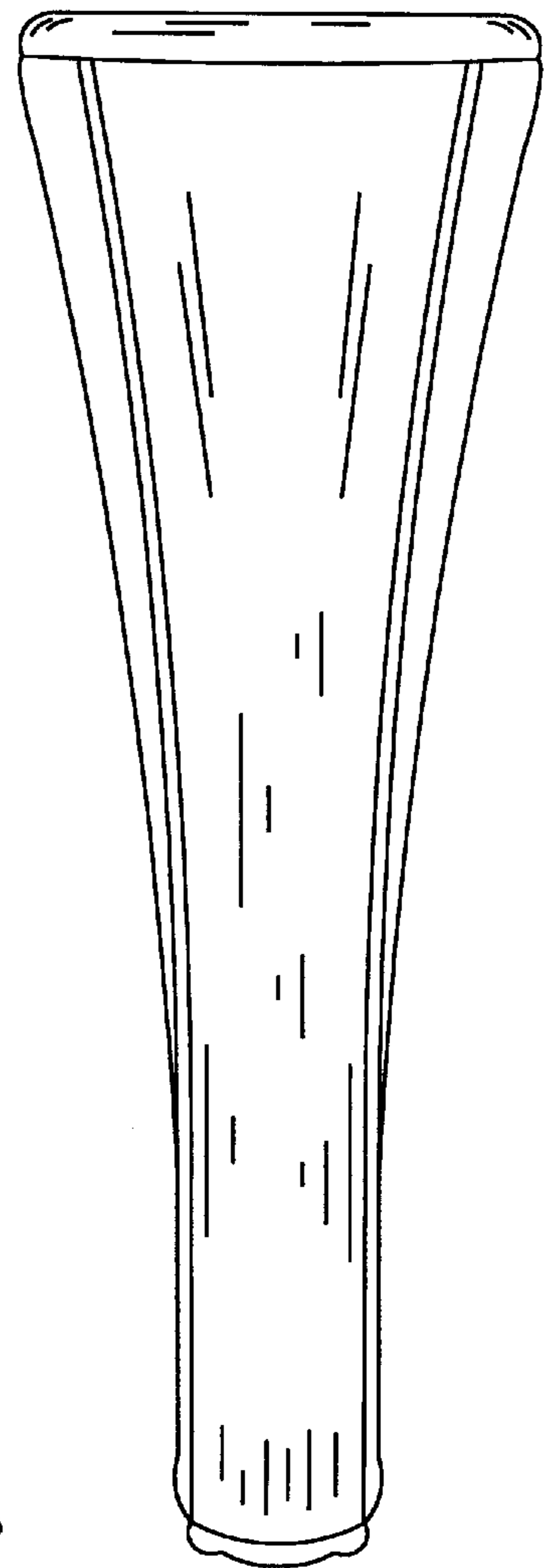

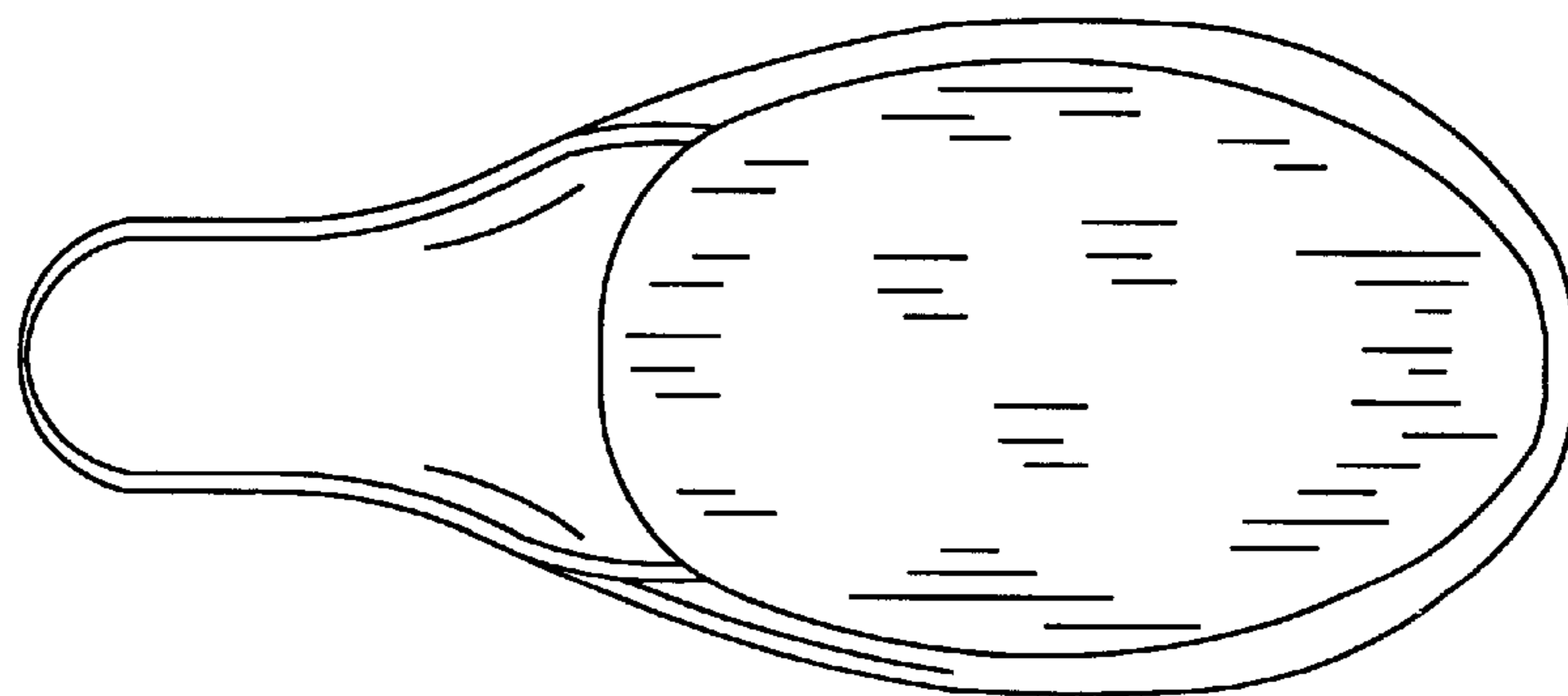
