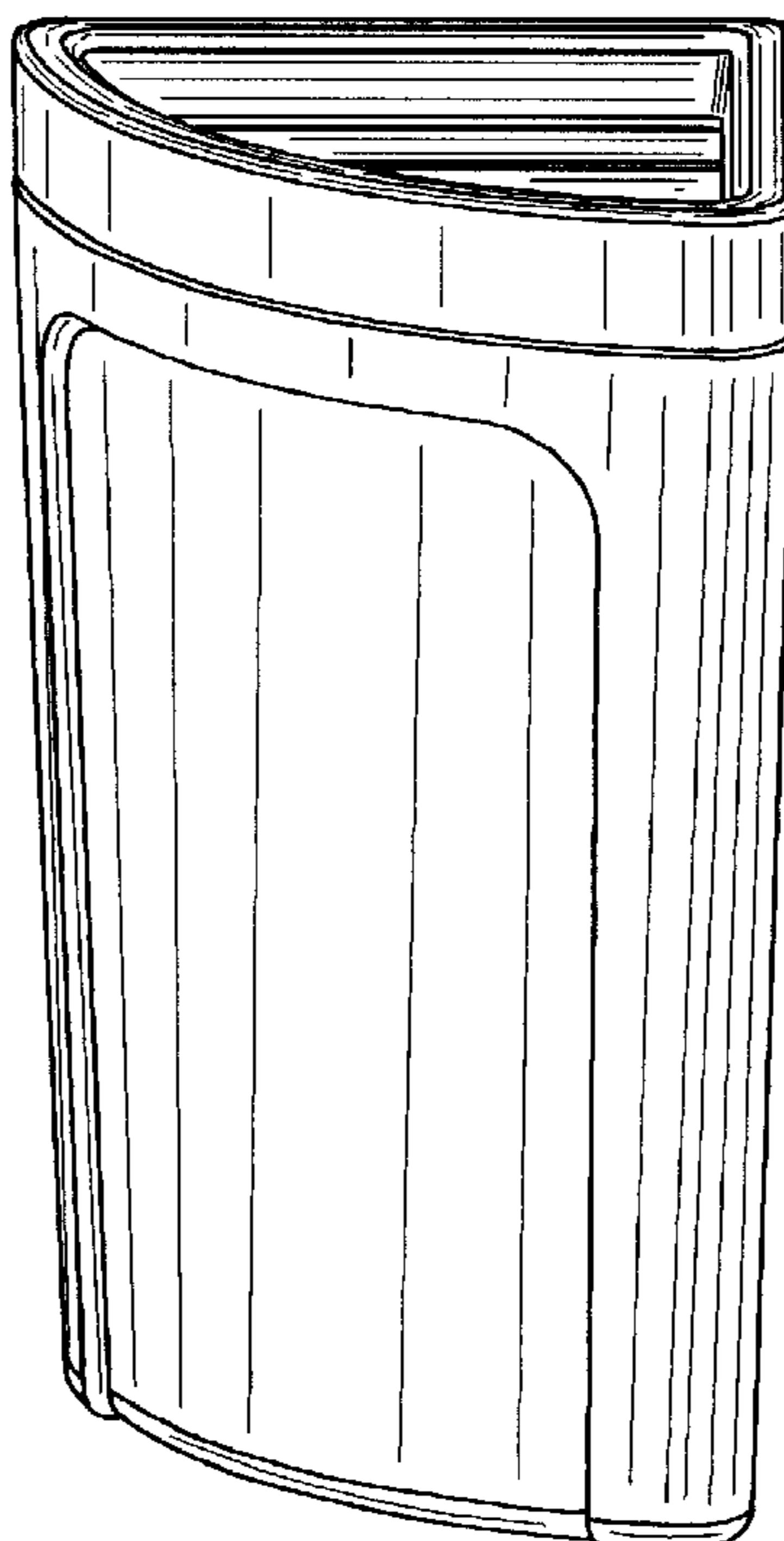
(57) **CLAIM**

The ornamental design for a corner waste container with collar, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a corner waste container with collar showing my new design;  
 FIG. 2 is a front elevational view of the corner waste container with collar of FIG. 1;  
 FIG. 3 is a right side elevational view of the corner waste container with collar of FIG. 1, the left side elevational view being a mirror image thereof;  
 FIG. 4 is a rear elevational view of the corner waste container with collar of FIG. 1; and,  
 FIG. 5 is a top plan view of the corner waste container with collar of FIG. 1.  
 The bottom view is unornamental and forms no part of the claimed design.

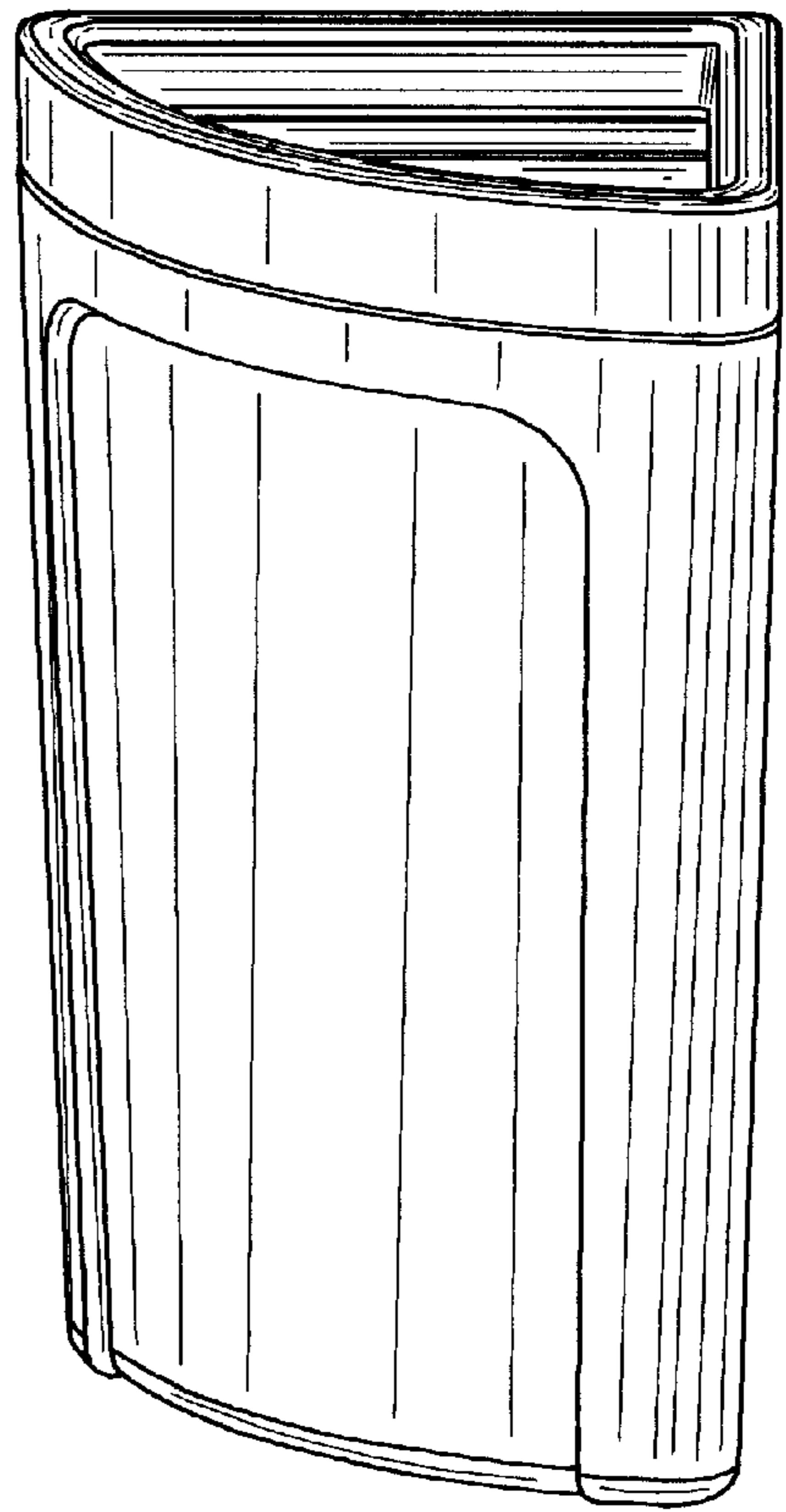

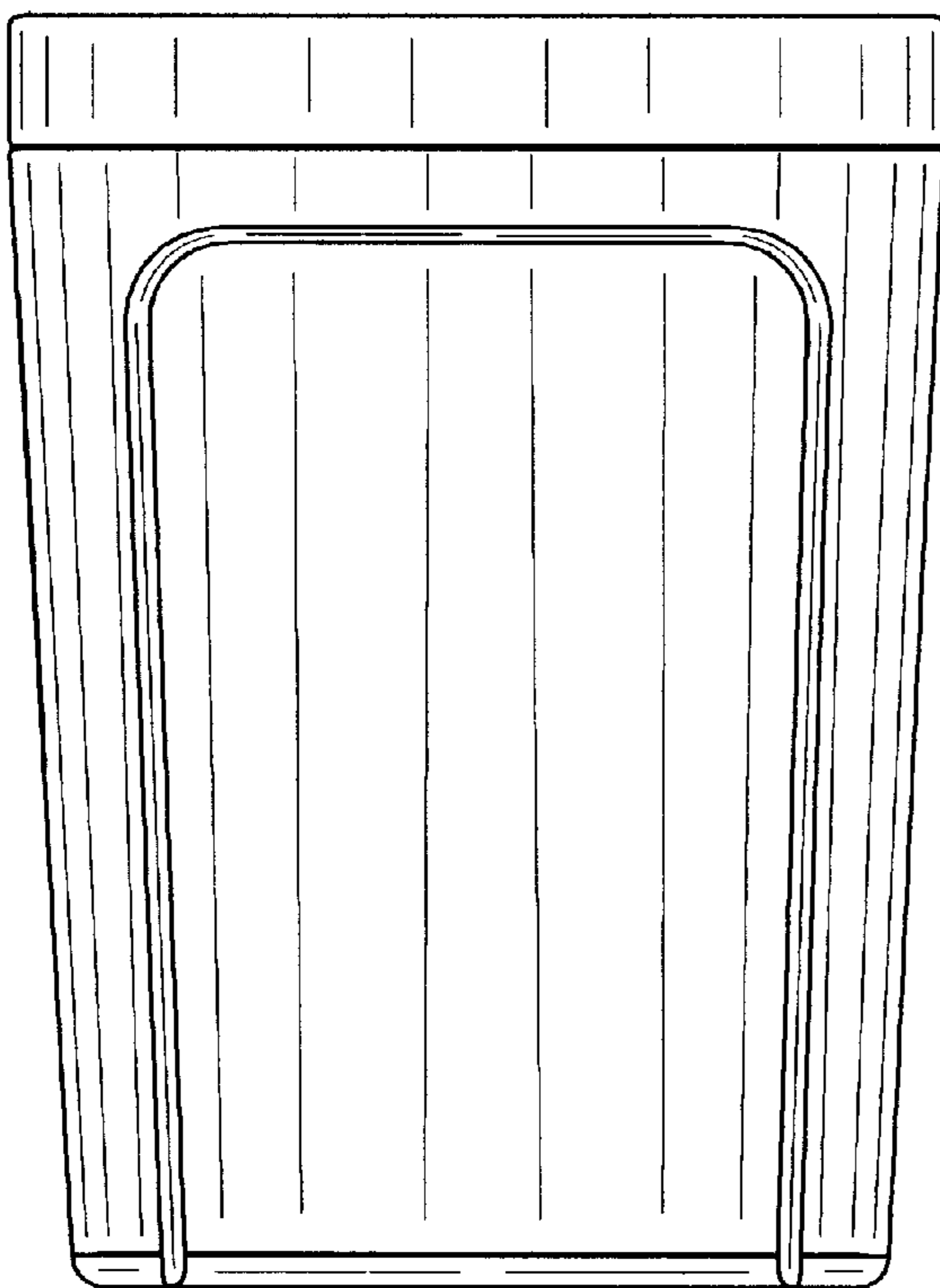

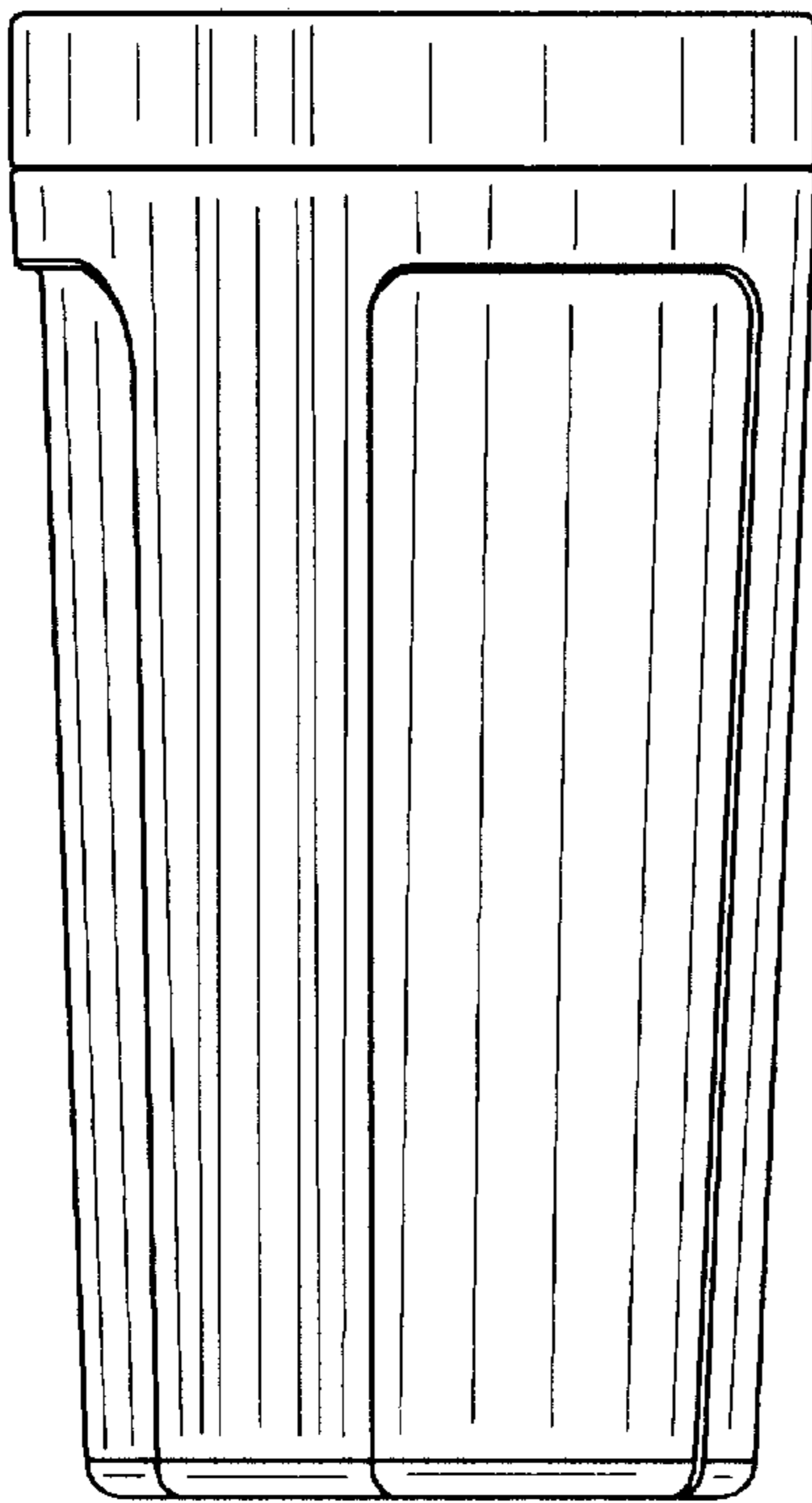

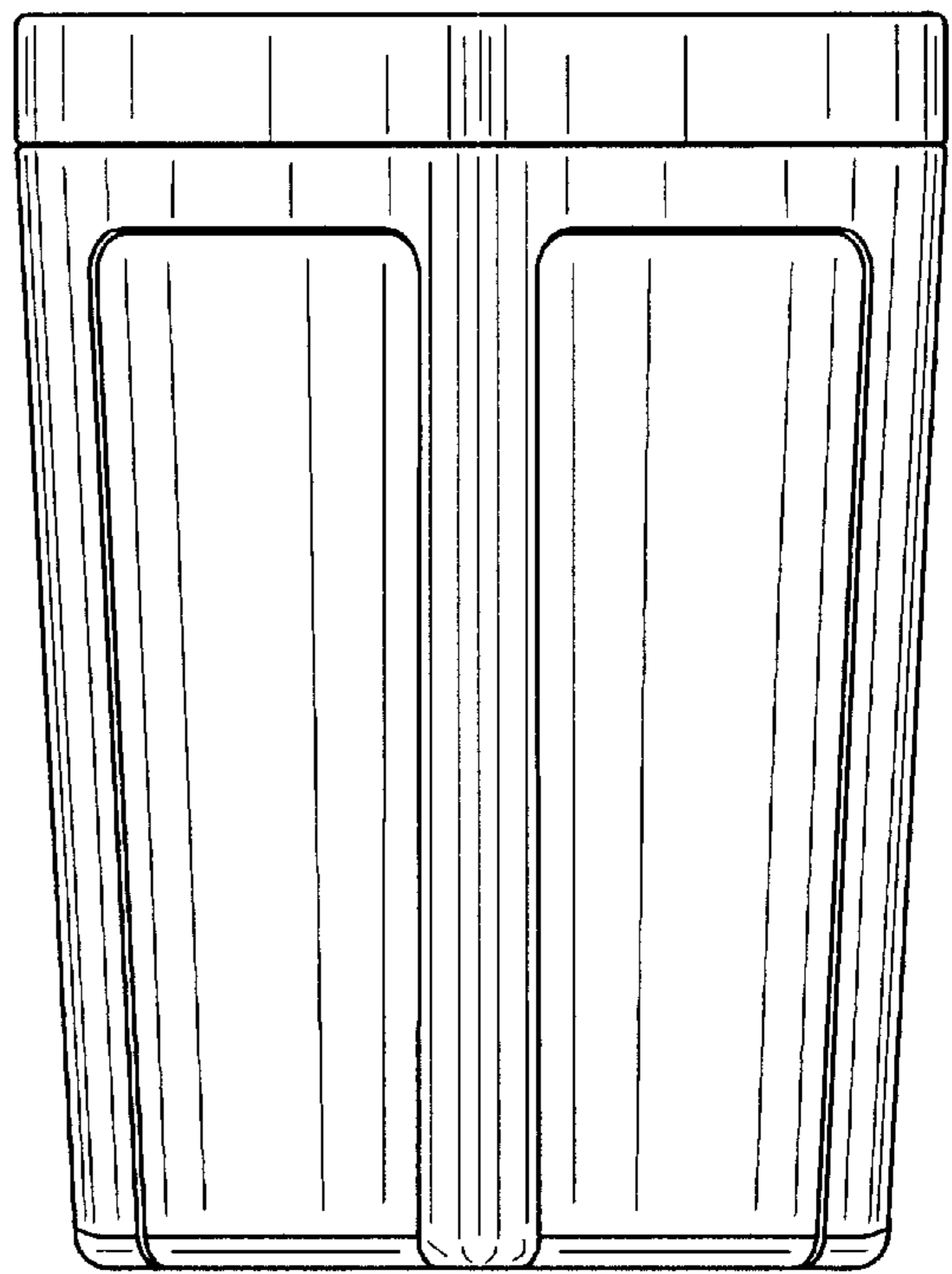

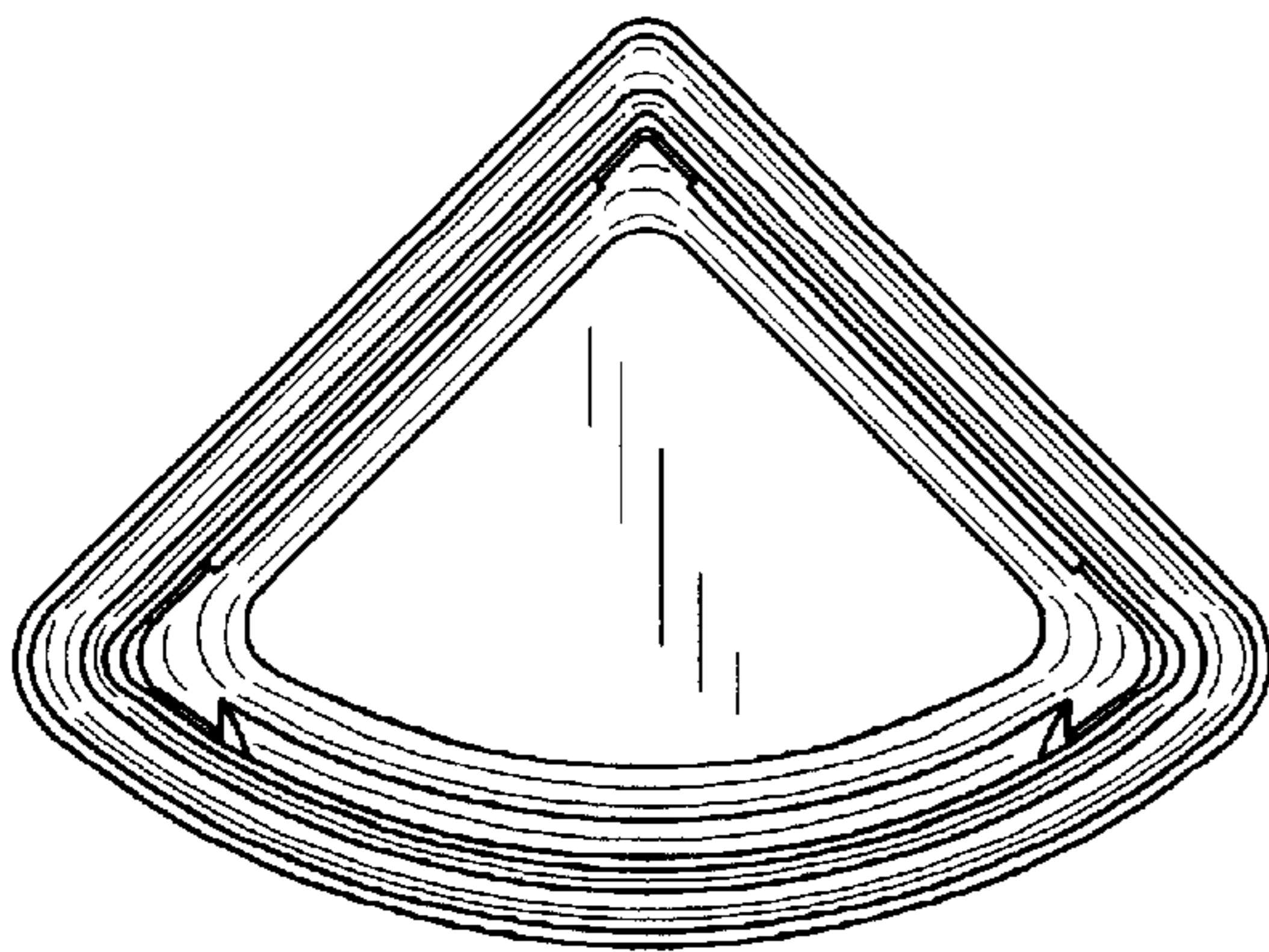
