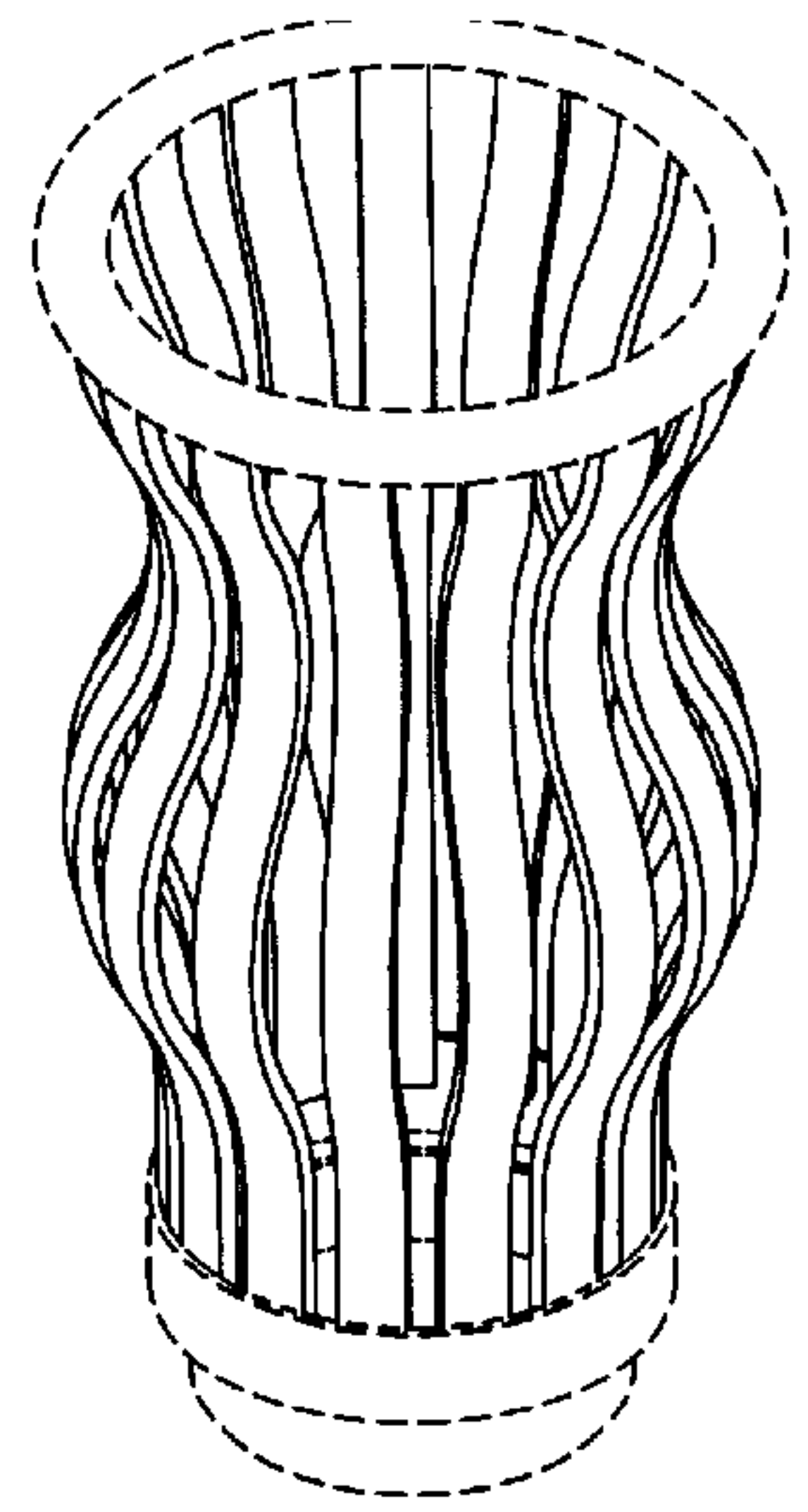
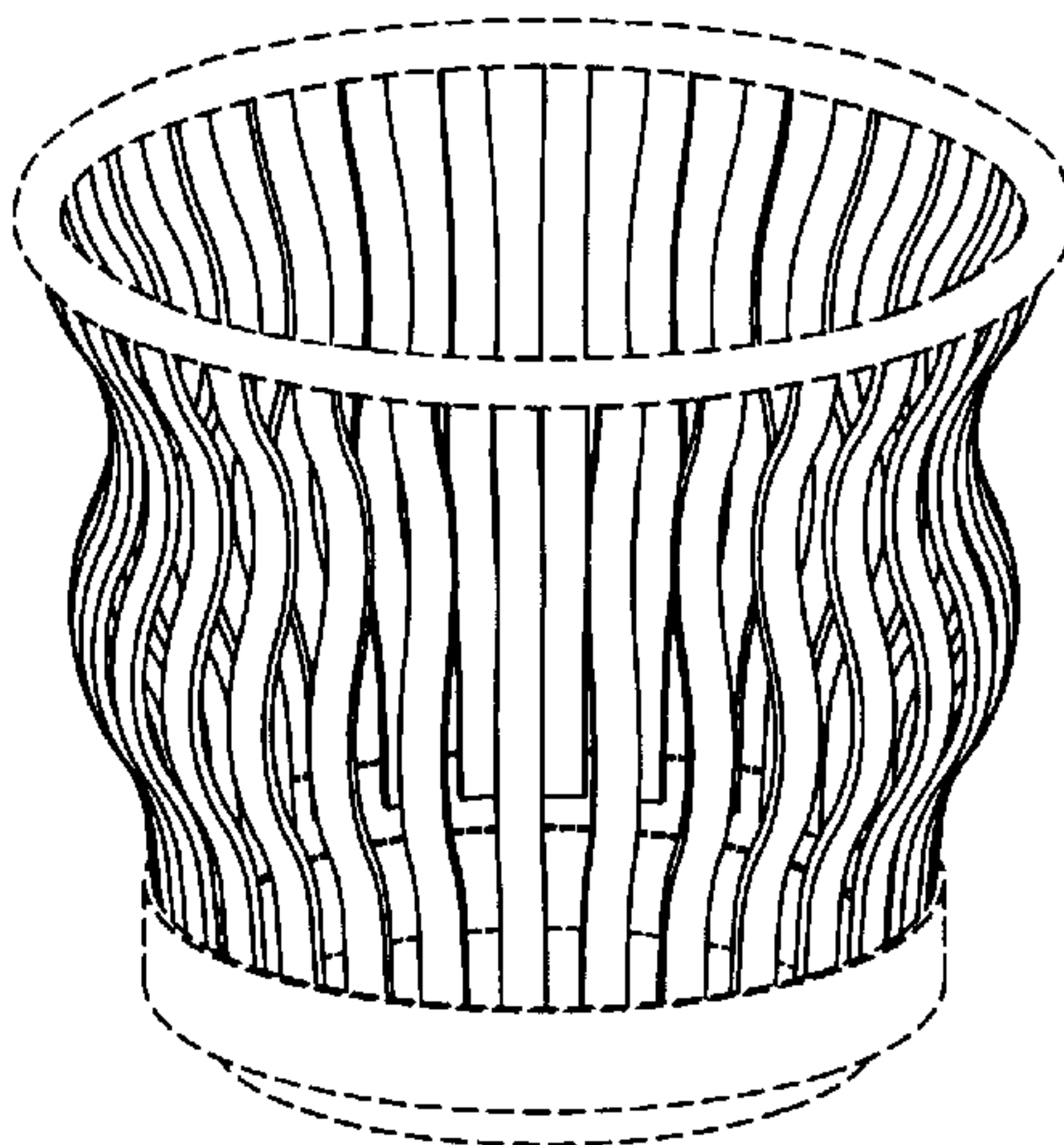
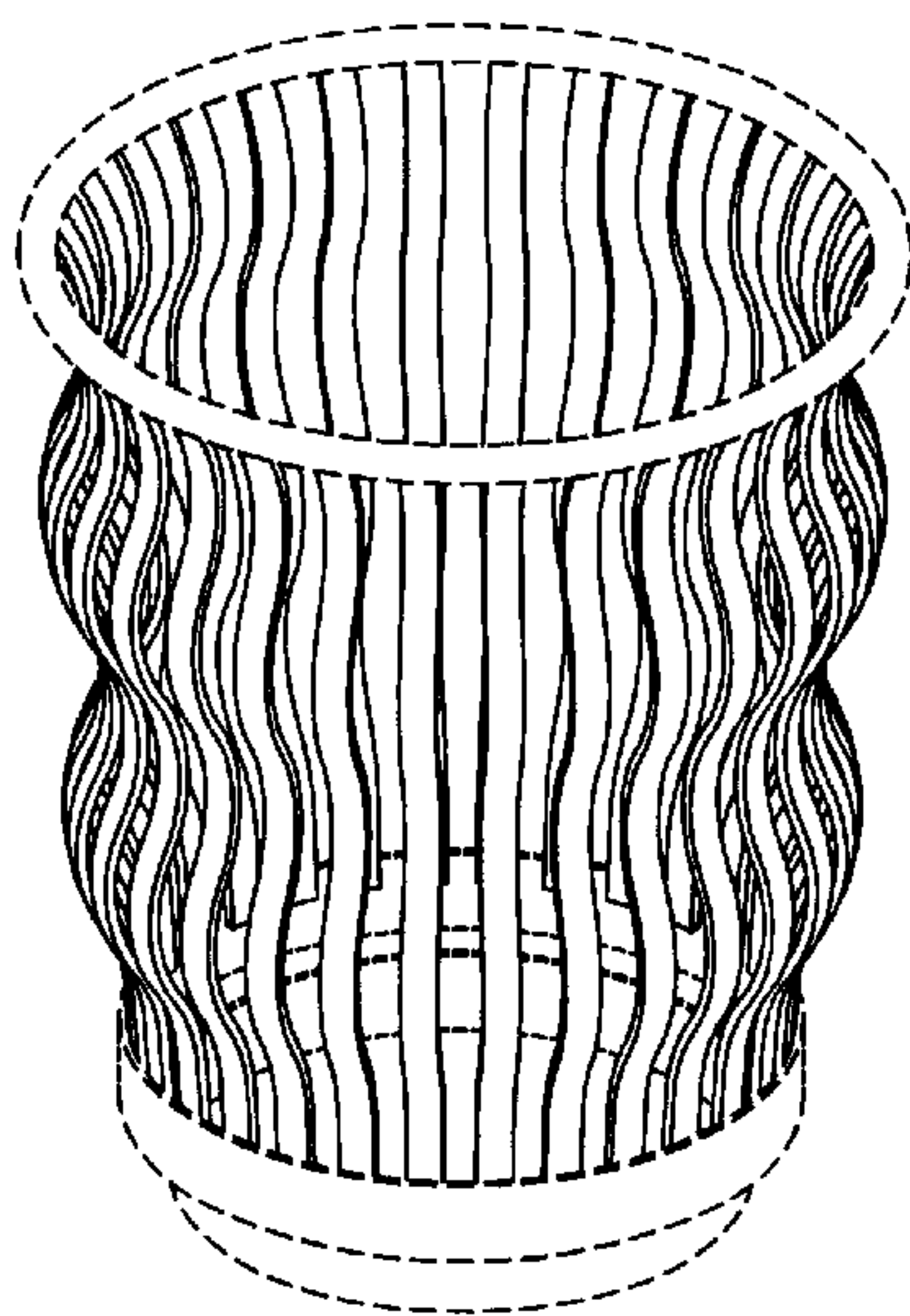
(57) **CLAIM**

The ornamental design for a receptacle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and top perspective view of a receptacle showing a first embodiment of my new design; FIG. 2 is a front elevation view of the receptacle of FIG. 1; FIG. 3 is a side elevation view of the receptacle of FIG. 1; FIG. 4 is a top plan view of the receptacle of FIG. 1; FIG. 5 is a bottom plan view of the receptacle of FIG. 1; FIG. 6 is a front and top perspective view of a receptacle showing a second embodiment of my new design; FIG. 7 is a front elevation view of the receptacle of FIG. 6; FIG. 8 is a side elevation view of the receptacle of FIG. 6; FIG. 9 is a top plan view of the receptacle of FIG. 6; FIG. 10 is a bottom plan view of the receptacle of FIG. 6; FIG. 11 is a front and top perspective view of a receptacle showing a third embodiment of my new design; FIG. 12 is a front elevation view of the receptacle of FIG. 11; FIG. 13 is a side elevation view of the receptacle of FIG. 11; FIG. 14 is a top plan view of the receptacle of FIG. 11; and, FIG. 15 is a bottom plan view of the receptacle of FIG. 11. The broken line showing of environmental structure in FIGS. 1-15 are for illustrative purposes only and form no part of the claimed design.

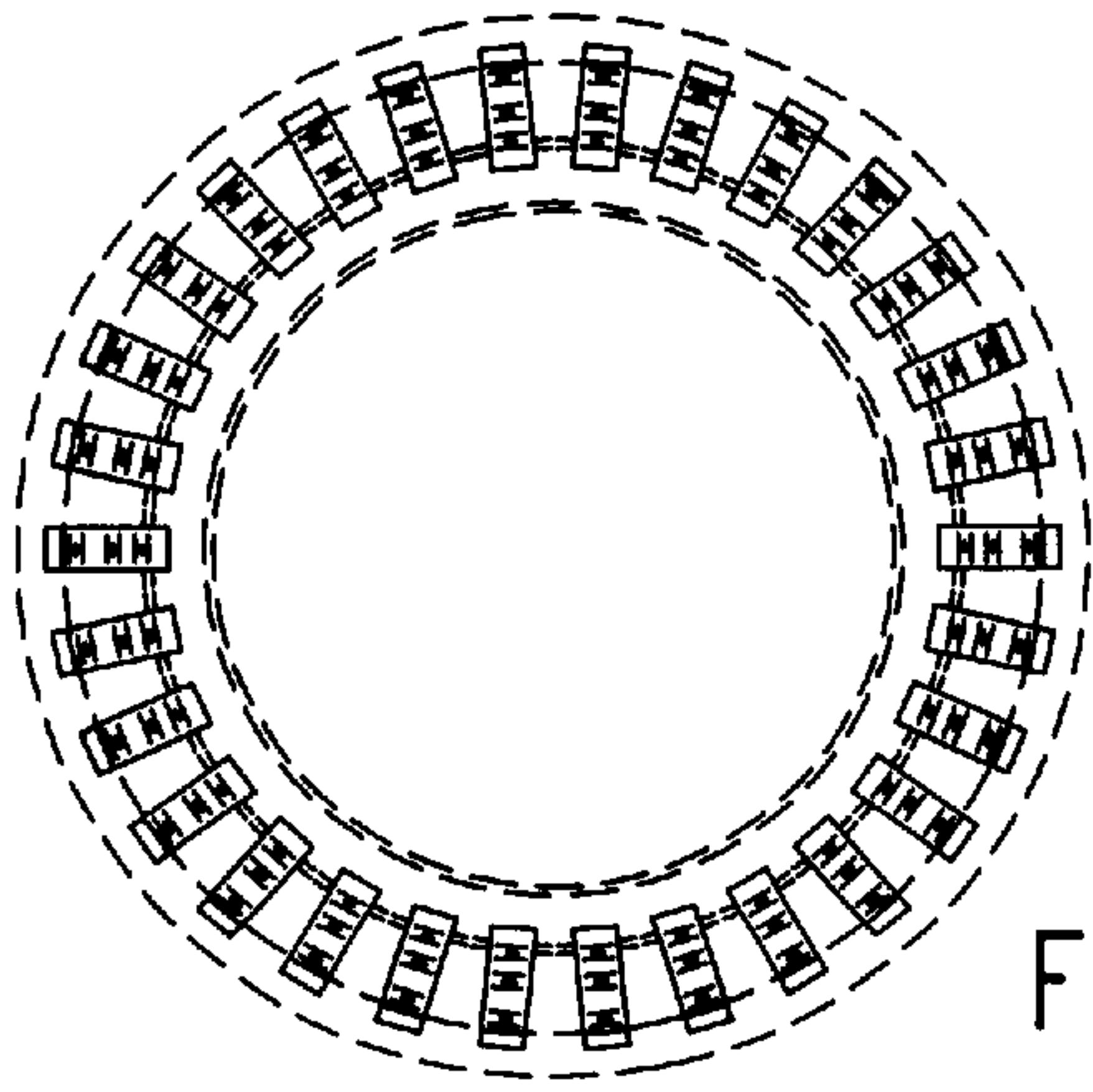

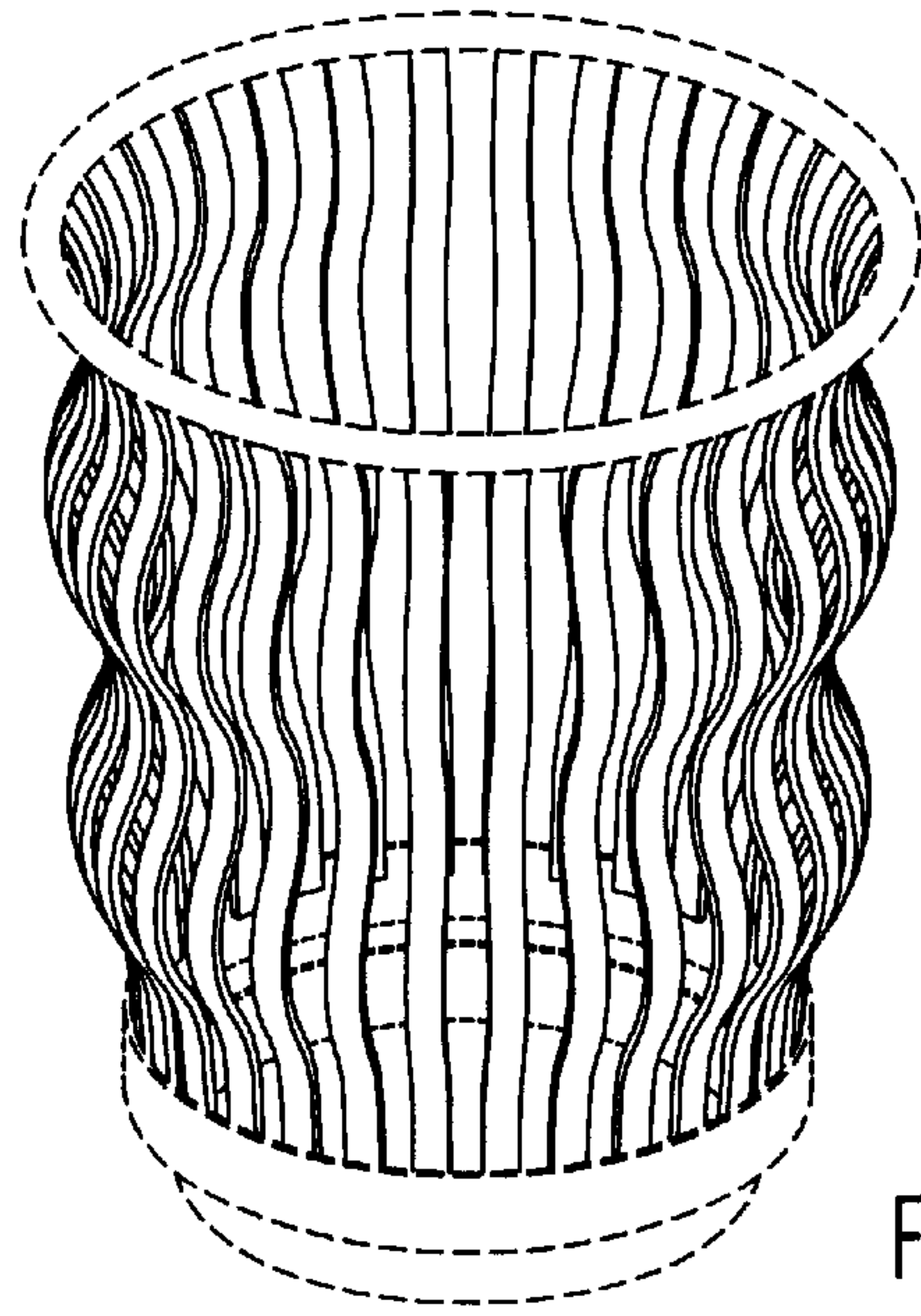

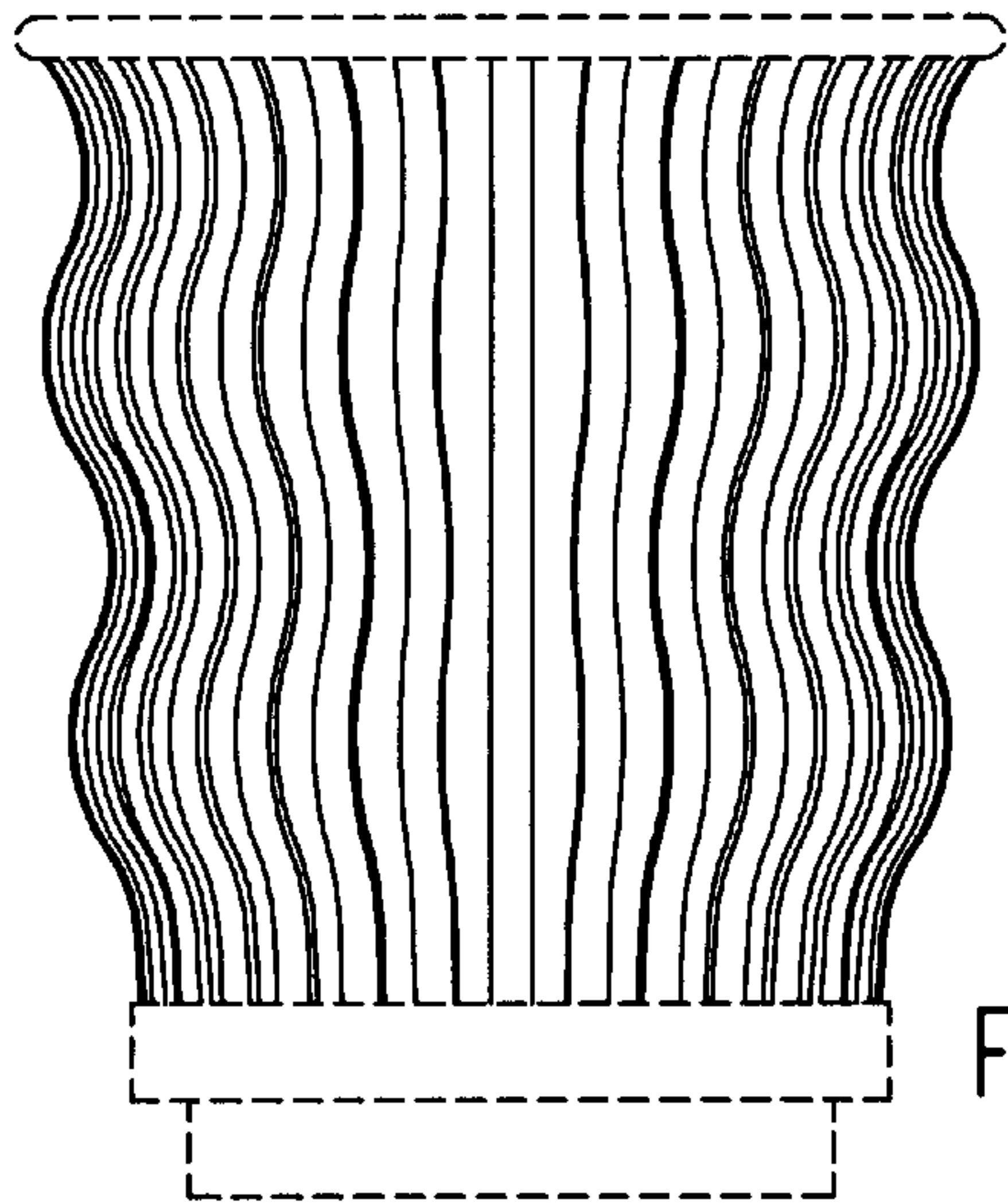

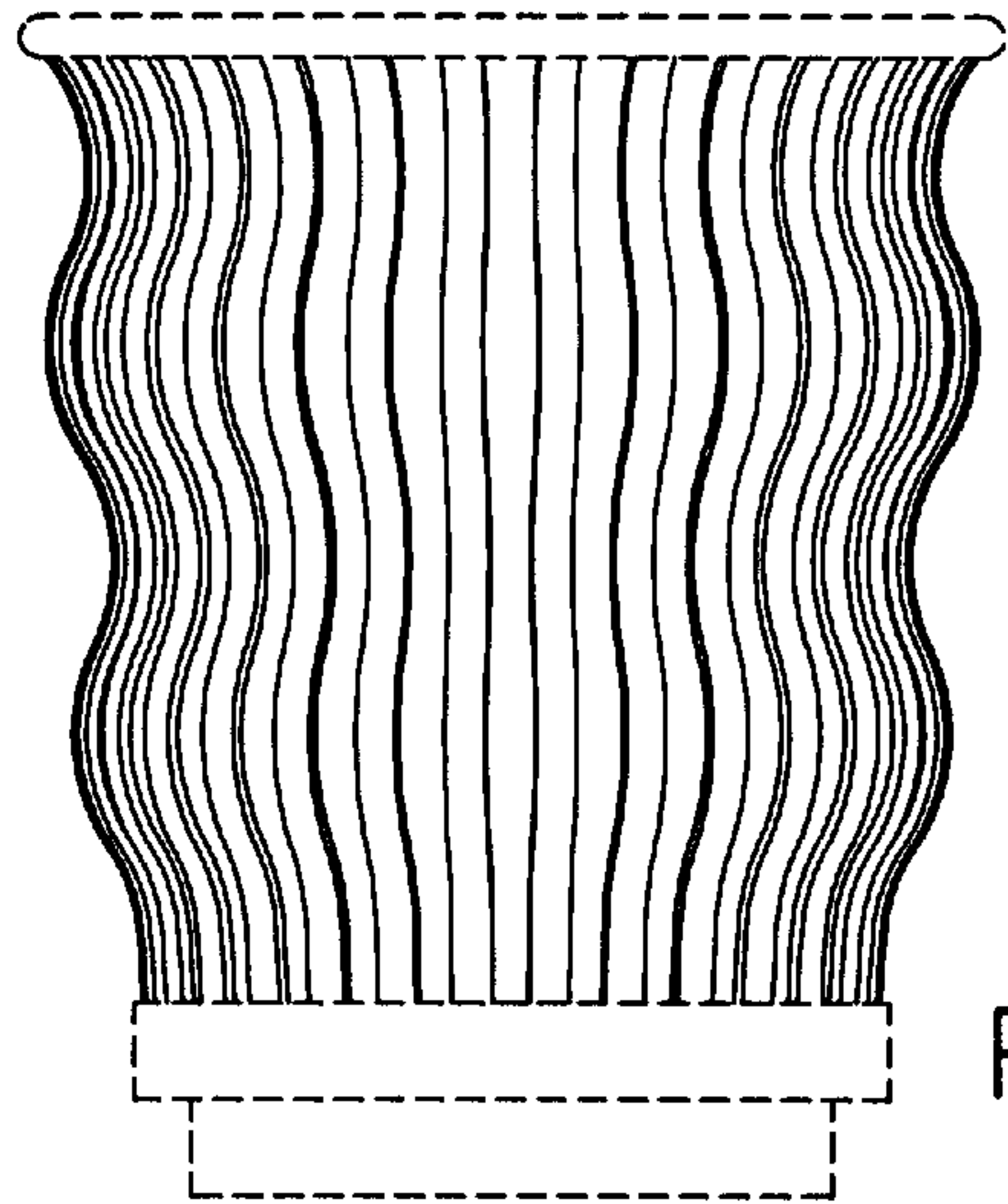

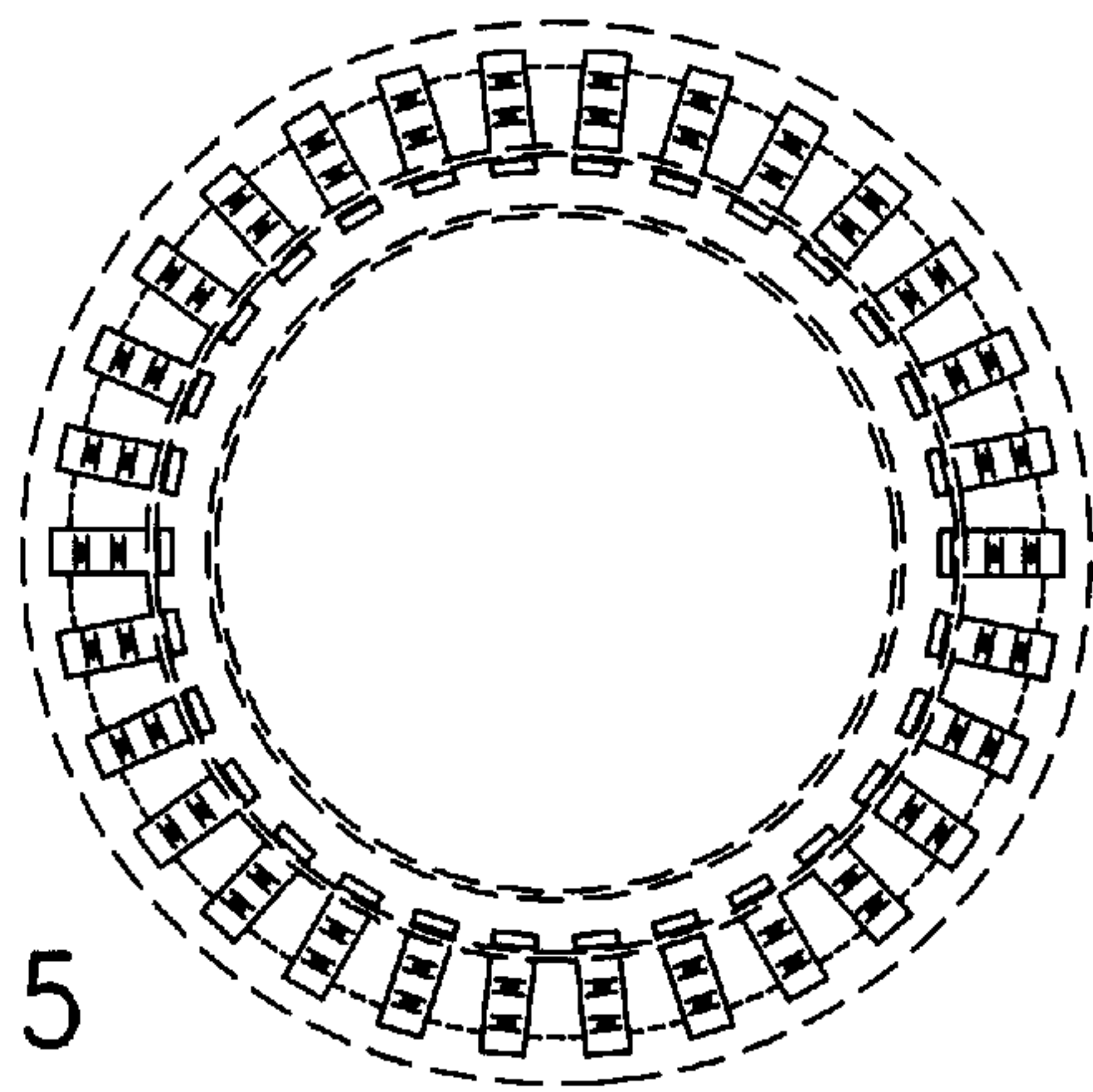

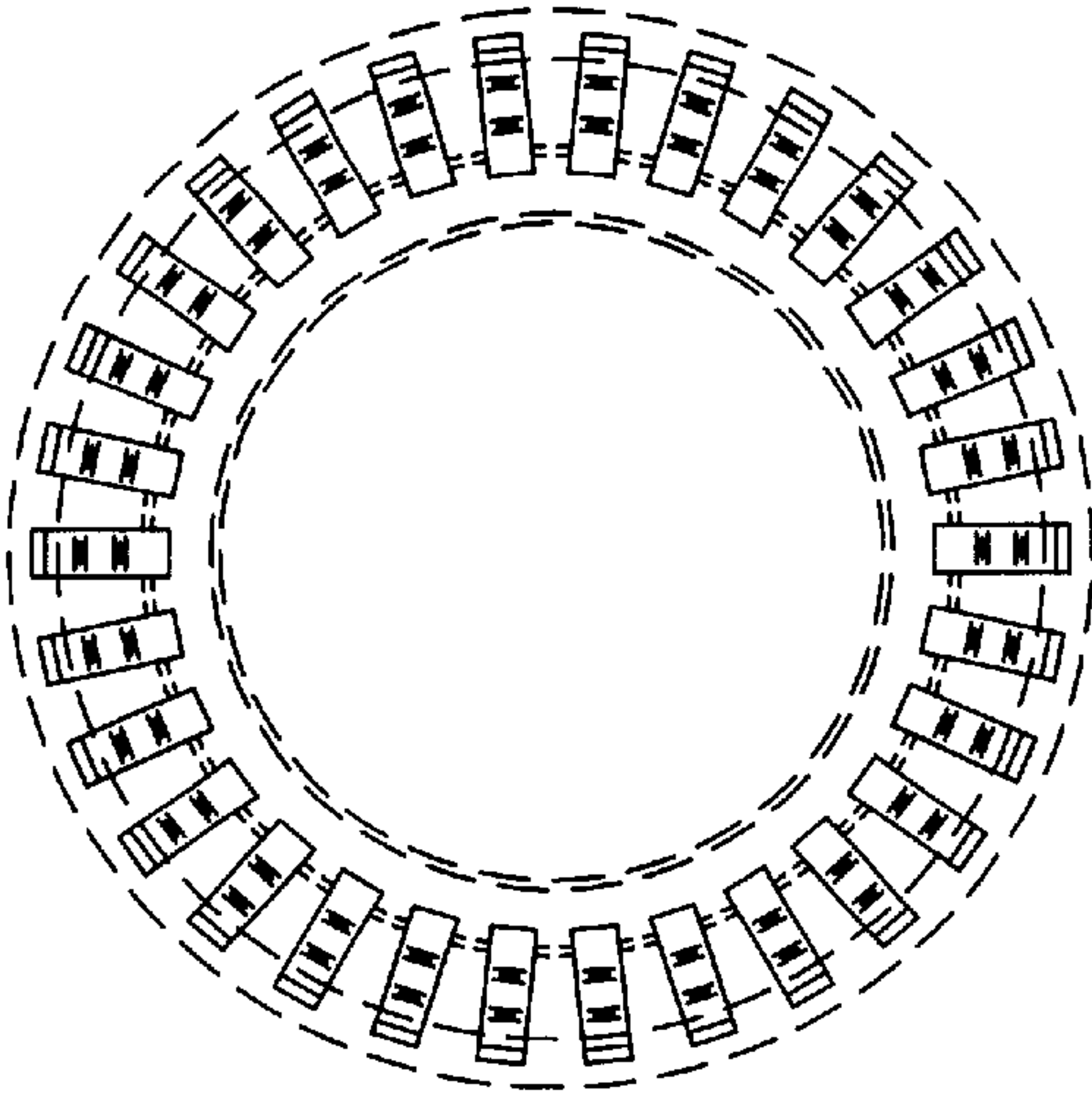

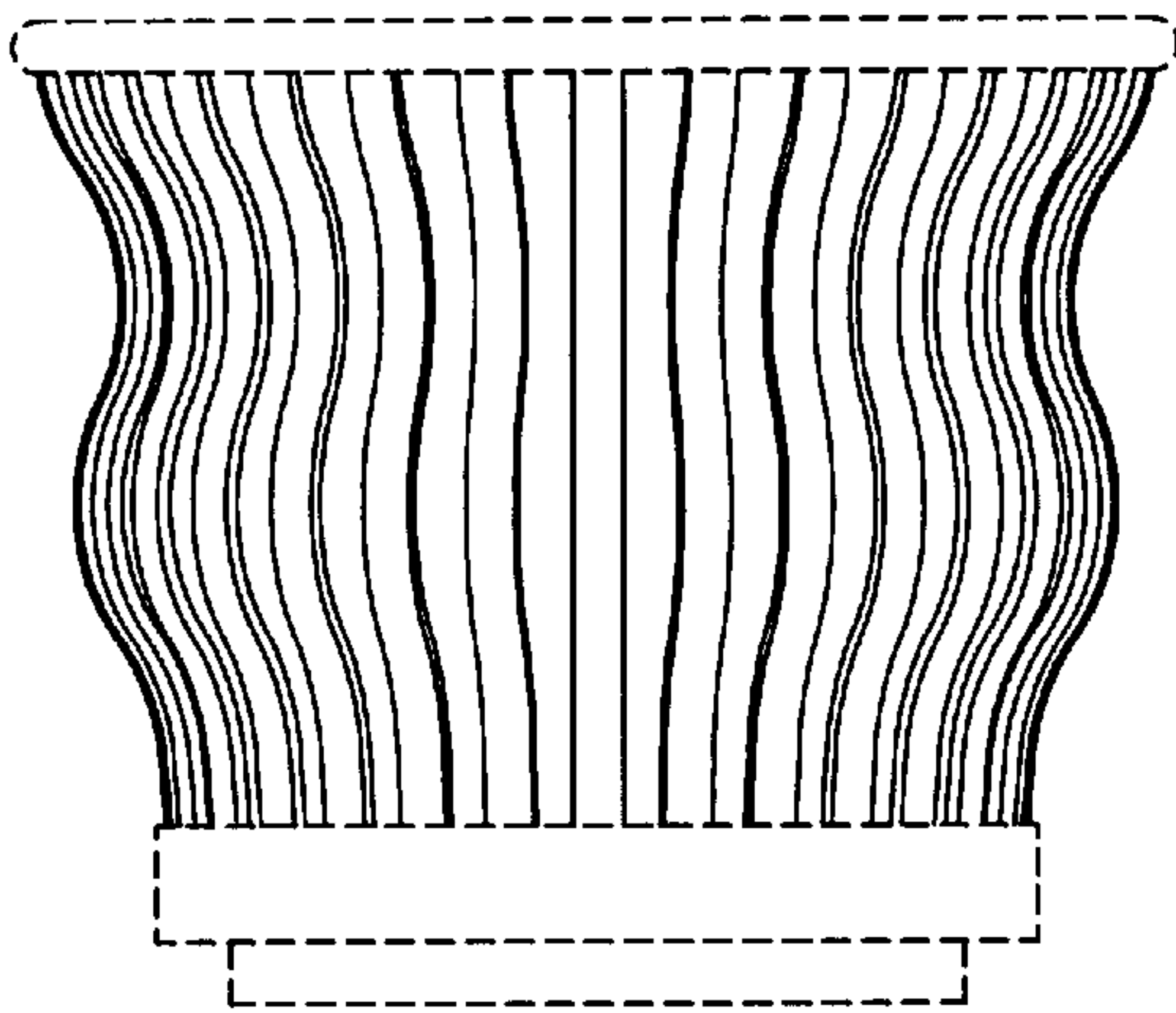
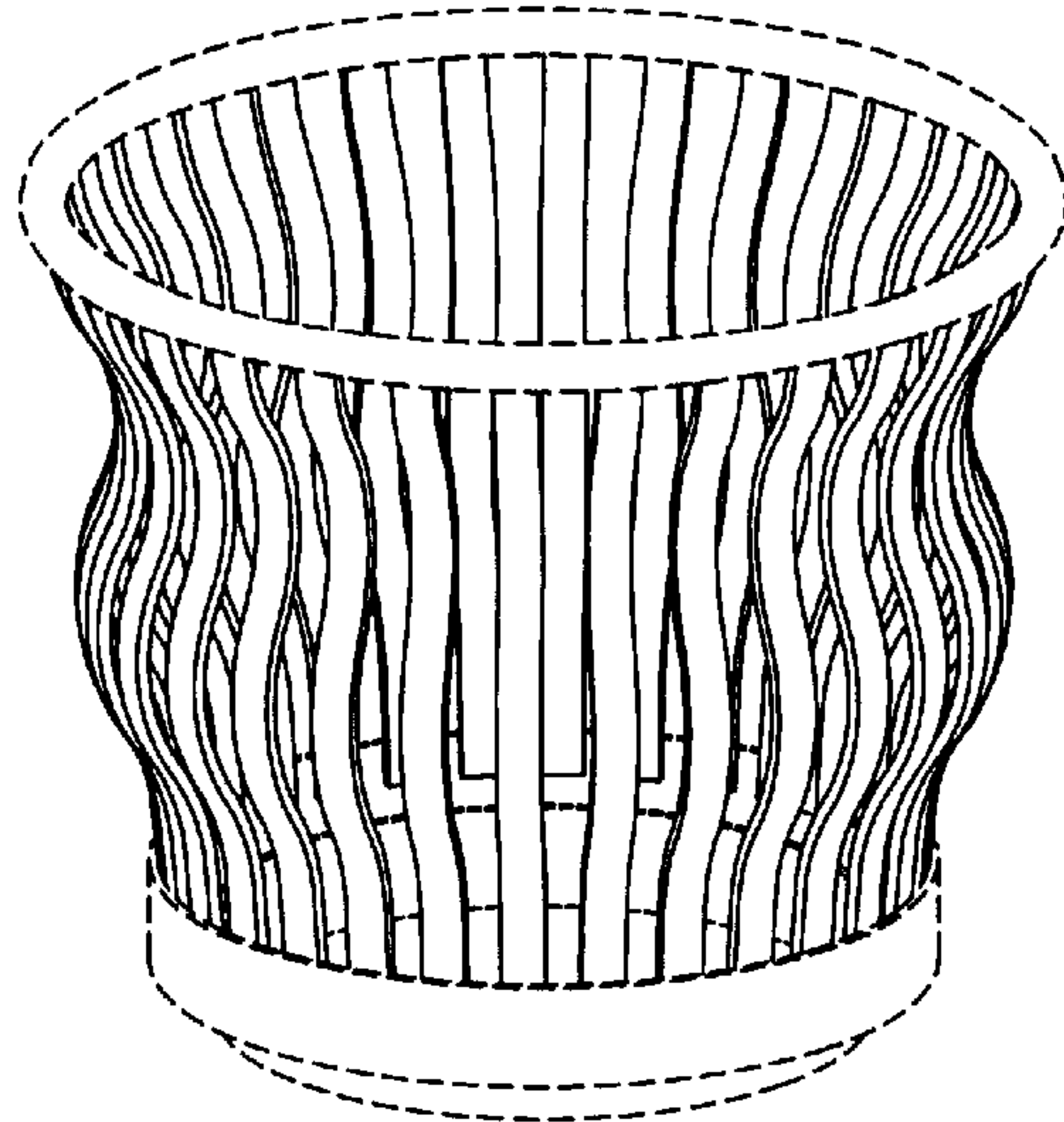

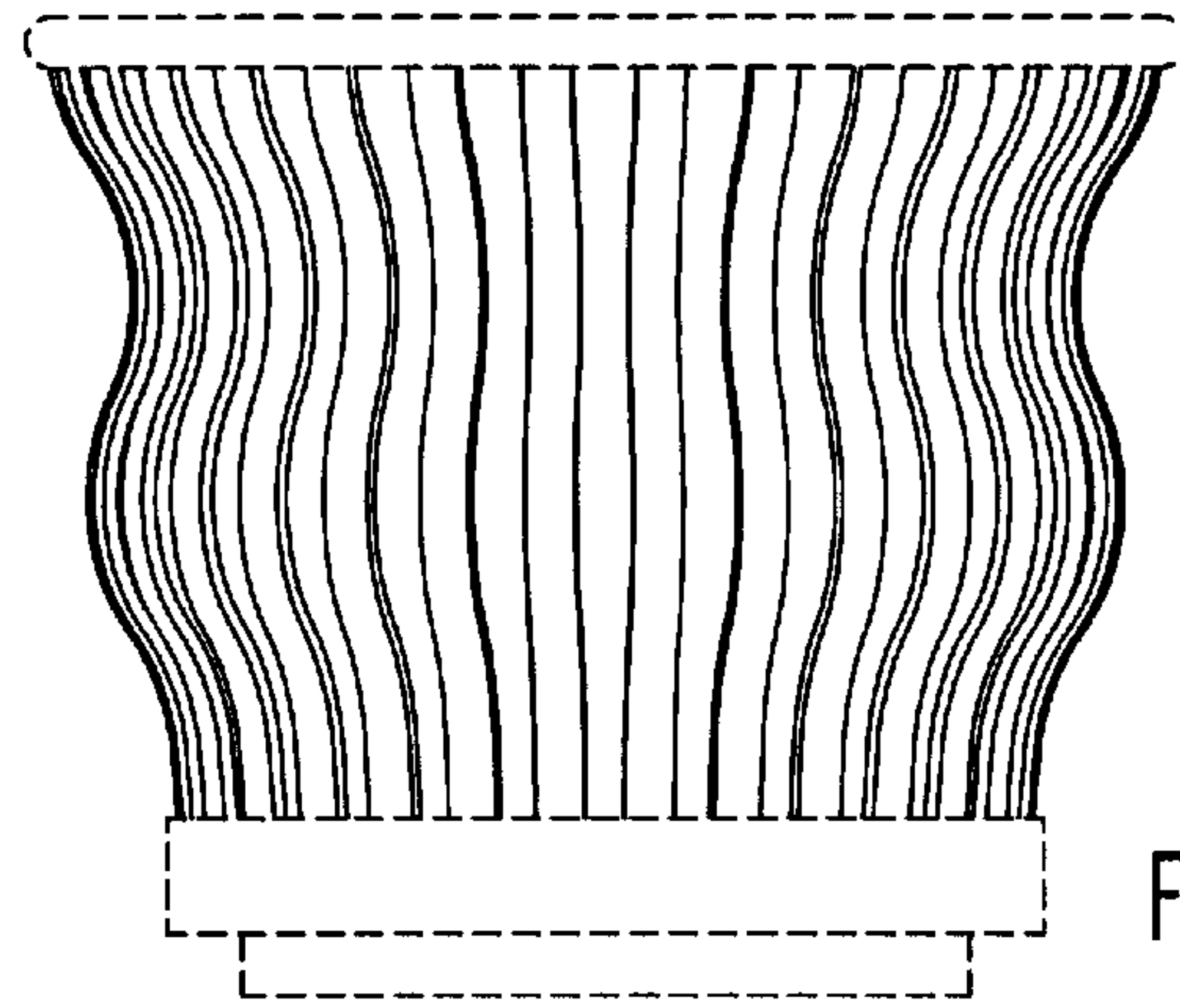
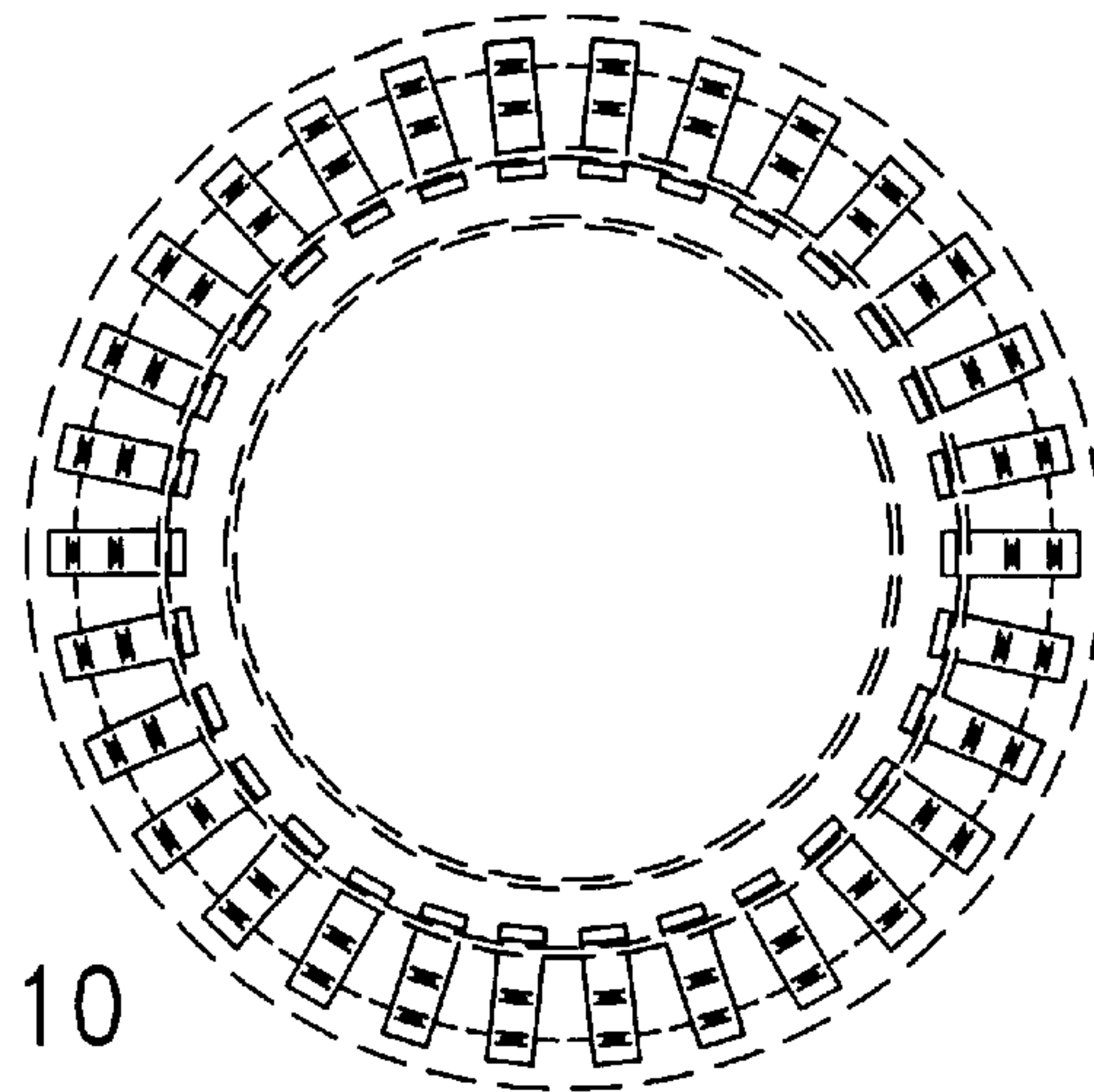

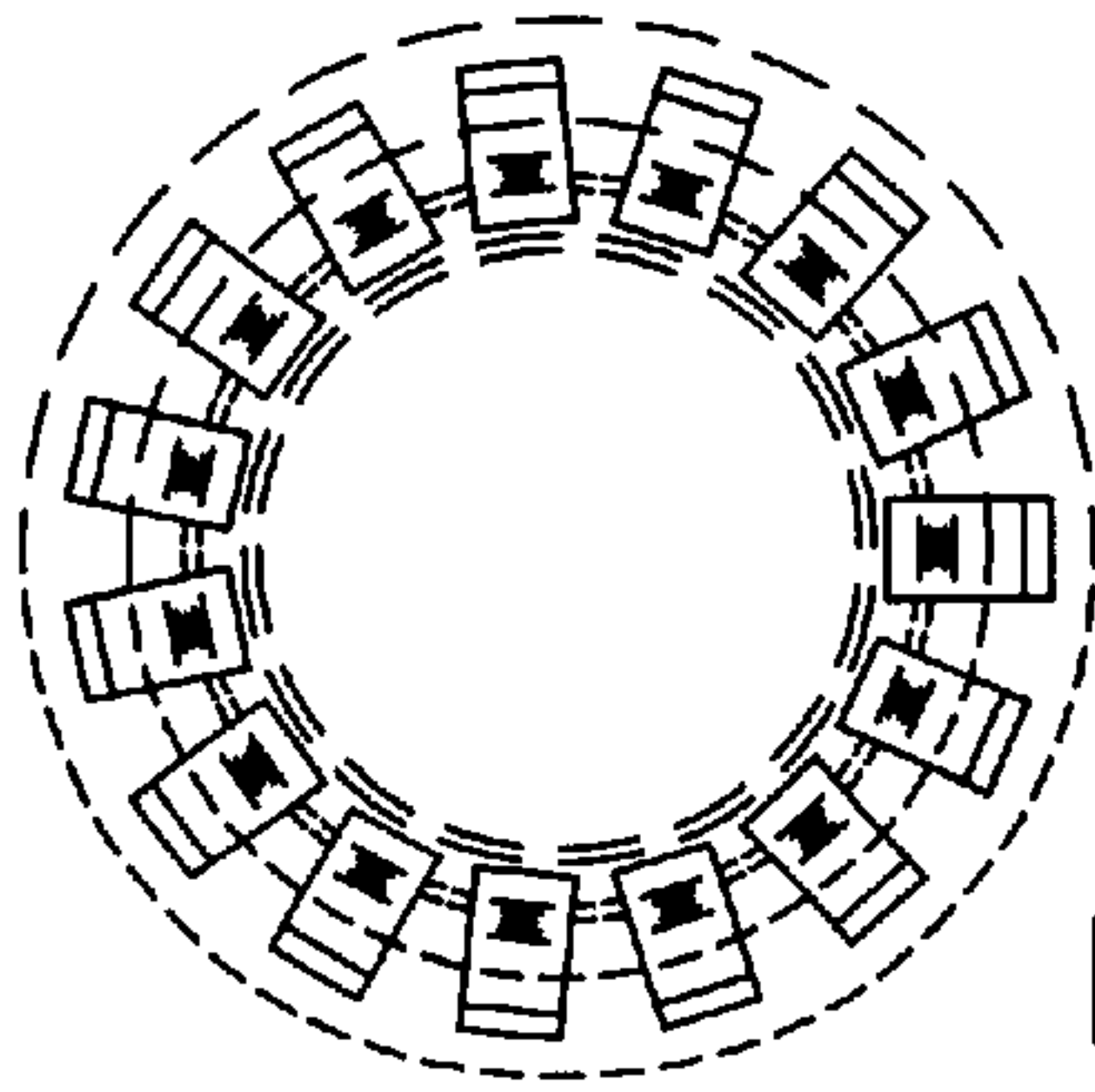

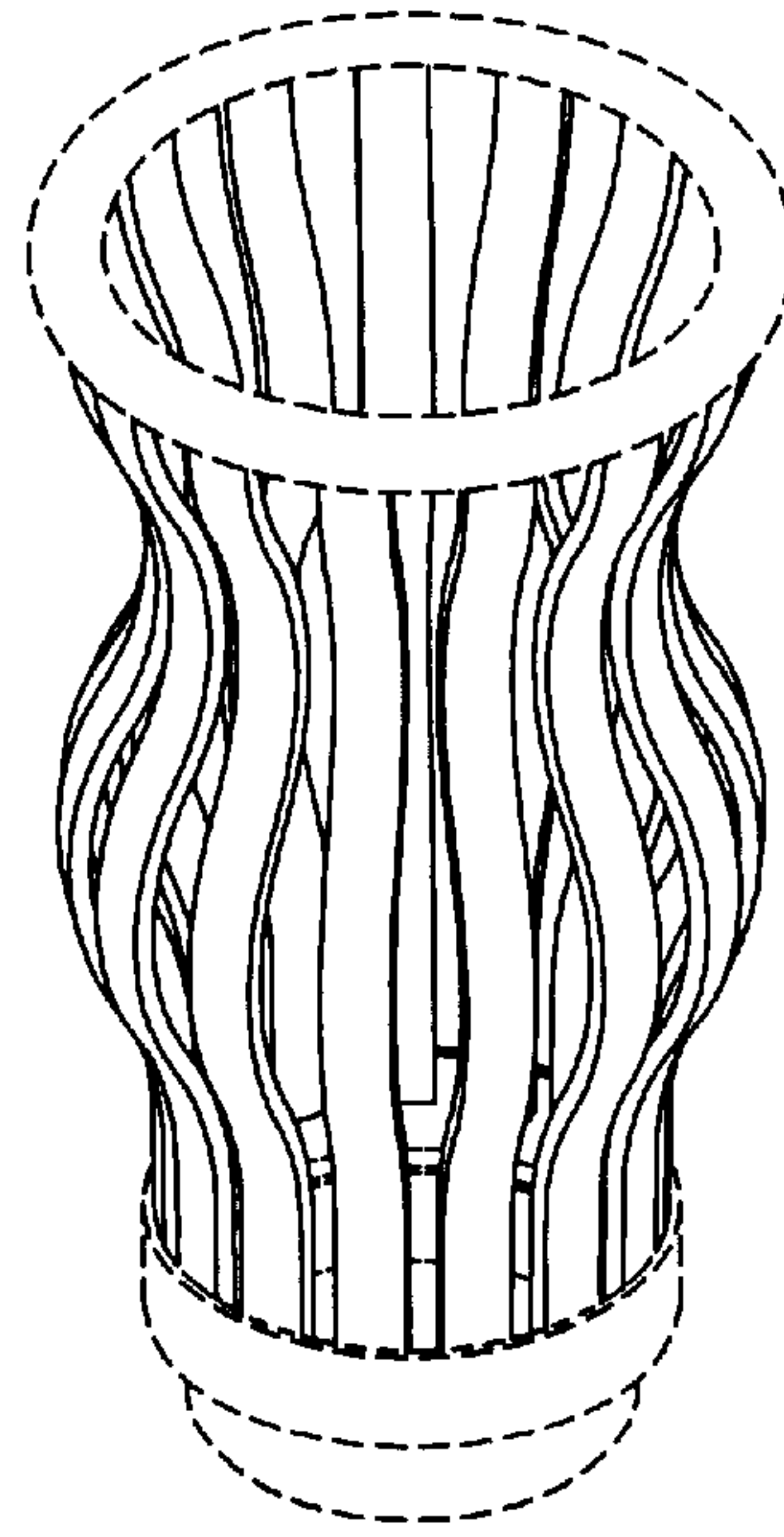

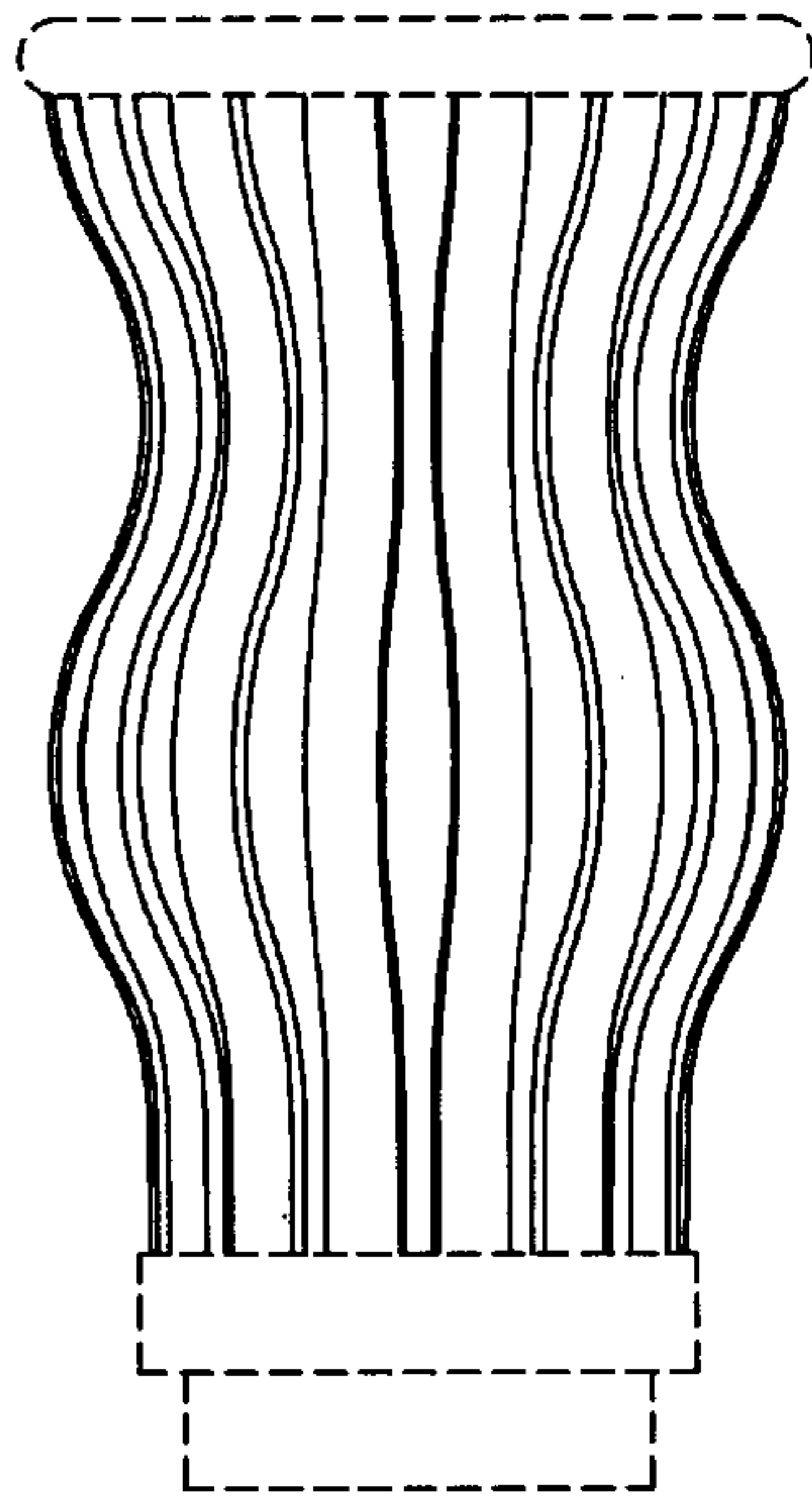

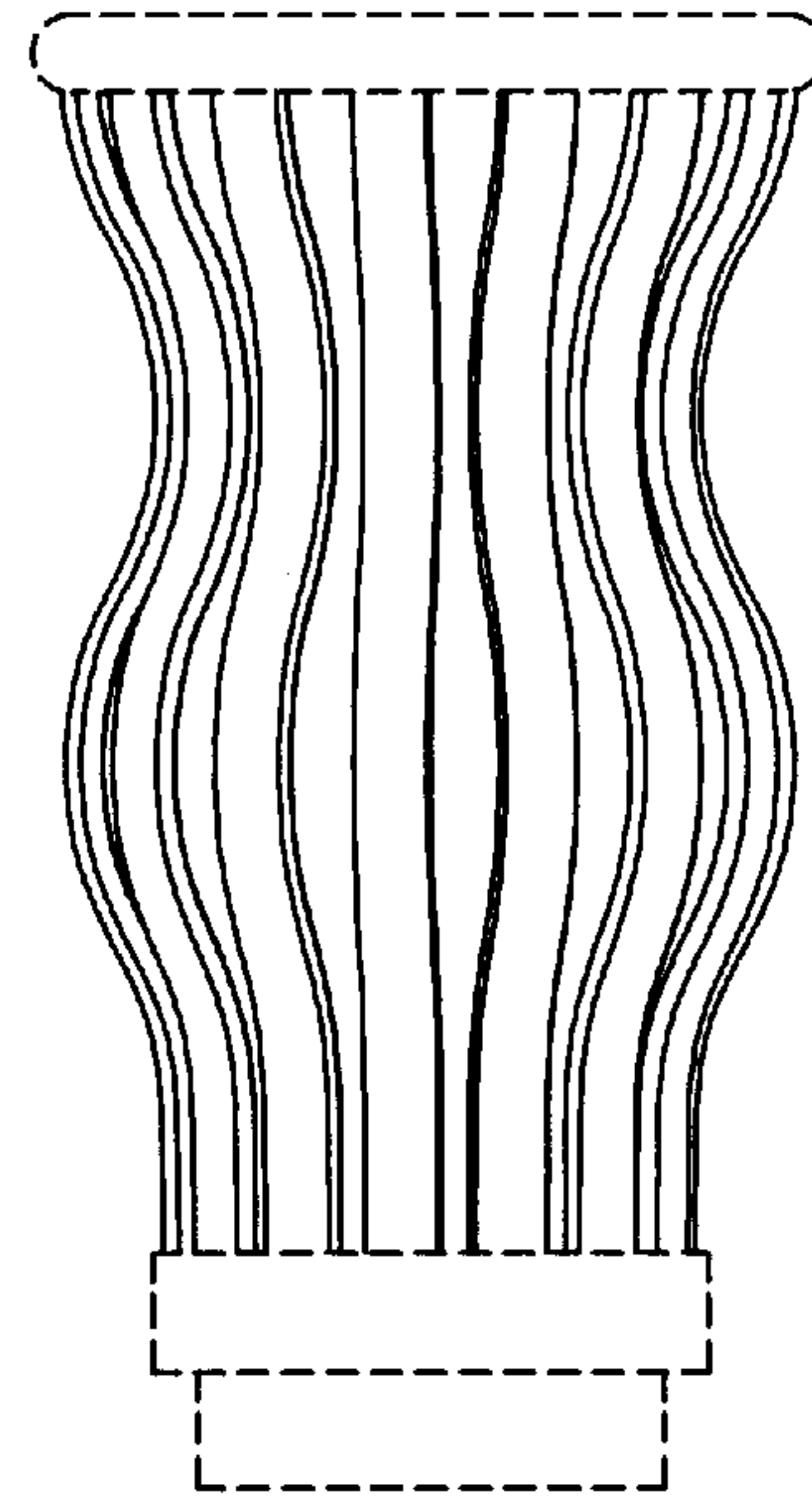

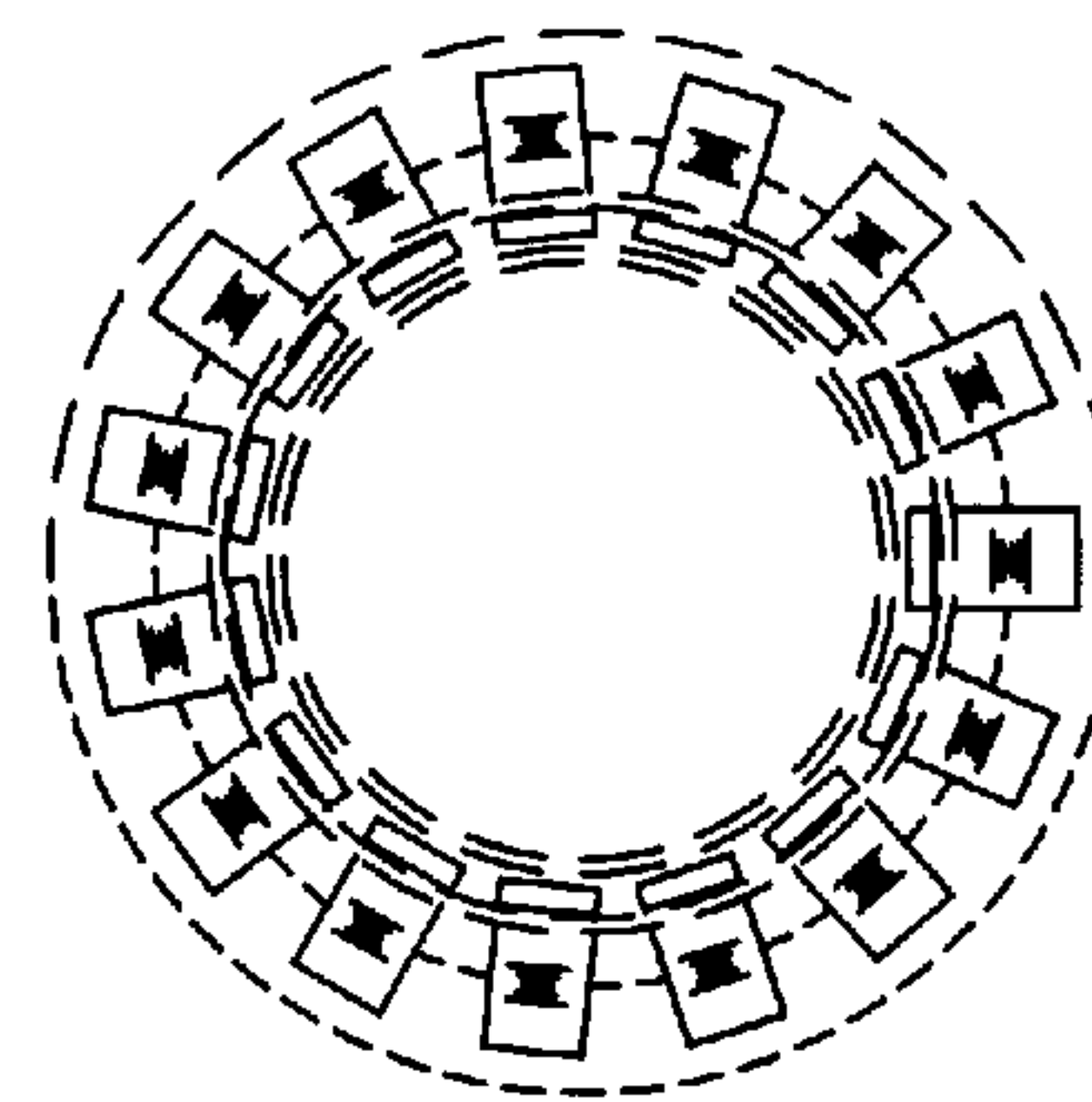
