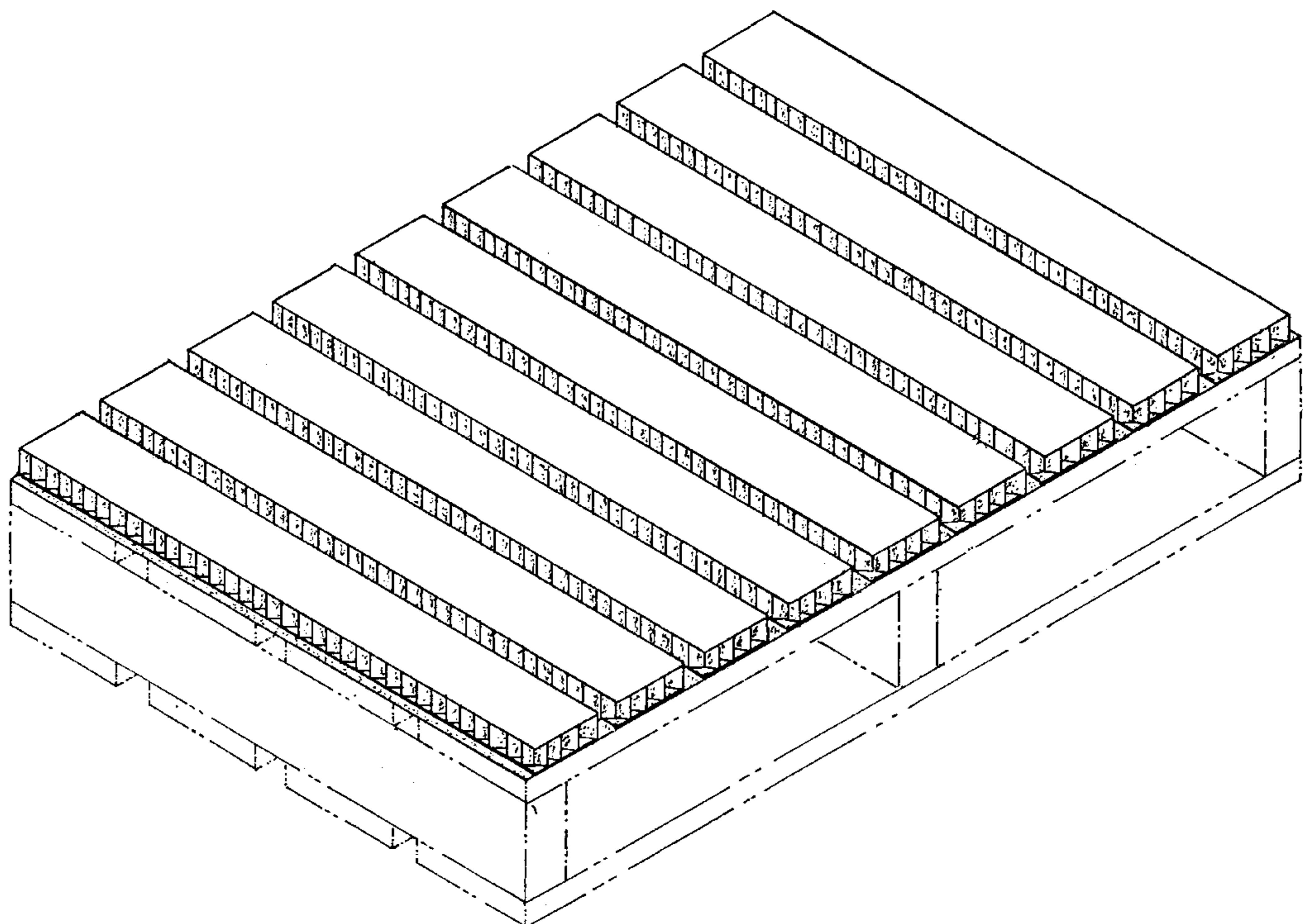
(57) **CLAIM**

The ornamental design for a paperboard pallet spacer, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the paperboard pallet spacer of this invention, shown applied upon a pallet, said pallet being disclosed in phantom line;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is an end view thereof, the opposite end view being a mirror image thereof;
 FIG. 4 is a front edge view thereof, the opposite edge view being a mirror image thereof; and,
 FIG. 5 is a bottom plan view of the pallet spacer.
 The broken line showing of a pallet in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

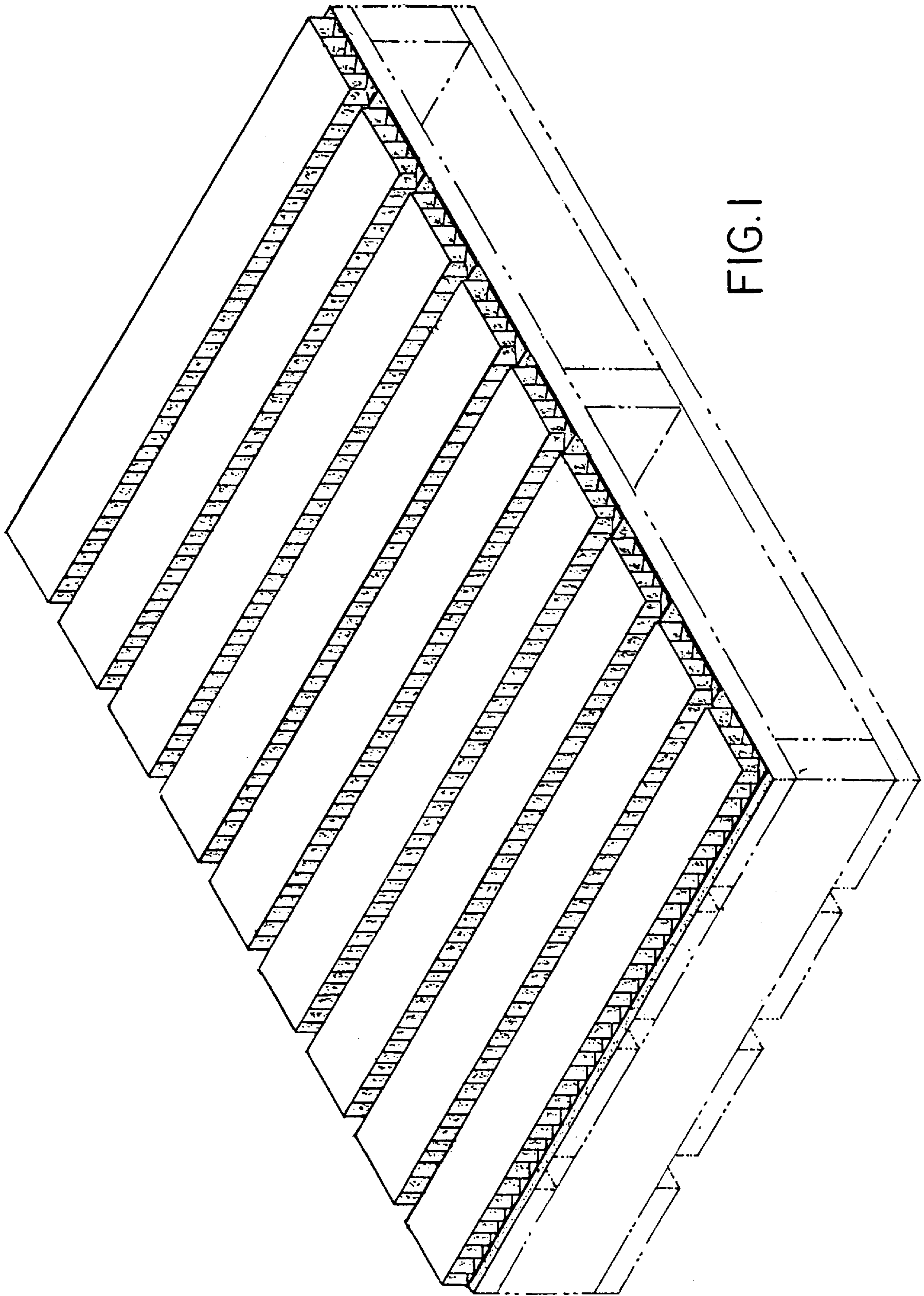

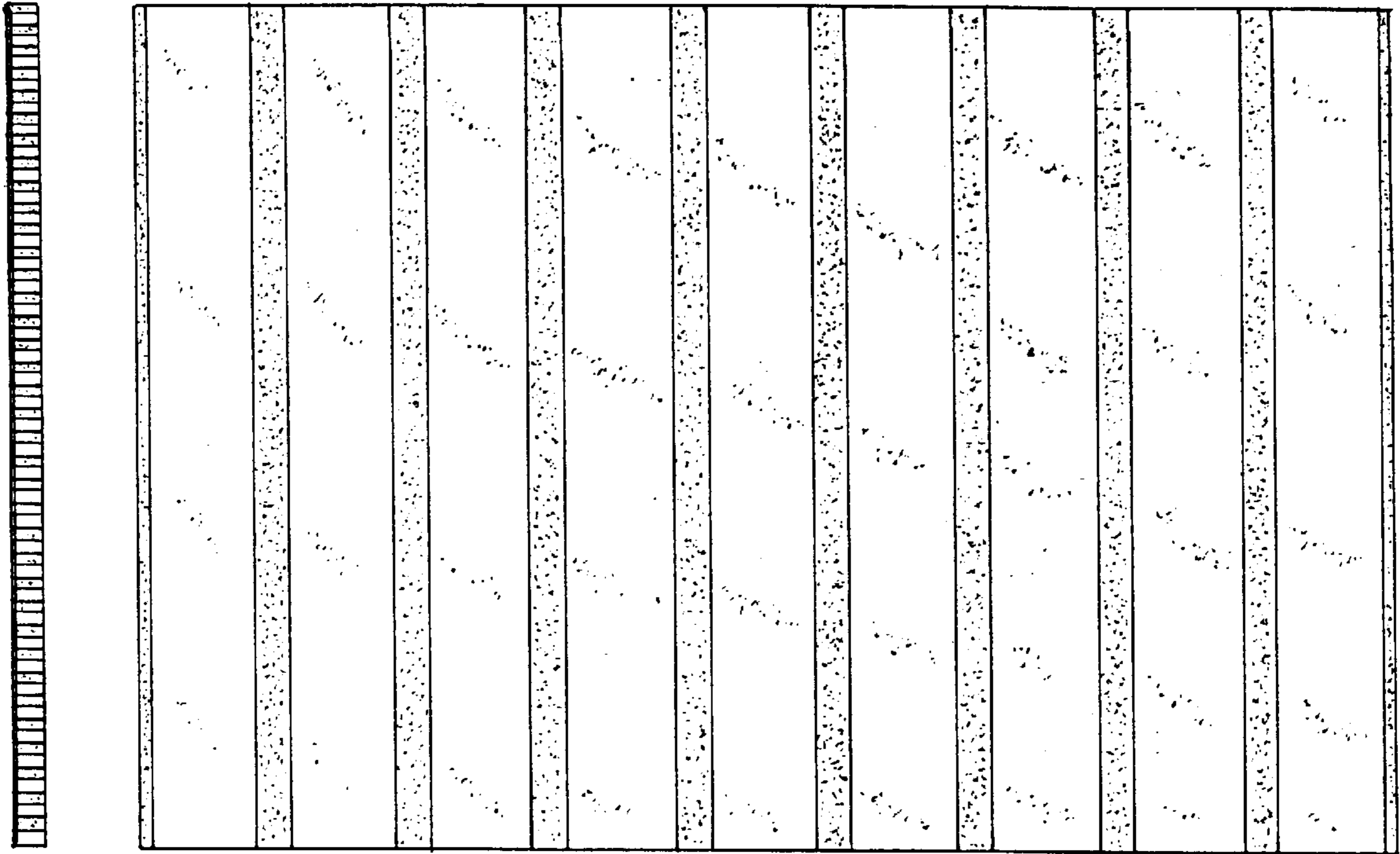

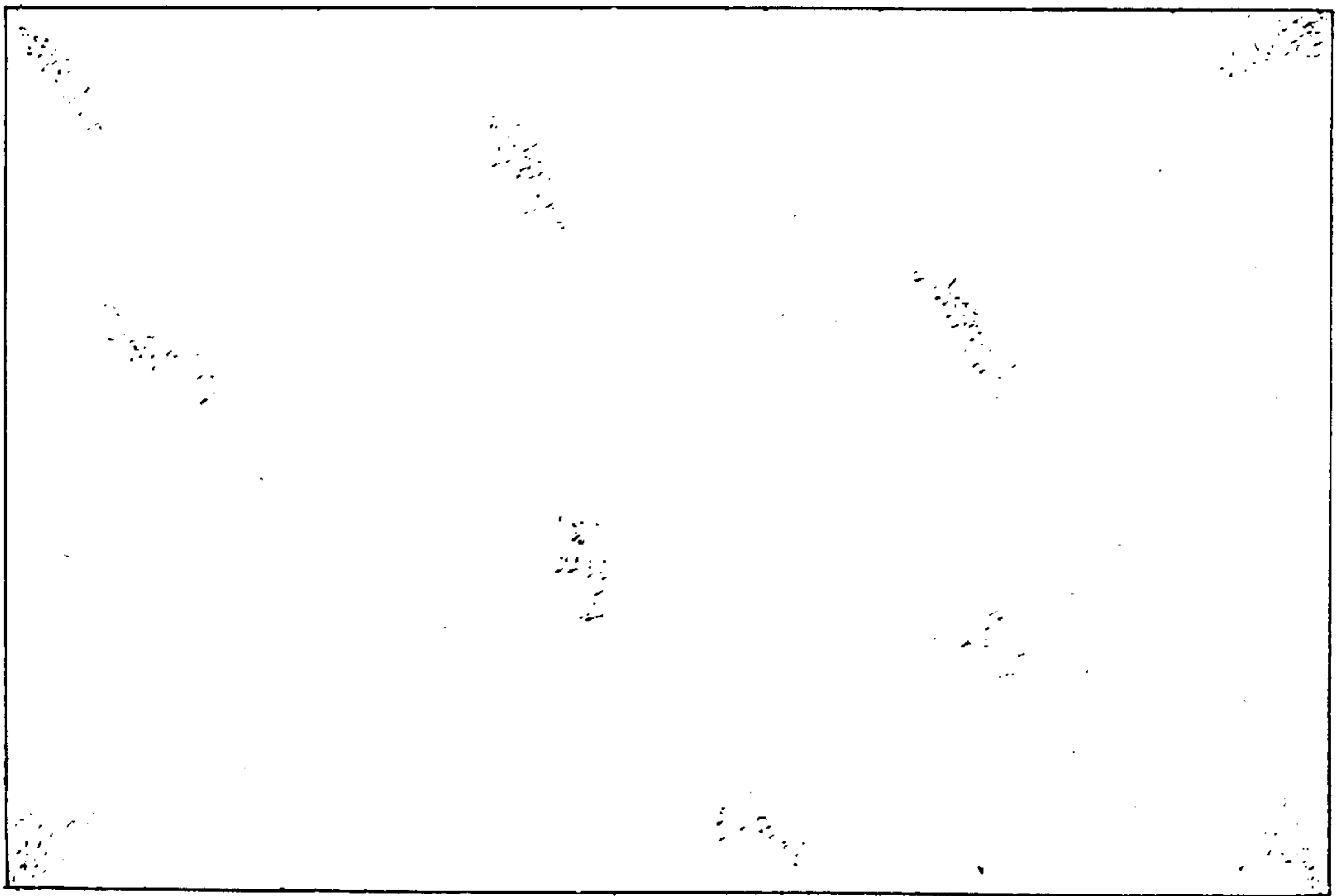
