(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is as a protective container for a wide variety of products.

FIG. 1 is a left, top, front perspective view of a container employing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a rear view thereof;

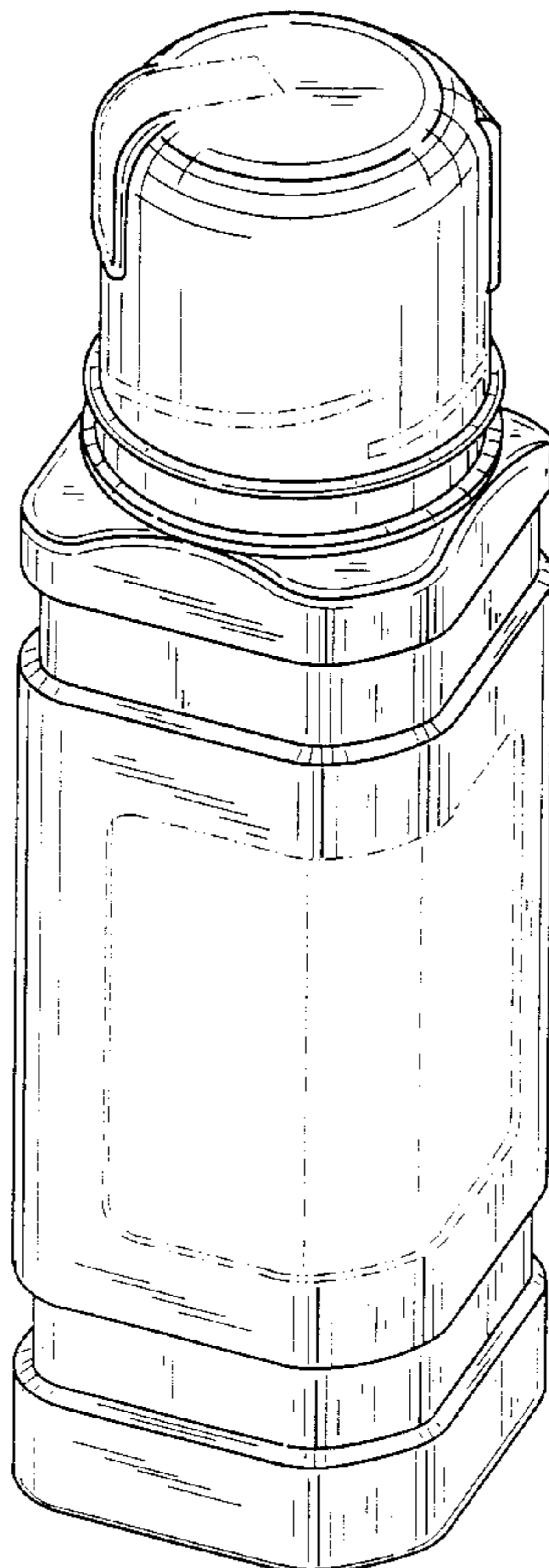
FIG. 5 is a left side elevational view thereof;

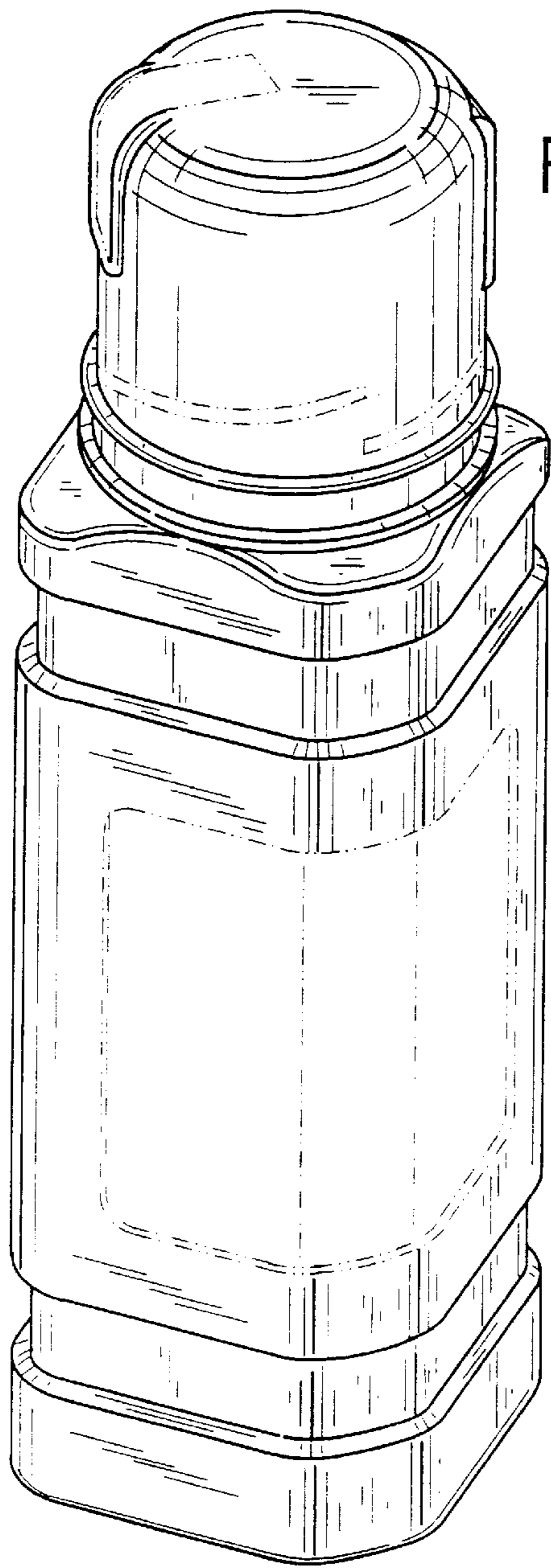

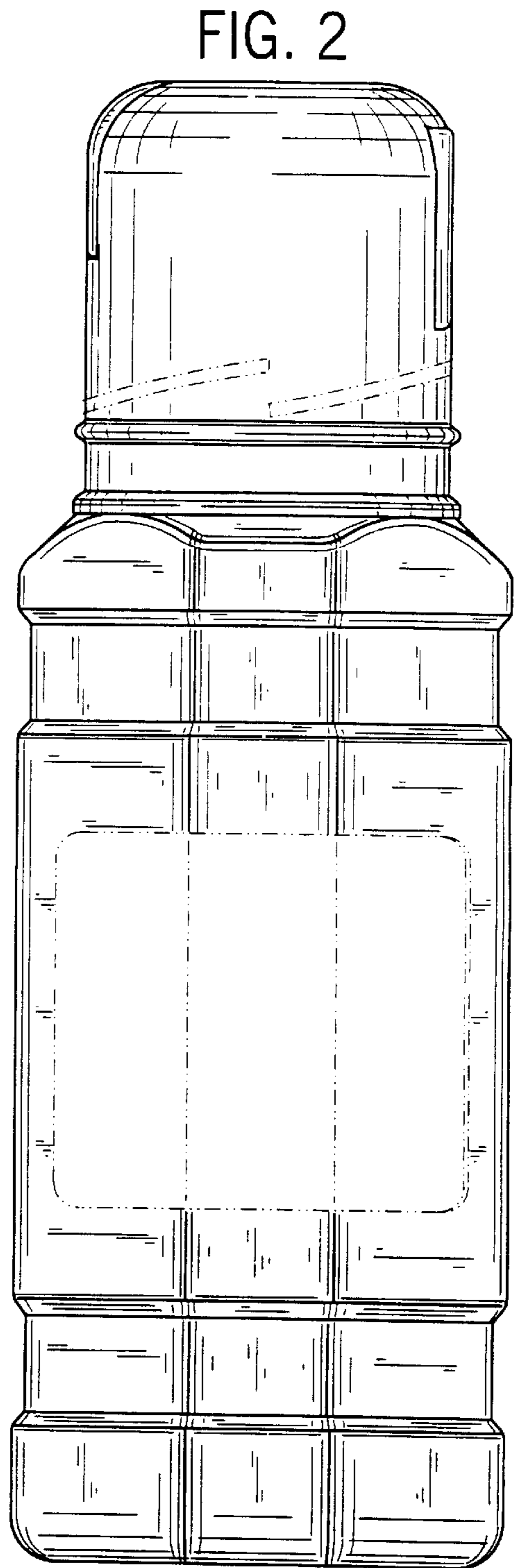

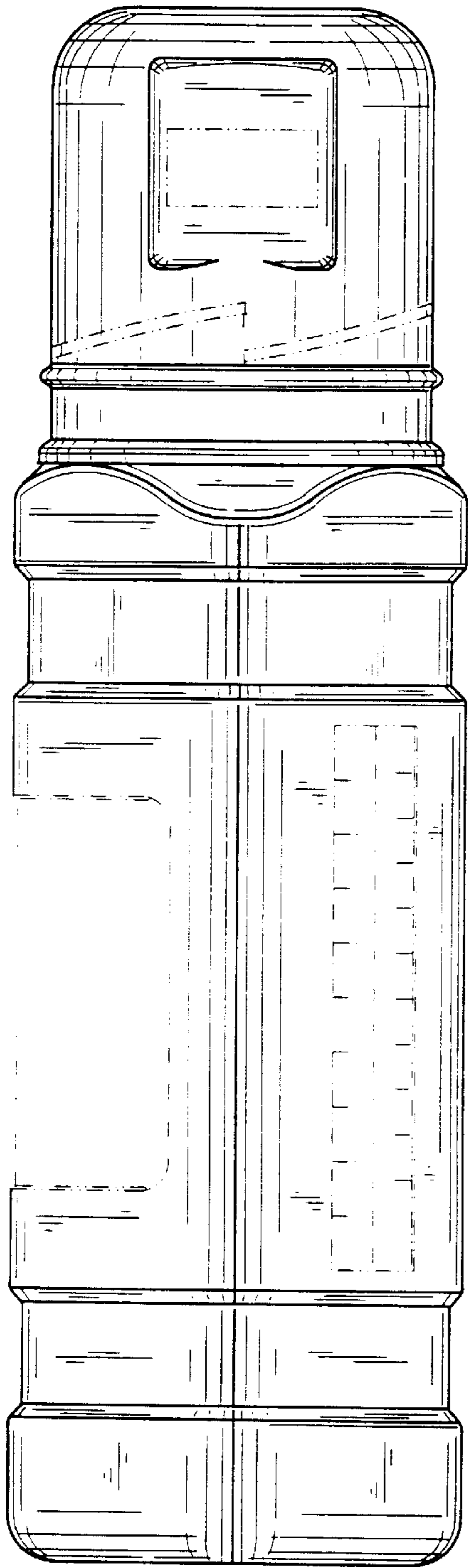

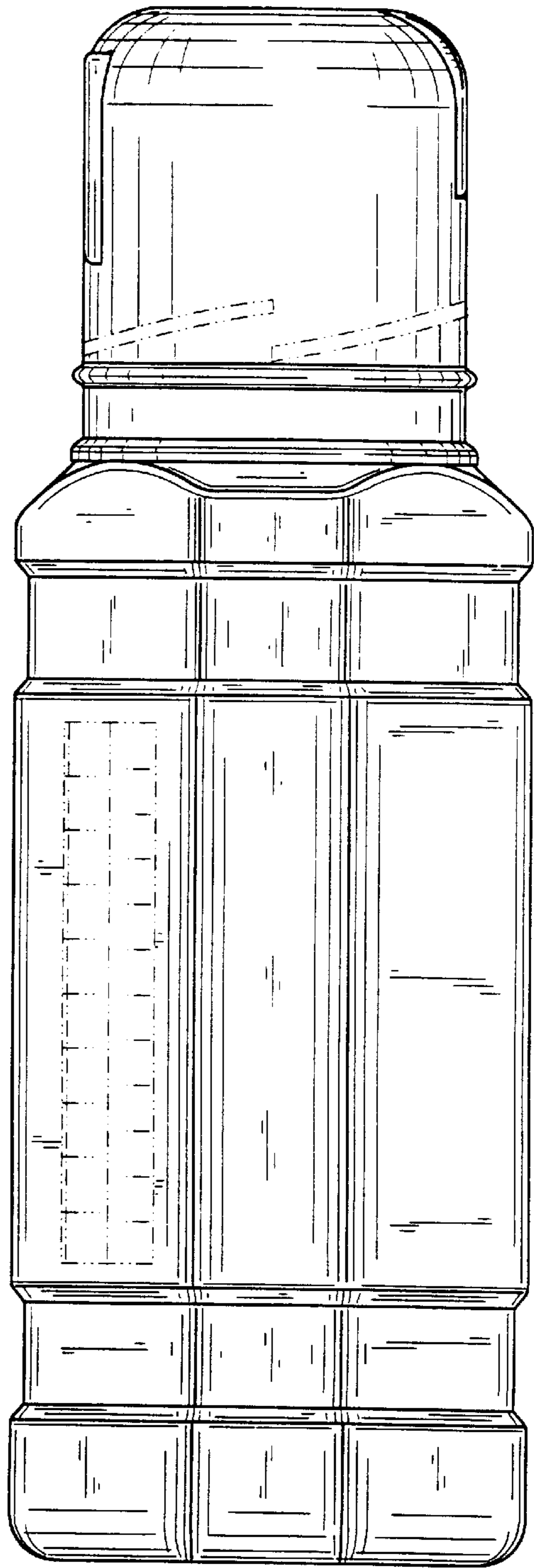

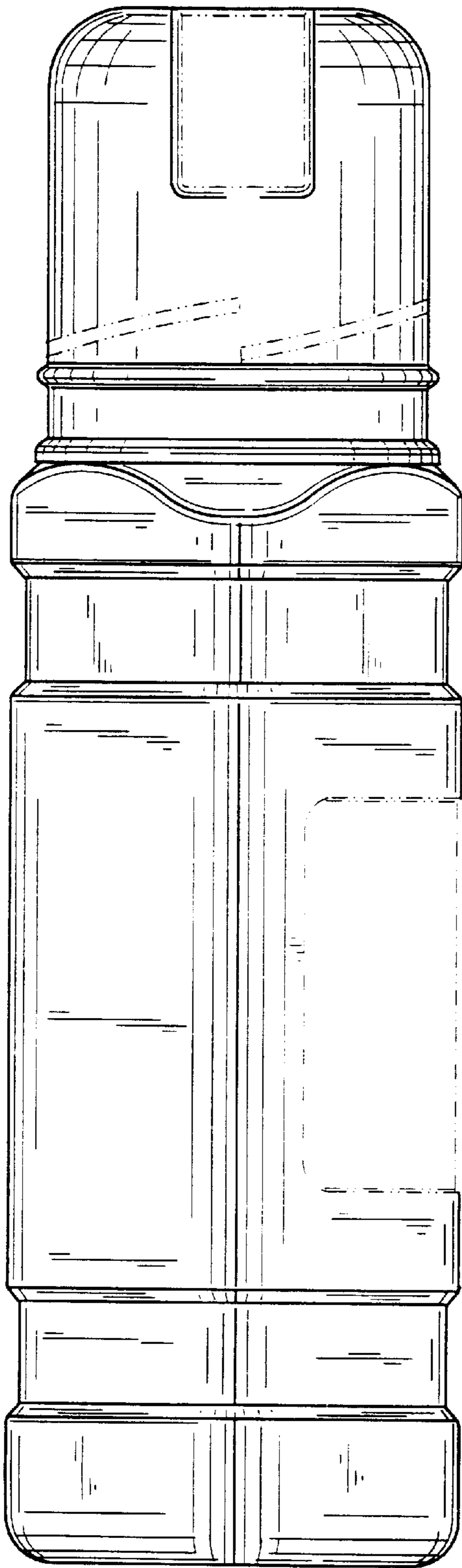

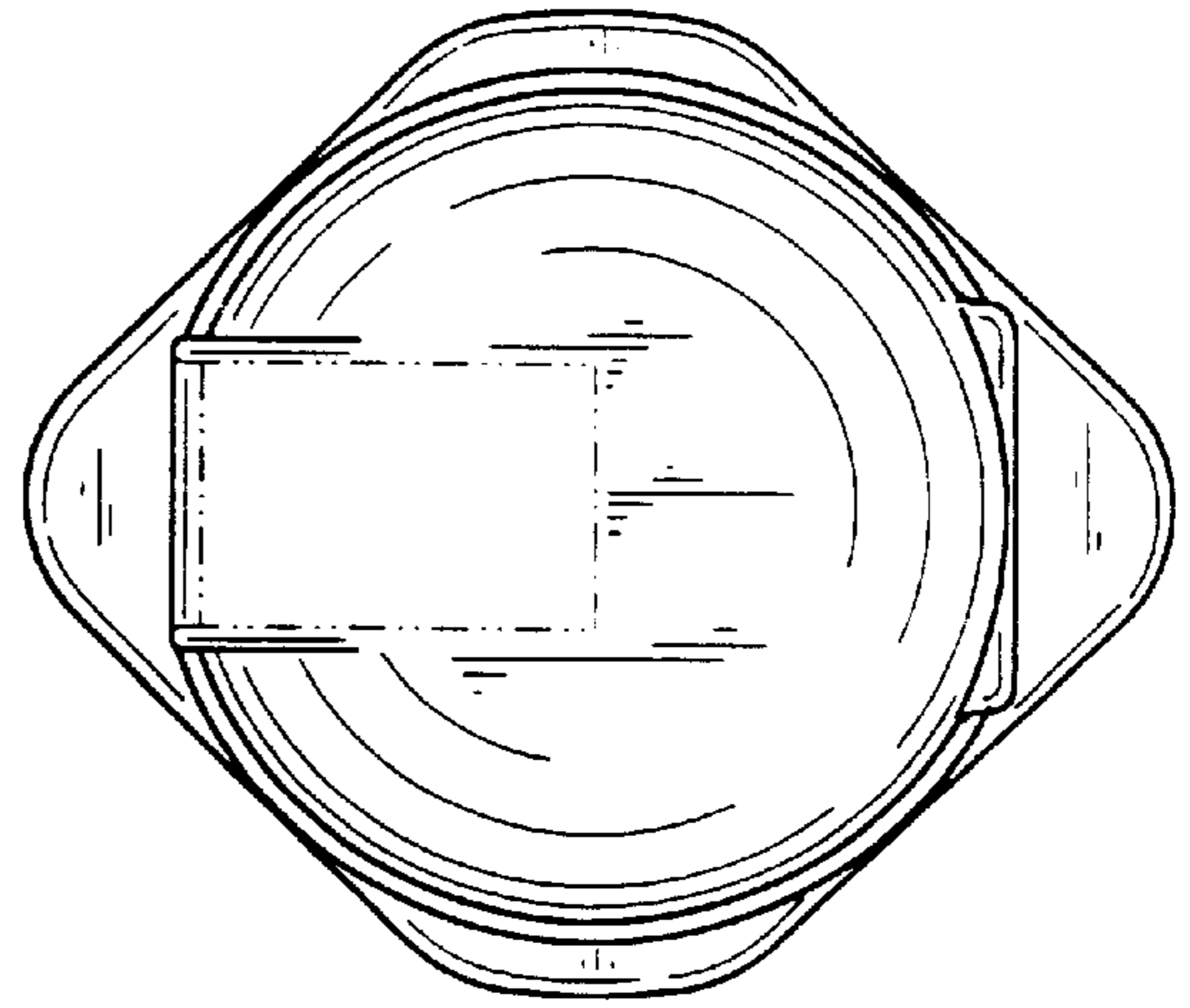
