The ornamental design for a color comparison and selection tool, as shown and described.

**DESCRIPTION**

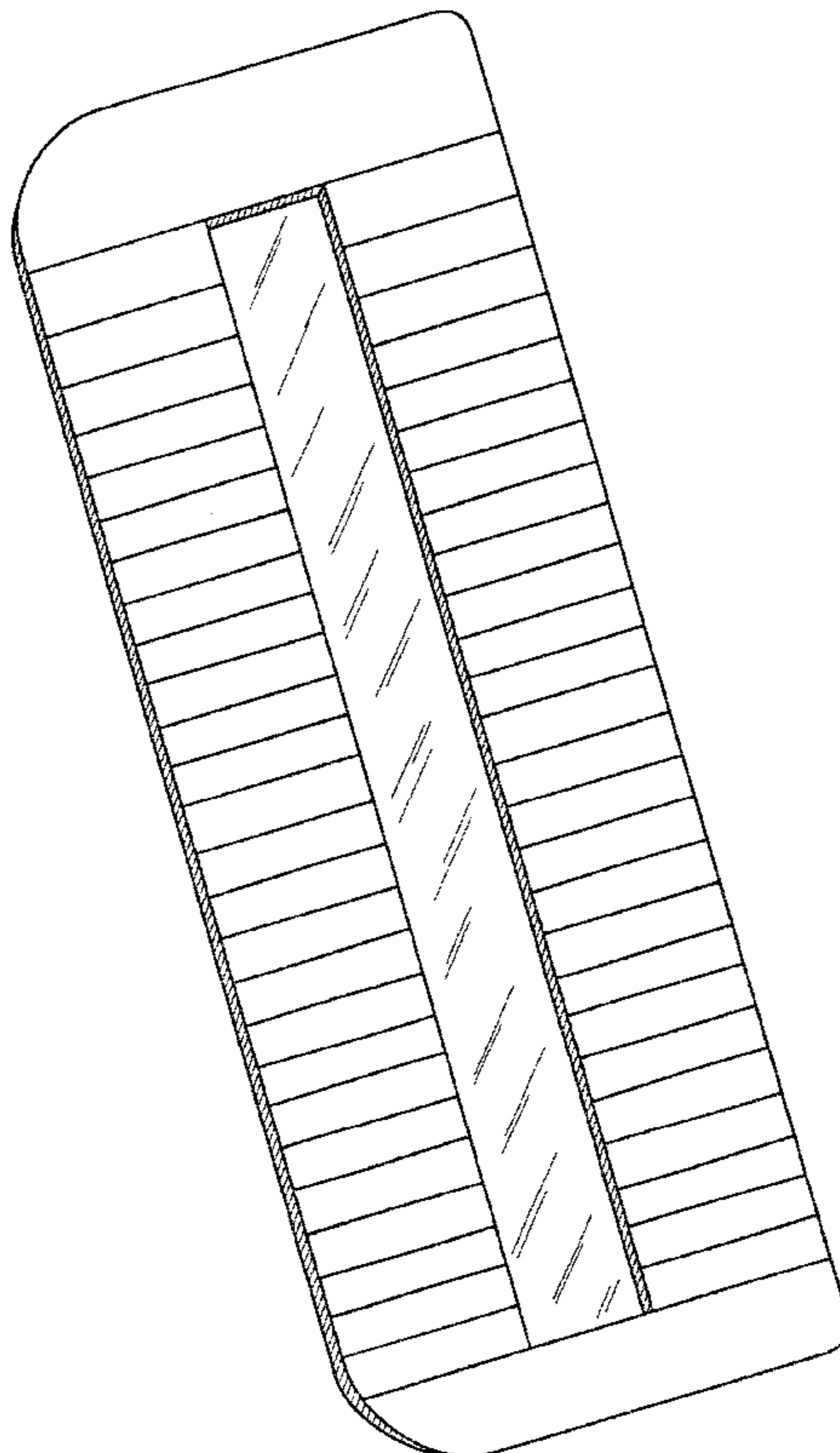
FIG. 1 is a front perspective view showing the color comparison and selection tool;  
 FIG. 2 is a front view according to FIG. 1;  
 FIG. 3 is a back view according to FIG. 1;  
 FIG. 4 is a perspective view according to FIG. 1;  
 FIG. 5 is a back view of a first variant of the color comparison and selection tool according to FIG. 1, which is void of ornamentation;  
 FIG. 6 is a front view of a second variant of the color comparison and selection tool according to FIG. 1;  
 FIG. 7 is a perspective view of a third variant of the color comparison and selection tool;  
 FIG. 8 is a front view of the third variant according to FIG. 6; and,  
 FIG. 9 is a back view of the third variant according to FIG. 6.

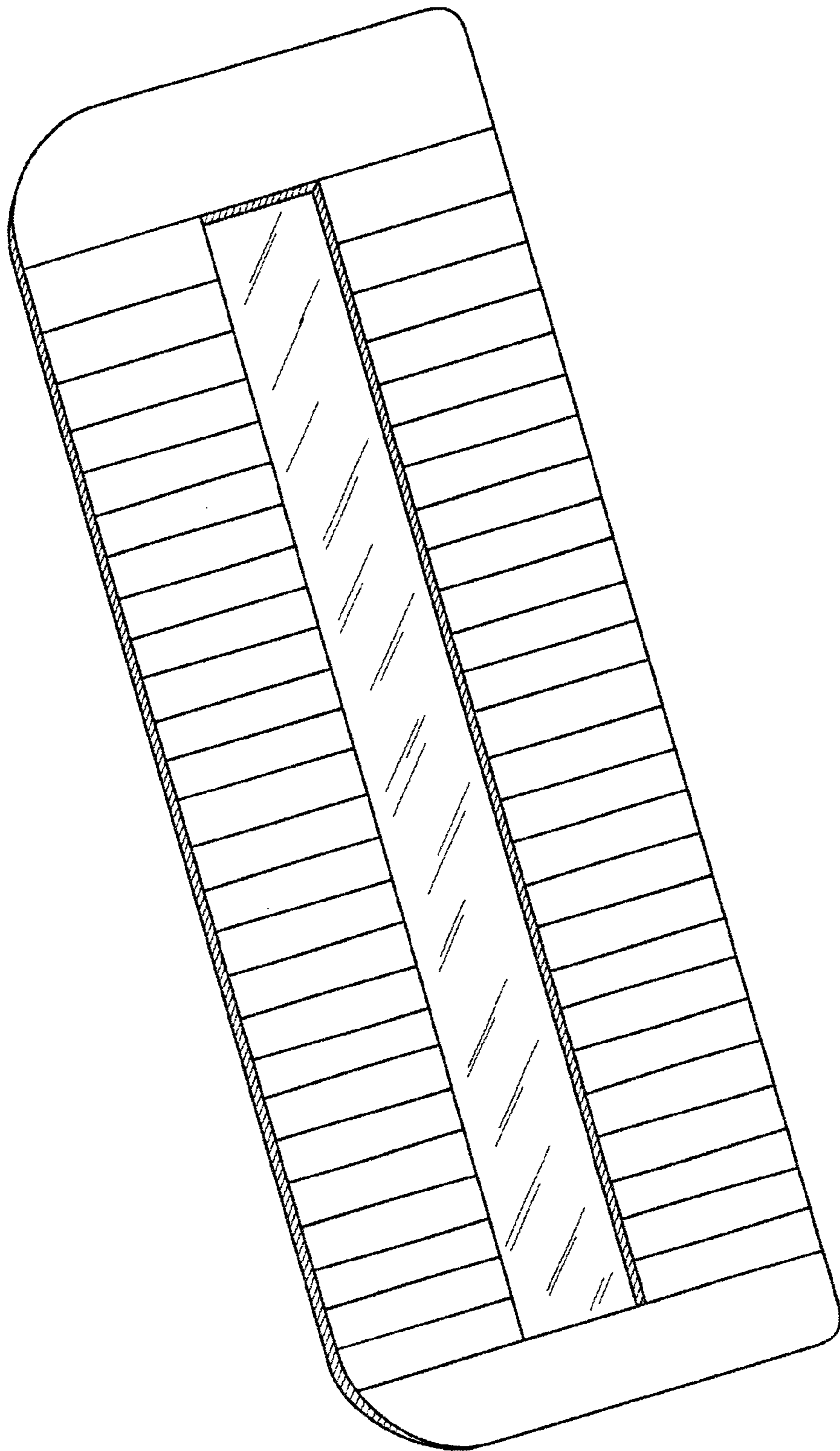
The edges of the color comparison and selection tool are flat and unornamented and are therefore not shown.

The surface of the color comparison and selection tool is characterized by 2 columns of a plurality of bands of varying colors.

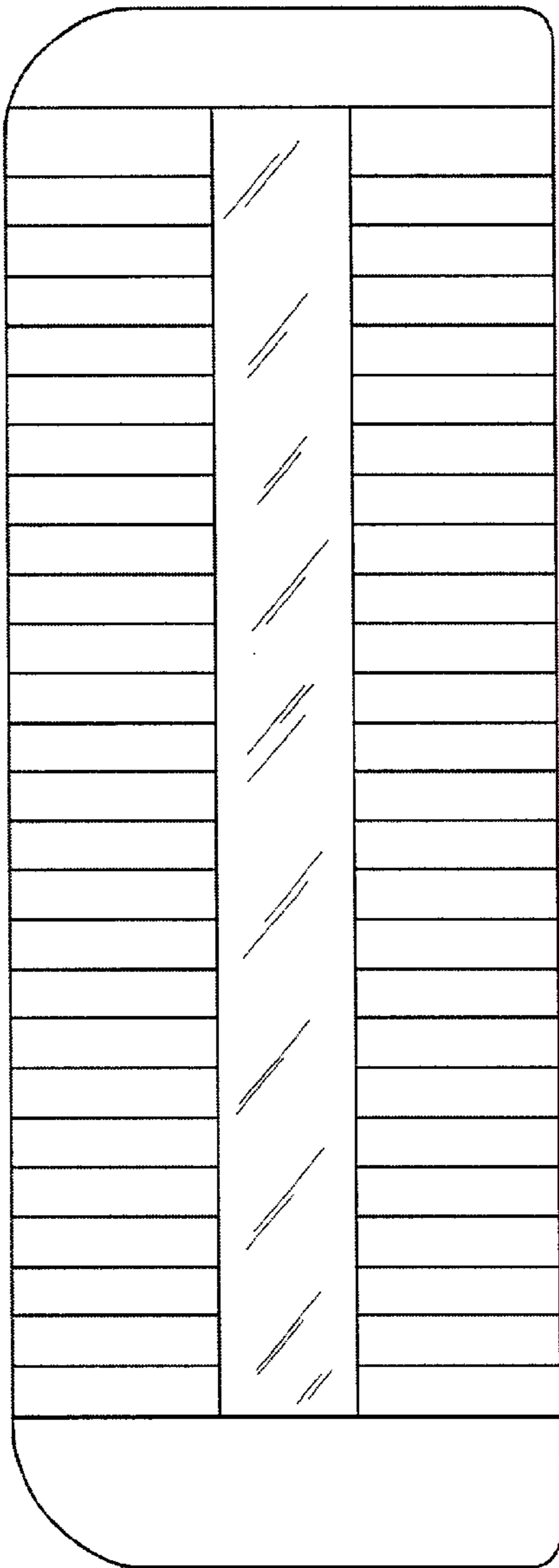
The indicia and other features illustrated in broken lines on FIG. 4 have been shown for illustrative purposes only and form no part of the claimed design.

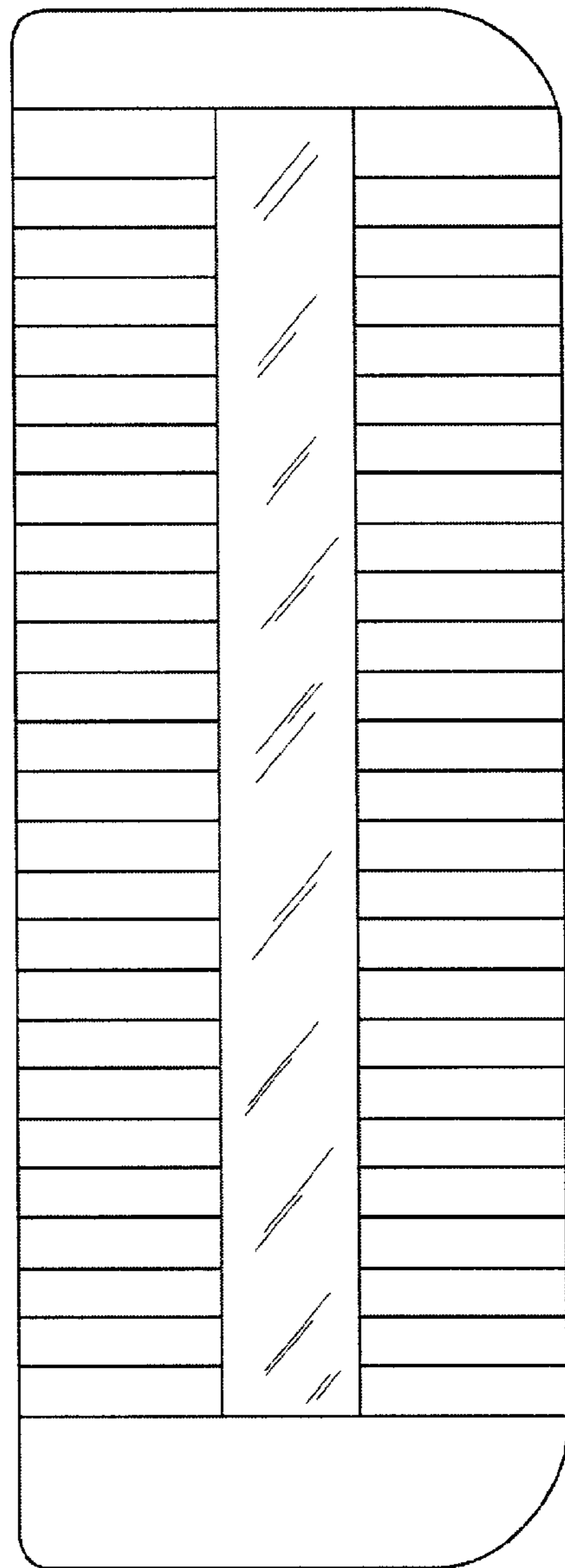


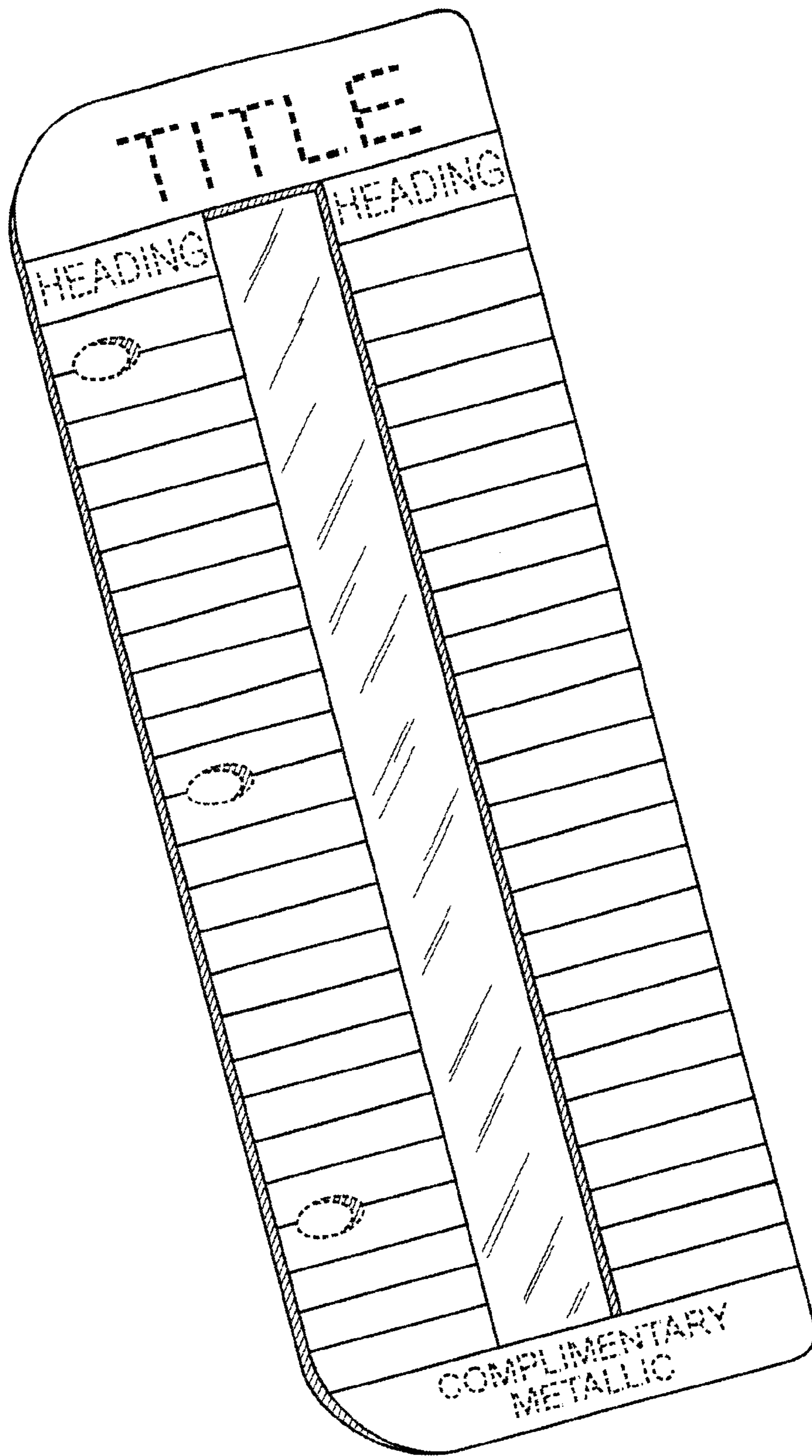

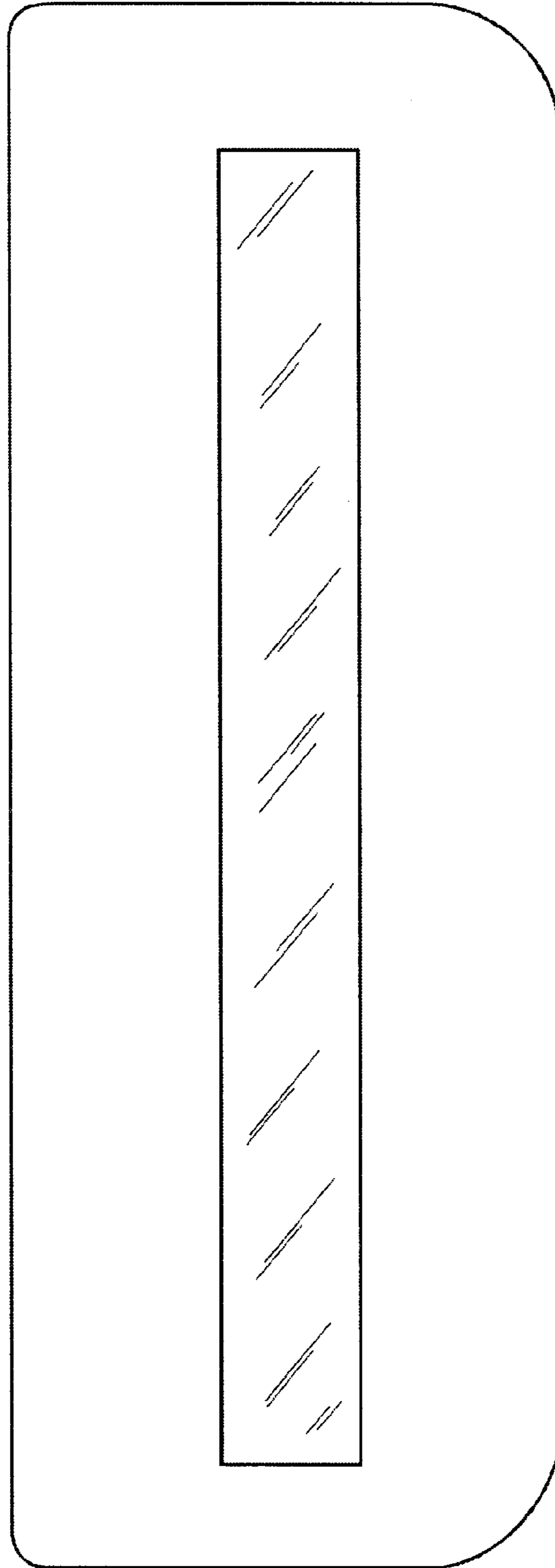

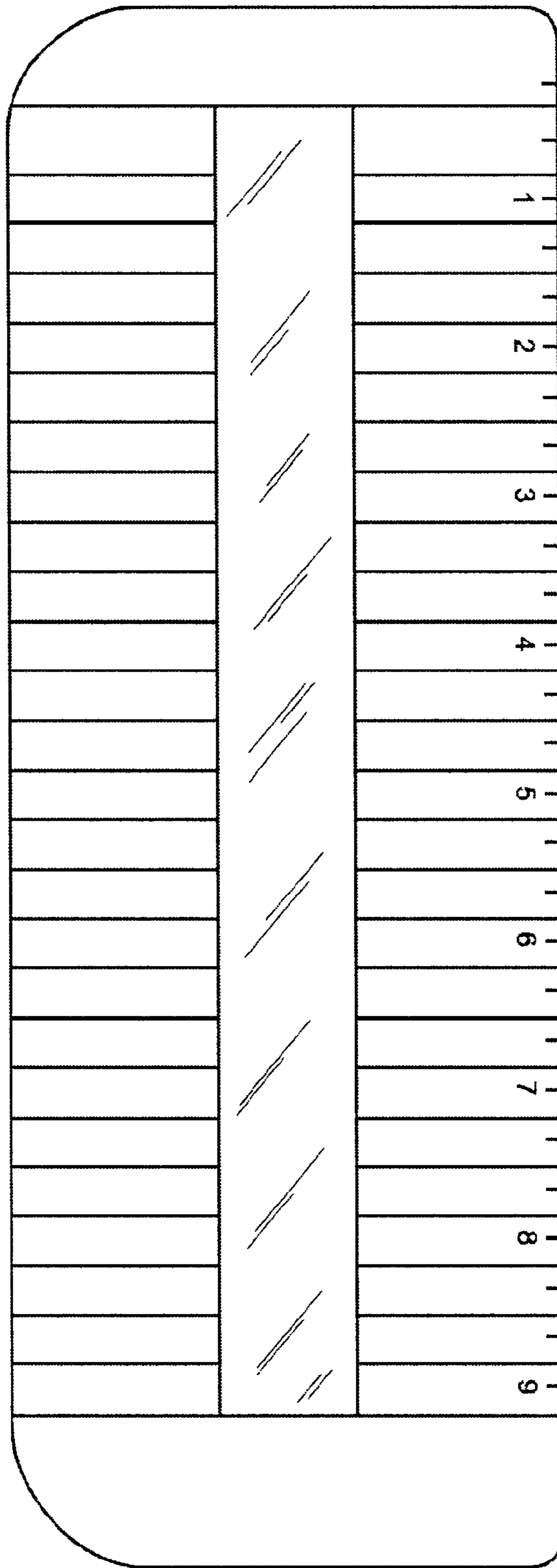




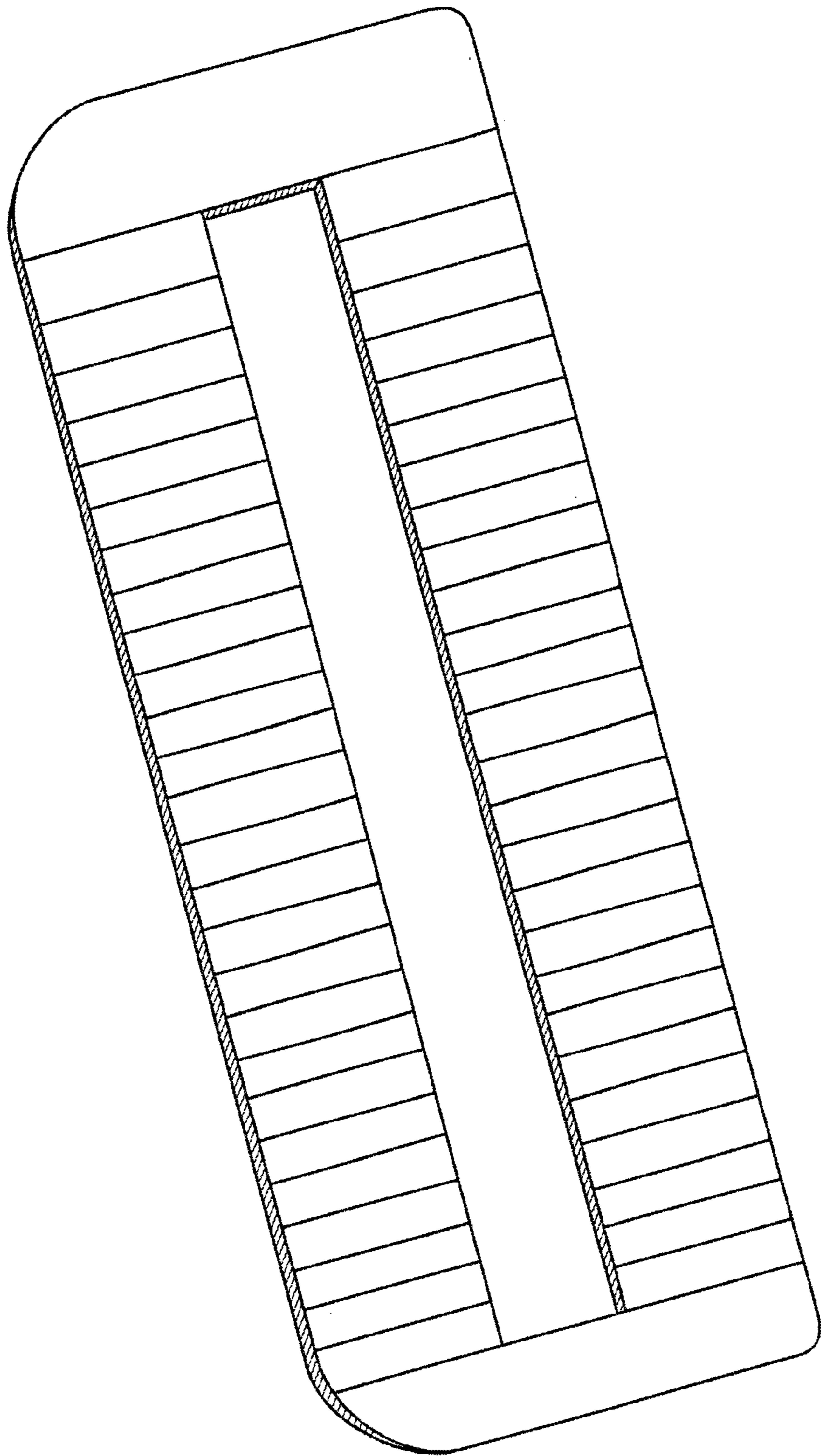

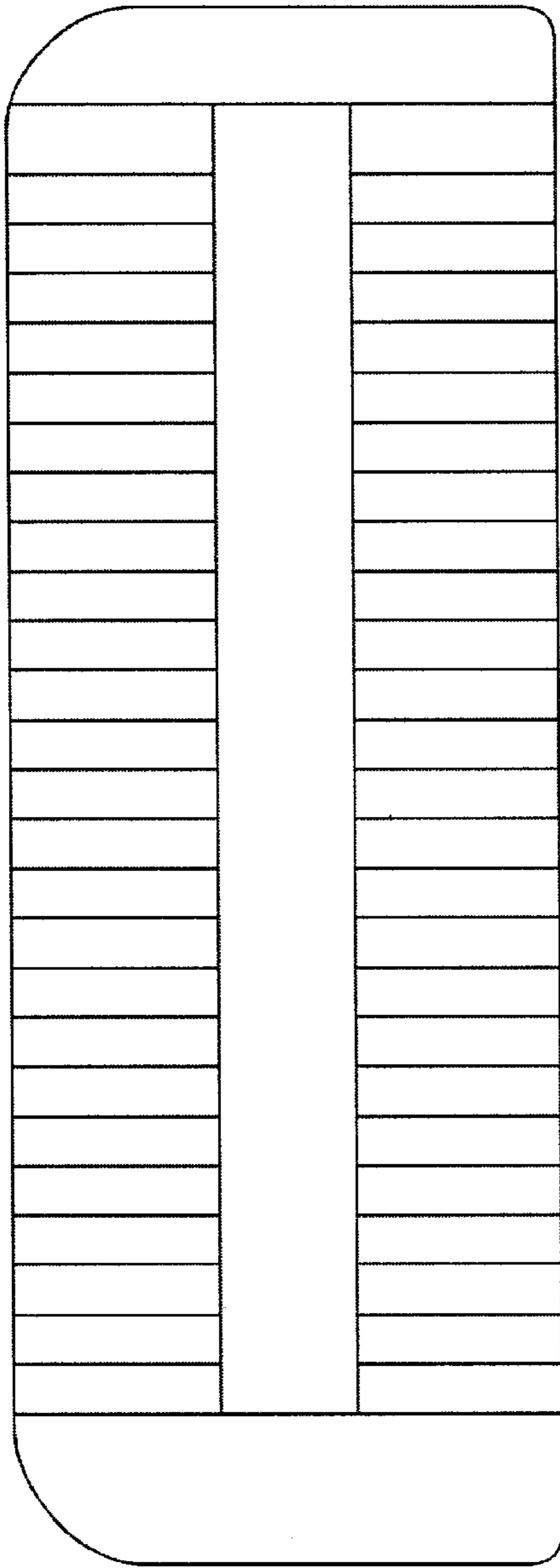
