(57) **CLAIM**

The ornamental design for a double shepherd hook, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of my new double shepherd hook;
FIG. 2 is a left side end view of the design of FIG. 1;
FIG. 3 is a right side end view of the design of FIG. 1;
FIG. 4 is a top plan view of the design of FIG. 1; and,
FIG. 5 is a bottom plan view of the design of FIG. 1.
The phantom bracket portion of FIG. 1 does not form a part of this invention. The rear elevation view is a mirror image of FIG. 1.

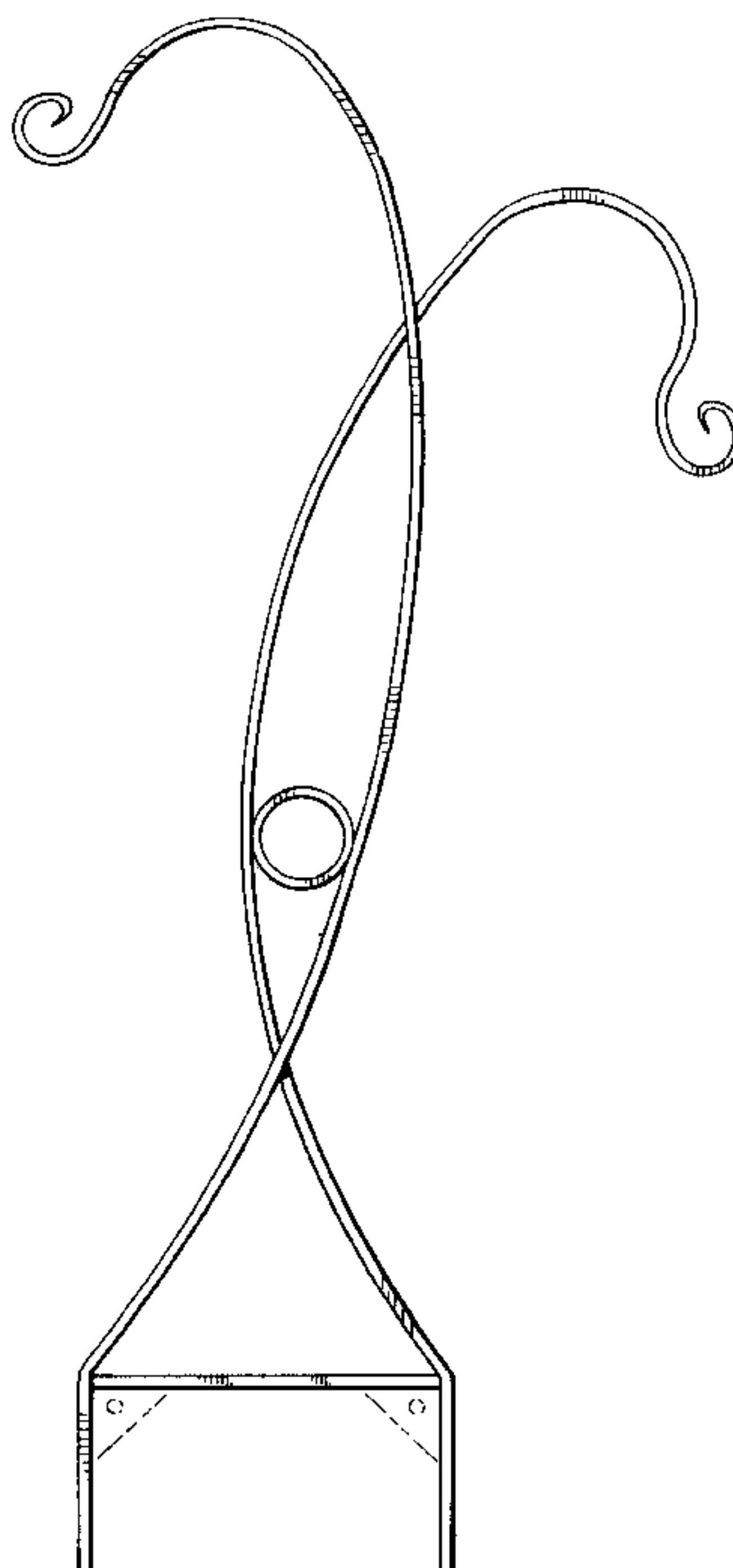

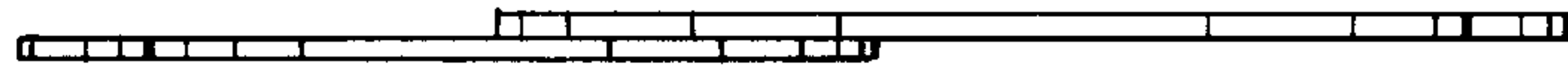

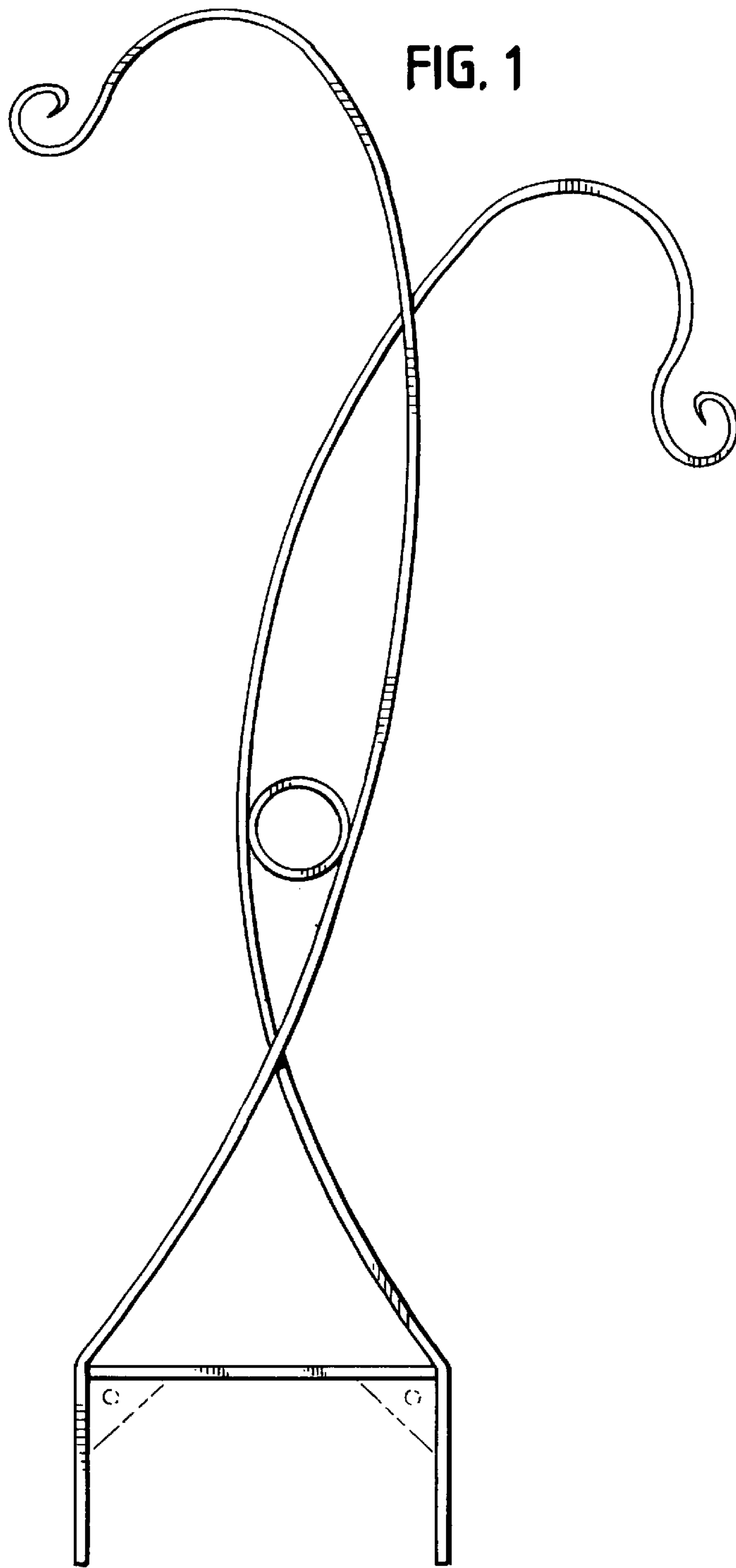
