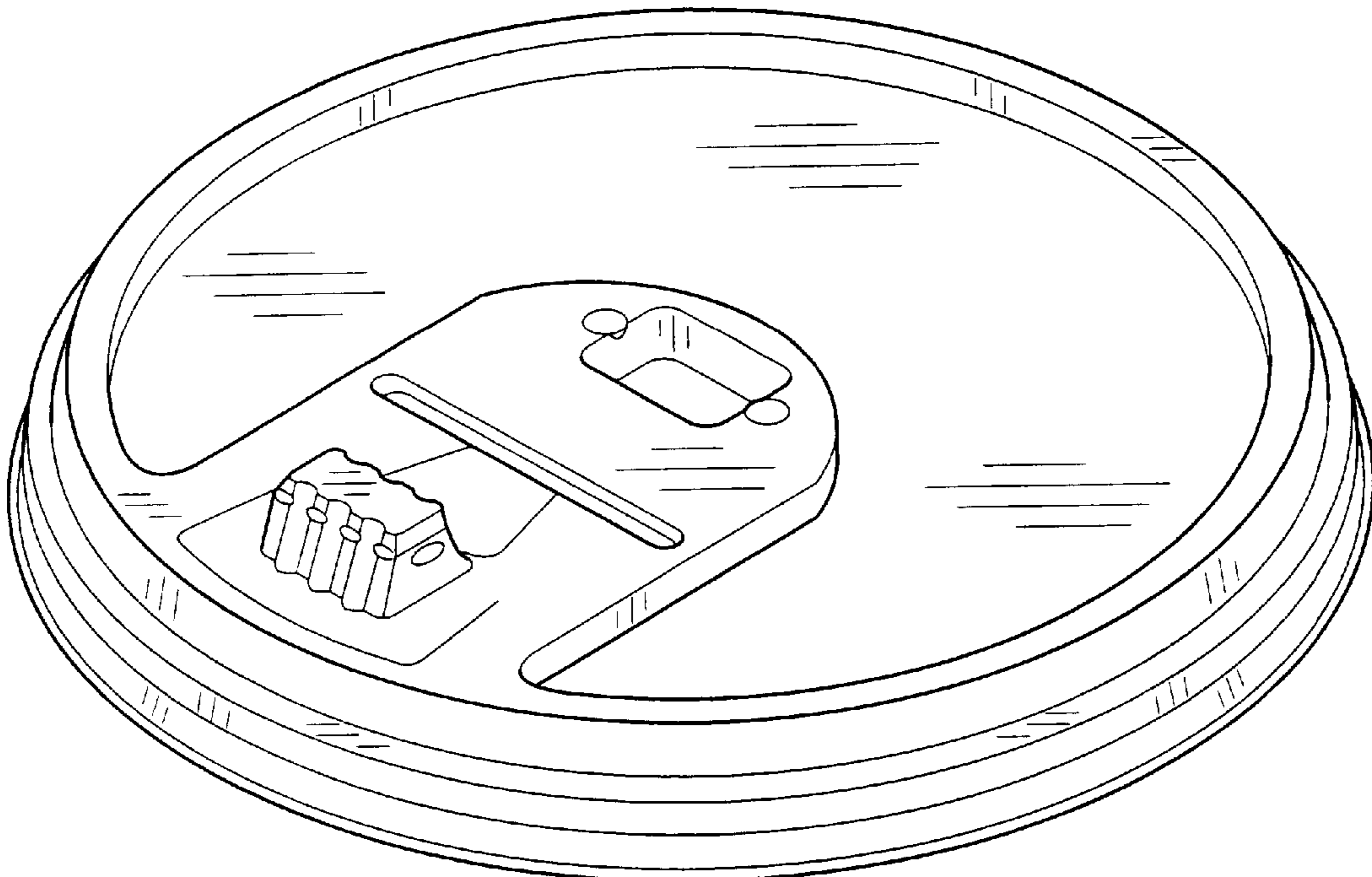
(57) **CLAIM**

The ornamental design for a disposable cup lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of disposable cup lid in keeping with the present invention;
 FIG. 2 is a reduced front view of the disposable cup lid of FIG. 1;
 FIG. 3 is a reduced back view of the disposable cup lid of FIG. 1;
 FIG. 4 is a reduced right side view (as seen in FIG. 1) of the disposable cup lid of FIG. 1;
 FIG. 5 is a reduced left side view (as seen in FIG. 1) of the disposable cup lid of FIG. 1;
 FIG. 6 is a reduced top view of the disposable cup lid of FIG. 1;
 FIG. 7 is a reduced bottom view of the disposable cup lid of FIG. 1;
 FIG. 8 is a perspective view of a second embodiment of disposable cup lid in keeping with the present invention;
 FIG. 9 is a reduced front view of the disposable cup lid of FIG. 8;
 FIG. 10 is a reduced back view of the disposable cup lid of FIG. 8;
 FIG. 11 is a reduced right side view (as seen in FIG. 8) of the disposable cup lid of FIG. 8;
 FIG. 12 is a reduced left side view (as seen in FIG. 8) of the disposable cup lid of FIG. 8;
 FIG. 13 is a reduced top view of the disposable cup lid of FIG. 8; and,
 FIG. 14 is a reduced bottom view of the disposable cup lid of FIG. 8.

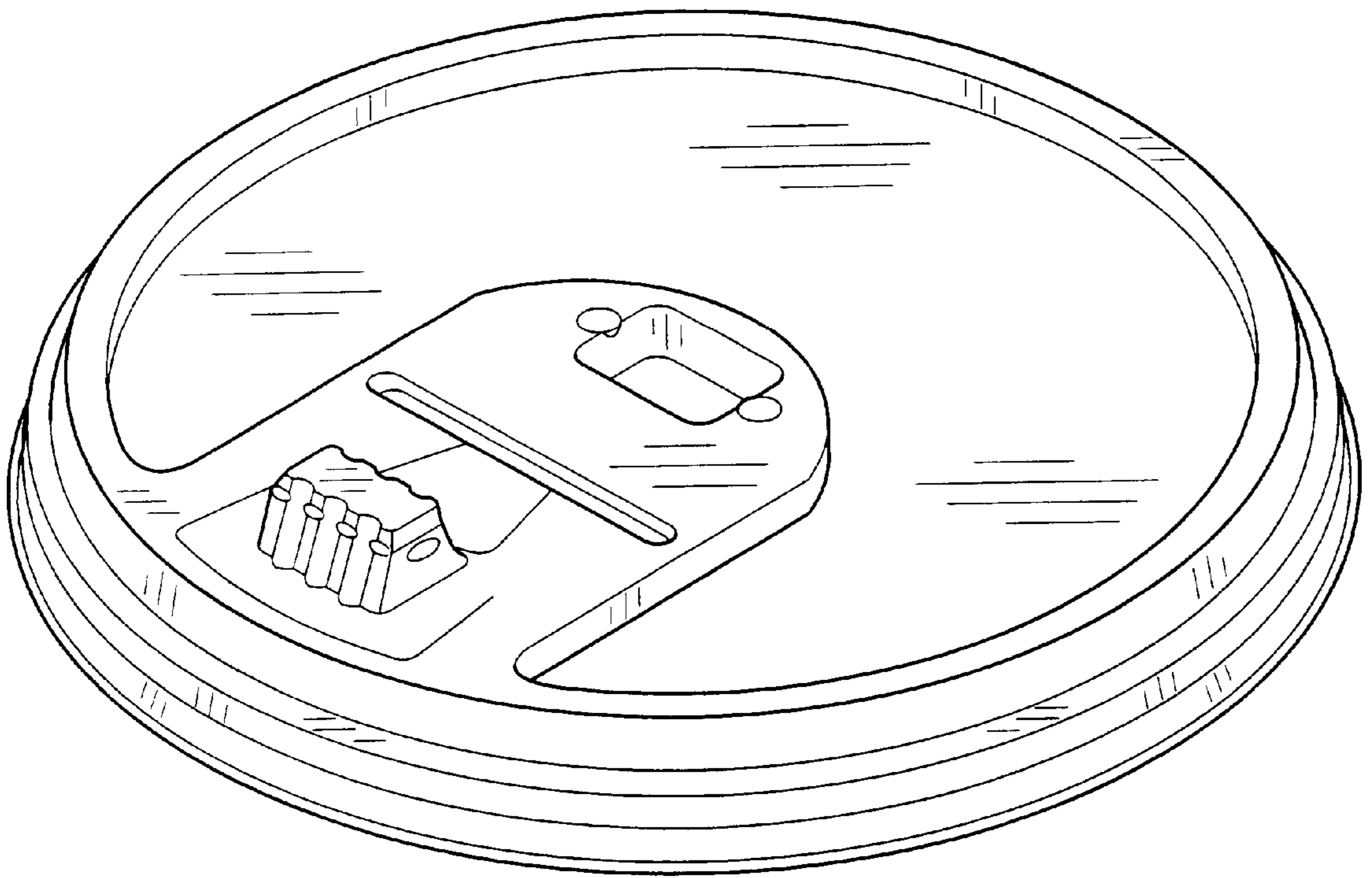

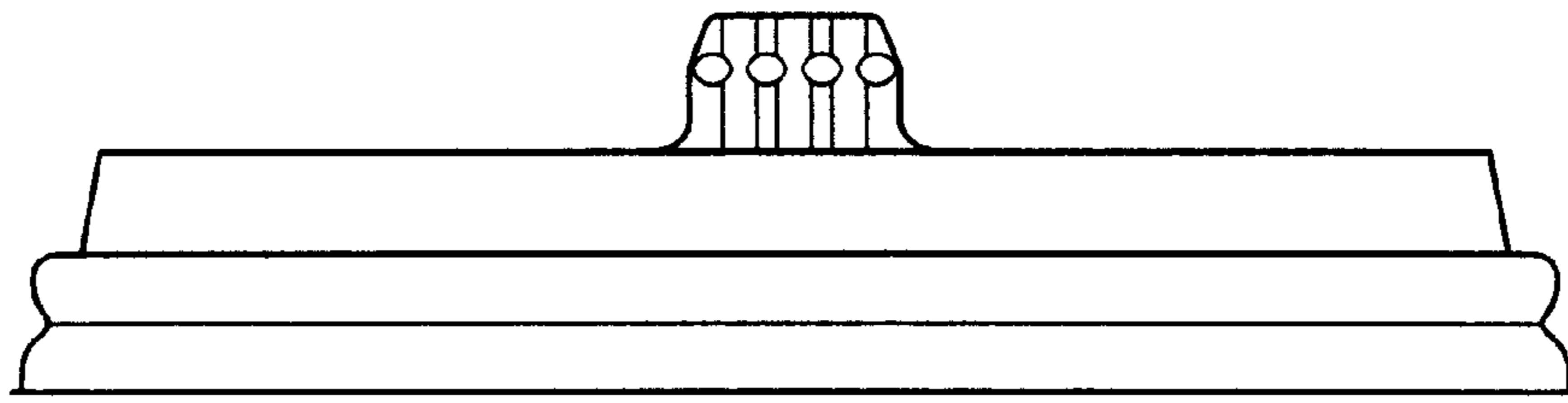

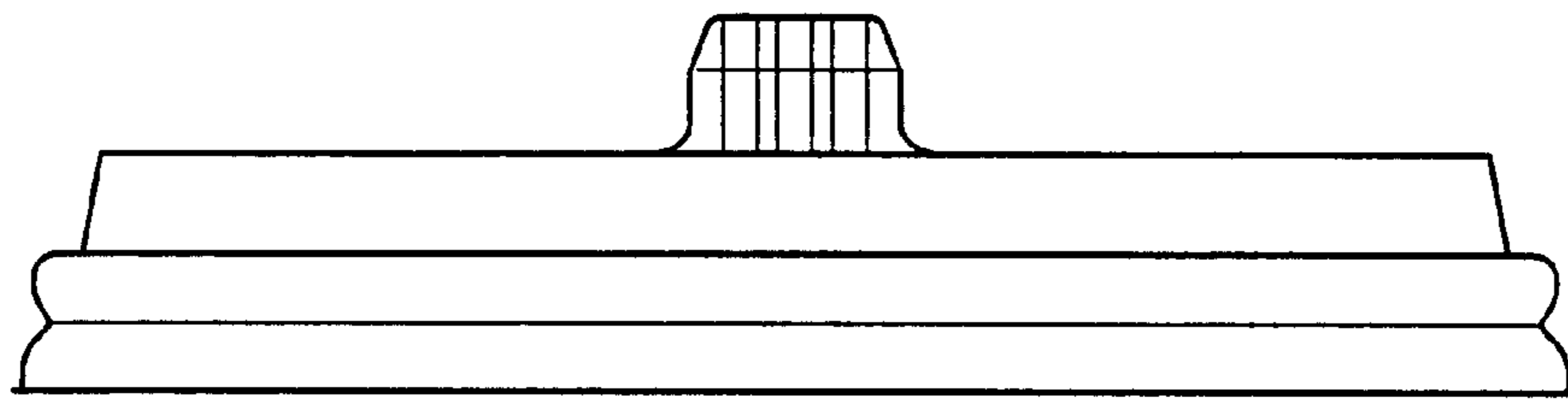

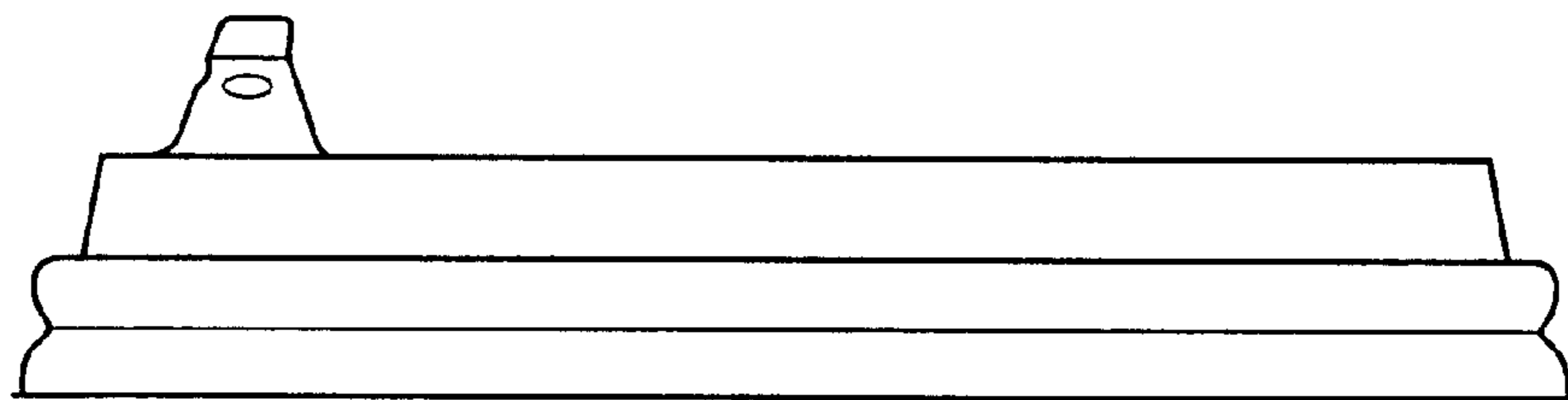

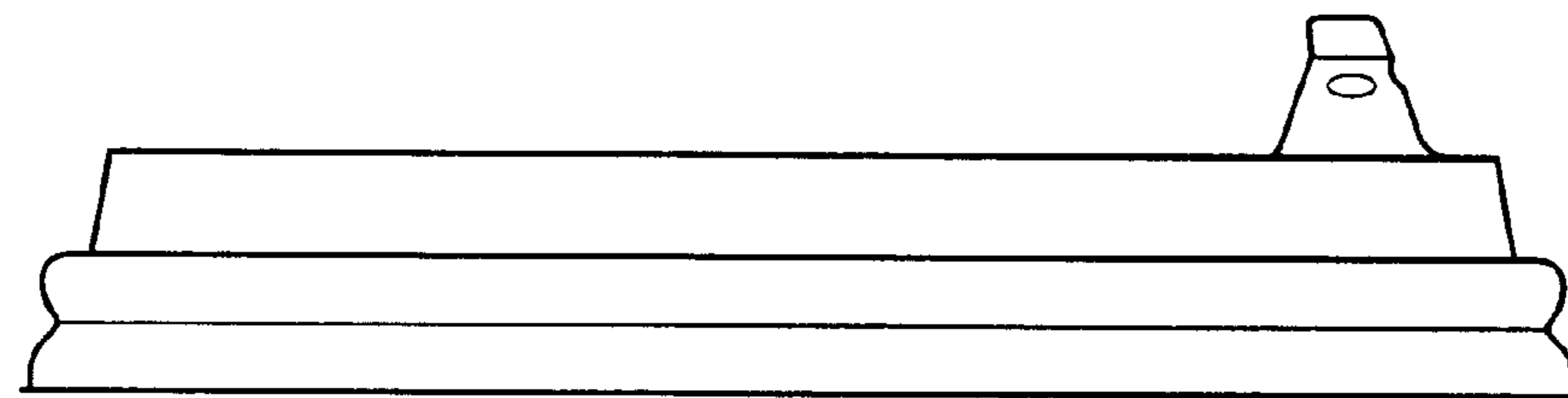

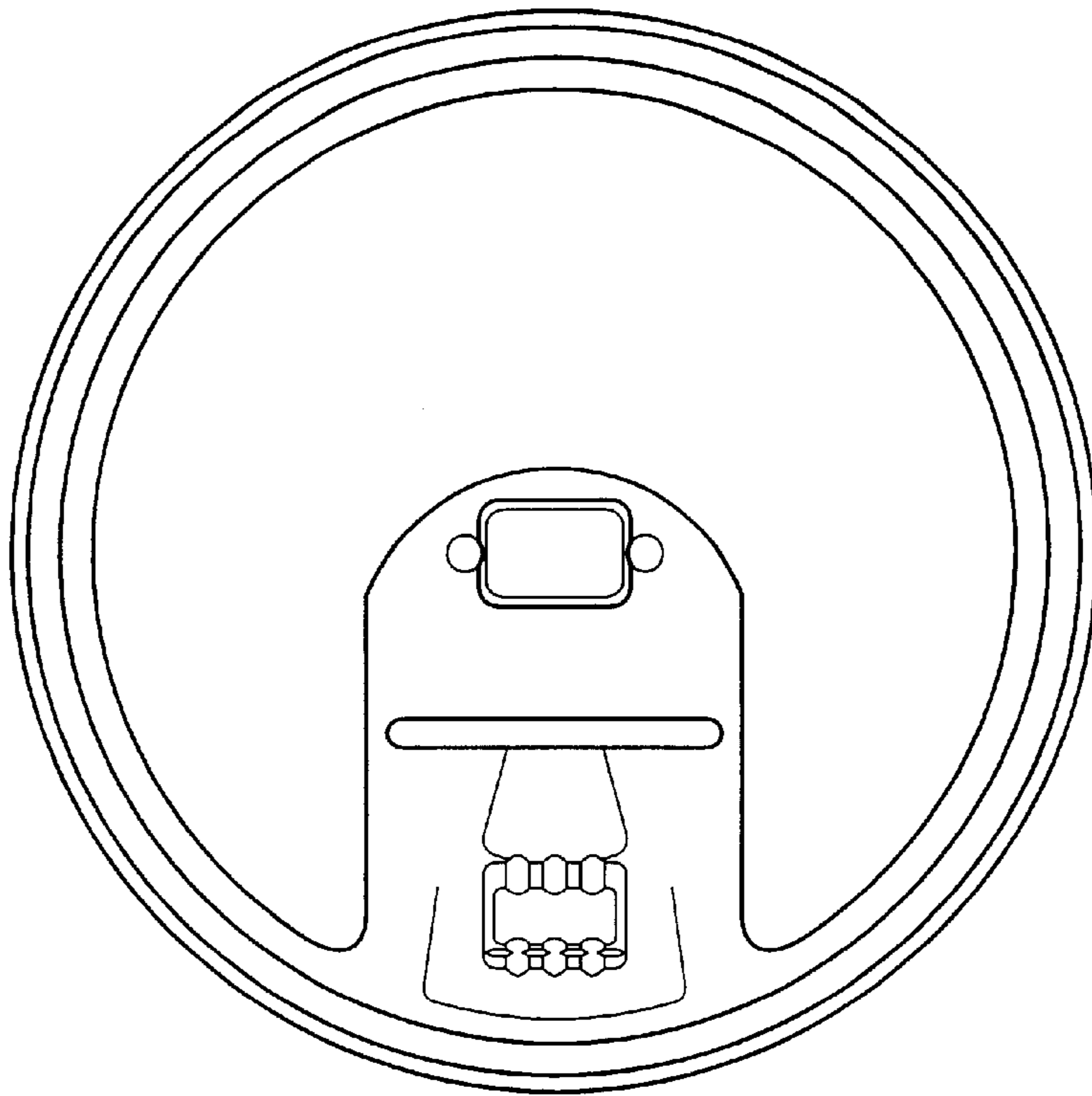

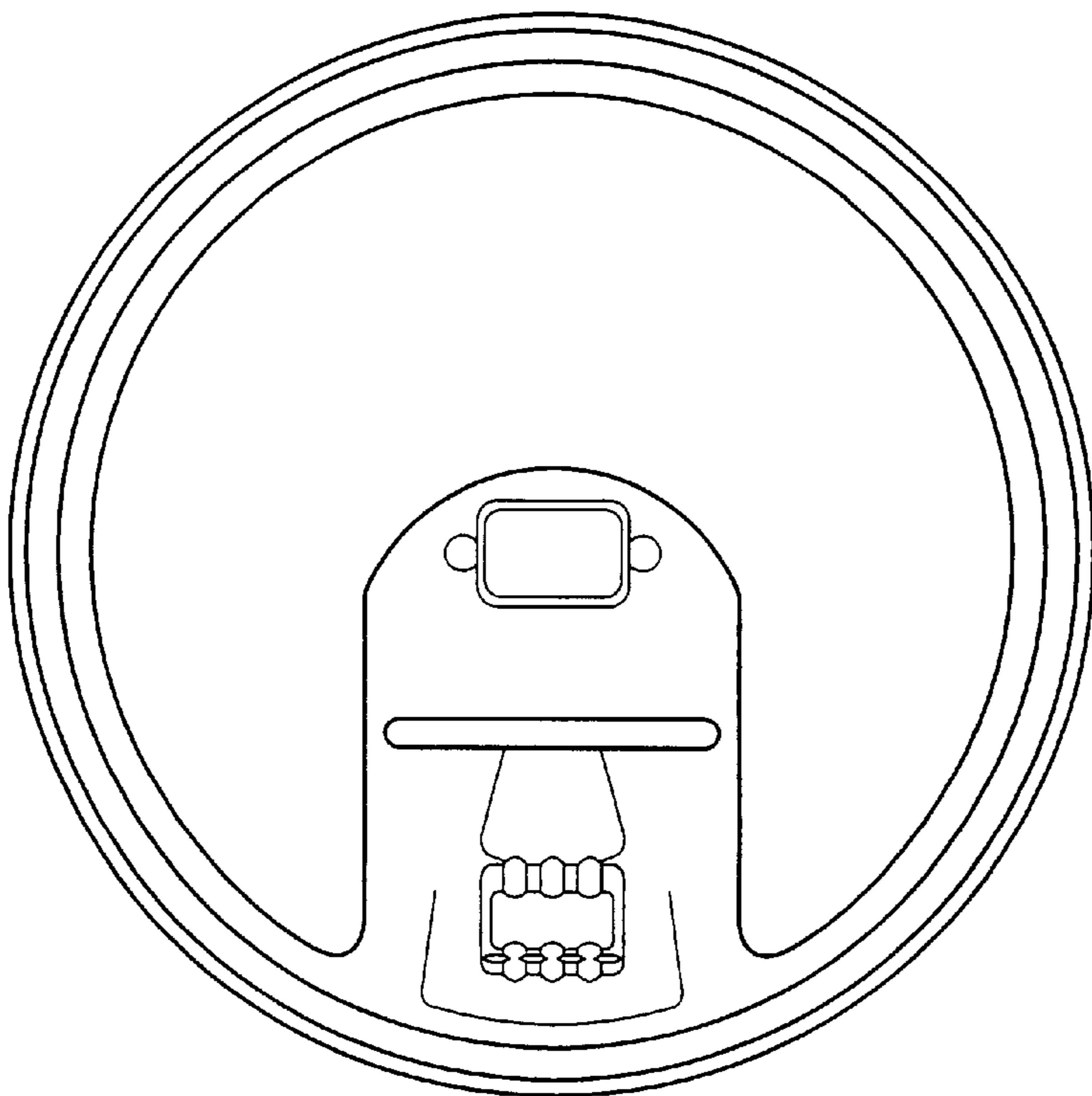

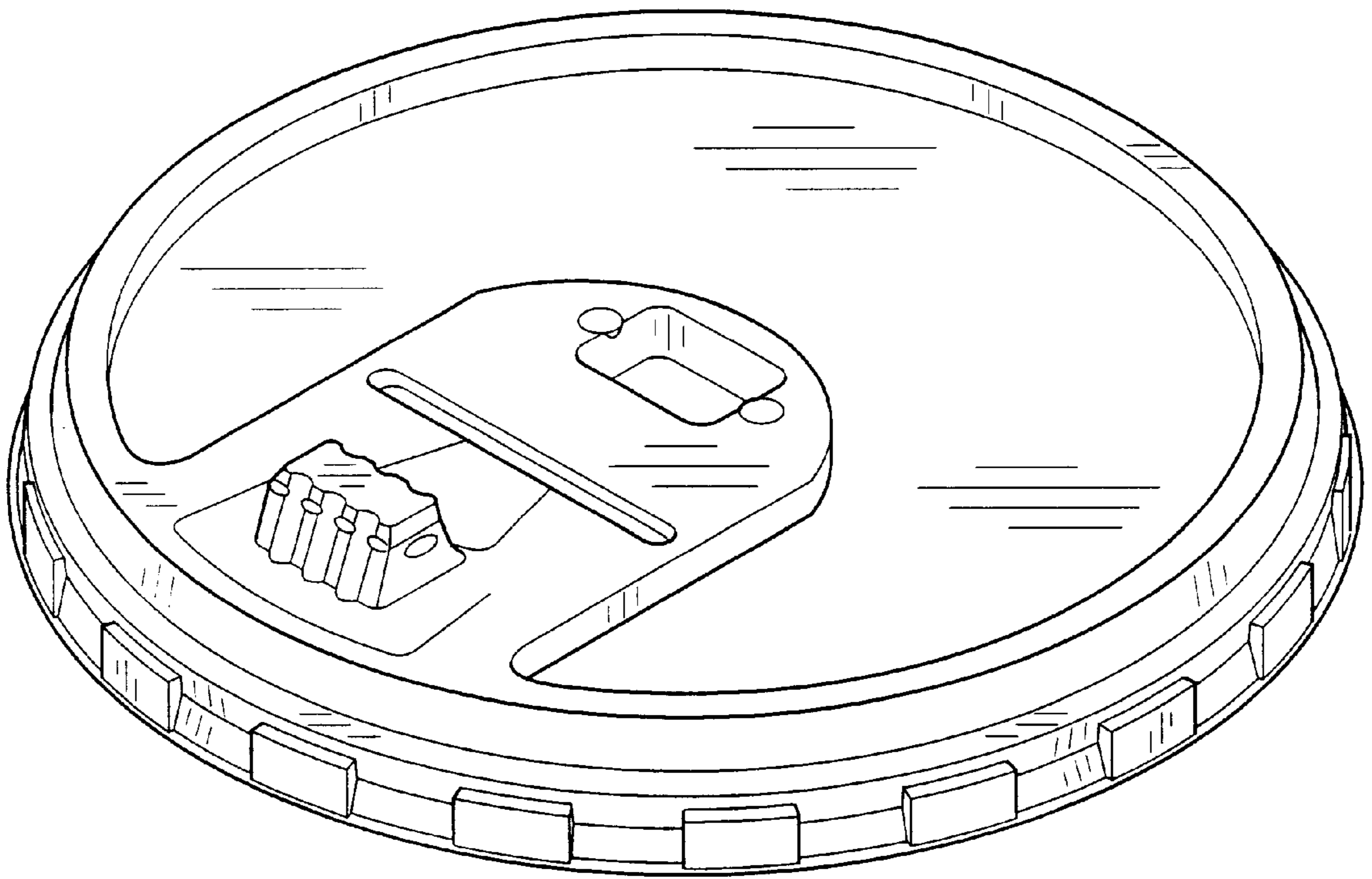

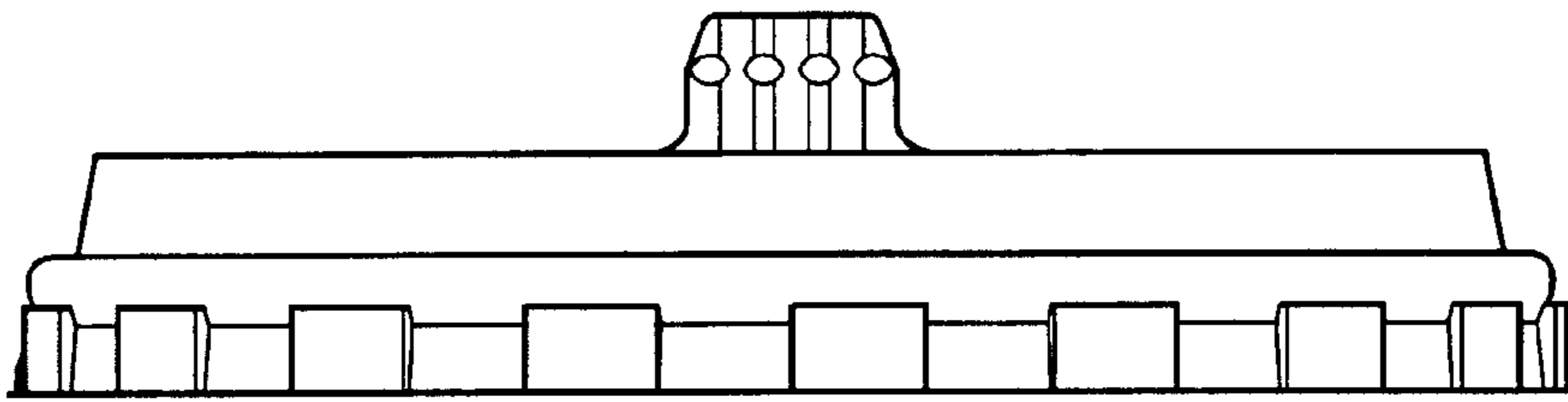

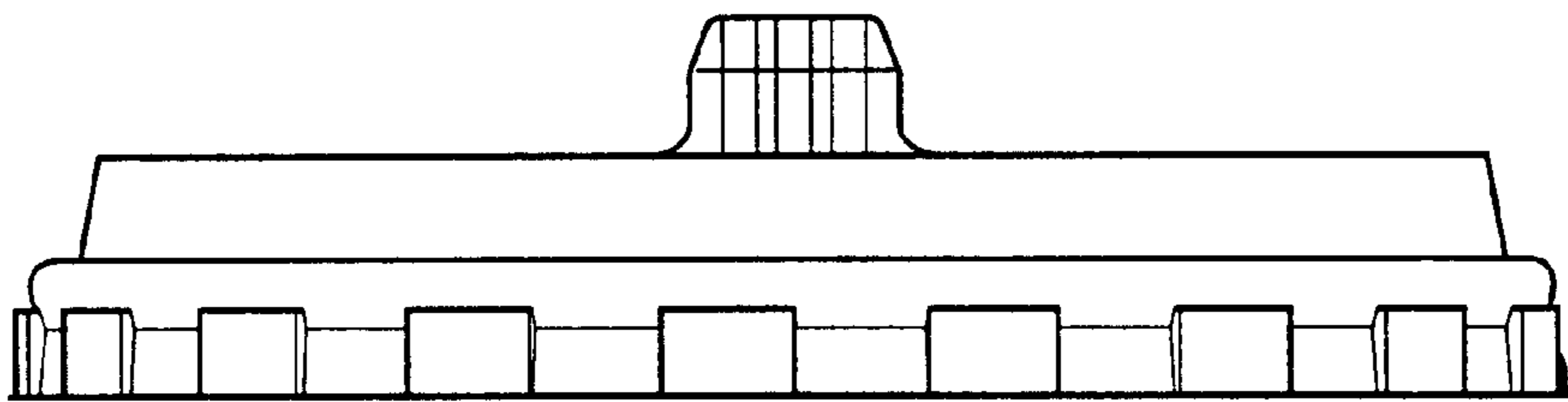

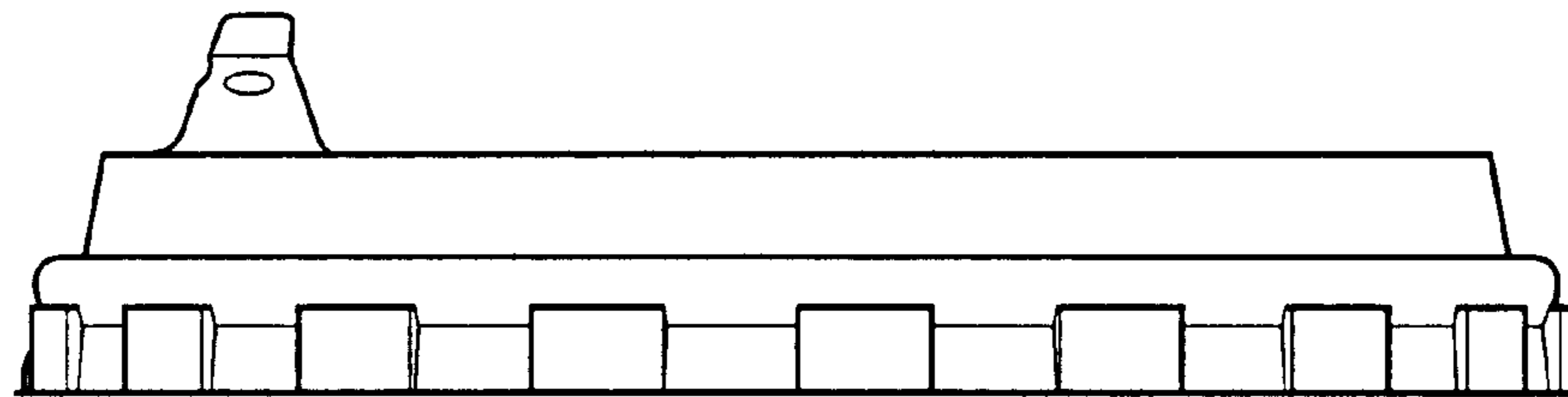

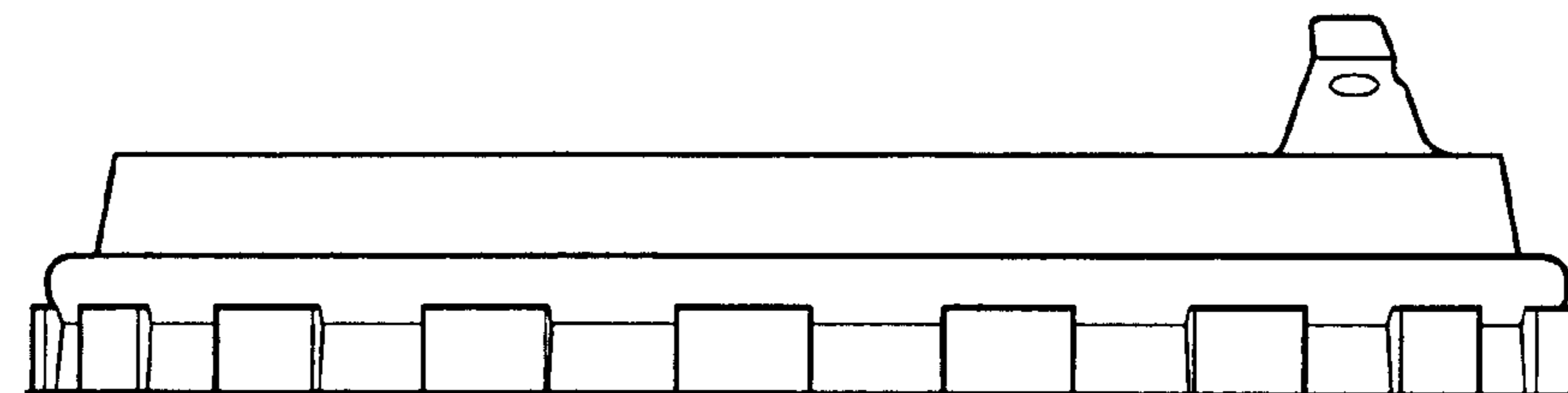

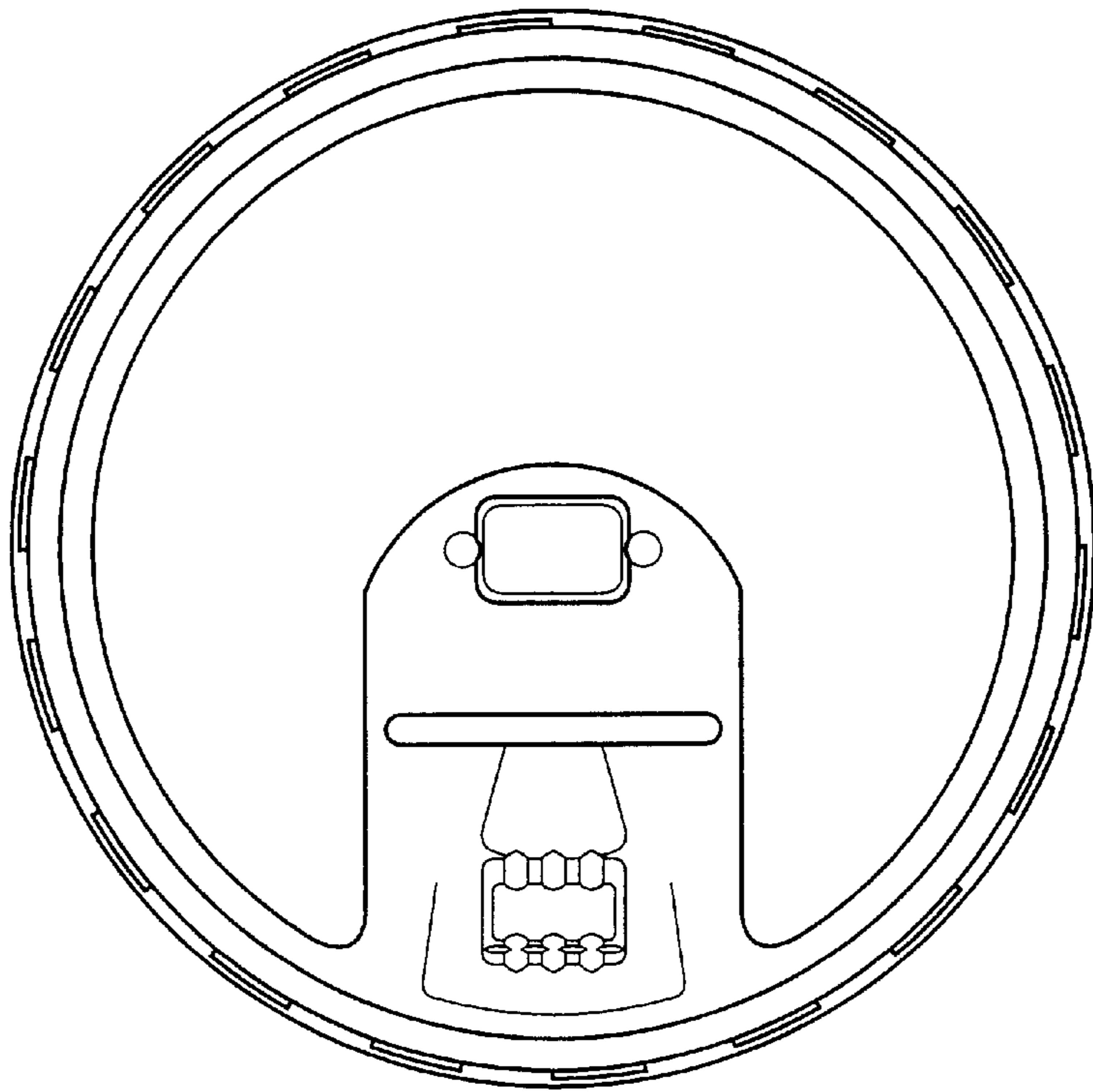

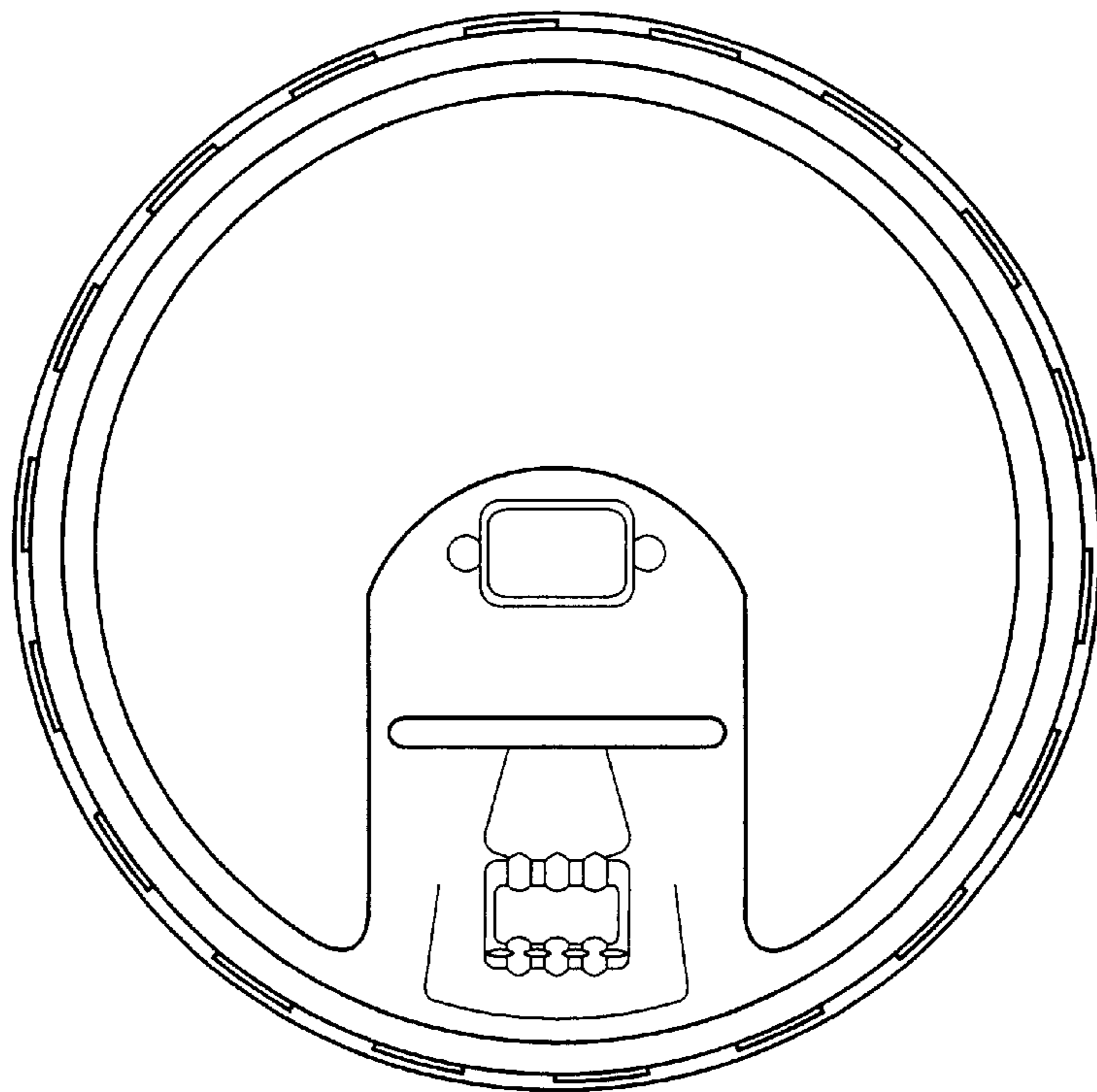
