FIG. 4 is a back view with the stand closed.

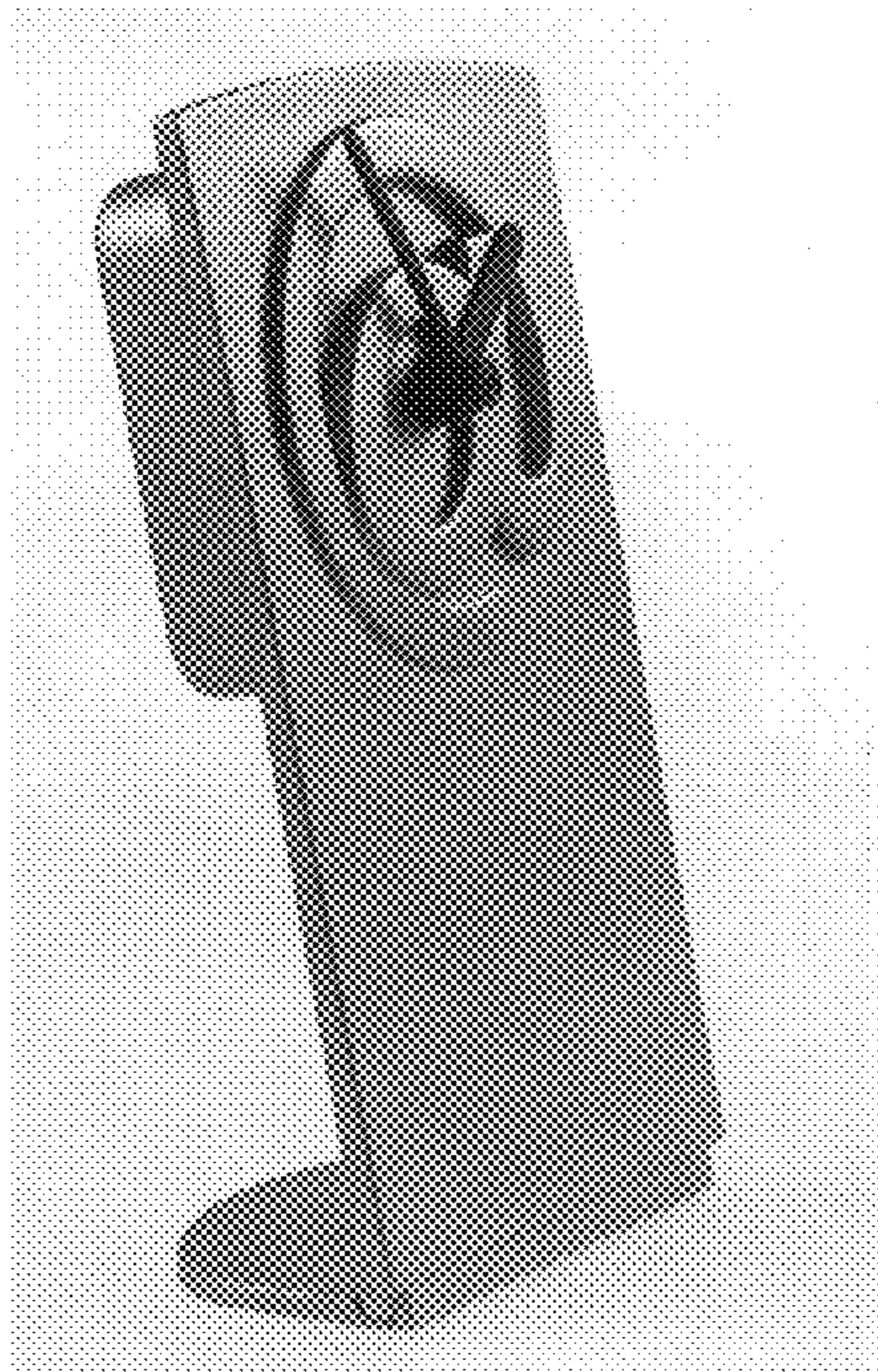
FIG. 5 is a top view thereof.

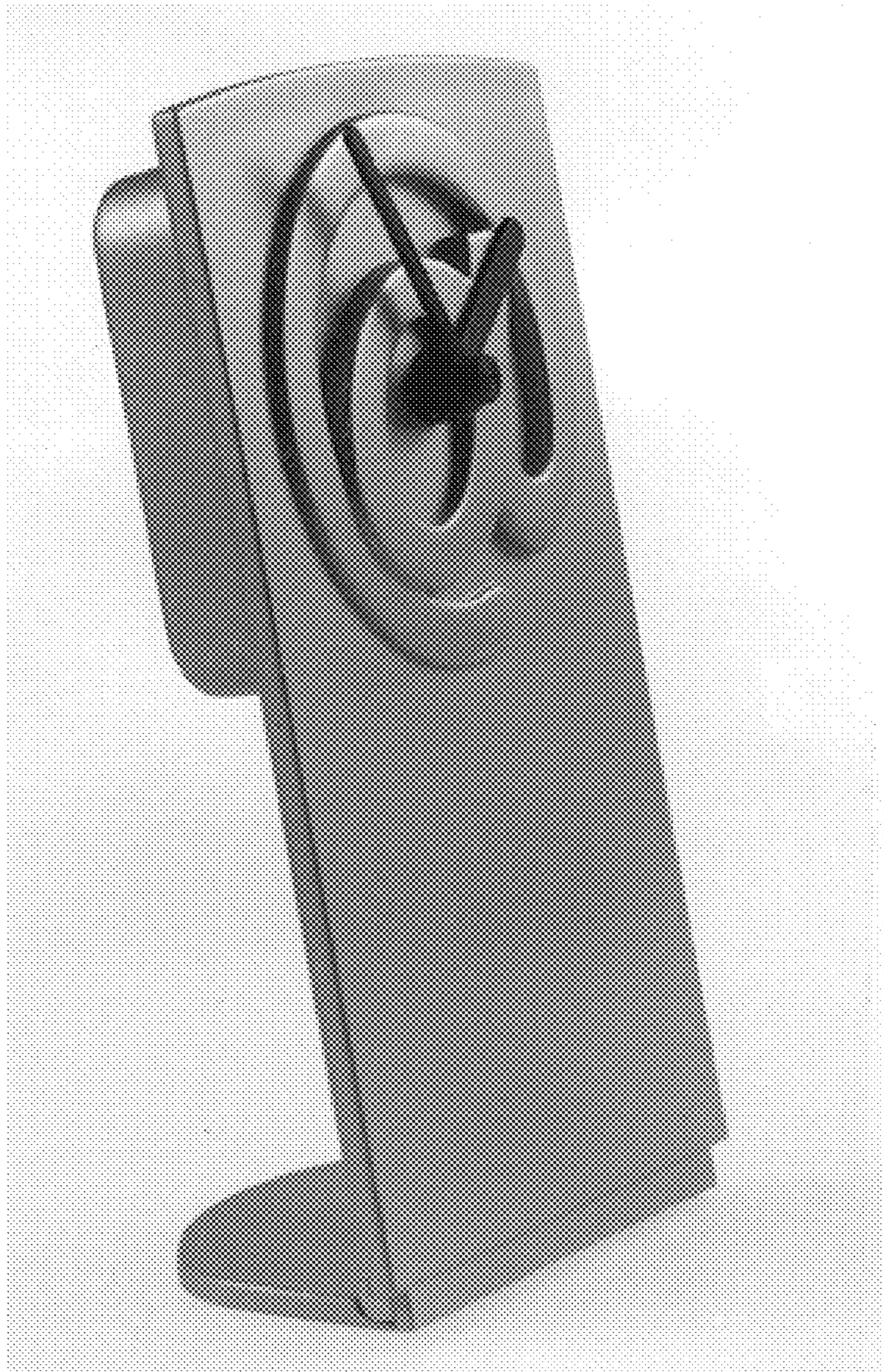

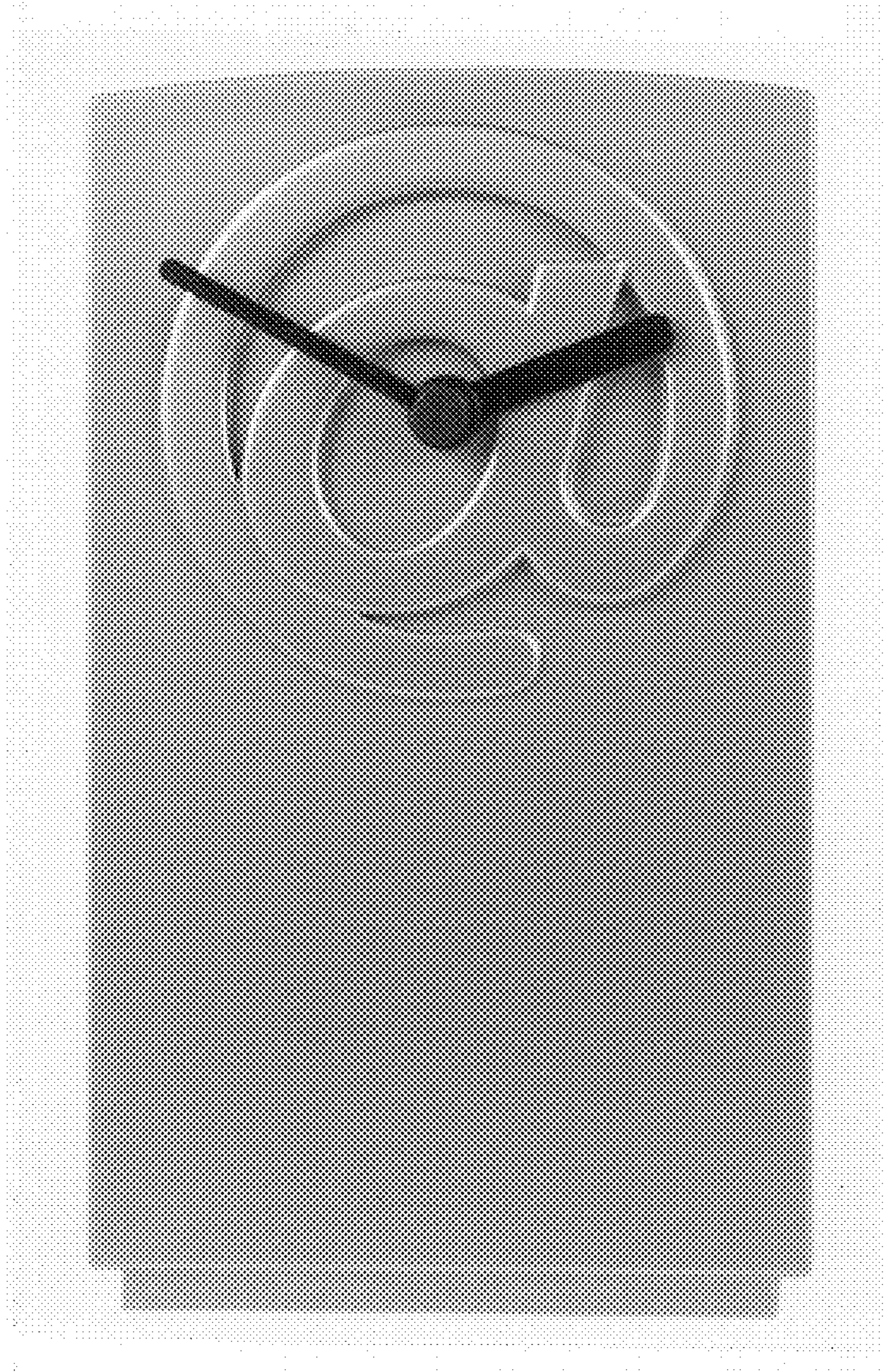

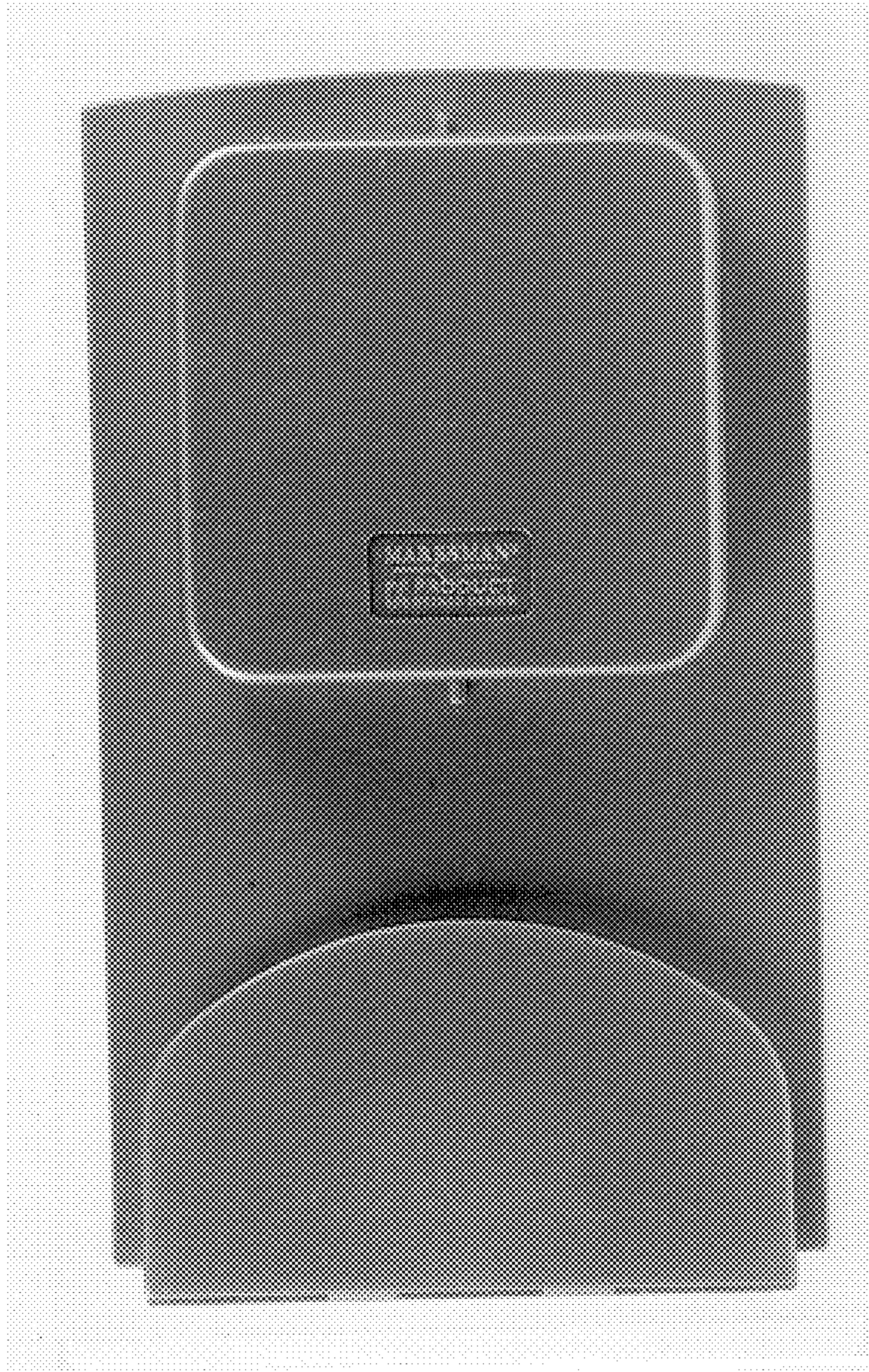

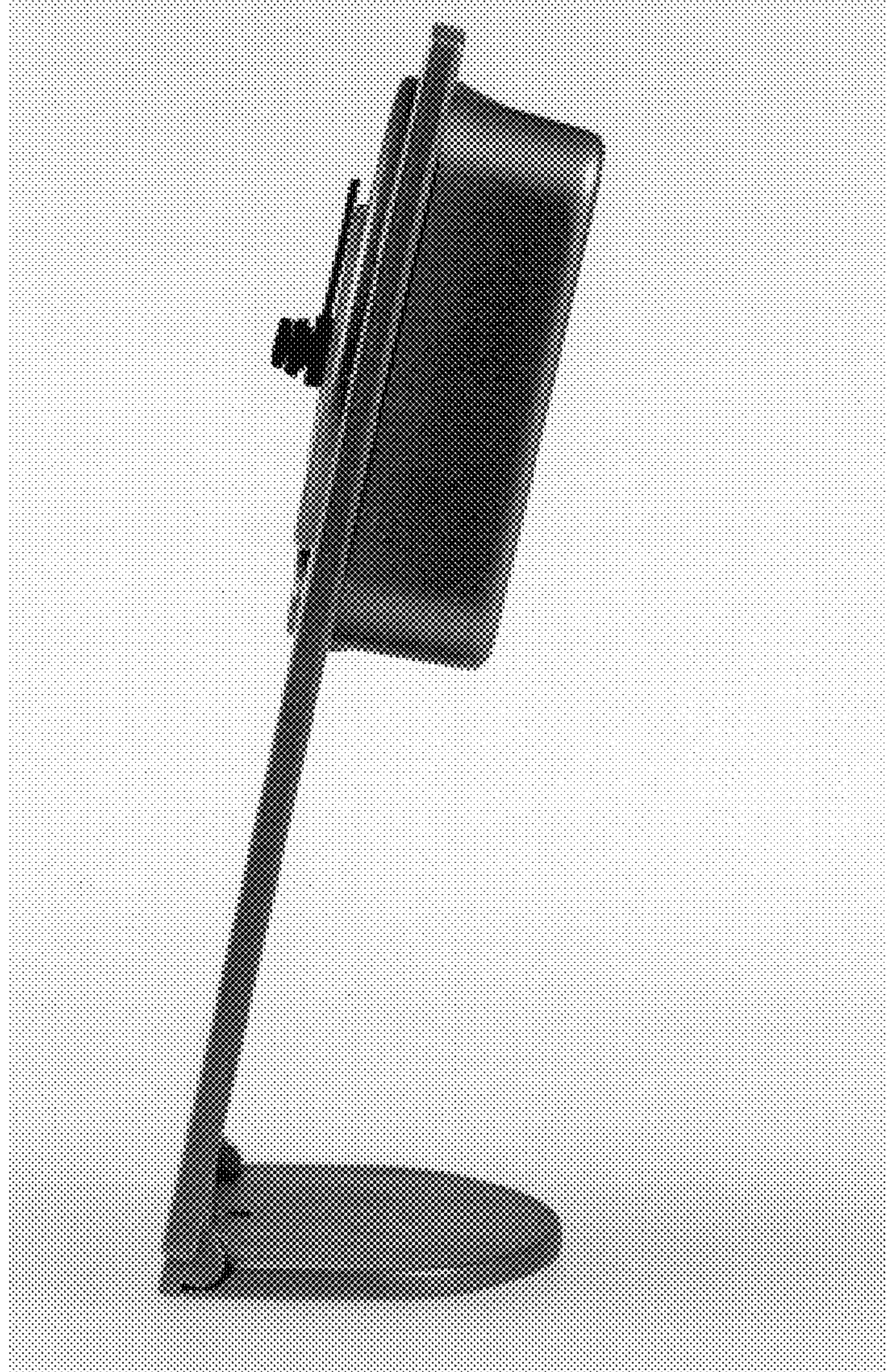

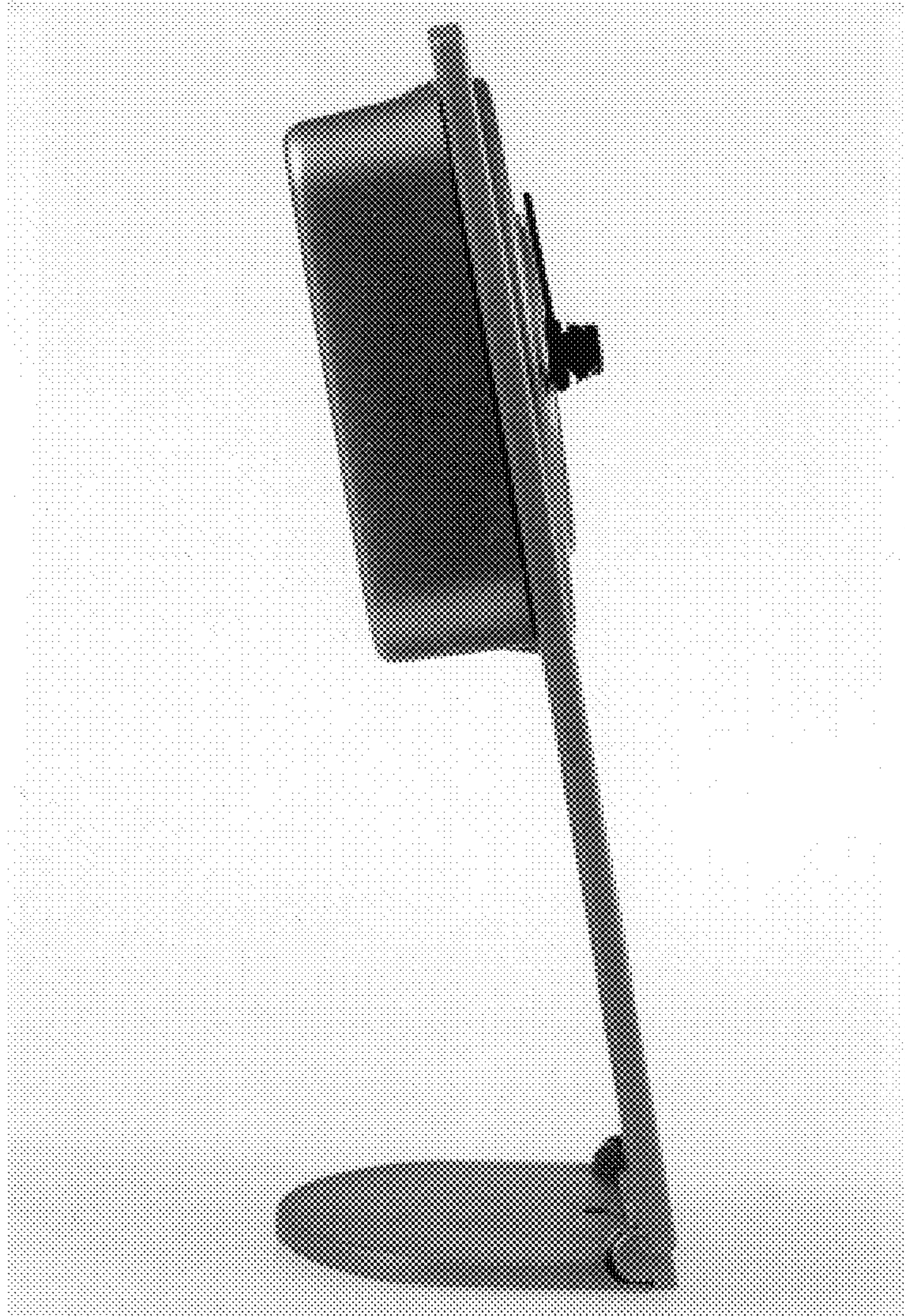
